BHUBANESWAR: Slamming opposition parties for propaganda against the BJP-led NDA, Prime Minister Narendra Modi on Friday asserted that they have "crushed" the spirit of the Constitution and rejected all norms of democracy. PM Modi, addressing party workers in Bhubaneswar, also said that the opposition has only one aim, "to somehow capture power by misleading people".

"Those who consider power as their birthright have not been in power at the Centre for the last decade," he said in an apparent dig at the opposition.

The prime minister said it is quite natural that there would be ideological differences among political parties on different issues, and that they have the right to express their views and resort to agitations.

"During my tenure as Chief Minister and PM, I saw different colours of politics. I admit that

Expect Intense Cold, Frequent Snowfall, Says IMD Scientist

SRINAGAR: Kashmir has started showing signs of winter arrival with noticeable shifts in the weather pattern. The region is bracing for harsh weather conditions this winter with heavy precipitation and prolonged cold spells, according to the India Meteorological Department (IMD) which has forecasted a La Niña event.

According to the IMD, Jammu and Kashmir is experiencing foggy mornings and there has been a gradual decline in both maximum and minimum temperatures. Dr Mukhtar, a senior

scientist at IMD, stationed

at Srinagar weather station confirmed to the news agency-Kashmir News Observer (KNO) the onset of the La Niña weather effect, predicting a colder and beyond normal precipitation for the Kashmir region this

He said the impact of La Niña was likely to be evident starting mid-December this year with an expectation of heavy precipitation and intensified cold spells.

La Niña is a natural climate phenomenon occurring in the Pacific Ocean. It is characterised by coolerthan-average sea surface



Economic Potential Eroding Rapidly While PM Modi Generates Hype: Congress

NEW DELHI: The Congress on Saturday attacked the government over India's economic growth slowing to near twoyear low, saying the country's medium and long-term economic potential is "eroding rapidly" and asked how long will the grim reality of stagnant wages for crores of workers continue to be ignored.

Congress general secretary in-charge communications Jairam Ramesh said the GDP growth figures released last evening for July-September 2024 are much worse than anticipated, with India recording a measly 5.4% growth and consumption similarly growing by an unimpressive 6%.

"The non-biological PM and his cheerleaders are wilfully blind to the causes of this sharp slowdown, but a new report on 'Labour Dynamics of Indian States' released by a leading Mumbaibased financial information services company, India Ratings and Research, on the 26th of November 2024 reveals its real cause: stagnant wages," Ramesh said in a statement.

The Congress leader pointed out that the report uses Periodic Labour Force Survey (PLFS) data to show that overall real wage growth at the national level has been flat at 0.01 per centover the last five years.

In fact, the workers in Haryana, Assam

sources of data have now confirmed this wage stagnation," he asserted. Citing Labour Bureau's Wage Rate



and Uttar Pradesh have seen their real wages decline in the same period, he said.

This is hardly the exception, nearly every piece of evidence points to this same damning conclusion that the average Indian can buy less today than they could 10 years ago, Ramesh said.

"This is the ultimate root cause for India's growth slowdown, and multiple Index, he said real wages for the labourers stagnated between 2014-2023 and in fact declined between 2019-2024.

Ramesh further cited the Ministry of Agriculture's Agricultural Statistics and said that under former prime minister Manmohan Singh, real wages for agricultural labourers grew at 6.8 per centeach year.

"Under Narendra Modi, real wages for agricultural labourers declined by minus 1.3 per centeach year," he said.

Citing the Periodic Labour Force Survey Series, Ramesh said the average real earnings over time have stagnated between 2017 and 2022 across all employment types' salaried workers, casual workers and self-employed workers.

Citing the Center for Labour Research and Action, Ramesh said the real wages of brick kiln workers have stagnated or declined between 2014 and 2022.

Brick kilns involve intensive labour and are a low-paying work of last resort for India's poorest, he said.

When real wages stagnate or fall as they have in the last few years, consumption will also be stagnant, he pointed out.

"The recent rush of statements by senior leaders from India Incabout slowing consumption are only the symptom of this deeper malaise.

This slowdown will have severe consequences for us: without adequate growth in consumption to assure them of a market for their products, India's private sector will be unwilling to invest in new production," Ramesh argued.

Modi 'biased' towards Adani, discriminating against Wayanad landslide victims: Rahul

KOZHIKODE (KERALA): Leader of Opposition in the Lok Sabha Rahul Gandhi on Saturday attacked Prime Minister Narendra Modi by accusing him of being "biased" towards industrialist Gautam Adani and of discriminating against Wayanad landslides victims by not providing them the due support.



Rahul hit out at Modi at a joint public meeting at Mukkam here with his sister and Congress MP Priyanka Gandhi who is visiting the Wayanad Lok Sabha constituency for the first time after her huge maiden electoral victory from there.

The LoP in the Lok Sabha alleged that Modi was treating Adani differently from the people of India, despite his indictment in the US, even though the Constitution says everyone should be treated equally.

"PM Modi says it does not matter if Adani has been indicted in the US and called a criminal there, in India we will not indict him," Rahul claimed. He further accused Modi of discriminating against the people of Wayanad, alleging that he was not willing to provide them the support which they were due. "This is the atmosphere in which we are operating. It is the feelings that people have toward us that gives us confidence and protects

Arambai Tenggol Chief, Kuki Militants Under Nia Radar Over **Attacks During Manipur Unrest**

GUWAHATI: Meitei radical organisation Arambai Tenggol's supremo Korou Nganba Khuman and Kuki militants are under the radar of the National Investigation Agency, which has been tasked with probing four cases of attacks on security forces and an IED explosion in strife-torn Manipur.

The cases include looting of arms and ammunition from the 1st Manipur Rifles complex in Imphal, attack on Indian Reserve Battalion post in Moreh and IED explosion in Bishnupur.

The Counter Terrorism and Counter Radicalisation Division of the Ministry of Home Affairs has recently ordered the NIA to undertake further investigation of the four cases.

The cases have recently been transferred by the Supreme court from the NIA Court in Imphal to NIA Special Court in Guwahati.

A copy of the transfer petition filed by the NIA before the Supreme Court said, "

The first case involving Khuman is related to an incident that occurred on November 1 last year when a large number of Arambai Tenggol members led by him and armed with sophisticated weapons, wearing camouflaged uniforms, and black colour shirts coming in many light vehicles gathered at Palace Compound in Imphal East district on a call given in Facebook page Korou Nganba Khuman in Manipuri language which literally translates to 'please come all brave brothers let us teach them all a final lesson today'." "When they were stopped by (personnel of) the Imphal East police station at the palace gate, the group fired at police, overpowered the local police and proceeded through Sanjenthong Bridge towards Imphal West side in many light vehicles," it said.

"The central government has received information from that happened on the same day at 6 pm.

The petition stated that a large number of AT members led by its chief rushed in from the $nor thwestern\,gate\,and\,attacked$ the 1st Manipur Riffles Battalion in Imphal.

"They ransacked government



the Government of Manipur regarding registration of an FIR at Porompat in Imphal East district dated 1/11/2023 under Sections 147, 148, 149, 186, 188, 307, 379 A, 395, 504, 505, 506, 34 of IPC, Sec 18 of UA(P) Act, Sec 6 (1) (a) of Official Secrets Act, Sec 25 (1-B) of Arms Act," an FIR filed by NIA Imphal said.

"The central government is of the opinion that a scheduled offence under the NIA Act 2008 has been committed and having regarded the gravity of the offence and ramifications on national security, it is required to be investigated by the NIA in accordance with the NIA Act," it added.

BJP Does Not Follow Rules, Democratic Norms: Priyanka

KOZHIKODE (KERALA): Congress MP Priyanka Gandhi Vadra, on a two-day visit to Kerala after



her maiden electoral win from the Wayanad hill constituency, on Saturday said the BJP did not play by any rules or follow democratic norms in its political attacks. Comparing the BJP's behaviour with the landslides that hit Wayanad in July, Priyanka contended that just like the natural disaster, the saffron party's conduct knows no rules, offers no explanations and follows no democratic norms that are normally adhered to in political fights.

"The political challenges we face (from the BJP) today are like landslides. There are no rules. There are no explanations."

"The behaviour of the ruling party (at the Centre), the BJP, knows no democratic norms, not even those we normally adhere to in a political fight," she said while speaking at a joint public meeting, with her brother and Leader of Opposition in the Lok Sabha Rahul Gandhi, at Mukkam here.

She further said that institutions were being destroyed, leading to the wavering of the people's basic faith in the electoral process and "the institutions that held our country together".

Later, at a reception given to her in Karulai in Nilambur assembly constituency in Malappuram district, Priyanka reiterated.

For District Hospitals, District Hospital Kishtwar ranked first, with District Hospital Shopian, District Hospital Budgam, District Hospital Samba, and District Hospital Reasi following in the rankings.

In the Community Health Centres (CHCs) category, CHC Marh, Jammu took the top spot, followed by CHC Pakherpora, Budgam, CHC Billawar, Kathua, CHC Batote, Ramban, and CHC Banihal, Ramban.

The JK e-Sahaj initiative, launched on November 4, 2022, is part of the Jashn-e-Sehat program and aims to automate hospital administration across different types of healthcare facilities in Jammu & Kashmir. It is integrated with the Rapid Assessment System (RAS), the 104 Centralised Health Helpline, and the RCH portal of the Ministry of Health and Family Welfare, Government of India.

The rankings were determined based on the registration process, conversion of Electronic Medical Records (EMR), registration of IPD patients, and patient feedback uploaded on the JK e-Sahaj portal for the month of September 2024. Efforts also aim to eliminate vertical transmission and reduce stigma, supported by the HIV and AIDS (Prevention and Control) Act, 2017. While progress is evident, challenges persist. Social stigma and systemic inequalities hinder efforts to end AIDS by 2030. Marginalization in this region transcends conventional dimensions of poverty or social exclusion; it is deeply intertwined with the aftermath of decades of conflict, displacement, and structural barriers. A comprehensive framework that embraces inclusivity, sustainability, and self-reliance is imperative for enabling the region's most disadvantaged to overcome these challenges. Here an attempt is made to propose $transformative paradigms \, and \, actionable \, strategies \,$ rooted in empirical evidence, historical insights, and contemporary innovations to pave the way for equity and empowerment. By harnessing education, health services, financial resources, and community-based governance models, this vision seeks to ensure dignity and opportunity for all.

In Kashmir marginalized groups include economically disadvantaged laborers, artisans, and craftspeople such as kangri makers, carpet weavers, handicrafts, pashmina artisans, who face limited market access and dwindling recognition of their craft. Fishermen, bat makers, and metal workers grapple with outdated techniques and insufficient resources to expand their livelihood. Socially excluded groups, including women, widows, orphans, and conflict survivors, $struggle\ with\ systemic\ inequities\ and\ inadequate$ institutional support. Persons with mental health issues, trauma, age old persons, specially abled persons, etc. Scheduled Tribes like the Gujjars and $Bakerwals\,remain\,underserved\,in\,education.\,There$ is an urgent need for them to open model schools with quality infrastructure, professional staff, with boarding and lodging facilities, they further $need free \, health care, and \, political \, representation,$ to further away their exclusion. Addressing their plight requires comprehensive, inclusive strategies that blend economic opportunity with social equity and empowerment.

Masons, carpenters, kangri makers, metal workers, fishermen, carpet weavers, handicrafts, and displaced families, face entrenched barriers to upward mobility. To empower them, a multipronged strategy rooted in skill enhancement, market access, and welfare support is essential. Government and non-government initiatives must focus on capacity-building programs that provide technical training and modern tools to improve efficiency, product quality, transport and marketing. For handicrafts, kangri walas and metal workers, innovative designs and branding should be promoted to tap into global niche markets. Fishermen can be supported through cooperative societies, subsidies for modern fishing equipment, and cold storage facilities to reduce post-harvest losses. Carpet weavers need financial incentives, direct market linkages, and technological integration to ensure fair pricing and global outreach. Welfare boards that ensure insurance, pension schemes, and healthcare services. Additionally, mobilizing Awgaf funds

and CSR initiatives to provide free transport for goods, exhibition platforms, and microcredit can significantly uplift these marginalized groups, ensuring dignity and sustainable livelihoods and their upcoming generations.

Recent data underscores the impact of free education programs in conflict-prone zones: dropout rates in general education among underprivileged students reduced by over 30% in regions where such initiatives were implemented. This highlights the transformative potential of such measures in

Capacity-building programs tailored to local needs can equip marginalized communities to engage meaningfully with modern economic systems while preserving cultural heritage.

The pathway to empowerment in Kashmir must reflect a symbiotic relationship between cultural values and progressive frameworks. Marginalization is not merely an economic or social challenge; it is a denial of dignity and agency. Scientists Create Instant 'Golden **Furmeric** Milk' With **Health Benefits**

olden turmeric milk has become quite popular in recent years and has many health benefits, so scientists created an instant version that maintains all these advantages while having a longer shelf life.

As swearing off coffee in favor of caffeine-free beverages continues to grow in popularity, many are looking for replacements that provide the same cozy experience while also offering increased

Some have turned to matcha, a Japanese green tea powder that has been shown to decrease stress while improving cognitive function, while others have added golden turmeric milk into their daily routine. Although the beverage has become trendy recently, it's based on a

traditional Indian drink called haldi doodh, which has been consumed as a cold remedy for generations. The beverage typically consists of milk, spices, and turmeric -aspice that contains the bioactive compound curcumin, a polyphenol

that has been shown to have anti-inflammatory and antioxidant effects. However, according to researchers, curcumin is difficult to separate from turmeric. It usually requires complicated extraction techniques that involve organic solvents, multiple days, and lots of energy. The compound also tends to break down over time, giving it a short shelf life.

As a result, scientists with the American Chemical Society set out to create an instant version that could be stored within plant-based milk while maintaining the same health benefits and an extended shelf life.



To do this, scientists added turmeric powder to an alkaline solution. Compared with plain water, the high pH of the solution made the curcumin more soluble and easier to extract. Researchers then added this solution to soy milk — chosen for its high amino acid content — before bringing the pH down to neutral, around seven. To create an instant powder, the researchers then removed the water from the solution through a freeze-drying process.



The researchers found this to be the most effective method of extracting curcumin from turmeric. They were also able to encapsulate the curcumin in oil droplets within the soy milk. This allows the body

to recognize and digest it as fat, making its benefits more available. This method also protects the curcumin from air and water which helps to extend its shelf life.

While the scientists used soy milk in their experiment, they said the same method could be used with other plant-based milks. The extraction method can also be used with different plant compounds. Blueberries, for example, are rich in anthocyanins, another water-soluble polyphenol.

"When we use the same method, within around a minute we can extract the polyphenols," said researcher Hualu Zhou, Ph.D., in a news release. "We want to try and use it to upcycle by-products and reduce the food waste from fruit and vegetable farming here in Georgia."

The researchers presented their results at the fall meeting of the ACS. While more research is needed before this instant, plant-based golden turmeric milk is available on shelves, researchers said the results are promising - and they taste good, too.



Keto High

Is It Real and Why Does It Happen?

ome Reddit users who started a ketogenic diet report experiencing a "keto high," defined as improved thinking and the feeling of euphoria. Experts say there may be several explanations, but a keto diet is not healthy long-term.

GHB, also known as the prescription drug Xyrem.

The drug is commonly used to treat narcolepsy by providing a boost of energy and can also be used for the treatment of alcohol and opioid dependence. Due to its ability to produce

ketones called BHB, which is closely related to intense euphoria, Xyrem is also used as a party drug known as liquid ecstasy.

Moody tells Healthnews, "Some researchers believe that the similar properties of the compound GHB and the ketone body BHB may produce similar feelings of happiness."



A ketogenic or keto diet is an increasingly popular eating pattern, followed by about 7% of Americans, according to 2022 data.

In the keto diet, 70–80% of calorie intake comes from fat, 10-20% from protein, and 5-10%. The diet focuses on animal products like meat, poultry, fish, and eggs, as well as leafy greens, cucumber, and celery. Low-carbohydrate and non-starchy vegetables are also allowed.

People on a keto diet normally experience ketosis, the process in which the body burns stored fat for energy instead of blood sugar. Ketosis can be accompanied by weight loss and so-called keto flu, which includes symptoms like constipation, headache, fatigue, and brain fog.

However, some Reddit users report opposite experiences after going into ketosis, which they dubbed "keto high." One Redditor even compared the experience to feeling like a "god."

"I remember realizing my brain was working properly for the first time in my life, my ADHD symptoms went away. I was energetic, no brain fog, I had better memory. I wouldn't freeze in conversations anymore, words would come out of my brain faster," the user explained.

Another user remembered the urge to run back to the office after lunch despite wearing business attire at the beginning of going into ketosis.

One Redditor said they felt "absolutely amazing" during the first few months on a diet and had some of the best performances in years. However, the alleged "keto high" seemed to fade after the first few months.

In fact, most Redditors reporting "keto high" said it eventually went away and didn't return.

What causes the keto high?

Destini Moody, a registered nutritionist at Top Nutrition Coaching says that there is no solid scientific evidence on the cause of a "keto high." However, a common hypothesis suggests that

Moody explains that it is also possible that people who started the keto diet could have begun adding more fruits and vegetables to their eating pattern as well as cutting out refined grains and added sugars that could kick them out of ketosis.

She adds, "This sudden shift to a more nutrientrich diet could give an individual more energy and less brain fog."

Is the keto diet safe?

Moody says there has been no research that has shown that the keto diet is inherently more effective for weight loss or health improvement than a traditional, balanced diet that includes all food groups

While the keto diet may be easier for some people to stick to than a traditional diet, they should pursue the journey under the supervision of a nutrition professional to reduce excess consumption of saturated fats and ensure they are getting all of the nutrients they need safely, according to Moody.

The keto diet is often praised for weight loss, which is attributed to accelerated calorie burning. However, a recent study suggests that the actual reason why people on a keto diet lose weight is because it normally involves reduced caloric intake.

According to a 2021 review article, the benefits of a keto diet may include lowered blood glucose, although its efficacy typically wanes within the first few months.

At the same time, the diet may raise cholesterol levels and increase the risk of chronic kidney disease, cardiovascular disease, cancer, diabetes, and Alzheimer's disease. Women who follow a ketogenic diet during pregnancy are more likely to have a child with a neural tube defect.

Some people on a keto diet may indeed experience increased energy and improved focus. However, a traditional diet emphasizing fruits, vegetables, and whole grains provide more substantial health benefits long-term.

Over 50 'Civilians' Forcibly Disappeared in Balochistan

QUETTA: A wave of enforced disappearances has been reported across Balochistan following a series of raids by Pakistani security forces in Turbat,

Dera Bugti, Sui, Barkhan, and Kalat. Over 50 individuals have been forcibly taken, raising grave concerns about human rights violations in the region, according to The Balochistan Post.

The most recent abductions occurred in Turbat on Thursday morning, where Pakistani forces stormed a residential area and detained multiple individuals. Among those abducted were Zafar s/o Mohammad Rahim, Rahim Jan s/o Zafar, and Mohammad Kareem s/o Bahram, along with five guests at Zafar's guest house.

In Dera Bugti, two individuals, Dangla s/o Haji Moj Bugti and Pir Mohammad s/o Pano Bugti, were taken on Wednesday

This marks the third time Pir Mohammad has been forcibly disappeared, with reports of severe torture during previous detentions.

Other incidents include the disappearance of Rashid Ahmad Khetran in Barkhan while traveling from Dera Ghazi Khan and Syed Hussain Shah in Kalat. Shah, the father of another missing

person, Syed Akhtar Shah, was taken during a two-day siege of the Iskalku area, where over 40

amid widespread harassment of residents. Network shutdowns have hindered the flow of information, leaving the identities and conditions of many

individuals were reportedly detained

detainees unknown. The Voice for Baloch Missing Persons (VBMP) and the Baloch Yakjehti Committee have called on human rights organizations to intervene and demand the release of the forcibly disappeared.

The VBMP protest in Quetta marked its 5,650th day on Thursday.

Speaking at the protest camp, the mother of Rashid Hussain Baloch, a longmissing individual, shared her anguish.

"I have been seeking justice for years, but the institutions refuse to act according to the constitution," she said, appealing for global advocacy for her son's release.

The raids and disappearances underscore the ongoing crisis in Balochistan, where forced disappearances remain a tool of suppression, drawing widespread condemnation from activists and international organizations.

"While the current conditions are neutral to weak La Niña, the phenomenon is expected to strengthen as the winter progresses. This intensification will likely amplify the impact of cold and precipitation across the Kashmir region and parts of northern India," it said.

Speaking on the changing weather pattern, Dr Mukhtar said, "The La Niña effect shifts atmospheric dynamics in ways that bring abnormal precipitation and colder temperatures. This can translate to a harsher winter for Kashmir, with more frequent snowfalls and prolonged cold spells "

He said that past instances of La Niña, particularly in 2018-19 and 2021-22, brought significant snowfall to the region. "The likelihood of heavy snow spells and rainfall is high this season, and this could result in a much colder winter compared to the last few years," he added.

The Kashmir Valley, already accustomed to freezing winters, remains highly vulnerable to the effects of La Niña.

Dr Mukhtar said it is important to learn from previous winters, citing the deficit precipitation observed during strong El Niño years and the subsequent changes in weather patterns. "Unlike last year, which was dominated by El Niño, this year's La Niña effect will likely bring a more traditional and harsh Kashmiri winter," he said.

MUMBAI: No one can take away the "phenomenal achievements" of Ravichandran Ashwin but the Indian team management is preparing Washington Sundar for near future when the former calls time, feels another spin maestro Harbhajan Singh. Ashwin, who with 536 wickets is second to Anil Kumble's 619 Test scalps for India but the next 84 victims could take time with young Washington suddenly becoming India's first-choice off-break bowler in the Gautm Gambhir era.

"Ithink that's what their (team management and selectors') long term plan is. Ravichandran Ashwin has done a phenomenal job playing for India in taking all those wickets in his career," Harbhajan told PTI in an exclusive interview when asked if he sees Ashwin's younger Tamil Nadu statemate taking over the mantle of lead spinner.

Ashwin's age is certainly a factor that is being kept in consideration.

"But now that he is at that stage, at the age of 38, so that's why they have kept Washington Sundar with them (for) whenever R Ashwin will retire. The team thinks that they have to prepare Washington, so I think they are working on the same path," the former off-spinner with 400 plus Test and 700 plus international wickets across formats aid.

Harbhajan spoke during the launch of a book titled "The Extraordinary Life of Kiran Dembla", authored by filmmaker Dr Deepak Singh.

Harbhajan, who didn't play the WACA Test

The former India player said while Bumrah was at the forefront, he singled out KL Rahul for his formidable batting at Perth in the first Test along with Yashasvi Jaiswal for India's triumph.

"To give credit, Jassi did a great job but along with that, Jaiswal (too)," he said.

WC medal hasn't come for long time, I want to achieve it in my career: Harmanpreet

DELHI: India men's hockey team captain Harmanpreet Singh has two Olympic bronze medals in his cabinet, but rues missing out on World Cup glory, an anomaly that he wants to set right in the next edition of the mega event in 2026.

India have till date won three World Cup medals -- bronze in 1971 (Barcelona), silver in 1973 (Amstelveen, Netherlands) and gold in 1975 (Kuala Lumpur) under Ajitpal Singh's leadership.

Harmanpreet, who won back-to-back Olympic bronze in Tokyo and Paris, the second one under his leadership, however, had won the Junior World Cup in Lucknow in 2016.

"The goal will always be to bag Olympic gold and a World Cup



medal. The way we performed in Paris shows that we can compete with top teams and win," Harmanpreet told PTI.

"Our immediate target is next FIH Pro League matches and then win the Asia Cup and qualify directly for the World Cup. A World Cup medal hasn't come for a long time and I want to fulfil that in my career," said Harmanpreet, one the best defenders and drag-flickers of the world right now.

"...Hope we can relive those golden days during our career. We will not surrender till we achieve that," he added.

The 2026 men's FIH Hockey World Cup will be the 16th edition of the quadrennial tournament scheduled to be held from August 15 to 30 in Wavre, Belgium and Amstelveen, Netherlands

From a personal point of view, Harmanpreet wants to better his drag-flick skills and remain fit to prolong his career.

"Drag-flick is getting tough day-by-day and the goal is to work on how to improve myself, bring in more variations and remain fit."

Harmanpreet credits current Indian women's hockey team coach Harendra Singh for shaping his career and believes the $women's \, side \, drag\text{-}flicker \, and \, star \, forward \, Deepika \, is \, in \, good \, hands.$

Sindhu cruises past Hooda to reach Syed Modi final, Lakshya too makes title clash

LUCKNOW: Top Indian shuttlers PV Sindhu and Lakshya Sen cruised to the women's and men's singles finals with dominating victories at the Syed Modi International Super 300 tournament here Saturday.

Top seed Sindhu outclassed the 17-year-old compatriot Unnati Hooda 21-12 21-9 in just 36 minutes in the semifinal, while Lakshya outclassed Japan's Shogo



Ogawa 21-8 21-14 in 42 minutes.

Hooda struggled to challenge Sindhu, committing a series of unforced errors $that allowed \, her \, illustrious \, opponent \, to \, maintain \, control \, throughout \, the \, match.$

"I am happy with today's performance. From the beginning, I maintained the lead. I was just trying out a few strokes and overall, I was confident with the way I was playing," Sindhu, a two-time Olympic medallist, said after the match.

"Unnati played her best, but I didn't give her a chance to overtake me. She is an upcoming player, and I wish her all the very best." A former world champion, Sindhu, currently ranked 18th, will face China's

Wu Luo Yu in the final as she chases her third Syed Modi International title. "I need to go back and prepare for tomorrow because it's not going to be easy. From the beginning, I need to give my best," said Sindhu

Commonwealth Games champion Lakshya, on the other hand, will face Singapore's Jia Heng Jason Teh in the summit clash. India's mixed doubles pair of Tanisha Crasto and Dhruv Kapila advanced

to the final with a convincing straight-game victory over China's Zhi Hong Zhou and Jia Yi Yang. The fifth-seeded Indians secured a 21-16, 21-15 win in the 42-minute semi-

final. They will meet Thailand's sixth-seeded pair Dechapol Puavaranukroh and Supissara Paewsampran. Indian men's doubles pair of Pruthvi Krishnamurthy Roy and Sai Pratheek

K entered final with a 21-17 17-21 21-16 win over fellow Indians Ishaan Bhatnagar and Sankar Prasad Udayakumar. Indian women's doubles pair of Treesa Jolly and Gayatri Gopichand beat

Thailand's Benyapa Aimsaard and Nuntakarn Aimsaard 18-21 21-18 21-10 to advance to the finals. But top seeds Tanisha Crasto and Ashwini Ponnappa missed out of a sum-

mit clash after going down 21-15 16-21 13-21 to China's Bao Li Jing and Li Qian in another semifinals.

In men's singles, second seed Priyanshu Rajawat went down 13-21 19-21 to Singapore's Jia Heng Jason Teh in 48 minutes to end his campaign at the semifinal stage.

Sindhu vs Hooda

Sindhu's semifinal contest saw her gradually take control as she moved to a 5-3 lead with a precise cross-court drop shot, while Hooda initially kept pace with well-placed pushes and drops.

However, the 17-year-old's errors, particularly in the length of her lifts, allowed Sindhu to lead 11-8 at the break.

Hooda's determination to stay in rallies often resulted in smashes and drops going wide.
