day in Kashmir valley.
A top official of Kashmir Power Dis-tribution Corporation Limited (KPDCL)

informed the news agency-Kashmir News Observer (KNO) that from the past more than a month, a huge number of DTs were damaged with some getting repaired immediately while others were taken to the workshops.

"On an average, at least 50 DTs are getting damaged every day. The main reason for the damage to DTs is overloading and using crude heating gadgets,"

the official said. He said, "Most of the DTs were getting damaged in rural areas wherein most of the consumers are unmetered."

Fearing loss of land, farmers oppose proposed Ang-Pahalgam railway line

SRINAGAR: A group of farmers in Anantnag district have appealed to the Jammu and Kashmir government to drop plans to build a railway line connecting the south Kashmir district headquarters with Pahalgam, which also serves as the base camp for the annual Amarnath Yatra.

"Hundreds of acres of agricultural land will turn barren if a railway line is built from Anantnag to Pahalgam. This stretch has one of the most fertile lands in Kashmir which provides livelihoods to thousands of families," Ghulam Nabi, a local farmer, said.

"The proposed Anantnag-Bijbehara-Pahalgam railway line passes through orchards and paddy lands. The railway line will kill the agrarian economy at all places it passes through, he added.

Local MLA and National Conference leader Bashir Ahmad Veerion Sunday met the agitated farmers and promised to convey their fears to the concerned

"I do not understand the purpose of building this railway line. Do they want to dispossess the farmers? Or they want to further shatter our economy? We do not have an industrial area here, and there is no industry

proposed Anantnag-Bijbehara-Pahalgam rail route (77.5 km) have resorted to protests. Concerns have grown, particularly since the issuance of tender for the final location survey of the proposed railway line.

Supreme Court Asks Protesting Farmer Leaders Not To Cause Inconvenience To People

asked Punjab farmer leader Jagjit Singh Dallewal, who is on a fast-unto-death at the Khanauri border point to press for the acceptance of farmers' demands, to persuade the protesting farmers not to obstruct highways and cause inconvenience to people.

A bench of Justices Surya Kant and Ujjal Bhuyan disposed of a habeas corpus petition filed on behalf of Dallewal, who was removed from the Khanauri protest site on the Punjab-Haryana border on November 26.

"We have seen that he has been released and he even persuaded a fellow protestor to end his fast-unto-death protest on Saturday," the bench said, adding that the issue raised by the farmers has been noted by the court and is considered in a pending matter.

"In a democratic setup, you can engage in peaceful protests but do not cause inconvenience to people.



You all know that the Khanauri border is a lifeline for Punjab. We are not commenting on whether the

protest is right or wrong," the bench told advocate Guninder Kaur Gill, appearing on behalf of Dallewal.

Justice Kant said that Dallewal could persuade the protestors to organise peaceful protests under the law and without causing any inconvenience

The bench said that at this stage, it was not entertaining Dallewal's petition but he could approach

Hours before beginning his fast-unto-death on November 26, Dallewal was allegedly forcibly removed from the Khanauri border and taken to a hospital in Ludhiana. He was discharged on Friday evening.

The plea was moved in the apex court on November 29 challenging his alleged illegal detention by the Punjab Police.

On November 30, a day after he was released, Dallewal joined the fast-unto-death at the Khanauri border point to press for the acceptance of the farmers' demands.

Farmers have been camping at Shambhu and Khanauri border points between Punjab and Haryana since February 13 after their march to Delhi was stopped by security forces.

The protesters have accused the Centre of not taking steps to address their demands, claiming that it has not held any talks with them on their issues since February 18.

Besides a legal guarantee for MSP, the farmers are demanding implementation of the Swaminathan Commission's recommendations, pension for farmers and farm labourers, farm debt waiver, reinstatement of the Land Acquisition Act, 2013 and compensation to the families of farmers who died during a previous agitation in 2020-21.

26-Year-Old IPS Officer, On His Way To First Posting, Dies In Road Accident

HASSAN (Karanataka) An IPS officer died in an accident while he was on his way to take up his first posting in Hassan district, police said on Monday.

Harsh Bardhan, (26), was a 2023-batch IPS officer of the Karnataka cadre and hailed from Madhya Pradesh, they said.

The accident took place on Sunday evening, when the tyre of the police vehicle he was travelling in allegedly burst near Kittane in Hassan taluk, following which the driver lost control and the vehicle hit a house and a tree on the roadside, police said. According to police, Bardhan was on his way to Hassan to report on duty as a

probationary Assistant Superintendent of Police in Holenarasipur, police said. Bardhan sustained severe head injuries and died in the hospital during the course of

treatment, while the driver, Manjegowda,

suffered minor injuries, a senior police officer said.The IPS officer had recently completed his four-week training at the Karnataka Police Academy in Mysuru, police said, adding his father is a sub-divisional magistrate. Karnataka Chief Minister Siddaramaiah

offered condolences to the officer's family. "Saddened to hear about the death of probationary IPS officer Harsh Bardhan in

SC Seeks EC's Reply On Plea Against Decision To Increase No. Of Voters Per Polling Station



NEW DELHI: The Supreme Court on Monday sought a response from the Election Commission (EC) on a PIL challenging its decision to increase the maximum number of voters per polling station from 1,200 to 1,500, saying it is "concerned".

A bench comprising Chief Justice of India (CJI) Sanjiv Khanna and Justice Sanjay Kumar asked senior advocate Maninder Singh, appearing for the poll panel, to file a short affidavit explaining the rationale behind the decision.

'Senior advocate Maninder Singh, appearing for the Election Commission, says on instruction that they will explain the position by way of a short affidavit. Let the affidavit be filed within a period of three weeks," the bench said.

It said it was "concerned" and no voter should be excluded.

The EC said political parties are consulted in every constituency when the total number of voters is raised per EVM (electronic voting machine). Singh said voters are always permitted to

cast their votes even beyond the prescribed

The bench has now listed the PIL in the week commencing January 27, 2025, and asked the EC to provide a copy of its affidavit to the petitioner before the next date of hearing.

The PIL, filed by Indu Prakash Singh, has challenged two communications issued by the EC in August increasing the number of voters per polling station in each constituency across India.

Singh has contended that the decision to increase the number of voters per polling booth was arbitrary and not based on any data.

AAP more interested in liquor sales than heath of Delhi citizens: Mandaviya

NEW DELHI: Union Minister Mansukh Mandaviya on Monday slammed the AAP dispensation for not implementing the Ayushman Bharat health insurance scheme and said it is more interested in liquor sales than the health of Delhi's citizens.

The Delhi assembly polls are slated for early next year. The minister's remarks also assume significance as they come a week after the Delhi High Court sought the AAP government's stand on a plea by Delhi's BJP MPs seeking implementation of the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY).

Addressing a press conference here, Mandaviya said it was unfortunate that states like Delhi and West Bengal are not implementing the scheme even after repeated requests by Prime Minister Narendra Modi and letters from the Centre.

"There could be political differences but public welfare works must be prioritised in India's federal democratic set up for the welfare of all," he said. "The government of India has

written to the Delhi government urging it to implement the scheme but the Delhi government is more interested in liquor sales and excise policy. They should

stressed that health services offered under the scheme are constantly monitored to weed out overcharging and waste. It had come to light during his



rather focus on the health of the citizens and for that it is important that the scheme is implemented in the national capital," he said.

Mandaviya added that the Centre has expanded health coverage for all aged 70 years and above irrespective of their income status under AB-PMJAY.

Nothing in the Hands of NC Govt, People's Suffering Continues: Usman Majid

Says Congress' U-Turn on Article 370 is a Betrayal

BANDIPORA: Former Minister and MLA Bandipora, Usman Majid, launched a scathing attack on the National Conference (NC) government during a workers' convention held at the Bandipora Audito-

Criticizing their governance, Majid accused the NC government of failing to address the people's



concerns, claiming that "nothing is in the hands of the NC government," and highlighted their inability to resolve disputes even within their coalition with Congress.

"People didn't vote for footpaths or drains; those are routine tasks managed by departments even during the LG administration's tenure. What they expected was genuine governance and development. This is a surrender of principles and a betrayal of the people's mandate," Majid stated.

Highlighting the limitations of the elected leadership, Majid expressed concerns about the governance structure in Jammu and Kashmir. "The Chief Minister is powerless, while the LG administration holds all significant authority. This undermines democracy and the mandate of the people," he remarked. He urged for reforms to restore power to elected representatives and ensure better governance.

Advocating for grassroots democracy, Majid called for immediate panchayat elections to empower local governance. He asserted that panchayat representatives play a critical role in bringing administration closer to the people and ensuring transparency. "Grassroots governance is the backbone of democracy. Panchayat elections must be held to strengthen the governance model," he added.

On remaining independent, Majid said, "I chose not to join Congress because my priority has always been serving my people. Aligning with any party would have limited my ability to work freely for Bandipora. My mission is to serve, not to seek pow-

Majid also warned against administrative biases and favoritism. "Officials must be impartial and serve the public fairly. Any discrimination against the people of Bandipora will not be tolerated, and I will fight for justice at every level," he asserted.

Encouraging youth participation in politics, Majid said, "The youth must take charge and contribute to the political discourse. Their fresh perspectives and enthusiasm are vital for addressing pressing issues and shaping the future of our region." He urged political parties to shift their focus from empty rhetoric to delivering tangible results.

"People of Jammu and Kashmir deserve leaders who work on meaningful manifestos and deliver on their promises. It's time for better leadership, policies, and results," Majid concluded.

In addition to these services, eShram is connected to the myScheme portal, which helps workers discover and access various government schemes based on their eligibility. This new platform centralises multiple social security schemes, allowing workers to access all the benefits they are entitled to through a single portal. Creating Equal Opportunities: Provisions for Children with Special Needs

n our society, there are children with disabilities, who face discrimination in day-to-day life in the form of negative attitudes. They have certain disabilities which hamper them to act smoothly. The disability would be of any one or multiple types. Actually a large portion of such children are not handicapped completely, but in certain fields and have some special requirements in comparison to normal one. Now these children are not termed as "Disabled Child", but "Child with Special Needs (CWSN)". To ensure that all children enjoy their basic human rights without discrimination, disability inclusion must be mainstreamed in all policies and plans. This applies to education systems also, which need to promote inclusion by ensuring the presence, participation and achievement of all children, including children with disabilities.

Recommendations in NEP 2020

The National Education Policy 2020 has recognised the importance of creating enabling mechanisms for providing Children With Special Needs (CWSN) or Divyang, the same opportunities of obtaining quality education as any other child. Para 6.10 to 6.14 of NEP 2020 deals with the provisions & strategies for such a category of children.

Children with disabilities will be enabled to fully participate in the regular schooling process from the Pre Primary Stage to higher education. The Rights of Persons with Disabilities (RPWD) Act 2016 defines inclusive education as a "system of education wherein students with and without disabilities learn together and the system of teaching and learning is suitably adapted to meet the learning needs of different types of students with

disabilities". This Policy is in complete consonance with the provisions of the RPWD Act 2016 and endorses all its recommendations with regard to school education.

The schools will be provided resources for the integration of children with disabilities, recruit-



ment of special educators with cross-disability training, and for the establishment of resource centres, wherever needed, especially for children with severe or multiple disabilities. Barrier free access for all children with disabilities will be enabled as per the RPWD Act. Schools will work and be supported for providing all children with disabilities accommodations and support mechanisms tailored to suit their needs and to ensure their

full participation and inclusion in the classroom. In particular, assistive devices and appropriate technology-based tools, as well as adequate and language-appropriate teaching-learning materials (e.g. textbooks in accessible formats such as large print and Braille) will be made available to help chil-

 $dren\,with\,disabilities\,integrate\,more$ easily into classrooms and engage with teachers and their peers. This will apply to all school activities including arts, sports, and vocationaleducation. High-quality modules will be developed to teach Indian Sign Language. Adequate attention will be paid to the safety and security of children with disabilities.

As per the RPWD Act 2016, children with benchmark disabilities shall have the choice of regular or special schooling. Resource centres in conjunction with special educators will support the rehabilitation and educational needs of learners with severe or multiple disabilities and will assist parents/guardians in achieving high-quality home schooling and skilling for such students as needed. Home-based education will continue to be a choice available for children with severe and profound

disabilities who are unable to go to schools. The children under home-based education must be treated as equal to any other child in the general system. While it is clear that the education of all children with disabilities is the responsibility of the State, technology-based solutions will be used for the orientation of parents/caregivers along with wide-scale dissemination of learning materials to enable parents/caregivers to actively support their

children's learning needs will be accorded priority.

Most classrooms have children with specific learning disabilities who need continuous support. The earlier such support begins, the better the chances of progress. Teachers must be helped to identify such learning disabilities early and plan specifically for their mitigation. Specific actions will include the use of appropriate technology allowing and enabling children to work at their own pace, with flexible curricula to leverage each child's strengths, and creating an ecosystem for appropriate assessment and certification.

The awareness and knowledge of how to teach children with specific disabilities (including learning disabilities) will be an integral part of all teacher education programmes, along with gender sensitization and sensitization towards all under-represented groups in order to reverse their underrepresentation.

Provisions under Samagra Siksha

In Samagra Shiksha, the centrally sponsored Integrated Scheme for School education, there are interventions for inclusive education of CWSN children. The programmatic as well as financial norms of the scheme are being modified in alignment with provisions of NEP 2020.

The key thrust of the programme will be on providing inclusive education to all children with special needs in general schools and funding will be based on data of CWSN provided under UDISE+. The Programme will also support special training, education through an open learning system, home schooling, wherever necessary, itinerant teaching, remedial teaching, community based rehabilitation (CBR) and vocational education.

Support for CWSN children as defined in RPWD Act 2016 will be available from ECCE classes in Govt.

primary schools to Sr. Secondary level. Resource centres (provision of TLMs) in conjunction with special educators will support the rehabilitation and educational needs of learners with severe or multiple disabilities and will assist parents/guardians in achieving high-quality home schooling and skilling for such students as needed. Block Resource Centers (BRCs), with online/offline facilities of special educators, can also act as Resource centres for learners with severe or multiple disabilities. Provision for Home-based education (HBE) will be available for children with severe and profound disabilities who are unable to go to schools.

In Samagra Shiksha, there will be provision of up to Rs. 3500/- per child, per year for children with special needs, studying in government, government aided and local body schools as per specific proposal. This will include aids and appliances, teaching material, etc. Provision of special educators at cluster/school level as per requirement would be done. The special educators should be qualified and registered with the RCI. Provision of stipend for CWSN girls @ Rs. 200/- per month for 10 months, for pre-primary to senior secondary would be made.

With the spread of inclusive education for CWSN, a positive change can be seen in the people concerned, the family as well as the society. The access to education and provision of proper resource support has helped these marginalised sections of the society to lead a better and fulfilling life. In addition to the government, the family as well as society should come forward for universalization of education for each and every CWSN child, which in true sense will lead to a "Samriddh, Samarth and Sashakt Bharat".



hen the gland over-activates and produces too much thyroid hormone, it can cause health problems in metabolism, bone health, and nervous, reproductive, and cardiovascular systems. In this article, you'll learn how to eat a healthy and balanced diet to maintain health in hyperthyroidism.

Thyroid hormones and functions

The thy roid gland secretes the hormones Thyroxine(T4) and triiodothyronine (T3) to the bloodstream. These hormones go to cells and control how your body uses energy. However, too much of thyroid hormones speed up metabolism and affect the entire body, including:

Cardiovascular system. Thyroid hormones help regulate cardiac output (the amount of blood your heart pumps in a minute), heart rate, and strength. Irregular and rapid heartbeat is only one symptom of hyperthyroidism.

Digestive system. The thyroid helps modulate bowel movements. Hyperthyroidism may increase bowel movement resulting in diarrhea.

Reproductive system. Hyperthyroidism negatively impacts the reproductive system, especially in women. An imbalance in thyroid hormone levels may result in irregular menstrual cycles and fertility

Bone health. The thyroid hormone is one of the determinants of bone synthesis. Too much thyroid hormone increases the rate of bone loss resulting in weaker bones or bone diseases such as osteoporosis.

Nervous system. In fetal development, thyroid hormone functions in the brain and nervous system develop. Thyroid problems may cause numbness, tingling, anxiety, nervousness, and irritability.

What causes hyperthyroidism

There are several causes of hyperthyroidism: Graves' disease, an autoimmune thyroid disorder, is the most common cause.

Nodules in the thyroid gland.

Thyroid gland inflammation is called thyroiditis. Excess iodine consumption. Iodine is essential for producing thyroid hormone, but too many results in increased thyroid hormones.

Thyroid medicine. If people with hypothyroidism (underactive thyroid) take too much thyroid medicine, their thyroid may get overactive.

Who's at risk for hyperthyroidism?

Certain conditions increase the risk of hyperthyroidism:

Having a family member with hyperthyroidism Being female

Being older than 60

Excess iodine intake or use of medication contains

Having had goiter (enlarged thyroid) or thyroid

Having pernicious anemia — a condition that occurs when the body lacks vitamin B12

Common symptoms of hyperthyroidism

Thyroid hormones affect your heart, brain, gut, reproductive organs, and bones. Too much may cause symptoms, including:

weight loss (despite having no issues with appetite and nutrition)

muscle weakness

nervousness or irritability mood swings

abnormal bowel movements

swollen thyroid gland fertility problems

irregular and rapid heartbeat

Diagnosis and Treatment of Hyperthyroidism

If you suspect having hyperthyroidism, schedule an appointment with your physician. Your doctor can diagnose the condition easily with a blood test for hormones, antibodies, and thyroid scans.

Medication, radioiodine therapy, and thyroid surgery are common treatments. Your physician and/or endocrinologist will choose the appropriate course of action based on your age, hyperthyroidism type, other health problems, and any allergies.

Nutrition for managing hyperthyroidism

There are no specific foods, diets, or supplements to treat thyroid diseases. However, sufficient levels of the micronutrients iron, selenium, iodine, and zinc are crucial for maintaining proper thyroid health. That's why it is important to choose healthier foods to match your nutritional needs.

The National Health Service recommends:

Eating five portions of fruit and vegetables daily Eating high-fiber foods — whole grains, beans, legumes, fruit, and vegetables

Choosing unsaturated fats over saturated and

Staying hydrated

Consuming dairy products

Avoiding foods with added sugars Eating antioxidant-rich foods

Eating enough protein — meats, eggs, beans,

Eating healthy fats — unsaturated fats, nuts Overall, eating a healthy and balanced diet provides your body with the nutrients it needs. However, dietary supplements can be used in cases of poor nutrition or nutrient deficiencies. Consult

with your doctor before taking supplements to avoid negative effects on thyroid function.

The best foods for hyperthyroidism Calcium, phosphorus, and vitamin D

Hyperthyroidism may cause weaker bones and osteoporosis. Calcium, phosphorus, and vitamin D are essential nutrients for bone health. Therefore, people with hyperthyroidism should eat foods rich

Calcium: dairy products, green leafy vegetables. Phosphorus: dairy products, meat, seafood, legumes, and nuts.

Vitamin D is found in oily fish and egg yolk in limited amounts. Sun is a major source of vitamin

Selenium

Selenium is found in the thyroid gland. It maintains thyroid hormone synthesis. In some cases, selenium supplementation is used to treat mild thyroid eye diseases. More research is needed to determine the effectiveness of selenium supplementation in preventing or curing thyroid diseases.

Doctors recommend eating foods rich in selenium, including nuts (especially Brazil nuts), fish, shellfish, white meats, lentils, and beans. Selenium supplementation shouldn't be taken without doctor approval since excess amounts of selenium may cause health problems such as nausea, diarrhea, fatigue, and irritability.

Foods rich in antioxidants

Graves' disease, an autoimmune thyroid disorder. is the most common cause of hyperthyroidism. With Graves' disease, the immune system makes the antibodies that stimulate the thyroid cells. As a result, thyroid hormone production increases.

Antioxidant foods help modulate the immune system. Thus, an increased intake of colorful fruits and vegetables - orange, red, yellow, and green are recommended.

Quality protein

Muscle problems and weight loss as a result of increased metabolic rate are common symptoms of hyperthyroidism. Eating high-quality protein in adequate amounts is crucial to maintaining muscle mass and function. Protein sources include meat, egg, dairy products, lentils, and beans.

Cruciferous vegetables

In theory, cruciferous vegetables such as kale, cauliflower, and turnips are rich in compounds that inhibit iodine usage of the thyroid resulting in lower thyroid hormone production. However, there is no scientific data specifying the ideal amount of cruciferous vegetables needed for decreasing thyroid hormone production.

Foods to avoid with Hyperthyroidism

Iodine-rich foods

Iodine is needed for synthesizing thyroid hormones. Our bodies can not produce iodine, so it must be supplemented by foods.

In some cases, excess iodine intake results in increased thyroid hormone synthesis. Thus, eating foods high in iodine may awaken or worsen the symptoms in people with hyperthyroidism. Foods high in iodine include:

Seaweeds include kelp (brown seaweed), dulse, and nori. A gram of seaweed contains around 2 mg of iodine — when scientists state that 1.1 mg/day is a safe upper limit.

Seafood — sea fish and shellfish. Saltwater fish.

Cow's milk and dairy products.

Iodine-fortified foods — some cereals, vegan milk, salt. According to UNICEF, almost 90% of the world's population consumes iodized salt. One teaspoon of iodine-fortified salt contains 284 micrograms of iodine.

Don't forget to check the label for iodine if you use medication, multivitamins, or other dietary

Excess iodine can harm people with Graves' disease or other autoimmune thyroid disorders. On the other hand, iodine deficiency may cause pregnancy-related problems, hypothyroidism, and goiter — an enlargement of the thyroid.

If you have a healthy thyroid or your doctor advises otherwise, you need a daily intake of 150 micrograms of iodine. Pregnant and breastfeeding women need more iodine because thyroid hormone is required for the baby's bone and brain development.

Caffeine can accelerate the symptoms like rapid heart rate, anxiety, nervousness, and irritability. Thus, avoiding food or drinks containing caffeine, such as coffee, tea, soft drinks, cacao, and some supplements, is recommended.

People with hyperthyroidism should eat enough calories from nutritious foods. They are advised to avoid iodine-rich foods and low-calorie and protein

Please be aware that other thyroid disorders may cause hypothyroidism (underactive thyroid) or don't affect thyroid hormone production (euthyroidism). In these cases, proper nutrition will be slightly different.

Lastly, always consult with a healthcare professional to decide what foods to eat or avoid the management of your hyperthyroidism and symptoms.

The dry weather, combined with vehicular emissions and the use of heating devices, has caused a surge in respiratory illnesses. Srinagar's Air Quality Index (AQI) recently reached 183, labeled as "Unhealthy," with PM2.5 levels at 119.7 μ g/m³—far above safe limits. "We are seeing a sharp increase in respiratory problems among children and the elderly due to prolonged exposure to polluted air," said Dr. Naveed Nazir, a senior pulmonologist at the Chest and Disease Hospital in Srinagar.

Winter tourism, a cornerstone of Kashmir's economy, is reeling under the impact of insufficient snowfall. "Destinations like Gulmarg are seeing fewer visitors, and if this trend continues, it will significantly harm our local economy," noted Fayaz Ahmad, a hotelier in Gulmarg.

Faced with the mounting challenges, many residents are turning to prayers, seeking relief from the unrelenting dry spell. "We are praying for snow not just for the beauty of winter but for the survival of our livelihoods and ecosystems," said Ghulam Nabi, a farmer from Anantnag.

The crisis calls for the urgent need for climate-resilient policies in agriculture, sustainable energy management, and improved pollution controls to protect the valley's fragile ecosystem and its people.

Siraj Finds Joy In His Bowling Again As The Wickets Follow

ohammed Siraj, who endured a difficult home season, where he only played four of their five Tests for a total of six wickets, is in Australia after a little bit of an epiphany.

"I could feel that I wasn't enjoying my bowling," he said at the end of the tour game against the Prime Minister's XI in Canberra on Sunday. "As a person I am someone who gets a different feeling when I'm enjoying my bowling, even if I'm not getting wickets. And now when I wasn't getting wickets, I went a bit deep into why I wasn't getting them. In India you know that spinners bowl most of the overs, so there it's a little tough to get wickets in [the] five-six overs [you get as a fast bowler]. So I just became a bit upset about why I wasn't getting wickets. But now I am having a lot of fun."

Even though its only been one match in the Border-Gavaskar Trophy, Siraj is already closing in on his wickets tally over the last three months, having picked up five in Perth. He checked in with former India bowling coach Bharat Arun to help find his centre.

"Ispoke with Bharat Arun sir, that this is what's happening with me," Siraj said. "Because he has known me for a while and he has seen my bowling from long time back. So he just told me to enjoy and not run after wickets. Just enjoy and you'll get wickets. And before travelling, I met [fielding coach] Dilip sir in Hyderabad and we practiced together as well. So it felt good and now I'm enjoying.

"Morne [Morkel, India's current bowling coach] keeps telling me that 'you are a warrior'. 'You'll get us wickets, but you just keep enjoying your bowling'."

Jasprit Bumrah took the honours in Perth but Siraj and Harshit Rana, who took four wickets in six balls at the Manuka Oval bowling short-pitched deliveries, helped keep the pressure up from the other end and they will be looking to do that again in Adelaide with the series resuming next Friday with a day-night Test.

"Ialways keep talking to Jassi bhai [Bumrah]," Siraj said. "Even before the first match, I spoke with himabout what I was going through. And he just told me one thing-don't run after wickets, just keep bowling consistently in one area and enjoy your bowling. If you still don't get wickets, then you come ask me. So I enjoyed my bowling and I got wickets as well.

"Australia is a place where a fast bowler enjoys because you get pace and bounce. As a fast bowler, you get everything you want. So you get a different kind of confidence to come and enjoy your bowling here."

Mehidy to lead Bangladesh in West Indies ODIs, Shakib continues to miss out

ehidy Hasan Miraz will continue to lead Bangladesh in regular captain Najmul Hossain Shanto's absence in the ODI series against West Indies. Mehidy was named captain for the ongoing two-Test series in the Caribbean, which the hosts are leading 1-0, with Shanto missing out due to groin strain. Shakib Al Hasan, who has not played for Bangladesh since the Tests in India, continues to miss out, with BCB president Faruque Ahmed saying the senior allrounder was not "in a mental state to play for the country".

Middle-order batter Towhid Hridoy also misses out due to a groin injury which he picked up while playing football recently. Mushfiqur Rahim also misses out as he recovers from finger injury, while Mustafizur Rahman has opted out



of the series due to personal reasons. Left-handed opener Zakir Hasan, meanwhile, has been dropped. Litton Das, who missed the ODIs against Afghanistan in November, returns to the side, while Parvez Hossain Emon, Afif Hossain Dhrubo, Hasan Mahmud and Tanzim Hasan Sakib have also been included.

Shakib, who retired from Tests and T20Is in September, missed the ODIs against Afghanistan last month too. He was part of the Abu Dhabi T10 where he played seven matches for Bangla Tigers. He had not traveled to Dhaka to play his farewell Test, against South Africa, in October because of protests against him after being named in an FIR for an alleged murder during the political unrest in the country.

BCB president Ahmed said Shakib remained in contention for selection in ODIs, adding that he needed sufficient preparation to get back into the national side.

"Right now, he [Shakib] is still in the list," Ahmed said. "We hope that the issues get solved in the way he wants. Definitely, he still possesses the capability to play for the national team. Playing for a franchise and playing for the country is not the same thing. You need preparation and also you really need to gel with the team. Since he can't do those things, I don't think he is in a mental state to play for the country. Because of that, we have left this thing up to him."

The players named for the ODIs will leave Dhaka on Monday to link with the rest of the players in St Kitts to play the three ODIs on December 8, 10 and 12.
