SRINAGA: Counter Intelligence Kashmir (CIK) and the Special Investigation Agency (SIA) Kashmir of Jammu and Kashmir Police jointly conducted searches at Central Jail, Srinagar in a terror-linked case. Several digital devices, including mobile phones, were recovered during the operation.

The searches were conducted under a search warrant issued by the Court of Special Judge, Designated under NIA Act, Srinagar, in case FIR No. 06/2023 under sections 153-A, 505, 121, and 120-BIPC read with sections 13 and 39 UA(P) Act.

The case pertains to a conspiracy involving proscribed terrorist organizations operating within Jammu and Kashmir and across the Line of Control (LoC, in collaboration with Pakistani agencies. These organizations are allegedly working with their **Over Ground**

Minimize Distress Cuts In Power Supply: CM Omar

Unveils monitoring tool to streamline power curtailments in J&K

JAMMU: Chief Minister Omar Abdullah chaired a comprehensive review meeting of the Power Development Department (PDD) at the Civil Secretariat today.

The meeting focused on addressing power supply challenges, curtailment schedules,

revenue realization, and strategies for improving the efficiency of the power sector during the peak winter season.

In his remarks, the Chief Minister emphasized minimizing distress cuts so that public begins to trust the schedule of power cuts notified by the power development department.

"Deviations from announced curtailment schedules must be kept to an absolute bare minimum. While people are ready to accept planned curtailments, unexpected and prolonged power cuts are difficult for them to tolerate," he stated.

He reiterated the need for a clear and reliable curtailment program, stressing that distressed curtailments should be rare and well-communicated.

India-China ties **De-escalation**, management of activities in border areas to be discussed in coming days: Jaishankar

NEW DELHI: Peace and tranquility in border areas is a pre-requisite for the development of bilateral ties with China and the two side will be discussing deescalation and effective management of activities in these areas in the coming days, External Affairs Minister S Jaishankar said on Wednesday while making a statement on India-China relations in the RajyaSabha.

A brief uproar was also witnessed following the statement and Opposition MPs walked out of the House after Chairman Jagdeep Dhankhar, disallowed them from seeking some clarifications.

Jaishankar, while making a statement



on "Recent Developments in India's Relations with China", also said disengagement has now been achieved in full in eastern Ladakh through a stepby-step process, culminating in Depsang and Demchok. He had earlier made an

identical statement in the LokSabha on Tuesday.

Jaishankar, in his statement, said India was and remains very clear that the three key principles must be observed in all circumstances, he said explaining: "one: both sides should strictly respect and observe the Line of Actual Control (LAC), two: neither side should attempt to unilaterally alter the status quo, and three: agreements and understandings reached in the past must be fully abided by in their entirety".

SC To Consider Modifying Orders That Barred HCs From Hearing Coal Block Allocation Cases

NEW DELHI: The Supreme Court Wednesday said it would consider pleas seeking modification of its earlier orders that barred high courts from hearing appeals against trial court orders passed in cases related to alleged illegal coal block allocations.

The apex court passed two orders between 2014 and 2017 restricting the accused from approaching the high court and had directed that appeals against trial court proceedings in the coal scam cases could only be filed in the top court.

The intent behind the orders was to expedite trial processes by preventing delays and to stall the proceedings by the accused seeking relief in high courts.

A bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar was considering pleas that urged it to modify the orders saying the Delhi High Court, being the appellate court, be allowed to deal with the pleas arising out of trial court orders related to coal scam cases.

"Is this the stand of the CBI that everything should come to us?" the CJI asked senior advocate R S Cheema who is conducting trial in CBI cases as a special public prosecutor.



"We also want to have the benefit of Delhi High Court orders passed in these cases," the bench said.

Senior advocate Mukul Rohatgi, appearing for a litigant, said the high court cannot be restrained from hearing appeals and the pleas seeking discharge in the cases. Lawyer Prashant Bhushan, appearing for NGO

'Common Cause', said the orders were passed to ensure that the trial does not get impeded by the accused by moving the high court against interlocutory orders passed by the trial court.

The bench said since the orders were passed by a three-judge bench, let it be listed before a bench of the same strength in the week commencing January 15, 2025.

The top court in 2014 quashed 214 coal blocks allocated by the Centre between 1993 and 2010 after taking note of the PILs and ordered a trial by a special CBI judge.

The bench had directed that any prayer for a stay or to impede the investigation or the trial could only be made before the Supreme Court, effectively barring other courts from entertaining such pleas.

Another bench headed by Justice Abhay SOka had earlier issued a notice to the Enforcement Directorate seeking clarification on whether the bar imposed by its earlier decision - restricting any prayer for a stay or impeding the progress of investigation/

trial in Coal Block Allocation cases to the top court alone - also applies to complaints filed under the Prevention of Money Laundering Act (PMLA).

It was submitted whether the bar outlined in earlier orders needed clarification, particularly whether it extends to cases under the PMLA linked to the coal block allocation scam.

The CBI filed 57 cases in the coal scam. Several consequential money laundering cases were also filed.

Fadnavis Elected Leader Of Maharashtra **BJP Legislature Party;** Set To Become CM

MUMBAI: Devendra Fadnavis was unanimously elected as the Maharashtra BJP legislature party leader at its meeting here on Wednesday, paving the way for his appointment as the chief minister



The swearing-in ceremony will be held in Mumbai on Thursday in the presence of Prime Minister Narendra Modi. Fadnavis' name was finalised for the top post at the BJP's core committee meet held here ahead of the legislature party meeting, sources said.

Bharatiya Janata Party (BJP) leader Sudhir Mungantiwar said leaders of the Mahayuti coalition will meet Governor C P Radhakrishnan at 3.30 pm on Wednesday to stake a claim to form government.

Union minister Nirmala Sitharaman, former Gujarat Chief Minister Vijay Rupani were present at the BJP legislature party meeting held at the Vidhan Bhawan in Mumbai.

The BJP had appointed Sitharaman and Rupani as central observers for the meet.

The BJP achieved remarkable success in the November 20 Maharashtra elections, securing 132 out of the 288 assembly seats in the state, marking its best performance in the state so far.

Together with its allies – the Shiv Sena led by Eknath Shinde and Ajit Pawar's NCP, the BJP-led Mahayuti coalition has a commanding majority of 230 seats.

On Tuesday, Fadnavis met caretaker Chief Minister Eknath Shinde at his official residence, 'Varsha,' here, the first inperson meeting since their discussions in Delhi last week for government formation.

While the hour-long meeting's details remain unclear, some political observers view it as an outreach effort by the BJP to placate an ally which is weighing its options, while others believe it served as a preliminary discussion regarding the swearing-in ceremony set for December 5.

Preparations were on in full swing for the swearing-in ceremony to be held on Thursday at the Azad Maidan in south Mumbai, which will be attended by Prime Minister Narendra Modi, as well as nearly 2,000 VVIPs and 40,000 supporters.

Several Union ministers, and 19 chief ministers and deputy CMs of various states are also expected to attend the ceremony.

BJP leader Prasad Lad has said the ceremony will be a "historic moment" for Maharashtra.

"The event will be telecast live across the state wherever LED screens are available." he said.

There are indications that the distribution of portfolios among the three allies might not be a smooth process.

Sena leaders on Monday said that as per the "convention" of alliance politics, their party should get the home portfolio if the CM post went to the BJP.

A Shiv Sena leader also said a broad consensus has emerged among top BJP leaders and other Mahauti allies to drop ministers facing serious allegations of corruption in the new government.

The money laundering probe stems from two FIRs filed by the Economic Offences Wing(EOW) of the Delhi Police that were registered to probe charges of cyber fraud to the tune of Rs 640 crore generated through betting, gambling, part-time jobs and phishing scams, the agency said in a statement.

The money of gullible people was "siphoned off" by layering funds cheated from them through more than 5,000 "mule" Indian bank accounts and cryptocurrencies have been recovered and are being analysed.

A fourth person has been arrested by the Delhi Police as part of this investigation.

Radhe Shvam Sharma, brother of "main accused" CA Ashok Kumar Sharma, was taken into custody by the police from a farmhouse in Delhi for "attacking and restricting with force" the ED team from entering the premises.

Some "incriminating" documents, chequebooks, ATM cards, PAN cards, digital signatures and Trust secret phrases used to open secret crypto wallets have also been seized, the ED said.

Rakesh Tikait detained by Aligarh Police on way to **Greater Noida for** farmers' protest

ALIGARH: BKU leader Rakesh Tikait was detained by the Aligarh Police on Wednesday while on his way to Greater Noida to participate in a meeting of farmer leaders, a police official said.

The Bharatiya Kisan Union's influential spokesperson and his associates were taken to the Tappal police station in a bus after they were stopped from proceeding on the Yamuna Expressway.

When contacted, an official spokesman of the Aligarh Police confirmed that Tikait had been "detained" but "not arrested".

Tikait told reporters that the police were preventing farmers from going to Noida in Gautam Buddh Nagar by forcing them to stay in their respective houses.

"How long will you detain us? If you keep us locked, then with whom will you talk?" he said.

He warned that if this approach of the authorities continued, the agitation of the farmers would intensify.

The BKU had on Tuesday convened an emergency meeting at the Kisan Bhawan in Sisauli village of Muzaffarnagar under the leadership of its chief Naresh Tikait and resolved to extend support to the farmers in Noida and Greater Noida who are agitating over the issue of land compensation and other demands.

The BKU had called on its workers and memhers from western Uttar Pradesh districts to gather at the Zero Point in Greater Noida on Wednesday, according to the union's youth wing president Anuj Singh. Meanwhile, hundreds of protestors from

'Tribunal can't outsource opinion, base decision on it': SC rejects NGT order

NEW DELHI: A tribunal has to arrive at its decision by considering all facts and circumstances, and cannot outsource an opinion and base its order on it, the Supreme Court has said and rejected an NGT order.

While hearing the appeals challenging a April 2021 order of the National Green Tribunal (NGT), a bench of Justices B R Gavai and K V Viswanathan said the tribunal

committed a "glaring error" as it based its decision only on the basis of the report of a joint committee.

"A tribunal is required to arrive at its decision by fully considering the facts and circumstances of the case before it. It cannot outsource an opinion and base its decision on such an opinion," the bench outlined.

The apex court therefore set

aside the NGT's order, which had held a firm guilty of violating the Environment Protection Act norms and imposed a penalty on it.


The top court observed the NGT initially directed the firm's plant to be examined by the state pollution control board, which gave its findings and then the tribunal appointed a joint committee, on whose recommendations it acted and passed the order.

"Another glaring error that has been committed by the NGT is that it has based its decision only on the basis of the report of the joint committee. The NGT is a tribunal constituted under the National Green Tribunal Act of 2010," said the bench in its November 27 verdict.

While observing the material on record,



the top court noted the firm was neither made a party to the proceedings before the NGT nor before the joint committee, and when it filed an application for impleadment, the tribunal rejected it."It further appears that even the joint committee appointed by the NGT neither gave any notice to the appellant nor an opportunity was given of being heard," observed the bench.

Over 30.42 crore unorganised workers have registered on the eShram portal, an initiative by the Government of India designed to support the unorganised workforce. To expand the range of benefits, the eShram portal has been integrated with several government schemes, enabling workers to access a variety of social security services. One of the key features of eShram is its integration with the National Career Service (NCS) Portal, allowing unorganised workers to register using their Universal Account Number (UAN) and search for job opportunities. Additionally, eShram is linked to the Pradhan Mantri Shram Yogi Maandhan (PM-SYM) pension scheme, which offers a monthly pension of ₹3,000 to workers aged 18-40. The government contributes 50% of the scheme's funding, making it an affordable option for workers. Moreover, eShram's integration with the Skill India Digital Portal provides unorganised workers with access to skill development and apprenticeship opportunities, enhancing their employability. In addition to these services, eShram is connected to the myScheme portal, which helps workers discover and access various government schemes based on their eligibility. On October 21, 2024, the Ministry of Labour and Employment launched eShram as a One-Stop-Solution for unorganised labour, aligning with the recent budget announcements. This new platform centralises multiple social security schemes, allowing workers to access all the benefits they are entitled to through a single portal. Currently, 12 central schemes are integrated, including Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY). Ayushman Bharat, and PM Awas Yojana, among others. This integration of various welfare schemes through eShram is a significant step toward providing unorganised workers with easier access to government services and financial security, reinforcing the government's commitment to their well-beina.



Improved paediatric asthma care is possible

WASHINGTON: Improving paediatric asthma care is possible, a new research has found. According to a University of Connecticutstudy, improved personalised inpatient assessments can enhance the accuracy of the prescribed asthma therapy, a child receives.

Paediatric asthma is the most common chronic childhood condition and one of the leading causes for paediatric hospital admissions.

Asthma can be severely disabling and even deadly. Asthma kills more than 3,600 people annually including several hundred children. It also leads to more than 300,000 adult and over 136,000 paediatric hospitalisations annually.

"The key to caring for paediatric asthma patients is that the most appropriate medication at the right dosage must be prescribed, and the child has to take their medication every day," said Dr. Alexander Hogan who led the quality improvement study.The study showed the quality of asthma care improved after clinicians were equipped with streamlined patient care decision tools, an electronic medical record system, and access to a mobile phone application to guide each patient's personalized care.

One important decision-making tool was

requiring physicians to ask each patient six key asthma control questions:

1. Number of asthma symptoms per week? 2. Number of night-time awakenings per month?

3. Inhaler use for symptoms per week? 4. What is the degree of asthma's interference with your normal activity? 5. Number of asthma exacerbations requiring

oral corticosteroids in the last year? 6. How many doses per week are you missing of your current controller therapy?

The study demonstrated the effectiveness of asking these key questions. The study

improved the frequency of asking the questions

from 40 to 98 percent and increased the many others. accuracy of the medications prescribed up to 80 percent in one year.

Hogan adds, "Our study findings show small changes truly do add up. If you are concerned your child's asthma is not well controlled, it is imperative you raise these concerns with your paediatrician."

People with asthma persistently suffer from airway inflammation and constriction due to various irritants. Irritants that inflame the lungs are called triggers.

Asthma triggers include: pollen, viruses, cigarette smoke, dust mites, pollution, cockroaches, exercise, mold, pet dander among

Some children with asthma have mild disease needing a rescue inhaler once in a while. However, children with persistent asthma need to use a daily asthma controller medication, such as an inhaled corticosteroid, to prevent asthma attacks.

Inhaled corticosteroids taken everyday decreases the chronic inflammation found in asthma. These medications have been proven to decrease the frequency and severity of asthma exacerbations.

They also have been shown to decrease missed days of school, emergency room visits and hospital admissions.

Sugary treats: Avoiding sugary treats might not be as easy as it sounds but you must do it for your health. Consuming excessive sugar can cause an imbalance in the gut microbiome which can affect the mood to a great extent. Therefore, moderate consumption must be ensured.

Gluten: One does not necessarily have to suffer from gluten intolerance or gluten allergy to follow a gluten-free diet. Although more research is required to back the claim, some studies have shed

light on the link of gluten to an increased instance of deteriorated mental health. Therefore, it is advised to limit its consumption in the daily diet. Some common sources of gluten include wheat, cereals, pasta, etc.

French fries: Trust us, we know how delicious french fries are, but we also know that they might not be the healthiest food choice. French fries are fried foods that are loaded with salt. Upon consumption, it can easily lead to an unhealthy intake of salt and oil. It is a source of trans fat which is also known for increasing the risk of depression.

White rice: Consuming refined carbohydrates can increase the risk of depression and rice is a popular source of the same. In a country like India where rice is one of the staple foods, it might not be easy to eliminate it from the diet.

VARICOSE **VIENS MAY INCREASE RISK OF BLOOD CLOTS**

Adults with varicose veins -- gnarled, enlarged veins, most commonly appearing in the legs and feet -- may be at increased risk of suffering from a blood clot that could lead to vascular diseases, a study has found.

The study found people with varicose veins were at five times increased the risk of developing a deep venous thrombosis (DVT) -- a clot in the legs which can lead to amputation or even death, the Daily Mail reported.

They were twice as likely to develop a pulmonary embolism -- a clot which travels into the lungs and can be deadly.

They also had double the risk of peripheral arterial disease, which reduces blood flow to the arms and legs

The study led by researchers including Pei-Chun Chen, a doctoral student from China Medical University in Taiwan, examined 212,984 patients aged 20 years and older with varicose veins, and a control group of equal patients without varicose veins.

The results, published in the journal JAMA, showed that among adults diagnosed with varicose veins, there was a significantly increased risk of incident DVT.

Varicose veins occur when the valves in the veins break down, allowing blood to flow backward and collect at certain points.

The condition is more likely to affect the elderly as age causes the skin to lose elasticity and valves in veins to weaken.

They are also linked to pregnancy as gestation causes the volume of blood in the body to increase but reduces the flow from the legs to the pelvis. Obesity and a family history of the condition also increase the risk.

Menstrual periods: 5 ways to outsmart period time food craving; what to eat and avoid

t's the time of the month, they say. Some even cast insensitive jokes by giving pre-menstrual syndrome a wrong name -- PMSng is a term that is also used in an impolite way to speak of someone's loss of temper or behaviour of irrationality.

When your periods arrive, do you usually dig into tubs of your favourite ice cream or bags of salty snacks... simultaneously binge-watching that new, old-timey romantic series can seem very comforting?

It's common to have cravings during or after your period. A study titled "Differential associations between ovarian hormones and disordered eating symptoms across the menstrual cycle in women" carried out in Michigan (USA) looking into this aspect found that progesterone, a hormone that is at its peak just before your period, and that explains why the bigger appetite and increased hunger.

Why the need for comfort food? Did you know that women find themselves face to face with upto 150 types of symptoms of premenstrual symptoms (PMS) ranging from physical to emotional to behavioural to cognitive? These symptoms are triggered by hormonal fluctuations and how they affect chemical messengers in the brain called neurotransmitters.

Sciencealert.com says that food cravings are up there with the most commonly reported behavioural PMS symptoms, along with mood swings, irritability, anxiety and tension, and sad or depressed mood. The symptoms usually get resolved around the third or fourth day of menstruation.

Beware of slipping off the fitness bandwagon:

Cleveland Clinic Ob/Gyn Dr Cristina McClure, DO, says that your period snacking go-to's have the potential to cause a number of problems. It's important to sort out the matter during

"Foods that are really sugary and sweet will increase your insulin levels, and high insulin levels can cause imbalances in other female-factor hormones. That's why you want to follow a low glycemic diet starting at least a



the days preceding the periods so that you make good food choices during this time. Redefine the "good stuff" first:

Periods can be difficult to tackle and that can show on your mood and the choices you make. When you're cramping and irritable, you just know that a doublecheese pizza or a box of chocolate eclairs or a hot fudge brownie sundae with extra fudge, nuts and whipped cream will make everything better. Most of these foods are carbohydrates and fat-laden.

Eating carbs is an activity that turns up levels of serotonin, a neurotransmitter in the central nervous system, which contributes to a general sense of wellcouple of weeks before your expected period," says Dr McClure.

If you eat a lot of carbs and sugar during your period, you might feel bloated or backed up. Women with the polycystic ovarian syndrome (PCOS) might experience irregular periods which could lead to other complications. But when your blood sugar levels are going up and down, Dr McClure says you might feel tired or get headaches frequently.

According to Dr McClure, start building up your iron levels a week or two before your cycle to increase your blood counts. But cook those iron-rich foods well to avoid inflammation. Stock up

healthy foods in the fridge and jars. Cook if you can. It's therapeutic. Avoid shopping for or ordering food when the blues hit.

What food to eat:

Whole grains: Have you tried preparing a bhel (salad) out of sprouted grains? Take some raw sprouts or boiled sprouts. Add chopped tomatoes, onions, squeeze lemon juice, add a pinch of salt. Or boiled corn with very little butter but more condiments and lemon juice? Avoid too much salt, though, as it can add to water retention and bloating.

More complex carbs: Whole wheat toast can provide us with the B vitamins thiamin, riboflavin, and niacin. Complex carbohydrates also provide us with fibre, which helps with bloating and constipation and helps us feel full with fewer calories.

Berries: Stock up on dark berries. Dr McClure says blueberries, blackberries, strawberries, raspberries and cherries are great sources of antioxidants. If you are craving fruits, choose low-glycemic options such as berries, cherries, grapefruits, pears, green apples.

Pumpkin seeds: This can be a moodlifter that can naturally increase our serotonin levels due to the high levels of tryptophan. Pumpkin seeds can easily be tossed into salads, smoothies or eaten as a snack. Have a salad that has melon pieces. Melon is made mostly of water and is a natural diuretic, which means it can help cure that puffy feeling you get during your period. It also contains a compound called Cucumis melo, a diuretic that helps flush excess fluid from the body.

Home-made Popcorn: It's a wholegrain food, for God's sake. Try sprinkling spices with no salt on air-popped popcorn and tossing in a handful of nuts while you're watching your favourite late-night TV.

Saffron: The spice increases serotonin levels, which typically drop before menstruation. It's expensive but this spice has been valued through the ages for its nutritional and mood-lifting properties.

Workers (OGWs), supporters, facilitators, and sympathizers in Kashmir to create new terror modules by misusing social media platforms. The goal is to radicalize and recruit youths for unlawful activities, including joining terrorist organizations and furthering their activities.

During the investigation of the case, it was revealed that mobile phones and other digital devices were being used by under-trial terrorists, OGWs, and supporters of various proscribed terrorist organizations inside Central Jail, Srinagar. These devices were being used for communication with active terrorists, receiving and transmitting directions from handlers based across the border to further the terrorists' activities.

The suspects/inmates were found to be in continuous contact with handlers or members of terrorist organizations across the border, passing on instructions to active terrorists operating in the Kashmir valley. As part of the investigation, searches were conducted in various blocks and barracks of Central Jail Srinagar. Incriminating materials, including SIM cards, mobile phones, and other digital devices, were recovered and seized for further investigation.

The investigating agency is also looking into the security breach at Central Jail Srinagar, specifically how the digital communication devices were smuggled inside the premises. Facilitators and collaborators involved in this act will also be investigated.

The operation aims to uncover crucial evidence, curb illicit activities, prevent the misuse of communication devices within security zones, including jails, and dismantle the terror ecosystem in Jammu and Kashmir. Legal action will be taken against those involved, as per the law of the land.

He revealed that the Department is hopeful to get the necessary approval as they have chalked a program to follow it up at the highest level.

He further gave in-depth analysis of college-wise seats and courses for which the applications had been made. Regarding addition of 50 MBBS Seats in new GMCs, it was said that same shall be taken up for the next session after requisite upgradation in human resource and infrastructure as per the set norms. It was added that proposals from GMC Baramulla, Anantnag & Kathua had been received in this regard.

The infrastructure projects which came up for review during this meeting includes key infrastructure projects like completion of New Medical Colleges, Additional block of LD Hospital, State Cancer Institute at Jammu/Srinagar, R.N Chopra Nursing Home Jammu, Labour block at SMGS Hospital, MCH Lamberi, DH at Reshipora (Budgam), and 100/50 bedded critical care blocks under PM ABHIM, ECRP programme.

He said that Horticulture provides employment to 3.5 million people in Kashmir, or about 23% of the population.

"If the railway lines were being constructed for a legitimate purpose, the legal requirements for public notice and social impact assessment should have been fulfilled," he said, adding that these steps were ignored, violating the law.

Aga Ruhullah further compared the project to a "colonial project" due to its disregard for democratic processes, public consultation, and local needs.

He urged the government to address the concerns of those whose agricultural and horticultural lands are being impacted by the project

Bijbehara-Awantipora

"The proposed railway line, starting from Pulwama and passing through Bijbehara and Awantipora, will cut through highly fertile land and orchards. This is a direct attack on people's livelihoods," she said, adding that protests in Bijbehara reflect public dissatisfaction with the plan.

Mufti suggested that the railway line should be rerouted through non-agricultural land. SHARJAH: Thirteen-year-old Vaibhav Suryavanshi lived up to the hype around his rare talent as India outclassed United Arab Emirates (UAE) by 10 wickets to enter the semifinals of the U-19 Asia Cup here on Wednesday.

Electing to bat, UAE lost wickets at regular intervals to be bundled out for 137 in 44 overs.

Right-arm medium pacer Yudhajit Guha was the pick of the bowlers for India with figures of 3/15, while Chetan Sharma (2/27)



and all-rounder Hardik Raj (2/28) scalped two wickets apiece. India cantered home in 16.1 overs riding on unbeaten halfcenturies from the opening duo of Suryavanshi (76 off 46) and Avush Mhatre (67 off 51).

Survavanshi recently turned heads at the IPL auction where he was sold to Rajasthan Royals for Rs 1.10 crore, becoming the youngest player to go under the hammer in the league's history.

While left-hander Suryavanshi decorated his innings with three hits to the fence and four strikes over it, Mhatre struck four boundaries and as many sixes during his knock. Majority of the 13-year-old's sixes came in the cow corner region.

India started their campaign on a disappointing note, losing to arch-rivals Pakistan by 43 runs in their group opener before thrashing minnows Japan by 211 runs.

India will play Group B toppers Sri Lanka in the semifinals, while Group A leaders Pakistan will be up against Bangladesh on Friday

Both Pakistan and Sri Lanka were unbeaten in the group stages.

Apart from Markram, several other all-format players - such as Marco Jansen, Keshav Maharaj, Kagiso Rabada and Tristan Stubbs - will miss the Pakistan T20Is, scheduled between December 10 and 14, with the second Test against Sri Lanka concluding on December 9. These players will, however, be a part of the ODI series against Pakistan in early 2025, which will be part of their last leg of preparations for the Champions Trophy.

Allrounder George Linde has also been named in the squad, after having last played a T20I in July 2021, against Ireland. He has played 14 T20Is and had an impressive performance in this season's CSA T20 Challenge, scoring 171 runs at a strike rate of 178.12 and claiming nine wickets at an average of 18.33. "Anrich is very much in line for the Champions Trophy," South Africa's white-ball head coach Rob Walter said. "He has a lot of experience so playing lots of 50-over cricket is not necessary. Before that, he will be very active in the SA20 and in this series. I am not worried about him from a playing point of view. He is not a young cricketer, he understands his game. There's enough cricket between now and then for him to be selected." He added that South Africa's No. 7 is normally filled with a seaming allrounder but with Wiaan Mulder injured and Jansen unavailable, they "needed to look for a spinning allrounder and George was someone who filled that role." South Africa do have two seam-bowling allrounders in Patrick Kruger and Andile Simelane, a 21-year-old, who has excellent potential for the future. "I'm very excited about Andile. He has got some wonderful attributes. The first ball he faced in international cricket he hit out of Kingsmead. He has got some power with the bat, he took some key wickets, he has a wonderful overall skill set that is still in its infancy. We want to keep giving him opportunities, keep growing his game." Although South Africa qualified for June's T20 World Cup final, they have not won a single bilateral series this year, largely because they have not had a first-choice squad available. Still, the microscope is on Walter, who was asked if he felt his position was in jeopardy. "I feel the most pressure from myself personally. I want the team to be better, expect the team to play better and that starts with me as the head coach. We are in the results business." The squad will begin preparations with a two-day camp at the Centre of Excellence in Pretoria from December 6-8. On Sunday, they will head to Durban where the first match will be played, followed by back-to-back games in Centurion and Johannesburg on December 13 and 14, respectively.
