

Supreme Court quashes defamation proceedings against Union minister L Murugan

NEW DELHI, Dec 5: In a relief to union minister L Murugan, the Supreme Court on Thursday quashed criminal defamation proceedings against him on a complaint filed by the Chennai-based Murasoli Trust for his alleged defamatory statements at a press conference in December 2020.

A bench of Justices B R Gavai and K V Viswanathan passed the order after Murugan's counsel said the politician never intended either to defame the Trust or cause any harm or injury to its reputation.

The bench noted that the advocates appearing for the Trust have graciously stated that since Murugan has clarified that he had no intention to defame or cause harm or injury to the Trust, they do not intend to continue with the prosecution.

"We place on record our appreciation for the graciousness expressed by the respondent (Trust),"

the bench said.

Challenging the proceedings against him, Murugan previously moved the high court, which recorded the Trust's submission in its order that he made the statements "with an ulterior motive to degrade and tarnish the reputation of the Murasoli Trust in the eyes of the general public".

"While dealing with the quash petition, this court cannot go into the merits of the case or the disputed questions of fact. This court has to merely go by what is alleged in the complaint and prima facie find out as to whether the offence is made out," the high court had said.

While dismissing his plea, the high court directed a Chennai trial court to dispose of the case within three months. "It is left open to the petitioner

(Murugan) to raise all the grounds before the trial court and the same will be considered on its own merits and in accordance with law," it had said.

Law Minister Meghwal Slams Cong For Not Giving Ambedkar His Due; Ensuring His Poll Defeat

NEW DELHI: Law Minister Arjun Ram Meghwal on Thursday slammed the opposition Congress for not giving BRAmbedkar his due and allegedly ensuring his defeat in the first Lok Sabha elections.

Addressing the media here, Meghwal credited Ambedkar with the creation of the Reserve Bank of India as well as the Finance Commission but lamented that the Congress "which talks of the Constitution, never gave Ambedkar the due he deserved.

He claimed the Congress made supporters of Ambedkar vote twice on ballot papers, making it invalid which led to his defeat.

He said Ambedkar wrote to the Election Commission about the way elections were held but the poll body did not act.



Period pains: Kashmir women narrate grim stories on dealing with menstruation 'stigma' 'From Students to Homemakers, all sailing in the same boat'

BANDIPORA: In Kashmir, women continue to struggle with menstruation, with many considering it "something dirty." The approach of the monthly cycle shakes them internally. From hiding it from family to feeling unable to openly ask for sanitary pads, the daily struggle highlights the stigma surrounding periods, which is deeply ingrained and takes a heavy toll on mental well-being.

Raziya (name changed), a student, shared her experience: "I got my period at the age of 17. I was very worried about it and couldn't tell anyone in my family. Eventually, I told my mother, and she said, 'Yes, this happens to girls. I had explained it to you before. Now that you are growing up, you need to take care of yourself. And yes, there is nothing to worry about.""

However, as the years have passed, Raziya feels that menstruation is something that women are forced to hide and cannot discuss, even in the most difficult circumstances. "People still view it as shameful, and some even look down on those who are menstruating with disgust." Menstruation is a natural process, but many girls in Kashmir still feel "hushed up" about it, struggling even to share it with their closest family members,



including mothers. Another challenge is that many families avoid discussing it altogether. As a result, many girls hesitate to buy sanitary pads, bound by unnecessary fears.

Although there have been efforts to normalize open conversations about menstruation and increase awareness elsewhere, women in Kashmir still feel shackled by social taboos.

Experts suggest that talking about menstruation can help eliminate these fears and empower young

women to take care of themselves confidently. "We need to educate ourselves first. Periods are not dirty; they are essential for the survival of the human species," they say, adding that many girls and women even suffer life-threatening conditions due to the stigma surrounding menstrual health.

Experts recommend scaling up awareness programs to educate girls on how to take care of themselves, what to eat, what medicines to take, and how to handle their periods, emphasizing that there is nothing to be ashamed of.

A 28-year-old mother of two children, living in poverty, shared her experience: "When I have my period, I still have to do every household task and take care of the children. I don't take rest during this time because I have to do everything myself. It's a big challenge for a girl to do all the work during this process."

She added, "If I talk about pads, I can't afford them. I use cloth," explaining that while she had heard of pads, she didn't know how to use them. When asked about the risks, she said, "No doubt, there is a risk of infection, but what can I do? Pads are so expensive," expressing her helplessness. Najmaa, a young girl, offers a glimpse into the challenges she faces: "I honestly don't like using cloth, but I belong to a poor family, and I can't afford sanitary napkins every month." She added, "I cut up old clothes and keep them in a box to use during my periods. When I wash them, I have to hide them so no one in my family sees them."

A teacher shared with Kashmir Convener that many girls try to skip school when they anticipate their period. "Students even get their periods at school, which is frustrating for them because they are afraid to talk about it or seek assistance," the teacher explained.

Insiders note that the lack of proper washrooms and facilities, including access to sanitary pads, adds to the woes of menstruating girls, especially with girls as young as seven beginning to menstruate.

A shopkeeper mentioned that many girls are too shy to ask for pads: "Half of the girls ask directly, while others can't speak up. To avoid embarrassment, we give them the packs in bags so they aren't visible," he said. "We have now placed female sales staff in shops so that girls can comfortably ask for sanitary pads without feeling shy."

India's Long-Range Cruise Missile Takes Flight

n November 12, 2024, the Defence Research and Development Organisation (DRDO) achieved a significant milestone by successfully conducting the first flight test of India's Long Range Land Attack Cruise Missile (LRLACM). Launched from a mobile articulated launcher at the Integrated Test Range (ITR) in Chandipur, Odisha, this test marked a monumental step in India's indigenous defense development program. The missile's performance met all primary objectives, underscoring its potential as a game-changer in modern warfare.

Development and Collaborative Efforts

The Long Range Land Attack Cruise Missile is the result of years of rigorous research and development led by DRDO's Aeronautical Development Establishment (ADE) in Bengaluru. It is a culmination of collaborative efforts by various DRDO laboratories and Indian industries, making it a testament to India's self-reliance in defense technology. Key industrial partners such as Bharat Dynamics Limited (BDL), Hyderabad, and Bharat Electronics Limited (BEL), Bengaluru, played a pivotal role as development-cum-production partners, ensuring the missile's seamless integration and deployment.

The project was approved under the Defence Acquisition Council's (DAC) Mission Mode framework, which emphasizes critical projects with strategic importance. With a planned range of over 1,000 km, the LRLACM is designed to meet the evolving needs of India's armed forces, offering unparalleled precision in long-range strikes.

Design and Capabilities

The LRLACM's design incorporates cutting-edge technology, state-of-the-art avionics, and advanced software. Its versatility is evident in its ability to be launched from both mobile ground platforms and frontline naval ships using the Universal Vertical Launch Module (UVLM). This capability enhances its operational flexibility, allowing it to adapt to radio-frequency seeker, which will be integrated in future trials, will enhance its terminal homing capabilities, making it a formidable weapon for for a few sensors and accelerometers, being locally sourced. This self-reliance reduces dependency on foreign technology and underscores the strength



diverse combat scenarios.

One of the standout features of the missile is its ability to perform complex maneuvers while flying at varying speeds and altitudes. This, coupled with its subsonic speed and terrain-following capabilities, makes it exceptionally difficult to detect and intercept, providing a strategic advantage in penetrating enemy defenses. During the first test flight, the missile demonstrated precise waypoint navigation, complex maneuvers, and accurate trajectory tracking, proving its reliability and accuracy.

To ensure stealth and efficiency, the missile employs terrain-adjacent flight paths, enabling it to evade enemy radar systems. Its advanced

precision strikes.

During the inaugural test flight, the LRLACM was closely monitored using an array of advanced sensors, including radars, electro-optical tracking systems, and telemetry equipment along its flight path. The missile's seamless execution of mission objectives was a testament to the robustness of its design and development.

Future plans include around 20 additional test flights to further refine the missile's performance and reliability. These tests will focus on enhancing its range, accuracy, and terminal homing capabilities. This milestone signifies a progressive step towards enhancing judicial infrastructure to ensure more efficient access to justice.



Faith and Action: Addressing Divisive Narratives and Societal Issues in J&K

However, in Jammu and Kashmir (J&K), the rise of pseudo-scholars has emerged as a major obstacle to these ideals. These self-proclaimed authorities exploit social media platforms to propagate divisive ideologies, creating discord among communities and diverting attention from pressing issues such as unemployment,

By focusing on modern skills and innovation, J&K's education system can empower its youth to compete on a global stage and reduce the frustrations that often lead to social unrest.

Prophet Muhammad (peace be upon him) also emphasized the importance of unity, urging Muslims to reject hatred and envy

"Do not hate one another, do not envy one another, do not turn away from one another, but rather be servants of Allah as brothers." (Sahih Bukhari, Sahih Muslim).

The need of the hour is for genuine scholars and community leaders to reclaim the narrative, guiding society away from divisive rhetoric and toward meaningful progress. This requires a collective effort to address the root causes of societal challenges while aligning the aspirations of youth with opportunities that empower them to thrive in a rapidly



Kashmir Combined Competitive Examination (JKCCE) Rules, 2018, amended by S.O. 61 on February 23, 2021.

In a recent incident, the power supply of SKIMS Soura went off for around eight minutes and it is due to that SKIMS doesn't have its own engineering wing now.

He said the procurement procedures have been taking more time and that needs to be redressed and this premier institute must get all equipment and medicine on time. "There hasn't been any recruitment in many departments in SKIMS in the last 10 years and one nurse has to take care of 30 beds at the hospital, which is quite unfortunate," he said.

Abdullah assured the SKIMS administration that every possible step will be taken for better patient care, recruitment and rationalisation so that the institute gets every necessary equipment and medicine on time will be taken.

He lauded SKIMS authorities for handling immense pressure due to inadequate infrastructure at district and sub-district hospitals, which forces patients with routine medical needs to seek treatment at SKIMS.

He said that SKIMS' autonomy, once a hallmark of its efficient functioning, has been eroded, impacting its engineering and maintenance capabilities. "The autonomy of SKIMS has also been compromised, affecting its engineering and maintenance capabilities. Narbal, involves significant land acquisition. He questioned whether the proposed satellite townships are intended for the local populace or outsiders.

"The government, elected with a massive mandate, must answer the people. Who are these satellite townships for? What compensation will landowners receive? These are not just questions from the PDP but from the people of Jammu and Kashmir," he said.

Calling for greater transparency, Dr. Beg demanded increased compensation for affected landowners and urged the government to act responsibly.

"Do the people of Jammu and Kashmir have any rights in these townships? Will the domicile laws be respected?" he asked.

Dr. Beg also disclosed that the Jammu and Kashmir Housing Board, through an order dated October 9, 2024, outlined plans for developing satellite townships along a 500-meter stretch on either side of the Ring Road. "This project, though presented under the guise of development, raises alarming questions about land rights, compensation, and the future of residents," he added.

He highlighted reports suggesting that approximately 1.20 lakh kanals of land would be required for the project, much of it sourced from fertile horticultural and agricultural zones-key components of Kashmir's economy.

The government's decision to reserve a one-kilometerwide corridor (500 meters on each side of the road) prohibits construction, leaving landowners in a state of uncertainty.

"While compensation for land acquisition is standard practice nationally, there is no clarity here on how much compensation will be provided or whether it will be adequate," he said.

Dr. Beg alleged that compensation rates were far below market values, with payouts reportedly as low as 20% of the actual land price. "This land is not just a source of income; it is our heritage and lifeline," he said.

He also raised concerns about whether the proposed townships align with Srinagar's Master Plan and existing land use policies.

"The government must clarify the objectives of these townships and ensure the protection of local residents' rights," he urged. "Compensation must be fair, and the affected people

Rob Key: Archer's IPL stint will put him 'behind schedule' for Test return

ob Key has conceded that Jofra Archer's decision to play in the IPL next year will put him "a couple of months behind" schedule in his attempted Test comeback. However, the league's new rules left

Key, England's managing director, had initially planned for him to play for Sussex in the County Championship in April and May to build up his workload ahead of England's Test series against India in June and July.



the ECB's management feeling unable to deny him the opportunity to earn two seasons' wages.

Archer has not played a Test since February 2021 due to back and elbow issues, but has been injury-free in 2024. His chances of a comeback increased this week when he signed an extension to his central contract, which now runs beyond the 2025-26 Ashes, while Ben Stokes said that Archer remains "very But under new regulations, missing the IPL's mega-auction would have rendered Archer ineligible for the subsequent mini-auction as well, at significant financial cost.

Archer's name was on the initial longlist of names circulated to IPL franchises before the auction but he did not feature on the shortlist, with the ECB making the case that they were still managing his injuries. But after clarification from the BCCI, he was added back to the shortlist and was bought for INR 12.5 crore (£1.18m) by Rajasthan Royals, following a bidding war with Mumbai Indians.

"Jofra is always brilliant to deal with," Key said, in an interview on Wisden Cricket Weekly's Patreon channel. "We were like, 'The best thing might be to miss the IPL this year and get yourselfready, and we'll start building your loads up... if you can get through a bit of Championship cricket, and then you can start the Test summer. He was happy with that.

"But we had to look and see what India were going to do with [the IPL's rules]. We thought that we could make the case that he's still in part of a managed workload period. The problem with that was he was then bowling with two slips and a gully and bowling 90mph in the T20s in the West Indies, so it's hard to make the case that he's injured when he's bowling like that.

"They [the BCCI] came back after a bit of back-and-forth and said, 'Well no, he won't be allowed to go into this year, next year from then on. So then you start thinking that could be about \$4 million that he loses out on there, and I don't then feel... then it's on him, really. You say, 'Jof, what do you want to do? This is your career, your life. You'll still be able to play Test cricket.'

"We believe there's a lot of water to go under the bridge for that, but we still think he'll be alright. We'll just be a couple of months behind... So then Jofra decided that he felt the best thing for him was to go into the IPL [auction], which we had no issue with, and then do that loading throughout the IPL and get himself ready for the Test series that way."

Key still believes Archer could be "one of the best bowlers" England have ever had and that he could play a role against India - though cautioned that he will not be an automatic selection. "The plan is that he'll be ready to play," he said. "He was only ever going to play one or two Tests this summer, probably - at a push, three.

"He's also got to get in the team now. I think he could be one of the best bowlers we've had, but he's got to find form. He's got to be able to show that he can sustain it through a whole four-day game. It's not a case that he's fit, so he just comes into play. We've got some very good bowlers around now... I don't see any reason why he can't [return to Tests]."

Key admitted that his decision-making as managing director has been informed in part by his concern that franchises will offer England players year-round deals which are so lucrative that they opt out of their central contracts. "You don't know what other governing bodies are going to do," he said. "We're very much in a new world.

"I don't think we want to be in a place where centrally-contracted England players walk away from English cricket... Let's say a franchise signs someone for \$2 million to play all year round: we won't see them for England. These franchise owners, they won't say, 'Oh, that's fine, we'll pay them \$2 million and you go and bowl them 20 overs a day in a Test match." Border-Gavaskar Trophy victory is one last thing to tick off for lot of us: Cummins

ADELAIDE: He has won the ODI World Cup along with the coveted Ashes multiple times but the Border-Gavaskar Trophy against India remains the "one last" unchecked item in the bucket list of Australian skipper Pat Cummins, who is quite confident of doing it this time around despite the opening Test debacle.

Cummins, who made his Test debut in 2011, played a Test against India for the first time in 2017. Since 2014-15, Australia have not won an India series either at home or away. The pacer is determined to change this stat despite the 295-run drubbing in the Perth game last month.



"For half of the (Australian) change room, we haven't won the Border Gavaskar Trophy. It is one last thing to tick off for a lot of us. Almost every challenge that we faced in last few years, we have stepped up and done well," Cummins spoke with a lot of determination ahead of second Test against India in Adelaide.

"I think we need to do that for another home summer and series. From two-three season thing, it has suddenly been a half a generation thing," he added.

Mitchell Starc, Josh Hazlewood (not playing this Test), Mitchell Marsh, and Nathan Lyon are some of the players, who were part of the 2-0 win back in 2014-15.

From then onwards, India have won all four series -- two at home (2017 and 2023) and two overseas (2018-19, 2020-21).

So, is there pressure on him to win it back this time?

"I don't think it's pressure. You are playing at home and you want to do well. We know they (India) are a really strong side and lot of us were part of those recent three series (defeats).

"Yeah, it's a big series and kind of not looking too far in the past. And every summer, when we play against them we want to do well," Cummins said.
