Wherever possible, the available space should be expanded to align with this vision," he said. Omar Abdullah also directed the department to revive the restoration of Naagar Nagar at the foothills of Hari Parbat, a project halted a decade ago, to save its deteriorating walls. He also called for immediate filling of departmental vacancies to ensure seamless functioning. Earlier, Principal Secretary Culture presented a detailed overview of the department's functioning, highlighting its initiatives through directorates such as Archives, Archaeology & Museums, Libraries and Research, and the Academy of Art, Culture & Languages. The progress on various key projects was reviewed, including the restoration of Mubarak Mandi Heritage Complex and archival repositories.

#### Reservation rules Controversy

#### Ministerial committee to hold consultation with all stakeholders

**SRINAGAR**: In a significant move, the Jammu & Kashmir Government on Tuesday constituted



a cabinet-sub-committee(CSC) headed by Social Welfare Minister Sakina Masood Ittoo to examine the grievances regarding reservation rules, which have triggered widespread resentment among the open merit candidates.

The CSC was constituted nearly 18 days after Omar-Abdullah cabinet approved it in its first cabinet meeting in Jammu on November 22.

The cabinet panel, according to an order, would examine the grievances projected by a section of aspirants for various posts regarding reservation rules, in consultation with all

> According to the order, the CSC would be serviced by the Social Welfare Department, which deals with reservation and allied issues.

The CSC shall submit its report to the council of ministers, which is empowered to make amendments in reservation rules.

However, the order doesn't set any deadline for the committee to submit its recommendation to the NC-led government, which, in its election manifesto, has promised to fill all vacant posts in government departments in its first 180 days. In its manifesto, NC has pledged to rationalize reservation rules which have become

#### **J&K paid Rs** 37,273 cr as GST since 2017: Gol

SRINAGAR: Jammu and Kashmir has paid a whopping amount of Rs 37,273 crore as Goods and Services Tax (GST) from 2017 till November 2024, the government data revealed on Tuesday.

During the period, the region has received Rs 59,611 crore in SGST, IGST settlements, and compensation payments.

Jammu and Kashmir's annual GST collections have grown steadily, from Rs 2,320 crore in FY 2017-18 (July 2017 to March 2018) to Rs 6,704 crore in FY

For the current fiscal year, the collections till November 2024 stand at Rs

Similarly, the settlements and compensation rose significantly, peaking at Rs 11,171 crore in FY 2021-22, with Rs 5,932 crore disbursed so far in FY 2024-25. "GST collection in India is classified

to the Consolidated Fund of India (CFI), SGST is credited to the Consolidated Fund of the respective States.

"For inter-state supply and imports, IGST is levied and collected by the Centre, with the collected into CGST, SGST, and IGST, depending on whether the supply of goods or services is intrastate or interstate," the government

# Chief Secretary, led SEC adds 5 more disasters to the SDRF list

**JAMMU** Chief Secretary, Atal Dulloo, today while chairing the State Executive Committee (SEC) Meeting for State Disaster Response Fund (SDRF) gave its approval for inclusion of 5 more local disasters to the already notified list of disasters as per SDRF norms.

Besides the Principal Secretary Home and DMRR&R, the meeting was attended by other members of the SEC including Principal Secretary Finance; ADGP L&O; Divisional Commissioner Kashmir/Jammu and Secretary Revenue.

Deputy Commissioners attended the meeting through video conferencing from their respective offices. During this high level meeting, the members of SEC had consensus on adding five more disasters of local nature to the already notified list as per SDRF. These include Glacial Lake Outburst Floods (GLOF), Lightening & Thunderstorm, Heavy Snowfall, Incidents of

Man-Animal Conflict and Boat Capsizing.

These disasters were notified as UT specific disasters for disbursement of the benefits to the affected persons as per the guidelines/items and norms set under SDRF. This step is going to bring much requisite relief to hundreds of people becoming victims of such disasters.

The SEC also gave its accent to release of over Rs 6 Cr in favour of Deputy Commissioners of Baramulla, Ganderbal, Kupwara, Srinagar, Rajouri and Ramban on their requisition for additional funds for meeting the expenses of various disasters which have occurred in these districts during this year.

It also decided to release an amount of Rs 6.5 Cr in favour of HG/CD/SDRF for modernizing the force by providing different kinds of equipments like drones, remote controlled Lifebuoy, Fire entry suits, Power Descenders, and Battery operated cutter cum spreaders.

#### **J&K Records 327 Cybercrime Cases** From 2021-2022

SRINAGAR: From 2021 to 2022, a total of 327 cybercrime cases were registered in Jammu and Kashmir while 178 people were arrested, 142 were chargesheeted, and one conviction was reported under cybercrime laws.

According to data accessed by the news agency—Kashmir News Observer (KNO), in 2020, 120 cases were registered while the charge sheet was produced in 14 cases. It added that 33 people were arrested



in 2020 while 23 were chargesheeted. However, 2021 saw a rise in incidents with 154 cases registered and 49 chargesheeted. The number of arrests increased to 102, and 60 people were chargesheeted in the particular year.

### Opposition MPs Protest On Adani Issue In Parliament **Premises With Black 'Jholas'**

**NEW DELHI**: Several Opposition MPs on Tuesday demonstrated over the Adani issue in Parliament premises. carrying black 'jholas' (bags) with caricatures of Prime Minister Narendra Modi and billionaire Gautam Adani printed on it and 'Modi Adani Bhai Bhai' written on the obverse side.

This is the latest in the series of unusual protests led by the Congress daily ahead of the sitting of Parliament in the morning.

Leader of Opposition in the Lok Sabha Rahul Gandhi, Congress general secretary Priyanka Gandhi Vadra, MPs from the Congress, DMK, JMM, Left, among others, protested in front of the Makar Dwar steps. They were carrying black

'iholas' with caricatures of Modi and Adani printed on one side and 'Modi Adani Bhai Bhai' written on the obverse side of the bag.

They raised slogans against alleged collusion between Modi and Adani and demanded a Joint Parliamentary Committee probe into the matter.

Earlier, Gandhi chaired a meeting of Congress MPs in the Lok Sabha to take stock of the party's stance on various issues and the way forward in Parliament.

The protest comes a day after leaders of some INDIA bloc

The opposition protests on the Adani issue have been taking place inside Parliament complex ever since the start of the winter session.

parties protested in Parliament complex over the Adani row, with Rahul Gandhi conducting a mock 'interview' over the issue with Congress members wearing masks of Prime Minister Modi and industrialist Gautam Adani.

Standing in front of the Makar Dwar steps in Parliament premises, Leader of Opposition in the Lok Sabha Gandhi and Congress president Mallikarjun Kharge along with MPs of other opposition parties had on Monday raised slogans of "Modi, Adani ek hain" and "we want justice".

The Congress and some other opposition parties have been demanding a joint parliamentary committee(JPC) probe following the indictment of Adani and other company officials in a US court. The Congress has said Adani's

indictment "vindicates" its demand for a IPC probe into the various "scams" involving the billionaire industrialist's conglomerate.

Rahul Gandhi has sought Adani's immediate arrest.

The Adani Group has dismissed all allegations as "baseless".

# DCC/DLRC: Bandipora Banks Report Rs 1757 Cr Advances with 96% CD Ratio for September Quarter



# 4500 Years Ago India Taught The World International Trade

In today's era, foreign trade constitutes an important attribute that paves the way for the progress of any nation. The basis of India's growing economy is also foreign trade. It is also noteworthy that 95% of India's

also carried out via Kuntasi, Padri, Nageshwar, Bagsara, Nagwara, Desalpur etc.

There is also clear evidence of what type of ships were built by the people living on the banks of Saraswati and Indus rivers around 4500 years ago and what was their shape. A seal has been recovered from the excavation of Mohenjodaro on which we can observe an engraving of a ship. An interesting feature can be observed in this ship which is a provision of a cabin for the sailors to stay on it. Along with this, we can also observe engraving of two birds on it. Scholars are of the opinion that the birds were probably used to work out the directions in the middle of the ocean.

There is a dire need to further establish this rich maritime heritage of India on the world stage. The first Indian Maritime Heritage Conclave is being organized by the Ministry of Ports, Shipping and Waterways (MoPSW) in New Delhi and this shall serve as a stepping stone on the maritime heritage of India.

foreign trade is conducted through sea route. Although the practice of conducting business across the sea is very ancient, but Indians were the first to introduce to the world successful businesses through sea route around 4500 years ago.

The reason for the rise of India's ancient Saraswati-Indus civilization was also international trade which was mostly done via sea route. Although the script of that civilization has not been deciphered yet, but archaeological evidence provides evidence of trade through sea route in the ancient civilization of India.

The archaeological site of Lothal, located in Ahmedabad district of present-day Gujarat, was the main centre of international trade through sea. This archaeological site was discovered and excavated by S. R. Rao of the Archaeological Survey of India. From Lothal we have recovered the remains of a huge dockyard which was built using baked bricks. Its size is 216×36 meters. It was connected to the sea through a canal. This dock, built 4500 years ago, is an example of the advanced engineering of our ancestors. From the excavations conducted inside this dock, we have found five anchor stones. This evidence proves that ships were anchored inside this dock. A 41 feet wide inlet was made in this dock for the ships to enter. From its width, it can be estimated that huge ships were built in the Saraswati-Indus civilization. S.R. Rao is of the opinion that about 60 tons of goods were loaded on a ship and sent to Mesopotamia via the Persian Gulf. Apart from Lothal, maritime trade was A toy boat made of baked clay has been found from Kot Diji, an archaeological site of the Saraswati Indus Civilization. This boat has been designed in the form of a bull. Clay statues of humans have also been made inside the boat. This boat is more than 4500 years old, which indicates that the construction of ships had begun around that time

Another significant find constitute the artifacts which were exchanged with other contemporary civilizations through maritime trade. The archaeological remains obtained from excavations show that cotton clothes were exported by the people of the Saraswati Indus Civilization. We have recovered a bundle of cotton cloth from Umma, an ancient city of the Sumerian civilization, which bears the seal of the Saraswati Indus Civilization. Beads made of semi-precious stones were also exported from India during that period. Combs made of ivory found from the archaeological site of Ur were also exported from India. A special type of pottery named Reserved Slip Ware has also been found in excavations at Lothal and Mohenjodaro. It is believed that these pots were imported from the archaeological site of Ur. A seal from the Persian Gulf found at Lothal is another example of bilateral trade.

The above archaeological evidences provides irrefutable evidence that 4500 years ago, on the basis of their advanced knowledge, ancestors of present-day Indians used to conduct international trade through maritime route with different ancient civilizations across the world.



In such a situation, the morale of the corrupt increased instead of decreasing. As a result the disease, which was limited to certain pockets earlier, has spread from top to bottom like the Amarbel today. From the smallest to highest positions of the state, the hands of most are engulfed in corruption.

There is an urgent need to create a nationwide environment to eradicate corruption completely. Political persons opposition did not get tired of calling the 'corrupt' today; the saga of their penance and sacrifice is being sung by including the same people in the opposition parties. As long as this obscene policy is in place, neither corruption will be curbed nor anything will happen to the oppressors.

Only government efforts towards eradicating corruption cannot be trusted, because corruption is in every sphere of the society. The responsibility of its abolition cannot be left to the government institutions alone. Unless the common man of the nation will stand against this sin and crime, it is not possible to get rid of it. Just as the oppressor as well as the victim of atrocities is equally guilty, in the same way the

corruption prevailing in the society and system, but there is also a need for such dedicated people who can do this work like a mission. The Central Government should also organize such fair, effective agencies which are capable of bringing punishment to the corrupt without any discrimination. It cannot be expected from the agencies of the State Governments alone that they can take from lowest to highest positions within the ambit of the Prevention of Corruption Act.

Orders recall of staff deployed without competent authority approval; reviews progress on Badminton Court in Changia

JAMMU: Secretary, Rural Development Department and Panchayati Raj(RDD&PR), Mohammad Aijaz Asad, on Tuesday conducted surprise inspections in Bishnah and Arnia blocks to assess their administrative functioning and ongoing developmental works.

# Hair Loss:

## Causes and Treatment

air loss, also termed alopecia in medicine, is a condition caused by an interference in your body's normal hair growth cycle or damage to your hair follicles. These follicles are tunnel-shaped structures within your skin from which your hair grows. Each strand has a follicle that connects it to your skin. On average, you shed between 50 to 100 strands of hair daily as your hair cycles through different stages. However, any factor that upsets this cycle will cause your hair to shed excessively more than it regrows, leading to alopecia. Though hair loss most commonly affects the scalp, it is not exclusive to this body part and can occur anywhere on the body.

#### Hair growth cycle

 $Let's first \ talk \ about \ your \ natural \ hair \ growth \ cycle \ to \ understand \ why \ and \ how$ hair loss happens. Hair follicles do not constantly produce hair. They do so by cycling through three stages at separate times as follows:

#### Anagen (growth) phase

During this stage, your hair follicles are most actively dividing, so more new hair is grown. This stage typically lasts two to five years. At any given time, about 80% to 90% of healthy hair follicles are in this stage.

#### Catagen (transitional) phase

Following the anagen phase, your hair follicles move into a brief transitional phase known as the catagen phase. This phase heralds the end of active hair growth and causes hair follicles to dwindle. It lasts about one to two weeks.

#### Telogen (resting) phase

Before producing new hair fibers, hair follicles go into a resting phase known as the telogen phase. It typically lasts around three months. At any given time, about 5–10% of your hair is in this phase. Before re-entering the growth phase, your hair falls out from its follicle.



#### **Causes of hair loss**

Many factors contribute to hair loss. What triggers hair loss determines if your hair can regrow on its own or not, such as:

High levels of stress. A body under stress can force hair follicles to stay resting for a typically more extended period, causing them to fall out eventually. This stress-induced hair loss, called "telogen effluvium (TE)," is transient and reversible, lasting up to 6 months.

Causes of stress-related hair loss include: Sickness, like COVID-19

Financial distress

A relationship breakup or divorce

Giving birth

Nutritional deficiencies. A poor diet may wreak havoc on your hair anatomy and growth. The deficiency of essential nutrients like vitamins B3, E, D, iron, zinc, biotin, and proteins can trigger severe hair loss. Taking a regular, healthy diet is therefore imperative.

Hereditary hair loss. According to the American Academy of Dermatology, hereditary hair loss is the most common cause of baldness. Experts refer to hereditary hair loss as androgenic alopecia. This type of hair loss follows a predictable pattern and is often known as male pattern baldness or female pattern baldness. The gene responsible for this type of hair loss is the androgen receptor gene. This gene boosts the androgen receptor activity and thus augments the androgen levels. Unlike telogen effluvium, hereditary hair loss is permanent if not treated on time.

Certain bad hair habits also trigger hair loss in the long run, such as: Females may wear hairstyles that tend to cause constant pulling on their hair, leading to bald spots known as traction alopecia. Hairstyles like tight, high ponytails,


wet messy buns, and tight braids repeatedly stress your hair out. Overusing hot styling tools tends to strip off the moisture, making it prone to


Trichotillomania. This mental health problem induces an irresistible urge to pull out hair from your scalp or other body parts. These people inappropriately use hair pulling to cope with negative emotions, such as stress, boredom, or anxiety.

Alopecia areata. When your immune system strongly disagrees with accepting your hair follicles as a part of your body, a condition called alopecia areata ensues. Surprisingly, the hair loss is not permanent in most cases as the follicles preserve their ability to regrow hair.

Medications like chemotherapy drugs can interfere with your hair growth and cause hair loss.

Gender. According to the American Hair Loss Association: roughly 85% of men will have remarkable hair thinning by age 50. In contrast, research shows that up to 40% of women will have noticeable hair loss by age 50.

Some ideas to maintain fluid intake while sick are as follows.

All these suggestions promote fluid balance while also helping decrease nausea, electrolyte imbalances, or dehydration. Vegetable and bone broths. These are thought to reduce inflammation in the gut, boost the immune system, and provide restorative amino acids. Broth can be purchased from your local grocery store or easily made at home.

Though yogurt seems to be the probiotic food of choice for children, adults and those managing diabetes will need to be aware of the high sugar content. Kombucha and broth are both low in sugar and may be the preferred food for these individuals.

Though vomiting is many people's most dreaded symptom of sickness, it normally lasts only 24 hours or less, and preventive measures are possible. Thankfully, certain foods help prevent and restore gut health. During bouts of vomiting, adequate fluid intake is the greatest priority.

# Doctors at SKIMS Bemina protest against reducing OM quota

**SRINAGAR**: The doctors from SKIMS Medical College Bemina on Tuesday staged a protest against the reduction in the Open Merit (OM) quota in NEET PG admissions in Jammu and Kashmir.

Doctors as per the news agency— Kashmir News Observer (KNO) expressed their concern over the drastic reduction in open merit seats for postgraduate medical courses.

The allocation has dropped from 75% in 2019 to just 38.5% in 2024, leaving limited opportunities for merit-based candidates after 50% of the seats are allocated to the All-India Quota.

They questioned the rationale behind extensive reservations, especially in specialized branches, arguing that it compromises the production of skilled doctors and undermines healthcare quality. "All students access the same resources during MBBS. Why should extensive reservations apply to NEET PG specialty courses?" one of the protesting doctors asked.



The protesters criticized Rule 17 of the J&K Reservation Rules (2004-2005), describing it as unfair to open merit candidates. They pointed out that when a reserved category candidate upgrades to a higher specialty, the vacated seat is reassigned to another reserved candidate rather than to an open merit candidate. This, they argue, disproportionately benefits reserved candidates.

The doctors warned that the

reservation system is already harming healthcare standards, with less qualified individuals securing seats and promotions. They emphasized the need to prioritize merit to ensure a competent healthcare workforce.

Medical professionals have voiced concerns over the impact of reservation-based selections on the quality of healthcare and the reputation of medical institutions. They emphasized that healthcare should remain

uncompromised, urging that leadership roles in the sector should be occupied by competent doctors selected on merit. The doctors highlighted the issue of candidates, who secure undergraduate medical seats through reservation but fail to qualify for postgraduate seats on open merit. They suggested that such candidates should be required to serve as medical officers in underserved areas, utilizing their reservation benefits for the greater good. Calling for a review of the reservation policy, the professionals stressed that only truly deserving candidates should benefit from these schemes. # GoI approves Rs 256.46 cr for tourism development in Ladakh

**SRINAGAR**: The Government of India (Gol) has sanctioned Rs 256.46 crore for a series of tourism development projects in Ladakh to bolster the region's growing tourism sector. This key announcement was made by Minister of Tourism, Gajendra Singh Shekhawat, during a Lok Sabha session on December 9.

According to details obtained by the news agency—Kashmir News Observer (KNO), the allocated funds will be directed towards several initiatives under the schemes of Swadesh Darshan, Swadesh Darshan 2.0, and Assistance to Central Agencies, with the aim of promoting infrastructure and enhancing adventure tourism. Shekhawat said the Ministry of Tourism is playing a crucial role in supporting initiatives to cultivate tourism, including promoting local events and leveraging social media campaigns.

"Efforts such as the Incredible India Digital Portal and the launch of the Incredible India Content Hub are designed to provide stakeholders in the travel industry with accessible resources to promote India as a leading tourism destination," he said.

Key components of the funding include Rs 77.33 crore for developing tourist facilities along vital routes and Rs 86.39 crore earmarked for facilities in Anantnag, Pulwama, Kishtwar and Zanskar regions. The minister said Rs 91.84 crore has been allocated for developing infrastructures for the Gulmarg-Baramulla-Kupwara-Kargil-Leh route.

He said the government also plans to enhance community involvement and sustainable tourism growth through its newly introduced Ladakh Homestay Policy 2023. This initiative aims to equip local households with essential kits to establish homestays.

### Ex-ISI Chief Charged For Multiple Offences

**RAWALPINDI** — Lieutenant General (retd) Faiz Hamid has been formally charged with multiple offences, including engaging in political activities and violating the Official Secrets Act, the military's media wing said on Tuesday.

These violations have compromised state security and interests, the Inter-Services Public Relations (ISPR) said in a statement. Additionally, the charges include misuse of authority and government

resources, as well as causing wrongful losses to individuals.

The process of field general court-martial (FGCM) was initiated against Lt Gen (retd) Hamid, who has served as the chief of Inter-Services Intelligence (ISI), under provisions of the Pakistan Army Act on August 12.

"[...] and in the first place has been formally

arraigned on charges of engaging in political activities, violations of Official Secret Act detrimental to safety and interest of the state, misuse of authority & government resources and causing wrongful loss to a person(s),"

the military's media wing said in a brief statement issued on Tuesday.

Moreover, the military's media wing said the former spy master's role in creating agitation and unrest including May 9 riots

"in collusion with vested political interests" was also being investigated.

The May 9 events refer to the violent protests that broke out in the country last year following the arrest of jailed PTI founder Imran Khan in a corruption case.

During the riots, the alleged supporters of PTI founder ransacked and attacked the public properties including military installations, prompting the civil-military leadership of the country to try the rioters under Army Act.

Besides PTI founder Imran, dozens of other party leaders have been implicated in the cases related to the May 9 mayhem.

In the statement today, the ISPR said: "During the process, involvement of Lt Gen Faiz Hamid (Retd), in events related to creating agitation and unrest, leading upto multiple incidents including but not

limited to 9th May 2023 incident for fomenting instability; at the behest of and in collusion with vested political interests, is also being separately investigated," read the statement.

"Lt Gen Faiz Hamid (retd) is being afforded [...] all legal rights as per the law," it added.

Speaking to Geo News, Brigadier (retd) Rashid Wali said the charges levelled against the ex-spy master were of a serious nature.



He said the trial of the former military officer would be conducted in the military court following which the court would announce its verdict.

He said after that Hamid could lodge an appeal against the court verdict as well.

The ex-ISI chief was taken into custody by the military on charges of abuse of power and violating the Army Act earlier this year in August.

The Pakistan Army, following Supreme Court orders, had conducted a detailed inquiry to investigate complaints against Hamid in the Top City case, according to the army's media wing.

It added that the court-martial process was started against the former spy chief based on these complaints.

It said that multiple instances of violation of the Pakistan Army Act post-retirement had also been established against the former general, who also served as Peshawar corps commander. The arrest was made in connection with a

petition filed by the housing society's chief executive officer in the Supreme Court last year, wherein Hamid was accused of land grabbing

and stealing valuables from the owner of a private housing society during a raid.

Three more retired officers were also taken into

"Concrete exposed to freezing conditions is vulnerable to frost damage, which can interfere with proper cement hydration and curing. This leads to concrete failing to set correctly, compromising strength and safety," reads an advisory, a copy of which lies with KNO.

It reads that, in light of this, all concreting work is advised to stop until the temperature conditions improve. However, Rural Engineering Wing (REW) Executive Engineers may proceed with concreting operations if they ensure that all necessary precautions are taken. These include using antifreeze additives to support proper curing and ensuring all requirements are met. All REW engineers in the region are directed to comply with this advisory to ensure safety and maintain structural integrity.

"Launched in 2021, the 'Citizen Financial Cyber Fraud Reporting and Management System' has facilitated the recovery of over ₹3431 crore in more than 9.94 lakh complaints, supported by a toll-free helpline number, 1930, for lodging online cyber complaints," it said, adding that proactive efforts by I4C have led to the identification and blocking of over 1700 Skype IDs and 59,000 WhatsApp accounts linked to digital fraud.

Also, more than 6.69 lakh SIM cards and 1,32,000 IMEIs have been blocked based on police reports until November 15, 2024.

The Central Government has also issued alerts about blackmail and digital arrest scams conducted by cybercriminals impersonating officials from agencies like NCB, CBI, and RBI. To address the misuse of international spoofed calls masquerading as Indian numbers, a system has been devised in collaboration with telecom service providers (TSPs) to detect and block such calls, which are commonly used in scams like fake digital arrests and impersonations.

### Trott to continue as Afghanistan men's head coach through 2025 Harmanpreet Kaur and her deputy Smriti

onathan Trott will continue as Afghanistan men's head coach till the end of 2025. His next assignment will be the ODI leg of Afghanistan's multi-format tour of Zimbabwe, but he will not take charge in the other formats for personal reasons. In his absence, Hamid Hassan will deputise as head coach and Nawroz Mangal as assistant coach.

The Afghanistan Cricket Board has extended Trott's contract by 12 months following a highly successful 2024 for the team. The



year featured Afghanistan's first ever World Cup semi-final appearance following victories over New Zealand and Australia in the Group- and Super-Eights stages of the T20 event in the West Indies and the USA. They have since beaten both South Africa and Bangladesh in ODI series in Sharjah.

Afghanistan's next major global tournament is a maiden appearance in the Champions Trophy next year. They qualified for the event after finishing among the top eight teams on the 2023 ODI World Cup points table, after a campaign that featured wins over England, Pakistan and Sri Lanka.

Trott's tenure began in July 2022 with an 18-month stint that was renewed by a year in January 2024. Afghanistan have won 14 of the 34 ODIs and 20 of the 44 T20Is they have played since his appointment.

The ongoing stint with Afghanistan is Trott's first as head coach. He was a consultant with Scotland during the 2021 T20 World Cup. As a player, he made 3835 runs in 52 Tests at an average of 44.08, and was a key figure in England's away Ashes victory in 2010-11. In ODI cricket, he made 2819 runs at an average of 51.25 with four hundreds and 22 fifties.
