**GMC Sgr Students Protest Over Reduced Open Merit Seats**

SRINAGAR, December 9: Medical students from Government Medical College (GMC) Srinagar have raised serious concerns over the drastic reduction in Open Merit (OM) seats in postgraduate admissions under the NEET PG framework.

The students claim that recent policy

changes, including the implementation of SO 176 (March 15, 2024) and SO 305 (May 21, 2024), have severely impacted merit-based admissions, leading to widespread discontent among aspiring doctors.

According to the students, the open merit quota, which previously accounted

for 75% of PG seats under SRO 49 of 2018, has been reduced to approximately 27% after the application of new reservation rules and Rule 17 of the J&K Reservation Rules (2004-2005). Out of 293 total PG seats available in government

# Against allocated Rs 1000 cr, SSCL utilizes 75% funds

**SRINAGAR**: The much-hyped beautification projects by Srinagar Smart City Limited (SSCL), which faced frequent criticism over planning

and timing, are moving closer to its completion, with officials expressing confidence that the remaining projects were likely to be finished by early 2025.

According to the official details available with the news agency—Kashmir News Observer (KNO) that out of a total 142 projects, 123 have already been completed. The officials added that the completed projects have marked a significant progress in the transformation of the City's urban landscape.

As per the officials, with an estimated budget of Rs 1,000 crore, approximately 75% of the allocated funds have been utilized so far, with the remaining budget left for the remaining

Among the completed projects, the officials highlighted revamped Polo View High Street, Clock Tower in the City Centre, and the landscaped Jhelum Riverfront Embankments.

Officials said that the refurbished prominent landmarks have enhanced the City's aesthetics and public spaces, adding that in addition to these projects, road resurfacing work has been

extensively undertaken in various parts of the City, improving travel comfort and road infrastructure. Notably, the road-widening policy, aimed

at expanding pedestrian pathways by reducing road space for vehicles, has drawn criticism



from residents. Many have voiced concerns about traffic congestion caused by the reduced carriageway width.

Defending the policy, the SSCL officials stated, "The designs were meticulously planned with input from subject matter experts and are aligned with legitimate practices to create sustainable,

pedestrian-friendly urban spaces." Pertinently, Srinagar Smart City projects have missed several deadlines on project completions in the past, while

## **ACB Registers 444 Cases In 5 Years**

SRINAGAR: In a bid to eliminate corruption from Jammu and Kashmir, the Anti-Corruption Bureau (ACB) has registered over 440 cases across the Union Territory in the last five years, indicating a strict response by the government against such practices.

Over the past five years, the ACB has registered a staggering 444 FIRs in different alleged corruption cases, exposing the persistent grip of corruption across Jammu and Kashmir.

From Kashmir's bustling Srinagar to the administrative heart of Jammu, the data tells a story of vigilance, challenges, and the relentless pursuit of accountability.

# Rahul Takes Dig At PM, Adani With Mock 'Interview' **In Parliament Premises**

**NEW DELHI**: Leaders of some INDIA bloc parties on Monday protested in Parliament complex over the Adani row, with Rahul Gandhi conducting a mock 'interview' over the issue with Congress members wearing masks of Prime Minister Narendra Modi and industrialist Gautam

Standing outside the Makar Dwar of Parliament, Leader of Opposition in the Lok Sabha Rahul Gandhi and Congress president Mallikarjun Kharge along with MPs of other opposition parties raised slogans of "Modi, Adani ek hain" and "we want justice".

After sloganeering, Rahul Gandhi conducted the mock 'interview' with Congress leaders

wearing masks of Modi and Adani. Gandhi asked the party member sporting mask of Adani why Parliament was not being allowed to function to which the Congress MP (posing as Adani) said "we'll have to ask Amit bhai... that man is missing".

MPs of the Left, DMK, Shiv Sena (UBT), RJD and NCP were among those who raised slogans a probe into the Adani Group.

The protest took place in front of the steps of Parliament's Makar Dwar and not on the steps leading to it following an advisory by the Lok Sabha Secretariat not

The Congress and some other opposition parties have been demanding a joint parliamentary committee(JPC) probe following the indictment of Adani and other company officials in a US court. The Congress has said Adani's

## Himachal Receives Season's First Snowfall, 87 Roads Closed

SHIMLA: Himachal Pradesh several high mountain passes, witnessed its first snowfall of received the first snowfall of



closure of at least 87 roads in the state, including Atari-Leh National Highway 3 near Manali's Rohtang Pass, the State **Emergency Operation Centre** (SEOC) said.

A total of 58 roads were closed in Shimla, followed by 17 in Kinnaur, six in Kangra, two in Lahaul and Spiti, one each in Kullu and Chamba districts. Some parts of Himachal suffered power outrages as 457 transformers were disrupted, the SEOC said.

Shimla, along with the nearby tourist resorts of Kufri, Fagu, Chansel, Narkanda and the Churdhar ranges, as well as and bringing cheer to the farmers, apple growers and hoteliers. Shimla received 2.5 cm

breaking a ten-week dry spell

of snow, and areas like The Ridge, Mall Road and Jakhoo Peak were covered in a light blanket of snow. Snowfall was also recorded in key tourist destinations such as Manali, Kasauli, and Chail.

High-altitude areas and mountain passes were blanketed in snow, causing minimum temperatures to drop by four to six degrees.

The high-altitude tribal areas experienced piercing cold,

with minimum temperatures ranging from 12 to 18 degrees below freezing. Tabo recorded a low of minus 12.3 degrees

Since Sunday evening, about 800 people stranded in 490 vehicles in Lahaul due to the snowfall have been rescued, according to the Lahaul and Spiti police. Snow and slippery road conditions also disrupted vehicular traffic on several roads in the upper Shimla region.

Despite the adverse weather, schools in Shimla remained open due to ongoing exams, and the supply of essential goods was also not affected.

Koksar recorded 6.7 cm of snow, followed by Khadrala with 5 cm, Sangla with 3.6 cm, Keylong with 3 cm, and Nichar and Shimla both with 2.5 cm.

The lower hills of the state saw light rainfall, with Kandaghat, Kasauli, Jubbarhatti and Mandi recording 2.2 mm, 2 mm, 1.9 mm, and 1.4 mm of rain, respectively. Intense cold wave conditions persisted, with temperatures staying two to six degrees below freezing at several locations.

## Sheena Bora case SC notice to CBI on Indrani Mukerjea's plea to travel abroad

**NEW DELHI:** The Supreme Court on Monday sought the CBI's response on former media executive Indrani Mukerjea's plea challenging a Bombay High Court ruling denying her to travel abroad as she is accused of killing her daughter Sheena Bora.

The travel restriction matter came up to the Supreme Court after a special court on July 19 allowed Mukerjea's plea to visit Spain and the United Kingdom for 10 days over the next three months.

The CBI approached the high court challenging the order passed by the special court. The high court quashed the special court's order on September 27. Mukerjea moved the apex court challenging this high court order.

A bench of justices M M Sundresh and Aravind Kumar issued a notice to the agency and sought its response on the appeal filed by Mukerjea against the high court order.In her plea filed through advocate Sana Raees Khan, Mukerjea said she was a British citizen as she sought permission to visit Spain



and her home country for "making necessary changes and amendments and taking care of pending work which cannot be transacted without her personal presence". She argued the activation of a digital certificate was a must for all relevant work and administration in Spain and her physical presence was mandatory. In its verdict, the high court noted Mukeriea wanted to travel abroad on the ground that she was a British national and was required to execute documents regarding her bank account and perform other work in Spain and the UK.

## **CUET-UG, PG Set To Undergo Changes In 2025, Revised Norms** To Be Announced **Soon: UGC Chief**

**NEW DELHI:** The Common University Entrance Test (CUET) for admission to undergraduate and postgraduate courses is set to undergo several changes in the 2025 edition following a review by an expert panel, according to UGC Chairman Jagadesh Kumar.

The University Grants Commission (UGC) had constituted an expert committee to review the conduct of CUET-UG and PG.

"Based on feedback from past years, it is also essential to continuously improve the examination process to provide a better, more efficient and conducive environment for students taking CUET. In this spirit, the UGC has constituted an expert committee to review the conduct of CUET-UG and CUET-PG for 2025," Mr. Kumar said.

"The committee has examined various aspects of the test, such as its structure, number of papers, duration of test papers, syllabus alignment and operational logistics. The commission considered these recommendations in a recent meeting,"

The UGC chief informed that the commission will soon release a draft proposal detailing the

revised guidelines for conducting CUET-UG and CUET-PG 2025, inviting feedback and suggestions from students, parents, teachers and institutions.

In the first edition of the exam in 2022, CUET-UG was plagued by technical glitches. Also, as a result of tests for a subject being conducted over multiple shifts, the scores had to be normalised during the announcement of results. The exam was conducted in hybrid mode for the first time in 2024. It was cancelled across Delhi a night before it was to be held citing logistical reasons.

## SC dismisses plea to clear road blockade caused by farmers' protest

**NEW DELHI**: The Supreme Court on Monday dismissed a plea seeking directions to the Centre and other authorities to immediately clear blockades on national and state highways in Punjab where farmers are staging protests.

A bench of justices Surva Kant and Manmohan said the matter is already pending before the court and it cannot entertain repetitive petitions on the same issue."We are already examining the larger issue. You are not the only conscience keeper of society. Don't file repetitive petitions. Some are filing for publicity interest and some are filing to play to the gallery. We cannot entertain repetitive petitions on the same issue," the bench told petitioner Gaurav Luthra, who claimed to be a social activist in Punjab. The court also refused Luthra's request to tag the petition with the pending matter. Farmers under the banner of the Samyukta Kisan Morcha (non-political) and Kisan Mazdoor Morcha have been camping at Shambhu and Khanauri border points between Punjab and Haryana since February 13 after their march to Delhi was stopped by security forces. The plea has alleged that farmers' and their unions have blocked the entire national and state highways in Punjab for an indefinite period. It sought directions to ensure that national highways and railway tracks are not blocked by the agitating farmers.

## **Bomb Threat Mail To Around 40 Delhi** Schools, Sender Demands USD 30,000 pm Sunday when the schools were

**NEW DELHI**: Around 40 schools in Delhi received a bomb threat mail Monday morning with the sender demanding USD 30,000, a police official said.

The threat was sent in a single e-mail marked to the city's prominent schools including DPS RK Puram: GD Goenka, Paschim Vihar; The British School, Chanakyapuri; The Mother's International, Aurobindo Marg; Modern School, Mandi House; DPS Vasant Kunj; Delhi Police Public School, Safdarjung; DPS East of Kailash and Salwan Public Schools.

Most schools that received the threat suspended their classes and sent students back home as officials said.

A Delhi Fire Service official said they received the first alerts about the bomb threats from DPS RK Puram and GD Goenka Paschim Vihar. He said bomb detection teams, fire

officials, local police and dog squads responded immediately and conducted searches at the schools. Nothing suspicious has been found

yet, a police official said around 9.30 He said said further operations

are underway. Sources said the email was

"I planted multiple bombs inside the building. The bombs are small and immediately as a precautionary measure. You are requested to kindly collect your wards from your respective



hidden very well. It will not cause very much damage to the building, but many people will be injured when the bombs detonate," the email read.

It also said, "You all deserve to suffer and lose limbs. If I do not receive 30,000 dollar. The group =E2=80=9CKNR=E2=80=9D is behind this attack," it reads.

In a message to parents, Mother Mary's School, Mayur Vihar, said, "An email was received this morning regarding a bomb threat in school. As such, the students are being dispersed

While taking his daughter back from the school, Harish, one of the parents, told PTI Videos, "I received a message about emergency from the school. This is the failure of the government as the schools are getting

such threats regularly." In May, more than 200 schools, hospitals and other important government installations in the city received a similar kind of bomb threat but the case is yet to solved as the mail was sent using Virtual Private Network.

## Rajya Sabha Witnesses Multiple Adjournments **Amid Uproar Over Cong-Soros 'Links'**

**NEW DELHI**: Rajya Sabha proceedings were disrupted on Monday as the treasury benches accused top Congress leaders of colluding with billionaire investor George Soros to destabilise the country, triggering protests from opposition members.

The Upper House witnessed three adjournments, including two during the pre-lunch session.

Soon after the House assembled for the day, it witnessed uproarious scenes with members of treasury benches on their feet, raising slogans and demanding answers from the Congress over reports of alleged links of some of its top leaders with Soros, who they accused of conspiring to destabilise the country and its economy.

Soon after a brief first adjournment during Zero Hour, Leader of the House J P Nadda said BJP members were agitated over an issue that involved

Congress leaders and wanted a discussion. "The link between Forum of Democratic Leaders in the Asia-Pacific (FDL-AP) and George Soros is a matter of concern. Its co-president is a member of

this House," he said. Nadda alleged the FDL-AP sees Jammu and support from the Rajiv Gandhi Foundation. Jammu tourism packagesJammu and Kashmir real estate As Chairman Jagdeep Dhankhar sought to know

why the ruling party members were protesting, many BJP MPs alleged that the top Congress leadership has links with Soros. They demanded that the issue be discussed in the House as it is connected to national security. Several MPs of the BIP and NDA allies raised

the issue and demanded an immediate discussion on it while Congress members claimed this was being done to divert attention from the Adani issue. Leader of the Opposition (LoP) Mallikarjun Kharge

and other Congress leaders like Jairam Ramesh and Pramod Tiwari asked how the chairman was allowing the ruling party members to raise the issue when he had rejected their notices in this regard. "It is wrong to raise the issue like this and damage the image of a member, who is not in the House,"

Kharge said. He also read out rules whereby any member cannot raise such an issue against another member, following which the chairman asked which member



he was referring to.

"We did not expect this from you," Congress' Digvijaya Singh told the Chair.

Congress' Pramod Tiwari alleged the ruling party MPs were siding with Adani and disturbing the House for him.

"The BJP is doing all this to protect Adani," he said. BJP MP Sudhanshu Trivedi said if the LoP was referring to another member, it becomes clear that the reports of involvement of a member are true, as the ruling party has not named anyone.

BJP's Radha Mohan Das Aggarwal said party MPs have not named any party and will speak during the discussion on how Congress leaders are colluding with elements of "deep state" and Soros to destabilise the country and break it into pieces.

"We want a discussion on this serious issue as they want to create instability in the country. These anti-nationals should be exposed before the country. Terror and anti-national activities are being carried out in the country at the behest of such forces and they should be exposed," he said.

The Congress, he claimed, was seen standing with such forces as it supported agitations in the

On the BJP's allegations about former Congress president Sonia Gandhi's links to an organisation financed by Soros, party MP Ghanshyam Tiwari said it is very bad for the country and its unity.

"We want that there should be a discussion

on the issue as it is linked to the issue of national security," he said.

Brij Lal of the BJP alleged Rahul Gandhi's trips abroad are funded by Soros.

### **Airtel Identifies** 8 Billion Spam Calls in Just 2.5 Months

Srinagar: Bharti Airtel, India's first spam-fighting network, has flagged a staggering 8 billion spam calls and 0.8 billion spam SMSes within two and a half months of launching its AI-powered spam detection system.

An official spokesperson said this advanced technology has successfully identified nearly 1 million spammers daily, alerting close to 252 million unique customers and contributing to a 12% decline in customers answering spam calls.

According to the report, 6% of all calls on the Airtel network and 2% of SMSes were identified as spam. Alarmingly, 35% of spammers used landline telephones to target users. Delhi customers received the highest number of spam calls, followed by those in Andhra Pradesh and Western Uttar Pradesh. Similarly, the

majority of spam calls originated from Delhi, Mumbai, and Karnataka. In the case of SMSes,

Gujarat topped the list of spam origins, followed by Kolkata and Uttar Pradesh, while Mumbai, Chennai, and Gujarat were the most targeted regions.

The analysis highlights that 76% of spam calls targeted male customers. Agewise, individuals aged 36-60 received 48% of spam calls, making them the most tar-



geted group, followed by the 26-35 age bracket, which accounted for 26%. Only 8% of spam calls were directed at senior citizens. Additionally, smartphones priced between 15,000 and 20,000 received 22% of all spam

Spam activity follows a daily pattern, starting at 9 am and peaking between 12 pm and 3 pm. Interestingly, spam calls decrease significantly by around 40% on Sundays.

This AI-driven initiative underscores Airtel's commitment to tackling the growing menace of spam. As India's first comprehensive spam-fighting network, Airtel continues to set new benchmarks in customer security, prioritizing privacy and convenience for its users.

## How Form and Substance Shape Our Existence

The relationship between form and substance lies at the heart of many philosophical, religious, and spiritual traditions, offering a profound lens through which we can explore the nature of existence and our place within it. Historically, these two elements have often been seen as dichotomous-form as the external, observable world of rituals, practices, and structures, and substance as the inner, unseen essence of thought, consciousness, and spirit. However, a more enlightened perspective encourages us to reconsider this separation, suggesting that form and substance are not opposing forces but rather supplementary complementary and reconciliatory dimensions of human experience. This dynamic interaction calls for a re-understanding of how outward practices can be deeply intertwined with inner truths, and how the external world, far from being a mere shadow of reality, is a vital expression of the deeper spiritual and philosophical essence that shapes our existence. By delving into this interplay, we find that the external world of form is not only a reflection of substance but also an essential channel through which we can engage with the profound mysteries of life, spirituality, and meaning.


In world sacred scriptures, the interplay between form and substance is emphasized as essential to true spiritual practice. The Bible highlights the need for sincerity in worship, as in Isaiah 29:13, where outward rituals are criticized without heartfelt devotion. The Quran, in Al-Bagarah 2:177, teaches that righteousness is not in outward rituals but in inner faith and charitable acts. "It is not their meat nor their blood that reaches Allah, but it is your piety that reaches Him" (Quran 22:37) The Bhagavad Gita (9:22) reveals that true devotion comes from a sincere heart, not external acts alone. Buddhism, in the Dhammapada (183), underscores that wisdom, not outward appearance, defines purity. The Tao Te Ching stresses that understanding comes from inner realization, not external knowledge (47). Zohar 1:19b: "The Torah is the lamp that illuminates the heart. Without the heart, there is no illumination; the inner light is that which

These scriptures collectively emphasize that external forms, when disconnected from inner substance, fall short of true spiritual realization.

In Western philosophy, Plato and Aristotle laid the foundation for discussions of form and substance. Plato's theory of forms, where the material world is an imperfect reflection of a higher, eternal realm, finds resonance in Rumi's mystical conception of the world. Rumi, like Plato, spoke of the material world as a reflection of a higher reality, where the soul seeks to transcend the external to reunite with the divine. For Rumi, the dervish's whirling form, for instance, was not simply an external practice but a manifestation of a deeper, internal state of spiritual ecstasy and transformation. Iqbal, too, emphasized this synthesis in his notion of selfhood, where individual realization moves from external practice to a profound, inward truth, a journey mirrored in his poetry's call for spiritual and intellectual awakening. His concept of the "Khudi" (selfhood) seeks to integrate the form of individualexistence with the substance of higher consciousness.

In Islamic mysticism, particularly in Sufism, the external forms of worship-such as prayer, fasting, and pilgrimage-are seen as symbolic pathways to deeper, more intimate experiences of the divine. Hafiz, one of the most celebrated Sufi poets, exemplifies this understanding in his work. For Hafiz, the forms of religious practice are not ends in themselves but serve to awaken the soul to its deeper essence, allowing one to experience the divine in a personal and intimate way. His poetry often emphasizes the mystery of the unseen, suggesting that the external forms of devotion are just veils, behind which lie the deeper, ineffable truths of divine love and unity. This resonates deeply with the works of Ibn Arabi, whose mysticism emphasized that the external world and rituals are but expressions of an infinite divine reality.

In the same tradition, Bedil and Jami echoed similar themes of the external as a reflection of the internal. Bedil,



a Persian Sufi poet, explored the idea that the forms of the world are illusions, with the essence of existence lying in the internal realization of the divine. His poetry often invites readers to transcend the forms and seek the deeper truth hidden within. Jami, too, emphasized the mystical union with the divine as a return to the origin of all substance, with the external practices merely guiding the soul to that realization.

In the Western philosophical tradition, Aristotle's rejection of Plato's separation between form and substance gave rise to a more integrated view, where form and substance are inseparable. This idea of integration finds its expression in the works of Emily Dickinson, who explored the tension between external appearance and internal truth in her poetry. Her poems, often quiet and intimate, reveal how external actions and words are insufficient to capture the depth of internal experience. Walt Whitman, in contrast, celebrated the connection between form and substance in a more expansive way, particularly through his poetry's exploration of the body and the soul, the material and the spiritual, as mutually constitutive. For Whitman, the form of the body and the substance of the soul are bound together, one enriching the other, in a dance of unity and purpose. Similarly, William Blake in his works like The Marriage of Heaven and Hell explored the relationship between the visible and the invisible, the physical and the spiritual, showing how both are part of a single, dynamic process.

In Heidegger's existential philosophy, the duality of form and substance is re-imagined in terms of being and becoming. Heidegger's concept of "being-in-the-world" emphasizes that the essence of existence is found not in abstract concepts but in the lived experience of being. His view echoes the insight found in S.H. Nasr's thought, where the understanding of external forms-whether religious or philosophical-must be grounded in an understanding of the inner reality of being. Nasr's focus on perennial wisdom highlights how forms, whether rituals or sacred symbols, are essential vehicles for realizing deeper, timeless truths about human existence and the divine.

In Schuon's work, the idea of form and substance is particularly vital to understanding the relationship between the outer world and the transcendent. Schuon, a scholar of perennialism, argued that the forms found in religious rituals, sacred art, and symbols are reflections of deeper metaphysical realities. He suggested that the external forms serve as conduits to the divine, guiding

as forms that provide access to the ultimate, formless reality of Brahman. Adi Shankaracharya's teachings in Advaita Vedanta present the non-duality of form and substance, where the external world of forms is not illusory but a reflection of the ultimate truth. This understanding is mirrored in the works of Ramakrishna and Vivekananda, who emphasized that the forms of worship-whether in temples, rituals, or devotion to the Divine Mother-are vehicles for the realization of

the absolute, formless Brahman. The Bhakti poets, such as Mirabai and Kabir, also navigated the tension between form and substance in their poetry. For Kabir, devotion was not confined to rituals alone but was an inner realization that transcended external practices. His poetry called for an experiential understanding of God, one that does not depend on external forms but instead comes from an inner, personal connection. Similarly, Mirabai, in her devotion to Krishna, saw the form of Krishna as a means to access the divine substance, but her poetry reveals a profound internalization of that connection, making her devotion deeply personal and experiential.

In Buddhism, especially in Mahayana and Zen traditions, form and substance are understood through the concept of nyat (emptiness). Nagarjuna's philosophy of emptiness challenges traditional notions of form and substance, proposing that both are empty of inherent existence. This idea suggests that form and substance, rather than being separate, are interdependent and inseparable. Rilke, in his poetry, mirrors this understanding, exploring the emptiness of form and the infinite potential that lies within the dissolution of fixed identities. His work often reflects the tension between the outer appearance of things and their deeper, hidden meanings, much like the Buddhist concept of emptiness.

In Confucianism, external forms of ritual are seen as vital for cultivating the inner substance of moral virtue. Confucius taught that the external forms of li (rituals) are necessary to shape a person's character and bring harmony to society. However, these forms must be infused with the inner substance of moral intention, for it is the inner sincerity that gives meaning to external actions. This understanding of form and substance is complemented by the insights of Mencius, who argued that virtue is inherent in human nature, and the role of ritual is to cultivate and manifest that internal goodness. This view can be extended to modern discussions of identity and authenticity, as seen in the works of Michel Foucault, who explored how external societal structures influence the internal substance of individual identity, often distorting it or guiding it toward conformity.

The tension between form and substance in modern secular contexts becomes evident in the work of Jean-Paul Sartre and Michel Foucault, who focused on the tension between external, imposed social structures and internal personal authenticity. Sartre's existential philosophy, particularly his concept of bad faith, explored how individuals may live inauthentically by conforming to external expectations, forsaking the internal, authentic self. Foucault, in his genealogies of power and knowledge, examined how external institutions shape and define the internal realities of individuals. Their work underscores the challenge of reconciling the form (external expectations) with the substance (authentic personal identity), a theme that resonates with the current age of social media and identity politics.

The visionary re-understanding of form and substance, as seen in the writings of Blake, Whitman, and Nasr, encourages a holistic view that recognizes the interdependence of both aspects. Rather than viewing form and substance as separate or hierarchical, a comprehensive understanding suggests that forms are not mere reflections of inner truths but essential vehicles through which those truths are realized. This understanding enriches our approach to spiritual practice, philosophical inquiry, and cultural transformation, revealing how the external and internal dimensions of life are dynamically intertwined. Whether through the mystical poetry of Ghalib, the philosophical insights of Nasr, or the existential reflections of Heidegger, the relationship between form and substance remains a profound source of exploration, offering new pathways for understanding human existence, spirituality, and the world around us.

The interplay between form and substance invites us into a more holistic understanding of human existence, one that transcends dualities and embraces the interconnectedness of all things. Whether through the philosophical insights of ancient thinkers, the mystical poetry of Sufi saints, or the reflections of modern existentialists, the relationship between form and substance challenges us to align our external actions with our internal truths. It is not enough to merely engage with one aspect of existence; rather, we are called to integrate form and substance, allowing each to inform and elevate the other. In this way, the external world becomes not just a passive reflection but an active participant in our spiritual and intellectual journey. However, when thyroid levels are abnormal, it throws the loop out of balance. This alters hormone levels throughout the body, affecting mood and other bodily functions.

Treatment goals for hypothyroidism include reversing clinical progression and correcting any metabolic abnormalities such as TSH and thyroid hormone levels, specifically free thyroxine (T4).

#### Who might be affected?

Thyroid disorders can affect anyone at any age but are much more likely to affect women between ages 20 and 40. However, as people age, that risk increases. People over age 60 have an increased chance of developing a thyroid disorder. The American Thyroid Association  $recommends\, screening\, at\, the\, age\, of\, 35\, years\, and\, then$ every 5 years thereafter. High-risk patients include pregnant women, patients with type 1 diabetes or

From day five to 14, breast milk is called transitional milk. It is creamier due to its higher content in fat and is also full of nutrients and bioactive ingredients. Mature milk is the milk formed from four weeks onwards. It is rich in macro and micronutrients, hormones, enzymes, growth factors and live cells needed to support the baby's

### growth and development.

### Mature breast milk composition

Human breast milk contains about 87-88% water, 7% carbohydrates, 1% protein and roughly 3.8% fats. Typically, mature milk contains about 65-70 kcal per 100 mL of energy, with about half of the total caloric energy coming from fats and 40% from carbohydrates. The composition varies depending on the mother's diet, mother's overall health and other factors.

Proteins. The most abundant proteins in breast milk are whey and casein. Proteins are essential for the growth, development and proper function of all cells and the body's tissues. Certain proteins also play important roles in fighting infections. For example, whey contains lactoferrin, which can inhibit iron-dependent bacteria and fungi. Another whey protein component called secretory IgA helps protect the baby from viruses and bacteria and may also help prevent allergies.

Lactose, also known as milk sugar, is the main source of carbohydrates. Lactose plays an essential role in nutrition and the development of the baby's gut flora. Furthermore, gut flora supports immune system function, digestion,

### and brain health.

Fat content varies significantly, with lower amounts found in the full milk lactating breast to higher amounts in the more drained lactating breast. Breast milk contains different fats, including triglycerides, essential fatty acids, linoleic acid and alpha-linolenic acid. The content of omega 3 fatty acids depends on the mother's diet- the milk is richer in omega 3s if the mother consumes more of them in the diet or takes supplements. Fats provide energy for the baby and are important for the development of the brain, eyes, immune system, and growth. Fats also help the baby absorb fat-soluble vitamins A, D, E and K.

The mother's diet highly influences the vitamin content of breast milk. For this reason, healthcare providers recommend a well-balanced nutritious diet and to continue supplementing with prenatal vitamins during lactation. Babies may require vitamin D and K supplements if exclusively breastfed because breast milk may not provide sufficient amounts. Lactating mothers who are vegan or vegetarian need additional supplementation with B vitamins, particularly

Breast milk contains 20 minerals, including iron, copper and zinc, with higher amounts in colostrum. Unlike vitamins,

the content of minerals in the breastmilk is not significantly affected by the mother's diet or supplement intake. Iron supplements are not recommended before 4-6 months of age. After six months of age, iron-enriched foods can be introduced into the diet.

Breast milk contains various compounds, including hormones like insulin, leptin and ghrelin, which regulate the metabolism and support immune health.

Growth factors play key roles in blood vessels, digestive system, brain and hormonal balance development.

Among other bodily fluids, breast milk is one of the richest sources of microRNAs. MicroRNAs are biologically active compounds that play essential roles in immune health, growth and development.

Breast milk is not sterile

In the past, it was believed that breast milk was sterile. However, research from the last two decades found that milk contains a microbial community, including plenty of friendly bacteria. A recent study identified 820 microbial species, including some strains of Lactobacillus and Bifidobacterium, in the human milk microbiota. Scientists are still investigating how these bacteria accumulate in the milk and their role in the baby's health.

"This has sent waves of despair among deserving students who worked hard to secure high ranks. How can a student with a rank of 90,000 get MD Radiology, while someone with rank 739 is denied a seat in the same branch?" questioned a student representative, as per news agency KNS.

The students also criticized Rule 17, describing it as "draconian and unique to J&K." Under this rule, reserved category candidates securing a seat in OM can upgrade to higher specialties, but the vacated OM seat is reallocated to the reserved category instead of being returned to the OM pool.

"This leads to a double advantage for reserved category candidates and further reduces the number of seats for OM candidates. No other state in India has such a policy," another protesting student told KNS. The students emphasized the importance of merit in specialty

courses like MD/MS, arguing that these fields require high levels of competence to ensure quality healthcare. They highlighted that all MBBS students study under similar conditions, access the same resources, and are assessed equally, making merit-based

Additionally, the students called for the implementation of a bond system for PG and DM courses in J&K, as practiced in other states. They believe this would encourage doctors to serve in underserved areas and address healthcare disparities in the region.

The protesting students have appealed to the J&K administration to restore the OM quota to a fair percentage, abolish Rule 17 to prevent double allocation of seats to reserved categories and implement a mandatory bond system for PG and DM graduates.

These steps, the students argue, will uphold meritocracy and ensure equitable access to medical education, ultimately benefiting the healthcare system.

If the central government's policy has changed, then take them wherever you want, but as long as they are here, they must not be treated like animals. They are human beings and must be treated as such," he added.

# Stokes lauds England's 'more dominant cricket' for series win in NZ

England needed just three days to secure a 2-0 lead in the three-match series, rounding out a thrashing of 323 runs at the Basin Reserve on Sunday afternoon. It comes a week



Latham ceding his side were unable to cope with the pressure they were put under by

after winning the opener at Hagley Oval by eight wickets.

England arrived on day three on 378 for 5 in their second innings, already leading by 533. Joe Root's 36th Test hundred eventually set New Zealand an improbable 583. They were bowled out for 259.

The bulk of the work had been done on day one. England battled seaming conditions by sprinting to 280 all out inside 55 overs thanks to a remarkable 123 from Player-of-the-Match Harry Brook. They then channeled those same conditions to dismiss New Zealand for 125 in their first innings, with Brydon Carse's 4 for 46 and Gus Atkinson's 4 for 31 (including a hattrick to finish the innings) leading the charge.

Stokes asserted it was England's aggressive nature that allowed them to boss this match, and the series sofar, particularly when up against it. Here, they were 43 for 4 before making it to 280. It was reminiscent of the first Test, when they rallied from 71 for 4 to make 499 - courtesy another Brook century - after New Zealand had posted 348.

"To play the more dominant cricket over the days we have played so far," answered Stokes when asked how this first away win in New Zealand for 16 years had been achieved.

"In this Test in particular, on day one we were 43 for 4 to be here on the winning side on day three is quite phenomenal. We got bowled out in fifty overs (54.5) but we had 270 runs on the board which was a good score on that day one-wicket, and then we obviously had time left with the ball to be able to make some inroads. To score 270 and take five wickets at the end of day one (New Zealand closed on 86 for 5) really set this game up."

"We back ourselves to be able to go out there and change games and we feel that there needs to be a bit of impetus put into the game, particularly with the bat.

"As a bowler you want to be able to plonk it on a length and plonk it onto the top of off stump over and over again. But sometimes when a batter is brave enough to take you on and knock you off your length, it's very hard to commit to still doing that."

Latham begrudgingly agreed with the sentiment. Though New Zealand knew what to expect-this was their seventh meeting and sixth defeat against England in the Bazball era. They were unable to halt the tourists' - especially Brook's - intent.

"It's the pressure they are able to put you under, especially with the bat. I think on day one it was offering enough for our bowlers and the way Harry played in that innings was outstanding.

"Credit where it's due. The way he played puts you under pressure from ball one. He played some incredible shots that you don't necessarily see from other teams around the world."

Meanwhile, Stokes was unwilling to be drawn on whether Jacob Bethell has emerged as a challenger to Ollie Pope's regular position at No.3.

Following Jordan Cox's broken finger, sustained on the final morning of England's warm-up match in Queenstown, the decision was made to move Pope to six to allow him to keep wicket, with Bethell, the spare batter, brought in at first drop.

Shastri, Gavaskar urge 'subdued' Rohit to return to opener's role

**ADELAIDE:** Former India players Ravi Shastri and Sunil Gavaskar want skipper Rohit Sharma to return to the opening spot so that he can be his aggressive and expressive self.

Rohit, who had missed the first Test, dropped down to the number six spot in the pink ball Test after KL Rahul excelled at the top in the series opener in his absence.

However, the Indian skipper looked "too subdued" as he managed scores of 3 and 6 in India's 10-wicket loss here.

"That's the reason I want him at the top. That's where he can



be aggressive and expressive. Just thought he was a little too subdued, just seeing his body language, "Shastri told 'Star Sports'.

"The fact that he didn't make runs, I don't think there was enough on the field there. I just wanted to see him more involved, and a little more animated," the former India coach added.

Ahead of the Adelaide Test, Rohit stated that he didn't wish to tinker with a combination that brought the team success in the series opener which the visitors won by 295-run win at Perth. He even batted in the middle order in the warm up game in Canberra. However, Rohit did admit it was not an easy decision for him to take personally.

"Personally, it was not easy. But for the team, yes, it made a lot of sense," Rohit, batted in the middle order for the first time since 2018, had said.

Rahul, who had looked solid with scores of 26 and 77 while sharing a 201-run partnership with fellow opener and centurion Yashasvi Jaiswal in the second innings of the first Test, failed to replicate his form in the second match.

Rahul's failure to capitalise on the opportunity has prompted former India captain Gavaskar to call for Rohit's return to his opening slot.

"He should return to his regular spot. We should remember why Rahul had opened. He did that because Rohit Sharma was not available for the first Test," Gavaskar said on 'Sports Tak'.

"In this Test in particular, on day one we were 43 for 4 to be here on the winning side on day three is quite phenomenal. We got bowled out in fifty overs (54.5) but we had 270 runs on the board which was a good score on that day one-wicket, and then we obviously had time left with the ball to be able to make some inroads.
