JKHC seeks govt response on controversial reservation policy

Hearing scheduled for December 27

SRINAGAR: The Jammu and Kashmir High Court has issued a notice to the J&K government, seeking its response to a petition challenging the



region's current reservation policy. The move comes amid ongoing public debate over the fairness and rationale of the policy.

According to the news agency—Kashmir News Observer (KNO), the petition, filed by Dawar Ali with the support of the Jammu & Kashmir Civil Society, raises questions about the transparency

and equity of the existing framework. The plea, listed as WP(C) 2864/2024 and CM(7835/2024), was argued by Team JUS Advocates & Solicitors Front from New Delhi, led by Advocate Junaid Mohammad Junaid.

The petition demands the annulment of the current reservation policy and calls for the establishment of an independent panel to reform and rationalise the reservation system within a defined timeframe.

A bench comprising Justice Rajnesh Oswal and Justice Mohd Yousuf Wani directed the J&K government to submit its reply within three weeks. The court has also clubbed this case with a related petition, WP(C) 2762/2024. The next hearing has been scheduled for December

Advocate Junaid said it is important to ensure constitutional fairness in the reservation system. "This petition does not aim to target any specific group but seeks to

44 J&K residents among 75 evacuated from Syria: MEA

SRINAGAR: The Ministry of External Affairs (MEA) on Wednesday said that the Government of India has evacuated 75 Indian nationals including 44 J&K residents from Syria, following recent developments in the country.

The evacuees included 44 'zaireen' from Jammu & Kashmir who were stranded at Saida Zainab, it said, adding that all Indian nationals have safely crossed over to Lebanon and will return by available commercial flights to India.

As per the news agency—Kashmir News Observer (KNO), it also said that the evacuation, coordinated by the embassies of India in Damascus and Beirut, was put into effect following the assessment of the security situation and requests from Indian nationals in Syria. The MEA said that the Government of India accords the highest

priority to the safety and security of Indian nationals abroad.

Plains Likely To Receive Season's First Snowfall

MeT predicts cold weather for next 10 days

SRINAGAR: The higher reaches of Kashmir including a tourist destination, Sonamarg experienced fresh snowfall on Wednesday while as per the forecast; a few areas of plains would likely receive the season's first snowfall in the next 24 hours.

According to the news agency-Kashmir News Observer (KNO), almost four inches of snowfall accumulated at the picturesque Sonamarg area today, bringing down the mercury further across the Valley.

An independent forecaster has predicted rains and snow showers at many places of

Kashmir for the next 24 hours. According to the forecast, light to moderate snowfall is expected at higher reaches including Gulmarg, Sonamarg, Doodhpatri, Pahalgam, Peer Ki Gali, Sinthan top, Razdan top, Zojila pass and other upper reaches during the period.

"Light rain is expected at some plains of Kashmir with slight possibility of season's first light snowfall at a few plains 45% chances during the next 24 hours," the forecast reads.

The local Meteorological department has however predicted no significant weather activity till December

No Possibility Of Alliance With Congress For Delhi Polls: Kejriwal

NEW DELHI: AAP supremo Arvind Kejriwal on Wednesday once again ruled out the possibility of an alliance with the Congress for the Delhi assembly polls, amid reports that the two parties could be jointly contesting the elections.

In a post on X, Kejriwal said the Aam Aadmi Party (AAP) will be fighting the election on its own strength in Delhi.

'There is no possibility of any alliance with the Congress," the former Delhi chief

His reaction comes amid media reports that the two parties were likely to have a tie up for the 70-member Delhi Assembly polls due in February.

Earlier this month also, Kejriwal had ruled out the possibility of the alliance between the AAP and the Congress for the Delhi elections.

The recent buzz over alliance between the two Indian National Developmental Inclusive Alliance (INDIA) partners was fuelled by cancellation of the Congress'



'Nyay Chaupal' event scheduled on Wednesday in which party leader Rahul Gandhi was to participate.

The event was to be held as culmination of the "Nyay Yatra" taken out by the Delhi Congress across Delhi ahead of the assembly

Also, Kejriwal on Tuesday met NCP chief Sharad Pawar amid the rising demand in the INDIA block to appoint West Bengal Chief Minister Mamata Banerjee as head of the political grouping currently chaired by Congress president Mallikarjun Kharge. However, neither Kejriwal nor AAP

have so far commented on the discussions in the meeting.

These developments were seen as the Congress and AAP making their moves cautiously in view of the upcoming Delhi polls so that the future options remain open, sources said.

The AAP and Congress fought the Lok Sabha elections in Delhi together earlier this year but lost on all the seven seats against the BJP. However, they failed to reach a seat-sharing agreement ahead of the Haryana Assembly polls in October despite several rounds of talks.

The AAP has so far released two lists of its total 31 candidates so far. The list of remaining candidates is expected to come soon.

Out of power in Delhi since 1998, the BJP is making all-out efforts to wrest power from the AAP.In the 2015 and 2020 Delhi Assembly polls, the AAP won 67 and 62 seats and the BJP won three and eight seats respectively. The Congress drew a blank.

NIA Raids 9 Locations In Punjab, Haryana In Gangster-Terror Nexus Case

NEW DELHI: The National Investigation Agency (NIA) conducted searches at nine locations in Punjab and Haryana on Wednesday (December 11, 2024) as part of its ongoing investigation into the gangster-terror nexus case.

The raids are underway at eight locations in Punjab and one in Haryana since early Wednesday following a tip-off against suspects linked to the case. The raids are reportedly aimed at cracking down on individuals and networks suspected of facilitating criminal activities linked to terrorist organizations.

This follows the agency's intensified efforts to curb the growing nexus between gangsters and terror groups operating in the region.Last month, the agency in a massive crackdown on the terror-gangster nexus case had also conducted extensive searches at premises linked with associates of the Davinder Bambiha syndicate at nine locations in Punjab,

NIA teams then conducted searches at the premises of suspects in the terror-gangster syndicate case in Palwal, Faridabad and Gurugram

districts of Haryana, Jalandhar district of Punjab, and Mathura district of Uttar Pradesh.

A host of incriminating materials, including mobiles and digital devices, banking transactions



and property-related documents, were seized during the searches. The searches were part of NIA's continuous crackdown on terror outfits engaged in criminal conspiracies to smuggle terrorist hardware, such as arms, ammunition, narcotics, explosives etc, into India.

NEW DELHI: Several opposition parties on Wednesday said the "partisan" conduct of Rajya Sabha Chairman Jagdeep Dhankhar prompted them to move a notice for his removal as vice president and alleged that

"The Rajya Sabha chairman's conduct in the House has harmed the country's dignity," he alleged.

Illegal Rohingya immigrant bought land in Pune, built house: Police

PUNE: A Rohingva man from Myanmar arrested earlier this year for allegedly living in India illegally

and built a house using earnings from his supari-selling business, a police official said on Wednesday.



had bought land in Pune area and built a house for himself and his family, investigation has found.

In July, Pimpri-Chinchwad Police arrested two Rohingya couples for illegal entry and stay in the country. Probe revealed that one of them.

Muzammil Khan (45), had purchased a small plot of land in a Dehu Road locality for Rs 80,000,

He and his wife had acquired Aadhaar and PAN cards besides Indian passports

They had been living in the area since 2013, police found. Khan told police he fled Myanmar

in 2012 with his family, seeking shelter in a refugee camp in Bangladesh before crossing

the border illegally and entering

West Bengal.

Haryana and Uttar Pradesh.

After arriving in Pune, he worked in a company and later got into supari

The couple acquired Aadhaar and PAN cards from Bhiwandi in Maharashtra.

The land was purchased without legal documentation from a woman named Kamble and there is no record of the transaction in official land records, the police official said.

"Khan had obtained Indian passports for himself, his wife, and two children, and was planning to visit Mecca,"

the officer added.

Though he had trained as a Maulana or cleric in Myanmar, he did not seem to have put the training to use while living in Pune.

The Khan couple's arrest followed the arrest of Ismail alias Shahid Shaikh, a Rohingya who and his wife were suspected to have entered India illegally.

Both the couples were booked under the Passport Act and the Foreigners Act. A chargesheet has been filed in the case, and the accused are currently out on bail. Authorities have initiated proceedings to cancel their passports.

Maharashtra cabinet expansion likely by Dec 14; Fadnavis to meet PM in Delhi

MUMBAI: The cabinet expansion of the Devendra Fadnavis-led Maharashtra government is likely to take place by December 14, a senior BJP leader said on Wednesdav.

Fadnavis left for Delhi on Wednesday, his office said, adding it was a courtesy visit, the first after becoming the chief minister, as he



would be meeting Prime Minister Narendra Modi, President Droupadi Murmu and Vice President Jagdeep Dhankhar.

Talking to PTI, a BJP leader said the Shiv Sena would not get the home department and was also unlikely to be allocated the revenue portfolio.

Talks are getting delayed because three rties (Mahavuti allies RIP Shiv Sena and NCP) are involved, the politician said.

"The cabinet expansion is likely by December 14. The allocation of home department to Shiv Sena is ruled out. The Shiv Sena may get urban development, but is unlikely to get revenue," said the leader, who did not wish to be named.

The BJP is expected to keep 21 to 22 ministerial berths, including the CM's post, the leader said, adding that four to five ministerial berths may be kept vacant.

Shiv Sena leader and Deputy CM Eknath Shinde was not travelling to the national capital, as per his office.

On December 5, Fadnavis took oath as CM along with Shinde and NCP leader Ajit Pawar as his deputies, after the Mahayuti alliance won 230 of the 288 seats in the state assembly polls. The Maharashtra cabinet can have a

maximum of 43 ministers, including the chief minister.

Sikh preacher Dhadrianwale booked for rape, murder: Punjab Police tells HC

CHANDIGARH: Punjab Police has registered a case against Sikh preacher Ranjit Singh Dhadrianwale in a 2012 case of alleged rape and murder of a woman in Patiala, the Punjab and Haryana High Court was informed.

The FIR under section 302 (murder), 376 (rape) and 506 (criminal intimidation) of the Indian Penal Code has been registered at Passiana Police station in Patiala on December 7, according to an affidavit filed by Punjab Police Director General of Police Gaurav Yadav before the high court on Tuesday. The FIR was lodged on a complaint filed by the victim's

brother, a Patiala resident.

Sikh preacher Dhandrianwale, who heads Parmeshwar Dwar gurdwara, a dera in Shekhupura village in Patiala, has a large following in Punjab and among the Punjabi diaspora abroad.

Dhadrianwale, in a video message, said he would cooperate with the police investigation.

"They (the family) have moved the high court. They have a doubt and they should clear their doubt. The high court has said investigate the case after registering the FIR. It may take some time but the truth will come out. I have

full faith in the high court and the Punjab Police," the Sikh preacher said. The DGP's affidavit came after the victim's brother alleged that his sister was raped and murdered. He further alleged that no action was taken by police at the time of the incident.



The petition of the woman's brother was taken up in November and during the previous hearing, the bench presided over by Chief Justice Sheel Nagu had asked the DGP to explain as to what action has been taken against officials who handled the case in 2012.

Modi Govt Believes In Democratising Technology: Vaishnaw In Lok Sabha

NEW DELHI: The Government on Wednesday said it is "open to the idea" of bringing in a new law to regulate artificial intelligence but a "lot of consensus" is required for it.

Responding to a question in the Lok Sabha, IT Minister Ashwini Vaishnaw also

said that the Modi Government believes in "democratising technology" which was not the case during the Congress rule, remarks that triggered protests by opposition benches.

Responding to a supplementary on whether the Government plans to bring a law on regulating artificial intelligence, Vaishnaw also said that fake narratives is a major challenge faced by societies across the world today.

He said accountability has to be established in the society and the legal framework has to change for which "lots of consensus" is required because as on the one hand there is freedom of speech and creating of a real, proper news network on the other.

Wildlife Department Cracks Down on Poaching at Wular Lake

SRINAGAR: The Department of Wildlife Protection, Wetland Division, has launched a series of raids in the Srinagar area following social media videos allegedly showing individuals involved in poaching activities at Wular Lake.



The action followed in response to social media videos showing individuals involved in illegal activities. The videos depicted individuals carrying firearms, suggesting involvement in wildlife hunting, prompting swift action from the authorities.

In a first of its kind, the department on December 10 conducted coordinated raids at multiple locations, aiming to apprehend those involved. During the raids, one accused from Habak area of Srinagar was arrested and a gun was seized from his house, while various decoys and gears used during illegal hunting were seized during the search operation at premises of other accused from Lal bazar area of Srinagar.

Deputy Conservator Wetlands, Altaf Hussain, stated that an investigation into the matter has commenced, and summons have been issued to other suspects for further

"The department is committed to taking strict action against poaching and ensuring the protection of wildlife," Hussain said, emphasizing a policy of zero tolerance toward illegal activities in protected areas.

The raids are being seen as a significant step in combating poaching activities and preserving the ecological balance of the region's wetlands.(KNS).

CEO Bandipora Directs Schools to Adhere Strictly to JKBOSE Curriculum

BANDIPORA: The Chief Education Officer (CEO) Bandipora on Wednesday warned the private schools for forcing parents to purchase books other than approved and published by JKBOSE.

In a circular issued on Wednesday, CEO instructed all government and private schools affiliated with the Jammu and Kashmir Board of School Education (JKBOSE) in the district to strictly implement the curriculum and textbooks prescribed by JKBOSE from the upcoming academic session

CEO Bandipora instructed the Schools not to compel parents or students to purchase books or materials other than those approved and published by JKBOSE. "Any non-compliance with these directives will invite strict disciplinary actions, which may include penalties or other statutory mea-

The directive, issued in compliance with a notification by JKBOSE under the IKBOSE Act 1975 and subsequent amendments under the Reorganization Act 2019, aims to ensure uniformity in the education system and prevent the imposition of unauthorized study material.

The circular also advises parents to report instances where schools enforce the use of unauthorized textbooks to the concerned Zonal Education Offices. School heads have been cautioned to adhere rigorously to the guidelines, with a stern warning that deviations will be dealt with seriously under the rules.

Officials said this step is expected to bring clarity and uniformity to the curriculum followed across schools, benefiting both students and parents in the district.

Forest Fire Ravages Bandipora for Four Days, Hundreds of Trees Lost

BANDIPORA: A massive forest fire has been raging in multiple forest belts across North Kashmir's Bandipora district for the past four days, causing extensive damage to the district's green gold.



Despite efforts by locals and forest officials, the flames remain out of control and continue to spread to nearby forest compartments.

Locals reported that the fire is visible from major roads in the area and has already consumed hundreds of trees. "Villagers and Forest Protection Force officers have been working tirelessly to douse the flames, but

the situation remains grim," a local resident said. Authorities have attributed the fire to the prolonged dry spell, which has allowed the flames to spread rapidly across compartments. "Efforts are underway to control the forest fire using the latest techniques, but the dry weather and remote location of the villages are making the task challenging," an official said.

Earlier this month, forest fires were reported in Doban, Aloosa, Konan, and Ajas forests, prompting emergency deployment of personnel and machinery to control the flames. However, locals allege that the response from the forest department has been inadequate, with fires continuing to cause substantial damage to the region's ecosystem.

"This is not the first time we are witnessing such devastation. Forest fires have become a recurring problem, yet the authorities fail to take proactive measures to prevent them," said a local from Ajas.

Notably, a massive blaze in Ajas forests last week caused significant damage to thousands of trees and remains uncontrolled. Similarly, fires in Aloosa, Doban, and Konan earlier this month wreaked havoc, lasting for days and destroying vast stretches of forest cover.

The locals criticized the forest department for its perceived failure to take tangible steps to address the fires. They expressed frustration over the lack of preparedness and the apparent inability to extinguish the flames promptly, despite the escalating frequency of such incidents.

Repeated attempts to reach the Divisional Forest Officer (DFO) Bandipora for a comment were unsuccessful.

Now in America too, preparations are being made to hold a big demonstration against it near the White House, the President's House. Despite this, the interim government of Mohammad Yunus in Bangladesh is not ready to give up its anti-India agenda under pressure from fundamentalists to China-Pakistan. Now the Yunus government has taken another step, which is going to give a big shock to India. The Yunus government has canceled an agreement related to mobile internet connectivity made with India during the tenure of Sheikh Hasina. Through this agreement, India was trying to increase the speed and coverage of the Internet in its Northeast states, but now this hope has been shattered. Amidst the attacks on ISKCON temples in Bangladesh, such reports are also coming out that the Pakistani intelligence agency ISI is engaged in preparing terrorists against India from among the Rohingya refugees present in Bangladesh.

Ethnic cleansing of Hindus is going on in Bangladesh. After 53 years, Pakistan is sending arms to Bangladesh. Meetings are also taking place between Khalida Zia and Pakistani officials. He is the younger brother of Awami League MP Fariq Khan. This is also believed to be the reason behind the decision of the Yunus government.

In Bangladesh, a mob of extremists has once again targeted the ISKCON temple. Radharaman Das, Vice President of ISKCON Kolkata, said that a mob of extremists has attacked the ISKCON temple in Namhatta, Dhaka.

He said that after attacking the Namhatta temple on Friday-Saturday night, extremist Muslims sprinkled oil on all the idols and set them on fire. The entire temple has been burnt. This temple is located in Dhaur village Rohingya refugees into terrorists in Bangladesh. 

An early menopause could also come from the stress of working late at night, as stress hormones are believed to disrupt sex hormones like oestrogen. Women who work in night shifts, even occasionally, are at an increased risk of early menopause, which can heighten the possibility of developing cardiovascular disease, osteoporosis and memory problems, finds a new study. The study showed women who had

done continued night shifts for 20 months or more in the preceding two years had a 9% increased risk of early menopause, the Daily Mail reported. If they had done rotating night shifts for more than 20 years, the risk rose to 73%. "For women who went through menopause before the age of 45, shift work seemed to be particularly important. This could be due to disruption of their circadian rhythms,

stress or fatigue, although more research is needed," lead author David Stock, from the University of Dalhousie in Canada, was quoted as saying. An early menopause could also come from the stress of working late at night, as stress hormones are believed to disrupt sex hormones like oestrogen. This could also increase the chance that a woman stops ovulating, according to the study published in the journal

Human Reproduction. Previous evidence suggests working in 'high-strain' jobs and those with 'difficult schedules' is linked to earlier menopause.

For the study, the team studied more than 80,000 nurses who worked at least in the night shifts in a month for over 22 years in addition to day and evening shifts.

Banana plant extract may help you relish melt-proof ice cream

NEW YORK: Love to savour your ice cream in its solid state for longer and hate to see it melt? Scientists have found a solution to this problem in a banana plant extract that they say could be key to a creamier and longer lasting ice cream.

The findings showed that adding tiny cellulose fibres extracted from banana plant waste to ice cream could slow melting, increase shelf life and potentially replace fats used to make the tasty treat.

"Our findings suggest that cellulose nanofibres extracted from banana waste could help improve ice cream in several ways," Robin Zuluaga Gallego, from the Universidad Pontificia Bolivariana, Colombia.

"In particular, the fibres could lead to the development of a thicker and more palatable dessert, which would take longer to melt. As a result, this would allow for a more relaxing and enjoyable experience with the food, especially in warm weather," Gallego added.

For the study, presented at the 255th National Meeting and Exposition of the American Chemical Society in New Orleans, the team extracted cellulose nanofibrils (CNFs), which are thousands of times smaller than the width of a human hair, from ground-up banana stems or rachis. Then they mixed the CNFs into ice cream at varying concentrations, ranging from zero up to threetenths of a gram per 100 grams of the dessert.

They found that ice creams mixed with CNFs tended to melt much more slowly than traditional ice creams. They also determined that CNFs could increase shelf life of ice cream, or at least decrease its sensitivity to temperature changes that occur when moved to and from the freezer.

In addition, CNFs increased the viscosity of low-fat ice cream, which improved the creaminess and texture of the product.

This suggests that CNFs could help stabilise the fat structure in ice creams. As a result, CNFs could potentially replace some of the fats -- and perhaps reduce calories -- in these desserts, the researchers noted.

Moving forward, the researchers plan to explore how different types of fat, such as coconut oil and milk fat, affect the behaviour of CNFs in other frozen treats.

Sugary drinks linked to increased cancer risk:Study



Higher consumption of sugary drinks may be associated with an increased risk of cancer, according to a study published in the British Medical Journal (BMI)

in the British Medical Journal (BMJ).

The findings add to a growing body of evidence indicating that limiting sugary drink consumption, together with taxation and marketing restrictions, might contribute to a reduction in cancer cases. The consumption of sugary drinks has increased worldwide during the last few decades and is convincingly associated with the risk of obesity, which in turn is recognised as a strong risk factor for many cancers, said researchers, including those from the University of Paris 13 in France.

However, research on sugary drinks and the risk of cancer is still limited.
Researchers set out to assess the associations between the consumption of sugary drinks (sugar sweetened beverages

and 100 per cent fruit juices), artificially sweetened (diet) beverages, and risk of overall cancer, as well as breast, prostate, and bowel (colorectal) cancers. The findings are based on 101.257 healthy French adults (21 per cent men; 79 per cent women) with an average age of 42 years. Participants completed at least two 24-hour online validated dietary questionnaires, designed to measure usual intake of 3,300 different food and beverage items and were followed up for a maximum of nine years. Daily consumption of sugary drinks and artificially sweetened (diet) beverages were calculated and first cases of cancer reported by participants were validated by medical records and linked with health insurance national databases.

Average daily consumption of sugary drinks was greater in men than in women. During follow-up 2,193 first cases of

breast cancers, 291 prostate cancers, and 166 colorectal cancers). Average age at cancer diagnosis was 59 years. The results show that a 100 millilitre per day increase in the consumption of sugary drinks was associated with an 18 per cent increased risk of overall cancer and a 22 per cent increased risk of breast cancer. When the group of sugary drinks was split into fruit juices and other sugary drinks, the consumption of both beverage types was associated with a higher risk of overall cancer.No association was found for prostate and colorectal cancers, but numbers of cases were more limited for these cancer locations, researchers said. The consumption of artificially sweetened liet) beverages was not associated with a risk of cancer, but the researchers warn that caution is needed in interpreting this finding owing to a relatively low consumption level in this sample. Possible explanations for these results include the effect of the sugar contained in sugary drinks on visceral fat (stored around vital organs such as the liver and pancreas), blood sugar levels, and inflammatory markers, all of which are linked to increased cancer risk.Other chemical compounds, such as additives in some sodas might also play a role, they said. This is an observational study, so can't establish cause, and the researchers said they cannot rule out some misclassification of beverages or guarantee detection of every new cancer case. The study sample was large and they were able to adjust for a wide range of potentially influential factors. The results were also largely unchanged after further testing, suggesting that the findings withstand

Eating walnuts daily lowers heart disease risk



Eating a handful of walnuts daily may lower the risk of developing cardiovascular disease (CVD), says a

The study, published in Journal of the American Heart Association, examined the effects of replacing some of the saturated fats in participants' diets with

walnuts. It found that when participants ate whole walnuts daily in combination with lower overall amounts of saturated fat, they had lower central blood pressure. For the study, the researchers recruited 45 participants with overweight or obesity between the 30-65 age group. Before the study began, participants were placed on a "run-in" diet for two weeks.

"When participants ate whole walnuts, they saw greater benefits than when they consumed a diet with a similar fatty acid profile as walnuts without eating the nut itself," said Penny Kris-Etherton, Professor of Nutrition at the University of Pennsylvania.

The research was one of the first to try to uncover which parts of the walnuts help support heart health".

During the study, participants were randomly assigned to one of three study diets, all of which included less saturated fat than the "run-in" diet.

All three diets substituted walnuts or vegetable oils for five percent of the saturated fat content of the "run-in" diet and all participants followed each diet for six weeks, with a break between diet periods.

The researchers found that while all treatment diets had a positive effect on cardiovascular outcomes, the diet with whole walnuts provided the greatest benefits, including lower central diastolic blood pressure (normal diastolic blood pressure is 80).

"Instead of reaching for fatty red meat or full-fat dairy products for a snack, consider having some skim milk and walnuts," said Kris-Etherton.

Slower walking can lead to Dementia-Study

ENGLAND: Some researchers state, older adults with slower walking speeds seem to have a greater risk of dementia than those with faster walking speeds.

On that note, a study says nearly 47 million people around the world are suffering from

It is a kind of chronic or persistent disorder of the mental processes caused by brain disease or injury and marked by memory disorders, personality changes, and impaired reasoning. The most prevalent cause of dementia is Alzheimer's disease, but other forms exist, too. No cure for dementia has been reported yet but it is also important to know about the factors that lead to developing it. A link has also been found between the changes in walking speed, changes in the ability to think and make decisions, and dementia.

In their study, the researchers of United Kingdom (UK) used information collected from 2002 to 2015. The study included adults aged 60 and older. They assessed participant's walking speed, and whether or not the participants developed dementia after the tests. Then, they compared the people who had developed dementia with those who had not. Researchers discovered that those with a slower walking speed had a greater risk of developing dementia. And people who

experienced a faster decline in walking speed over a two-year period were also at higher risk for dementia. People who had a poorer ability to think and make decisions and those whose cognitive abilities declined more quickly were also more likely to be diagnosed with dementia. It was concluded that older adults with slower walking speeds, and those who experienced a greater decline in their walking speed over time, were at increased risk for Dementia. But, the researchers noted, changes in walking speed and changes in an older adult's ability to think and make decisions do not necessarily work together to affect the risk of developing dementia.

& Kashmir Assembly enacts law over the matter. However, the law regarding salaries of MLAs in erstwhile state of Jammu & Kashmir was protected under the Reorganisation Act," they said.

Under section 31 of J&K Reorganisation Act, LG should determine salaries of MLAs until J&K Assembly would enact a law on the matter.

"Members of the Legislative Assembly shall be entitled to receive such salaries and allowances as may from time to time be determined by the Legislative Assembly by law and, until provision in that behalf is so made, such salaries and allowances as the Lieutenant Governor may, by order determine," reads the Act.

Interestingly, the law governing salaries of MLAs in the erstwhile State of J&K was kept intact through the same Reorganisation Act-2019.

The "Salaries and Allowances of Members of Jammu and Kashmir State Legislature XIX of 1960" was among 166 state laws which were made applicable to J&KUT through Reorganisation Act.

Talking to news agency—Kashmir News Observer (KNO), Speaker Abdul Rahim Rather said that he has written to the government over the matter.

"I am hopeful that they will soon get their salaries," he said. In the erstwhile state, each MLA was entitled to salary and allowances of Rs 1.60 lakh per month after it was doubled during the PDP-BJP rule in 2016.

Winter Vacation In Colleges Likely From Dec-27

SRINAGAR: Amid bone chilling winters, the Jammu and Kashmir Higher Education Department has proposed to announce 50-days winter vacations from December-27 for colleges of Kashmir division.

Besides, the department has also proposed 10-days winter vacations for colleges of Jammu division.

Director Colleges of Jammu and Kashmir, Sheikh Ajaz Bashir informed the news agency—Kashmir News Observer (KNO) that the higher education department has sent a proposal of vacations to the government and was waiting for the final decision.

"As per the academic planner, we have sent a proposal to the government wherein we have anticipated that the 50-days winter vacations shall be announced for the colleges of Kashmir region from December-27 to February-14," he said.



The Director Colleges further said that it has also asked deans of the universities not to conduct any sort of exams during the vacation period.

In the meantime, the department of higher education in a Uniform Academic Calendar for all academic activities across Jammu and Kashmir said it has been observed that examinations are sometimes scheduled during the vacation period.

"This practice not only disrupts the planned break for students and faculty but also leads to logistical challenges for the colleges," it reads.

It further states that the extreme climatic conditions

during peak winter/summer months, when the winter zone experiences severe cold waves and dense fog and the summer zone experiences scorching heat waves thus making it difficult for students and faculty to commute and to carry out any academic activity during the period.

"Considering the challenges, deans of universities are requested to ensure that no examinations are scheduled during vacation periods. This will help maintain the integrity of the academic calendar, ensuring that students and faculty can enjoy their well-deserved breaks without disruption. Additionally, it will mitigate the difficulties posed

by severe climatic conditions, ensuring a smoother, more comfortable academic experience for all involved," it reads.

About the heating arrangements for students and staff of the colleges of Kashmir region, an official said, "We have already notified that there shall be proper heating arrangements for them."

Pertinently, the School Education Department earlier this week announced winter vacations in phased manner from December-10 and December-16 respectively in the Kashmir division and winter zones of Jammu division.

Principal Secretary School Education Department Suresh Kumar Gupta in a order had said that for students upto 5th standard,

the vacations shall begin from December-10 to February-28 and in case of students from 6th standard to 12th standard, the vacation shall begin from December-16 to February-28-2025.

J&K: Over 263 lives lost to disastrous weather events in 5 years

'Floods, heavy rains claim 147 lives'

SRINAGAR: A total of 263 deaths have been reported due to disastrous weather events in Jammu and Kashmir over the five years from 2019-2023, as per official data.

According to the data accessed by the news agency—Kashmir News Observer (KNO), in 2023, there were 54 fatalities: 9 due to snowfall, 5 due to lightning, and 40 from floods and heavy rains.

In 2022, 57 deaths were recorded: 3 due to snowfall, 4 from gales, 7 from lightning, and 43 caused by floods and

heavy rains.In 2021, 32 lives were lost: 4 due to snowfall, 2 from cold waves, 4 from lightning, 1 from a hailstorm, and 21 from floods and heavy rains.

The government said that the India Meteorological Department (IMD), in coordination with research centers, has implemented measures to improve monitoring and early warning systems for extreme weather events.

"It provides weather information to stakeholders, including government

bodies, and issues forecasts, warnings, and color-coded alerts to aid disaster management," it said.

"IMD has developed tools like the online "Climate Hazard & Vulnerability Atlas of India" and mobile apps such as "Mausam," "Meghdoot," and "Damini" for weather forecasts, agromet advisories, and lightning alerts," it said. "These efforts are supported by preparedness meetings and collaborations to minimize the impact of extreme weather. Climate change

anisha Crasto described her turbulent Olympic debut in Paris as a period of heartbreak, admitting she made the "mistake" of not taking a break afterward, but said reuniting with Ashwini Ponnappa with a renewed approach led to their triumph at the Guwahati Masters.

Tanisha and her seasoned partner Ashwini, who endured three lopsided losses on the trot to make a group stage exit in Paris, bounced back to put up a dominant performance and defend their Guwahati Masters Super 100 title on Sunday.

"It's been a tough transition after the Olympics for everyone, including me and Didi (Ashwini). I made the mistake of not taking a break, and it left me emotionally drained. But Diditook a huge break, and when we reunited, we focused on enjoying the game," the 21-year-old told PTI Videos.

"We decided not to think about results, just to go out there and enjoy ourselves. And when we did that, the results followed."

The Paris Olympics was a challenging chapter for Tanisha and all other Indian shuttlers as India returned without a medal for the first time in 12-years.


"It hurts because you're there, representing your country, and when things don't go your way, it's tough to process... I didn't take a break after the Olympics, thinking it would help me snap out of it. But as a person, I was a mess, dealing with insane emotions", she said.

"We cried together during an interview, and even the interviewer was moved to tears," Tanisha recalled.

All-round Linde, Miller give South Africa 1-Ó lead

South Africa 183 for 9 (Miller 82, Linde 48, Shaheen 3-22, Abrar 3-37) beat Pakistan 172 for 8 (Rizwan 74, Ayub 31, Linde 4-21) by 11 runs

aving not played for South Africa for three years, George Linde made up for lost time on one electric Kingsmead evening with a stunning all-round performance. A 24-ball 48 with the bat and 4-21 with the ball battered a valiant Pakistan, who went down by 11 runs. The umpire even thought he had a hat-trick in the penultimate over before a review denied him that glory but not his undisputed Player-of-the-Match award. Mohammad Rizwan, who faced the first ball, was there



in the final over as his team went down fighting, a late attack from the captain not quite enough to undo the damage of a sluggish first half of an innings where he managed just 36 in his first 44 deliveries, even if he did finish with 74 off 62.

South Africa came into the first T20I in Durban with a decidedly second-string side, but it doesn't matter when David Miller is in the form he found today. A majestic 40-ball 82 ran through the first innings like a dagger for Pakistan, who believed they had made early progress when Shaheen Shah Afridi and Abrar Ahmed removed Rassie van der Dussen, Reeza Hendricks and Matthew Breetzke early. But Miller ensured the runs kept flowing, and Pakistan's spinners couldn't have the impact they hoped for on a true, flat Durban pitch Heinrich Klaasen had little hesitation in opting to bat first on.

Saim Ayub gave Pakistan a flying start despite the loss of Babar Azam for a duck early on, but South Africa reined them in through the middle overs. Rizwan struggled to get going and Pakistan's inexperienced middle order couldn't keep the asking rate in check from the other end. It allowed South Africa to get tidy overs in through the middle while picking up regular wickets, and all of a sudden Pakistan were running out of batters and overs.

 $An \, errant \, 17 th \, over \, from \, the \, otherwise \, impressive \, 18 \text{-} year\text{-}old \, Kwena \, Maphaka$ allowed Pakistan 24 runs, and they suddenly found themselves back in the game. Rizwan was flying by then, smashing two sixes off Maphaka and three fours off Ottneil Baartman, and Pakistan had suddenly dragged themselves back in, needing 19 off the final over. But Maphaka, who returned for the 20th over, had Rizwan top-edging a slower ball, and the game was over as a contest. Pakistan had paid for their generosity with the ball at the death, and tardiness with the bat early on. South Africa were clinical enough to take full advantage.

The Killer Miller Show

David Miller has made a reputation for being a middle- and late-overs bludgeoner. But after Shaheen and Abrar struck early, Miller came in at No. 4 in an inexperienced side. And for the next hour or so, he demonstrated how his timing and technique were every bit equal to his power. Taking advantage of beginning his innings in the powerplay, he whipped Shaheen off the pads to get going, before punching him through the covers for another boundary.

The quality of his timing was on full display against Sufiyan Muqeem just after the powerplay. The left-arm wristspinner tried to stay out of his arc by bowling wide of off and spinning it away, but Miller's extension of the arms and strength at the end of his range lay waste to that tactic. He creamed him over the extra-cover boundary, where the fielder could only watch it sail over his head. Muqeem tried it once more two balls later, only to have the same treatment meted out to him with - if it was possible - even less effort.
