

# HM Amit Shah Likely To Review J&K Situation Today

**NEW DELHI**: Union Home Minister Amit Shah on Thursday is likely to review the security situation in Jammu and Kashmir, the first such meeting after the last assembly elections held in September-October, sources said.

Jammu and Kashmir Lieutenant Governor Manoj Sinha, top officers of the Army, paramilitary forces, JK administration, intelligence agencies and Ministry of Home Affairs (MHA) are expected to attend the meeting.

"The home minister will review the security situation



in Iammu and Kashmir. He will be briefed about the prevailing situation in the Union Territory (UT) and the situation along the border areas," sources said.

This will be Shah's first meeting after the assembly elections conducted in the UT where a National Conference (NC) government, headed by

assumed charge.

After the abrogation of the Article 370 and bifurcation of the erstwhile state into two UTs in 2019, the law and order is the direct responsibility of the central government.

The home minister is likely to have a detailed discussion on the security roadmap ahead for the 2025, the sources said.

Sporadic incidents have been continuing in Jammu and Kashmir. On October 20, seven people were killed in a terror attack in central

#### 6 Die, 4 Injured In Kathua Fire Incident

LG Sinha, CM Omar grieved over loss of lives

**JAMMU**: Six persons of a family including two children died while four others were injured due to suffocation allegedly caused by a fire incident in a residential house in Kathua on Wednesday, officials said.

According to the news agency— Kashmir News Observer (KNO), the incident took place in the mid night at a residential house in ward number 16, Shiva Nagar Kathua.

As per the initial reports, the fire started from a rental room due to a lamp and spread to other parts of the room, resulting in the death of six persons, who were inside the room. The six persons died of suffocation caused by the smoke.

The victims have been identified as the owner of the house Avatar Krishan, 81, Ganga Bhagat, 17, Danish Bhagat, 15, Barkha Raina, 25, Takash Raina, 3 and Advik Raina, 4. They were taken to the hospital but were declared dead.

Four others were injured in the incident, who have been identified as Swarna, 61, Neetu Devi, 40, Arun Kumar and Kewal Krishan, 69.

All the injured are undergoing

treatment at Government Medical College and Hospital, Kathua.

Giving details, Principal GMC Surinder Atri said that the incident related to the recently retired Assistant Matron, who had been living in a rented house. He said six persons were brought dead and four others were injured in the incident.



He further said the incident reports at around 2 am in the night and prima facie, it has been established the fire was caused due to a lamp at Pooja room (jot) and the person died due to suffocation. He said there is no burn mark on the dead persons, while all four injured are stable.

## B.R. Ambedkar Was the Greatest Opponent of Article 370: HM Shah Reiterating Ambedkar's role in opposing Article

**SRINAGAR**: Union Home Minister Amit Shah on Wednesday addressed a press conference at the BJP headquarters, highlighting B.R. Ambedkar's strong opposition to Article 370, which had accorded special status to Jammu and Kashmir. The Minister's statement comes amid controversy over his remarks regarding Ambedkar and the Congress party's historical stance on constitutional values.

According to the news agency—Kashmir News Observer(KNO)correspondent, in the press briefing, Shah criticized the Congress for its alleged distortion of facts during the parliamentary debate on the 75 years of India's progress, referred to as the Gaurav Yatra and Vikas Yatra. He emphasized that discussions in democratic forums like Parliament should always be rooted in facts and truth, which he claimed the Congress had failed to uphold.

"The Congress Party has consistently undermined the values of B.R. Ambedkar. From opposing Ambedkar during his lifetime to leaving no stone unturned to defeat him in the elections of 1951-52 and 1954, the Congress has shown its anti-Ambedkar stance," Shah alleged. He further accused the Congress of being anti-reservation, anti-constitution, and of repeatedly distorting Ambedkar's legacy for political gain.

370, Shah said, "B.R. Ambedkar was the greatest opponent of Article 370. He believed in the unity and integrity of India.



The Minister also launched a scathing attack on the Congress for its imposition of the Emergency, undermining the judiciary, and "insulting martyrs of the army" by compromising India's territorial integrity. According to him, these actions reveal a pattern of the Congress prioritizing political expediency over national interest."The BJP has always been the true defender of Ambedkar's legacy while the

# Pitiable: Supreme Court On Pension Of Retired HC Judges

Wednesday lamented the meagre pension, ranging from Rs 10,000 to Rs 15,000, being given to some retired high court judges and termed it "pitiable".

The Apex Court asked the authorities to have a "humane approach" instead of adopting a "legal approach".

A bench of Justices B R Gavai and K V Viswanathan was dealing with a batch of pleas raising the issue of different pension being payable to retired high court judges.

One of the key reasons was that the High Court Judges, who have been elevated from district judiciary, were covered under the New Pension Scheme.

While those, who have been elevated to the High Court from the Bar, were the beneficiaries of the Old Pension Scheme leading to the mismatch in the pension payable to two sets of high court judges.

"You cannot have a legal approach in every matter. Sometimes, you need to have a humane approach," the apex court observed on Wednesday.

"It is pitiable," the bench said, noting



pension between Rs 10,000 and Rs 15,000. Attorney general R Venkataramani mentioned the matter before the bench

and requested for a hearing in January, 2025. Venkataramani said the government would try to resolve the issue. "It is better you persuade them that our

intervention should be avoided," the bench

It said the matter would not be decided on individual cases and whatever the top court might lay down would be applicable to all the high court judges.

The bench posted the hearing on January 8, 2025.While hearing a separate plea in March, the Apex Court said there cannot be any discrimination in computing the pensionary benefits of retired Judges of High Courts based on whether they were elevated from the bar or the district judiciary.

Pensionary benefits of a retired High Court Judge, who was elevated from the district judiciary, should be computed based on his or her last drawn salary as a High Court judge, it had said. During the hearing on one of the pleas in the matter in November, the top court expressed "shock" that some retired high court judges were getting a meagre pension ranging between Rs 6,000 and Rs 15,000.

The bench was hearing a petition filed by a retired high court judge who said he was receiving a pension of Rs 15,000.

The petitioner, who was elevated as a judge of the Allahabad High Court after serving as a judicial officer in the district court for 13 years, claimed the authorities had refused to consider his judicial service while computing the pension.

"If there are retired high court judges before us who are getting Rs 6,000 and Rs 15,000 as pension, it is shocking. How can that be?" the bench had remarked while hearing the plea.

#### Parliamentary dialogue between India, Armenia grown in recent years: Om Birla

**NEW DELHI**: The political and parliamentary dialogue and cooperation between India and Armenia have increased in recent years, opening up new avenues of partnership in various sectors, Lok Sabha Speaker Om Birla said on Tuesday.

Birla held bilateral meeting with Armenian President Alen Simonyan in the Parliament House Complex on Tuesday where both sides held discussions on various issues of mutual interest including trade and investment.

The Speaker noted that in recent years, political and parliamentary dialogue and cooperation between the two countries have increased, opening up new avenues of partnership in various sectors.

Noting that India is leaping forward at highest economic growth rate in the world, Birla highlighted the efforts towards Ease of Doing Business and world-class infrastructure in India which has generated huge interest across the world in

"Emphasising the importance of continued dialogue and cooperation between the two countries on multilateral fora, he said regular discussions on regional and global issues between the two nations and two Parliaments would further strengthen the bilateral ties," an official statement said.

"Underlining deep historical and cultural ties between India and Armenia, he hoped that with the growing bilateral cooperation will strengthen people-topeople connection," it added.

Birla emphasised that the cooperation between Parliaments of India and Armenia should be further strengthened to reinforce the core principles of democracy.

Mentioning that India has always championed the cause of gender equality, Birla informed the delegation that the first legislation passed in the new Parliament building was the 'Nari Shakti Vandan Act', which strengthens the commitment to women-led development in the country.

"He observed that in recent years, Parliament of India has made extensive use of digital technologies, simplifying



processes and enhancing transparency. He said that the 'Digital Parliament' project was one such initiative which has led to increased participation by citizens in India's democratic processes," the statement said.

#### Punjab: Train services affected due to farmers' 'rail roko' protest



**CHANDIGARH**: Train services in Punjab were affected as farmers squatted on rail tracks on Wednesday as part of their three-hour 'Rail Roko' protest to press the Centre into accepting their various demands, including a legally binding minimum support price for crops.

The call for the 'rail roko' was given by the Samyukta Kisan Morcha (Non-Political) and Kisan Mazdoor Morcha.

Kisan Mazdoor Morcha leader Sarwan Singh Pandher said farmers have been squatted on rail tracks at many places from 12 noon to 3 pm.

Protesting farmers blocked train routes at many places, including Moga, Faridkot, Kadian and Batala in Gurdaspur; Phillaur in Jalandhar; Tanda, Dasuya, Mahilpur in Hoshiarpur; Makhu, Talwandi Bhai in Ferozepur; Sahnewal in Ludhiana; Shambhu in Patiala; Mohali; Sunam and Lehra in Sangrur, Rampura Phul in Bathinda and Devidaspura in Amritsar.

The Humsafar Express from Jammu to Sealdah, Dadar Express from Amritsar to Mumbai and Shan-e-Punjab Express from New Delhi to Amritsar were halted at different platforms of the Ludhiana railway station. The Shatabdi Express coming from New

railway station.

Delhi for Amritsar was halted at Khanna

A protesting farmer said, "We are demanding a legal guarantee for MSP from the government."Farmers under the banner of Samyukta Kisan Morcha (Non-Political) and Kisan Mazdoor Morcha have been camping at Shambhu and Khanauri border points between Punjab and Haryana since February 13 after their march to Delhi was stopped by security forces. For the past three weeks, Punjab farmer leader Jagjit Singh Dallewal has been on a fast-unto-death at the Khanauri border point between Punjab and Harvana to press the Centre to accept the agitating farmers' demands, including a legal guarantee of MSP on crops.

A "jatha" (group) of 101 farmers made three attempts to enter Deini on loot on December 6, December 8 and again on December 14. Haryana security personnel did not allow them to proceed. Besides a legal guarantee on MSP for crops, the farmers are demanding a debt waiver, pension for farmers and farm labourers, no hike in the electricity tariff, withdrawal of police cases and "justice" for the victims of the 2021 Lakhimpur Kheri violence.

# NIA Chargesheets Two Key Aides Of Khalistani Terrorist Landa

**NEW DELHI**: The National Investi gation Agency has chargesheeted two key aides of designated terrorist Lakhbir Singh alias Landa of the banned Babbar Khalsa International outfit in a Punjab terror conspiracy case, according to the probe agency on Wednesday.

Jaspreet Singh of Punjab's Ferozepur district and Baljeet Singh of Madhya Pradesh's Barwani district were chargesheeted on Tuesday before the NIA special court in Mohali, it said.

They were identified by NIA as members of a terror gang formed by foreign-based Khalistani terrorist Landa, said a statement issued by the probe

A probe by the NIA found Jaspreet Singh to be an important on-ground operative of Landa and his associate Pattu Khaira, while Baljeet Singh was involved in supplying weapons to members of the Landa gang and other gangsters.

It further emerged during the investigation that Jaspreet Singh was involved in Landa's drug smuggling and

extortion network aimed at generating funds for BKI, the NIA claimed.

Baljeet was manufacturing weapons



locally and using social media to supply them to operatives of the Landa gang, it added.

He was one of the various weapons suppliers with whom the terrorists had tied up across the country for the supply of arms and ammunition, the NIA said.

In the course of the investigation, NIA seized various arms, ammunition, narcotics and drug money, digital devices, and other incriminating articles from the accused.

# Kharge, Rahul Attend PM-Led Panel To Select **New NHRC Chairperson**

**NEW DELHI**: A committee led by Prime Minister Narendra Modi met here on Wednesday to select the next chairperson of National Human Rights Commission (NHRC), sources said. They also said Congress president Mallikarjun Kharge and party leader Rahul Gandhi attended the meeting as leaders of the

opposition in Rajya Sabha and Lok Sabha respectively.The post of NHRC chairperson has been vacant since Justice (retd) Arun Kumar Mishra completed his tenure on June 1.A former judge of the Supreme Court, Justice Mishra served as the eighth chairperson of the rights panel and was appointed to its top post in June 2021.

#### **Pakistan Issues 84 Visas** To Indian Pilgrims To Visit **Katas Raj Temples**

NEW DELHI, Dec 18: The Pakistan high commission on Wednesday said it issued 84 visas to Indian pilgrims to visit the Shree Katas Raj temples in Punjab province's

Chakwal district. The group has been given visas to visit the Katas Raj temples from December 19 to 25.

The temples are also known as Qila Katas. It is a complex of several Hindu temples connected to one another by walkways.

Under the provision of a bilateral protocol on visits to religious shrines, Sikh and Hindu pilgrims from India visit Pakistan every year. Pakistani pilgrims also visit India every year under the protocol.

"The Pakistan high commission in New Delhi has issued 84 visas to a group of Indian pilgrims for their visit to the sacred Shree Katas Raj Temples in Chakwal district of Punjab," the Pakistani mission said.

Pakistan's Charge d'Affaires Saad Ahmad Warraich wished the pilgrims a "spiritually rewarding" and a "fulfilling" journey.
"Under the Pakistan-India protocol on visits to re-

ligious shrines of 1974, each year thousands of Sikh and Hindu pilgrims from India visit Pakistan to attend various religious festivals/occasions," the Pakistan high commission said.

"The issuance of pilgrimage visas is in line with the policy of the government of Pakistan to facilitate visits to religious shrines and promoting interfaith harmony," it said in a statement.

# 'Satellite beams turned off over India': Elon Musk rejects claim Starlink being used in Manipur



**IMPHAL**: SpaceX founder Elon Musk said Starlink satellite beams were turned off over India, reacting to claims that its device was being used in restive Manipur.

The security forces recently seized some internet devices along with arms and ammunition during a raid in Keirao Khunou in Imphal East district.

The Spear Corps of the Indian Army had shared photos of the items seized on X, and social media users were quick to note that one of the

devices had a "Starlink logo" on it. Pointing to it, an X user posted, "@Starlink is being used by terrorists. Hope, Elon @elonmusk looks into it and help control misuse of this technology." To this, Musk replied,

Musk's Starlink, which provides satellite internet services, does not have a licence to operate in India.

In a post on 'X', the Dimapurheadquartered Spear Corps had put out the photos of the items recovered in the search operation that included the internet device with the Starlink

It featured inscriptions of the RPF/PLA.

The recovery of the Starlink-like device has also prompted agencies to investigate how the equipment found its way to the strife-torn state, officials had said.

There is no official confirmation on whether it is a genuine Starlink

made during a search operation in Imphal East on December 13. Among the items seized from Keirao Khunou were "one internet Satellite Antenna, one internet Satellite router, and 20 meters (approx.) of FTP cables", according to the state police.

The search operation was carried out jointly by the Indian Army and Assam Rifles in coordination with the Manipur Police in Churachandpur, Chandel, Imphal East and Kagpokpi,

The Spear Corps further said 29 weapons comprising snipers, automatic weapons, rifles, pistols, country-made mortars, single barrel rifles, grenades, ammunition and war-like stores were recovered in the operation.

In a separate post on 'X', the Manipur Police said one MA4 assault rifle, one 12-bore gun, one 9 mm pistol, one .32 pistol,

five hand grenades, five arming rings, two detonators, 30 5.56 mm ammunition, one internet satellite antenna and one internet satellite router were among those recovered from Keirao Khunou in Imphal East

#### **Regulating OTTs Comes Under Preview Of I&B Ministry, Concerns Of Telecom Service Providers Are** Raised: Jyotiraditya Scindia

**NEW DELHI**: Regulating over-the-top (OTT) platforms comes under the purview of the Information and Broadcasting Ministry, Union Minister for Communications Jyotiraditya Scindia adding that one of the six advisory groups that he had established, had flagged the issue,



highlighting concerns from the perspective of telecom service providers (TSPs).

"That is something that, to be very candid. comes under the domain of the Ministry of I&B (information & broadcasting). Having said that, I have six advisory groups that I have set up and this concept has come up as an issue that they would like to discuss from the point of view of the TSPs," Scindia said.

The debate stems from calls for OTT platforms to share the costs incurred by Telecom Service Providers (TSPs) in delivering content to consumers. While TSPs argue that cost-sharing network expansion, while critics highlight the potential violation of net neutrality principles.

Net neutrality mandates equal treatment of all internet traffic, prohibiting payments from content providers to TSPs. Introducing such payments, critics argue, could allow network operators to prioritize certain platforms, undermining the internet's democratic nature.

Proponents of cost-sharing highlight that the digital economy and telecom landscape have evolved dramatically in recent years. Between 2015 and 2023, India saw an

explosive growth in mobile data consumption, with average usage per user jumping from 0.09 GB to 17.36 GB per month. However, the expansion of network

infrastructure, such as the number of mobile towers, has not kept pace with this demand. Emerging technologies like artificial intelligence, cloud computing, and the Internet of Things (IoT) are expected to further amplify data consumption, intensifying the need for network upgrades.

It is argued that a blanket approach to net neutrality may no longer be sufficient to address the current challenges.

Instead, a nuanced framework could balance the interests of all stakeholders.

For instance, larger OTT platforms with significant revenue streams, such as subscription fees or advertising, could be required to contribute to network costs.




I have shared my contact number through the advisory, and people can also send us video clips showing such violations. We will take strict action based on those," he added.

The introduction of this scheme is a welcome move, as it brings both economic and environmental benefits to rural communities. Authorized PACS representatives must undergo training and pass a qualifying exam with a score of 80% before they are granted distributorships. This ensures that PACS can effectively manage the distribution process, operate safely, and maintain the necessary infrastructure, including storage facilities and capital support. From an environmental and health perspective, this initiative is especially important. By replacing traditional cooking methods, such as using firewood, with cleaner LPG, rural households can significantly reduce health risks and environmental degradation. Additionally, the financial sustainability of PACS will be significantly enhanced through the new revenue streams created by LPG distributorships. This will strengthen their operational capacity and help them serve their members more effectively, creating a more resilient and empowered rural economy. This innovative move to involve PACS in LPG distribution exemplifies a holistic approach to rural development addressing the immediate needs for clean energy while ensuring the longterm sustainability of PACS. Marriage, a sacred bond and cornerstone of human society, has historically symbolized union, commitment,



# J&K's Salal-Haimana shows potential for lithium, titanium resources: Govt

Says preliminary lithium exploration projects underway in Reasi

**SRINAGAR**: The Union Government has confirmed that the Salal-Haimana area in Jammu and Kashmir's Reasi district holds significant resources of lithium and

According to the Ministry of Coal and Mines, G. Kisshan Reddy, the Geological Survey of India (GSI) conducted preliminary exploration (G3 stage) primarily for bauxite, during which additional resources of lithium and titanium were also identified.

The GSI has submitted mineral samples to the Indian Bureau of Mines, Nagpur, and the Institute of Minerals and Materials Technology, Bhubaneswar, for beneficiation studies. In addition, two other preliminary exploration projects (G3 stage) for lithium are underway in the Salal East and Panasa areas of Reasi district as part of the current field season for 2024-25, he said.

Regarding the timeline for exploration and auctioning, the government as per the news agencyKashmir News Observer (KNO) has not specified a fixed period for the area to reach the G1 or G2 exploration stage, which would be necessary for the auction process and commercial mining to begin.

Efforts to reduce India's dependence on lithium imports have been a key focus. The Mines and Minerals (Development and Regulation) Act, 1957, has been amended through the MMDR Amendment Act, 2023, introducing major reforms in the mining sector, he said.Reddy added the amendments include the addition of 24 critical minerals, including lithium, to the First Schedule of the MMDR Act, empowering the Central Government to auction mineral concessions exclusively for these minerals.

Also, the government has set up a joint venture company, Khanij Bidesh India Limited (KABIL), which aims to secure critical mineral assets abroad. KABIL has already acquired a 15,703-hectare area in Argentina's Catamarca province for exploration and mining of lithium, he said.

## Indian Army Opens AI Incubation Centre to Boost **Technology in Defence**



**JAMMU**: The Indian Army has taken a major step toward modernizing its operations by opening an Artificial Intelligence (AI) Incubation Centre in Bengaluru.

The Indian Army Al Incubation Centre (IAAIIC) was virtually inaugurated by Chief of the Army Staff (COAS) General Upendra Dwivedi.

This centre aims to use AI to improve the Army's efficiency, decision-making, and readiness for modern security challenges. It will focus on creating data-driven solutions to enhance the Army's operational capabilities.

The centre is being set up with the support of Bharat Electronics Limited (BEL), which is providing infrastructure and IT assistance. It will be operated by Indian Army personnel.

The IAAIIC will also collaborate with universities, startups, and industry experts to develop homegrown AI solutions suited to the Army's unique needs. Research will focus on areas such as advanced surveillance, autonomous systems, decisionmaking tools, and predictive maintenance.

A supercomputer with advanced capabilities, provided by the Centre for Development of Advanced Computing (CDAC), will be used for AI training and development at the facility.

# In four years, JK sees power consumption surge by 13 Pc

**SRINAGAR**: Amidst growing demand for power, the electricity consumption in Jammu and Kashmir has increased by more than thirteen percent in the past four years.

The official documents accessed by the news agency-Kashmir News Observer (KNO) states, "Over the span from 2020-21 to 2023-24, Jammu and Kashmir saw a steady increase in electricity consumption per capita, rising from 1,322 Kilowatt-Hour (KWHr) to 1,507KWHr."

"This trend reflects a growing demand for power amidst a population increase from 13.41 million to 13.70 million, with units purchased and consumed escalating from 17,721.76 million to 20,644.47 million units over the period," it reads.

Currently, are 23.45 lakh electric connections and consumers of different categories in JK who are being catered electric power supply.

"At least 14 lakh smart

meters are targeted to be installed, 7.27 lakh smart meters are targeted to be installed by March 2025 out of which 5.78 Lakhs stand installed," reads the document.

It also said that the government will complete the loss reduction infrastructure projects by March 2025. About the renewable energy sector in Jammu and Kashmir, the

already commissioning projects like 5 MW SHP Bultikulan and 3.75 MW SHP Khari," it reads.

Year-wise, J&K Bank Limited reported 11 fraud cases in FY 2021-22 involving Rs 14.23 crore. In FY 2022-23, the number of cases rose to 13, but the amount involved escalated significantly to Rs 298.09 crore. However, FY 2023-24 saw a notable reduction with only eight cases reported, involving Rs 8.10 crore, the reply reads.

The Reserve Bank of India attributes the overall decline in banking frauds to comprehensive measures, including revised Master Directions on Fraud Risk Management issued in July 2024. # Had A Lot Of Fun But It's Over Now: Ashwin **Announces International Retirement**

**BRISBANE**: India's premier off-spinner R his emotions but sitting alongside longtime Ashwin on Wednesday surprised the cricketing world by announcing his retirement with immediate effect in the middle of the Test series against Australia here despite having a "bit of punch left" in him.

Ashwin retires from the game as the second highest wicket-taker for India in Tests with 537 scalps in 106 games, placing him only behind the great Anil Kumble (619 wickets) in the overall statistics.

He will continue to play club cricket, including the IPL, where he will return to play for Chennai Super Kings next year.

"I won't take too much of your time. Today will be the last day for me as an India cricketer in all formats," Ashwin said at the end of the drawn third Test here in a joint press conference with captain Rohit Sharma during which he declined to take any questions and left after making the announcement.

Ashwin, who would be headed back to India on Thursday, was seen sharing an emotional moment with star batter Virat Kohli in the dressing room hours before the announcement, sending social media into a frenzy.

The 38-year-old played the day-night Test in Adelaide and picked up one wicket. He not being a sure starter in the playing eleven over the course of the three Tests prompted him to think about his future in the team and eventually call time on a remarkable career.

Ashwin was not just the master of his craft, he was also considered one of the brightest minds in world cricket.

The Chennai-based bowler, who holds an engineering degree, usually does well to hide teammate Rohit, Ashwin left the stage for the fear of getting overawed by the occasion.

gratitude towards the BCCI and other senior teammates for his career which began in 2010 in the one-day format before he made his Test



"I do feel there is bit of punch left in me as a cricketer but I would like to showcase that in club level cricket. I have had a lot of fun. I must I have created a lot of memories alongside Rohit and several of my other teammates," he said.

Singh Dhoni had quit Tests after conceding an unassailable lead to the home side.

'He'd been thinking about it' Ashwin's decision may seem like a bolt from the blue but Rohit revealed that he had a chat with the champion spinner on the sidelines of the Perth Test.

"...this was on his mind and there are obviously a lot of things that went behind it, I am pretty sure Ash will be able to answer that but he understands what the team is think-

"When I arrived in Perth, this was a chat we had and I somehow convinced him to stay for that pink ball Test match and then after that it just happened so that he felt that if I am not needed right now in the series, I am better off saying goodbye to the game," the India captain added.

India played Washington Sundar ahead of Ashwin in Perth before the veteran returned for the pink ball Test. Ravindra Jadeja played in the Brisbane Test.

"It's important when a player like him who has had so many moments with the Indian team and he has been a truly big match winner for us, he is allowed to make those decisions on his own and if it was now, so be it," added Rohit.

The BCCI was also quick to congratulate Ashwin on a special career.

"A name synonymous with mastery, wizardry, brilliance, and innovation," said the BCCI in its tribute post on X.

ESPNcricinfo understands Samson had written to the association stating his unavailability for the camp, but the KCA has decided to stick to its original decision. With senior batter Sachin Baby also unavailable due to injury he picked up during SMAT, batter Salman Nizar has been named captain for the 50-over competition. Samson, fresh off two T20I centuries on the tour of South Africa, played in five of Kerala's six games at SMAT, scoring 135 runs including one half-century.

Pandey has 7973 runs in 118 first-class matches at an average of 50.78, with 25 centuries. Overall, he also has over 13,000 runs across the white-ball formats. He played the most-recent of his 68 white-ball games for India in 2021. Last month, he was re-signed by reigning IPL champions Kolkata Knight Riders ahead of the
