» At -8.5°C Srinagar breaks over three-decade-old record

SRINAGAR: The 40-day harsh winter period, Chillai Kalan, began with an intense cold wave across Kashmir, as Srinagar recorded its coldest December night in over three decades at minus 8.5°C. This marks the second-lowest December temperature recorded in the last 133 years.

The all-time lowest December temperature in Srinagar was recorded on December 13, 1934, at minus 12.8°C, while the now-third lowest was minus 7.9°C, observed on December 13, 1986.

According to the news agency—Kashmir News Observer (KNO), the intense cold wave continues in Kashmir for weeks, with no major weather activity expected until the In Qazigund, the gateway to Kashmir, the mercury dropped to minus 8.2°C, the lowest of the season so far. Pahalgam, a popular tourist destination, recorded minus 8.6°C. The coldest place in the Valley was Anantnag, where the temperature plunged to minus 10.5°C, followed closely by Shopian at minus 10.4°C and Pulwama at minus 10.3°C. Kulgam recorded a minimum of minus 6.8°C.

41,141 km roads built, 410 bridges completed in J&K this year

SRINAGAR: Jammu and Kashmir witnessed substantial advancements in infrastructure development so far this year, encompassing road network expansion, tunnel construction, ropeway projects, and road safety initiatives, reveals an official data.

According to the data accessed by news agency—Kashmir news observer, the Union Territory now boasts a total road network of 41,141 km, including 1,735 km of national highways, 696 km of state highways, and 37,351 km of other district and village Roads. Of this, 30,326.48 km is black-topped.

Business Rules for J&K

Draft of New Business Rules for JK Under Final Review

3-Member CSC Considers Previous Rules, Recent Amendments Before Submission to Cabinet

SRINAGAR: The cabinet sub-committee, constituted by the National Conference-led government, has prepared a draft of business rules, which is currently under discussion, sources said.

According to news Agency KNO, 3-member CSC headed by Deputy Chief Minister Surinder Choudhary and comprising Ministers Javed Rana and Sakina Ittoo, has developed the draft of business rules, and it is being discussed at various levels.

According to sources, the CSC has examined the business rules that were in effect in the erstwhile state of Jammu & Kashmir, as well as the Transaction of Business of the Government of Union Territory of Jammu and Kashmir Rules, 2019, which were unveiled by the Union Home Ministry in 2020, along with subsequent amendments

made in 2023 and 2024.

Two of the three ministers on the CSC, who wished to remain anonymous, stated that the work of the CSC is in its final stages and that it would soon submit its report to



the cabinet. "The cabinet sub-committee is expected to meet again soon to finalize its recommendations," they said, adding that the CSC has only met once.


Why Is ECI Afraid Of Transparency: **Congress After Election Rule Tweak**

NEW DELHI: The Congress on Saturday hit out at the Election Commission for tweaking an election rule to prevent public inspection of certain electronic documents such as CCTV camera and webcasting footage, asking why the poll panel was afraid of transparency.

Congress general secretary in-charge communications Jairam Ramesh said the party would legally challenge amendment.

"If there was ever a vindication of our assertions regarding the rapidly eroding integrity of the electoral process managed by the Election Commission of India (ECI) in recent times, this is it," Ramesh said in a post on X.

Sharing a December 20 notification, the Congress leader said, "This move of the ECI will be challenged legally right away." The government has tweaked an election rule to prevent public inspection of certain electronic



documents such as CCTV camera and webcasting footage as well as video recordings of candidates to prevent their misuse.

Basedontherecommendation of the poll panel, the Union law ministry has amended Rule 93 of the Conduct of Election Rules, 1961, to restrict the type of "papers" or documents open to public inspection.

According to Rule 93, all "papers" related to elections

shall be open to public inspection. The amendment inserts "as specified in these rules" after

"papers". Ramesh said sunlight was the best disinfectant and information would restore faith in the process – a reasoning Punjab and Haryana High Court agreed with when it directed the ECI to share all information it was legally required to with the public.

"Yet, the ECI, instead of

complying with the judgment, rushes to amend the law to curtail the list of what can be shared,"

"Why is the ECI so afraid of transparency?" the Congress general secretary asked.

Transparency openness are key in exposing and eliminating corruption and unethical practices and information restores confidence in the process, Ramesh noted.

Law ministry and ECI officials separately explained that a court case was the "trigger" behind the amendment.Punjab and Haryana High Court had recently directed the poll panel to provide copies of the required documents related to the Haryana Assembly elections to advocate Mehmood Pracha.

He had filed a petition seeking the videography, CCTV camera footage, and copies of Forms 17-C Parts I and II related to the conduct of elections.

Delhi LG Gives Nod To ED To Prosecute Arvind Kejriwal In Excise Policy Case

NEW DELHI: Ahead of the upcoming 2025 Delhi Assembly Polls, Delhi Lieutenant Governor (LG) VK Saxena has granted permission to the Enforcement Directorate (ED) to prosecute AAP Chief and Former Delhi Chief Minister, Arvind Kejriwal, in the excise policy case.

On December 5, the Enforcement Directorate sought permission for sanction of prosecution against Arvind Kejriwal.

This move comes after months of investigations into the Delhi government's excise policy, which has been at the center of controversy and allegations of corruption. Meanwhile, the Delhi High

Court on Friday granted the Enforcement Directorate (ED) additional time to file its reply to the petition filed by Arvind Kejriwal and Manish Sisodia. The petition challenges the trial court's decision to take cognizance of the chargesheets in the Delhi Excise Liquor Policy

SIRSA (HARYANA): Vice President Jagdeep Dhankhar, Union minister Manohar Lal Khattar, Haryana Chief Minister Nayab Singh Saini and a host of other leaders paid their last respects to former chief minister Om Prakash Chautala at the Teja Khera village here on Saturday.

A prominent lat leader and five-time chief minister of Haryana, Chautala died in Gurugram on Friday at the age of 89.

A state funeral will be held late afternoon in the village.

On Saturday morning, people paid their last respects to the Chautala at the family's Teja Khera farmhouse. The Indian National Lok Dal (INLD) chief's body was wrapped in the Tricolour and decked with garlands.

Vice President Dhankhar, who was in Chandigarh to attend an event at the Panjab University, reached Sirsa along with his wife, Sudesh Dhankhar, in the afternoon.

Former Punjab deputy chief minister and Shiromani Akali Dal (SAD) leader Sukhbir Singh Badal also reached Teja Khera village.

Om Prakash Chautala's vounger son Abhay Singh Chautala, an INLD leader, elder son and JJP chief Ajay Singh Chautala and other family members, including former deputy chief minister Dushyant Chautala, were present there.

Congress leaders Randeep Singh Surjewala and Kumari Selja reached the Chautala farmhouse earlier in the day to pay their last respects. Common people have gathered in the village in large numbers as well for the cremation.

The Haryana Government declared a three-day state mourning on Friday. It has also declared Saturday a public holiday in all its offices.

BSP supremo Mayawati hits out at Amit Shah over comments on Ambedkar

LUCKNOW: Bahujan Samaj Party (BSP) chief Mayawati on Saturday hit out at Union Home Minister Amit Shah, saying that he should apologise for his statement on B R Ambedkar. If this does not happen, the BSP will protest across the country on December 24, she said.

In a series of posts on X in Hindi, Mayawati said, "BabasahebDr Bhimrao Ambedkar, the author of the original book in the form of the super-humanistic and welfare Constitution for the self-respect and human rights of the Dalits, deprived, and other neglected people of the country, is as revered as God.

His disrespect by Shri Amit Shah hurts the hearts of the people." She further mentioned

that people from all sections of society in the country are quite angry and agitated by the words spoken by him in Parliament regarding such a great man.

"Ambedkarite BSP has demanded that he take back

his statement and repent, which has not been done till now, she said.

The BSP chief also stated that in such a situation, if the demand is not met, the BSP will raise its voice across the country. "That is why the party has now decided to hold a nationwide

movement on December 24 in support of this demand. On that day, a complete peaceful dharna-demonstration will be held at all district headquarters across the country," she said.

During a debate on the Constitution in the Rajya Sabha on Tuesday, Shah had said, "Abhi ek fashion ho gaya hai – Ambedkar, Ambedkar, Ambedkar, Ambedkar, Ambedkar, Ambedkar, Itna naam agar Bhagwan ka lete to saat janmon tak swarg mil jata (It has become a fashion to say Ambedkar, Ambedkar, Ambedkar, Ambedkar, Ambedkar. Frozen Wular Lake Brings Fishing and Harvesting to a Standstill in Bandipora

second-largest freshwater lake, frozen solid and disrupting the lives of local fishermen in Bandipora.

Adding to the fishermen's woes, Srinagar and other districts have recorded their coldest nights since 1990, signaling the severity of this year's winter. The freezing of Wular underscores the harshness of the current cold spell, which has already set records ahead of Chillai-Kalan's full impact.

As the valley braces for weeks of extreme cold, fishermen are urging the administration to step in with immediate measures to support the affected community. The disruption of livelihoods in Bandipora highlights the pressing need for contingency plans to assist those impacted by the region's unforgiving winter conditions.

Power, Violence, and Memory: Confronting the Archives of Human Suffering

The arc of history is both a testament to human progress and a chronicle of its darkest failures, marked by unparalleled brutality and enduring questions of justice and morality. These acts, whether committed by individuals, states, or ideologies, are not merely episodes of violence but complex systems of dehumanization and control. Their roots lie in the interplay of power, prejudice, economic greed, and the legitimization of violence through cultural, religious, or ideological frameworks. The complex interplay between power, ideology, and violence reveals the depths of human depravity as well as the resilience of the human spirit. As we delve into the agents and systems behind history's most harrowing atrocities, we confront not only the acts themselves but also the narratives that preserve, obscure, or distort them. This research seeks to unravel these layers, combining rare insights, critical analyses, and authentic data to offer a profound exploration of humanity's relationship with cruelty, complicity, and redemption. It is a journey into the mechanisms of historical brutality and the archives that document them, urging a reevaluation of how memory, truth, and justice are constructed and contested.

The works which share a common thread and question the objectivity of historical narratives and reveal how history is often shaped by those in power to reinforce ideologies, national identities, or cultural myths are, Howard Zinn - A People's History of the United States (1980), Eric Hobsbawm and Terence Ranger - The Invention of Tradition (1983), Benedict Anderson - Imagined Communities: Reflections on the Origin and Spread of Nationalism (1983), E.H. Carr - What Is History? (1961), Edward Said -Orientalism (1978), Pierre Nora - Realms of Memory: The Construction of the French Past (1996), Dominic Sandbrook - Who Dares Wins: Britain, 1979-1982 (2019), Prasenjit Duara- Rescuing History from the Nation: Questioning Narratives of Modern China (1995), David Lowenthal -The Past Is a Foreign Country (1985), Yuval Noah Harari - Sapiens: A Brief History of Humankind (2011).

In The Use and Abuse of History (Published in 1981) by Marc Ferro a critical exploration in the same vein also shows how history is used, manipulated, and sometimes distorted to serve political, cultural, and ideological purposes,, the book focuses on the ways historical narratives are constructed and presented, particularly in school textbooks, and how these narratives shape collective memory and national identity. Ferro highlights how inconvenient truths are often omitted or downplayed in historical narratives. This "historical amnesia" serves to create sanitized versions of the past that align with national or ideological goals. He examines how this process occurs across different countries, from France to the Soviet Union, and even in post-colonial states. History is not a singular narrative but a collection of competing perspectives. Ferro emphasizes that the histories taught to children in one country often differ significantly from those taught in another, even regarding shared events. For example, World War II is portrayed differently in German, British, American, and Russian textbooks, reflecting each country's distinct experiences and agendas. Ferro provides a rich array of examples from around the world, including colonialism, the French Revolution, the Russian Revolution, and World War II. He shows how

became cogs in a machinery of death. This observation aligns with Hannah Arendt's concept of the "banality of evil," which highlights how ordinary people can commit extraordinary acts of cruelty when situated within systems that normalize such behavior. Archives documenting these brutalities play a

Archives documenting these brutalities play a dual role. On one hand, they serve as repositories of memory and evidence, preserving the voices of victims



different societies construct historical narratives that reflect their political and cultural priorities, often at the expense of historical accuracy.

Ferro underscores the responsibility of historians to uncover suppressed voices and challenge dominant narratives. He advocates for a more inclusive and critical approach to history that considers multiple perspectives, especially those of marginalized groups. Ferro critiques how history education can become a form of propaganda, instilling loyalty, patriotism, and obedience in young minds while discouraging critical thinking.

However, works which share thematic connections with Marc Ferro's work but whose focus often extends beyond specific ideological manipulations to broader philosophical frameworks for understanding civilizations are Ibn Khaldun - Muqaddimah (Prolegomena) (1377), Arnold J. Toynbee - A Study of History (1934–1961), Oswald Spengler - The Decline of the West (1918–1922) etc.

The agents of historical brutalities often emerge from systems that normalize violence under the guise of necessity, progress, or divine mandate. From the enslavement of populations in ancient empires to the genocides of the modern era, these acts often find their justification in ideologies that dehumanize the "other." The transatlantic slave trade, for instance, represents a convergence of economic greed, racial prejudice, and political expediency.it was a system supported by monarchies, corporations, and religious institutions. Pseudotheologians argued for the spiritual salvation of enslaved peoples as a justification for their subjugation, while scientists of the time produced pseudoscientific racial hierarchies to rationalize their exploitation. Similarly, colonial powers employed narratives of cultural superiority and the "civilizing mission" to justify their campaigns of territorial expansion, resource extraction, and the suppression of native cultures. These brutalities were not isolated acts but systemic projects sustained by propaganda, legal frameworks, and economic incentives that made complicity pervasive.

Modern atrocities, such as genocides and ethnic cleansings, reveal the horrifying efficiency of bureaucracy and ideology in perpetuating brutality. The Holocaust, often cited as the epitome of industrialized genocide, was enabled by a meticulously organized state apparatus. From the Nuremberg Laws to the operation of death camps, every step was systematized to dehumanize and destroy targeted groups. What is chilling is not just the scope of the atrocity but the ordinary nature of its perpetrators-bureaucrats, soldiers, and civilians who

and the records of crimes for posterity. The testimonies of Holocaust survivors, for instance, are invaluable for understanding the human impact of genocide. On the other hand, archives often reflect the biases and intentions of their creators. Official state archives may sanitize or omit atrocities, as seen in colonial records that glorify empire while erasing indigenous resistance and suffering. Even well-intentioned archives, such as those created by human rights organizations, face challenges in balancing comprehensiveness with accessibility, avoiding sensationalism, and ensuring ethical representation of survivors' voices. The perpetrators ranged from political leaders to ordinary citizens complicit in a system that normalized atrocity. Archives of this period, such as

Open-source investigations, social media, and decentralized archives allow for real-time documentation of atrocities, often bypassing state censorship. Platforms like Bellingcat and initiatives like the Syrian Archive demonstrate how technology can democratize the process of truth-telling. However, these tools are not without risks. The digital divide can exclude marginalized voices, while the proliferation of data raises questions about authenticity, verification, and ethical use...



the meticulous records kept by the Nazis themselves, serve as chilling evidence of bureaucratic inhumanity but also raise questions about the role of documentation in perpetuating or challenging oppressive systems.

A deeper critique of archives involves questioning not just their content but their structure and purpose. Who decides what is worth preserving, and whose stories are left untold? For example, colonial archives often reduce entire cultures to anthropological curiosities, stripping their subjects of agency and context. In these cases, the very act of archiving becomes an extension of the violence, perpetuating systems of erasure and marginalization.

The digital age has introduced new paradigms for documenting and critiquing brutality. Open-source investigations, social media, and decentralized archives allow for real-time documentation of atrocities, often bypassing state censorship. Platforms like Bellingcat and initiatives like the Syrian Archive demonstrate how technology can democratize the process of truth-telling. However, these tools are not without risks. The digital divide can exclude marginalized voices, while the proliferation of data raises questions about authenticity, verification, and ethical use. Moreover, the sheer volume of information can overwhelm audiences, leading to desensitization or apathy rather than action.

Understanding the perpetrators of brutality also requires an exploration of psychological and sociological factors. Studies of mass violence, such as those conducted by Christopher Browning and Philip Zimbardo, reveal how ordinary people can become perpetrators under specific conditions. Dehumanization, obedience to authority, groupthink, and fear are recurring themes in such research. These insights challenge simplistic notions of "evil" and compel us to examine the systemic and situational factors that enable brutality. They also underscore the importance of fostering critical thinking, empathy, and moral courage to resist complicity.

The critique of historical brutalities and their documentation is not merely an academic exercise but a moral imperative. It is a call to confront uncomfortable truths, challenge dominant narratives, and recognize the humanity of those who have suffered. This process involves not just preserving memory but actively engaging with it, ensuring that history's lessons inform present and future actions. As the philosopher George Santayana famously observed, "Those who cannot remember the past are condemned to repeat it." To this, one might add that those who fail to critically examine how the past is remembered risk perpetuating its injustices.

The study of history's brutalities and their documentation is more than an academic pursuit; it is a moral imperative that speaks to the core of what it means to be human. By critically engaging with the past and scrutinizing the biases inherent in its preservation, we honor the voices of those who suffered and reclaim the humanity lost in cycles of violence. This research not only exposes the agents and systems that perpetuated atrocities but also challenges us to confront our complicity in shaping narratives of power and exclusion. With rare and authentic insights, it invites a timeless reflection on the ethical responsibilities of memory and justice, urging society to transform its understanding of history into a catalyst for compassion, accountability, and a future defined by collective dignity. This endeavor, though fraught with challenges, remains one of humanity's most profound and urgent responsibilities. It demands $an \, unwave ring \, commitment \, to \, amplifying \, marginalized$ voices, interrogating systems of power, and fostering a more inclusive and humane understanding of history.

Nikshay Shivir: A Community-Driven Mission to Eliminate TB in Kashmir



Tuberculosis (TB) has long been a major public health concern across the world, particularly in countries like India, where the burden of the disease remains high. Despite the global effort to combat this infectious disease, it continues to pose a significant challenge, and efforts to eliminate it remain a top priority for the Government of India. To tackle this, the government has introduced several initiatives over the years, among which the "Nikshay Shivir" has emerged as one of the most impactful and far-reaching campaigns for TB elimination. This 100-day intensified campaign is a critical part of India's strategy to eliminate TB and its burden from the country by the year 2025. In Kashmir, the initiative holds great promise, and efforts have been made to bring together the community, healthcare providers, and government and non-government agencies, ultimately creating a multi-faceted approach to eliminate TB from Kashmir.

India is the global leader in terms of the TB burden, with nearly a quarter of the world's TB cases. Nationally, the incidence rate is about 195 cases per lakh population, significantly higher than in Kashmir, where the incidence is below 50 cases per lakh population in most districts, including Srinagar. Even in the Kashmir Valley, where Srinagar is a healthcare hub due to its tertiary care hospitals and advanced private healthcare facilities, around 1,400 cases are diagnosed and notified annually. This number is nearly three times higher than the actual number from Srinagar District itself. which is under 500 because of cases from other districts and even States and UTs are diagnosed and even treated here. Moreover, in many cases, the notified number of cases may

be higher, especially due to the phenomenon of duplication in case notifications. This happens when individuals, after receiving a TB diagnosis, seek second opinions or retests in other facilities, often under different names or contact details, leading to duplicate entries in the health system. To curb this issue, the government of India is in process of mandating Aadhaar-based identification to ensure accurate tracking and prevent duplication in notifications.

There appears to be confusion surrounding the concepts of TB elimination and eradication, with some medical professionals and journalists mistakenly believing that the Department of Health is claiming TB eradication in certain districts of Kashmir. This issue was highlighted in the article "TB Still Persists in J&K" by Zehru Nissa, published in Greater Kashmir on December 18, 2024, in which an anonymous pulmonologist was quoted. While the terms "elimination" and "eradication" may sound similar, they have distinct meanings, particularly within the context of public health. Eradication refers to the permanent global reduction of TB to zero incidence, meaning the disease would no longer exist anywhere on the planet. While this is a long-term global objective, achieving eradication is challenging in the short term, especially given the high incidence of TB in neighboring countries. On the other hand, TB elimination means reducing

the incidence of TB in a specific region or country to a level where it is no longer a public health concern. The programmatic operational definition for TB elimination is when the incidence of TB falls below 44 cases per lakh population, at which point the disease is no longer a significant threat to public health in that particular geographic area. Most districts in Kashmir, including Srinagar, are nearly reaching this operational target, putting them in a strong position to eliminate TB. In fact, some districts such as Budgam, Anantnag, and Pulwama have already reached this milestone.

It is important to understand these definitions to manage expectations. While TB eradication remains a long-term global goal, elimination is a more achievable and realistic

objective for regions like Kashmir. Thus, initiatives like the Nikshay Shivir focus on TB elimination, aiming for the reduction of TB incidence to a point where it no longer poses

prevention of TB. The Nikshay Shivir campaign is an integral part of India's commitment to achieving the goal of a TB-free India by 2025. The success of the Nikshay Shivir campaign relies on active case finding—the process of identifying TB cases through outreach and targeted screenings. In Kashmir, the Department of Health Services has expanded its focus to include high-risk populations such as elderly individuals, smokers, diabetics, people living in congregate settings, and those who have had close contact with TB patients diagnosed in the past five years. Additionally, people who are immunocompromised, underweight, alcoholics or suffer from other

chronic diseases are also targeted in the screening efforts. More importantly the aim is to increase awareness among

the population regarding TB symptoms, the importance of early diagnosis, the availability of treatment, and the government's nutritional and other support interventions. In an effort to ensure early detection, vulnerable populations are being mapped, and a proactive approach is being adopted for screening and testing in these high-burden areas.

To increase the effectiveness of the Nikshay Shivir campaign, various high-sensitivity diagnostic tools are being

employed. These include traditional methods like X-rays and the Nucleic Acid Amplification Test (NAAT), which can accurately detect TB in a matter of hours. Moreover, innovative new tools such as the cough app, which uses symptoms like the type of cough to predict potential TB, have been introduced to enhance case detection. The campaign follows a three-

pronged screening approach: Screening 100% of the identified

vulnerable populations through active case finding in communities.

Screening 100% of individuals attending specialized OPDs, such as those for HIV, non-communicable diseases (NCDs), tobacco cessation clinics, cancer centers, and dialysis units.

Screening at least 10% of adult patients in general OPDs in community health centers (CHCs), sub-district hospitals (SDHs), district hospitals (DHs), and medical colleges, and 5% in Primary Health Centers (PHCs) and similar urban primary

A key element of the Nikshay Shivir campaign is Janbagidari-community participation. The success of TB elimination efforts depends not only on healthcare professionals and government institutions but also on the active involvement of local communities, NGOs and other stakeholders at all levels. This approach involves mobilizing local leaders, NGOs, and voluntary organizations to raise awareness, educate the public, and provide direct support to those affected by TB.

At the national level, elected representatives such as MPs, along with ministries like Health and Panchayat Raj, play a crucial role in advocating for policy changes, securing funding, and driving awareness campaigns. At the state and district levels, the involvement of local officials like MLAs, district collectors, and medical officers is essential for coordinating screening efforts, ensuring timely treatment, and ensuring that TB control measures are implemented effectively.

At the village level, Gram Panchayats, Self Help Groups (SHGs), and Ayushman Arogya Mandirs are actively involved in raising awareness, providing care, and supporting TB patients with nutritional interventions. These community-driven efforts are crucial for building trust, ensuring better health outcomes, and fostering a sense of collective responsibility toward TB elimination.

The success of Nikshay Shivir is also reliant on collaboration with various sectors and organizations. The campaign actively engages corporate partners, trade unions, market associations, and private healthcare providers. These stakeholders help with spreading awareness, providing financial and nutritional support to TB patients, and ensuring the availability of healthcare services for workers in industries and other sectors prone to TB exposure. For example, the campaign organizes TB screening camps for workers in mining industries and corporate sectors, provides nutritional support to TB patients through corporate partnerships, and conducts awareness programs through trade unions and market associations. This collaboration enhances the reach of the campaign and strengthens its effectiveness.

As the campaign continues to evolve, with more tools, better diagnostics, and increased awareness, Kashmir's healthcare system is poised to take a giant leap forward in the battle against TB. By leveraging the power of community participation, advanced screening techniques, and collaborative efforts, the region can create a healthier, TB-free future for its citizens and set a benchmark for other parts of India to follow.

FROM MISDIAGNOS TO RECOVERY:

A PERSONAL JOURNEY OF HEALING AND GRATII

In the world of healthcare, where patient well-being should be the ultimate priority, navigating the complexities of treatment and medical costs can often become as challenging as the illness itself. For one patient, what began as a simple injury in Gulmarg turned into a harrowing journey through misdiagnosis, inflated medical costs, and eventually, finding expert care at Max Super Specialty Hospital in Dwarka,

The next day, Fortis contacted us again, this time offering a Rs 1 lakh further reduction, bringing the cost down to Rs 2.5 lakh . At this point, I $\,$ began questioning the transparency of the hospital's pricing, and with a sense of unease, we decided to walk away. The constant bargaining and price reductions felt more like a sales transaction than a compassionate medical consultation.

The Disappointment at Batiya Hospital

We then moved to Batiya Hospital in Sector 37, Chandigarh, where Dr. Arvind Singh Bhatia initially told us that the fracture was not severe and could be treated with a plaster. predicted light snowfall in some higher reaches of north Kashmir until tomorrow (Sunday) morning. Dr Mukhtar Ahmad, Director of the MeT Department, said the weather is expected to remain dry between December 23 and December 26.

"From late December 27 to the forenoon of December 28, light rain is likely in Jammu plains, with light snow in higher reaches of Chenab Valley and the Pir Panjal region," he said. "The weather is expected to remain dry again on December 29 and 30, with light snowfall possible in a few higher-altitude areas thereafter."

The MeT has issued an advisory predicting a slight rise in minimum temperatures by 1-2°C over the next two days, followed by another drop of 2-3°C by December 26. Tourists, travellers and transporters have been advised to exercise caution, given the subfreezing temperatures, icy road conditions and the possibility of fresh snowfall in higher reaches—(KNO)

DHSK issues

News Observer (KNO), the advisory defines a cold wave as a weather phenomenon marked by a significant drop in air temperature, sometimes accompanied by frost and hazardous conditions like icing.

DHSK urred people to stray undated and adequately prepared

DHSK urged people to stay updated and adequately prepared about the weather patterns and district-specific warnings.

Among those identified as high-risk groups are homeless individuals, the elderly, economically disadvantaged people, disabled individuals, pregnant and lactating mothers, children, outdoor workers, managers of night shelters, farmers, and individuals who use illicit drugs. "These groups are particularly vulnerable to the adverse health effects of prolonged exposure to extreme cold."

The DHSK further warned that intense cold can lead to serious health conditions such as hypothermia, frostbite, and other cold-related injuries like immersion foot and chilblain.

"Hypothermia, a medical emergency, can be life-threatening if not addressed promptly. Symptoms of hypothermia in adults include shivering, memory loss, exhaustion, slurred speech, confusion, drowsiness, and fumbling hands," it reads.

The advisory further reads that among the infants, it manifests as bright red, cold skin and low energy.

It further stressed upon the importance of immediate action, including moving the affected person to a warm shelter, removing wet clothing, and warming their body with blankets or skin-to-skin contact. Emergency medical attention is essential for severe cases.

DHSK has recommended several preventive measures to prepare for and combat the cold wave. These include stocking adequate winter clothing and emergency supplies such as food, water, and medicines.

"People are advised to wear multiple layers of loose-fitting, warm clothing, cover extremities like the head, neck, hands, and feet, and eat a healthy diet rich in Vitamin-C to boost immunity. Drinking warm fluids regularly and keeping the skin moisturized is also advised to maintain body heat and protect against dryness," it reads.

DHSK in the advisory urged the public to avoid prolonged exposure to cold. It also asked the public to refrain from consuming alcohol and not ignore signs of shivering, which indicates the body is losing heat.

The directorate further asked the locals to remain vigilant for symptoms of frostbite or hypothermia and suggested to seek medical attention immediately if such symptoms occur—(KNO)

Avoid unnecessary

The advisory as per news gathering agency KINS reads: "Avoid Unnecessary Travel: Minimize travel, especially during early mornings and late nights when temperatures are at their lowest".

"Ensure vehicles are equipped with winter tyres, antifreeze coolant, and fully functional lights and wipers. Motorists should also check their vehicle's battery, as extreme cold can affect performance".

Travel Planning: Allow extra time for journeys to account for potentially slippery roads. Keep the fuel tank at least half full to prevent fuel line freezing.

Driving Tips: It is recommended to drive slowly, maintain a safe distance, and avoid sudden movements to prevent skidding. Bikers are advised to wear thermal gear and helmets with anti-fog visors.

The advisory also warns against overtaking on icy or foggy roads and urges drivers to stay focused and avoid using mobile phones while driving. In case of vehicle skidding, drivers should steer gently in the direction of the skid and avoid slamming the brakes.

Motorists are encouraged to stay updated on weather conditions and traffic advisories before setting out on their journeys.(KINS)

Business Rules

council of ministers. As per Section 55 of the Act, the Lieutenant Governor shall make rules on the advice of the Council of Ministers for the allocation of business to the Ministers and for the more convenient transaction of business with the Ministers, including the procedure to be adopted in case of a difference of opinion between the Lieutenant Governor and the Council of Ministers or a Minister.

deferrals and the formation of ministerial groups to address

unresolved issues.

While Omar refrained from comparing this meeting to previous ones, he stressed the importance of protecting Jammu and Kashmir's

The speculation over increased taxes from the existing 12 percent to a whopping 28 percent on Kashmiri shawls had caused concern among stakeholders in the valley, who rely heavily on the intricate craft for their livelihoods.

Peoples Democratic Party (PDP) leader, Naeem Akhtar and People's Conference (PC) chairman Sajad Gani Lone had voiced strong opposition to the proposed Goods and Services Tax (GST) hike on Kashmiri shawls from 12% to 28%, warning that such a move would devastate Kashmir's fragile economy and leave thousands of artisans in distress.

Earlier on Friday, responding to certain reports appearing in a section of media regarding the proposed revision of tax slab in the upcoming GST Council meeting, a spokesperson of the Jammu and Kashmir government clarified that the UT administration had already taken up the matter with the Union Ministry for Commerce & Industry.

The spokesperson said they have requested the Union government to lower the GST rate structure from the existing 12% to 5% uniformly, including shawls priced above Rs 1,000 to reduce the tax burden on this artisan-driven industry and support marketability.

Govt committed

would go a long way in promoting and giving a new lease of life to the local film industry in both the regions.

Deputy Commissioner, Rajesh Kumar Shavan, local MLAs and representatives of Panchayati Raj Institutions (PRIs) besides district officers attended the meeting.

The Union Minister called upon the National Hydro Power Corporation Limited (NHPCL) to undertake capacity building of local unskilled labour to increase their employability for projects requiring specific skills and specialised training.

Reviewing the status of projects aimed at boosting connectivity in the district, Dr Singh called for expediting the construction of a full-fledged airstrip in the district under Ude Desh Ka Aam Nagrik (UDAN). The facility aims to improve connectivity for the population living in tough terrain.

Sydney Sixers 164 for 5 (Silk 36*, Philippe 35, Dwarshuis 20*, Ferguson 2-32) beat Sydney Thunder 163 for 5 (Bancroft 70*, Davies 47, Hosein 2-23, Dwarshuis 2-26) by five wickets

Ben Dwarshuis hit Sydney Sixers to an unlikely last-ball win over Sydney Thunder, taking 15 from the last over to take his team past the victory mark.

On the same night that Sam Konstas was bowled for a duck in his last innings before a likely Boxing Day Test debut, Dwarshuis hit Sixers home at Engie Stadium.

Chasing 164 for victory, Sixers looked shot when they needed 47 from the final four overs. But Jordan Silk (36* off 25 balls) helped them take 17 from a Nathan McAndrew over, before Dwarshius provided the late heroics with 20 not out from eight balls.


After launching Lockie Ferguson for six from the first ball he faced, Dwarshuis took charge with 15 needed from Chris Green's final over. Green's first three balls were hard to get away but he was hurt by two straight wides outside off. $Then \, with \, seven \, needed \, from \, two \, balls, Dwarshuis \, smashed$ Green over the long-on rope for six, before taking a quick single off the last ball to finish the job.

Earlier, Cameron Bancroft hit an unbeaten 70 from 52 balls to help Thunder reach 163 for 5. Bancroft was the favourite to return to the Test team when Cameron Green was ruled out for the season, before a nightmare summer with the bat pegged him back.

In his past 15 innings across all formats before Saturday night, Bancroft passed 20 twice as Nathan McSweeney and Konstas both went past him in the pecking order. But Bancroft looked back to being in good touch against Sixers, hitting three sixes and five fours. His innings helped keep Thunder's innings together, as Oliver Davies also banged 47 from 34 for the hosts and hit three straight sixes off Todd Murphy.

Playing for the first time since being called into Australia's Test squad, Konstas went to cut a short ball from Akeal Hosein and bottom-edged it on to his stumps. The 19-year-old's duck came after he had set the BBL alight on debut five days earlier, smashing the fastest 50 in Thunder's history against





Dropped McSweeney after a lot of deliberation: Bailey

ustralia's chairman of selectors George Bailey revealed on Friday that he had "deliberated a lot" before deciding to drop opener Nathan McSweeney for the final two Tests of the Border-Gavaskar Trophy, a decision based on how the series had unfolded.

Teenage sensation Sam Konstas received his maiden call-up following a string of disappointing performances from the Australian top order in the first three Tests, particularly from McSweeney.

Having made his Test debut in the series-opener in Perth, the 25-year-old McSweeney capped scores of 10, 0, 39, 10 not out, 9 and 4 in his six innings and was dismissed by Indian pace spearhead Jasprit Bumrah four times.

"(It was a) really hard decision for Nathan and one that we spent a lot of time deliberating over. Particularly after a small sample size of three Tests... That's never a great phone call, is it?" Bailey was quoted saying in ESPNCricinfo.

Bailey conceded that McSweeney was dejected after getting the news but said the top-order batter has the ability to bounce back and be in Test reckoning in future.

"Nathan was disappointed and really the message to him was much the same as at the start of the series, that we believe he has the ability and temperament to

"But just given the way the series has played out, we just want the option of throwing something different at India for this next Test (in Melbourne)," added Bailey. The five-Test series is keenly poised with both teams level at 1-1 after the

drawn third Test at the Gabba. "It has clearly been a challenge at the top of the order for batters throughout the series and we want to provide the option of a different line up for the next two matches." he added

Former pacer and ex-selector Merv Hughes had cautioned selectors against making any changes to the batting lineup for the Boxing Day Test.

"Now it would almost be a panic call to me... Just stay calm. They (India) drew the last Test. The last two Tests have been a draw and a win, so what is there to panic about," Hughes had told 'The Courier Mail'.
