Govt Forms Committees for Verification of PDS Beneficiaries

SRINAGAR: The Government of Jammu and Kashmir has issued an order sanctioning the formation of District Level Committees to verify beneficiaries enrolled in the Public Distribution System (PDS) database. The committees will oversee the identification of eligible individuals, removal of ineligible entries, and inclusion of left-out beneficiaries under the PDS.

According to Government Order No. 2129-JK(GAD) of 2024, the committees will be chaired by the respective Deputy Commissioners. Other members include the Assistant Commissioner(Revenue), Assistant Commissioner (Development),

The terms of reference for the committees include verifying the eligibility of beneficiaries as per applicable rules, ensuring the inclusion of eligible but left-out individuals, and completing e-KYC for all pending eligible beneficiaries under the PDS.

The committees have been directed to submit their reports to the Department of Food, Civil Supplies, and Consumer Affairs within one month. The initiative aims to streamline the PDS database and ensure that benefits

He also asked them to make it a regular feature to keep check on the Health & Wellness Centres and Ayushman



Yuval Noah Harari on AI: A Microscope for the Mind and a Mirror to Humanity

Artificial Intelligence (AI) has emerged as one of the most transformative technologies of our time, carrying immense promise and profound challenges. In a recent interview, renowned historian and philosopher Yuval Noah Harari shared his perspective on AI's impact on humanity, offering a thought-provoking mix of optimism and caution. His reflections shed light on AI's potential to enlighten us about our capabilities and limitations while serving as a sobering reminder of the ethical, social, and existential questions we must confront.

The Enlightenment of AI: Unlocking Human Potential Harari underscores that AI has a remarkable ability to illuminate the human mind's capabilities. By analyzing vast amounts of data, identifying patterns, and automating complex tasks, AI reveals how much can be achieved through ingenuity and collaboration. It demonstrates the potential of humans to create systems that augment intelligence and solve problems on an unprecedented scale.

During the interview, Harari was asked:

Q: "How do you see AI transforming the way we understand ourselves and our place in the world?"

A: "AI can be like a microscope for the mind. It doesn't just process data—it helps us perceive the hidden structures of our thoughts and decisions. For example, when an AI analyzes millions of decisions made by humans, it often exposes biases we weren't aware of. This can help us understand ourselves better and aspire to higher standards of morality and rationality."

For instance, Al applications in medicine are revolutionizing diagnostics and treatment, enabling early detection of diseases and personalized care. Similarly, in education, Al-

driven tools are tailoring learning experiences to individual needs, fostering better understanding and engagement. Harari emphasizes that such innovations not only improve quality of life but also inspire a deeper appreciation for human creativity and resilience.

The Sobering Reality: Risks to Autonomy and Society However, Harari warns that Al's rapid advancement comes with sobering challenges. One of his key concerns is the erosion of human autonomy. As Al systems increasingly portionately affecting vulnerable populations. The resulting economic disruption could deepen existing inequalities, sparking social unrest and political instability.

Al as a Mirror to Humanity

Harari also presents Al as a mirror that reflects humanity's aspirations and flaws. Al systems are trained on human-generated data, meaning they inherit our biases, values, and priorities. This mirroring effect forces us to confront uncomfortable truths about discrimination, power



make decisions in areas ranging from hiring to law enforcement, there is a risk of ceding critical choices to opaque algorithms. This shift could lead to a loss of agency and accountability, particularly if these systems embed biases or are manipulated by powerful entities.

are manipulated i When asked:

Q: "What is your biggest fear about the misuse of AI?" A: "My greatest concern is the concentration of power. Imagine a handful of corporations or governments using AI to monitor and manipulate billions of people. It's not just about privacy—it's about freedom. If we're not careful, AI could create a system where a few control the many, and individuals lose the ability to make meaningful choices."

Moreover, Harari highlights the societal impact of Alon employment and inequality. While automation can enhance efficiency, it threatens to displace millions of jobs, dispro-

dynamics, and ethical blind spots in our societies. In the interview, Harari addressed this dynamic:

Q: "Do you believe AI can ever be truly neutral?"
A: "No, because neutrality doesn't exist in the data it learns from. AI is not a divine oracle; it's a reflection of us. If we train it with biased, flawed, or prejudiced data, it will amplify those flaws. But this also presents an opportunity—it forces us to take a hard look at ourselves and ask, 'What kind of world are we teaching AI to create?'"

For example, controversies surrounding biased facial recognition systems or discriminatory credit scoring algorithms highlight the urgent need for fairness and inclusivity in Aldevelopment. Harari argues that addressing these issues is not merely a technical challenge but a moral imperative, requiring collaboration across disciplines and cultures.

quiring conaboration across disciplines and culture Charting a Path Forward: Harari's Call to Action To navigate the dual nature of Al's enlightenment and sobering consequences, Harari advocates for a proactive and inclusive approach. State Taxes Department Imposes Rs 1.52 Crore **Penalty on Tax Violations in 2024-25**

SRINAGAR: In a significant development, the Enforcement (Central) wing of the State Taxes Department, Kashmir, has imposed a total penalty of Rs 1.52 crore for tax violations related to major commodities, including cement, scrap, TMT bars, timber, and plywood, for the financial year 2024-2025 up to December. This action is part of the department's ongoing efforts to maintain strict vigilance on goods being transported across the state.

Under the leadership of Deputy **Commissioner State Taxes Enforcement** (Central) Kashmir, Waseem Raja, and the overall supervision of Commissioner State Taxes, PK Bhat, the department conducted special enforcement activities in Srinagar, Budgam, and Ganderbal districts.

To maximize detection and deterrence, three field teams and a flying squad were formed, comprising State Taxes officers, inspectors, sub-inspectors, and guards. These teams carried out surprise checks and inspections even during late hours and on Sundays.

A special enforcement team at Srinagar airport focused on monitoring mobile phones and other cargo items. The department's efforts have led to a significant rise in penalties compared to previous years. A penalty of Rs 9 lakh was imposed on cement-related

tax violations, while scrap shipments attracted a fine of Rs 2,47,494, marking a 162% increase from last year's penalty of Rs 94,590.

The timber and plywood sector saw a penalty amounting to Rs 9,84,654, which is a 95% increase from the previous year's penalty of Rs 5,03,762. Additionally, penalties on TMT bars amounted to Rs 1,99,800,



reflecting a 60% rise from last year's Rs

An analysis of violations in September, October, and November 2024 shows a remarkable surge in penalties, particularly in scrap and cement sectors. A penalty of Rs 1,06,100 was realized from scrap cases during these months, representing a 268% increase compared to the Rs 28,800 charged in FY 2023-24. Similarly, the enforcement teams imposed Rs 5,01,580 in penalties on cement violations during the same

To enhance the efficiency of its operations, a Data Analytics Cell was established by DC Enforcement (Central) to monitor transporters and track e-way bills. This cell collects data from the online MIS/E-way bill portal and shares critical inputs with field teams, enabling more accurate and efficient enforcement. "The creation of the Data Cell aims

to streamline our enforcement activities by utilizing smart work to track violators," said Waseem Raja. "The information provided through the online portal has proven to be invaluable in our operations." Raja praised the efforts of the

enforcement teams, noting the success in adhering to recent directions from higher authorities to monitor certain commodities more closely. "Our aim is to further enhance our activities and achieve even greater results by the end of the financial year," he added.

As of December, the enforcement wing has levied a total penalty of Rs 1.52 crore, verifying over two lakh e-way bills from April to November 2024, marking a 45% increase from the same period last year.



He called for timely replacement of damaged transformers and urged for protection of field staff with proper safety gear to prevent accidents during repair work.

If the master's house caught fire, they'd pray for a strong wind to come along. This was the difference between the two.

And today you still have house Negroes and field Negroes. I'm

a field Negro".

improving the quality of life in tribal-majority villages. Under the proposal, which is being submitted to Ministry for Tribal Affairs (MoTA), the mission will cover 20 districts, 112 blocks and 393 villages notified in J&K.

Additionally, 676 new villages and 204 villages from aspirational districts including Baramulla and Kupwara, have been identified for inclusion, bringing the total number of tribal villages under the mission to 880. The Dharti Aaba Mission will prioritize interventions in infrastructure, education, healthcare and livelihood development.

The Minister emphasized the inclusion of newly recognized tribal communities under welfare schemes. With the recent amendment to the Jammu and Kashmir Scheduled Tribes Order, 2024, communities such as Pahari Ethnic tribe, Gadda Brahmin, Koli and Paddari have been added to the Scheduled Tribes list, doubling the tribal population of J&K to approximately 30 lakh, which accounts for 11.9 percent of J&K's total population. These newly recognized tribes will immediately benefit from key programs such as Pre-Matric and Post-Matric scholarships to boost educational opportunities and Dharti Aaba scheme for livelihood development.

Additionally, the Pradhan Mantri Aadi Adarsh Gram Yojana PMAAGY) will be extended to tribal villages, focusing on holistic development with an emphasis on improving basic amenities and socio-economic indicators. A detailed socio-economic survey is also in the pipeline to identify the specific challenges and needs of tribal communities, ensuring that interventions are targeted and effective.

To further strengthen the tribal economy, self-employment hemes like Van Dhan Vikas Kendras are being prioritized. Under these initiatives, tribal artisans and entrepreneurs will receive skill development training, financial support and market linkages to promote their indigenous crafts and products.

The Tribal Affairs Department has prepared a comprehensive proposal to expand the coverage of tribal villages, selecting them based on specific criteria, such as a minimum population of 500 people with at least 50 percent belonging to Scheduled Tribes. For instance, Baramulla district will include 43 new villages alongside 54 aspirational district villages, while Kupwara will cover 50 new villages and 150 aspirational district villages, making them major hubs for tribal-focused areas.

Underlining the intent of the Government to ensure that all tribal welfare schemes reach their intended beneficiaries, the Minister instructed the Director Tribal Affairs to plan the launch of a series of awareness campaigns in collaboration with tribal leaders, NGOs and local bodies. These campaigns will educate communities about their rights and entitlements under various welfare schemes, he added.

Stressing the importance of a robust monitoring mechanism to oversee the implementation of tribal welfare schemes, Rana directed for regular reviews to ensure transparency, accountability and timely delivery of benefits.

Recognizing the pivotal role of women and youth in tribal communities, the Minister announced roll out of special initiatives under the Dharti Aaba Mission to empower tribal women through skill development centers and Self Help Groups (SHGs). Dedicated programs will also be launched for tribal youth, including career counseling sessions, sports programs and training for competitive exams to foster leadership and educational growth among the younger generation.

DUBAI: Swashbuckling Indian batter Smriti Mandhana closed in on the top spot while occupying the second slot in both the ICC T20I and ODI batting rankings released on Tuesday.

While Mandhana moved a spot in the T20I rankings, the Indian vice-captain retained her second place in the ODI charts, following impressive performances against the West Indies in both the formats.

The left-hander's ODI rating of 739 is only bettered by Laura Wolvaardt's 773, and her T20I rating of 753 is narrowly shaved by Beth Mooney's 757.

Mandhana made 62 (41b) and 77 (47b) in the two T20Is for the week to move up to No.2, completing a trifecta of halfcenturies against Hayley Matthews' team in as many matches.

The 28-year-old went on to make 91 (102) in the opening ODI in Vadodara, and now boasts scores of 50 plus in her last five visits to the crease in international action.

On the opposing side, Matthews too showed her class with bat in hand, with scores of 85 not (47) and 22 (17) in the two T20Is across the week, leading to a two-spot jump to equal-third on the Rankings, level with Tahlia McGrath with a rating of 748.

The bottom half of the ODI batting top-ten meanwhile saw multiple shuffles, as ICC Women's Championship action played out across the world.

Harman preet Kaur's score of 34 at Vadodara helped her jump three spots and is back in the top 10.

Australian Alyssa Healy's scores of 39 and 34 against New Zealand saw the opener up two spots to the eighth place with a rating of 640.

Compatriot Annabel Sutherland enjoyed arguably the most noteworthy jump of the week, with scores of 105 not out and 42 leading to an 11-spot climb to 18th (563 rating points).

The right-arm quick went on to claim 3/39 in the third ODI to see her move up two spots into 7th on the All-Rounder rankings (301), moving past Sophie Devine and Chamari Athapaththu.

While there was little change in top ten bowling rankings across ODI and T20I cricket, emerging talents across series in India and New Zealand did make significant strides.

iki Prasad will lead almost the same squad that won the recent Under-19 Asia Cup for women at next month's U-19 World Cup, in Malaysia. The only change in the 15-member squad is the inclusion of Vaishnavi S in place of 15-year-old medium-pacer Nandhana S, who has been named among the stand-bys.

The other standby players are Ira J and Anadi T, who have replaced Hurley Gala, Happy Kumari, G Kavya Sree and Gayatri Survase from the standby list for the Asia Cup.

The U-19 women recently lifted the Asia Cup in Kuala Lumpur by beating Bangladesh by 41 runs in the final.

Gongadi Trisha, the Player of the Match in the final, had top-scored with 52 off 47 balls while opening the batting with G Kamalini, who had bagged a WPL contract with Mumbai Indians on the same day she scored an unbeaten 44 off 29 against Pakistan in the Asia Cup.

The others from the squad to get their first WPL deals were Prasad (Delhi Capitals) and VJ Joshitha (RCB). Medium-pacer Shabnam Shakil was already with Gujarat Giants, and has the experience of playing four WPL games and a couple of white-ball games for India A in Australia in August.

Trisha, Shakil and Sonam Yadav will be playing their second U-19 World Cups, having been part of the previous edition too.

India's win at the Asia Cup came after an unbeaten run (apart from a washedout game against Nepal). They won their other league game, against Pakistan, and beat Bangladesh and Sri Lanka in the Super Fours before winning the final.

The upcoming World Cup will be the second such edition, to be played from January 18 to February 2. The 16 teams have been divided into four groups of four each; India are the defending champions and in Group A along with Malaysia, West Indies and Sri Lanka. India will play all their league games at the Bayuemas Oval in Kuala Lumpur.

India's campaign will start against West Indies on January 19 before they play Malaysia on January 21 and Sri Lanka on January 23.

After the league stage, three teams will progress from each group for the Super Sixes in which there will be two groups of six teams each. Every team will carry forward their wins, points and net run-rate, which is secured against their fellow Super Six qualifiers. The top two sides from each group will then play the semifinals on January 31 before the final on February 2.
