

# 24x7 electricity unlikely without 100% metering: CM Omar

**SRINAGAR**: Amidst the promises of 200 free electricity units to the consumers, the Jammu and Kashmir Chief Minister

Omar Abdullah has made it clear that the round-the-clock electricity to the consumers would not be possible before the 100 per cent metering is done.

According to the news agency—Kashmir

News Observer (KNO), Omar told the media persons that they are trying their best to provide better facilities to the people and the complaints would pour in with regard to the pesky power cuts as it is the outcome of overloading. "The people have an agreement of 4 bulbs but they use 4 heaters at home, which leads to the overloading and thus results in the unscheduled power cuts,"

However, he said that the 24x7 electricity would be possible only when the 100 per cent metering is done.

Furthermore, he added that adequate arrangements are put in place for better facilities to the people during winters, but since there is a drought-like situation in J&K, he prays for the early snowfall so that the situation improves.Omar added that the tourist rush is expected to increase once the snowfall occurs, adding that the efforts are



However, according to the news agency - Kashmir News Observer (KNO), criticism regarding planning, execution and

delays has highlighted the need for more inclusive and efficient project management.

The launch of Srinagar's ecofriendly electric bus service in late 2023 marked a significant change in sustainable urban mobility. In 2024, these buses transported over 61 lakh passengers, with September recording the highest ridership of 7.2 lakh passengers.

While the initiative has been lauded for reducing emissions and providing safe, modern transit options, residents in peripheral areas criticized the limited routes and lack of availability. Authorities acknowledged the issue and announced plans to expand

## Mahatma Gandhi's legacy under threat from those in power in Delhi: Sonia Gandhi BELAGAVI: Asserting that Mahatma Called 'Nava Satyagraha Baithak'.

Gandhi has been and will continue to be the fundamental source of inspiration, Congress Parliamentary Party (CPP) chief Sonia Gandhi on Thursday said his legacy is under threat from those in power in Delhi and the ideologies and institutions that have nurtured them. In her message read out at the Congress Working Committee (CWC) meeting here, Sonia Gandhi lashed out at the Modi government and the RSS, and called for fighting the forces which she claimed had created a toxic atmosphere that led to Mahatma Gandhi's assassination.

Sonia Gandhi, who was not present at the meeting as she could not travel to Belagavi, said Mahatma Gandhi becoming Congress president here was a turning point for the party and for the Independence movement.

"It was a transformational milestone in our country's history. Today, we rededicate ourselves to preserve, protect and promote the legacy of Mahatma Gandhi. He has been and will continue to be the fundamental



source of our inspiration," she said.

"It was he who moulded and guided all our remarkable galaxy of leaders of that generation. His legacy is under threat from those in power in New Delhi and the ideologies and institutions that have nurtured them," she said in her message.

"These organisations never fought for our

freedom. They opposed Mahatma Gandhi bitterly. They created a toxic atmosphere that led to his assassination. They glorify his killers," Sonia Gandhi said.

The former Congress president said Gandhian institutions in various places across the nation are under assault and noted that it is fitting that this meeting is

"It is now our sacred duty to renew our resolve to confront these forces with all the might at our command and with uncompromising determination," she said.

"I am sure that the issue of strengthening our organization further to face the challenges it confronts will also come up today. Our great organization with such a glorious history has, time and again demonstrated its resilience. Let us individually and collectively move forward from this meeting firm in our resolve to meet the many challenges our party faces with a renewed sense of urgency and a refreshed sense of purpose," she said.

The CPP chairperson regretted that she was unable to be present at the "historic occasion". It is, therefore, only appropriate that you are assembled at Mahatma Gandhi Nagar," she said in her message to the Congress leaders present at the extended CWC meeting.

## **Controversy Erupts Over 'Incorrect Indian Map' During Congress Session**

**BELAGAVI (Karnataka)**: A controversy has erupted over the alleged misrepresentation of the India map on the posters displayed by the Congress to commemorate the centenary of 1924

Congress session in Karnataka's Belagavi, with the BJP dubbing it as "vote bank" politics by the national party.



The ruling Congress has put up these posters throughout Belagavi town as part of celebrations for the centenary event.

According to BJP and its ally JD(S) in Karnataka, the Indian map featured on the posters omits the Gilgit region of Pakistan-Occupied Kashmir as well as the Aksai Chin region, currently under the Chinese administration, which are integral parts of Jammu and Kashmir Reacting to the controversy, Deputy Chief Minister DK Shivakumar, who is also the Congress Karnataka unit president, said the posters would be removed if there is any mistake.

'Some leaders might have made some mistake we are removing everything. Don't try to pick a small stone in the curd..

We have done according to Indian tradition and values of those days... BJP is there to attack us, they can't digest. There is no medicine for jealousy. Let them do what they want..." he told reporters in Belagavi.

The national unit of BJP strongly criticised

the Congress. In a post on 'X' it said, "RaGa's Mohabbat ki Dukaan is always open for China! They would break the nation. They've done it once. They'll do it again."

The BIP Karnataka unit termed the "incorrect depiction" of the Indian map as a way to appease its "vote bank".

"@INCKarnataka, has shown utter disrespect

for India's sovereignty by displaying a distorted map at their Belagavi event, portraying Kashmir as part of Pakistan. All this just to appease their vote bank. This is shameful!" the party posted

Hitting out at the Congress, BJP's Vijayapura MLA Basanagouda Patil Yatnal demanded that the police register a case against the

"The publication of an incorrect map of India not only constitutes a breach of Geospatial information standards but also violates the law," Yatnal said in a post on 'X'.

According to him, under section 74 of the IPC, displaying a wrong map of India is a clear offence. It is also a violation under the National Honour Act.

"This is the way how the Congress celebrates its historic CWC session by distorting the map of India, not showing PoK as part of Indian territory. Shame on @INCKarnataka.

"I appeal to the @SPBelagavi to register a case against the organizers for wrongfully depicting the map of India immediately," he said.

Targetting the Congress over the issue, the JDS in a post on 'X' said, "

The Italian Congress has omitted the territory of Kashmir from the map of India drawn in Belgaum under the name 'Gandhi Bharat'. Distorting and altering the map of India is a serious criminal act, like treason.'

The party held Shivakumar responsible for it. "Kashmir is an integral part of India, but the Congress' anti-national mentality of expressing support for Pakistan by playing politics of appeasement for votes is now getting wide spread all over the country through banners," it said.

Jal Shakti Ministry Eyes

2025 To Complete Tap Water

Connections In Rural India,

**Achieve Sanitation Goals** 

**NEW DELHI**: The Jal Shakti ministry has set its sights on 2025 to achieve the ambitious targets of the Jal Jeevan Mission (JJM) and Swachh Bharat Mission-Gramin (SBM-G) after falling short of the 2024 deadline to provide tap water connections to all rural households.

The ministry also aims to ensure universal Open Defecation Free (ODF) Plus status for villages while advancing ecological restoration under the Namami Gange Programme.

Over 15.37 crore rural households out of a total of 19.36 crore have been equipped with tap water connections under the Jal Jeevan Mission. However, around four crore households remain uncovered.

Jal Shakti Minister CR Paatil expressed optimism about achieving full coverage, emphasising his ministry's continuous coordination with lagging states and Union territories.

"All the four crore connections are at some level of completion, and though it is a state subject, we have urged all states and Union territories to accelerate their efforts to ensure 100 per cent coverage as soon as possible," Paatil told PTI.

Eleven states and Union territories have already achieved complete rural tap water coverage. However, larger states like Rajasthan, Jharkhand, Kerala, and West Bengal are trailing with less than 60 per cent coverage, according to official data.

A ministry official said it is focused on bridging these gaps in 2025, ensuring no household is left without access to clean drinking water.

Sanitation remains a parallel priority for the ministry in 2025.

Currently, 95 per cent of villages in India have declared themselves ODF Plus, a status that encompasses

not just toilet construction but also solid-liquid waste management and holistic sanitation.

Of the country's 5,86,707 villages, 5,60,897 have achieved this milestone. Uttar Pradesh leads the ODF Plus tally with 93,947 villages, followed by Madhya Pradesh with 50,580 villages and Maharashtra with 37,327 villages.

Notably, over 49,000 villages in Madhya Pradesh have reached the "model" category, showcasing exemplary sanitation standards.

Since the launch of SBM-G in 2014, the construction of over 11.76 crore individual household latrines has significantly improved rural hygiene infrastructure, officials said.

Importantly, the current scale of ration/relief benefits and norms will remain unchanged, added the document.

began spreading Islam's teachings with love, compassion, and heartfelt connection. Hazrat Ghousul Azam successfully propagated the religion of peace, Islam.



Taking this as a sign, they observed the day as the 30th of Ramzan and fasted. Hazrat displayed profound wisdom throughout his life. These miracles testified to the divine blessings bestowed upon him, reinforcing his influence and teachings.

Throughout his life, Hazrat Sheikh Syed Abdul Qadir Gilani (RA) left an enduring impact on humanity through his teachings, literary works, and contributions. Though he departed this world, his teachings remain a guiding light for all. His shrine, situated on the east bank of the Tigris in Baghdad, Iraq, remains a revered pilgrimage site. The shrine houses a copy of Quran handwritten by Hazrat Ali Murtaza (RA) and the holy strand of the hair of Hazrat Ghousul Azam (R A). The holy relic of Ghouse Azam (R.A.) is displayed on special occassions like the Urs days which is annually celebrated in the Islamic month of Jamid-us-sani. Besides, on the every 11th day of the Islamic lunar month, we honor the life and teachings of Hazrat Ghousul Azam Sheikh Syed Abdul Qadir Gilani (R.A.), the revered founder of the Qadriyah order by observing Ghyarvi Sharif.

Later, Khwaja Abdul Qadir Chewoo gifted them with his land and a house at khanyar. This transformed Khanyar into a hub of spiritual seekers, attracting scholars and Sufi saints. Noted personalities of the time like Baba Usman Qadri, Khwaja Abdul Rahim Qadri, Khwaja Mohammad Murad Tang beame your diciples. In the revered lineage of Sufi saints, Hazrat Sakhi Shah Mohammad Fazil Qadiri Gilani (RA) shines as a radiant exemplar of spiritual excellence. The family tree goes lies this-Syed Sakhi Mohammad Fazil Gilani S/O Syed Abdullah Thathvi Gilani S/O Syed Mehmood Hamvi Gilani S/O Syed Abdul Qadir Sani Gilani S/O Syed Abdul Basit Gilani S/O Syed Shah Hussain Gilani S/O Syed Shahab ud din Ahmed Gilani S/O Syed Sharaf ud din Qasim Gilani S/O Syed Mohi ud din Yahya Salis Gilani S/O Syed Badru din Hassan Gilani S/O Syed Ala ud din Ali Gilani S/O Syed Shams ud din Abu Abdullah Gilani S/O Syed Saif ud din Abu Zakariya Gilani S/O Syed Zahir ud din Abu Masood Gilani S/O Syed Mohi ud din Mir Abu Nasr Gilani S/O Syed Imad ud dun Mir Abu Sualeh Gilani S/O Syed Abdur Razaq Gilani S/O Ghousul Azam Hazrat Sheikh Syed Abdul Qadir Gilani RA (References from 'Zikr Sadati Gilania', by Syed Mubarak Shah Fitrat Gilani ). Actually this family had came from Baghdad to Hamma. From Hamma Syed Abdul Qadir Sani had shifted to Thatha Sakhar Sindh.

Hazrat Syed Abul Hassan Gilani RA, who along with his brother had arrived Srinagar, returned back to Peshawar in abidance with the spiritual guidance of Hazrat Ghousul Azam. His Shrine is famous in Peshawar by the name of Dargah Hassan Badshah. He is the father of renowned saint Hazrat Syed Shah Mohammad Ghous Lahori, whose shrine is famous in Lahore. It was due to the permanent stay of Hazrat Sakhi Shah Mohammed Fazil Gilani in Kashmir that thousands of people including the contemporary religious scholars, nobles, landlords, and leaders joined "Silsilai-Qadria" and Khanyar Shareef came to be the centre of its operations Hazrat Syed Mohammed Fazil Qadri Gilani (RA) was the first Heir (Sajada Nisheen) of the Holy Shrine. He was followed by his son Hazrat Syed Mehmood Qadri Gilani (RA), then his son Hazrat Syed Ghulam-ud-Din Azad Qadri Gilani and then his son Hazrat Syed Buzarg Shah Qadri Gilani became the Shrine Heirs (Sajada Nisheen).

Here in Khanyar, Srinagar Hazrat Syed Sakhi Shah, a direct descendant of Ghouse Azam RA, followed the spiritual guidance of Jinabi Ghousul Azam to reach this sacred destination. His mausoleum, nestled within the heart of the Dastgeer Sahib Shrine at Khanyar remains a sacred site, attracting devotees seeking blessings and guidance. The majestic Dastgeer Sahib Shrine, built in 1806 A.D. in Srinagar's Khanyar locality, honors Hazrat Ghousul Azam's memory. Renovated by Khwaja Sonaullah Shawl in 1877 A.D., this sacred site embodies spirituality. As we walk through the shrine, let us strive to cultivate Hazrat Ghousul Azam's virtues, guided by his legacy.

Kashmir's spiritual heritage dates back to Aurangzeb's rule in 1095 Hijri (1322 A.D.), when Hazrat Syed Sakhi Shah Gilani arrived in Khanyar. This land has long been a spiritual hub, blessed by great saints. Hospitable Kashmiris have preserved meditation sites and holy tombs. Notably, Hazrat Ghouse-ul-Azam (RA) never visited Srinagar; instead, his great-grandson Hazrat Syed Sakhi Shah Fazil Gilani (RA) settled permanently. These historical facts are documented in "Aainay Fitrat" authored by Syed Mubarak Shah Fitrat Gilani, a famous scholar, Persian poet, Author and founder of Bazm Sadati Gilani, Jammu & Kashmir.

Take care of vour body, it's the only place where you live a quote by famous motivational speaker Jim Rohn stands apt for the generation today.

For most of us working for long hours, stressing ourselves, not eating on time and even missing meals to compensate for the lack of regular exercise is the norm. While many of us accomplish our professional goals, we tend to overlook the damage unhealthy eating habits do to our body.

While, some side effects show instantly and can be taken care of, others gradually surface over a period of time. The most common reaction of our body to unhealthy eating and

lifestyle is fatigue and weight gain. We may not be very health conscious, but a lot of us tend to be weight conscious. To control the excessive weight some of us do try to crunch in exercise in our busy schedules but many look for quick fixes to deal with this excessive weight. We look out for various diet plans, programmes and selective food intake that seemingly offer a relatively easier and faster result. However, many of us are unaware about the consequences of these quick solutions. To lose weight, the calorie intake of the body needs to be reduced and many believe that by skipping a meal, often dinner, we may be able to achieve results.

Depriving our body of food for a prolonged period of time could lead to major physical as well as psychological problems.

However, contrary to common belief, omitting dinner from our diet may do more damage that we are aware of. Renowned nutritionist Kavita Devgan feels that misinforma-

tion and lack of knowledge about the subject often leaves the patient confused. When asked whether giving dinner a skip was a good idea, she responded with a clear no. "Skipping a meal, let alone dinner, is the worst thing you can do to yourself. With lesser calorie and protein intake, the metabolism will come to a grind and there will be side effects." While she does suggest eating an early dinner and also a bit of a stroll before sleeping, she strongly criticises the habit of not eating dinner. "It may give short-term results, but not benefit in the long run," she adds. While eating right is difficult, it's

fairly simple to eat wrong. As per Dr Sandhya Pandey, chief clinical nutritionist, Fortis Memorial Research Institute, missing meals has a lot of do with the lifestyle and routine an individual follows. Most of the people who come to her belong to an early age bracket. "Today, youngsters who are single or live alone find it convenient to skip



dinner. They have busy routines and often feel lazy to cook for themselves. Also, weight is one of the factors why people stop eating." Pandey also feels that people tend to follow diets and routines without proper information and guidance. Stating the common saying; breakfast like a king, lunch like a common man and dinner like a

pauper, Pandey suggests eating light and healthy but not skipping a meal.

While we would want to believe in quick fixes, but there aren't many when it comes to losing weight and eating right. Eating unhealthy food during the day and then skipping dinner to balance the calorie count often leads to weight gain. As per Devgan, "There is no right way of

eating as each body is different but for majority of people eating three meals, along with two light snacks is recommended." She also suggests increasing protein intake and reducing carbohydrates.

According to both nutritionists, depriving our body of food for a prolonged period of time could lead to major physical as well as psychological problems. While, constipation, restlessness and fatigue are some of the known repercussions, anxiety and depression too could be related to unhealthy eating.

So, skipping dinner is a huge no. "Nowadays, healthy options are available in the market. If one doesn't want to put in a lot of effort in making dinner, oats is always a good option. Avoid eating wheat or rice and instead consume two bowls of pulses," says Pandey. "It's better to eat protein over carbs," she adds. If weight loss is your objective, then increased intake of fruits and greens would benefit physically as well as psychologically.

## Coffee crazy? Your caffeine kick could help reduce diabetes risk!

offee, for many people around the globe, is an essential apparatus to help kickstart the day. It is a cup for all seasons and without their favourite brew, the day seems incomplete.

Known for its high caffeine content, coffee has often been on the list of 'things to avoid' given to us by dieticians and health and fitness experts.

While many studies have contradicted its negative effects by showing its health benefits, another study supports its healthy properties by suggesting that coffee may cut the risk of diabetes.

Diabetes is considered to be a silent killer by medical professionals across the world. Even a single symptom reflecting the onset of the disease is a cause for concern.

It is a disease that could be hereditary and can also develop due to an unhealthy lifestyle.

However, scientists have identified compound in the beverage that may cut risk of developing Type 2 diabetes.

Researchers from Aarhus University Hospital in Denmark also found that one of these previously untested compounds appears to improve cell function and insulin sensitivity in laboratory mice.

The finding could spur the development of new drugs to treat or even prevent the disease.

Previous studies show that a compound in coffee called cafestol increased insulin secretion in pancreatic cells when they



were exposed to glucose.

Cafestol also increased glucose uptake in muscle cells just as effectively as a commonly pre-

scribed anti diabetic drug. Researchers wanted to see

if cafestol would help prevent or delay the onset of Type 2 diabe-

They divided mice that are prone to develop Type 2 diabetes into three groups. Two of the

After 10 weeks, both sets of

cafestol-fed mice had lower blood glucose levels and improved insulin secretory capacity compared to a control group, which was not given the compound.

Cafestol also did not result in hypoglycemia, or low blood sugar, a possible side effect of some anti diabetic medications.

The researchers conclude that daily consumption of cafestol can delay the onset of Type 2 diabetes in these mice, and that it is a good candidate for drug development to treat or prevent the disease in humans.

The study was published in the journal Journal of Natural

## High salt intake may double heart failure risk



ove to eat salted wafers, nuts, french fries and other processed foods? Beware, according to a study, high salt intake is associated with a doubled risk of heart failure.

The findings showed that people who consume more than 13.7 grams of salt daily may be at two times higher risk of heart failure compared to those consuming less than 6.8 grams.

in heart failure risk was independent of blood pressure level — increased level of which is also a risk factor for cardiovascular diseases, the researchers said.

The optimal daily salt intake is probably even lower than 6.8 grams. The World Health Organisation (WHO) recommends a maximum of five grams per day and the physiological need is two-

three grams per day. 'The heart does not like salt. High salt (sodium chloride) intake is one of the major causes of high blood pressure and an independent risk factor for coronary heart disease (CHD) and stroke," said Pekka Jousilahti, professor at the National Institute for Health and Welfare, Finland.

The results were presented at the European Society of Cardiology Congress in Barcelona. For the study, the team followed 4,630 women and men aged 25 to 64 in Finland over 12 years. Samples of their urine were tested to gauge their sal

The researchers divided the participants into five groups based on their salt intake; the low-salt group consumed less than 6.8 grams a day and the highest had more than 13.7 grams a day. Over the course of the study, 121 men and women developed new heart failure.

The results showed that the group consuming the most salt were 2.1 times more likely to develop heart failure and the group who ate the second highest amount of salt between 10.96 and 13.7 grams — were 1.7 times more likely.

#### **FIGHT DEPRESSION BY EATING RIGHT**

Food packed with vitamins, rich in antioxidants, nuts and green tea are some of the eatables that can help you fight depression, suggest experts

Sunita Chowdhury, chief dietician at BLK Super Specialty Hospital, and Tanu Arora, Head of the department at Clinical Nutrition and Dietetics, Aakash Healthcare, have shared Antioxidant rich foods are

packed with vitamins, minerals and fibre and not only help the immune system fight diseases but also minimise cell damage and aging. These are all red, orange, yellow and green vegetables and fruits. Minimum of 750-100 gm is the recommended allowance per day. Such food includes berries, oranges, bell peppers, broccoli, pumpkin, watermelon. pomegranate and green leafy vegetables like spinach, cucumber, tomato and beetroot. It is better to eat these fruits and vegetables than to juice them, to get maximum benefit out of them.

Eat Nuts: All nuts, especially walnut, are thought to be good mood elevators as they contain omega-3 fatty acid. Researchers have shown that walnuts support proper brain function and reduce depression. All nuts are rich in phytochemical such as resveratrol and also vitamin E which keep one healthy.

Try green tea as it has antioxidant properties and also has an overall calming effect on the nervous system and so helps hold off stress and depression. Avoid indulging in alcohol, caffeine, processed and high fat foods, carbonated beverages, soda and too many sweets.

Omega 3: Having good sources of omega 3, vitamin, Selenium, tryptophan, Beta carotene in the diet helps the body to build a strong immune system which fights depression.

#### Fermented food like yoghurt good source of nutrients: Experts

ermented foods have always held a special place in Indian cuisine culture with curd, in its various forms like 'lassi' and 'chhaachh', being an intrinsic part of people's diets.

Yoghurt, a popular food import from the West, is also evolving as an alternative healthy snack food among Indian consumers.

Food experts suggest that yogurt, which is produced by bacterial fermentation of milk, can be a source of important nutrients, including protein.

'Yogurt is a nutrient-dense food that is good for people of all ages. Since it is a milk based product, it is a good source of protein, calcium and potassium. A single serving of yogurt gives a significant boost of Phosphorous, Potassium, B12, Riboflavin, Zinc, Iodine, and Vitamin B5," Dr. Nandan Joshi, head of nutrition science and medical affairs at Danone India, said.

Besides, providing good nutrition, yogurt contains live and active cultures, living beneficial bacteria which supports digestion and improves gut health, he added.

Fermented products are a vehicle for novation, Danone. fortification and can be an efficient tool to combat nutrient deficiencies, that is, vitamin D. Yoghurt consumers across various distinct populations appear to have healthier metary patterns, nutrient adequacy, and lifestyles compared with non-consumers.

According to the experts, lot of studies are being conducted to gather evidence on the health benefits of yoghurt. There is substantial evidence on health benefits of yogurt like weight management, cardiovascular and gastrointestinal health and cancer.

'Recent meta-analyses have shown that dairy consumption is neutral or beneficial for weight control, coronary disease, diabetes, hypertension, and most cancers.

"Currently, extensive research has been conducted to investigate the mechanisms through which vogurt generates beneficial effects. Gut microbiota appear to be an important factor that can be modified by dietary prebiotics, as well as probiotics such as yogurt," said Fariel Dif, head of communication for Dairy Research and In-

There is a growing interest in the relationship between yogurt and obesity, as evidenced by the number of publications on the topic over the last few years.

rogurt may have a superior effect than other food, beverages and snacks on inducing satiety due to its high protein content. Moreover, the substitution of nutrient-poor, energy-dense items with nutrient?rich foods such as yogurt can have a beneficial impact on weight maintenance and obesity, Dif said

Further, yogurt is that one by-product of milk that can be better tolerated by people with lactose intolerance, said Dr. Joshi.

Bacterial fermentation of yogurt results in changing lactose (the sugar in milk) to lactic acid, and hence lower intake of lactose.

"The good bacteria present in vogurt secrete an enzyme called Galactosidase that allows them to pre-digest part of the lactose. Therefore, lactose intolerant individuals can better digest yogurt and show better tolerance to yogurt as compared to milk," Dr. Joshi said.

Working out burns up calories and we need supplements to make up for the energy loss and to avoid exhaustion. A good supplement ensures that you get adequate and measurable essential nutrients.

Sportspersons and athletes, especially, need supplements for stamina and post-workout recovery. There are a number of supplements in the market. But you need to read the label carefully.

Here's what, according to Manpreet Kaur, nutritionist at Proquest Nutrition, one should look out for and what you should guard against, while picking up nutritional supplements.

Look out for:1) Nutritional supplements help athletes meet their increased protein requirement. Intensive training endurance athletes, athletes trying to gain muscle mass and strength athletes all need high-protein supplements in the initial stages of training. Even though the International Society of Sports Nutrition recommends that it is best for athletes to get their protein requirements from their diet, it is not always possible, so supplements are a practical and convenient way to meet the demand. Supplements with whey and casein protein, because of their "high protein digestibility, corrected amino acid score and ability to increase muscle protein mass, meet athletes' post-workout needs.

2) Creatine, in the supplement, aids muscle performance Protein supplements usually contain creatine.



Creatine is said to improve strength, increase lean muscle mass, and help the muscles recover quickly after exercise. The European Food Safety Authority reports that, for high intensity workout, athletes who consume 3g of creatine everyday achieve "an increase in physical performance during shortterm, high intensity and repeated exer-

3) Branched chain amino acids promote muscle protein synthesis.

Studies have shown that branched chain amino acids (BCAA) in nutritional supplements improve recovery and exercise performance during intense workout. BCAAs are three amino acids — leucine, isoleucine and valine - with similar structures that beneficially influence the muscles. They help to promote muscle protein synthesis and minimise muscle protein breakdown without putting any substantial calorie load.

1) Health risks: Consuming too much protein in nutritional supplements over a period of time can increase the risk of developing osteoporosis, cause kidney stones and worsen existing kidney problems. Other side-effects includes: dehydration, constipation, increased bowel movements, nausea, cramps, bloating, reduced appetite, fatigue and interaction with medication.

2) Not always nutritionally balanced: Protein shakes are often marketed as meal replacements. However, not all of these are nutritionally balanced; excess intake of protein could also lead to nutritional imbalance and harm your digestive system.

3) May contain harmful substances: Many of us take supplements not just to make up for what's lacking in our diet, but also to give ourselves an extra health boost. But, some supplements may contain harmful ingredients which can be detrimental to health. Steroids, stimulants and hormones, sometimes included in some supplements, can result in kidney failure, seizure or heart problems.Read the label carefully. Pick a reputed brand - one that's safe and provides optimum nutrients for maximum performance!

In September, three terrorists were neutralized in the Tapper area of Pattan on September 13, just days ahead of assembly polls in Jammu and Kashmir.

the fleet by 100 more buses, though the timeline for this expansion remains uncertain.

The introduction of the National Common Mobility Card (NCMC) in August 2024 allowed cashless transactions. However, some commuters pointed out the high initial cost of the card and limited public awareness campaigns, which may have hindered its broader adoption.

Projects like revamped Polo View High Street, landscaped Jhelum Riverfront and renovated Clock Tower are visible makeovers. However, the execution of these projects has not been without criticism.

Critics argue that the timing and planning of construction have caused undue inconvenience to residents and businesses. The reduction of road space for vehicles to create pedestrian-friendly pathways, while aligned with global urban planning trends, has been particularly contentious.

"Reducing carriageway width has led to massive traffic jams, especially during peak hours," locals said.

Others questioned prioritising the beautification projects over essential services like traffic management and waste disposal.

One of the most criticised aspects of the Smart City initiative in 2024 has been the non-functional Intelligent Traffic Management System (ITMS). Traffic lights installed at key intersections remain inoperable, forcing traffic police to manually manage congestion.

"Travelling through intersections like Shaletnag Chowk and MA Road has become a nightmare due to diversions and delays," many aggrieved commuters said.

However, authorities at Srinagar Smart City Limited (SSCL) this month announced the launch of the Intelligent Traffic Management System (ITMS) alongside an e-Challan system in Srinagar City.

SSCL authorities said smart traffic signals Intelligent controllers will optimize signal timings based on real-time conditions, minimizing delays.

They said that with the automated Rule Enforcement feature,

over 1,050 cameras will ensure compliance with rules, detecting violations like red-light jumping, overspeeding, mobile use, helmetless riding and more.

Of the 142 projects under the Smart City Mission, 123 have

Of the 142 projects under the Smart City Mission, 123 have been completed. Yet, residents criticized the frequent extensions of deadlines and disruptions caused by prolonged construction work. However, the officials expressed confidence that the remaining projects are likely to be finished by early 2025.

"Many of these projects were announced years ago, but we're still waiting for their completion," local businessmen in the city centre said.

As per the officials, with an estimated budget of Rs 1,000 crore, approximately 75% of the allocated funds have been utilised so far, with the remaining budget left for the pending projects.

Among the completed projects, officials highlighted the revamped Polo View High Street, Clock Tower in the city centre and the landscaped Jhelum Riverfront Embankments. Refurbished prominent landmarks have enhanced the city's aesthetics and public spaces.

Launched in 2023 to promote eco-friendly cycling under the Srinagar Smart City Project, of over 1000 bicycles, over 380 have been vandalized, and more than five have been stolen by 'miscreants', according to officials.

"These bicycles not only promote eco-friendly transport and

a clean environment but also contribute to public health," the officials said.

According to the officials, docking stations, placed throughout

Srinagar, vary in holding capacity from 5 to 20 cycles.

Despite the criticism, authorities at the Srinagar Smart City Mission said they have made notable progress. They are optimistic about completing the remaining 19 projects by early 2025, including modern bus stops, operational traffic systems, and expanded bus fleets

Authorities said the mission's successes in eco-friendly mobility, heritage conservation and urban beautification have laid a foundation for a more sustainable Srinagar.

However, addressing public grievances, improving planning processes, and ensuring timely project delivery will be critical to regaining public trust and achieving the initiative's full potential.

Kashmiri Shawl Makers Welfare Foundation, comprising artisans from different areas, highlighted the challenges faced by the traditional shawl-making trade and sought the government's support in safeguarding their livelihood.

BARAMULLA: North Kashmir recorded a total of 19 gunfights, including eight infiltration bids, resulting in the elimination of 27 terrorists.

the death of five security personnel and two civilian casualties in 2024, according to details obtained by the news agency — Kashmir News Observer (KNO).

The first quarter of 2024 remained quiet with no gunfights reported. However, in April, the region saw its first infiltration attempt along the Line of Control (LoC) in Uri on April 5, where two terrorists were killed. Later in the month, a gunfight in Sopore on April 26 claimed the lives of two terrorists, including top Pakistani terrorist commander Saifullah. This was Sopore's first gunfight in 22 months. The operation also left two soldiers and a civilian injured.

#### There really was no need for that, Kohli won't want such legacy: Gavaskar

MELBOURNE: The legendary Sunil Gavaskar on Thursday criticised Virat Kohli for his heated altercation with young Australian debutant Sam Konstas, saying there was "no need" for the incident and the Indian star wouldn't want his legacy to be tarnished by such episode.

Kohli was fined 20 per cent of his match fee and awarded one demerit point for breaching Level 1 of the ICC Code of Conduct after he and Konstas bumped shoulders in the 10th over of the Australian innings on the opening day of the fourth Test here.

"Well I'm not sure what was the reason but there really was no need for that, we don't need to have this in any grade of cricket, certainly not at the highest level. You can play very very competitive cricket without getting physical," Gavaskar told India Today.

"I think we all want to remember Kohli as one of the greatest cricketers ever in the game and not as somebody who was fined whatever it is or censured by the ICC, we don't want to want to hear that.

"You don't want a legacy left where that is going to be also a talking point or a sticking point. So maybe hopefully, he'll learn from that and not want to to repeat this again."

The incident happened after the 19-year-old Konstas had left India in a state of shock with his sensational stroke-play, taking down Jasprit Bumrah, on his way to a 65-ball 60. In 10th over, while crossing over, Kohli and Konstas

bumped shoulders and quickly turned around to glance at each other, engaging in a heated exchange of words.

The Australian opener Usman Khawaja immediately stepped in to separate them, putting his arm around Kohli. The on-field umpires also had a word with the two, as things cooled down rather quickly.

Known for his passionate on-field persona, Kohli has courted controversy in the past, often for rubbing the opposition the wrong way in the past too. He was sanctioned by the ICC in 2019 for another shoulder-barging incident with South Africa's Beuran Hendricks

#### India needed Rohit to open, Washington's variation at MCG: Nayar on axing Gill

MELBOURNE: India's assistant coach Abhishek Nayar on Thursday defended axing Shubman Gill from the Boxing Day Test, saying it was in team's best interest to not only have Rohit Sharma back to his usual opening slot but also add some sting to the attack by drafting in spin all-rounder Washington Sundar.

Gill, who missed the first Test due to a finger injury, scored 31 and 28 in the Pink Ball Test and looked the most assured among Indian batters. He, however, got out for a duck in Brisbane.

With Rohit Sharma opening the innings and KL Rahul coming at No. 3, Gill had to make way for a third specialist all-rounder in Washington.

"Yes, Rohit will come up in the order and more likely than not, he will open the innings. That was the thought process. Unfortunately for Gill, just how things spanned out, he had to miss out," Nayar said at the end of the day's play.

"I just feel for a young player in a position like that, a big day, he wants to make his mark. He understands it's the team's requirement and it's unfortunate, but I wouldn't say that he's been dropped per se. It's just unfortunate that he couldn't find his place in this game," the former Mumbai stalwart said but the explanation lacked conviction.

He elaborately explained why playing Washington at the MCG made sense ahead of Gill.

"A lot of the decisions when they are made, and the process of it being made, the communication is always there and transparency is there. It's pretty obvious that we felt in these conditions, looking at the pitch, having Washy in the bowling attack will give us that variation, especially towards the end once the ball

"Post the 50 overs, we felt that was an area that we wanted to get better at. We felt Washy could give us that solidarity with Jaddu (Ravindra Jadeja), especially the way Travis Head and Alex Carey were getting runs lower down. So we felt having an offie in the ranks will provide us with that."
