

NGT issues notice to J&K Govt over axing of trees

SRINAGAR: The National Green Tribunal

(NGT) has issued notices to the Jammu and Kashmir government, including the Chief Secretary, Deputy Commissioner Baramulla, Block Development Officer (BDO) Lalpora Tangmarg, and other officials, over the alleged felling of over 1000 trees in the village of Sonium Lalpora and the diversion of a local stream for the construction of a playground.

According to the complaint, the BDO

Lalpora and the former Sarpanch of Sonium village are accused of cutting down 1000 trees, including 600 willow trees, 300 poplar trees, around 100 acacia and rubina trees, and 10 walnut trees.

Also, part of the Badyari stream was diverted to pave the way for the playground. This action is reportedly in violation of the Jammu and Kashmir Preservation of Specified Trees Act, 1969, and the National Water Policy 2012.

According to the news agency—Kashmir News Observer (KNO), it was also noted that the BDO had sought a No Objection Certificate (NOC) for the diversion, but the Assistant Executive Engineer of the Irrigation and Flood Control Department rejected the request on February 23, 2024 The Engineer instructed the BDO to stop the unauthorized activities and restore

the stream to its original course, but these directions were reportedly ignored.
The issue was raised before the NGT by RTI and climate activist Dr. Raja Muzaffar Bhat, who submitted a representation

NIA delivers 100% conviction rate, foils terror attempts

SRINAGAR: In 2024 the National Investigation Agency (NIA) delivered 100% conviction rate and foiled multiple attempts by anti-national forces to unleash violence in the country, including Jammu



and Kashmir.

ANIA statement, said, "The successful investigation of several important/highprofile cases and a strong focus on tackling Left Wing Extremism (LWE) marked a year of many highs for the National Investigation Agency (NIA), which delivered a record 100% conviction rate for 2024."

"Arms seizure emerged as a key milestone against attempts by anti-national

forces to unleash violence in the country. Cases of weapons recovery and seizure were reported from across the country, including Jammu, Jaipur, Ranchi, Patna, and Chandigarh," it said.

The statement said, "The notable among these was the seizure, in Jammu,

of arms/ammunition and other incriminating materials from a car driver working as an overground worker (OGW) of the banned Hizbul Mujahideen (HM) terrorist outfit. As many as 2 hand grenades, 34, 9 mm pistol rounds, 1 Chinese pistol, 1 Turkish pistol, 20 Chinese pistol rounds and 1 pistol silencer were recovered in this case."

"The arrest of 11 ISIS Jihadis, 5 J&K Jihadis and 24 other lihadis marked another major step forward for the agency," the statement added.

It said, "A massive haul of 5 rifles, 6 pistols, 1 revolver, 215 rounds ammunition, 5 detonators, 2 packets of gun powder, 75 fired empty cartridges & 75 Kgs of suspected explosive substance were also seized in a case



Farmers Protest: SC Defers Hearing On Shifting Dallewal To Hospital, Punjab Says Negotiations On

NEW DELHI: The Supreme Court on Tuesday deferred its hearing till January 2 on compliance of its order by the Punjab government on shifting of farmer leader Jagjit Singh Dallewal, who has been fasting for past 35 days over various demands, to hospital. A vacation bench of Justices Surya Kant and Sudhanshu Dhulia listed the matter for further hearing on January 2 after Advocate General Gurminder Singh, appearing for the Punjab government, said that an application has been moved seeking three days more time for compliance of the court's December 20 order. Singh said that a team of negotiators are holdings talks with the protesting farmers at the protest site and efforts are being made to shift Dallewal to the nearby makeshift hospital on Punjab side of Khanauri border.The bench said it does not want to comment on the discussions with the protesting farmers and it only wants compliance of its earlier orders. It recorded the submissions of Singh and adjourned the hearing on the matter.Earlier on December 28, the top court came down heavily on the Punjab government for not shifting Dallewal to a hospital even as it doubted the intention of the agitating farmers for resisting availability of medical aid to their septua-

Poor, Deprived Suffering Brunt Of 'Manuvaad' Under BJP: Kharge

NEW DELHI: Congress president Mallikarjun Kharge on Tuesday accused the BJP governments at the Centre and the states of having a mindset against the deprived sections of society who are suffering because of the brunt of 'Manuvaad'.

> He said a crime is committed every hour against Dalit-tribal women and children, and according to the National Crime Records Bureau (NCRB), this figure has doubled since 2014.

In a post in Hindi on X, Kharge alleged that Union Home Minister Amit Shah insults Babasaheb Dr BR Ambedkar in Parliament and the same mindset against the deprived is being repeated in the BJP ruled states.

He claimed that in the last two days – a Dalit youth is murdered in police custody in Madhva Pradesh's Dewas and the tribal women are tied to trees and beaten in Balasore, Odisha.

"In Bhiwani, Haryana, a Dalit girl student is forced to commit suicide after being unable to pay her BA exam fees. In Palghar, Maharashtra, a tribal pregnant woman has to travel 100 kilometers in search of ICU and dies."

"In Muzaffarnagar, Uttar Pradesh, three Dalit families are forced to migrate because



of caste-based attacks on them and the police remains silent," he claimed.

"It is well known that atrocities are being committed against Dalits, tribals, backward and minority communities under the 'anticonstitutional rule' of the Modi government. Those who are poor and deprived are suffering the brunt of Manuvaad," the Congress chief alleged.

He said a crime is committed every hour against Dalit-tribal women and children, and according to the National Crime Records Bureau (NCRB), this figure has doubled since 2014.

"The Congress Party will not allow the constitutional rights of 140 crore Indians to be violated and will continue to oppose the anti-constitutional thinking of the BJP-RSS," Kharge said.

A 35-year-old Dalit man Mukesh Longre died on Saturday after being called to Satwas Police Station in Madhya Pradesh for questioning in a complaint submitted against him by a woman on December 26. This triggered protests from his kin, who alleged murder.

Separately, Union Minister Ramdas Athawale on Monday alleged that Dalit man Somnath Suryavanshi was assaulted in a police lock-up in Parbhani, Maharashtra, leading to his death.

The Odisha Police arrested three persons on charges of assaulting two women over allegations that they were attempting religious conversion of some tribal families in Balasore district.

Govt Forfeits Medal Awarded To CBI Inspector Who Was Arrested In Bribery Case

NEW DELHI: The Government has "forfeited" the Union Home Minister's medal for Excellence in Investigation awarded to CBI Inspector Rahul Raj in 2023 who was later caught by the agency red-handed, allegedly receiving Rs 10 lakh bribe and dismissed from the service, officials said.

The action comes on the recommendation of CBI Director Praveen Sood who has cracked down on corrupt elements detected in the agency's internal vigilance process.Raj, a recipient of a prestigious medal in 2023. was caught "red-handed" on Mav 19 while allegedly accepting an illegal gratification of Rs 10 lakh from Malay College of Nursing chairman Anil Bhaskaran and his wife Suma Anil, an official alleged. The couple were also arrested.

Bandipora records 357 fire incidents in 2024, lowest in North Kashmir

SRINAGAR: North Kashmir has recorded a staggering 1212 fire incidents in 2024, leading to extensive damage to hundreds of



structures and property worth crores reduced to ashes. The incidents mark a sharp rise compared to previous years, attributed to prolonged dry weather and technical mishaps.

According to data, Baramulla district topped the list with 548 fire incidents, showing an alarming increase of 170 cases compared to 2023, when the district reported 378 incidents.

Kupwara recorded 407 incidents, up by 108 from the previous year. Bandipora, while witnessing

a comparatively lower number of incidents, reported 357 cases, marking a rise of 77 from 2023.

> Speaking to KNO, Mir Arif, Deputy Director, F&ES, attributed the sharp rise in fire incidents across North Kashmir to prolonged dry weather conditions in the valley. "The dry spell has significantly contributed to the increase in fire incidents,

alongside common causes like electricity short circuits and gas leaks."

He said that 42 fire and emergency stations/posts under command headquarters, staffed by around 444 dedicated personnel, have been at the forefront of managing these emergencies. "No

firemen were injured during the operations despite the challenging conditions and the sharp rise in fire incidents this year", he

"In Baramulla district, we have 175 personnel actively working to manage emergencies, while Kupwara has 182 dedicated staff. Bandipora, however, operates with 87 personnel," Arif said.

The sharp increase in fire incidents, however, has raised concerns among residents and officials alike, prompting calls for improved preventive measures, enhanced infrastructure and public awareness campaigns to mitigate such disasters in the future.

The top office urged the public to remain vigilant and take fire safety precautions, recommending installation of smoke detectors on every level of the home, ensuring the availability of fire extinguishers and creating an evacuation plan for emergencies. He also advised against overloading power outlets, leaving open flames unattended and delaying the reporting of potential fire hazards-(KNO)

NGT issues notice to J&K Govt over axing of trees

SRINAGAR: The National Green Tribunal (NGT) has issued notices to the Jammu and Kashmir government, including the Chief Secretary, Deputy Commissioner Baramulla, Block Development Officer (BDO) Lalpora Tangmarg, and other officials, over the alleged felling of over 1000 trees in the village of Sonium Lalpora and the diversion of a local stream for the construction of a playground.

According to the complaint, the BDO Lalpora and the former Sarpanch of Sonium village are accused of cutting down 1000 trees, including 600 willow trees, 300 poplar trees, around 100 acacia and rubina trees, and 10 walnut trees.

Also, part of the Badyari stream was diverted to pave the way for the playground. This action is reportedly in violation of the Jammu and Kashmir Preservation of Specified Trees Act, 1969, and the National Water Policy 2012.

According to the news agency–Kashmir News Observer (KNO), it was also noted that the BDO had sought a No Objection Certificate (NOC) for the diversion, but the Assistant Executive Engineer of the Irrigation

rejected the request on February 23, 2024. The Engineer instructed the BDO to stop the

Police spokesperson in a statement states that the property, measuring 2 Kanals and 7.5 Marlas, was attached under the Unlawful Activities (Prevention) Act. The land, registered under Survey Nos. 898 (1.5 Marlas), 862 (7.75 Marlas), and 938 (1 Kanal 9.25 Marlas), was identified as proceeds

The property belongs to Mushtaq Ahmad Mir, son of Gh Mohiuddin Mir, a resident of Hilalabad Nesbal Sumbal, who is reportedly operating as a terror handler from Pakistan.

"The attachment was carried out after the individual was declared a proclaimed offender in connection with Case FIR No. 37/2024 under the UA(P) Act, IA Act, and E&IMCO Act of Police Station Pethkote," statement reads.

Spokesperson said this operation reaffirms the Bandipora Police's commitment to combating terrorism and dismantling its financial networks.



Rural BPO in J&K

Prime Minister Narendra Modi's inauguration of Jammu and Kashmir's first rural Business Process Outsourcing (BPO) unit in Bandipora in 2019 was a historic milestone, setting the stage for digital transformation and employment generation in the district. Bandipora's BPO unit, the first of its kind in Kashmir, has already showcased its potential by providing opportunities for local youth to build careers in the Information Technology (IT) sector without having to migrate to cities. With providing employment to about 200 seats at a time, the centre has successfully trained hundreds of indiviuals since 2019, empowering them with employable skills and creating avenues for socio-economic growth.

While this single BPO has proven to be a game-changer, the question arises: why has this model not been replicated in other districts? The Union Budget has already earmarked provisions for expanding BPOs in the UT, yet two years have passed without significant progress. The lack of concrete $action, from \, land \, identification \, to \, mobilizing$ administrative machinery, highlights a concerning inertia in the implementation process. Little Knowledge to the officers including DCs about the project endagers the sustainability of already existing BPO in Bandipora, least to talk about new projects. BPO's hold immense potential to address unemployment and foster digital service delivery. Functions such as customer support, payroll management, technical assistance, and market research can be effectively outsourced, saving costs and enhancing efficiency for businesses While Govt can also use these BPO services for a range of activities to reach out to people for implementation of various welfare schemes. For a region like Jammu and Kashmir, these units could attract investors, entrepreneurs, and even multinational corporations to establish operations, boosting the local economy and positioning the UT as a hub for digital services. Bandipora's success demonstrates how even a single BPO can create ripples of transformation. However, to harness this potential fully, district administrations must be actively involved in planning and execution. The UT government must also address the existing gaps by expediting processes such as incentives to the Companies to attract to the districts besides land allocation, infrastructure development, and the integration of BPOs into district-level economic planning. Funds and provisions under the IBPS are available, removing financial constraints as an excuse. The onus lies on the government to act swiftly and decisively. Expanding BPOs across Jammu and Kashmir is not merely an economic initiative but a socio-digital revolution.

Gratitude: A Daily Practice for a Better You

Have you ever paused to acknowledge the blessings, big or small, that enrich your life? Imagine beginning every day with the question, 'What am I thankful for?' How often do we fail to notice the small pleasures that add beauty to our lives? These questions might seem small, but they hold the key to unlocking a deeper sense of contentment and fulfilment.

In an era of stress, distractions, and rapid change, practicing gratitude is not merely a luxury, but a requirement for improving our overall quality of life. Being grateful is more than just saying 'thank you'. It's an attitude that changes our perspective and allows us to see the world with possibilities and fullness. It is a profound emotional state that recognizes and values the positive aspects of life, which is frequently linked to mental as well as physical health. Gratitude is fundamentally about acknowledging the goodness in our life and the origins of that goodness. These sources might be either external (other people, nature, or even a higher power) or internal (our resilience and efforts). Gratitude focuses our attention away from what we lack and onto what we have, generating a sense of fulfilment and abundance.

In positive psychology, gratitude is the human way of acknowledging the good things of life. Psychologists have defined gratitude as a positive emotional response that we perceive on giving or receiving a benefit from someone (Emmons & McCullough, 2004).

Psychologists and researchers have extensively explored the virtues of gratitude. As Robert Emmons, a prominent positive psychologist, states, 'Gratitude allows us to celebrate the present. It enhances happy emotions while blocking toxic negative feelings.' Modern psychological research validates this viewpoint, emphasizing gratitude's transforming capacity in promoting emotional and social well-being.

Research in positive psychology has demonstrated that gratitude has a significant impact on mental health. Regular practice of gratitude can improve emotional well-being, relationships, and even physical health. Psychologist Martin Seligman, one of the founders of positive psychology, emphasizes the importance of gratitude in boosting happiness. In his study on the "gratitude visit," Seligman discovered that persons who wrote and delivered a letter of gratitude to someone they valued reported a significant boost in happiness and a decrease in depressive symptoms.

It has been found that gratitude reduces negative feelings like jealousy, resentment, and regret while concurrently raising positive emotions like joy, hope, and optimism.'Gratitude is strongly and consistently associated with feelings of well-being and happiness,' according to a positive psychologist Sonja Lyubomirsky. She adds that cultivating gratefulness is a crucial component of psychological resilience since it can result in long-lasting increases in life happiness. In addition to its emotional benefits, gratitude has been linked to physical health improvements. People who frequently practice gratitude have been shown to have stronger immune systems, reduced blood pressure, and better sleep.

Gratitude has gained popularity as a clinical psychology intervention due to its many advantages. It is frequently incorporated into therapy strategies to address a range of mental health conditions, such as stress, anxiety, and depression. Maintaining a gratitude journal is one of

the most popular gratitude interventions. This entails making a list of daily or weekly things for which one is grateful. According to research, this little exercise can have a big impact on one's wellbeing and mood. Writing letters of gratitude, doing good deeds, and practicing mindfulness are additional gratitude therapies besides journaling. The goal of these interventions is to help

your plate and the work it took to get there by pausing during meals.

Bahu Fort Aquarium cum Oceanarium to become prime tourist attraction in Jammu: Javed Dar

Inspects progress of work on Aquarium Cum Awareness Centre at Bahu Fort

Says Fisheries department has vast potential for employment generation in J&K

JAMMU: Minister for Agriculture Production, Rural Development and Panchayati Raj, Javed Ahmad Dar remarked that Bahu Fort Aquarium Cum Oceanarium will become prime tourist attraction in Jammu region in coming days.

These remarks were made by the Minister during his visit to Aquarium Cum Awareness Centre, Bahu Fort to take stock of ongoing works on Phase-II of the project.

During his inspection, the Minister was informed that the establishment of Aquarium Cum Awareness Centre was proposed to be completed in two phases.

He said the Oceanarium shall be harbouring various varieties of Marine Fishes in a Glass Tunnel with a holding capacity of about 4,00,000 Litres of water. He added that the Oceanarium at Bahu



Fort will be developed as prime tourist spot.

He instructed for undertaking up gradation/face-lifting of some already existing structures so that the works on the same are completed by or before the opening of Oceanarium.

The Minister also directed the Officers of the department to carry out the implementation of schemes in private sector strictly in accordance to the guidelines of the schemes and achieve the

targets in a stipulated timeframe.

He directed officers to work with zeal and zest to cover maximum number of beneficiaries under various Fish culture schemes allotted to them. Stating that the Fisheries sector has vast potential for employment generation, the minister urged youth to avail benefits under the department's schemes.

During the inspection, the Minister was informed that works on the Oceanarium involving certain technicalities are going on in full swing and shall be completed within two months.

While as phase-I of the project was thrown open in the year 2007, attracting good number of tourists, visitors on daily basis.

Among the visiting points, the project also comprises of MultimediaHall where lectures regarding fish culture are delivered to the students and 24 number of Aqua-caves with different water holding capacities wherein more than 120 species of Fishes are being reared and put to display.

160-bedded state-of-the-art orthopaedic block at B&J hospital completed: CEO ERA

'Tenders to be floated soon for additional Gynae block at LD Hospital'

SRINAGAR: Chief Executive Officer (CEO) Jammu and Kashmir Economic Reconstruction Agency (ERA), Jhelum Tawi Flood Recovery Project (JTFRP), Mohammad Aijaz Asad, on Tuesday said that the additional block comprising 160 beds at Bone and Joint (B&J) Hospital in Barzulla, Srinagar, has been completed, and the trial run of the new facility is presently underway.

Chairing a meeting to review the progress of the World Bank-funded Ihelum Tawi Flood Recovery Project (JTFRP), CEO highlighted the advanced features of the new Orthopaedic hospital block, which has been constructed using modern earthquake-resilient

The state-of-the-art building includes modular operation theatres, a laminar flow system, a Theatre Sterile Supply Unit (TSSU), Intensive Care Units (ICU), pre- and post-operation care wards, a Central Sterile Supply Department (CSSD), specialized laundry facilities, a pneumatic tube system, and a waste collection system. Additionally, the building has received certification from the India Green Building Council (IGBC) and features a biomedical waste management facility.

CEO Asad emphasized that the completion of this facility marks a significant milestone in enhancing healthcare infrastructure in the region, providing advanced medical services and ensuring better patient

"The use of earthquake-resilient technology ensures the safety and stability of the hospital, making it a robust addition to the healthcare facilities in Srinagar,"

The CEO directed the Chief Engineer, R&B, which

is the Project Implementation Unit (PIU) for this initiated. The Medical Superintendent of Bone and prestigious health sector project, to expedite the tendering process for crucial health sector projects under the World Bank-funded JTFRP and ensure their completion as per the agreed timelines.

Key progress under credit linked schemes was reviewed in detail. The meeting was informed that 1906 cases have been disbursed under KCC (Animal Husbandry) against 2230 sponsored cases, while under KCC (Sheep Husbandry) 36

cases were disbursed out of 87 sponsored cases. Similarly 21 cases were disbursed under KCC (Fisheries) against 30 sponsored cases. The DDC instructed banks to ensure the timely disbursement of pending cases.

It was further informed that 52 cases have been disbursed under the Prime Minister's Formalization of Micro Food Processing Enterprises (PMFME). Noting slow disbursement under the Holistic Agriculture Development Program (HADP), the DDC directed concerned officers to take immediate corrective measures.

Reviewing the progress under the selfemployment schemes, the chair was informed that disbursement has been made against 73 proposals sponsored under PMEGP. The DDC directed the District Industries Centre to motivate the maximum number of youth for self employment by promoting PMEGP and other like schemes.

The DDC also reviewed the progress under Mission Youth, RSETI, NRLM and other schemes, urging all departments to expedite sponsorship and disbursement to meet targets.

INDIAN NAVY

SHIPBUILDING PROJECTS

With over 133 ships/submarines having been built and commissioned in India to date, the Indian Navy continues to propel the domestic shipbuilding industry's growth by supporting self-reliance in defence manufacturing. The IN remains the key pillar that supports the growth of Indian shipbuilding sector, with 63 of the 64 warships planned to be inducted in the Navy being built in India, orders for 62 more ships and submarines being in the final stages of approval, and steadfast focus on achieving higher indigenisation content across weapons, sensors and equipment.

The ships/submarines which have been commissioned/ delivered and those scheduled for delivery this year are

INS Sandhayak, the first of four Survey Vessel Large (SVL) was commissioned into the Indian Navy in the presence of Raksha Mantri in February 2024, at Visakhapatnam. Induction of the vessel has enhanced the hydrographic survey capabilities of the Navy and the Nation.

The second ship of SVL project, Yard 3026 (Nirdeshak), was delivered to Indian Navy by GRSE on October 08, 2024 and commissioned in the presence of Raksha Rajya Mantri on December 18, 2024.

The contract for construction of two ships, Addl P1135.6 FO, ex Russia, was signed on October 23, 2018 between MoD and JSC RoE. The first of the two ships, INS Tushil, was commissioned on December 09, 2024. The ship is installed with state-of-the-art weapon and sensors and would significantly enhance the combat capability of the Indian Navy.

Delivery of the fourth Ship of P15B - Y12707 (Surat), being constructed at MDL, is being targeted by December 2024.

Seven P17A ships are at various stages of construction, with four ships being built at M/s MDL and three ships at M/s GRSE. Delivery of the first ship, Nilgiri, is planned in December 2024.

The sixth and final submarine of Kalvari class (Vaghsheer) is planned to be delivered in December 2024. The first ASW SWC, Arnala, is at advanced stage of readiness and delivery is targeted by December 2024.

Three 25 Tons Bollard Pull tugs, four of the eleven Ammunition Cum Torpedo Cum Missile barges and fifth of the eight Missile Cum Ammunition barges were delivered to Indian Navy in 2024 by MSME shipyards namely, Shoft Shipyard Pvt Ltd, Suryadipta Projects Pvt Ltd and SECON Engineering Projects Pvt Ltd respectively.

NAVAL AVIATION

Induction of Drishti-10 MALE RPAs marks an important addition to the Indian Navy's RPA inventory. This technologically advanced aircraft would significantly bolster Indian Navy's surveillance capabilities and augment Maritime Domain Awareness efforts.

Rotary Naval Shipborne Unmanned Aerial Systems have been inducted in the IN in early 2024. Four systems comprising two aerial vehicles have been integrated on Fleet ships and are being effectively utilised for surveillance.

First nine of the 24 MH 60Rs helicopters being procured by IN have been operationalised onboard Fleet ships. These multi-role helicopters have significantly bolstered IN's Anti-Submarine Warfare capabilities. The aircraft have also participated in multinational exercises such as MALABAR. SIMBEX and MILAN 24. The first MH 60R Squadron, INAS 334, was commissioned at INS Garuda, Kochi in March 2024.

OPERATIONAL DEPLOYMENTS/ EXERCISES

Mission Based Deployments: The Indian Navy (IN) undertook Mission Based Deployments in Areas of Interest in the Indian Ocean Region (IOR) to safeguard national maritime interests and maintain continuous/ near continuous presence in the areas of maritime significance in the IOR. IN ships and aircraft were regularly deployed in the Gulf of Oman/Persian Gulf, Gulf of Aden/Red Sea, South and Central IOR, off Sunda Strait, Andaman Sea/approaches to Malacca Strait and Northern Bay of Bengal. These deployments aligned with the larger GoI vision of 'Security And Growth for All in the Region (SAGAR)', whereby enhanced Maritime Domain Awareness, swift Humanitarian Assistance and Disaster Relief (HADR) assistance to IOR littorals. security to Indian and international maritime community were ensured, and operational engagements with friendly navies through capability development and capacity building programmes were facilitated.

Anti-Piracy Patrol in Gulf of Aden (Op PoG): Anti-Piracy Patrol in Gulf of Aden commenced in 2008 to ensure safe passage of Indian Flagged Merchant Vessels, and 127 IN ships have since been deployed in the Gulf of Aden. In addition, IN commenced deployments to counter piracy off the West Coast of Africa, in Gulf of Guinea, since 2022. Over the last year, the Indian Navy has successfully conducted six Anti-Piracy operations, saving 120 lives.

Maritime Security Operations: In view of the Israel-Hamas conflict, the Indian Navy commenced Maritime Security Operations. The high tempo of operational deployments of IN assets continues to be maintained, with a close watch on Indian Flagged Merchant Vessels and vessels carrying critical commodities for India. Over the last one year, in response to Houthi shipping attacks, and rising incidents of piracy in the Western Arabian Sea, the Indian Navy has deployed over 30 ships in the region and has responded to over 25 incidents. The credible and swift actions of IN saved more than 400 lives, irrespective of the nationality of the crew. As of November 2024, IN has safely escorted over 230 Merchant Vessels, carrying over 90 Lakh Metric Tons of cargo, valued at over Four Billion USD. IN efforts have garnered international/ national acclaim, consolidating its position as a 'Preferred Security Partner' and 'First Responder'.

Response to Maritime Incidents: Mission deployed unit(s) in Gulf of Aden (GoA) and adjoining seas have responded to numerous maritime incidents with resolve and

Anti-Narcotics Operations: Over the last three years, 13 Anti-Narcotics Operations have been undertaken by the IN, resulting in seizure of narcotics worth about Rs 35,000

crore. In February 2024, an IN Ship seized the largest ever consignment (by quantity) amounting to 3,300 kgs of narcotics in northern Arabian Sea. In April 2024, IN Ship deployed for Focussed Operations Crimson Barracuda seized about 940 kgs of contraband from a Fishing Vessel in South Western Arabian Sea. In November 2024, IN ship again apprehended another vessel and seized over 750 kgs of narcotics.

MILAN - 2024: MILAN 2024 was conducted at/off Visakhapatnam from February 19-27, 2024. This year's edition was conducted at an unprecedented scale, involving participation of over 36 ships, two submarines, 55 aircraft and senior leadership of 47 friendly countries from six continents.

· P8I Deployment in North Sector: P8I aircraft of Indian Navy was deployed in Northern Sector for surveillance on various occasions in support of Army/Air Force taskings. The deployments enhanced inter-service operability and iointmanship.

Twin Carrier Operations: IN's carriers participated in MILAN 2024 and twin carrier operations were conducted off Goa in March 2024 on the sidelines of the first edition of the biannual Commanders' Conference. These operations have been a potent demonstration of IN's fast growing blue water capability and gained considerable attention from national and international media.

Exercise Poorvi Lehar: IN conducted Exercise Poorvi Lehar in March 2024 in multiple phases on the East Coast. The exercise was aimed at validation of procedures towards assessment of Indian Navy's preparedness to respond to various maritime security challenges.

Coastal Security: Regular coastal security deployments and exercises have greatly assisted in streamlining the SOPs and enhanced interoperability with various stakeholders. Coastal security exercises Sea Vigil, Prasthan, and Op Sentinel have been conducted in 2024.

Navika Sagar Parikrama II - INSV Tarini: INSV Tarini, with two women officers embarked onboard, sailed from Goa on October 02, 2024 for dual handed Navika Sagar Parikrama (sailing expedition around the world). The expedition encompasses ocean sailing over 21,600 Nm in about 240 days, across four continents, three oceans and three challenging Capes. The voyage aptly highlights Nari Shakti and Atmanirbharta in sail boat construction, whilst also contributing to maritime consciousness.

Final Operational Clearance of INS Vikrant: INS Vikrant, the first indigenously built aircraft carrier of the Indian Navy, post-certification of aviation facilities, commenced Final Operational Clearance in January 2024. As part of the FOC, more than 750 hours of flying have been undertaken from Vikrant with various types of carrier-borne aircraft, including extensive day and night flying by fighter aircraft and all types of helicopters in the Indian Navy.

EXERCISES WITH FOREIGN NAVIES

Ex-Malabar: The 28th edition of Exercise MALABAR, which is a multinational maritime exercise between India. Australia, Japan and the US, was hosted by Indian Navy at/ off Visakhapatnam from October 08 to 18, 2024.

RIMPAC: IN Ship Shivalik, P8I aircraft and team of Marine Commandos were deployed in South China Sea and Pacific Ocean from May to August 2024 for participation in the 29th edition of multinational exercise RIMPAC at/ off Pearl Harbour, Hawaii, from June 27 to August 02, 2024.

JIMEX 24: The eighth edition of bilateral maritime exercise between the Indian Navy and the Japanese Maritime Self Defence Force, JIMEX 24, was held in Yokosuka, Japan in two phases, from June 11 to 14, 2024.

Ex-Indra: IN Ship Tabar participated in Exercise Indra 2024 from July 25 to August 01, 2024 with the Russian Federation Navy. The ship also took part in the Russian Navy Day celebrations at St. Petersburg, Russia. Ex-Varuna: The 22nd edition of Exercise Varuna

was conducted from September 01 to 04, 2024, in the Mediterranean Sea, wherein maiden P8I European detachment was undertaken at Istres, France for participation in Ex-Varuna 24.

IBSAMAR VIII: IN Ship Talwar participated in the India-South Africa-Brazil trilateral exercise IBSAMAR VIII at/offSimon's Town, South Africa, from October 10 to 16, 2024.

Ex-Tiger Triumph: In consonance with the established partnership between India and the US, an advanced September 05 to 22, 2024.

Ex-Sea Dragon: IN P8I aircraft operated from Andersen Air Force Base, Guam, for the multilateral exercise Sea Dragon from January 08 to 22, 2024. The Indian P8I crew was adjudged first in the identification of tonals.

ASSISTANCE TO FOREIGN GOVERNMENTS

One IN Dornier (DO) aircraft was handed over to the Government of Sri Lanka (GoSL) on August 15, 2022 for a period of two years. An IN technical team consisting of five personnel (two officers and three sailors) has also been deputed to Sri Lanka to oversee maintenance of the aircraft. Regular training of Sri Lankan Navy (SLN) pilots on ALH operations and of SLAF and SLN crew on Dornier operations is being undertaken.

A Letter of Exchange was signed between GoI and GoSL for positioning one Dornier 228 Maritime Patrol Aircraft at Sri Lanka, for undertaking Maritime Surveillance and Search and Rescue operations. Dornier aircraft IN 234 has been handed over to Sri Lankan Air Force on August 27, 2024 at Kochi on yearly turnaround basis.

As part of refit preparatory activities of MCGS Huravee (ex-Tarmugli; gifted by IN to MNDF), a three member IN technical delegation from Naval Dockyard (Mumbai) was deputed to Maldives from June 23 to 26, 2024 for undertaking assessment of the scope of work. Expeditious provisioning of machinery spares, including that of control systems, was undertaken to Maldives in August 2024 for sustenance of MCGS Huravee.

Two Fast Interceptor Crafts from IN inventory have been gifted to Government of Mozambique. These were transhipped onboard IN Ship Gharial to Mozambique in October 2024.

Sevchelles

Two detachments were undertaken by the IN DO squadron from March 19 to 23, 2024 and July 17 to 21, 2024. The squadron flew several surveillance missions in areas off Seychelles.

Mauritius

Maiden Short Refit of MCGS Victory was conducted from October 15, 2023 to January 31, 2024. The refit of the ship was successfully completed within the promulgated timelines.

HADR & SAR OPERATIONS

Op Sadbhav – Typoon Yagi: IN ship Satpura was deployed to Yangon, Myanmar on September 17, 2024 to provide HADR in response to the flash floods caused by Typhoon Yagi. IN swiftly delivered 21.5 Tons of essential supplies such as medical aid, food and shelter materials.

Cyclone Hidaya: In the aftermath of Cyclone 'Hidaya', making a landfall off Dar-es-Salaam, Tanzania on May 04, 2024, mission-deployed IN ship off Somalia (for anti-piracy operations) was diverted to render HADR assistance. The ship handed over HADR relief material (food, clothes and medicines) to Government of Kenya at Mombasa on May 10, 2024

SAR Assistance to MV Prestige Falcon: On July 15, 2024, IN responded to provide SAR assistance towards locating and rescuing crew of Comoros Flagged Oil Tanker MV Prestige Falcon, which had capsized at about 70 nm South of Duqm, Oman (approx. 800 Nm West of Mumbai). IN ship Teg rescued nine surviving crew members (eight Indians and one Sri Lankan) and recovered mortal remains of one

SAR Assistance on Landslide in Karnataka: On July 16, 2024, IN diving teams ex-Karwar helped to locate and recover one missing LPG tanker from Gangaveli river in Uttar Kannada, post landslide near NH 66.

Disaster Relief Operations at Kerala: On July 30, 2024, IN personnel were deployed to Wayanad to render SAR assistance in the aftermath of massive landslide near Meppadi in Wayanad District, Kerala. The deployed IN personnel provided medical aid, undertook extensive SAR ops and distribution of relief material.

SAR Assistance in Andhra Pradesh: On September 01, 2024, IN teams were deployed at Nuziveedu town (approx. 60 km from Vijayawada and 280 km from Visakhapatnam)

Eluru District, Andhra, post incessant rains. A total of 751 civilians were rescued and 4537 Kg of relief material were

Food Relief at Vijayawada: During floods at Vijaywada from September 01 to 04, 2024, two ALH, two Chetak and one Dornier aircraft were deployed to the affected areas. $22\,stranded$ individuals were rescued and more than $1000\,Kg$ of food aid was air dropped. 10 Flood Relief Teams were also deployed to rescue citizens stranded in the flooded areas.

SAR Assistance in Jharkhand: IN provided SAR assistance from August 22 to 27, 2024 at Chandil Reservoir (approx 100 Km South East of Ranchi), on request of the District Administration, Seraikella-Kharsawan, Jharkhand for two seater training aircraft (Cessna VT-TAJ, with two pilots), which had reportedly crashed on August 20, 2024. Mortal remains of both the pilots were recovered and aircraft debris/ wreck were salvaged by IN team and handed over to District Administration on August 27, 2024.

WELFARE AND EMPOWERMENT

IN has taken significant steps for becoming a true genderneutral and inclusive force, both in letter and in spirit. IN has commenced induction of women into all branches, and all avenues for career progression are now available for women in the IN. In the last two decades, newer ships have been inducted into the Navy that cater for gender specific needs of women, and their appointment onboard warships commenced from December 2020.

Women Officers: Women officers are inducted into the Navy through a common entrance process and are subject to uniform 'Terms and Conditions' of Service. Further, duties, job specifications and training for women officers is in no way different from their male counterparts. The working conditions, promotion prospects, as well as pay and allowances of women officers are also exactly the same as male officers.

Permanent Commission to Women Officers: SSC women officers are eligible for grant of PC. As on date, 72 women officers (excluding Medical and Dental officers) have been granted PC.

Women Officers Onboard Ships: Women officers are being appointed onboard warships. Currently, 44 women officers are deployed on afloat billets.

Naval Air Operations Officers on Helicopters: Women NAO officers have been appointed as specialist NAO officers to shipborne helicopter flights.

RPA Stream: Women officers can join the Remotely Piloted Aircraft (RPA) stream and the first woman officer joined a RPA squadron in March 2021.

· Overseas Assignments: Women officers are being deputed overseas including as part of 'Mobile Training Teams' and other foreign cooperation engagements.

Command of Combat Units: Meriting women officers are being selected to command combat units. Indian Navy appointed the first woman Commanding Officer of a naval ship in December 2023.

A woman officer was appointed as Executive Officer

First woman helicopter pilot of IN was awarded 'Wings' on June 07, 2024 and also the first woman officer qualified as 'P8I' aircraft pilot in July 2024.

Women Sailors in the Navy

· Agniveers: Indian Navy became the first Service to leverage Agnipath to tap into the vibrant 'Nari Shakti' of the nation's workforce. Women Agniveers are subject to the same training curriculum, professional courses and enrolment criteria for selection as regular sailors as their male counterparts. Women sailors will be employed across all trades for sailors, including onboard frontline operational units. As on date, 1,321 women Agniveers are borne on the strength of Indian Navy

ADDITIONAL IMPORTANT ACTIVITIES

President Smt Droupadi Murmu attended the 'Day at Sea' event off Goa on December 07, 2024. During the visit, the President witnessed several naval operations, including missile firing drills, and fighter aircraft operations from the deck of Vikrant, and was also briefed on the role of Indian Navy and the naval Concept of Operations.

Raksha Mantri laid the foundation stone of a new Very Low Frequency Station of the Indian Navy at the Damagundam Reserve Forest site, Pudur Mandal in Vikarabad, Telangana in October 2024. The facility, built at a cost of Rs 3,200 crore, will be spread across 2,900 acres. It will bolster the Indian Navy's operational readiness, ensuring effective command and control capabilities in challenging maritime environments.

As part of Navy Day celebration, an Operational Demo by frontline naval ships and aircraft, to demonstrate Indian Navy's preparedness to respond to maritime threats and challenges, was conducted off Puri (at Golden Beach), Odisha in December 2024. The event is in consonance with the Government of India policy to celebrate Service Days in various cities apart from Delhi. The President presided over the event as the Chief Guest.

As part of the first edition of Naval Commanders' Conference 2024, Raksha Mantri interacted with the Naval Commanders on the inaugural day of the conference on March 05, 2024 and witnessed the naval Operational Demonstration, including Twin Carrier operations.

Nausena Bhawan, the newly-constructed Headquarters of the Indian Navy, located at Delhi Cantt. was officially inaugurated by Raksha Mantri Shri Rajnath Singh in March 2024.

As part of Project Seabird, four major marine piers at Karwar have been completed/handed over to Indian Navy in early 2024. Further, five more piers are scheduled for delivery by end December 2024.

The statement further said, "As many as 210 accused were

arrested across key categories of crimes in 80 cases registered by NIA in 2024. Of these cases, Left Wing Extremism (LWE) and North East insurgency topped the list at 28 and 18 cases. Seven J&K Jihadi cases were followed by 6 Explosive Substances and 5 Human Trafficking cases. NIA further registered 4 Other Jihadi cases, 4 Khalistan and 2 ISIS Jihadi cases, and 1 case each in Gangsters, Cyber Terrorism, FICN and other categories," the statement said.

"The NIA's impressive performance for 2024 was marked by convictions of 68 accused (in 25 cases) and charge sheeting of 408 accused. A total of 137 properties/assets worth Rs 19.57 crore were attached during the year as part of the agency's sustained efforts to dismantle the various terrorist, gangster and other criminal networks. Left Wing Extremism remained under NIA's scanner throughout the year, leading to the maximum of 69 arrests of the total 210 arrests reported in 2024," it said.

"Twenty eight cases of LWE were registered, and 12 chargesheets filed against 64 accused in this category," it added.

"The crackdown on the growing terrorist-gangster was also a key highlight of the year. NIA arrested 14 accused in connection with foreign-based Khalistani terrorist cases during the year, which saw 101 searches being conducted in these cases. The total searches carried out across all kinds of cases in 2024 stood at 662. Thirteen arrests were made in gangster related cases during the year," the statement said.

"The agency's agile efforts in cracking terrorism cases were evident in the fact that it had charge sheeted Pakistan-based Babbar Khalsa International (BKI) chief Wadhawa Singh @ Babbar and five other terrorists in the murder of VHP leader Vikas Prabhakar @ Vikas Bagga in Punjab within months of the fatal attack, " the statement said, adding, "Similarly, 10 accused, including foreignbased terrorist Goldy Brar, were expeditiously charge sheeted in the case pertaining to firing for extortion at the house of a businessman in Chandigarh by aides of Brar. Early in the year, NIA had also charge sheeted Khalistan Terrorist Force (KTF) members Manpreet Singh alias Peeta and Mandeep Singh, after their successful deportation from Philippines."

"The NIA further secured the conviction of four terrorists, including chief conspirator Kulwinderjeet Singh @Khanpuria, in a terror conspiracy case related to the banned Babbar Khalsa International (BKI) outfit. Khanpuria was involved in many terrorist cases, including a bomb blast at Connaught Place and a grenade attack at Red Fort, Delhi, in the nineties. He was also wanted in many terrorist cases, including a conspiracy to carry out targeted killings in Punjab. Another notable development in the Khalistani terror related cases was the successful extradition of Tarsem Singh Sandhu of Tarn Taran district of Punjab from UAE, in a case of conspiracy of KLF, BKI & ISYF to wage war against the country," the statement added.

"As far as extraditions secured by NIA are concerned, another accused, Salman Khan, was brought in from Rwanda in an arms seizure case of Bengaluru, Karnataka," it said.

"The NIA scaled up its operations multifold in 2024, cracking the Rameshwaram café blast case, which rocked the nation early in the year, within a matter of months. With five accused already arrested and four charge sheeted in this high-profile case," it said, adding, "The NIA once again proved its ability to solve tough cases with speed and agility, backed by technical and field investigations in coordination with various state police forces and other agencies. "

"A total of 27 absconding criminals were nabbed by NIA during the year. Notable among them was Savad, who was nabbed after being on the run for 13 years in the Kerala Professor hand chopping case. Other key absconders arrested during the year included Mohammed Sahjalal Haldar and Idris in a Bengaluru case relating to human trafficking from Myanmar into India, Shokat Ali @ Shaukat Ali in the Jaipur customs gold seizure case, and Mohammed Mustafa & Kodaje Mohammed Sherif in BJP leader Praveen Nattaru murder case. The arrest of absconder Kamran Haider in the Laos human trafficking and cyber slavery case signified NIA's concerted focus on destroying the chain behind this criminal activity, which has led to several innocent youth being trapped on foreign land by unscrupulous elements," the statement said.

"A key aspect of the speedy action and breakthroughs in the Rameshwaram café blast and other major cases was the stellar role played by the intelligence agencies and the concerned state police forces," it said, "NIA coordinated closely with them throughout the year, working in a spirit of team work and sharing information on

a continuous basis to crack various important cases with speed and alacrity. As part of its efforts to enhance the capacity of the state police forces, NIA also engaged in their capacity building, providing training to 1,678 state police officials through 11 training programmes/courses in 2024. At the same time, given the growing scale and magnitude of major terror related and other serious crimes with the potential to disrupt India's peace and harmony, NIA made significant efforts during the year to strengthen its own capacities. The establishment of two new exclusive NIA courts, one each in Jammu and Ranchi, was an important step in this direction. NIA also released a handbook on UA(P)A investigations to bring standardisation into the probing of terror cases," it said.

PCB retains **Aaqib Javed on** selection committee despite interim head coach role

KARACHI: The Pakistan Cricket Board (PCB) has decided not to remove former Test pacer Aaqib Javed from the national selection committee, despite him accepting the position of interim head coach for both the white and red-ball national squads.

According to sources within the PCB, since Aaqib'srole as head coach is temporary, he will remain a part of the selection committee.

However, one insider noted that Aaqib's influence as a selector had diminished, especially after he assumed the role of red-ball head coach following Jason Gillespie's resignation before the South Africa Test series. Since then, other selectors have gained more authority in decision-making.

"Aaqib's role as selector has been minimal in recent times with the team playing its test series in South Africa. As the other selectors, Azhar Ali, Asad Shafiq, Aleem Dar, Hasan Cheema have been more authoritative and had their say on Shaheen Shah Afridi being sidelined for the two tests in SA after the white ball series," he said.

Earlier this year, the PCB had appointed South Africa's Gary Kirsten and Australia's Jason Gillespie as head coaches for the white and red-ball teams. Both were granted selection committee membership and given the final say in team selections.

"But after Pakistan fared poorly in the World T20 Cup followed by the two nil whitewash by Bangladesh in the test series at home, the PCB decided to bring revamp the selection committee by adding Aaqib, Azhar and Aleem to the mix and also stripped Kirsten and Gillispie of considerable powers they enjoyed including being members of the selection committee and final say in team selections," the insider said.

Indian cricket has depth to fill Rohit, Virat's void: **Lehmann**

MELBOURNE: Indian cricket has produced a generational superstar in Yashasvi Jaiswal and will remain in good health even when Virat Kohli and Rohit Sharma decide to call time on their careers, feels former Australia head coach and two-time World Cup winner Darren Lehmann.

The 54-year-old, who played 27 Tests and 117 ODIs during his decade-long career, is also captivated by Jasprit Bumrah's skills, claiming to have never seen any player have more impact in a single series.

Talking about impending retirements of Rohit and Kohli following their poor show in the ongoing series where India trail 1-2, Lehmann was empathetic and practical about the transition in Indian cricket.

"Look whenever they decide to give it away and whatever happens in next few days they have been great players for India over a long period of time," Lehmann, a member of 1999 and 2003 ODI World Cup-winning teams told PTI.

"Now actually we see younger players starting to step up for India and play well



at next level. There is so much depth in Indian cricket I won't worry too much," Lehmann was pretty matter of fact.

"Whenever these two guys decide to retire, there are so many talented youngsters that Indian cricket will be in good stead."

Having watched Jaiswal emerge as the flagbearer of Indian batting in the series, Lehmann made a bold prediction about the southpaw, who has scores of 161, 82 and 84 in this series.

"Oh, superstar. One of the best I have seen," Lehmann said quickly, before the question was finished.

"He (Jaiswal) and Harry Brook are two next generation players. They are the ones that people will sit back and say they are good players. He played very well in Melbourne and was outstanding in Perth. He has come up leaps and bounds on this tour," the beefy left-hander of yesteryears said.

But Lehmann reserved his highest praise for Bumrah, equating him with all-time greats such as Wasim Akram and Glenn McGrath.

"I presume he (Bumrah) is the next captain when Rohit finishes. He did a really good job in Perth. He is the best bowler I have ever seen live.

"I have seen Wasim Akram, Glenn McGrath and all but I have not seen a bowler have impact like him in a single series like Jasprit Bumrah has since Mitchell Johnson in 2013-14 Ashes win.

"This is very similar as Bumrah already has 30 wickets. He has been outstanding to watch. He will do well when he gets a chance to lead India."

Talking about transition, Lehmann noted that Australia's batting could be a concern, rather than the bowling, even though Pat Cummins, Mitchell Starc, Josh Hazlewood, Scott Boland, and Michael Neser are all in their early to mid-30s.

"I am not so worried about bowling as lot of good kids are coming up. Lance Morris, Xavier Bartlett from Brisbane Heats, so there are plenty of them. Spinners are okay but it is the batting that is being tested at the moment," said Lehmann.

"There will be some changes with greats retiring but fast bowling will be good enough. How long Cummins and Starc survive time will tell, but hopefully, they will get to till next Ashes."
