The 2024 annual report of the MHA accessed by the news agency—Kashmir News Observer (KNO) states that the country is heading towards achieving the goal with the approach of zero tolerance against terror. "Under this vision, the MHA designated Hizbut-Tahrir as a terrorist organisation under UAPA. The MHA designated Goldy Brar & Qasim Gujjar as terrorists. Nine organisations have been declared as Unlawful organizations," it states.

"In a significant step towards the goal of terror-free Bharat, two



different categories of explosive detectors indigenously manufactured by Electronics Corporation of India Limited, Department of Atomic Energy, and DRDO were handed over to the Director, IB, by the Principal Scientific

Adviser to GOI for Security Forces. The indigenously developed detectors are to be handed over by IB to 12 identified security agencies for field deployment," the report states.

SRINAGAR: Amid peak winters, Kashmir Power **Development Corporation** Limited (KPDCL) on an average is getting nearly 1700 Megawatts (MW) of Power against the average demand of nearly 1800 MWs.

Atop official informed the news agency—Kashmir News Observer(KNO)that "The local DISCOM on an average was receiving nearly 1700 MW of power against the peak demand of over 1800 MW."

The official further said that the highest demand of power in the ongoing winters was recorded at 1922 MW including the enduring power curtailment schedule.

Govt Asks IAS Officers To Submit Property Details By Jan 31st

SRINAGAR: The General Administration Department (GAD) of Jammu and Kashmir has issued a directive requiring IAS officers to submit their annual Immovable Property Returns (IPR) online by January 31, 2025. This initiative aims to enhance accountability and ensure compliance with the All India Services (Conduct) Rules, 1968. In Circular No. 01-JK(GAD) of 2025, issued today,

the GAD emphasized that failure to file the IPR within the stipulated deadline would lead to disciplinary action. The department reminded officers that this requirement is mandated under Rule 16(2) of the AIS (Conduct) Rules, which stipulates the timely submission of property returns to maintain transparency within the administrative system.

Congress to launch 'Jai Bapu, Jai Bhim, Jai Samvidhan' campaign on Jan 3

'Jai Bapu, Jai Bhim, Jai Samvidhan Abhiyan' in all blocks, districts and states on January 3. The campaign will culminate in a public rally at Mhow on January 26.

The campaign was to be launched on December 27 but was suspended in view of the demise of former prime minister Manmohan Singh on December 26 and the announcement of a seven-day mourning in his honour. The decision to organise the campaign was taken at the last meeting of the Congress Working Committee (CWC) at Belagavi on December 26.

Congress general secretary Jairam Ramesh said the implementation of the CWC resolution of December 26 was suspended for a week as a mark of "deep respect' and reverence for Singh.

"It will take more time to get used to the fact that he is no longer with us," he said. "Even so the Jai Bapu, Jai Bhim, Jai Samvidhan Abhiyan will resume in blocks,



districts and states, on January 3, 2025 leading up to rally in Dr. Ambedkar's 'janmabhoomi' Mhow on January 26, 2025 which is also the 75th anniversary of the Constitution of India coming into effect and the Republic of India being created,"

Ramesh said. The CWC, in its resolution, had said the Congress is "fiercely committed" to protecting the Constitution and the ideals of the Indian Independence Movement.

Accordingly, the CWC resolution said, the Congress will launch the Jai Bapu, Jai

Bhim, Jai Samvidhan campaign beginning with a rally in Belagavi on December 27 and culminating in a rally at Mhow on January 26.

During this month, it said, rallies and marches will be organised in every block, district and state as well.

Given the urgency of the need to preserve, protect and promote the legacy of Mahatma Gandhi as well as that of the Constitution, this movement will extend beyond January 26 as well, it said.

The CWC also said between January 26, 2025 and January 26, 2026, the Congress will launch a "massive", nationwide public outreach campaign called the Samvidhan Bachao Rashtriya Padayatra in which all leaders will participate.

"This padayatra will be from village to village, township to township in the form of a relay," the CWC said.

leader Gaurav Gogoi has sought roll back of the government's decision to withdraw the India Post's book packet service saying it will bring hardship to the literary community and directly impact millions of Indians in accessing books that contribute to their education, personal growth and connection to the world.

In a letter to Union Minister for Communications Jyotiraditya Scindia, Gogoi expressed deep concern over the decision to discontinue the India Post's book packet service and said it will affect readers in smaller towns and villages across India since the service was often the most accessible and cost-effective way to receive books.

"On December 18. India Post decided to withdraw this service in favour of alternatives like Speed Post and Registered Post, which cost nearly 50 per cent more. This price increase poses a significant challenge for publishers, particularly those catering to niche audiences, regional languages, and specialised genres, and could make books less affordable for many readers," he said.

PATNA: Bihar Chief Minister Nitish Kumar owns movable and immovable assets worth Rs 1.64 crore, according to his latest disclosure of assets.

According to details of assets of the chief minister and his cabinet colleagues uploaded on the Bihar government website on December 31, Kumar has Rs 21,052 in cash and



nearly Rs 60,811.56 in different banks.

The Nitish Kumar government has made it mandatory for all cabinet ministers to disclose their assets and liabilities on the last day of every calendar year.

As per the disclosures, several ministers are richer than

According to the disclosures made by the CM on the website of the Cabinet Secretariat Department, Kumar has total movable properties worth around Rs 16,97,741.56, while he has immovable assets worth Rs 1.48 crore. The CM has only one residential flat at a cooperative housing society at Dwarka in New Delhi. In 2023, the CM had movable and immovable assets worth Rs 16,484,632.69.

According to disclosures, Bihar Deputy CM, Samrat Choudhar, has Rs 6,70,000 in cash, whereas his wife Kumari Mamta has Rs 5,70,000 in cash. Choudhary also owns a rifle worth Rs 4 lakh. He also owns immovable assets worth Rs 8.28 crore. Another DyCM Vijay Kumar Sinha owns immovable assets worth Rs 2.42 crore, whereas his wife owns immovable assets worth Rs 3.32 crore. Sinha, who does not have cash in hand, also owns a revolver worth Rs 77,181.

Manilal penned several books and published over 200 research papers besides introducing many new plant species. He is a recipient of several national and international awards.



Rajnath Singh Calls 2025 A Year Of Reform, Says "A Step In Modernisation Of Armed Forces"

In order to give impetus to the ongoing and future reforms, it was unanimously decided to observe 2025 as the 'Year of Reforms' in the MoD. This would aim at transforming the Armed Forces into a technologically advanced combat-ready force capable of multi-domain integrated operations," as per a Ministry of Defence release.

During the meeting, it was decided that the MoD would focus that reforms should further



bolster Jointness & Integration initiatives, facilitating the establishment of integrated Theatre Commands. Additionally, it was also emphasised that reforms should focus on new domains such as Cyber and Space, and emerging technologies like Artificial Intelligence, Machine Learning, Hypersonics and Robotics. should also be developed.

Raksha Mantri Rajnath Singh expressed confidence that the 'Year of Reforms' would be a momentous step in the modernisation journey of the Armed Forces.

He stated, "It will lay the foundation for unprecedented advancements in the country's defence preparedness, thus preparing to ensure the security and sovereignty of the nation amidst the challenges of the 21st century."

NPCIL Invites Proposals To Set Up Small Nuclear Reactors

NEW DELHI: India's nuclear power operator NPCIL on Tuesday invited proposals from the industry to set up 220 MW Bharat Small Reactors for captive use, replacing the existing coal-fired thermal power plants used by the steel, aluminium, copper and cement industries.

Bharat Small Reactors are 220 MW Pressurised Heavy Water Reactors (PHWR) with an impeccable safety and excellent performance record, which are compact and tailored for captive use, according to a statement from the Nuclear Power Corporation of India Limited (NPCIL).

"NPCIL has today invited Request for Proposals (RFP) from visionary Indian

industries for setting up 220 MW Bharat Small Reactors (BSRs) for captive use," said the statement.

The nuclear power operator said BSRs can provide a sustainable solution for decarbonization of hard-to-abate

It would also help these industries secure economic benefits resulting from savings in carbon emission related taxes, thus increasing competitiveness of their products in the global markets, the statement said.

The government plans to deploy 40-50 of these nuclear reactors over the next decade in partnership with the private sector. This is part of the 220-megawatt BSR that Finance Minister Nirmala Sitaraman had unveiled in her budget speech in July.

"In line with the announcement in the 2024-25 Union budget, BSRs areplanned to be set up with private capital, within the existing legal framework and approved business models," the NPCIL said.

CBI probes ED officers in bribery & scholarship scam

SHIMLA: The Central Bureau of Investigation (CBI) has registered two First Information Reports (FIRs) against officials of the Enforcement Directorate (ED), including an Assistant Director and senior officers posted in Shimla, for allegedly demanding and accepting bribes.

The bribery allegations are linked to the ongoing investigation of the 181 crore scholarship scam in Himachal Pradesh.

According to CBI sources, the first FIR pertains to a bribe demand of 85 lakh, while the second involves 80 lakh. Both cases reportedly involve ED officers demanding money from educational institution promoters $who \, are \, under \, investigation \, for \,$ financial irregularities under the Prevention of Money Laundering Act (PMLA).

The primary accused, ED Assistant Director Vishaldeep Singh, allegedly summoned the complainants to his Shimla office, tortured them, and coerced them into paying hefty bribes. The accused officers also involved middlemen, including Vishaldeep's brother, a senior manager at Punjab National Bank

in Delhi, who allegedly helped facilitate the transactions. The CBI, based on complaints

from the educational institution promoters, planned a trap

funds intended for SC, ST, and OBC students were allegedly misappropriated by private educational institutions The CBI which began investigating the



operation near Chandigarh. The complainants were instructed to pay 55 lakh in cash to the accused officer while CBI operatives monitored the transaction. However, Vishaldeep Singh, reportedly alerted to the trap, escaped during the operation. His brother and a middleman were arrested, and 55 lakh in marked currency notes were

The bribery allegations have a direct connection to the 181 crore post-matriculation scholarship scam. Between 2013 and 2017,

scam in 2019, found evidence linking ED officials to attempts to cover up the scam in exchange for bribes.

The scope of the investigation has now widened, with the second FIR reportedly addressing the alleged quid pro quo arrangement involving ED officers to shield the accused institutions.

Following the scandal, the ED has transferred the accused Assistant Director and two supervisory officers-a Deputy Director and a Joint Directorto Delhi. However, the CBI has

yet to apprehend Vishaldeep Singh, who remains absconding. Attempts to locate him are ongoing.

During a press conference in Shimla, the complainants accused the ED officers of harassment, mental torture, and coercion. They revealed how they were summoned repeatedly, threatened with arrests, and forced to arrange large sums of money. One of the complainants even considered suicide, underscoring the extent of the alleged abuse.

The CBI has recovered

substantial evidence, including 55 lakh in graft money and other documents implicating the accused. The agency is also probing the involvement of additional ED officials and their associates. The allegations of corruption within the ED's Shimla office have raised serious concerns about the integrity of enforcement agencies tasked with combating financial crimes. With the CBI expanding its investigation, the scandal is likely to have far-reaching implications, not only for the accused but also for the credibility of institutions meant to uphold justice.

NEW DELHI: Hailing the Supreme Court collegium proposal against the appointment of close kin of the judges in the high courts, noted lawyer and Congress leader Abhishek Singhvi has said they should be implemented sooner as judicial appointments are "non objective" that originally conceived.

"If true, both proposals under SC collegium consideration, seemingly radical, are good and should be implemented sooner rather than later," Singhvi said in a post on X.

of judicial "Reality appointments is much murkier and much much more non objective than originally conceived. Mutual Back scratching, uncle judges, family lineages etc demoralise others and bring disrepute to institution," he said.

"But easier said than done: till now we are unable to even ban lawyer relatives practising in same HC as judge relatives. Time and again the system has proved stronger than desirable impulses for reform," Singhvi lamented.

According to sources, the collegium could consider the idea of instructing the high court collegiums to refrain from recommending candidates, whose parents or close relatives were current or former Supreme Court or high court judges.

While this proposal may disqualify some deserving candidates, one of the sources believed it would open up opportunities for firstgeneration lawyers and broaden the representation of diverse communities in the constitutional courts. However, this may lead to unjust denial of judgeship to deserving people just because they are related to sitting or former judges of the higher judiciary, added the source. The three-member

collegium, which recommends names for the judgeship in the apex court at the moment, comprises Chief Justice of India Sanjiv Khanna and Justices B R Gavai and Surya Kant. Justices Hrishikesh Roy

and Abhay S Oka are also part of the larger five-member apex court collegium that decides and recommends names for judgeship in the high courts.



BANDIPORA: In a surprising and contentious decision, the Jammu and Kashmir government has appointed Dr. Masarat Iqbal, who has faced multiple allegations of corruption and administrative misconduct during his previous tenures in Bandipora, as the Medical Superintendent of District Hospital Bandipora.

On Sunday, the government transferred Dr. Masarat Igbal Wani (Medical Officer, Block Lar) to District Hospital Bandipora as Medical Superintendent, vide Government Order No. 915-JK(HME) of 2024, dated December 29, 2024,

Dr. Masarat's first tenure as In-Charge Block Medical Officer (BMO) Bandipora in 2018 was marred by allegations of embezzlement, misuse of resources, and illegal appointments.

According to official documents (a copy of which is available with Kashmir Convener), he was accused of withdrawing Rs 30,000 from the Hospital Development Fund (HDF) for unauthorized salaries and diverting Rs 50,168 from the HDF to a private service station without approval from the local MLA, who was the Chairman of the Rogi Kalyan Samiti (RKS).

He was also accused of consuming fuel worth Rs 1.5 lakh by using a hospital ambulance for his daily commute to his residence in Goshbug Pattan from Bandipora.

Notably, the Directorate of Health Services Kashmir (DHSK)

attached him to the Directorate's office following an inquiry but did not lodge any formal case. (The year of this incident has not been specified.) Then-local MLA Bandipora, Usman Majid, had directed the recovery of Rs 1.85 lakh from the accused for alleged

In his second tenure in 2021 as BMO Bandipora, Dr. Masarat once again found himself in the spotlight for the wrong reasons. On November 25, 2021, the BMO office was gutted in a mysterious fire that destroyed the service books of over 60 employees. Locals suspected the fire was a deliberate attempt to conceal evidence of illegal appointments, although these allegations were never independently verified.

Sources revealed that during the same tenure, the BMO office had a strained relationship with the Chief Medical Officer (CMO) office. Both offices exchanged allegations and counterallegations regarding the procurement of medicines and oxygen concentrators, with each accusing the other of corruption. "This internal discord badly impacted the smooth functioning of healthcare services in Bandipora," civil society members told Kashmir

Dr. Masarat's repeated controversies have cemented his reputation as a contentious figure within the health department. especially in Bandipora, where both of his previous tenures were characterized by allegations of mismanagement and misconduct.

Civil society members expressed concerns over his return to Bandipora in a senior administrative role. "After a long time, Bandipora District Hospital was back on track, but now we are again concerned. We hope the past mistakes are not repeated, and the government should also be cautious about the same," said Mohammad Iqbal, a resident of Bandipora.

Critics argue that appointing a figure with such a controversial history undermines public trust in the healthcare system. However, some suggest that his return offers an opportunity for redemption and improved healthcare delivery in the district.

"Bandipora has always had bad luck. Twice he has been reverted for the wrong reasons. All defaulters have been reserved for Bandipora. He has been tested twice in Bandipora but failed both times, yet he has been sent back with even more responsibilities," said Gowhar Ahmad, another resident.

Locals appealed to the district administration and public representatives to maintain extra vigilance to ensure past mistakes

Attempts by Kashmir Convener to reach out to the Secretary of Health & Medical Education Syed Abid Rasheed Shah, Director Health Kashmir Dr. Jehangir Bakshi, and the officer in question, Dr. Masarat, proved futile. As soon as the officers provide their responses, Kashmir Convener will update their versions online.

Despite rich literary history, Bandipora awaits district library

Bandipora: In a land known for 'Alim (knowledge, Adab (literature) and Aab (water)', the students and aspirants in north Kashmir's Bandipora district face difficulties as there is no modern district-level library.

The district has a tehsil-level library, established in 1972, which operates in private accommodation with limited study materials and no internet access. Its location is unknown to some students, and many are unaware of its existence.

The lack of a modern district-level library forces civil service aspirants to travel to Srinagar for library access.

Students speaking with the news agency-Kashmir News Observer (KNO) said, "Had the facility been available in Bandipora, it would save poor students a significant amount of money."

"The library consists of only two rooms, one serving as a reading area and the other for office staff. It is only open during

office hours, limiting study time for students," they said.

Since its establishment, the tehsil library has been relocated multiple times. Initially located in the main market, it was destroyed by fire in 1974. It was then moved to different locations, including near Noor Masjid and the Board office. The library lacks essential resources.

Mariya, a student, said that while some books are available, there is a need for improvements in infrastructure. During her visit, she felt it resembled an old bookshop more than a library.

Although the district is known for its historical association with knowledge, literature and water, the lack of an upgraded library is a concern.

Locals have requested that the library be developed with modern technology and a 24-hour reading room for students preparing for com-

Sahil Bhat, a student, said the library's limited hours and poor seating arrangements are major issues. He questioned why intellectuals had not advocated for improvements over the years. Many aspirants find it difficult to study in groups due to limited space.

Another significant problem is the lack of access to e-books and online resources. Students from the outskirts also face challenges in visiting the library and have asked for online access to books.

The library is housed in private accommodation, and the people have urged the government to find a permanent location for its establishment.

An official said that higher authorities had approved the Detailed Project Report (DPR) with a budget of 5.5 crore rupees, and construction is expected to start in March 2024. The site for the new library has already been identified, he said.

However, locals are concerned about the time taken to initiate construction and request that the government prioritise a suitable location for the

Mushtaq Ahmad, another student, said that local ministers had neglected this issue during their tenures. He urged the government and district authorities to prioritise the construction of a modern library with modern technology.

In Hajin, a town with a history of scholars, the local library, established in 1977, operates from a rented building. The library faces challenges like an insufficient collection of new books and a lack of modern infrastructure.

The library's holdings were last updated in 2018, and there have been no additions since. The library's resources are limited to two local newspapers, excluding national newspapers that are necessary for civil service

The absence of national papers highlights the gap in resources. The infrastructure of the library is in need of repair.

Nadeem Azad Bhat, an aspirant, said the library lacks essential features like internet access, proper seating and modern technology, which limits its potential for education and community development. The library is also hard to locate, as the rented building has no signage,

and its presence is not well-known.

Zafar Farooq Mir, a civil service aspirant, said he travelled five kilometres to find the library closed.

The lack of resources and operational issues have forced students like Mir to consider moving to Srinagar for better facilities. The library's failure to meet the needs of students underlines the urgency for improvement.

The absence of electricity hampers technological advancements, and the lack of cooling or heating systems makes it difficult to study during extreme weather conditions—(KNO)

Six new defence wings: Towards increasing its footprint across the globe, IAF is in the process of establishing six new defence wings, commencing with Spain, Armenia and Ivory Coast, while continuously exploring avenues to increase its presence in the Indo Pacific Region, Europe, the Americas as well as Africa.

Exercises: The exercises include Ex Desert Knight 24.1, Ex-Khanjar XI, Ex-Southern Discovery, Ex-Tiger Triumph, Red Flag Alaska-24-2, Hop Ex, Ex Pitch Black-24, Ex Udara Shakti-24, PASSEX with CSG of USA (USS Abraham Lincoln, Ex Tarang Shakti-24, Ex Eastern Bridge-VII in Oman, Air to Air Mission with ITS Cavourm and Ex JMT-24 with RSAF.

Op Sankalp-Anti Piracy Mission: On 16 March 2024, one IAFC-17 aircraft undertook a joint operation with Indian Navy wherein two combat boats, armament load and MARCO teams were inserted at the designated objective area, in support of antipiracy operations. The mission was flown in international airspace in covert mode to support the rescue ops for the bulk carrier vessel 'MV Ruen', which was hijacked by Somali pirates near the Yemeni island of Socotra.

Work services for Development of Basic Infrastructure at Nyoma C/o AFS Leh was sanctioned on 31 Mar 2023 at a cost of Rs 219.39 crore. Project includes construction of runway including allied operational works, necessary maintenance and administrative infrastructure. Work is likely to be completed by Aug 2025.

The Prime Minister laid the foundation stone of Air Force Station Deesa airfield virtually on 19 October 2022. Works Services for "Construction of Runway and Associated Infrastructure at AFS Deesa (Phase-I)" was sanctioned for Rs 393.64 crore by MoD on 31 Mar 2021. Present progress is 90%. Runway work has been completed and execution of certain allied works are in progress.

IAF has inducted indigenous Counter Unmanned Aerial System to thwart sub conventional threats to IAF Vulnerable Area/Points. To encourage start-ups/MSMEs towards an Aatmanirbhar Bharat, contracts for development of such systems and Jamming Guns under iDEX challenge were concluded on March 2024.

First batch of Weapon Systems branch cadets completed their Stage-I training at Air Force Academy in June 2024. The cadets are undergoing Stage-II training at the newly raised Weapon Systems School in AF Station Begumpet. This is the first time since independence that a new operational branch has been created in the IAF.

This will go a long way in achieving Aatmanirbharta in the air armament domain and reduce foreign exchange spending of the nation.

Weather Information and Network Data Systems (WINDS) envisages setting up Automatic Weather Stations (AWS) at block level and Automatic Rain Gauges (ARGs) at panchayat level. Under WINDS, 5 times increase in current network density is envisaged to develop hyper local weather data. Under the initiative, only data rental costs are payable by Central and State Governments. 9 Major States are in the process of implementing WINDS (namely Kerala, Uttar Pradesh, Himachal Pradesh Puducherry, Assam, Odisha, Karnataka, Uttarakhand & Rajasthan are in progress), while other States have also expressed willingness to implement.

WINDS could not be implemented by States during 2023-24 (1st year as per EFC) due to various background preparatory and planning work required before tendering. Accordingly, the Union Cabinet has approved 2024-25 as the first year of implementation of WINDS as compared to 2023-24 earlier to give benefit to State Governments with higher central fund sharing in 90:10 ratio.

ACB J&K Transitions To Electronic Challan System For Enhanced Transparency



SRINAGAR: The Anti-Corruption Bureau (ACB) of Jammu and Kashmir is taking a significant step towards enhancing transparency and efficiency in its operations by transitioning to a fully electronic challan system.

Effective January 1st, 2025,

all ACB branches will discontinue the use of manual registration of FIRs and submit their respective challan electronically through the Crime & Criminal Tracking Network and System (CCTNS), a statement issued to the news agency—Kashmir News Observer (KNO) reads.

This initiative aims to streamline the challan filing process, improve record-keeping, and facilitate faster case management. All Investigating Officers (IOs) within the ACB will be required to submit specific forms within the CCTNS system for each case challan.

To facilitate this transition, CCTNS labs have been established in all eight ACB police stations across Jammu and Kashmir. Additionally, 18 officials have undergone training to ensure smooth operation of the CCTNS platform.

Stoinis, Lawrence fifties deliver Stars' first win of the season

elbourne Stars have broken an eightgame Big Bash League [BBL] losing streak thanks to a Marcus Stoinis batting masterclass and a stunning Glenn Maxwell catch in the outfield. Stars defeated defending champions Brisbane Heat

by five wickets at the Gabba in a breakthrough win after losing their opening five games this season and the final three of last year's campaign.

Heat made 149 for 7 batting first thanks to a blistering and unbeaten 77 off 48 deliveries by Max Bryant, during which Maxwell took one of the greatest catches seen in the BBL in an all-round brilliant individual fielding exhibition.

The hosts had the perfect start to Stars' run-chase with fast bowlers Xavier Bartlett and Spencer Johnson rocking the top-order to have the visitors teetering at 14 for 3.

Stars needed someone to stand up and Stoinis (62 off 48) and England import Dan Lawrence (64* off 38) delivered in a 132-run partnership for the third wicket.

Stoinis walloped Paul Walter for four fours in one over and paced the chase perfectly, bludgeoning anything loose to secure his first win this season as Stars captain. Lawrence upped the ante at the end to take the pressure off Stoinis in an innings of class.

Maxwell has done a plethora of freakish acts of genius in T20 cricket but he took it to the next level with a classic catch for the ages, his fourth for the innings.

The 36-year-old leapt metres over the long-on boundary to catch the ball in one hand before throwing it back into the field of play while in the air. He then calmly stepped back over the boundary rope to complete the catch and send a stunned Will Prestwidge (4) on his way.

Konstas' Audacious Knock At Mcg Unlikely To Become A Blueprint: Carey

ustralian wicketkeeper-batter Alex Carey said on Wednesday that he was mesmerised by the way young opener Sam Konstas $\,$ scored an audacious half-century in the Boxing Day Test against India but insisted that it was unlikely to become a "blueprint" for future matches.

Making his debut in front of a near sell-out crowd at the MCG on December 26, 19-year-old Konstas didn't show any nerves during his scintillating 60 off 65 balls, which was studded with two sixes off India's best bowler Jasprit Bumrah.

"I was a spectator that first session," Carey told reporters ahead of the fifth Test against India beginning at the SCG on Friday.

"I probably had the emotions of the 90,000 (spectators) that were there. At times I couldn't watch it, at times I was cheering," said Carey.

Konstas, who was handed the Test cap after Nathan McSweeney's unimpres-



to Australia's batting but Carey said he didn't expect the teenage opener to go all guns blazing in every match he plays.

"Just the energy he brought, it was something different. Probably wasn't expecting that amount of difference, but he played a style of cricket that was probably new to India as well.

"We'll wait and see how he plays out here (SCG). I don't think that's his blueprint every Test match, but to be able to throw a few punches early and get a bit of momentum for us, the opening partnership was probably just lacking that intensity." he added.

He said that while the opening pair in the first three Tests, McSweeney and Usman Khawaja, had done a decent job in "tough situations", Konstas brought something more to the table. "I thought Nathan and Usman got us through tough situations as well by facing

lots of balls. Sam was able to score a little bit, so hopefully another opportunity in front of his home fans."

Carey also rejected talk of any animosity between Konstas and Virat Kohli after their brief physical altercation on the opening day of the Boxing Day Test, which led to the Indian stalwart coping a 20 per cent fine on his match fee.

Both players quickly turned around to glance at each other and engage in a heated exchange of words before Khawaja stepped in to separate them. The on-field umpires also had a word with the two.

"Not that I'm aware of... I think I saw a photo of them shaking hands and a little tap on the back. It's Test cricket. I'm not 100 per cent sure, but Sam didn't take it to heart," said Carey.
