

# **Two HMPV Cases Confirmed In Karnataka: ICMR**



NEW DELHI: The Indian Council of Medical Research has detected two cases of Human Metapneumovirus (HMPV) in Karnataka through routine surveillance for multiple respiratory viral pathogens, the Union health ministry said on Monday.

A three-month-old female infant with a history of bronchopneumonia was diagnosed with HMPV after being admitted to Baptist Hospital in Bengaluru. She has already been discharged, the ministry said.

An eight-month-old male infant with a history of bronchopneumonia tested positive for HMPV on January 3 after being admitted to Baptist Hospital. He is now recovering, it said. It is important to note that neither of the patients have any history of international travel, the ministry underlined.

It emphasised that HMPV is already in circulation globally, including in India, and cases of respiratory illnesses associated with it have been reported in various countries.Furthermore, based on the current data from the Indian Council of Medical Research (ICMR)

and the Integrated Disease Surveillance Programme (IDSP) network, there has been no unusual surge in Influenza-Like Illness (ILI) or Severe Acute Respiratory Illness (SARI) cases in the country, it added.

The World Health Organisation (WHO) is already providing timely updates regarding the situation in China to further inform the ongoing measures. The recent preparedness drill conducted across the country has shown that India is wellequipped to handle any potential increase in respiratory illnesses and public health interventions can be deployed promptly if needed, the ministry stated.

Amid reports of rising cases of respiratory illnesses in China in the past few weeks, a meeting of the Joint Monitoring Group (JMG) was held under the chairmanship of the Directorate General of Health Services (DGHS) on Saturday.

# Protesting farmers to meet high-powered committee today, SC told

**NEW DELHI**: A delegation of the protesting farmers at the Khanauri border between Punjab and Haryana will be meeting the high-powered committee appointed by the Supreme Court at around 3 pm Monday.

Among the protesting farmers is also septuagenarian Jagjit Singh Dallewal, who has been on an indefinite fast for the past 40 days, and whose health concerns has kept the Punjab government on toes with the top court keeping a close watch.

A bench of Justices Surya Kant and N Kotiswar Singh was informed by senior advocate Kapil Sibal, appearing for the Punjab government that they had managed to persuade the protesting farmers to meet Justice (retd) Nawab Singh, who chairs the committee.

"We have managed to persuade them. Kindly post the matter for some other day. We are expecting some breakthrough," Sibal said.

"Hope better sense prevails on everyone," the bench said.



The apex court asked Sibal to prepare a brief note of the deliberations and posted the hearing on January 10.

Solicitor general Tushar Mehta, representing the Centre, said the committee would file a brief note on the meeting's outcome.

Justice Surya Kant agreed and said it was expected that the committee filed a note.

# Barred by jurisdiction: Lokpal disposes of corruption complaint against ex-CJI Chandrachud

**NEW DELHI:** The anti-corruption ombudsman Lokpal has disposed of a complaint alleging corruption against former CJI DY Chandrachud for being "barred by jurisdiction", according to an official order.

A complaint was filed on October 18, 2024, "against the sitting Chief Justice of India (CJI) as on that date, for alleged abuse of office, amounting to corruption and malicious exercise of power to favour and protect a certain politician and political party", it said. CJI Chandrachud demitted office

on November 10.

The Lokpal, in its order, examined in detail if a sitting CJI or a Supreme Court judge was amenable to its jurisdiction under Section 14 of the Lokpal and Lokayuktas Act and decided to "eschew from dilating upon the diverse allegations contained in this complaint running into 382 pages".

"We say no more," according to the order dated January 3.

"In light of the above, we dispose of this complaint as being barred by jurisdiction," said the order by Lokpal chairperson Justice AM Khanwilkar and five other members.

The order said the complainant was free to pursue other remedies, as permissible in law.

"We may not be understood to have expressed any opinion on the merits of the allegations, one way or the other including about the maintainability of the legal remedies to be resorted to by



the complainant," it added.

The Lokpal examined different provisions under Section 14 -"jurisdiction of Lokpal to include prime minister, ministers, members of Parliament, groups A, B, C and D officers and officials of central government" - of the Act.

"The textual and even contextual interpretation of this provision would lead us to the conclusion that only the persons referred to with their designation or description in this provision, have been made amenable to the jurisdiction of the Lokpal, as being a public servant against whom the Lokpal is bestowed with the duty to inquire or cause an inquiry to be conducted into any matter involved in, or arising from, or connected with, any allegation of corruption within the

meaning of provisions of the Prevention of Corruption Act, 1988 (for short, PC Act 1988), made by way of a complaint to the Lokpal," it said.

Indubitably, a sitting judge or CJI would not come within the ambit of clauses (a) to (e), (g) and (h), the order said.

"The only expansive clause that may come into play is Clause (f), which, however, predicates that any person who is or has been a chairperson or member or officer or employee in any 'body' or board or corporation or authority or company or society or trust or autonomous body (by whatever name called) 'established by an Act of Parliament' or wholly or partly financed by the central government or controlled by it," it said.

At first impression, there can be no

debate about the fact that the Supreme Court is a body of a group of judges associated for common purpose or object, the order said.

'The judges, generally including that of the Supreme Court, also come within the ambit of expression of public servant within the meaning of Section 2(c) of the PC Act," it said.

The judge of a court would not come within the excepted category of public servant in respect of whom jurisdiction is exercisable by any court or other authority under the specified acts, the order said.

"In that sense, the judge of any court would be a public servant and also can be proceeded with for having committed an offence of corruption, including under the PC Act, as ordained by the Constitution Bench of the Supreme Court, in K Veeraswami vs Union of India and Ors...," it said. The moot question is "whether the Supreme Court of India is a body established by an 'Act of Parliament'", the order said and added the expression used in Section 14 of the Act was very definite and did not leave any room for interpretation.

"We need to remind ourselves of the cardinal principle of interpretation of statutes that while interpreting any penal statute, strict interpretation must be preferred," it said.

"In other words, it will have to be first explored whether it is open to take the view that the Supreme Court of India has been established by an 'Act

of Parliament'. To this, the answer is an emphatic 'NO'. For, the Supreme Court of India has been established by virtue of Article 124 of the Constitution of India," it added.

Suffice it to observe that the Supreme Court, even though a body of judges, does not come within the ambit of expression "body" employed in Section 14(1)(f) of the Act, as it is not established by an "Act of Parliament" as such, the order said.

Further, the Supreme Court is neither wholly or partly financed by the central government or controlled by it as such, it said. The same logic must apply to the judges of the Supreme Court or the CJI, namely, as not being wholly or partly financed by the central government or controlled by it as such, the Lokpal said.

"As a concomitant to this view, it must follow that the sitting judge of the Supreme Court or the Chief Justice of the Supreme Court will not be amenable to the constricted jurisdiction of the Lokpal of India in terms of Section 14 of the Act of 2013," the order said.

The anti-corruption ombudsman, however, clarified that the view "propounded hitherto" was only to consider the status of the judges and the CJI of the Supreme Court, having been established by virtue of Article 124 of the Constitution.

"This view may not squarely apply to the judges of the other courts, including high courts...," it added in the order.

NEW DELHI: Actor-filmmaker Kangana Ranaut shared the trailer of her much awaited film "Emergency" on Monday, calling the journey to the release of the political drama a long one "filled with challenges".

Starring Ranaut as former prime minister Indira Gandhi, the film missed out on its September 6, 2024 release date as it was unable to obtain the clearance certificate from the Central Board of Film Certification (CBFC).

"Emergency" was mired in controversy after Sikh organisations, including the Shiromani Akali Dal, accused it of misrepresenting the community and getting facts wrong.


Ranaut, who also serves as director and producer on the film, said she is looking forward to its release on January 17.

# India's Groundwater Revival

Groundwater, often termed as the "invisible resource," is an indispensable pillar of India's water security. It sustains millions of lives, bolsters agricultural productivity, and powers industries. Yet, its overextraction and contamination have posed serious challenges. Against this backdrop, the recent advancements in India's groundwater recharge and management highlight a crucial turning point in the nation's journey toward sustainable water usage. The National Compilation on Dynamic Groundwater Resources, 2024, marks a significant achievement. With a total annual recharge assessed at 446.90 Billion Cubic Meters (BCM), the increase of 15 BCM compared to 2017 reflects the success of concerted efforts in water conservation and recharge initiatives. The decline in groundwater extraction by 3 BCM during the same period is equally noteworthy, signaling a positive shift in usage patterns. These improvements are largely attributed to the proliferation of conservation structures like tanks, ponds, and water control systems, which have consistently contributed to groundwater recharge. Encouragingly, the percentage of "safe" assessment units has risen to 73.4% in 2024, a marked improvement from 62.6% in 2017, while overexploited units have significantly declined. However, ensuring the quality of groundwater remains as critical as its availability. India's comprehensive approach to groundwater management is commendable. Initiatives like the Jal Shakti Abhiyan, Atal Bhujal Yojana, and Mission Amrit Sarovar have not only increased awareness but also driven impactful actions at grassroots levels. Despite these strides, challenges persist. Groundwater extraction still outpaces recharge in many regions, and contamination continues to threaten water quality. Addressing these requires a multi-pronged approach involving stricter regulations, advanced technologies, and widespread community engagement.

Prime Minister Narendra Modi's call to "Reduce, Reuse, Recharge, and Recycle" encapsulates the ethos needed for this mission. India's progress in groundwater revival is a beacon of hope, demonstrating that sustainable practices and proactive policies can yield transformative results. By maintaining this momentum, the nation can ensure a water-secure future, safeguarding this vital resource for generations to come.

Growers highlight increased yields, economic benefits in high-density farming after plantation and are typically **Pulwama:** In a groundbreaking harvested in November, which development, the Shahoora area in south sometimes exposes growers to damages due to untimely snowfall. However, high-density apples are harvested in August and are supported by facilities that protect them from hailstorms and

> Javid Ahmad, who has high-density apples on around 8 kanals of land in the Shahoora area, said this farming method



has benefits. "We have prepared fresh 12 kanals and are going for high-density apple farming as it requires low input and labour costs. The quality of such apples is also high, with uniformity in colour and size," he said.

Some of the high-density apple varieties grown in J&K include Jeromine, King Roat, Gala Scarlet, Red Velox, Scarlet Spur-II, Super Chief, Redlum Gala and Auvi Fuji.

The growers added that high-density apples fetch higher market rates compared to traditional varieties, often earning double the returns. "You don't need to wait for decades to get fruit. In the very first year, high-density plants start bearing fruits with a bumper crop every year. It also requires less fertiliser and pesticides," lavid said.

Farooq Ahmad, another grower, said that only in Niloora village of Shahoora, over 10,000

> high-density plants are being planted this vear. while around 5,000 were planted last year. "Other villages in the area are also converting hundreds of kanals of land

into high-density apple orchards," he said. Officials said the shift toward highdensity orchards involves innovative planting techniques, advanced cultivation methods, and the incorporation of cuttingedge technology.

This transformative approach is attracting attention from apple enthusiasts and industry experts alike," they said, adding that farmers are recognising the potential for enhanced productivity and

One grower shared his success story: "I planted high-density apples on around 3 kanals of land and fetched over 8 lakhs in just two years. The same land would have generated 8 lakhs from paddy cultivation over 100 years.

Horticulture officials told KNO that around 1,500 hectares of land have been brought under high-density apple farming in J&K so far, and efforts are underway to increase this to around 5,500 hectares in the coming years. They noted that a 50 per cent subsidy is provided to orchardists who establish or switch to high-density fruit production.

In September 2015, the then I&K Chief Minister Mufti Mohammad Sayeed inaugurated the erstwhile State's firstever high-density apple orchard at Bamdoora in south Kashmir's Anantnag district.

Kashmir produces over 20 lakh metric tonnes of apples annually, with some years reaching 25 lakh metric tonnes. According to the 2017 economic survey in J&K, half of Kashmir's population is directly or indirectly dependent on the apple industry, with over 3.5 lakh hectares under apple cultivation.

Horticulture contributes significantly to the state's Gross Domestic Product (SGDP), accounting for about 9.5 per cent. The sector also generates around 8.50 crore man-days of employment in J&K every year-(KNO)

Kashmir's Pulwama district is rapidly transforming into a hub for high-density apple varieties, reshaping the traditional Hundreds of growers from the Litter other climatic challenges. Tehsil of Pulwama district are converting

their land to cultivate a diverse range of premium apples, which promises not only increased yields but also unique flavours and textures.

Growers from the Litter area of Pulwama told the news agency-Kashmir News Observer (KNO) that a few farmers initially planted high-density varieties and earned handsome returns. Inspired by their success, many more have now prepared land on a large scale to plant high-density apple varieties.

This area, which traditionally did not have any apple orchards, saw some people converting their paddy land into highdensity apple orchards. After the experiment yielded grand success, almost everyone in the area started adopting high-density apple farming.

The growers said these new varieties of apples were introduced in Kashmir after 2015. The standout feature of these apples is that they begin bearing fruit just a year after plantation and reach full production in the fourth or fifth year.

They said traditional apple trees start bearing fruit at least ten years

Help With Multiple Sclerosis?



### What is multiple sclerosis?

ultiple sclerosis (MS) is a potentially disabling disease of the central nervous system (CNS) that results in chronic inflammation. The cause of MS is currently unknown, but it is thought to be autoimmune. With MS, the immune system attacks the CNS, specifically the myelin sheath that surrounds the nerves. This causes lesions and inflammation, which leads to symptoms such as:

Chronic pain. Fatigue. can be of use. Studies on caffeine and MS are promising and many show that regular caffeine use in the form of coffee consumption is associated with a lower risk of MS and other neurodegenerative diseases.

### Supporting research

Many studies have shown that caffeinated coffee has neuroprotective properties and lowers the production of inflammatory chemicals in the body called cytokines. Researchers are not positive that the effects seen are the result of caffeine only, as coffee contains many other antioxidants. Headaches; Dehydration; Anxiety; Increased heart rate; Dependence. MS symptoms and caffeine The studies have varied results but overall, they

tend to show a positive benefit for people with MS. Caffeine intake may reduce inflammatory chemicals in the body, which could lead to less severe symptoms. Caffeine intake may have the following effects on MS symptoms:

Symptoms usually come and go over the years and are dependent on where the nerve damage has occurred. Multiple sclerosis affects 2.5 million people worldwide and is more common in women. There is no cure for MS, but medication can delay the progression of the disease and lessen the severity and frequency of relapses.

There are over a dozen disease-modifying therapies (DMTs) currently authorized for people with MS, but most patients still live with chronic symptoms. Fatigue is a very common symptom for people with MS, with nearly two-thirds of people reporting it. More therapies are needed. Scientists have been studying the effect caffeine has on MS-related fatigue and other symptoms. The results are promising.

### Are caffeine and MS connected?

Caffeine is a substance found naturally in more than sixty different plants, including coffee beans, tea leaves, and cacao pods (chocolate). It is also a central nervous system stimulant that can make you feel more alert and energetic. In addition, caffeine causes increased urination, higher levels of stomach acid, and higher blood pressure. Coffee has over 1,000 bioactive compounds but caffeine is one of the major components. Studies show that caffeine acts as an antioxidant and has anti-inflammatory properties. Since MS is an inflammatory condition, caffeine might be helpful.

Caffeine is absorbed by the small intestine within 45 minutes and can stay in your bloodstream for up to 7 hours. It is widely used, mostly in the form of coffee, tea, soft drinks, and energy drinks. Caffeine has many benefits. It is considered to be neuroprotective and anti-inflammatory, which may lower the risk of cognitive decline and help with fatigue. Unlike most molecules, caffeine can cross the blood-brain barrier. This allows caffeine to enter the brain and affect neurotransmitters (chemical messengers in the brain). This is one of the reasons it is being studied in patients with MS.

No drug has ever been able to reduce inflammation at the source, so some researchers have turned to bioactive compounds found in nature to see if they Studies show that coffee drinkers may be less likely to develop MS than people who don't drink coffee. One study found that people who drank three cups of coffee a day were 30% less likely to develop MS than people who didn't drink coffee. The researchers pointed to the caffeine in coffee that was most likely responsible for the difference. The lowered risk of MS was found for people who began drinking coffee with caffeine at diagnosis and also for people who had been drinking it for years.

Another study looked at the effect coffee had on people with MS. This study found that drinking caffeinated coffee resulted in positive benefits in their daily routines. The positive benefits were higher in patients with lower disability scores. The participants experienced the following benefits from using caffeine:

Higher levels of concentration when working. Longer attention span.

A more satisfying daily routine with increased structure.

Researchers noted that patients with milder symptoms may be able to, "Benefit from the effects of coffee consumption due to their still preserved cognitive reserves." The study also demonstrated no serious side effects or sleep disturbance in participants who drank caffeinated beverages. Experts aren't sure exactly how caffeine seems to have a protective effect and no negative link has been found between caffeine and MS.

Scientists have not found the mechanism by which caffeine improves fatigue in patients with MS, but they suggest that it may be useful as a therapeutic approach if other treatments for fatigue have failed. Research on caffeine and MS is ongoing.

### Possible side effects of caffeine

Drinking caffeinated beverages may be a good addition to your lifestyle if you have MS, but keep in mind that not everyone can tolerate caffeine well. Some people experience the following symptoms after drinking high levels of caffeine:

Insomnia; Restlessness; Dizziness; common symptom of MS. Experts recommend that if you're going to drink caffeinated beverages, do it earlier in the day because caffeine can interfere with your sleep;

Brain fog. Caffeine is widely known to increase mental alertness. It may help people with MS to feel more awake and focused;

Constipation. This is a common symptom for people with MS. Coffee, a good source of caffeine, is known to activate the bowel. This may be helpful in reducing the occurrence of constipation;

Other symptoms. Some people with MS have reported an increase in nausea and heat intolerance after the effects of caffeine have worn off.

Additional studies are needed, but caffeine seems to be a safe choice for people with MS and may even provide some benefits. It may be especially helpful with fatigue. Caffeine is associated with few harmful effects and only in higher doses. If you have MS, speak with your healthcare provider if you choose to include caffeine as part of your diet. messengers in the brain). 'The development of railways is creating lakhs of job opportunities. In the last 10 years, lakhs of youth have been employed in the railways, and initiatives like Gati Shakti University will further enhance the workforce's skillset," he said.

Referring to the strides in high-speed train services, PM Modi noted that more than 50 Vande Bharat trains are now operational, connecting long distances in shorter times and setting a benchmark for modern Indian trains.

"The time is not far when bullet trains will traverse across the country, making railway journeys memorable," he added.

PM Modi emphasised that the railways are undergoing a transformation with the promotion of Made in India. "Modern coaches are being developed for metros and railways. their sobs and wails breaking the sombre silence. Hundreds joined the funeral procession of the deceased, braving the winter chill to pay their last respects.

"We have lost an entire family. Ajaz, who was working at a renowned hotel in Srinagar for several years was the backbone of his household. His children were so young, full of life. This is an unimaginable loss," Bashir Ahmad, a neighbour said. "Ajaz was the sole breadwinner for the family and an honest, hardworking man who dreamt of a better life for his children. However, fate has something else in store for him and his family."

Villagers expressed their grief and anger. They urged authorities to step up efforts to prevent such tragedies in the future. "Many families in Kashmir rely on firewood or coal for heating during winters. This isn't the first time such an incident has happened. Authorities must create awareness about safer heating options," said a relative of the deceased.

Local representatives urged authorities to provide financial and emotional support to Aijaz's paralysed father and ailing mother. "We appeal to the administration to come forward and assist Ajaz's elderly parents. They are shattered beyond repair," they said.

The incident occurred on Sunday evening, with the senior police official stating the family was discovered unconscious late at night in rented accommodation at Pandrethan after reportedly inhaling toxic fumes from a heating appliance.

Meanwhile, Chief Minister Omar Abdullah, MLA Uri, Sajad Shafi, Health Minister Sakina Itoo and others expressed their profound grief over the tragedy. They conveyed their deepest condolences to the bereaved relatives, praying for strength and patience to help them cope with this irreparable loss.

# **Unvented** gas

Dr Murtaza Ahmad, a doctor at the Directorate of Health Services Kashmir (DHSK), speaking with the news agency–Kashmir News Observer (KNO) said that unvented gas heaters emit combustion byproducts like carbon monoxide, which can accumulate to lethal levels in poorly ventilated rooms. "Carbon monoxide poisoning is a grave risk associated with these heaters. The best way to prevent such deaths is to stop using unvented gas heaters altogether and switch to vented alternatives," he said.

Dr Ahmad said that if unvented gas heaters are still used, they should only be operated in rooms with adequate ventilation and never in bedrooms, bathrooms, or enclosed spaces. "These heaters lack a chimney to vent harmful combustion products outside. As a result, toxic pollutants like carbon monoxide remain inside the room, posing a severe threat," he explained.

In a first, Kupwara was selected from J&K in a pilot phase of PMGS District Master Plan to adopt it at district level. The same model in future is going to be adopted by other districts as well.

As far as the performance of different departments is concerned H&UDD and Jal Shakti Department were said to stand as major achievers in the UT with all of their assets mapped. It was further given out that all the departments had almost mapped their offices and other major assets over the UT Master Plan portal.

It was further revealed that 50 projects across 10 departments had been discussed in TSU/NPG meetings till date. Orientation session and portal demonstration on project planning was also held earlier in 2024 for the understanding of nodal officers. As far as the future prospects of the PMGS is concerned it was given out that the integration for

# South Africa seal ten-wicket win despite Pakistan's great resistance

South Africa's target of 58 was little more than a formality

South Africa 615 (Rickelton, Bavuma 106, Verreynne 100, Abbas 3-94) and 61 for no loss (Bedingham 47\*) beat Pakistan 194 (Babar 58, Rabada 3-55) and 478 (Masood 145, Babar 81, Rabada 3-115) by ten wickets

outh Africa marked their qualification for the WTC final in style, romping to a ten-wicket win over Pakistan. It is their seventh successive Test win. and came after two and a half days of toil with the ball before they finally prised Pakistan out for 478 in the third innings. A valiant century from Pakistan captain Shan Masood and numerous other contributions forced South Africa to bat again as the visitors overcame the second-highest first-innings deficit in Test history. However, the target - 58 - was little more than a formality, and South Africa took 7.1 overs to knock it off.

But Pakistan made them wait for the win. When South Africa enforced the follow-on leading by 421 on Sunday afternoon, they did not anticipate having to bowl another 122.1 overs. Masood, unbeaten overnight on 102. carried on and tried to rebuild after a mammoth 205-run opening stand with Babar Azam. South Africa were frustrated for large parts of the day, most notably during an 88run stand between Mohammad Rizwan and Salman Agha in the afternoon. But Keshav

Pakistan overcame a deficit of 421 but Maharaj, who had been denied for most of the wickets came to pace. the day, found the breakthrough, and regular wickets after that ensured a finish was on in the late-evening sunshine.

Earlier in the day, Marco Jansen got night-

Shahzad had done his job and never quite looked equipped to carry on too long. When a length ball from Jansen grew too big on him, he chipped it straight to Maharaj at point. Ghulam watcher Khurram Shahzad out early on before never quite appeared to settle, keeping the slip

Rabada cleaned up Kamran Ghulam. Maharaj more or less bowled through the entire session, interrupted only when he switched ends at one point. His variations in pace and flight, as well as a ball that continued to turn, posed the most significant threat to the batters, but

Just after overstepping, he found a beauty that nipped back off the seam into Ghulam, pegging back his middle stump. It was an excellent way to bring up his 50th Test wicket at Newlands, with the roar that followed it making clear how much it meant to him.

Saud Shakeel and Masood continued to make South Africa work for each scalp, and yet South Africa could have had one more before lunch. Kwena Maphaka squared Shakeel up with a lovely delivery that straightened as it hit the pad, only for South Africa to opt against a review. As Shakeel received extensive treatment for the blow, Hawk-Eye showed it was hitting leg stump.

Masood's vigil at the crease ended in somewhat contentious circumstances. Maphaka got one to shape away off the seam that kept low before cannoning into the batter's front pad. Umpire Nitin Menon felt it was missing off stump, but when South Africa reviewed, Hawk-Eye showed it hitting. It prompted a furious response from Masood, whose protests continued all the way along his slow walk off the crease and into the dressing room.

It capped a bright first hour post lunch for South Africa. Shakeel had been dispensed with shortly after play resumed in much the same way he fell in the first innings: nicking off into the slips while drove at Rabada. With Masood departing, there was a danger Pakistan might crumple in a heap, as they have tended to recently.

ndia's regular captain Harmanpreet Kaur and fast bowler Renuka Singh have been rested for the three ODIs against Ireland, set to begin on January 10 in Rajkot. Smriti Mandhana has been named captain in Harmanpreet's absence, while Deepti Sharma is the vice-captain.

Raghvi Bist and Sayali Satghare have been called up for the series, while the likes of Arundhati Reddy, Shafali Verma and Radha Yadav continue to miss out. Bist recently made her T20I debut in the T20I series against West Indies in Navi Mumbai in December last year, where she played two games and made scores of 5 and 31. Satghare, meanwhile, received her India call-up for the ODIs against New Zealand in October 2024, but did not get a game.

Pratika Rawal and Tanuja Kanwar, who made their India debuts in the West Indies ODIs in Vadodara, keep their places in the squad.

Mandhana also stood in as captain when Harmanpreet sat out of the last two T20Is against West Indies. Harmanpreet, however, returned for the ODIs, making 88 runs in three matches.

Shafali, who was dropped for the series against Australia and West Indies late last year, misses out on selection despite finishing as the top run-getter in the Senior Women's One-Day Trophy that concluded on December 30. She scored 527 in seven games at 75.29, including a 197 against Bengal. More recently, on January 5, she scored a match-winning 91 off 71 halls for Team A in the chase against Team B in the ongoing One Day Challenger Trophy.

The India vs Ireland series, part of the 2022-2025 future tours programme, will be Ireland's first-ever bilateral tour of India, and the teams' first series against each other since 2006. Ireland have lost all of the 12 ODIs they have played against India so far. The sides last met in the T20 World Cup in 2023, when India won by five runs.



# Cummins likely to miss Sri Lanka tour but no end in sight for captaincy

here's no end in sight for Pat Cummins' captaincy as he prepares to put family first and skip his first full tour since taking over from Tim Paine four years ago.

Sunday's six-wicket win over India at the SCG on Sunday sealed the Border-Gavaskar Trophy and ensured Australia own every bilateral trophy for which they compete, capping a superb run for the team under Cummins.

With ODI and T20 World Cups also captured in that time, Cummins was asked after the SCG win if he felt he "had completed cricket".

Cummins will likely miss Australia's next tour, admitting on Sunday he "likely might struggle" to play in Sri Lanka as he awaits the birth of his second child.

Steven Smith is expected to return to the captaincy in his place, having already filled in four times previously in the past four years. But in the long run, Cummins is still driven and in no way feels as if his job as captain has been finished.

"First of all, I absolutely love what I do. That's the biggest driver in wanting to play Test cricket and work with this team and support staff," Cummins said. "I absolutely love everything about it; it's that much fun. If I can keep doing it for a while, even better."

The transition of the Test team has been a key talking point for the past year, with Sam Konstas the only player in the fifth Test side under 30. But Cummins still has several years left in him with a mega 2027 on the horizon, which includes away Test tours of India and England, despite him initially hinting at a shorter tenure when he took over in 2021.

"You always talk about [succession]. We have two vice-captains in the team. We have had three debutants in this series," Cummins said. "You're always balancing between the here and now, but have a bit of an eye towards the future.

"They are conversations we always have, but I don't think there is any point in doing things for the sake of it. Those can play out over the next few years."

Cummins' leadership in the 3-1 Border-Gavaskar trophy triumph was immense.The Australian team under his watch has often become a target for criticism, of which there was plenty after they were thrashed by 295 runs in the series opener.

Claims of fractures in the team were known to have frustrated players, after press-conference comments from Josh Hazlewood were picked apart by sections of the media. The team's preparation also came under the microscope, after Cummins and other players skipped white-ball matches in the lead up to the Tests.

But Cummins pulled the right rein at almost every opportunity after Perth, with his captaincy at its peak in the final-hour win at the MCG last week.

"When you start a series behind, a lot of things get questioned, fairly and unfairly," Cummins said. "But I think it shows a strength of the group to stay strong. Know we weren't at our best but we can be better."
