SRINAGAR: Prime Minister Narendra Modi is scheduled to visit Jammu and Kashmir on January 13 to inaugurate the Z-Morh tunnel on the Srinagar-Sonamarg road to make Sonamarg an all-weather tourist destination.

Official sources said that the PM will arrive here on January 13 to physically inaugurate the Z-Morh tunnel that will bypass the road from Gagangir to Sonamarg allowing visitors and locals to

visit the hill station throughout the year. At present, the Gagangir-Sonamarg

The Z-Morh Tunnel is a 6.5 km long 2-lane road tunnel between Gagangir and Sonamarg in the Ganderbal district of Jammu and Kashmir. It is named after the Z-shaped stretch of road that the tunnel has replaced (Z-Morh translates to "Z-turn" in English).

## 2025 Begins With 59 % **Deficit Rainfall In J&K**

**SRINAGAR**: The New Year–2025 has begun with the deficit precipitation as Jammu and Kashmir has recorded a deficiency of 59 per cent in the first week of January.

According to the details available with the news agency-Kashmir News Observer (KNO), from January 01 to January 08, J&K has recorded a deficit rainfall of 59 per cent despite the recent snowfall in most parts of the Valley. Against the normal rainfall of 18.4 mm, J&K has recorded

#### a precipitation of 7.6 mm.

Nine stations across J&K including the winter capital of the Union Territory-Jammu recorded large deficit rainfall. The large deficit rainfall is being marked from 60 per cent to 99 per cent.Four stations including the summer capital of Jammu and Kashmir, Srinagar have recorded the normal precipitation during the period. As per the details, Budgam and Ganderbal stations in central Kashmir saw large excess rainfall from January 01 to January 08.

## Court's Opinion V. Legislative Power: SC On CEC, Election Commissioners Selection

**NEW DELHI**: It will be court's opinion versus the legislative power to enact law, the Supreme Court on Wednesday said as it posted the pleas challenging the appointment of the chief election commissioner and election commissioners under the 2023 law on February 4.

Abench of Justices Surya Kant, Dipankar Datta and Uijal Bhuyan was informed by advocate Prashant Bhushan, representing an NGO, the incumbent Chief Election Commissioner (CEC) Rajiv Kumar was set to superannuate on February 18, and a new CEC would be appointed under the new law, if the court didn't intervene.

Bhushan said the top court in its the March 2 2023 verdict set up a panel comprising the Prime Minister, the Leader of Opposition and the CII to appoint the CEC and election commissioners (EC).

"However, under the new law the selection committee will comprise the Prime Minister, a union cabinet minister, the Leader of Opposition or the leader of the largest opposition party in Lok Sabha. They have removed CJI from the selection committee," submitted Bhushan.

While posting the hearing on February 4, the bench said it would see whose views had supremacy.

"It will be the opinion of the court under Article 141 versus legislative power to enact law," it underscored.

Senior advocate Gopal Sankaranaravanan. appearing for one of the petitioners, said the government did not remove the basis of the March 2, 2023 judgement, and enacted a new law.



Bhushan said the government couldn't control the appointment of election commissioners as it would be a threat to democracy.

"We are of the view that the government cannot remove the CII from the selection panel which was directed to be formed by the Supreme Court on March 2, 2023," he said.

Sankaranarayanan said the only way the Centre could have got around the judgement was by amending the Constitution and not enacting a law.

The bench asked Bhushan and Sankaranarayanan to remind the judges on February 3 for the matter

to be taken up the following day. On March 15, 2024, the top court refused to stay the appointments of new ECs under a 2023 law which excluded the CJI from the selection panel and deferred the hearing on a batch of pleas challenging the appointments.

The top court told the petitioners the March 2, 2023 verdict directed for the three-member panel comprising the Prime Minister, Leader of Opposition and the CJI to operate till Parliament enacted a law.Bhushan, who appeared for the petitioner Association for Democratic Reforms (ADR), challenged the CJI's exclusion and contended the Election Commission should be insulated from "political" and "executive interference" for maintaining a healthy democracy.

ADR's plea alleged the verdict was overruled by the Centre without removing its basis and the composition of the selection committee under the new law which amounted to excessive interference of the executive in the appointments and was detrimental to the independence of the poll panel.

Former IAS officers Gyanesh Kumar and Sukhbir Sandhu were recommended to be appointed as ECs in 2024 by a selection panel chaired by Prime Minister Narendra Modi under the new law.

The NGO challenged the validity and sought a stay on the operation of Section 7 of the Chief Election Commissioner and Other Election Commissioners Act, 2023, which excluded the CJI.

The apex court's March 2, 2023 verdict held leaving the appointment of the ECs and CEC in the hands of the executive would be detrimental to the health of the country's democracy and the holding of free and fair elections, it said.

Another petitioner, Congress leader Java Thakur from Madhya Pradesh, sought to restrain the Centre from appointing new ECs under the 2023 law while challenging its provisions.

The Constitution bench on March 2.2023, ruled. "As far as appointments to the posts of chief election commissioner and election commissioners are concerned, the same shall be done by the president of India on the basis of the advice tendered by a committee consisting of the Prime Minister of India, the Leader of Opposition in the Lok Sabha and, in case there is no such leader, the leader of the largest party in the opposition in the Lok Sabha and the chief justice of India."

### Lower GDP forecast: Mayawati urges Centre to focus on public welfare, shun 'narrow politics'

NEW DELHI: Bahujan Samaj Party chief Mayawati on Wednesday urged the Centre to prioritise national and public welfare over "narrow politics", after the government revised downwards the GDP growth estimate for the current fiscal.

Her remarks came at a time when the Indian rupee has hit a record low of 85.83 against the US dollar, and the GDP growth rate is forecast to drop to 6.4 per cent for 2024-25, the lowest in four years.

It is the slowest growth since the Covid pandemic year of 2020-21, when GDP recorded a negative growth of 5.8 per cent, significantly lower than the 8.2 per cent achieved in FY 2023-24.

## Aiming to produce 5 mn tons of Green Hydrogen by 2030: PM Modi

VISAKHAPATNAM (ANDHRA PRADESH) Prime Minister Narendra Modi on Wednesday said as part of National Green Hydrogen Mission, the country is aiming to produce 5 million tons of green hydrogen by 2030.

After virtually laying the foundation stone and launching projects worth over Rs 2 lakh crore here, Modi said two green hydrogen hubs will be set up in the country out of which one will come up here.

"The country launched the National Green Hydrogen Mission in 2023. Our aim is to make 5 million metric tons of green hydrogen production (annually) by 2030. As a first step, two green hydrogen hubs will be set up, out of which one is in Visakhapatnam," he said.

He further said as part of "Swarnandhra Pradesh", by 2047, Andhra Pradesh is aiming to become approximately a USD 2.5 trillion economy and the Center will work with the southern state in realizing that vision. Describing the state as



a "land of possibilities and opportunities", Modi said the time has come for it to become a centre of new futuristic technologies.

Union Home Minister Amit Shah had also sent a letter to chief ministers of all states and Union territories in this regard. The states and Union territories had actively participated in this exercise and had furnished the details of the number of prisoners who benefitted from the provisions of Section 479 of BNSS up to November 26, 2024.

However, the ministry has conveyed to the states that it was not a one-time exercise and the states and Union territories need to take advantage of the provisions of Section 479 of BNSS and provide the benefit of the same to all eligible prisoners on a continuous basis.

"The states and UTs are requested to provide details, as in the attached proforma, for the period November 27, 2024 to December 31, 2024, on urgent basis, whereafter a monthly report, even a NIL report, is to be provided to this ministry in the prescribed proforma, starting from January 1, 2025," the communication said.



#### 1984 Anti-Sikh Riots **Verdict In Murder Case Against** Sajjan Kumar Likely On January 21



NEW DELHI: A Delhi court is likely to deliver on January 21 its verdict in a 1984 anti-Sikh riots murder case against former Congress MP Sajjan Kumar. The case is linked to the alleged

killings of two men in the Saraswati Vihar area during the riots.

Special Judge Kaveri Baweja, who was scheduled to pass the order on Wednesday, deferred the pronouncement."January 21 is the next date," the judge said. Kumar, currently lodged in Tihar central jail, appeared before the court via videoconferencing.

The court had reserved the judgment after hearing the final arguments in the case related to the killings of Jaswant Singh and his son Tarundeep Singh on November 1, 1984.

Though the Punjabi Bagh police station initially registered the case, a special investigation team subsequently took over the investigation.On December 16, 2021, the court framed charges against Kumar, finding a "prima facie" case against him.According to the prosecution, a huge mob armed with deadly weapons, resorted to large-

#### Jal Shakti minister reviews Swachh ~~~ >>>> Bharat progress in Karnataka, Haryana

NEW DELHI: Union Jal Shakti Minister CR Patil on Tuesday conducted comprehensive review meetings of the Swachh Bharat Mission-Grameen (SBM-G) for Karnataka and Haryana, charting the way forward for rural sanitation and waste management.

The review meetings assessed the progress made by the two states in the 2024-25 financial year.

In his address, Patil lauded the states for their progress in achieving Open Defecation Free (ODF) Plus Model Village status, noting that 37 per cent of Haryana's villages and 18 per cent of Karnataka's villages had been declared **ODF-Plus Model** 

However, he emphasised the need to address

the remaining gaps. "Both Haryana and Karnataka must strive to become regional leaders in achieving the Swachh Bharat Mission goals. Sustaining these achievements and driving targeted interventions will ensure a cleaner and healthier environment

for rural communities," Patil said. Of Haryana's 6,619 villages, 97 per cent (6,419) have been declared ODF-Plus, with 2,500 villages achieving the ODF-Plus Model status. Of these, 1,855 villages have also been verified. The state has achieved 76 per cent Greywater Management (GWM) coverage in its villages

and implemented solid waste management in 65 per cent of villages.

Additionally, Haryana has reported 100 per




cent access to and usage of toilets, according to an official statement issued by the ministry. Efforts are on to ensure the functionality of

the Solid Liquid Waste Management (SLWM) assets and to conduct ground truthing to verify progress.

At the meeting, Patil urged Haryana to intensify its efforts to address gaps in the waste management systems.

Karnataka has also made notable advancements, declaring 4,873 villages as ODF-Plus Model, with 99.3 per cent of its villages managing solid waste effectively.

Karnataka has linked 1,905 villages to Faecal Sludge Management (FSM) systems. With a target of achieving ODF-Plus Model status for all 26,484 villages by March 2025, the state is on track to make significant progress, the statement said.

## **Committed to End TB** by 2025: NTEP team organises Nikshay Shivir in Border villages of Uri

BARAMULLA: In line with the national goal of eliminating tuberculosis (TB) by 2025, the NTEP Team Uri, under the guidance of the Chief Medical Officer (CMO) Baramulla and with the support of Block Medical Officer (BMO) Uri, organized a Nikshay Shivir in the border villages of Balkote, Hathlanga, and Mothal in Uri.

The camp witnessed encouraging response from the local population, providing free TB screening, diagnosis, and treatment to residents in these remote areas. A skilled team of doctors, nurses, and paramedics was deployed to deliver comprehensive medical services.

During the camp, 204 individuals were screened for TB. Out of these, 54 were tested using NAAT, 130 underwent X-ray examinations, and 18 were tested with Cy-TB. The initiative aimed to ensure early detection and timely treatment of TB cases in these underserved communities.

Speaking on the occasion, a retired teacher, expressed his gratitude to the district health administration for reaching out to these far-flung areas with much-needed healthcare services. He commended the efforts of the NTEP team for their commitment to public health.

While interacting with media, Dr. Iftikhar Ahmad, Nodal Officer for NTEP, assured that similar camps will be organized in every panchayat of Block Uri. He emphasized the importance of these camps in bridging the gap between rural communities and quality healthcare.

## Masjid, a fundamental Institution in Islam

The mosque has always been the heart of a Muslim community, serving as a sanctuary of unity, learning, and spiritual rejuvenation. From the humble structures of early Islam to the grand masjids of today, the essence carpets for comfort and during winters hot water while masjid hamaam provides comfort, warmth (A Hamam in Kashmiri refers to a heated room with limestone slabs over a hollowed floor, warmed by a fire beneath, traditionally used in mosques and shrines for warmth and ablution in winters.) of a mosque is through prayer, not its structure.'

"Duniyakebutkadonmein, pehlawohgharKhudaka, Hum us kepasbaanhain, wohpasbaanhamara." (Among the idol houses of the world, the first is the house of Allah al-Haram.

We are its guardians, and it is our protector.) This profound verse highlights the reciprocal relationship between believers and the mosque. It reminds us of our role as custodians, emphasizing that protecting and honoring this sacred trust safeguards our faith and identity.

A Space of Unity and Equality

Mosques are sacred spaces where worldly distinctions dissolve, and believers stand shoulder to shoulder in devotion to Allah. Allamalqbal eloquently reflects this egalitarian spirit in his couplet:

"Ek hi safmeinkharayhogayeMahmood o Ayaz, Na koi bandarahaaurna koi bandanawaz. Banda o sahib o mohtaj o ghaniek hue,

Teri sarkarmeinpohanche to sabhiek hue." (Sultan Mahmood and his servant Ayaz stood together in the same row.

No servant remained, nor did any master. The servant, the king, the needy, and the wealthy became one.

When they came into Your presence, all became equal.) This imagery underscores Islam's emphasis on equality, where the only distinction in Allah's sight is righteousness, as stated in the Quran:

"Indeed, the most noble of you in the sight of Allah is the most righteous of you." (Surah Al-Hujurat: 13). The Rights of the Mosque These blessings come with the obligation to ensure their sustenance.—how often do we consider our responsibilities toward it?

A mosque is not anyone's personal property; it is our collective heritage. Its protection, maintenance, and cleanliness are responsibilities that rest upon all of us. Here are key areas where believers can contribute: Financial Support:

Every worshiper should contribute a fixed monthly amount to the mosque, no matter how small. Consistent donations collectively ensure the mosque's upkeep. Maintenance and Cleanliness:

Participating in cleaning and maintaining the mosque is as important as monetary contributions.

Support for the Mosque Team: Those who dedicate their time to administrative and

fundraising efforts deserve the community's wholehearted support.

Just as we budget for household expenses like electricity, internet, and school fees, the mosque should be part of our financial priorities. The services we enjoy water, electricity, and cleanliness—require resources. It is our shared duty to provide them. A Call to Action

A mosque is not merely a place of worship but the foundation for strengthening community and society. It serves as a spiritual haven, a center of learning, and a hub for unity and support. However, its upkeep often goes unnoticed, depending entirely on the contributions of the faithful.

Supporting the mosque is not limited to financial contributions. Volunteering time and skills, organizing community events, and teaching younger generations the value of the mosque are equally important. Together, these efforts ensure that the mosque continues to enrich the lives of future generations. The mosque's True Beauty Despite all these efforts, the true adornment of a mosque lies in the establishment of prayer, as emphasized by our beloved Prophet (PBUH) in the hadith: 'The beauty Salah is profoundly emphasized in the Hadith: Sunan al-Tirmidhi (Hadith 2620):

"The covenant that distinguishes between us and them (disbelievers) is prayer; whoever neglects it has committed disbelief."

SunanIbnMajah (Hadith 1079):

"Between a person and disbelief is abandoning the prayer."

The detachment of Muslims from their mosques signifies a distance from Allah's mercy. This estrangement is one of the reasons why oppressor nations have gained dominance over us. Reflecting on the condition of Muslims and their relationship with mosques, Allamalqbal poignantly remarked:

'Masjid to bana di shabbharmeinimaankihararatwalon ne,

Mann apnapuranapapihai, barsonmeinnamazi ban nasaka.'

"Though the mosque was built overnight by the passionate believers,

Their hearts, tainted by old sins, could not become devout even after years."

This verse captures the irony of building magnificent mosques while neglecting the spiritual transformation that true devotion and prayer bring."

May Allah Almighty grant us the understanding that the mosque is not just a building but an integral part of our spiritual and communal life.

May He guide us to fulfill this sacred responsibility with sincerity, enabling us to prioritize Salah, revive the essence of mosques in our daily lives, and strive for spiritual and moral transformation? Only through such efforts can we hope to regain the honor and dignity that Allah has promised to those who adhere steadfastly to His commandments.



## **Satish Sharma calls on Union Minister Pralhad Joshi**

Holds discussion on augmentation of Renewal Energy, Solarisation, PDS in J&K

**NEW DELHI:** Minister for FCS&CA, Transport, Youth Services and Sports, Information Technology, Science and Technology, ARI & Training, Satish Sharma, today called on Union Minister for Food and Public Distribution, New and Renewable Energy, Pralhad Venkatesh Joshi, in New Delhi and had a detailed discussion on matters pertaining to consumer affairs, public distribution and renewal energy

The Minister discussed various matters of public interest including extension of Jammu Solarisation Scheme for two more years under which almost 50 thousand households have already been covered, necessary assistance for solarisation of all hospitals falling in border areas in the national interest besides solarisation of emergency/trauma centres in accident prone areas.

He also requested to increase 20 villages (one in each district) under Model Village Scheme and award one crore rupees for each such village for maximum solarization, sanction of 4000 more agricultural pumps under PM KUSUM Yojana for the benefit of farmers.

Regarding development of Solar Power Infrastructure, the Minister urged for establishment of large scale Solar Power Plants in regions of J&K where solar irradiance is high, financial and technical assistance for augmentation/implementation of rooftop solar installations across government buildings, educational institutions and residential areas under the Grid-Connected Rooftop Solar

Program, establishment of Solar Parks under Solar Energy Corporation of India (SECI) particularly in arid and barren lands of J&K, augmentation of ongoing PM Surya Ghar Muft Bijli Yojna across all parts of J&K.

JAMMU: Minister for Jal Shakti, Forest Ecology & Environment and Tribal Affairs, Javed Ahmad Rana, today chaired a meeting at Civil Secretariat here to review the functioning of tribal hostels in Jammu and Kashmir.

The meeting was attended by Secretary Tribal Affairs, Prasanna Ramaswamy G, Director, Tribal Affairs, Ghulam Rasool and other officers. The Minister had a detailed assessment of functioning of the hostels with emphasis on the staff strength, improving sanitation, dining facilities, digital classrooms, libraries and recreational spaces to foster academic and personal growth for hostel inmates.

The Minister said that the government has launched various schemes for the upliftment of tribals that envision saturation of critical gaps in social infrastructure, health, education and livelihood of tribal areas. He emphasised the need for coordinated efforts in effective implementation of schemes so that the benefits percolate to the last man.

The Minister asked the concerned officers to take up the matter of ongoing construction works in districts with the respective Deputy Commissioners so that all the projects are completed within the stipulated time frame.

Javed Rana also reviewed the expansion of Dharti Aaba Mission to all tribal villages, focusing on education, healthcare and livelihood opportunities. He took first hand appraisal about implementation of the scheme being executed for welfare of tribal people. He also discussed various aspects related to the scheme and other modalities for its successful execution to achieve the target. Secretary Tribal Affairs gave a brief about the functioning of tribal hostels across Jammu and Kashmir. He also highlighted various ongoing works being executed under UT Capex Budget 2024-25.

He informed that under UT Capex Budget, a number of works for up-gradation of G&B Hostels, construction of 100 bedded new Hostels, adequate electricity, water supply and connectivity to tribal villages, transit accommodation for migratory nomadic population, empowerment of unemployed, skill development, establishment of Animal/ sheep/goat units, establishment of smart classrooms/eclass rooms, creation of electric sub-station, installation of hand pumps, bore well have been taken up.

The Secretary said that during the current financial year 2024-25, the annual plan has been approved for a total outlay of Rs. 78.00 crore across the entire UT, against which 80% funds stand already released for different works which are under execution. He said that this shall significantly improve the infrastructure and standard of living of the tribals residing in remote/far flung areas.

During the meeting, the need of human resources for smooth running of tribal hostels and the offices at district level was also discussed in detail.

The road used before was avalanche-prone and often got blocked for several months, but the Z-Morh tunnel provides allweather connectivity to the Sonamarg tourist town. It takes only 15 minutes to travel the 6.5 km long tunnel compared to hours over the zig-zag road up and down the hills.

Together with the adjacent Zoji-La Tunnel, this geostrategically important tunnel on the Srinagar-Leh Highway will provide yearround weather-proof connectivity to Baltal (Amarnath cave), Kargil and other places in the Ladakh region.

It will also enhance military logistics and boost tourism and the economy. In addition to providing all-weather connectivity to Sonamarg, the tunnel will help the employment of local youth and boost tourism and allied activities in the area.

It is one of the 31 road tunnels, 20 in Jammu and Kashmir and 11 in Ladakh.

The construction of the tunnel was started in 2018. The tunnel workers came under terror attack on October 20, 2024, when two terrorists entered the workers' camp at Gagangir and fired indiscriminately. Instead, he urged the Chief Minister to be "resilient," "express the dissent of the people," and lead what he called their "rebellion" in demanding their right to statehood and the return of Article 370.

When asked about the response Chief Minister Omar Abdullah had received from the Prime Minister and the Home Minister after his efforts to engage with the Modi government, Ruhullah described it as "disrespectful."

He stated that the Modi government appears to "turn a deaf ear" to the people of Jammu and Kashmir.

He also expressed concern over the delay in granting statehood, which the government had assured the Supreme Court it would restore. "The delay is very worrying," he said, adding that the people of Jammu and Kashmir are "more committed than ever" to the restoration of Article 370

### Kashmir's ancient stone carving faces collapse amid mining ban

## Carvers seek govt support, sustainable solutions; say hundreds of families lost livelihoods

**SRINAGAR:** Stone carvers in Sanderkoot village of north Kashmir's Bandipora district are grappling with the fallout of a mining ban imposed in 2019 which has now disrupted a centuries-old tradition of stone carving, leaving hundreds of families without their primary source of income.

The carvers, locally referred to as sang taraash, have relied on devere stone from local mountains for generations to craft curbstones, gravestones, and floor stones. Since the 2019 mining ban, they



have lost access to this essential material, halting their craft and threatening their livelihoods and a centuries-old cultural tradition.

Notably, the Sanderkoot village is renowned for its centuries-old tradition of stone carving, which holds a significant place in Kashmir's cultural heritage.

The skilled artisans have been crafting exquisite stone pieces such as curbstones, gravestones, and floor stones from the region's unique devere stone.

Sharing his concern with the news agency– Kashmir News Observer (KNO) Shakeel Ahmad, a local who took up the craft in 2008, said they now face challenges. "For years, I supported my family with this work. After the ban, everything changed. The government tells us to look for other jobs but does not provide alternatives or address our concerns. This is not just about stone carving; it's about survival for many of us," he said.

Mushtaq Ahmad, another carver, said this craft has been in their families for hundreds of years. "It's not just a job but a way of life. Generations have passed this skill down, and now we cannot continue it. The government is preserving other art forms, so why not ours? We only ask for the

means to work again," he said.

Haleema Begum, the wife of a stone carver, spoke about the struggles faced by families. "My husband's earnings came from carving stones for homes and masjids. Now, we don't even have enough for basic necessities. We don't want charity; we want to work. The ban has left us dependent on odd jobs, which are not enough to sustain our family," she said.

The locals said the ban was implemented without consultation or an understanding of its impact.

Several carvers have tried switching to other professions, but with limited skills outside their traditional craft, options remain scarce. "I tried working as a labourer, but the income is inconsistent," said Bashir Ahmad, another carver. "This art was our identity. Losing it feels like losing a part of who we are."

"This craft has been part of our lives for centuries, passed down from one generation to the next," said Nazir Ahmad, a stone carver. "Now, with the ban, we are unable to continue what our ancestors sustained for so long. NOTICE

# Virat Kohli is always super motivated, he'll know what to do: Faf du Plessis

CAPE TOWN: Virat Kohli will be "super motivated" to put a struggling phase behind him and the premier India batter is capable of returning to his run-making ways, said former South African captain Faf du Plessis here on Wednesday.

Kohli had a torrid time in Australia during the recent Border-Gavaskar Trophy, amassing a mere 190 runs at an average of 23.75 across five Tests despite starting off with an unbeaten hundred in the first Test at Perth.

Du Plessis backed Kohli, his one-time teammate at Royal Challengers Bangalore, to come back stronger from the struggles, and said retirement is a "very personal" choice. "That is very, very personal. No one can

speak to you about when that time is (up) as a player, you'll know," du Plessis told PTI on the sidelines of the SA20 Season 3's Captain's Day. "I know someone like him is super super

motivated, he's gone through it all before, so he knows exactly what to do," said Du Plessis. The 40-year-old then went back to the day

when he felt his time was up as a Test cricketer. "It is different for every player. Every player needs to answer that question. I remember when that time was for me," he said.

"I just knew that certainly from the Test cricket perspective for me. I didn't have that same hunger and drive anymore and I felt that that stage certainly for me was a good time to let new guys come in and also step into the T20 world. "I wanted to do that at the stage where I still

"SA deserve to raise WTC trophy"

South Africa spinner Keshav Maharaj rated the consistency of his side in Test cricket "phenomenal" and said they deserve to "raise a prestigious title.'

The Proteas will face Australia in the final of the World Test Championship in June at the Lord's.

South Africa advanced to the title clash of the 2023-25 cvcle with a 2-0 win over Pakistan at home, while India's string of losses against New Zealand at home and against Australia ended their hopes of a third consecutive WTC final appearance.

"If you look at our Test unit, not many people would have afforded us the opportunity of making the final, but we've been phenomenal from a consistency point of view, from a cricket perspective," Maharaj told PTI.

"The togetherness on the field and the camaraderie and spirit (that) you see within the dressing room propelled us to get there.

"Hopefully, this is our year and we go one better than we've done previously and raise a very prestigious title in the Test format," he said.

Maharaj, however, conceded that defending  $champions Australia are a formidable {\it opponent}.$ 

"It's the hardest format of the game. It's most challenging physically, mentally and emotionally. As a unit, the (kind of) cricket (that) we have played, we deserve to go and raise a trophy.

#### **Bumrah continues** to remain No. 1 in **Test rankings**

DUBAI: India's pace spearhead Jasprit Bumrah continued to reign supreme at the top of the bowlers' chart with a career-best rating of 908 in the latest ICC Test Rankings, released on Wednesday.

Bumrah, who made history ahead of the fifth and final Test against Australia by recording the highestever ICC Rankings rating for an Indian bowler at 907 points, improved that tally by one point after taking two wickets in the first innings at the SCG.

However, a back spasm ruled him out of bowling in the second innings, restricting his role to just batting.

Left-arm spinner Ravindra Jadeja, who climbed a spot to be joint-ninth, is the other Indian giving Bumrah company in the top-10.

He shares the ninth spot with Australian pacer Scott Boland, who has made a remarkable leap of 29 places to break into the top 10.

Boland's stellar performance in the Sydney Test, where he claimed a 10-wicket haul (4/31 and 6/45), proved too much for the Indian batters on a lively pitch.

His efforts were instrumental in Australia's triumph, ending a decade-long wait to reclaim the Border-Gavaskar Trophy.

Australia skipper Pat Cummins also made gains in the rankings, climbing to number two after picking up five wickets in the final match. South Africa's Kagiso Rabada rose a spot to occupy the third place while injured Josh Hazlewood moved down two places to be fourth.

Rishabh Pant's blistering 33-ball 61 in the second innings earned him a three-spot rise in the batting rankings, moving him to number nine while India opener Yashasvi Jaiswal retained his fourth spot.

South Africa captain Temba Bavuma extended his rich vein of form, scoring a vital century in the first innings to climb three spots to number six, also achieving a career-best rating of 769.

Meanwhile, Kyle Verreynne's impressive century saw him rise four places to secure the 25th spot.

## **Pakistan docked** five WTC points for slow over rate during Cape **Town Test**

akistan have been docked five World Test Championship (WTC) points and fined 25% of their match fee for maintaining a slow over rate during their 10-wicket defeat in the second Test against South Africa in Cape Town. They were ruled to be five overs short of their target after time allowances were taken into consideration. Match referee Richie Richardson imposed the sanction, which Pakistan captain Shan Masood accepted after pleading guilty to the charge - levelled by on-field

umpires Kumar Dharmasena and Nitin Menon, third umpire Alex Wharf and fourth umpire Stephen Harris - which meant that was no need for a formal hearing.

Teams are deducted one point for every over by which they fall short of their target. This is Pakistan's third points deduction in the 2023-25 WTC cycle. They were docked two points after the first Test against Australia in Perth in December 2023, and six points following the first Test against Bangladesh in Rawalpindi in August 2024.



Match referee Richie Richardson imposed the sanction, which Pakistan captain Shan Masood accepted after pleading guilty to the charge - levelled by on-field umpires **Kumar Dharmasena** and Nitin Menon, third umpire Alex Wharf and fourth umpire Stephen Harris - which meant that was no need for a formal hearing.

As a consequence, Pakistan now have 35 points - instead of a possible 48 - from 12 Tests in the 2023-25 cycle. The latest deduction has brought their percentage of points contested - the number that determines a team's position on the WTC table - down from 27.78 to 24.31. They remain in eighth place as before, but their points percentage is now only a few decimal points better than West Indies, who occupy the bottom of the nine-team table with a percentage of 24.24 - with no overrate deductions.
