# Z-Morh tunnel inauguration: PM's 12th visit to J&K in 10-years

**SRINAGAR:** In over one decade of his tenure since 2014, Prime Minister Narendra Modi is all set to make his 12th visit to Jammu and Kashmir on Monday (January 13) to inaugurate the much-awaited Z-Morh tunnel at Sonamarg in Central Kashmir's Ganderbal district.

Modi assumed the office of Prime Minister for the first time on May 26, 2014 and took the oath as PM for the third consecutive term on 9th June, 2024.

According to the details gathered by the news agency—Kashmir News Observer (KNO), the Prime Minister Narendra Modi during his previous 11 visits to Jammu and Kashmir from 2014 inaugurated dozens of development projects and announced financial packages worth thousands of crores.

On July 4, 2014, the PM inaugurated the Udhampur-Katra railway line, improving access to the Vaishno Devi shrine while in September 2014 during devastating floods, the PM visited to assess the damage and announced a relief package of Rs 1,000 crore for rescue and rehabilitation.

In 2015, the PM, besides inaugurating the second phase of Baglihar Hydro Electric Project (450 MW) in Ramban, launched a comprehensive economic package of Rs 80,000 crore for Jammu and Kashmir.

On November 7, 2015, the PM inaugurated the second phase of the Baglihar Hydro Electric Project (450 MW) in Ramban and laid the foundation for national highway projects (Udhampur–Ramban and Ramban– Chenani-Nashri Tunnel, India's longest road tunnel at the time, improving Jammu-Srinagar connectivity while on October 19, 2017, the PM celebrated Diwali with soldiers in Gurez, acknowledging their contributions.

### Srinagar Launches First Shelter Home for Beggars

**SRINAGAR**: Deputy Commi ssioner Srinagar, Dr. Bilal Mohiuddin, discussed the city's efforts to address social challenges, urbanization, and infrastructure development.

In an exclusive interview with KNS, he highlighted the administration's commitment to creating a welfare-driven city and shared key updates on initiatives such as the rehabilitation of beggars, traffic management, and preparations for national events.

Dr. Mohiuddin announced the launch of Srinagar's first shelter home for beggars in the Hawal area, established under the Smile Scheme by the Ministry of Social Justice and Empowerment. Managed by the NGO "Prayas," the shelter accommodates 50 people and offers food, basic living facilities, and rehabilitation services. The initiative includes skill training in trades such as tailoring, batik work, and bulb making, with special childcare

homes and schools for children involved in begging.

Heelaborated on the historical context of the 1960 J&K Provincial Beggary Act, which criminalized begging but was later struck a major issue in Srinagar, he highlighted the implementation of Intelligent Traffic Management Systems (ITMS) and collaborations with the Regional Transport Authority. These measures are part

## **Extensions In Service Set Back To** Those Who Are In Line: Jagdeep Dhankhar

said on Saturday that extensions in service, extensions in any form for a particular post are set back to those who are in line.

Dhankhar was delivering the inaugural address at the 25th National Conference of Chairpersons of State Public Service Commission being held in

According to him, extension of service indicates that some individuals are indispensable.

"Indispensability is a myth. Talent abounds in this country. No one is indispensable. And therefore, it lies in the domain of public service commissions at the state and the central level that when they have a role in such kinds of situations, they must be firm," added the VP.

He also said public service commissions' appointments cannot be driven by patronage, or by favouritism.

"We cannot have a public service commission Chairman or a member, wedded to a particular ideology or an individual. That will be undoing the essence and spirit of the framework of the constitution," said Dhankhar.

The Vice-President also frowned upon postretirement recruitment and said it is antithetical to



what was visualised by framers of the Constitution. "In some states, it has been structured. Employees never retire, particularly those in the premium services. They get a number of ad-hoc nomenclatures. This is not good. Everyone in the country must have

due and that due is defined by law," said the VP. The VP also said fairness of selection has no meaning if paper leakages occur.

"Paper leakage has become an industry, a form of commerce. This is a menace that must be curbed,"

He commended the initiative the government has taken in this regard, with the Public Examinations (Prevention of Unfair Means) Bill, 2024.

The Vice President is also of the view that although it is "India's century", without a "calm political atmosphere" India will not really gain.A vitiated political climate is far more dangerous than the climate change we are facing, he pointed out.

"Our polity at the moment is too divisive, too polarised. Interaction is not taking place at the premium level in political organisations."

The solution, according to him, is harmony in polity."Harmony is imperative. If there is no harmony in polity, if the polity is polarized, deeply divisive, with no communication channels functioning, imagine you are in an earthquake, you are lost and you have no connection with the outside world, things will be terrible for you," he added. He also said for India to stand strong, we need strong institutions.

"Any institution, if it is weakened, the damage is to the entire nation. Weakening of an institution is like a prick on the body. The entire body will be in pain," said Dhankhar. To build strong institutions. he added, states and Union governments must work in tandem. "They must be in synergetic mode. They must be in sync with one another when it comes to national interest," said the VP.

Noting that discussion is deeply rooted in our civilizational ethos, the Vice President urged senior leadership for all political parties, irrespective of their ideologies, to "enhance dialogue, believe in consensus and always be ready for deliberation".

Karnataka Chief Minister Siddaramaiah, who was also present on the occasion, said Public Service Commissions are pillars of democracy, upholding meritocracy and fairness, and contributing immensely to governance.

"Karnataka has a rich history in public administration, starting with the Mysore Civil Services (MCS) examination initiated by Dewan Sir K Seshadri Iyer in 1892. This pioneering step set the foundation for a cadre of distinguished administrators, a legacy Karnataka continues to uphold with pride," he added.

He said tackling challenges such as paper leaks remains a top priority for Karnataka today. He also said learning from the best practices of other states and leveraging advanced technologies like artificial intelligence will make recruitment more transparent and corruption-free.

#### Spadex docking: Satellites on hold mode at 1.5 km distance, further drift to reduce it to 500 m tomorrow

**CHENNAI**: A day after arresting the excessive drift between the two spacecrafts

as part of Spadex docking experiment mission, the Indian Space Research Organisation(ISRO) on Friday evening said the spacecraft were now at a distance of 1.5 km and on holdmode. Further drift to reduce the distance to 500 m was planned to be achieved by Saturday morning.

The docking experiment was twice deferred due to technical glitch.

In a post on X on SpaDeX Docking update,

the Space Agency said "Spacecrafts are at a



distance of 1.5 km and on hold mode. Further drift to 500 m is planned to be achieved bytomorrow morning."

Yesterday, ISRO said "The drift has been arrested and spacecrafts put in a slow drift courseto move closer to each other. By tomorrow, it is expected to reach initialisation conditions".

The excessive drift has led to the postponement of docking of the two satellites-Chaserand Target-scheduled for today morning, but was postponed for the second time. The docking was earlier scheduled on January 7 and was deferred to yesterday as it required

### IMD looks to use data from Cube Sats, IoT devices for better forecasts

**NEW DELHI**: The India Meteorological Department (IMD) is looking to access data from CubeSats, crowdsourcing, and Internet of Things devices besides conventional weather satellites to improve it forecast accuracy, a former official said.

The IMD has also sent a dedicated meteorological satellite in orbit and installed a new high power computing system (HPCS) last year that would allow it to issue more accurate forecasts.

"IMD will soon move to an ensemble prediction system with a horizontal resolution of 6 km, which is an improvement over the current resolution of 12 km," Madhavan Rajeevan, Ministry of Earth Sciences' former secretary, said in article penned on the occasion of the 150th Foundation Day of IMD.

"The improvement of observation networks incorporating state-of-the-art technologies such as crowdsourcing, CubeSats, IoT devices and unmanned platforms will significantly improve data quality and forecast efficiency," he said.



Raieevan said the IMD was also setting up separate research testbeds in Bhopal and Mumbai to deepen the understanding of monsoon dynamics and cloud physics.

"As user expectations continue to grow, the IMD must continuously innovate and proactively address these demands," he said. The IMD has access to weather observations from over 6,000 surface observatories in addition to data from

weather balloons, satellites, a network of radars which feed information to prediction models."By embracing cutting-edge technologies and continually

## **ISRO Scientist** Delivers a special talk on "From Space to Species" at Jammu University

JAMMU: The Department of Botany, University of Jammu, in collaboration with the J&K Biodiversity Council, organized a special talk titled "From Space to Species: Monitoring of Essential Biodiversity Variables Using Remote Sensing" by Dr. C. Sudhakar Reddy, Head of the Forest Biodiversity and Ecology Division, NRSC, Indian Space Research Organization (ISRO), Hyderabad.

Initiating his insightful and thought-provoking talk, Dr. Reddy outlined the underlying causes of biodiversity loss, its far-reaching implications, and the various measures being undertaken to address these challenges. Focusing on the concept of Essential Biodiversity Variables (EBVs), Dr. Reddy elaborated on Remote Sensing-based methodologies such as Spectral Reflectance Patterns, which are instrumental in measuring ecological biodiversity, forest types, land cover, long-term forest cover changes, global tree cover loss, leaf area index, and forest fragmentation citing some specific examples from India and globe. He also detailed the application of remote sensing approaches for biomass estimation and discussed their utility in addressing critical biodiversity threats, including forest fires, invasive alien species, and the shrinkage or loss of water bodies. Additionally,



he emphasized the role of remote sensing in mapping the global spatial distribution of endemic and threatened species and predicting their suitable habitats. Conveying his gratitude to the University of Jammu, Dr. Reddy desired he seeks to have meaningful collaborations with the Universities and research organizations in Jammu & Kashmir, and Ladakh for gathering essential information for the monitoring of EBVs at scales relevant to research and decision-making for conservation. #### **GMC Srinagar rebuts news** item suggesting increase in the Neonatal mortality rate at LD Hospital

**SRINAGAR:** The Government Medical College (GMC) Srinagar has strongly refuted the news item circulated by some media outlets suggesting an increase in the mortality rate at Lal Ded Hospital (LD Hospital) for

In an official statement issued here, it has been clarified that the neonatal mortality rate (NMR) at Government Lal Ded Hospital (LD Hospital) for the year 2024 stands at 9.9 per 1000, which is significantly lower than the national average, though neonatal mortality rate at LD cannot be used as an index of neonatal mortality in the society.

The GMC authorities further explained that the neonatal mortality rate has not risen but, in fact, has been effectively contained through advanced treatment methods. These improvements have ensured that the rate remains well below the national average, demonstrating the hospital's success in providing high-quality care.

In 2024, LD Hospital attended to a total of 221,163 outpatients (OPD), with 37,908 inpatient (IPD) admissions with 29,939 live births. Further 3,107 neonatal IPD admissions were recorded. Out of these neonatal admissions, 297 deaths occurred, resulting in a neonatal mortality rate of 9.9 per 1000 which is below than the national neonatal mortality which at present is 17-21 per 1000 live births.

The millennium development goal is to reduce neonatal mortality rate to 12 per 1000 live births. This figure reflects a remarkable achievement in the face of challenges and is attributed to the advanced healthcare systems in place at the valley's only tertiary maternity care hospital. The state-of-the-art medical infrastructure and skilled medical professionals at the hospital have played a crucial role in maintaining these positive outcomes. It is pertinent to mention here that the patients who need termination of pregnancies earlier in maternal interest or for different fetal reasons like decreased blood flow to fetus are also referred to LD hospital which also increases the neonatal admissions and mortality. But given all the facts and advanced health care system the neonatal mortality rate is below the national average.

Different measures have been implemented to reduce the neonatal mortality rate in the Neonatal Intensive Care Unit (NICU). These include the round-the-clock availability of doctors and paramedics, the provision of high-end equipment such as ventilators, CPAP machines, and warmers, as well as the free availability of life-saving medications like surfactants. Additionally, the hospital ensures that there is consistent support for oxygen supply, including an oxygen plant that provides adequate pressure for ventilators and CPAP machines.

# **Defeating The Human** Metapneumovirus?

Human metapneumovirus has emerged as a global health concern, particularly for vulnerable populations such as children, the elderly, and immunocompromised individuals.

First identified in 2001, human metapneumovirus causes significant respiratory infections worldwide, leading to hospitalization and mortality, particularly in low-income countries.

As viral outbreaks such as human metapneumovirus pose increasing challenges, it is important to strengthen regulatory frameworks for effective management. Human metapneumovirus has become a significant global health concern due to its widespread spread, particularly during seasonal outbreaks.

The virus is gaining attention as its impact increases across regions. In China, increased surveillance has revealed a rise in human metapneumovirus cases, particularly in children and the elderly, indicating an increase in detection rates.

The World Health Organization reports that human metapneumovirus accounts for 3%–10% of hospitalizations globally, with a significant increase in children under five years of age.

The virus often spreads rapidly during flu season, leading to a surge in respiratory infections, making it a seasonal health threat. In China, the flu season coincides with a surge in human metapneumovirus cases, leading to increased hospitalizations and media coverage.

Despite being in circulation for years, many countries, including India, lack a comprehensive and affordable testing infrastructure for human metapneumovirus. While global agencies monitor human metapneumovirus, many regions still face challenges in detecting and reporting it, affecting early interventions. The virus disproportionately affects certain vulnerable groups, such as children under five years of age.

Human metapneumovirus disproportionately affects young children, particularly those under the age of five, who are at higher risk of severe illness and hospitalization. The elderly, particularly those with existing health problems, are more vulnerable to severe outcomes from human metapneumovirus infection.

In China, a rise in human metapneumovirus cases in the elderly has led to a rise in hospitalizations, highlighting the vulnerability of the older population. People with weakened immune systems are at higher risk of severe infection with human metapneumovirus, requiring intensive medical care.

Deaths due to hMPV are significantly higher in vulnerable groups, including infants and immunocompromised people. The case fatality rate for children under five years of age is 1%, raising concerns about the impact of the virus on high-risk populations in both developed and developing countries.

In low- and middle-income countries, limited healthcare access increases the risk of severe outcomes for vulnerable popu-

The Ministry of Health and Family Welfare can expand the Integrated Disease Surveillance Programme to include real-time human metapneumovirus tracking across all states. India can launch public health campaigns to raise awareness about human metapneumovirus, focusing on prevention methods and recognizing symptoms, especially among vulnerable populations.

The Ministry of Health can partner with the media and NGOs to conduct information campaigns, especially in rural areas, to recognize symptoms of respiratory infections such as human metapneumovirus.

## How Carbon dioxide

Has Been Regulating Earth's Climate

Around 370 million years ago, Earth gradually descended into the longest lived and probably the most intense ice age witnessed by complex life: the Late Palaeozoic ice age. At its peak, huge continental ice sheets spread across much of the globe and the sea level fell by more than 100 metres. In all, this ice age lasted around 100 million years.

The transition in and out of the Late Palaeozoic ice age was one of the biggest climate transitions in Earth's history, a turning point in the evolution of life and environment. It significantly shaped the two periods of time that made up the end of the Palaeozoic era.

First, it led to the creation of iconic "coal forests" full of giant insects in the Carboniferous period during the ice age. It also paved the way for the rise of reptiles in the Permian period that followed.

I lead an international team of scientists who have just published research demonstrating, for the first time, that carbon dioxide (CO ) played a central role in this huge climatic transition.


The Late Palaeozoic ice age has long been a climate enigma. Atmospheric CO estimates for this period vary widely, and different reconstructions of the likely temperature vary by as much as 20°C.

The occurrence of glacial deposits throughout time has often been used to track the ice age. However, this approach is biased by the incompleteness of the geological record and has only loose time constraints. When attempting to reconcile the individual pieces of the puzzle, paradoxes have emerged, such as peak ice conditions coinciding with high CO levels.

Closely regulated by carbon

Our new study provides an original 80-million-year CO record that tracks the climate during the descent into and emergence from the Late Palaeozoic ice age. We did this by looking at the fossilised shells of ancient clam-like creatures known as brachiopods. These shells store chemical fingerprints such as boron isotopes, which enable us to calculate how much CO was in the atmosphere when the brachiopods were alive.

This type of CO reconstruction from Earth's deep geologic past is entirely novel. Crucially, the reconstruction has a consistent timeline which enables us to bring



together all pieces of the puzzle to demonstrate that the climate of the Late Palaeozoic era was closely regulated

What did the Late Palaeozoic climate and CO look like? Our reconstruction showed that for part of this era the Earth's atmosphere sustained relatively low CO (about 330 parts per million or ppm), reaching minimum values of about 200 ppm about 298 million years ago around the boundary between the Carboniferous and Permian periods.

The low atmospheric CO combined with less heat coming from the younger sun would have caused the intense "icehouse" conditions, with ice sheets extending as far as the planet's mid latitudes.

Our reconstruction also revealed an unexpected end to the icehouse period. Scientists previously thought that the Late Palaeozoic ice age gradually waned away, but our findings showed it ended much earlier. Around 294 million years ago, large-scale volcanic activity triggered a rapid rise – at least on geological timescales – in atmospheric CO , and Earth became warmer and drier.

While the past couple of decades have brought much progress in reconstruction of CO from Earth's more recent past (in particular the past 60 million years where we have seafloor sediments), CO reconstruction from the rock record has been long considered challenging. As such, our study pushes the boundaries in geological reconstruction of atmospheric CO and

provides a key to unlocking its history to the beginning of Earth's fossil record.

While CO is expected to play an important role, as demonstrated during the Late Palaeozoic, precise knowledge of past levels and changes is fundamental to understanding of every aspect of the Earth system. Addressing the remaining gaps and continuously refining records is crucial to fully grasping CO 's influence on Earth's climate and habitability—past, present and

### **GMC** Srinagar rebuts news item suggesting increase in the Neonatal mortality rate at LD Hospital

Neonatal mortality rate at LD Hospital significantly lower than the national average

**SRINAGAR:** The Government Medical College (GMC) Srinagar has strongly refuted the news item circulated by suggesting an increase in the mortality rate at Lal Ded Hospital (LD Hospital) for the year 2024.

In an official statement issued here, it has been clarified that the neonatal mortality rate (NMR) at Government Lal Ded Hospital (LD Hospital) for the year 2024 stands at 9.9 per 1000, which is significantly lower than the national average, though neonatal mortality rate at LD cannot be used as an index of neonatal mortality in the society.

The GMC authorities further explained that the neonatal mortality rate has not risen but, in fact, has been effectively contained through advanced treatment methods. These improvements have ensured that the rate remains well below the national average, demonstrating the hospital's success in providing high-quality care.

In 2024, LD Hospital attended to a total of 221,163 outpatients (OPD), with 37,908 inpatient (IPD) admissions with 29,939 live births. Further 3,107 neonatal IPD admissions were recorded. Out of these neonatal admissions, 297 deaths occurred, resulting in a neonatal mortality rate of 9.9 per 1000 which is below than the national neonatal mortality which at present is 17-21 per 1000 live births.

The millennium development goal is to reduce neonatal mortality rate



in the face of challenges and is attributed to the advanced healthcare systems in place at the valley's only tertiary maternity care hospital. The state-of-the-art medical infrastructure and skilled medical professionals at the hospital have played a crucial role in maintaining these positive

It is pertinent to mention here that the patients who need termination like decreased blood flow to fetus are also referred to LD hospital which also increases the neonatal admissions and mortality. But given all the facts and advanced health care system the neonatal mortality rate is below the national average.

Different measures have been implemented to reduce the neonatal mortality rate in the Neonatal Intensive Care Unit (NICU). These include the round-the-clock availability of doctors and paramedics, the provision of high-end equipment such as ventilators, CPAP machines, and warmers, as well as the free availability of life-saving medications like surfactants. Additionally, the hospital ensures that there is consistent support for oxygen supply, including an oxygen plant that provides adequate pressure for ventilators and CPAP machines.

LD Hospital, with its 710 beds, is the primary maternity and neonatal care center for the region, serving not only the valley but also districts such as Ramban, Doda, Rajouri and Kishtwar, as well as the Union Territory of Ladakh.

The hospital's comprehensive approach to healthcare has made it a vital resource for improving neonatal health in the region.

# Inorganic Food Additives

## To Increase Allergy Vulnerability For Babies

A study suggests inorganic nanoparticles in our food, which get transferred into the mother's breast milk through the placenta, can interfere with intestinal regulation, leading to an increase in babies' chance of food allergies

ur society today is heavily focused on clean eating, or healthy eating with the advancement of organic restaurants, various types of diets, and more. We still, however, find excessive amounts of food additives and processors in our food. From jar foods to sauces, to even fast food menus, food additives are everywhere in our lives

and nanoparticles, we have to be considerate about food allergy and the effect it has on fetuses. Such immunotoxic biocidal particles can impede the host-intestinal microbiota's favorable transfer, leading to a hindered immune system development.

Growth of food allergy

Food allergy, or FA, refers to an unfavorable response resulting from an immoderate response to dietary proteins which results from a damaged introduction of oral tolerance.

FA can severely affect one's life, resulting in multiple mechanisms from nausea, hives, swelling, and even asthma. FA can also lead to a serious allergic reaction called anaphylactic shock, which can be fatal. FA affects around 6 to 8 percent of children,

exposed breast milk can get immune-related disorders.

"Due to the immunotoxic and biocidal properties of nanoparticles, exposure may disrupt the host-intestinal microbiota's beneficial exchanges and may interfere with intestinal barrier and gut-associated immune system development in fetus and neonate," continued Dr. Karine Adel-Patient.

Nanoparticles are not engrossed but rather processed in the gut, impacting the epithelium



## Understanding nanotechnology

Nanotechnology is a popular concept in food science that positively influenced our food culture, from food processing, packaging, and most importantly, the safety of our food. In-depth, nanotechnology can help with a myriad of elements from detecting bacteria, increasing food life, and discharging preservatives to helping with food packaging. With such accelerated advancement, however, inorganic nanoparticles have come into the picture.

"Nanotechnology introduces new chances for innovation in the food industry at immense speed, but uncertainty and health concerns are also emerging. EU/WE/global legislation for the regulation of nanotechnology in food is meager. Moreover, current legislation appears unsuitable to nanotechnology specificity," said Dr. Bhupinder Singh Sekhon in his research.

A recent study by the University of Paris-Saclay shared that these inorganic nanoparticles found in our everyday food could have much more serious health benefits than we think. The Université Paris-Saclay colleagues said nanoparticles not only affect ourselves but also the placenta, eventually reaching fetuses.

With such common exposure to food additives

"The impact of such exposure on the development of food allergy has not been assessed to date," stated corresponding study author Dr. Karine Adel-Patient.

"This may be linked to the epidemic of immunerelated disorders in children, such as food allergies - a major public health concern," continued Dr. Adel-Patient.

## How does it get transferred to babies?

When the mother gets exposed to foodborne nanoparticles, they transfer through the placenta, directly affecting the fetus. It also paves its way through breast milk, which is then fed to babies. Even healthy babies who get exposed to their mother's

intestinal barrier that is crucial to building a healthy reaction to dietary proteins.

"This may be linked to the epidemic of immunerelated disorders in children, such as food allergies – a major public health concern."

The perinatal term is crucial for babies to receive sufficient nutrients and pave the way to create a healthy susceptible metabolism.

Dr. Adel-Patient also shared that the "review highlights the urgent need for researchers to assess the risk related to exposure to foodborne inorganic nanoparticles during acritical window of susceptibility and its impact on children's health."

Aside from other environmental components, certain inorganic nanoparticles can severely impact a baby's dietary health, including intestinal homeostasis, which can lead to FA. More study is needed to thoroughly examine the impact of fetal and neonatal subjectivity on nanoparticles.



## Covid variants still transmissible between species: Study

he SARS-CoV-2 virus is still highly transmissible between mammals, according to a study based on computer simulations.

Researchers at Rochester Institute of Technology (RIT), US, found that coronaviruses use their spike proteins -- which help them to infect cells -- to attach themselves to the host cells in both bats and humans in much the same way.

The findings, published in the journal Royal Society Open Science, show how the viral spike proteins in several SARS-CoV-2 variants interact with the host cell receptors known as ACE2 in both humans and various bats of genus Rhinolophus.

nd various bats of genus Rhinolophus. "We were hoping to see really cool adaptive evolution happening as the virus got more used to humans and less used to bats, but we actually saw that there wasn't a whole lot of change," said Associate Professor Gregory Babbitt

"Because this binding site has not evolved very much, there's really not much stopping it from transmitting from humans to bats," Babbit said in a statement.

Scientists believe bats first transmitted SARS-CoV-2 to humans in December 2019, and the virus has since evolved into several variants such as Delta and Omicron.

The study suggests that there would be pretty widespread cross-species



infectivity, and the literature has shown there has been a lot of evidence of that.

The researchers used a computer simulation method called molecular dynamics to put proteins in a solvated simulation and then watch them move.

The approach uses high performance computing on graphics processors to show what every atom does over time.

Babbitt said this approach allows

scientists to study questions that cannot be answered in a traditional laboratory. "It would be dangerous to do

experiments where we reinfected bats with human viral strains, so our computer-based simulations offered a much safer alternative," Babbitt added.

The Union Home Minister said that we have made several changes in investigations, not only exposing drugs but also uncovering the terrorism networks associated with them.

DARK WEB, CRYPTO-CURRENCY, ONLINE MARKETPLACES, DRONES CONTINUES TO POSE CHALLENGE

Shah stated that the use of the dark web, cryptocurrency, online marketplaces, and drones continues to pose a challenge for us. He said that all agencies should strengthen the resolve for a drug-free India by stopping drug smuggling through the dark web, crypto-currency, and drones.

Shah said that for the success of the 'Nasha Mukt Bharat' campaign, technical solutions to these challenges must be found by our agencies, state governments, and the youth involved in this field; only then this fight could be result-oriented. He mentioned that India is one of the largest producers of precursor chemicals, which is a concern in the fight against drugs. When strict measures are taken against traditional drugs, a natural diversion towards chemical drugs occurs. He added that at least 50 illegal labs have been caught across the country, which shows that due to our strict actions, the demand for drugs has increased, and they are being diverted through different channels. He emphasized that we need to stop this diversion immediately. The Home Minister urged all states to destroy illegal clandestine labs with rigor and take legal action against them with a ruthless approach.

PM MODI LED GOVT MOVING FORWARD WITH RUITHURSS APPROACH

The Union Home Minister said that the PM Modi led government has changed its approach against drugs since 2019. He mentioned that the Modi government is moving forward with a ruthless approach against the drug supply chain, a strategic approach for demand reduction, and a human approach for the victims.

He also stated that we need to increase the use of PIT-NDPS (Prevention of Illicit Trafficking in Narcotic Drugs and Psychotropic Substances Act). Heemphasized the need to strategically and cautiously expand the use of legal provisions for asset confiscation. Amit Shah also urged states to take proactive steps to enhance the capacity of Forensic Labs (FSL) instead of relying solely on the Centre for support.

Shahstressed upon the importance of investigating drug cases using both 'top-to-bottom' and 'bottom-to-top' approaches. He highlighted that no narcotics case should be treated as an isolated incident, and investigations must continue until the entire network behind it is uncovered. He urged that each case should be seen as an opportunity to dismantle a broader network, ensuring the fight against drugs reaches its logical conclusion. Shah emphasized the critical role of financial investigations in tackling the drug trade, including seizing properties linked to illicit activities. He stated that no major case should be concluded without a thorough financial investigation.

virtually from Jammu, emphasizing J&K UT's commitment to neutralise the narco-terror nexus and combat the drug menace.

While addressing the conference, the Lieutenant Governor said that concerted efforts were made in the year 2024 to target the illicit proceeds of narcotics trafficking and 188 properties of traffickers have been identified for attachment under Smugglers and Foreign Exchange Manipulators Act (SAFEMA). 274 repeat offenders were detained under PIT-NDPS Act.

The Lieutenant Governor said in 2024 significant improvements were recorded over previous years and 210 convictions were secured which is the highest ever. In 2024, around 1,514 cases under NDPS Act were registered and 2,260 arrests were made. He said the government is determined to completely dismantle the entire drug syndicate which is posing a serious and direct threat to the nation's sovereignty and security. Five special NDPS Courts have been established for speedy trial of cases.

"Financial investigations are now being carried out in all cases to work out forward and backward linkages so that the entire network is neutralised in every NDPS case," the Lieutenant Governor said.

He said, under the guidance of Prime Minister Narendra Modi and Home Minister Amit Shah, J&K Union Territory has adopted a whole of government approach to deal with drug trafficking and drug abuse. The Lieutenant Governor said that Inter-departmental coordination on various aspects and challenges is ensured and regular NCORD meetings have been held in the last two years.

The Lieutenant Governor said that the forensic labs have been strengthened and modern equipments as well as manpower has been ensured. This has resulted in effective functioning of labs and strengthening of the entire legal justice framework through filing early charge-sheet and effective trial of cases.

expenditure, including holding of seminars, conferences, and workshops with utmost economy, while it also directed that holding exhibitions, fairs and conference outside J&K be strongly discouraged.

The Finance department has directed respective departments that during the last quarter of the current financial year the revenue expenditure should be limited to 30% of budget allocation and in the month of March, it should be limited to 15% of such allocation. "In the last month of the current financial year, payments may be made only for the works duly executed, and the goods and services already procured," the order states. The order further directs departments that no amount should be released in advance in the last month with the exception of the loans or advances to government servants as per service conditions or on compassionate grounds or to disaster victims as a measure of relief and rehabilitation.

The government has also ordered that rush of expenditure on procurement of goods and services should be avoided during the last month of the current financial year to ensure that codal procedures are complied with and there is no infructuous expenditure. "Director(s) Finance / Financial Advisor(s) are advised to specially monitor this aspect in their respective departments," it said. The government also imposed a 10 percent economy cut on the budget allocation for OE, LTC, telephone / POL, advertisements, publicity, hospitality & sumptuary.

"Utmost economy shall be observed in organising conferences/ seminars/workshops. Holding of exhibitions/fairs/seminars/conferences outside J&K is strongly discouraged," the order said, adding that there shall be complete ban on holding of meetings and conferences at private hotels," the order states. According to the order, government buildings/halls should be utilised for holding meetings and conferences instead. It also imposed a 10 percent economy cut on the budget allocation for conduct of camps, conferences and seminars.

It also said that purchase of new vehicles is strictly discouraged. "Exceptional cases for meeting critical operational requirement shall be permitted with 20% reduction against condemnation as a replacement measure and with the concurrence of Finance Department. The already condemned vehicles must be auctioned and auction proceeds deposited as miscellaneous Revenue before submitting such proposal," the order said. It also directed administrative secretaries that travel expenditure should be regulated so as to ensure that each department remains within the allocated budget. "Re-appropriation/augmentation proposals on this account will not be entertained," it said, adding that international travel shall not be allowed until specific permission is granted by the Finance Department.

has finally made a comeback to the India squad with his selection for the five T20Is against England starting on January 22 in Kolkata. He returns after last playing for India in the ODI World Cup final in November 2023, after which he had ankle surgery and also suffered from knee-related niggles.

The T20I squad, led by Suryakumar Yadav, was picked by the selectors on Saturday but they are yet to announce India's ODI squad for the three matches against England in February as well as the provisional 15 for the Champions Trophy, the deadline for which is January 12.

Jasprit Bumrah was not among the 15 for the T20Is against England, with uncertainty still prevailing over the nature of the injury  $that \, prevented \, him \, from \, bowling \, in \, Australia's$ second innings of the fifth Test in Sydney.

Rishabh Pant, who was India's preferred wicketkeeper at the 2024 T20 World Cup and in two of the three T20Is in Sri Lanka in July last year, was not part of the squad; he was likely rested along with Yashasvi Jaiswal and Shubman Gill after playing the Test series in Australia. #### **James Anderson in** talks to play for Lancashire in 2025 season

ames Anderson looks set to make a professional comeback in Division Two of the County Championship next season, after it was revealed he is in talks with Lancashire about an all-format return that will take his career past his 43rd birthday.

Anderson played his 188th and final Test against West Indies at Lord's in July 2024. He bowed out after 21 years as an England cricketer with 704 Test wickets at 26.45, and has not featured competitively since.

However, he showed he had unfinished business when he put himself forward for the IPL auction in December - where he went unsold - and has staved fit during his role as England's Test bowling coach, with regular stints in the nets plus work with the team's strength and conditioning coaches.

Now, according to The Telegraph, he is ready to commit to at least one final season with Lancashire - the club that first signed him as a teenager almost a quarter of a century ago, and for whom he made his first-class debut in 2002.

Lancashire were relegated from the top flight of the  $County\,Champions hip\,last\,season, although\,Anderson$ demonstrated his enduring prowess in first-class cricket with figures of 7 for 35 in his solitary appearance against Nottinghamshire at Southport in June.

He is expected to be available from the start of the 2025 season, including a return to Lord's to face Middlesex in Lancashire's opening match from April 4 to 7, and - assuming he continues his coaching role with England - he could feature in five matches before the Test summer begins with a one-off match against Zimbabwe in May.

Anderson's comeback would also have to be combined with his burgeoning media duties, while Lancashire would also have to pay his wages for the first time in more than a decade, now that he is no longer an ECB centrally contracted player.
