CM Omar Stresses On Planned Development

JAMMU: Chief Minister Omar Abdullah today chaired a series of meetings to review and discuss implementation of proposed urban planning schemes and policies aimed at transforming the urban landscape of Jammu and Kashmir to bring about planned development in urban areas.

During the meeting, the Chief Minister was briefed on the Land Pooling Policy, including its background, guiding principles, and objectives. Under the land pooling policy, developers or private land owners shall come together to pool their land and obtain authorization for development.

While authorizing development, the concerned urban governance agencies shall keep sufficient land for development of infrastructure, wide roads, parks, open spaces and other amenities and the remaining land would be returned to the landowners which they would share proportionately among themselves.

The benefits of land pooling for various stakeholders would be that the value of land increases for the landowners and better infrastructure gets created as compared to the irregular land plots pooled by the landowners developing that land parcel.

This would help in creation of infrastructure as a sustainable alternative to conventional land acquisition methods. The scheme is aimed tobe a win-win situation for both the government and various stakeholders, including individual landowners and real estate developers.

As per understanding reached between two sides, 95 percent jobs would be exclusively reserved for natives of Ladakh, while five percent jobs would be kept open for those living in Union Territory for minimum 15 years.

For this, according to sources, domicile certificate would be issued to those who are living in Ladakh for minimum 15 years. "The domicile certificate

wouldn't confer them any other

right," they said. Of 95 percent jobs for natives, 80 percent would be reserved for scheduled tribes, one percent for scheduled caste, 10 percent for economically weaker sections (EWS) and four percent for those living close

Rahul Triggers Row With 'Fighting Indian State' Remark, BJP Says He Has Exposed Cong's 'Ugly Truth'

NEW DELHI: Congress leader Rahul also strengthened this belief. Gandhi's remarks that "we are now fighting the BJP, the RSS and the Indian state itself" triggered a row on Wednesday with the BJP claiming that the Congress' "ugly truth" has been exposed by its own leader and that his statement was straight out of "George Soros' playbook".

Addressing party leaders after the inauguration of the Congress' new headquarters at 9A, Kotla Road here, Gandhi said, "Do not think that we are fighting a fair fight. There is no fairness in this. If you believe that we are fighting a political organisation called the BJP, that we are fighting a political organisation called the RSS, you have not understood what is going on.

Kharge condemns Bhagwat's 'independence' remark

NEW DELHI: Congress president Mallikarjun Kharge on Wednesday condemned RSS chief Mohan Bhagwat's remarks that India's 'true independence' was established on Ram temple consecration day, and warned that it would become difficult for him to move around in the country if he continues to make such statements.

Addressing party leaders after the inauguration of the Congress' new headquarters located at 9A, Kotla Road here, Kharge said RSS people believe that independence was achieved with Ram Temple inauguration and don't remember the independence of 1947 as they did not fight for it.

"You would know that those people who had nothing to do with independence and did not fight for it are making such statements. I read the statement by the RSS chief. He said real independence was established with the inauguration of the Ram Temple. He had inaugurated the temple along with (Prime Minister) Narendra Modi...Modi believes that independence was achieved in 2014 when he became PM," he said.

"RSS people believe that independence was established with Ram Temple inauguration. It is a matter of shame that even though we got independence in 1947 they are not acknowledging it because they did not struggle for it, go to jail, and therefore they do not remember. We remember because our people died for independence and struggled for it," he said.

Kharge condemned Bhagwat's statement and said that "it would become difficult for him to move around in the country if he keeps giving such statements".

The Congress chief's remarks come after Bhagwat said the date of Ram temple consecration in Avodhva should be celebrated as "Pratishtha Dwadashi", as the "true independence" of Bharat, which faced "parachakra" (enemy attack) for several centuries, was established on this day.

Kharge said the Congress headquarter would become the centre of fighting forces that are working against the Constitution and democracy.

DELHI AIRPORT: 6 Flights Diverted, Over 300 Delayed As Fog Impacts Operations

New Delhi, Jan 15: Six flights were diverted, more than 300 flights delayed and departures were briefly put on hold at the Delhi airport early morning on Wednesday as low visibility conditions due to dense fog significantly impacted operations.

"Runway visibility at Delhi Airport is improving, and flight operations are gradually resuming," airport operator DIAL said in an update on X at 2.20 pm.

An official said six flights were diverted to Jaipur between 8 am and 10.30 am due to adverse weather conditions in the national capital. Also, departures were put on hold for a brief period early this morning amid low visibility conditions.


Amid the high-pitched campaigning for next month's Delhi Assembly polls, the leader of the opposition in the Lok Sabha visited Rithala and celebrated Makar Sankranti with residents of the area where he had "Dahi-choora" on the occasion and also served it to some women.

After his visit, Gandhi shared on X a video of the "nullah" flowing through the area and wrote, "This is Kejriwal's 'shining' Delhi — the Delhi like Paris!" He used the hashtag "#SaafKaroDilli" with

his post. In the video, Gandhi can be seen walking through piles of garbage along the "nullah" as he showed its pitiful condition and lack of roads to the people accompanying him. He can be heard saying, "See Delhi, the shining

Delhi... Delhi like Paris. It is the same situation everywhere." The Congress also shared the video of his interaction with locals and said, "This is Delhi -

which Kejriwal ji had claimed will shine. He had



talked about making it like Paris and London."

"Watch, understand and use the power of your vote," the party said, using the hashtag "#SaafKaroDilli". Gandhi was campaigning in favour of Sushant Mishra, the Congress candidate from Rithala.

JK Govt asks people to register over 65 feet deep tube wells, borewells within 15 days

SRINAGAR: The Jammu and Kashmir Government has asked people including Government, Semi-Government Or individual persons to register bore wells and tube wells within 15 days.

Department of Public Health Engineering (PHE), Ground Water Division Srinagar, has issued a public notice on Wednesday mandating the registration of bore wells and production wells across Kashmir

Executive Engineer PHE Ground Water Division, Srinagar Hakeem Mushtag said the directive, based on the Jammu & Kashmir Water Resources Regulatory Authority (JKWRRA) regulations of 2010 and 2011, aims to regulate groundwater usage and prevent exploitation of this vital resource

He said as per the act, it is



mandatory for all individuals, firms, industries, factories, institutes, organizations, workshops (whether government, semi-government, or private) constructing, operating, or using bore wells or production wells within their premises or jurisdiction in Kashmir to register these wells with the Department of Public Health Engineering (PHE), Ground Water

Division Srinagar.

"This registration must occur thin 15 days from the date of construction. However, most of these entities have failed to do so until now," He added.

The notice requires all individuals, firms, industries, factories, institutes, organizations, and workshopswhether government, semigovernment, or private—constructing, operating, or using bore wells deeper than 65 feet to register these wells within 15 days. Non-compliance will result in strict action as per JKWRRA rules, the department warned.

Additionally, users already registered with the department have been instructed to clear any pending dues within the same timeframe. The department has cautioned that defaulters' names will be published in newspapers, followed by legal action.

The PHE Division has urged public cooperation to regulate and conserve groundwater resources in Kashmir and has appealed to citizens to report any misuse of groundwater in their respective areas. Sweden: Researchers have found a study that sperm is affected by diet and its results appear rapidly. The research also gave new insights into the sperm process which, in the long term, can continue to assess sperm values by modern testing methods. The study published in 'PLOS Biology' was found by researchers at Linkoping University who fed healthy young men a high sugar diet. Anita Ost, a senior lecturer in the Department of Clinical and Experimental Medicine at the University, and also the head of the study said: "We see that diet influences the motility of the sperm, and we can link the changes to specific molecules in them. Our study has revealed rapid effects that are noticeable after one to two weeks.'

Many environmental and lifestyle factors,

including obesity and related diseases, may affect sperm quality, such as type 2 diabetes, are well-known risk factors for poor sperm quality.

Epigenetic anomalies, which influence physical properties or rates of gene expression, are of concern to the research group which conducted the new study, even if the genetic material, the DNA code, is not altered. In some cases, such epigenetic changes will contribute to the transmission of properties through the sperm or egg from parent to parent.

In an earlier study, researchers have shown that male fruit flies that had eaten excess sugar shortly before the patient became overweight more often produced offspring. Scientists have hypothesized that RNA sperm fragments may engage in epigenetic

processes, but it is too early to tell whether they do in human beings. The new study was initiated by the researchers to investigate whether high consumption of sugar affects the RNA fragments in human sperm.

The study examined 15 normal, non-smoking young men, who followed a diet in which they were given all food from the scientists for two weeks. The diet was based on the Nordic Nutrition Recommendations for healthy eating with one exception: during the second week, the researchers added sugar, corresponding to around 3.5 litres of fizzy drinks, or 450 grammes of confectionery, every day. The sperm quality and other indicators of the participants' health were investigated at the start of the study, after the first week (during which they ate a healthy diet), and after the second

week(when the participants had additionally consumed large amounts of sugar).

One third had poor sperm motility at the beginning of the test. Motility is one of several factors influencing the quality of sperms, and that of the general population was the proportion of people with low sperm motility studied. The authors were surprised to learn that the motility of sperm of all participants during the research had become

natural. "The study shows that sperm motility can be changed in a short period, and seems to be closely coupled to diet. This has important $clinical \, implications. But we can {\it `tsay} \, whether$ it was the sugar that caused the effect, since it may be a component of the basic healthy diet that has a positive effect on the sperm," said Anita Ost.

Asthma may lead to infertility, barring regular medicine-takers

LONDON: It seems Asthma is linked to infertility, but not among women taking regular asthma preventers. A European Lung Foundation-study said that women with asthma, who use long-acting asthma preventers, conceive as quickly as other women, breaking the previous conception that women with asthma who only use short-acting asthma relievers take longer to become pregnant than other women. The study was conducted on more than 5,000 women in Australia, New Zealand, the United Kingdom and Ireland and was led by Dr Luke Grzeskowiak. He claimed that the results provide reassurance for asthmatic women that using inhaled corticosteroids to prevent symptoms does not appear to reduce fertility.Dr Luke explained, "Five to ten percent of all women around the world have asthma and it is one of the most common chronic medical conditions in women of reproductive age. Several studies have identified a link between asthma and female infertility, but the impact of asthma treatments on fertility has been unclear". "Studying the effect of asthma treatments in women

who are pregnant or trying to get pregnant is important as women often express concerns about exposing their unborn babies to potentially harmful effects of medications", he further noted.

The researchers examined data from the international Screening for Pregnancy Endpoints (SCOPE) study, which recruited over 5,000 women expecting their first babies in the early stages of pregnancy. Women were asked if they had been diagnosed with asthma and, if so, which medicines they had used. They were also asked how long it had taken them to become pregnant. More than ten percent of women in the study said they had asthma and, overall, these women took longer to get pregnant.

When researchers separated this group according to the types of asthma treatments they were using, they found no difference in fertility between women using long-acting asthma treatments and women without asthma.

Often, men suffering from the disorder are shy in seeking medical help and start self-diagnosis or consult quacks, a practice that can be extremely detrimental for the condition. It is important to understand that a cure for this problem is available at all ages.' Due to the stigma associated with ED, people pursue

than gaining a proper understanding of the causes behind the disease. Apart from a sedentary lifestyle, medical conditions

such as heart diseases, type 2 diabetes, chronic kidney disease, high blood pressure, high cholesterol, obesity and injury to the urinary system, spinal cord or penis can lead to erectile dysfunction.

Moreover, regular intake of antidepressants, antiandrogens, sedatives and hypertension medication can occasionally become the cause of this problem. Age can also play a role in the issue.

'Many researches have revealed that ED is one of the major causes of unconsummated marriages in India, leading to high psychological impact. Patients have the same queries, 'Does this mean that I can never be a father?' 'Is IVF now my only option?'. Most of the individuals suffering from the disease don't know that there are multiple treatment options available for them. There are implants available where a device is inserted in the penis that can be activated whenever the requirement arises. Moreover, with the advancement of technology, many painless yet effective ways to manage the problem have emerged," explained Dr. Vineet Malhotra, Diyos Men's Health Center

"There was a time when Army's support was necessary to hoist the tricolor at Lal Chowk in Srinagar. But today, no one dares to do any mischief when Krishna Janmashtami procession passes through the Lal Chowk," the home minister said.

Nearly 2.80 crore tourists, mostly from Gujarat, have visited Kashmir and returned safely without facing any issues, he said, adding that this transformation was the result of PM Modi's hardworking, sensitive and alert leadership.

"Under the PM's leadership, India became the fifth largest economy in the world, and it is certain we will reach the third spot in 2027. And, we are working towards making India the number one country by 2047 and God will definitely help us in our endeavour," said Shah, Lok Sabha MP from Gandhinagar.

protection laws in J&K. He sensitised them about their mandate and asked them to use their writ to act against the violators as per laws in force.

The Chief Secretary also reviewed the works being carried out by JMC, SMC and Directors of ULBs in both the divisions of Jammu and Kashmir.

Commissioner Secretary, H&UDD, Mandeep Kaur, presented an overview of different projects proposed and approved by GoI under SBM 2.0 for districts of the UT. She revealed that the facilities for both solid and liquid waste treatment are being created all over I&K in addition to inviting tenders for treatment of legacy waste on scientific lines.

Commissioner JMC, Devansh Yadav, threw light on the detailed works undertaken by the JMC, SMC and other local bodies in different parts of J&K. He elaborated that the waste is segregated for its treatment and the solid waste is being taken to MRF facility where as the liquid one to compost units for making good soil or Bio-CNG plants for fuel making.

It was further explained that different components of the waste are treated differently with some producing Refuse Derived Fuel (RDF) being used by cement factories. It was added that only the inert waste without any use is sent to landfill sites for its final disposal.

Regarding the facilities created in various districts, it was divulged that MRF of the capacity of 40 TPD by JMC and 100 TPD by SMC is presently in operation for treating its waste. In addition, the ULBs of Jammu had installed the capacity of 79 TPD 17 locations and ULBs of Kashmir 18TPD at 9 locations across Kashmir.

Moreover, for treating the liquid waste STPs of the capacity of 25.29 MLD had been established by SMC, 36.7 MLD by LCMA, 71 MLD by JMC, 13.6 MLD by the ULBs of Jammu and 6 MLD collectively by the ULBs of Kashmir division.

Regarding the upcoming facilities of waste management, it was informed that an MRF facility of the capacity of 150 TPD would come into operation at Kotbalwal in September this year and one of 55 TPD at Bandurakh for JM. For SMC, an MRF of the capacity of 459 TPD is soon going to be approved by MoHUAunder the revised action plan.

As far as upcoming STPs are concerned, it was added that STPs of the capacity of 66.9 MLD are under construction in Srinagar, Sonamarg, Baramulla and Charar-i-Sharif in Kashmir Valley. In Jammu, the STPs of the overall capacity of 109.2 MLD are going to be established at Jammu, Akhnoor, Samba, Kathua and Katra towns.

Regarding the remediation of legacy waste, it was revealed that a total of 6.16 lakh MT has been tendered out by JMC and 11 lakh MT by SMC for its

treatment. Similarly, ULBs of Jammu has tendered 1.87 lakh MT and 2.98 lakh MT of legacy waste by ULBs of Kashmir for its treatment through NAFED.

The meeting was further apprised that legacy waste of the magnitude of about 1.56 lakh MT by JMC, 1.72 lakh MT by 36 ULBs of Jammu and 0.78 lakh MT by 40 ULBs of Kashmir stands remediated till date. Besides, the PDMC consisting of engineers and design analysts for taking up works of waste management in smaller ULBs of J&K is going to be finalised soon.

The meeting was also apprised that on an average 450gm/person/day of waste is generated in big cities and 300 gm is generated in smaller towns. The municipal bodies have been tasked to segregate the dry and wet waste and process it on scientific lines to reduce the environmental pollution as per the NGT guidelines.

The meeting also delved into the Transferable Development Rights (TDR) Policy, focusing on its broad contours, objectives and mechanisms. The potential use of TDR for heritage properties, ensuring their preservation while enabling urban growth was also discussed. Under TDR scheme, for the land surrendered by a land owner or a developer freeof-cost for public purposes such as road widening, public passage, for conservation, heritage and other infrastructure development, shall be granted a nonfinancial compensation in the form of a TDR certificate specifying the Built-Up Area (BUA) or Floor Area Ratio (FAR) given to a land owner or developer which he can utilize in remaining part of his property or build elsewhere and even monetize by selling TDR to any other developer or user in receiving areas.. This would allow developers to build over and above the permissible Floor Area Ratio (FAR) for the land surrendered in congested areas.

The concept of Transit-Oriented Development (TOD) was also discussed, with emphasis on its objectives to promote sustainable urban mobility and to ensure planned development around public transport stations. The stipulations of TOD would facilitate compact, walkable urban spaces around transit hubs.

Separate discussions were held on proposed services under Integrated Solid Waste Management (ISWM) for municipalities and urban local bodies across Jammu and Kashmir. Presentations by Housing & Urban Development department outlined strategies for collection, transportation and processing of solid

Chief Minister exhorted the Housing & Urban Development Department to initiate implementation by taking up projects under Land pooling, TDR & TOD to create few success stories which would infuse confidence among stakeholders to adopt these urban planning strategies for overall development of our cities.

Besides, the meeting discussed management of waste disposal facilities, cleaning of roads, drains and waterbodies on Public-Private Partnership (PPP) model.

A presentation on the challenges of solid waste management in Udhampur district depicted dumping of daily waste at landfills resulting in choking of drains and water channels.

Proposed solutions discussed included waste segregation, recycling mechanisms, and pollution control machinery to tackle these pressing issues

Representatives of the National Bank for Financing Infrastructure and Development (NaBFID) also delivered a separate presentation. The discussion focused on infrastructure development projects across Jammu and Kashmir.

The meetings were attended by Advisor to the Chief Minister Nasir Aslam Wani, Chief Secretary Atal Dulloo, Additional Chief Secretary to the CM Dheeraj Gupta, Principal Secretary Finance Santosh D Vaidya, Commissioner Secretary Housing & Urban Development Department Mandeep Kaur, and other senior officials. Officers based in Srinagar participated through video conferencing.

Pending 3% DA, regularization of 61,000 daily wagers Employees to protest on Jan 16: EJCC Chief



SRINAGAR: Frustrated with the delay in the release of 3% Dearness Allowance (DA) for over seven months and demanding the regularization of daily wagers, the Employees Joint Consultative Committee (EJCC) is set to hold protest demonstrations in both Jammu and Srinagar.

Speaking to the news agency—Kashmir News Observer (KNO) over the phone, Aijaz Ahmad Khan, Chairman of the EJCC, outlined the key issues prompting the protests. These include the pending 3% DA since July 2024, unresolved house rent allowance matters, and amendments made by the previous government to SRO 43, which they believe should be restored to its original 1996 form under the Farooq Abdullah-led government.

"Additionally, we have urged the government to regularize 61,000 daily wagers. Before the elections, political leaders, including Omar Abdullah, promised that employee-related issues would be resolved immediately after the polls. Unfortunately, it seems the government is not serious about addressing these concerns. This protest aims to ensure our voices are heard," Khan said.

The protest, initially planned for January 13, was postponed due to the Prime Minister's visit to inaugurate the Sonamarg Tunnel. As per employee leaders, the demonstration has now been rescheduled for January 16 in both Srinagar

"The protest was originally planned at the Srinagar Press Colony and in Jammu. However, given the Prime Minister's visit to Jammu and Kashmir on January 13, our core group decided it would be inappropriate to hold the protest on the same day. Therefore, the event has been moved to January 16," Khan said.

He further noted that during this phase, the protest will be led by EJCC leaders in both regions, without involving general employees at this stage. "If the government does not take notice of our concerns after this demonstration, we will decide on the next course of action," the EJCC Chairman said.
