AKHNOOR: Declaring that Jammu and Kashmir remains "incomplete" without Pakistan-occupied Jammu and Kashmir (PoJK), Defence Minister Rajnath Singh delivered a strong message to Pakistan on Tuesday warning Islamabad to dismantle its terror infrastructure or face serious consequences.

Speaking at a gathering of armed forces veterans in Akhnoor, Singh emphasised that the abrogation of Article 370 has initiated a transformation in the region.

"The situation in Jammu and Kashmir has changed drastically, and this truth must be accepted. Jammu and Kashmir is incomplete without PolK, which remains the crown jewel of India," he said.

Reaffirming India's stance, Singh said, "For Pakistan, PoJK is nothing more than foreign territory" and the aspirations of the people of Jammu and Kashmir have never aligned with those of Pakistan.

He cited the sacrifices made by many Muslim residents of the region in the fight against terrorism, highlighting that PoJK has been exploited by Pakistan as a base for terrorist training camps and infiltration



Head-on Collision

5 killed, two critically injured in Kargil accident

SRINAGAR: At least five persons were killed while two others sustained critical injuries after two vehicles had head-on collision at Shilikchey area of Kargil district on Tuesday, officials said.

An official told the news agency-Kashmir News Observer (KNO) that two vehicles – a Scorpio (UP79A/1150) and a tipper (JK02AD/5118) — collided head-on, causing both to plunge into a deep gorge. They said a rescue operation

was launched immediately.

"All the victims were rushed to the hospital, where doctors declared five dead. The other two are in critical condition," the official said. He added that three of the deceased were locals, while the remaining two were non-locals.

The locals who lost their lives have been identified as Mohd Hassan, son of Mohd Hussain, a resident of Stakpa; Liyaqat Ali, son of A.K. Raza, a resident of Choskore; and

Mysterious disease claims another life in Rajouri; death toll reaches 14

SRINAGAR: A six-year-old girl has succumbed to a mysterious disease in



Badhaal village, located in the Kotranka sub-division of Rajouri district, bringing the death toll to 14 since December 2024. The latest victim passed away in a local hospital while receiving treatment.

The outbreak has sparked widespread panic among residents as the disease continues to claim lives, including many

children, in the village.

Residents of Badhaal are increasingly worried by the fatalities, especially since the victims do not belong to any single family. This has left every household concerned about the health of its members.

Symptoms exhibited by the victims include high fever, excessive sweating, vomiting and episodes of loss of consciousness. Despite extensive medical management, the precise cause of the illness remains unidentified. This has prompted doctors to treat cases symptomatically while waiting for definitive findings.

According to the news agency-Kashmir News Observer (KNO), Minister of Health Sakina Itoo discussed the situation, saying, "In December, there were several mysterious deaths recorded in the district, which were later controlled.

SC acquits brother-in-law convicted for abetting woman's suicide over dowry

NEW DELHI: The Supreme Court has acquitted a man convicted for abetting a woman's suicide in a dowry case observing there was no evidence like aiding or instigating her to take the extreme step.

Abench of Justices J B Pardiwala and R Mahadevan therefore set aside an order of the Allahabad High Court that had upheld the conviction of the man, who was the brother-in-law of the woman who died by suicide.

"There is practically no evidence on the basis of which it could be said the appellant herein as brother-in-law abetted the commission of suicide...," the bench held.

"In the absence of any cogent evidence as regards harassment or abetment in any form like aiding or instigating," it said in a January 9 verdict, "the court cannot



straightaway invoke Section 113B B of the Evidence Act, 1872 and presume that the accused abetted the commission of suicide."

The prosecution alleged harassment of the woman by her husband, in-laws and the appellant due to which she set herself ablaze

on September 27, 1990 and succumbed to severe burn injuries.

Her father got an FIR registered with the Ajgain Police Station, Unnao on the same day.

The police later filed a chargesheet under relevant provisions for the alleged offences against four accused persons, including the brother-in-law.

The trial court had initially framed a dowry death charge under Section 304-B of the IPC against the accused but acquitted them, and instead convicted them under Section 306 and 498 of the IPC besides Sections 3 and 4 of the Dowry Prohibition Act for the abetment of suicide.

While the woman's parents-in-law died during the pendency of the appeal, her husband had undergone the sentence imposed by the trial court.

Accusing the BJP of adopting unfair means, Kejriwal claimed that the party is distributing jackets, shoes, sarees, money and even gold chains to buy votes.



election' will be a milestone towards achieving the goal of 'Viksit Bharat' or developed India, Union Agriculture and Rural Development Minister Shivrai Singh Chouhan said on Tuesday, as he gave a call to people to come out in support of the proposal.

Speaking at an event organised by 'Panchjanya', a magazine associated with the Rashtriya Swayamsevak Sangh (RSS), Chouhan said the whole government machinery halts at the time of elections, and frequent polls have become a major disruptor for governments to take decisions in public interest.

Asked about the proposal to hold simultaneous polls that is under the scrutiny of a joint parliamentary panel, Chouhan said, "The makers of our Constitution made a provision for elections every five years, but they never thought that Article 356 will be misused so many times. Elections were held together till 1968 because till 1966, Congress had governments everywhere. When other parties started coming to power, they were toppled."

"At present, there is some election or the other all the time. Now Delhi is going to polls, then it will be Bihar. Political parties are only preparing for elections 365 days, they are not able to work in public interest. "The agriculture

"Should nothing happen in the country apart from elections? These continuous elections are the biggest barriers in India's development. Looking at the situation today, this (simultaneous polls) is an appropriate step," he added. The Congress' outburst came on the first anniversary of the lunch of the 'Bharat Jodo Nyay Yatra' that began in Manipur.

The Congress had launched Rahul Gandhiled 'Bharat Jodo Nyay Yatra' from Manipur on January

14 last year aiming to put the spotlight on issues such as unemployment, price rise and social justice.

A Congress' rally at Shivaji Park in Mumbai had marked the culmination of the 'Bharat Jodo Nyay Yatra', which was carried out in hybrid mode in the run up to the Lok Sabha polls.

"Today, exactly a year ago, the Bharat Jodo Nyay Yatra was launched by the Indian National Congress from Manipur. The BJNY followed in the wake of the historic Kanyakumari to Kashmir Bharat Jodo Yatra and covered 6,600 kms going through 15 states, culminating in Mumbai on March 16, 2024," Congress general secretary Jairam Ramesh said in a post on X.Jammu and Kashmir tourism

"Manipur still awaits a visit by the Prime Minister, who has found the time, inclination, and energy to go all over the world – but has not seen it necessary to reach out to the distressed people of Manipur," he added.

The prime minister has "steadfastly refused to meet with political leaders of Manipur, including his own party legislators and the CM himself", Ramesh alleged.

"The agony of Manipur has continued unabated since May 3, 2023. Just a few days back the Parliamentary Standing Committee on Education, Women, Children, Youth, and Sports was asked to put offits proposed study tour to the state," he said.

Maintain decorum of Home Minister's post: Pawar on Shah's remarks

MUMBAI: Former Union Minister Sharad Pawaron Tuesday rubbished Union Home Minister Amit Shah's remarks that the BIP's victory in the November 20 Maharashtra assembly polls ended the politics of betrayal and treachery started by him in 1978.

"I was the chief minister in 1978. I am not aware about his whereabouts then," Pawar told reporters in Mumbai. "When I was the Chief Minister, there were people like Uttamrao Patil from Jan Sangh in my ministry," Pawar added.

The decorum of the post of home minister should be maintained, the NCP (SP) chief said, bemoaning the lack of communication between present political leaders.

"There used to be 'susanvad' (good communication) between political leaders earlier but that is missing now," he said.

"The victory of BJP in Maharashtra ended the politics

of instability and backstabbing excellent home ministers, but started by Sharad Pawar in 1978.

You (people) have buried such politics 20-foot in the ground," Shah had said, addressing a statelevel convention of BJP in Shirdi on Sunday.

Pawar recalled that then PM Atal Bihari Vajpayee had made him the vice-chairman of the Disaster Management Authority after the Bhujearthquake despite being in the opposition.

"This country has seen many

from his state," Pawar said, in an apparent reference to Shah being externed in 2010 from Gujarat for two years in connection with the Sohrabuddin Sheikh fake encounter case.

He was acquitted of all charges in 2014. "When he (Shah) could not stay in Gujarat (after being externed), he went to Balasaheb Thackeray for help," Pawar said.

He highlighted the role of the executing agencies in ensuring accountability and timely completion





Controversy erupts over appointment of non-nursing professional as Principal at MMINSR,

SRINAGAR: Discontent has erupted within the nursing community over the recent appointment of a non-nursing professional as Principal of the Madr-e-Meharban Institute of Nursing and Research (MMINSR) at Sher-i-Kashmir Institute of Medical Sciences (SKIMS)

The decision, made by the Director of SKIMS, has drawn strong opposition from nursing professionals, students, and various stakeholders, who have expressed concerns about its implications for nursing education and professional autonomy.

The Nursing Education and Research Trained Nurses' Association of India strongly objected to the appointment, citing it as a violation of Indian Nursing Council (INC) guidelines. These guidelines mandate that nursing institutions must be led by qualified and experienced nursing professionals. Javaid Ahmad, chairperson of the association,

said that such decisions undermine the expertise and leadership of highly qualified nursing faculty within the institution. "This decision disregards the qualifications and experience of



senior nursing professionals, undermining the sanctity of nursing education. Nursing is a specialized profession that requires leaders with in-depth knowledge of nursing sciences," he told news agency

KINS, adding that he has received numerous complaints from students and nursing officers expressing their concerns. The controversy has also brought attention to senior faculty

members at MMINSR, particularly Ayoub Dar, the senior-most nursing professional at the institute. With a postgraduate degree in nursing and over 15 years of teaching and administrative experience, Dar has been highlighted as a suitable candidate for the role. Critics argue that such experienced professionals were unjustly overlooked in favor of an individual lacking the necessary nursing background.

"What is the purpose of attaining the highest degrees in nursing if our professionals must work under non-nursing personnel? How can someone without knowledge of nursing ethics, pedagogy, and clinical practice do justice to this critical role?" Javaid questioned.

The nursing community is calling for the intervention of higher authorities, including the Health Minister and Chief Minister, to re-

consider the decision. They demand that the position of Principal at MMINSR, SKIMS Soura, be filled by a deserving and qualified nursing professional in accordance with INC guidelines. (KINS)

What Meta's Move To Community Moderation Could Mean For Misinformation

Meta, the parent company of Facebook, Instagram,WhatsApp and other services has announced it will discontinue its third-party factchecking programmes, starting in the US.

Journalists and anti-hate speech activists have criticised the decision as an attempt to curry favour with the incoming US president, Donald Trump, but there could be an even more cynical reason. Meta's strategy could be a calculated move for greater user engagement and income.

This decision marks a significant shift in how the social media giant addresses misinformation

Meta's official rationale for ending its independent $fact checking \, in \, favour \, of \, crowd sourced \, contributions$ centres on promoting free expression. Chief executive, Mark Zuckerberg, said that the company seeks to reduce censorship and will concentrate its enforcement efforts on illegal or highly harmful content.

 $This \, move \, aligns \, with \, broader \, discussions \, among \,$ governments, social media companies, civil society groups and the public on balancing freedom of expression and content moderation. These debates have become urgent, as there is mounting evidence that there are biases in content moderation.

For example, a 2023 University of Cambridge study discusses how biases in content moderation disadvantage the cultural, social, and economic rights of marginalised communities.

The crowdsourcing model does encourage participatory moderation. But professional factchecking can be more effective at ensuring accuracy and consistency in content moderation, due to the expertise and rigorous methods of trained factcheckers or automated models.

However, social media platforms, including Meta, make their revenue from user engagement. The type of content flagged as misleading or harmful often attracts more attention due to platform algorithms amplifying its reach.

A 2022 US study, for instance, shows that political polarisation increases truth bias, which is the human tendency to believe people with they identify with are telling the truth. This can lead to higher user

engagement with disinformation, which is further amplified by algorithms that prioritise attentiongrabbing content.

What might this mean for our digital information

1. Increased exposure to misinformation Without professional factcheckers, the prevalence of false or misleading content will probably rise. 2. The burden of verification

As professional oversight diminishes, the responsibility for assessing content accuracy falls on users. But many social media users don't have the media literacy, time, or expertise needed to evaluate complex claims. This shift risks amplifying the spread of falsehoods, particularly among audiences who are less equipped to navigate the digital

from unreliable sources, especially during the early stages, before an article went viral.

This evidence shows that organised groups can exploit crowdsourced moderation to amplify the narratives that suit them. Such a dynamic could undermine the credibility and objectivity of the moderation process, eroding trust in the platform. Millions of X users have already migrated to its rival Bluesky for similar reasons.

4. Impact on public discourse

Unchecked misinformation can polarise communities, create distrust, and distort public debate. Governments, academics and social groups have already criticised social media platforms for $their role\,in\,amplifying\,divisive\,content, and\,Meta's$ decision could intensify these concerns. The quality $of discussions \, on \, Face book \, and \, In stagram \, may \, decline$ as misinformation spreads more freely, potentially influencing public opinion and policy-making.

There is no perfect solution to the challenges of content moderation. Meta's emphasis on free expression resonates with longstanding debates about the role of tech companies in policing online content.

Critics of censorship argue that overly aggressive moderation suppresses important discussions. Meta aims to create a platform that fosters open dialogue and minimises the risk of suppression, by reducing its reliance on factcheckers.

However, the trade-offs are clear. Free expression without proper safeguards can enable the unchecked proliferation of harmful content, including conspiracy theories, hate speech and medical misinformation.

Achieving the right balance between protecting free speech and ensuring the integrity of information is a complex challenge, and one that is evolving. Meta's announcement to shift from professional $fact checking \, to \, crowd sourced \, community \, moderation$ risks undermining this balance by amplifying the spread of disinformation and hateful speech.

Why resilience won't solve the mental health crisis among young people

Around 20% of eight to 16 year olds in the UK had a probable mental health disorder in 2023, according to NHS statistics. This is up from 12.5% in 2017. At the same time, a 2024 report $from \, the \, Children's \, Commissioner \, for \, England$ found that more than a quarter of a million children were not able to access the mental health support they need.

Some have questioned whether we are dealing with a "genuine" mental health crisis or a different problem - a lack of resilience in children and young people. Resilience is the ability to bounce back from adversity, and higher resilience is linked to lower rates of mental ill-health in young

But the evidence around exactly what role resilience plays in mental health paints a more complex picture. What we do know is there are skills and actions that children can be taught to improve their mental wellbeing. But there's also a good argument for not ignoring other root causes of children's health problems.

Resilience often comes up in mental health discussions as a response to possible overpathologising – the tendency to interpret even mild signs of distress or sadness as symptoms of mental illness. This in turn could undermine young people's resilience because they are not able to differentiate between normal variation in human emotions and mental ill-health.

While the research evidence of overpathologising in young people is limited, it has been suggested that it might be a side-effect of increased mental health awareness education and campaigns. While such efforts reduce stigma around mental health, they may have increased the perception that disclosing issues with mental health is socially desirable.

A more balanced approach to mental health in education and society should teach young people both about symptoms of mental ill health to reduce stigma and about the normal range of emotions. This could involve noticing emotions without reacting to them – the non-judgmental awareness of emotions – and emotion labelling, since naming emotions we experience decreases their intensity. This may in turn enhance resilience.

But resilience can be misinterpreted as the need to be more "tough". This could lead to $excessive \, reliance \, on \, strategies \, such \, as \, emotion$ suppression-putting on a brave face-to manage emotions and this could under mine mental health.Society and mental health

Robust research shows that social factors, particularly poverty and discrimination, lead to poor mental health. Indeed, in the 2023 NHS survey, rates of probable mental health disorders were much higher in UK children whose parents

didn'thave enough funds to support their children's out-of-school activities.

Focusing on resilience as a solution to the mental health crisis risks shifting responsibility for mental health onto those affected, rather requires action from social media companies,

Overlapping approaches

What's more, mental ill-health prevention involves much more than resilience. It's tempting

Our wellbeing is also boosted by taking action. that benefits others and finding wholesome meaning and purpose in life. All of these skills can protect mental health and wellbeing.

For effective prevention, we need to start



than calling out and changing policies and systems contributing to poor mental health.

The impact of global crises, including climate change, is another example of this. The NHS survey found that over half of young people aged 17-25 reported feeling worried about the climate crisis. Claiming that children and teenagers should just be more resilient can distract from the responsibility adults face to take climate

Similarly, problematic social media use may undermine young people's mental health. Social media content may celebrate the achievement of extrinsic goals, which rely on the approval of others: fame, wealth and beauty. Research has linked a focus on extrinsic goals to poor mental

Teenagers may be particularly vulnerable to the addiction-like effects of social media due to normal developmental changes in their brains. Clearly, the solution here needs to include more than enhancing resilience in young people. It

to think that we have found the one approach, in this case resilience, that could shift the mental health crisis. But resilience closely overlaps $with other mental \, health \, concepts \, and \, approaches.$ These include self-regulation – the ability to manage our thoughts, emotions and behaviour.

For example, resilience and self-regulation are often fostered by the same approaches – the development of social-emotional skills or $mindfulness\,training.\,And\,if\,we\,look\,at\,the\,brain$ activity linked to resilience and self-regulation, we find close overlaps there too.

Instead of relying on a single concept or approach, we should focus on the key skills $underpinning \, mental \, health \, and \, well being \, shared$ across different approaches.

These skills include fostering emotional awareness, as well as the ability to manage rumination – repeated negative thoughts about past events-and reactivity to emotions. Building connections is important, as well as cultivating gratitude and awe.

thinking about mental health skills in the same way we are thinking about fostering maths and reading skills. Similarly, acquisition of mental health skills requires time, careful scaffolding, continuity, repetition and lots of practice.

 $This should be {\it reflected in Of sted} \, assessments$ and much more comprehensive and clearer guidance on mental health curricula grounded in robust research.

Poor mental health can undermine young people's academic outcomes and their lifelong prospects. It is time to recognise that piecemeal approaches, such as a focus on resilience, are just pieces of the puzzle. They are not the much $needed\, transformational\, solutions\, to\, the\, mental$ health crisis.

plans are being formulated to avoid future inconveniences for students.

"We are closely monitoring the situation in coordination with the Chief of Operations Team (COT) to ensure that textbooks reach children at the earliest," he said. These teams have been directed to act on genuine complaints within 24 hours. "We have already taken action in several cases where complaints were verified. State Health Agency Suspends Empanelment of Shifa Hospital for Guideline Violations

Srinagar: The State Health Agency (SHA) in Jammu and Kashmir has taken strict action against Shifa Medical Centre, Srinagar, suspending its empanelment for six months due to multiple violations of guidelines issued by the National Health Authority (NHA).

The hospital has also been penalized with a fine exceeding Rs 26 lakh for unauthorized payments collected from beneficiaries.

According to an official order issued by the SHA, the action was prompted by a series of grievances and complaints lodged against the hospital.

Beneficiaries reported that the hospital was coercing patients into out-of-pocket expenditures and denying treatment, actions that blatantly disregarded the guidelines of the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) and AB PM-JAY SEHAT schemes.

A surprise inspection conducted on November 23, 2024, revealed significant violations, corroborated through direct interaction with patients and beneficiaries. Following this, a show-cause notice was served to the hospital, requesting an explanation. However, Shifa Medical Centre failed to respond

Empanelment Guidelines, the committee decided to impose a six-month suspension on the hospital. Additionally, a fine of Rs 26,15,000 was levied for illegal

reastfed babies receive antibodies and protection from a variety of health conditions from their mothers in breast milk.

What to eat when breastfeeding

Mothers might need to eat more to make up for the calories that the baby consumes in breast milk. Some mothers do get hungry and need those extra calories. Breastfeeding mothers are encouraged to choose nutrientdense snacks such as peanut butter, yogurt,

Protein-rich foods can support milk production. Lean meats, legumes, dairy, and eggs are good choices.

Fish and other seafood are good choices, but they need to be low in mercury. Mercury can be harmful to the baby's developing nervous system. Clams, cod, haddock, salmon, sardines, and tuna are examples of lowmercury choices. Fruits and vegetables round out the healthy breastfeeding diet.

Get enough to drink

If your urine becomes dark, then you might need to drink more fluids. Normally urine ranges from pale yellow to amber.

Foods can affect the color of your urine. For instance, if you have recently eaten beets, then your urine will be darker. Aim for yellow urine to determine if you need to drink more

Water is perfect to help you stay hydrated. If that gets boring, there are other choices to help you stay hydrated, but it is best to avoid sugary drinks. You might be tempted to drink sports drinks for the electrolytes, but you could be getting a lot of sugar and caffeine too. It is important to read labels.

Some caffeine is okay. If you are a coffee drinker 2 to 3 cups (8 ounces each) are safe but if your baby seems agitated or has trouble sleeping, try reducing the amount of coffee to see if that makes a difference. Tea has less caffeine than coffee, and herbal teas usually do not contain any caffeine.

What to avoid when breastfeeding

If you drink alcohol, it will be in your

It is also important to avoid dehydration. breastmilk and no amount of alcohol is safe for your baby.

If you want to drink alcohol, consider pumping first so that you have milk for the baby. After drinking alcohol, it is best to wait for 2 to 3 hours after each standard drink before breastfeeding. This gives your body enough time to clear the alcohol.

Foods that should be limited

Limit the amount of caffeine you drink and choose fish and seafood that have minimal amounts of mercury.

Peppermint, sage, and parsley can decrease milk production. Sage dressing with chicken or turkey is not likely to affect your milk production. If you are drinking several cups of peppermint tea and massaging with peppermint essential oil daily and you are concerned about the amount of breastmilk you are producing, you might want to cut back to see if that helps.

To Clean Your Brain And Prevent Urodegeneration

rainwashing, more scientifically known as brain waste clearance, is a process during which harmful waste products, so called "biological trash", is removed from your brain. This is crucial for optimal brain functioning and to lower the risk of neurodegenerative diseases such as Alzheimer's disease, Parkinson's disease and dementia, which are associated with buildup of such harmful waste products. Only recently scientists discovered that your brain is cleaned only when you are sleeping.

Waste products build up in the body and brain throughout the day

First you might be wondering what needs to be cleaned and removed here? What is "biological trash"?

Throughout the day all cells in our body produce leftover molecules and metabolites due to cellular activity. There is also cellular debris and other harmful toxic molecules that get into our body from the surrounding environment. Moreover, due to various internal and external factors such as our genetic predispositions and UV exposure, certain proteins in our body might change their structure, lose their normal function and become harmful. All of these molecules need to be removed from our body to avoid health problems and disease.

Brain has a different system to clean waste products than the rest of the body

Our body has a wonderful "cleaning system" that removes such "biological trash" and detoxifies our tissues, called the lymphatic system. It consists of specific lymphoid organs, such as thymus, bone marrow and lymph nodes, lymphatic vessels and a fluid called lymph that circulates throughout our body and removes excess fluid and waste products.

However, not even a single trace of the lymphatic system is detected inside our brain. This is rather surprising as the brain is the most active organ of our entire body and therefore is likely to produce most waste products. In 2012 a groundbreaking study was published which showed that our brain has a different kind of waste

clearance system than the rest of the body. The study described the anatomical pathways and the working principle of the brains' waste disposal system, which was given the name of the glymphatic system. Apparently, the brain uses a system of tunnels that are formed around the brain's blood vessels by special brain cells called the astrocytes. Astrocytes belong to a group of so-called glial cells, hence the name glial + lymphatic = glymphatic. A special brain fluid

Brains' waste disposal system is ON when we sleep

Another groundbreaking study was released just a year later in 2013 which showed that waste products from the brain are removed almost only during sleep. Scientists injected a green dve into the brain of mice after which half of the mice went to sleep and the other half stayed awake. After two hours scientists checked how much of the green dye was left in the brains of

Surprisingly, brains of mice which stayed awake were still full of the green dye, while the brains of the ones that slept barely had any trace of green dye. These results indicated that substances are removed from the brain much faster during sleep when compared to being

Now many studies in various animal species including humans support the finding that our brains are cleaned from harmful molecules almost exclusively during sleep. For example, a 2018 study with 20 healthy adults showed that a single night of no sleep is associated with significant increase in levels of a specific brain waste product, a protein called amyloid-beta.

A 2021 study investigated how well an externally delivered molecule is cleaned from the brain if you sleep compared to if you don't sleep. Scientists delivered a special molecule called contrast agent into the brains of patients. Half of them were allowed to sleep and half were asked to spend one night not sleeping. When scientists scanned the brains of these 2 groups of patients, they found higher levels of the contrast agent in the no-sleep group compared to the group that slept. This means that even one night of sleep deprivation impairs brain waste clearance.

Build-up of certain waste products in the brain is associated with increased risk of neurodegenerative diseases, such as Alzheimer's, Parkinson's diseases and dementia. Now we know that our brain is cleaned and waste products removed when we are sleeping. This would mean that if we don't get enough sleep, we expose ourselves to higher chances of neurodegenerative diseases.

For example, one study examined nearly 8000 people and found that people who slept six hours or less per night in their 50s and 60s were 30% more likely to develop dementia later in life compared to those who slept 7 hours or more every night.

Another study investigated nearly 700 individuals who due to their genetic make-up were at risk of developing Alzheimer's disease. Researchers found that better sleep reduced the likelihood of developing clinical Alzheimer's disease and even reduced the amount of harmful proteins in the brain.

A recent 2020 study showed that sleep disturbances early on can even forecast how much of the harmful protein amyloid-beta will accumulate in a person's brain. The worse people sleep, the more likely they are to end up having larger amounts of amyloid-beta in their brain which is known to increase the risk of neurodegenerative diseases.

Build-up of waste products in our tissues is a physiological process that happens due to cellular activity. As long as these waste products are efficiently removed, we should not worry. Now we know that our brain has a different kind of waste disposal system than the rest of our body, which interestingly is ON only when we sleep. Therefore, make sure to get enough sleep every night to keep your brains "clean" (literally), and to reduce your risk of developing neurodegenerative diseases!

The Defence Minister recalled the bravery of the Indian Army during the 1965 war with Pakistan, emphasising the strategic brilliance and sacrifices that led to India's victory.

"History stands as a testament that Pakistan has lost every war against India – be it the tribal invasion of 1948, the 1965 war, the 1971 war, or the 1999 Kargil conflict. In each case, Pakistan has faced humiliation and defeat," he remarked.

Reflecting on the lessons learned from the 1965 war, Singh criticised the missed opportunity to capitalise on strategic military gains during negotiations, citing Haji Pir as an example where territory was ceded despite army success.

"If that had not happened, the routes for terrorist infiltration would have been closed back then. However, we began to change this by abrogating Article 370," he concluded.

The three-phase agreement — based on a framework laid out by US President Joe Biden and endorsed by the UN Security Council – would begin with the gradual release of 33 hostages over a six-week period, including women, children, older adults and wounded civilians in exchange for potentially hundreds of Palestinian women and children imprisoned by Israel.

Among the 33 would be five female Israeli soldiers, each of whom would be released in exchange for 50 Palestinian prisoners, including 30 convicted militants who are serving life sentences. By the end of the first phase, all civilian captives - living or dead - will have been released.

During this first, 42-day phase, Israeli forces would withdraw from population centers, Palestinians would be allowed to start returning to their homes in northern Gaza and there would be a surge of humanitarian aid, with some 600 trucks entering each day.

Details of the second phase still must be negotiated during the first. Those details remain difficult to resolve and the deal does not include written guarantees that the ceasefire will continue until a deal is reached. That leaves the potential for Israel to resume its military campaign after the first phase ends.

The three mediators, however, have given Hamas verbal guarantees that negotiations will continue as planned and that they will press for a deal to implement the second and third phases before the end of the first, the Egyptian official said.

The deal would allow Israel throughout the first phase to remain in control of the Philadelphi Corridor, the band of territory along Gaza's border with Egypt, which Hamas had initially demanded Israel withdraw from. But Israel would pull out from the Netzarim Corridor, a belt across central Gaza where it had sought a mechanism for searching Palestinians for arms when they return to the territory's north.

In the second phase, Hamas would release the remaining living captives, mainly male soldiers, in exchange for more prisoners and the "complete withdrawal" of Israeli forces from Gaza, according to the draft agreement. But Hamas has said it will not free the remaining hostages without an end to the war and a complete Israeli withdrawal, while Israeli Prime Minister Benjamin Netanyahu has in the past vowed to resume fighting unless Hamas's military and governing capabilities are eliminated.

Unless an alternative government for Gaza is worked out in those talks, it could leave Hamas in charge of the territory.

In a third phase, the bodies of remaining hostages rould be returned in exchange for a three- to fiveyear reconstruction plan to be carried out in Gaza under international supervision.

Growing pressure ahead of Trump's inauguration Israel and Hamas have come under renewed pressure to halt the conflict in the lead-up to Trump's inauguration next week. His Middle East envoy, Steve Witkoff, recently joined US, Egyptian and Qatari

The tragic sequence of events began on December 8 when Mohammad Fazal and his four children lost their lives, followed by the deaths of three children from another family, led by Mohammad Rafiq. Rafiq's pregnant wife also died on December 23, a case linked to medical negligence.

Two siblings succumbed to the illness on January 12, with another sibling passing away on January 13. On Monday evening, 62-year-old Mohammad Yusuf, a relative of the affected family, died at GMC Rajouri, and on Tuesday, a six-year-old girl succumbed.

Dr Rakesh Magotra, Director of Health Services Jammu, informed KNO that toxicology is likely behind these deaths, although no viral or infectious link has been established so far. He said experts from the national institutions have verbally noted the presence of toxins, and further investigations are ongoing.

He made out that the reports furnished by different institutions are now available with us and more are going to be received soon. He maintained that these should be enough to conclude the investigations and reach to possible reasons of these deaths reported from this particular village.

Dulloo also took this occasion to hear from the different experts from PGIMER (Chandigarh), NIV CSIR and NCDC about their findings after studying numerous samples taken from the affected persons or area. He also sought suggestions from them about the future course of action to be taken from here.

It was given out by these experts that after carrying out of extensive microbiological studies no viral, bacterial or microbial infection was found to cause these deaths. These were found to be localised and possibly having some epidemiological linkage.

It was also given out that certain neurotoxins were found in the samples of the deceased persons which is further investigated to know more about it.

It is pertinent to mention here that from 7th of December, 2024 about 12 deaths out of 38 affected persons were reported in three different incidents from the village Badhal of District Rajouri the causes of which were unknown.

The government has taken several measures including rushing of Rapid Response Teams, carrying out investigations of samples from humans and animals, testing of water etc besides taking assistance of reputed health institutions of the country to know about the actual causes behind these deaths.

In decontrolled Kashmir markets, sellers call shots

SRINAGAR: In absence of the government regulations, prices of essential commodities have skyrocketed in Kashmir and no quality check has added to the insecurities of the consumers.

The Department of Food Civil Supplies and Consumer Affairs (FCSCA) that regulated the prices and checked the quality of essential items like bread, mutton, vegetables, and milk lost its teeth after the markets were decontrolled in the Valley.

An official of the FCSCA department while talking to the news agency-Kashmir News Observer (KNO) said, "Our department has no power to regulate the prices of the essential commodities sold in the open market."He said that many years have passed since markets in Kashmir were decontrolled. "At present, shopkeepers and traders are free to fix the prices."Asked whether the department is authorized to check the quality of the items being sold in the market, the official said, "No." "In the open market it's the duty of the traders, vendors and shopkeepers to ensure that no substandard product is sold."

It may be recalled that earlier the government used to fix the rate of mutton, chicken and other items and special squads were deployed to check the quality of the essential commodities sold

"Butchers had to get the mutton stamped before selling it in the open market. The stamp was put by a SMC official under the supervision of an official of the Animal Husbandry Department," said an official.

He said that mutton prices were deregulated a few years ago. "At present there is no slaughter house in Srinagar. A new slaughter house is being constructed at Alocha Bagh in uptown. Once it becomes operational the mutton will be checked and stamped again," the official said, adding, "The process of putting stamps on mutton was a certification that it's fit for human consumption."

In December last year Kashmir Trade Alliance (KTA) had urged the government to regulate essential commodity prices in the Valley. "The decontrolled prices are hitting the common masses hard. There is a pressing need to revert to the previous pattern of price regulation to provide succour to the people," the KTA had said in a statement. According to the consumers,

prices of vegetables and other commodities have surged beyond previous highs. "Cost of the mutton has reached Rs 700 per kg, forcing many families to reconsider their food choices and cut down on consumption," said Mohammad Furgan.

"Without the fixed price lists and enforcement mechanisms that were once in place, the market has been left to operate without oversight. Prices of vegetables and other essential commodities vary from area to area. Earlier prices used to be consistent but now there is no regulation. Consumers have been left at the mercy of the sellers," said a resident.

Another consumer said, "The costs of bakery items like cakes, pastries and patties too have witnessed a steep hike. A plain cake which used to cost around Rs 40 not long ago is now being sold at Rs 80. Many bakery items have gone out of reach of the consumers due to exorbitant price hike."

The deregulation of markets besides hitting a common man hard has also created problems for the small businesses such as restaurants, roadside food vendors and others.

Common people have been left with no other option other than to cut back on what to eat, while the small business owners have increased the prices to

According to economists, supply and demand determine prices in a free market, government intervention is essential to prevent inflation and protect both producers and consumers. "A balance needs to be maintained to protect the interests of both buyers and sellers," said an economist.
