**JAMMU**: The Govt has been closely monitoring the situation in village Budhal, Rajouri, where an unexplained illness has claimed 14 lives. One child admitted in SMGS hospital is critical.

Investigations, and samples empirically indicate that the incidents are not due to a communicable disease of bacterial or viral origin and that there is no public health angle. Pertinently all samples have tested negative for any viral or bacteriological etiology. The tests were conducted on different samples in some of the most reputed labs of the country. These include National Institute of Virology Pune, National Centre for disease control New Delhi, National Institute of Toxicology and Rsearch Lucknow, Defence Research Development Establishment Gwalior, the Microbiology Department of PGIMER Chandigarh besides the ICMR-Virus Research and Diagnostic Laboratory, GMC Jammu.

### J&K parts receive fresh snowfall, rains lash plains

**SRINAGAR:** Jammu and Kashmir parts on Thursday recorded fresh snowfall while the rains lashed some areas in Jammu as well as in Central Kashmir districts, bringing down the mercury in the Union Territory.

As per the details collected by the news agency—Kashmir News Observer (KNO), the moderate snowfall was recorded in Sinthan Top, Duksum, Kokernag, Kishtwar, Poonch areas and other places where

up to six inches of snow accumulated this evening.

The fresh snowfall was experienced under the influence of a Western Disturbance (WD), which mostly affected the southern parts of Kashmir.

According to the details shared by the independent weather forecasters from Kashmir, Duksum recorded a snowfall of 6 inches while Pahalgam recorded around 4 inches and Baltal Pahalgam and Chandanwari recorded 6-8 inches of snow today.

Qaizgund recorded a snow accumulation of two inches while light snowfall of 2 cm was recorded in South Kashmir's Shopian and Pulwama areas.Reports of light snowfall

# Supreme Court Bats For Uniform Policy For Management Of Tiger Reserves Across India

Thursday favoured a uniform policy for management of tiger reserves throughout

A bench headed by Justice BR Gavai, which was hearing a matter related to Corbett Tiger Reserve in Uttarakhand, observed that it wanted to have a common policy on a pan-India basis.

"We want a uniform policy throughout the country so far as management of tiger reserves are concerned," said the bench, which also comprised Justices Augustine George Masih and K Vinod Chandran.

The bench observed the policy should also include the aspect of vehicular movements inside Tiger reserves.

Justice Gavai referred to the suo motu cognisance taken recently by the Bombay High Court over an incident where safari vehicles carrying

tourists obstructed the movement of a tigress and her cubs in Maharashtra's Umred-Pauni-Karhandla Sanctuary on

the New Year eve. "In Nagpur, I came across a news item.



Fortunately, the high court has taken a suo motu cognisance," Justice Gavai observed.

Senior advocate K Parameshwar, who is assisting the top court as an amicus curiae in the matter,

 $referred\,to\,an\,enquiry\,by\,the\,Central$ Bureau of Investigation (CBI) into the illegal construction and felling of trees in the Corbett Tiger Reserve.

The bench said it had seen the CBI's

report in the matter.

The counsel appearing for the Uttarakhand government informed the bench about the status of a departmental inquiry initiated against officials who were allegedly involved in illegal felling of trees and illegal construction in the Tiger reserve.

The state's counsel said departmental inquiry was complete in 17 cases and

When the state's counsel referred to the CBI enquiry, the bench said, "You are not concerned with the CBI. The CBI is directly reporting to us. Fortunately, it does not have to come via you".

The bench posted the matter related to the Corbett Tiger Reserve for hearing on March 19.

"We make it clear that if by March 19, we find that you are not sincere in taking action, then your chief secretary will be unnecessarily invited here," the bench said.

The bench said it also wanted to know what action has been taken against the officials concerned and how many of them have been penalised.

The state's counsel said he would file a detailed affidavit to place on record as to what was the stage of proceedings against these officers.

The bench said the CBI shall also file a report on further investigation carried out in the matter before the next date of hearing.



NEW DELHI: Indonesian President Prabowo Subianto will be the chief guest at India's 76th Republic Day celebrations on January 26, the Ministry of External Affairs (MEA) announced on Thursday.

Subianto will visit India from January 25 to 26 in his first trip to

The MEA said the forthcoming visit of the Indonesian President will provide an opportunity for the leadership of the two countries to undertake a comprehensive review of bilateral ties as well as to discuss regional and global issues of mutual



the country as president.

As a comprehensive strategic partner, Indonesia is an important pillar in India's Act East Policy and its vision of the Indo-Pacific, the MEA said.

"At the invitation of Prime Minister Narendra Modi, President of the Republic of Indonesia Prabowo Subianto will pay a state visit to India during January 25-26," the MEA said, "President Prabowo will also be the Chief Guest for India's 76th Republic Day celebrations," it said in a statement.

"India and Indonesia share warm and friendly ties spanning over millenia," it said.

Every year, India invites world leaders to attend its Republic Day

celebrations.

Last year, French President Emmanuel Macron was the Republic Day chief guest while Egyptian President Abdel Fattah El-Sisi graced the occasion in 2023.

There was no Republic Day Chief guest in 2021 and 2022 in view of the COVID-19 pandemic.

In 2020, then Brazilian President Jair Bolsonaro was the chief guest at the Republic Day celebrations.

In 2019, South African President Cyril Ramaphosa was the chief guest at the Republic Day parade, while in 2018, leaders of all 10 ASEAN countries attended the celebrations.

In 2017, Crown Prince of Abu Dhabi Sheikh Mohamed bin Zayed

Al Nahyan was the chief guest at celebrations, while then French President Francois Hollande graced the occasion in 2016.

In 2015, then US President Barack Obama watched the parade.

In 2014, then Japanese Prime Minister Shinzo Abe was the chief guest at the celebrations, while Bhutan king Jigme Khesar Namgyel Wangchuck attended the parade in

The heads of state and government who have attended the Republic Day celebrations include Nicolas Sarkozy, Vladimir Putin, Nelson Mandela, John Major, Mohammed Khatami and Jacques Chirac.

The then British Prime Minister John Major had attended the celebrations in 1993, Nelson Mandela participated as then South African President in 1995 while South Korean President President Lee Myung Bak witnessed the parade in 2010.

In 2008, Sarkozy participated in the celebrations as French President, while another French President Chirac graced the occasion in 1998. Other world leaders who have

attended the celebrations include Nepal's King Birendra Bir Bikram Shah Dev in 1999, Iran's then President Mohammed Khatami in 2003.

#### Label campaign material generated using Al: EC to parties ahead of Delhi polls

NEW DELHI: Amid increasing use of artificial intelligence in campaigning and its potential to influence voter opinion, the Election Commission on Thursday issued an advisory to political parties asking them to promote transparency and accountability in the use of AI-generated content.

The advisory introduces labelling and disclosure norms requiring parties to clearly label any images, videos, audio or other materials generated or significantly altered by AI technologies with a notation such as "Al-Generated"/ "Digitally Enhanced"/"Synthetic Content".

It also requires political parties to include disclaimers during dissemination of campaign advertisements or promotional content, wherever synthetic content is utilised.

Chief Election Commissioner Raiiv Kumar had recently cautioned against the potential of AI and deep fakes in compounding the malaise of misinformation.

He had expressed concern that deep fakes and misinformation have the potential to erode trust in electoral processes. During last year's Lok Sabha elections, the Commission had issued guidelines for responsible and ethical use of social



### No One Is Safe From Drug-Resistant Microbes Until Everyone Is Safe



SHOBHA SHUKLA

No one is safe until everyone is safe," said Dr Umesh Dahal, Director General, Department of Livestock Services, Government of Nepal. He was referring to antimicrobial resistance or drug resistance when microbes (such as bacteria, virus, fungi or parasites) stop responding to medicines which makes diseases difficult (or impossible) to treat.

Misuse and overuse of antimicrobial medicines is alarmingly high in human health, animal health, and agriculture, and it eventually impacts our environment too. With rising antimicrobial resistance (AMR), medicines are failing to treat diseases in human beings, plants, and animals.

"AMR can be prevented," said Dr Palpasa Kansakar, World Health Organization (WHO) National Professional Officer for AMR and Laboratories in Nepal. Dr Palpasa and Dr Umesh were among the experts at the South Asia Media Workshop to prevent AMR organised by Health TV Online, Global AMR Media Alliance (GAMA), Ministry of Health and Population of Nepal and partners.

"Universal access to high quality and affordable antimicrobials is an essential component of universal health coverage," said Dr Palpasa. She also pointed out that access to WHO recommended diagnostics and standard treatments should also be ensured at all levels for everyone if we are to deliver on universal health coverage. The use of antimicrobials underpins modern medicine. Without effective antibiotics, even minor surgery and routine operations could become high-risk procedures if serious infections cannot be treated. Microorganisms which become resistant to antimicrobials, so-called 'superbugs,' do not respond or respond less well to available treatments.

#### Reality check on antimicrobial use in human and animal

came to seek healthcare in outpatient clinics, 22% to 28% of them were found to buy antibiotics without prescriptions and did not complete the full recommended course of antibiotics.

The study referred to by Dr Joshi also looked at antimicrobial use by veterinary doctors. "Onethird of veterinarians had access to drug susceptibility testing facilities in their working areas. But only 32% of them went for this test before prescribing antibiotics," said Dr Pramod Joshi.

Drug-resistant infections arise when the microbes (including bacteria, fungi, viruses and parasites) that cause them change over time, developing the ability to resist the drugs designed to kill them. This genetic adaptation is driven by the exposure of microbes to antimicrobials in humans, animals and the environment over time. The result of this genetic adaptation is that many antimicrobial medicines like antibiotics - are becoming less effective at treating cer-

extreme poverty by 2030. AMR can directly affect progress in achieving at least 6 of the 17 United Nations Sustainable Development Goals and can also be linked indirectly to the remaining 11. Moreover, the spread of new resistant strains of bacteria in terrestrial and aquatic animals increases animal suffering and losses. This in turn affects livelihoods worldwide, as 1.3 billion people rely on livestock for their living and over 20 million people depend on aquaculture," said Dr Joshi.

"If antibiotics lose their effectiveness, we lose the ability not only to treat bacterial infections but also to manage other health conditions. For example, modern medicine is often dependent on infection prevention and control, and the ability to prevent and treat infections using antimicrobials - such

as during surger-

ies," said WHO

susceptibility testing, they should decline the indiscriminate use of medicines.

Dr Mishra added that "Let us ask questions to doctors why are we being prescribed antimicrobial medicines? Is the diagnosis accurate? Is drug susceptibility test report there? We also need to do a reality check on who should write a prescription. If a doctor is authorised to do so then what happens to those who reside in remote areas where there is no doctor?"

A major share of those who deal with drug-resistant infections and untimely deaths associated with AMR is attributed to TB (tuberculosis).

Drug-resistant forms of TB infected an estimated 410,000 people in 2022 globally as per the WHO Global TB Report 2023, informed Dr Prajowl Shrestha, Director of National TB Programme of Nepal. But only 43% of them (176,650) were diagnosed and initiated on treatment in the same year – or in other words, only 2 out of every 5 people with drugresistant TB could get diagnosed and put on treatment.

In South-East Asian region, 170,000 people developed drugresistant forms of TB in 2022 out of which only 74,300 were diagnosed and put on treatment (43%), shared Dr Shrestha.


#### Nepal is among the 30 high burden countries for drug-

resistant TB globally AMR threatens the effective prevention and treatment of an everincreasing range of infections. For instance, urinary tract infections, upper respiratory tract infections, typhoid and influenza are becoming difficult to treat, resulting in treatment failure, permanent disability or even death. Bacterial resistance to antibiotics directly caused 1.27 million deaths and indirectly caused, contributed to or was associated with an additional 4.95 million deaths annually in 2019. The emergence of extensively drugresistant gonorrhoea is another major public health concern.

Strengthening infection prevention and control, along with boosting access to standard quality diagnostics and treatments with equity globally - especially in low- and middle-income countries - is vital to curb AMR. Raising awareness and health literacy is a bedrock to advance progress towards preventing AMR, as well as towards universal health coverage.

Let us hope world leaders at next month's United Nations General Assembly High-Level Meeting on AMR will commit for stronger action to effectively address the global health threat that AMR poses.

Certificates were distributed among the trainees for successfully completing the three days training programme.



recent study has found that both moderate and strenuous exercise alleviate symptoms of anxiety, even when the disorder is chronic. The research has been published in the 'Journal of Affective Disorders' The study was based on 286 patients with anxiety syndrome, recruited from primary care services in Gothenburg and the northern part of Halland County. Half of the patients had lived with anxiety for at least ten years. Their average age was 39 years, and 70 per cent were women. Through drawing of lots, participants were assigned to group exercise sessions, either moderate or strenuous, for 12 weeks. The results showed that their anxiety symptoms were significantly alleviated even when the anxiety was a chronic condition, compared with a control group who received advice on physical

activity according to public health recommendations. Most individuals in the treatment groups went from a baseline level of moderate to high anxiety to a low anxiety level after the 12-week program. For those who exercised at relatively low intensity, the chance of improvement in terms of anxiety symptoms rose by a factor of 3.62. The corresponding factor for those who exercised at higher intensity was 4.88. Participants had no knowledge of the physical training or counselling people outside their own group was receiving.

"There was a significant intensity trend for improvement -- that is, the more intensely they exercised, the more their anxiety symptoms improved," stated Malin Henriksson, a doctoral student at Sahlgrenska Academy at the University of Gothenburg, a specialist in general medicine in the Halland Region, and

the study's first author. Previous studies of physical exercise in depression have shown clear symptom improvements. However, a clear picture of how people with anxiety are affected by exercise had been lacking up to now. The present study is described as one of the largest to date. Both treatment groups had 60-minute training sessions three times a week, under a physical therapist's guidance. The sessions included both cardio (aerobic) and strength training. A warmup was followed by circle training around 12 stations for 45 minutes, and sessions ended with a cool down and stretching. Members of the group that exercised at a moderate level were intended to reach some 60 per cent of their maximum heart rate -- a degree of exertion rated as light or moderate. In the group that trained more

intensively, the aim was to attain 75 per cent of maximum heart rate, and this degree of exertion was perceived as high. The levels were regularly validated using the Borg scale, an established rating scale for perceived physical exertion, and confirmed with heart rate monitors.

Today's standard treatments for anxiety are cognitive behavioural therapy (CBT) and psychotropic drugs. However, these drugs commonly have side effects, and patients with anxiety disorders frequently do not respond to medical treatment. Long waiting times for CBT can also worsen the prognosis. The present study was led by Maria Aberg, associate professor at the University of Gothenburg's Sahlgrenska Academy, a specialist in general medicine in Region Vastra Gotaland's primary healthcare organization, and corresponding author.

### BREASTFEEDING SECRETS EVERY MOM SHOULD KNOW

Breastfeeding seems to be a most natural process, but to some, it may be a challenge. Be patient and feed often, say experts.

Mimansa Malhotra (PT), Lactation Consultant and Lamaze child birth educator on behalf of Philips,  $and \, Shilpi \, Srivastava, Lactation \, Consultant \, at \, Mamma$ Mia, Fortis Memorial Research Institute, list some tips to keep in mind:

\* Try to nurse within the first hour after delivery. That's when your breast produces colostrum, or first milk. It is packed with nutrients in a small amount. And a small amount is just what a newborn

\* Feed often to increase supply. The rule is simple. The lesser you nurse, the lesser milk your body will produce. Ensure you are eating well and getting  $enough\,rest. You\,will\,need\,both\,as\,your\,body\,converts$ your calories to milk.

Ensure that when your baby is latched, his/her mouth should take in as much of the dark part of your breast, the areola, as possible. The baby squeezes the milk ducts beneath that area to draw the breast milk out. If your baby is only sucking on the nipple, it will pinch and hurt you. Also, the baby won't be able to get as much milk.

\* Don't be in a hurry to offer the second breast. It is perfectly alright to leave your baby on the first breast until he/she comes off on his/her own and then offer the second breast. Many babies take one breast at some feedings and both breasts at some. Don't be rigid and don't be scared.

\* As the experts say breastfeeding is a learning process in which both the counterparts are learning, hence it needs a lot of patience and it may take a few days to weeks to master it.

\* During the first week, the baby seems hungry all the time as the baby is trying to cope with the new environment and frequent breast feeds will not only help him in adjusting but also help your body to make more milk to meet baby's demand.

\* Breastfeeding is easier with the right help.

# THIS POPULAR food on your platter could be the culprit

t a time when cancers, heart diseases, and diabetes have been wreaking havoc on mankind, issues like fatty liver disease - alcoholic or nonalcoholic - often take a backseat. However, fact remains that non-

If left untreated, NAFLD can result in inflammation and scarring of the liver known as cirrhosis.

### Plant-based diet ramps up metabolism, reveals new study

plant-baseddietboosts after-meal burn, leads to weight loss, and improves cardiometabolic risk factors in overweight individuals, according to a new randomised control trial published in JAMA Network Open by researchers with the Physicians Committee for Responsible Medicine. The study randomly assigned

participants who were overweight and had no history of diabetes -- to an intervention or control group in a 1:1 ratio.

For 16 weeks, participants in the intervention group followed a lowfat, plant-based diet based on fruits, vegetables, whole grains, and legumes with no calorie limit. The control group made no diet changes. Neither group changed exercise or medication routines unless directed by their personal doctors.

Researchers used indirect calorimetry to measure how many calories participants burned after a standardised meal at both the beginning and end of the study.

The plant-based group increased after-meal calorie burn by 18.7 per cent, on average, after 16 weeks. The control group's after-meal burn did not change significantly.

findings "These groundbreaking for the 160 million Americans struggling with overweight and obesity, "said studyauthor Hana Kahleova, MD, PhD, director of clinical research for the Physicians Committee. 'Over the course of years and

decades, burning more calories after



every meal can make a significant difference in weight management," added Kahleova.

Within just 16 weeks, participants in the plant-based group lowered their body weight by 6.4 kg (about 14 pounds), on average, compared to an insignificant change in the control group. The plant-based group also saw significant drops in fat mass and visceral fat volume--the dangerous fat found around the internal organs.

The researchers also teamed up with Yale University researchers Kitt Petersen, MD, and Gerald Shulman, MD, to track lipid and intramyocellular hepatocellular lipid--the accumulating fat in muscle and liver cells--in a subset of participants using magnetic resonance spectroscopy. Those in the plantbased group reduced the fat inside the liver and muscle cells by 34% and 10%, respectively, while the control group did not experience significant changes. Fat stored in these cells has been linked to insulin resistance and type 2 diabetes.

"When fat builds up in liver and muscle cells, it interferes with insulin's ability to move glucose out from the bloodstream and into the cells," adds Dr Kahleova.

"After just 16 weeks on a low-fat, plant-based diet, study participants reduced the fat in their cells and lowered their chances for developing type 2 diabetes," added Dr Kahleova.

The study also offered new insight into the link between fat within the cells and insulin resistance.

The plant-based group decreased their fasting plasma insulin concentration by 21.6 pmol/L, decreased insulin resistance, and increased insulin sensitivity--all positive results--while the control group saw no significant changes.

Secretary Department of Health Research, MOHFW and DG ICMR Govt of India Dr. Rajeev Bahl held a video conference to discuss strategies and steps to rule out any epidemic.

The Government took several steps immediately after the first incident on December 7, including deputing a medical team along with the food safety department to collect food and water samples, organizing medical camps, establishing mobile medical units, door-to-door screening, and deploying rapid action teams.

A team of the state rapid response experts, including epidemiologists, microbiologists, and others from DHS Jammu, GMC Jammu, and Rajouri, visited the area to conduct detailed screening and collect contact tracing samples. Experts from NCDC, NIV Pune, and PGI Chandigarh also visited the area to assist in containing the situation.

Clinical reports, lab investigations, and environmental samples indicate that the incidents are not due to a communicable disease.

The toxicological analysis conducted by CSIR-IITR has detected toxins in multiple biological

Observer (KNO), Aslam recounted the tragic events. "I have lost three daughters and two sons in just a few days. Now, my only daughter is fighting for her life. I have nothing left but her," he said, his voice trembling with a mix of grief and hope.

"I couldn't save my other children, but I'll do whatever it takes to save her," he said, adding that her condition remains critical.

Aslam said his children were healthy until last Sunday when they began showing symptoms of minor vomiting and fever. They were rushed to the hospital, but six out of seven, including his five children and his maternal uncle, succumbed to the illness, he said.

"My daughter is still alive, but I fear I may receive news of her death any moment," the devastated

Aslam expressed frustration over the lack of timely support from authorities, saying that while the Deputy Commissioner and SSP visited his residence and provided some assistance, no representative from the government, especially the NC-led administration, has come forward to help.

He urged the government to expedite the investigation to identify the cause of the outbreak and take immediate action to prevent further loss of life. "I have lost everything, but I don't want others to suffer the same fate. The government must act quickly to save lives in this area," he pleaded.

# Vijay Hazare Trophy: Padikkal, Shetty step up as Karnataka storm into final

Karnataka 238 for 5 (Padikkal 86, Smaran 76, Sindhu 2-47) beat Haryana 237 for 9 (Ankit 48, Himanshu 44, Shetty 4-34, Shreyas 2-36, Prasidh 2-40) by five wickets

evdutt Padikkal put on a batting exhibition on an up-anddown surface at the Kotambi Stadium in Vadodara as he helped Karnataka to their fifth Vijay Hazare Trophy final. He continued his stellar run in the competition, hitting his seventh successive fifty-plus score in India's premier 50-over domestic competition and in the process, knocked defending champions Haryana out.

Padikkal made 86 off 113 balls - following his 102 off 99 against Baroda in the last outing, his first this season - and added 128 for the third wicket with Ravichandran Smaran as Karnataka chased down the 238-run target with relative ease. The win was set up by their bowlers led by left-arm quick Abhilash Shetty, who returned 4 for 34. His wickets included both Nishant Sindhu and Parth Vats, the two half-centurions from Haryana's preliminary quarter-final win that knocked out Bengal.

Legspinner Shreyas Gopal was instrumental in turning the tide Karnataka's way with the ball when he broke a fluent second-wicket partnership worth 70 between Himanshu Rana and Ankit Kumar by trapping the latter lbw on 48. Shrijith's shoddy glovework also resulted in a few byes. The second-wicket pair for Haryana was doing well to set a base. Which is when Agarawal brought spin on to apply the brakes.

Shreyas and left-arm spinner Hardik Raj tested both the edges of the batters, with the former using the googly to excellent effect. After he denied Haryana's captain, Ankit, a fifty, Himanshu had an ill-timed dash down the surface against Raj and was stumped by Shrijith. Those twin wickets gave Karnataka enough of an opening. Dinesh Bana, Rahul Tewatia and Sumit Kumar all got starts but none lasted more than 36 balls.

But that did not bother Karnataka, who made regular inroads to trigger a collapse. One that was enough to propel Karnataka to their first Vijay Hazare Trophy final since 2019-20 after three semi-finals and a quarter-final appearance in the last four editions. They will meet the winner of Vidarbha vs Maharashtra in Saturday's final.

### **Stephen Fleming** steps down as Southern Brave head coach

tephen Fleming has stepped down as SouthernBrave's head coach in the men's Hundred, citing family reasons. Fleming replaced Mahela Jayawardene in the role ahead of the 2023 season and twice led the Brave to the knockout stages, losing the eliminator in his first year in charge and the final last season.

He will be replaced by Adi Birrell, the Hampshire head coach, for the 2025 season, with Hundred franchises growing stronger ties with their host clubs as part of the ongoing privatisation process. Birrell has enjoyed recent success in franchise cricket, leading Sunrisers Eastern Cape to back-to-back SA20 titles.

Birrell will become the first county head coach also taking charge of a men's Hundred team, though several have served as assistant coaches. He will be replaced as Hampshire coach during the Metro Bank Cup, the 50over competition which runs parallel to the Hundred, but remains in charge for the County Championship

Fleming's resignation avoids a situation in which he would coach a team part-owned by a rival IPL franchise, given his long-running association with Chennai Super Kings. Hampshire were sold to the GMR Group - co-owners of Delhi Capitals - last year and are set to become majority shareholders in the Brave this year.

He has coached Chennai since 2009, and has also taken charge of their affiliated franchises in Major League Cricket (Texas Super Kings) and the SA20 (Joburg Super Kings), where he is currently. Fleming said in a statement that stepping down from his role with the Brave would allow him to spend more time at home.
