Inter-ministerial team arrives in Rajouri to investigate mysterious deaths

SRINAGAR: A high-level interministerial team formed by Union Home Minister Amit Shah has arrived in Budhal village, Rajouri, to investigate the mysterious deaths that have claimed 17 lives over the past 50 days.

An official told the news agencies that the team was accompanied by experts from some of the most reputed institutions in the country. The team interacted with locals and officials and collected various samples for comprehensive analysis.

The investigation team included experts from the Ministry of Health and Family Welfare, the Ministry of Agriculture, the Ministry of Chemicals and Fertilizers and the Ministry of Water



Resources. Specialists from animal husbandry, food safety, and forensic science laboratories were also present.

The team was supported by Deputy Commissioner Rajouri, SSP Rajouri, and other senior officials. The experts' primary objective is to understand the causative factors behind the deaths and manage the situation effectively.

J&K Health Minister Sakina Itoo said no virus or infection has been identified as the cause of the deaths.

She said samples analysed at premier laboratories revealed the presence of neurotoxins, which have caused brain damage. The government has sent these samples for broader investigations to determine the specific toxin responsible, as there are over 800 potential poisons

A local water spring, used by around 15 families—including three directly affected families—was sealed after traces of pesticides and insecticides were found in the water.

Union Home Minister Amit Shah on Saturday directed the formation of the inter-ministerial team after three incidents of unexplained deaths were reported in the village.

The operation marks the first gunfight in Jammu and Kashmir in the year 2025.

The operation, conducted in Gujjar Pati, Zaloora, under the jurisdiction of Sopore police district, was based on intelligence inputs regarding the presence of terrorists, an official informed reporters.

He, however, said that after an extensive search, the terrorists managed to flee the encounter site. The operation was then called off.

The official said the operation began with a joint team of the Army, CRPF, and Jammu & Kashmir Police cordoning off the area. The search intensified after fire was observed from inside a busted hideout. The operation, which was halted due to darkness, resumed at first light. Security measures had already

SRINAGAR: The traffic enforcement authorities in Kashmir have made significant strides in improving road discipline, generating a revenue of Rs 28,36,03,261 from 8,25,304 challans issued between January and December 2024.

In addition to this, a total of 12,612 vehicles were seized across the region for various traffic violations. In Traffic City Srinagar, 4,13,150 challans were executed, leading to a revenue collection of Rs 16,56,97,211.December saw the highest number of challans at 43,947, followed by 41,225 in July and 37,506 in August. August also recorded the highest revenue collection at Rs 1,61,85,600, while February brought in Rs 1,52,42,000.

Roadside Parking Near HP Gas Plant in Pampore Poses Threat to Public

PAMPORE: Dozens of oil tankers and trucks carrying HP gas cylinders are parked along the roadside near the HP Gas Plant in Letterbal, Pampore, creating a significant safety hazard for commuters. The illegal parking has severely reduced the width of the road, causing traffic congestion and increasing the risk of accidents.

Commuters have raised concerns about the growing number of fatalities near the plant, which they attribute to the frequent illegal parking by truckers and tankers. The plant does have its own parking area, but the vehicles continue to block the road, creating an unsafe environment for both pedestrians and drivers.

Mohammad Asif Ganie, Vice

SC Asks 23 States, 7 UTs To File Reports On Compliance Of Legal Provisions, Rules

NEW DELHI: In a significant order, the Supreme Court on Monday directed 23 states and seven union territories to file compliance reports indicating implementation of the Motor Vehicle law's recent provisions besides rules on electronic monitoring and road safety

 $A \, bench \, comprising \, Justices \, Abhay \, S$ Oka and Ujjal Bhuyan noted six states and a UT, namely, West Bengal, Maharashtra, Tamil Nadu, Karnataka, Kerala and Delhi, had filed their compliance reports.

The top court on September 2, 2024 passed directions on the implementation of Section 136A of the Motor Vehicles Act read with Rule 167A of the Motor Vehicles Rules which allow authorities to electronically monitor speeding vehicles.

The bench has now asked the remaining 23 states and seven UTs to file their compliance reports which will be shared with the Supreme Court committee on

The apex court panel, in turn, would look into all aspects and provide its inputs which could be considered by the Centre in framing the standard operating procedure on electronic monitoring and enforcement of road safety measures, the bench said.

Senior advocate Gaurav Agrawal, assisting the bench as an amicus curiae, their reports and the necessary directions may be passed with regard to them.

It also emphasises electronic monitoring on national highways, state highways, and urban roads in cities with



The bench said it would consider the aspect on March 25 and its panel on road safety, in the meantime, could seek assistance of the six states while deliberating upon the reports.

Section 136A, introduced in 2021 in the Motor Vehicles Act, 1988, aims to deploy advanced technologies such as speed cameras, closed-circuit television (CCTV) cameras, speed guns, body-worn cameras, and automatic number plate recognition systems to ensure better traffic management and enforcement of traffic laws.

Rule 167A of the Motor Vehicles Rules deal with the implementation and other regulatory aspects of road safety measures.

Under the rule, the state governments have to ensure installation of electronic enforcement devices at high-risk and high-density corridors on national and state highways,

and at critical junctions at least in major cities with more than a million population and also including 132 cities as specified in the rules.

"Section 136A of the Motor Vehicles

Act is an innovative provision with the potential to transform road safety enforcement by leveraging technology. Proper implementation will ensure road discipline and allow for the efficient prosecution of violators," the bench had

It directed the Ministry of Road Transport and Highways to circulate the order to all states and union territories for immediate compliance.

The bench said the state governments were required to install devices in highrisk corridors, major junctions, and cities with populations exceeding one million.

Devices such as body-worn cameras used by enforcement officials must notify offenders about ongoing recording, it said, and offenders will be issued electronic challans, complete with photographic evidence, date, time, and location stamps, apart from details of the violations.

The court, however, clarified electronic enforcement devices must not be used for surveillance purposes unrelated to traffic violations.

The Supreme Court committee on road safety was tasked by the bench to oversee the nationwide implementation of the measures.

The top court was hearing a PIL on road safety filed in 2012.

Remarks Against Amit Shah

SC Stays Proceedings In Defamation Case Against Rahul Gandhi

NEW DELHI: The Supreme Court on Monday stayed trial court proceedings against Congress leader Rahul Gandhi in a criminal defamation case filed against him for alleged defamatory remarks against Union Home Minister Amit Shah.

Naveen Jha, a BJP worker, had filed the case against Gandhi in 2019 for his alleged remarks

During one of his public speeches in Chaibasa before the 2019 Lok Sabha elections, Gandhi had allegedly referred to Shah as a "murderer".

Abench of Justices Vikram Nath and Sandeep Mehta issued notice to the Jharkhand government and the BIP leader while seeking their response on Gandhi's appeal.

"Issue notice. Till further orders, further proceedings in the trial shall remain stayed," the bench said.

Senior advocate Abhishek Singhvi, appearing for Gandhi, said there are several judgments which say that only the aggrieved person can file a criminal defamation complaint.

He submitted that the defamation complaint cannot be filed by a proxy third party.

Senior advocate Mahesh Jethmalani appeared

Gandhi has challenged the Jharkhand High Court order, which rejected his petition to quash proceedings against him in a trial court in connection with the complaint.

The Congress leader had contested the decision of a magisterial court in Ranchi, which instructed him to personally appear before the court to undergo trial. Later, Gandhi moved the high



court, which issued a stay order on any further actions in the lower court against him.

After recording the statements of the complainant and witnesses, the magistrate had found merit in the case against Gandhi and directed him to appear before the trial court on February 4, 2023.

Later, the HC, while issuing a stay on the notice issued by the magistrate, ordered that "no coercive steps" be taken against Gandhi.

People of Delhi suffering in battle of supremacy between AAP govt, Centre: Sachin Pilot

UDAIPUR: Ahead of the Delhi polls, Congress leader Sachin Pilot on Monday said the people of the capital are suffering in the battle for supremacy between the AAP-led city government and the BJP-led central government, and that his party



Speaking to reporters here, he exuded

confidence that the people of Delhi will vote for the Congress this time.

"There is a battle of supremacy between the Delhi government and the central government and the people (of the city) are suffering in this," Pilot said. The Congress party has emerged as the "better option" and people will give the mandate to it in the Delhi assembly elections, he said.

"We have given some guarantees to the people of Delhi. They also remember the development that took place under the Sheila Dikshit-led Congress government.

We will fight strongly and the Congress will do well in the Delhi polls," the former deputy chief minister of Rajasthan said.

Constitution under assault; RSS chief must apologise for 'antinational' statement: Congress

NEW DELHI: Ahead of its 'Jai Bapu, Jai Bhim, Jai Samvidhan' rally in Karnataka's Belagavi, the Congress on Monday alleged the Constitution is under assault and reiterated its demand that RSS chief Mohan Bhagwat must apologise for the "anti-national statement he delivered on the freedom movement".

The opposition party also claimed that Mahatma Gandhi is being insulted and BR Ambedkar is being

"Tomorrow, the INC's Jai Bapu, Jai Bhim, Jai Samvidhan rally will be held in Belagavi. This was to take place on Dec 27th, 2024 but was postponed due to the passing away of Dr. Manmohan Singh," Congress general secretary in-charge communications Jairam Ramesh said in a

It was at Belagavi that Mahatma Gandhi had taken over as Congress president on December 26, 1924, he

"Mahatma Gandhi is being insulted, Dr. Ambedkar is being attacked. The Constitution of India and its values er assault "Ramesh alleged

The Belagavi rally is a reaffirmation of the Congress' steadfast resolve to preserve, protect, and promote the legacy of Mahatma Gandhi and Ambedkar, he said.

This will be followed by a similar rally at Mhow – Dr. Ambedkar's janmabhoomi — on January 27, Ramesh said. "Shri Mohan Bhagwat must apologise for the atrocious, anti-national statement he delivered on the freedom

movement on January 14th 2025," he said. "The Union Home Minister must resign and tender an apology for his atrocious remarks on Dr. Ambedkar

in Parliament on December 17th, 2024," Ramesh said. Last week, Ramesh had described Bhagwat's remarks that India's "true independence" was established on the day of the Ram temple's consecration as "anti-national" and demanded an apology over the statement.

Bhagwat said the date of the Ram temple's consecration in Ayodhya should be celebrated as "Pratishtha Dwadashi" as the "true independence" of Bharat, which had faced

"para chakra" (enemy attack) for several centuries, was established on this day.

The Congress has repeatedly also alleged that Home Minister Amit Shah's remarks in the Rajya Sabha during a debate on the Constitution during the winter session show that the BJP and the RSS leaders have a "lot of hatred" for Ambedkar and demanded an apology from him.



The rally in Mhow will commemorate the 75th anniversary of the Constitution and the founding of India's republic as well as the purported attack on the legacy of Babasaheb Ambedkar by the ruling regime, a party circular had said.

Following Singh's demise on December 26, the Congress had announced that all party official programmes, including its foundation day celebrations, will be cancelled for seven days as a mark of respect.

Singh, the architect of India's economic reforms, died at the age of 92.

Singh passed away just hours after the Congress party concluded its Congress Working Committee meeting at Belagavi, marking the 100th anniversary of Mahatma Gandhi assuming the presidency of the party at the Belgaum session in 1924.

Sanjay Roy Sentenced To Life Imprisonment Till Death In Rape, Murder Of RG Kar Hospital Doctor

KOLKATA: A Kolkata court sentenced Sanjay Roy to life imprisonment till death on Monday after he was convicted of rape and murder of an on-duty doctor at the state-run RG Kar Medical College and Hospital. The court of Additional District and Sessions Judge Anirban Das in Sealdah had on Saturday held Roy guilty of the crime committed against the postgraduate trainee doctor at the hospital on August 9 last year, which sparked off unprecedented and prolonged nationwide protests.

Judge Das said the crime did not fall under the "rarest of the rare" category as justification for not giving death penalty to the convict. The court also directed the state to pay a compensation of Rs 17 lakh to the family of

the deceased doctor. The sentence was passed after the judge

heard the final statements of the convict and his counsels placed in self-defence as well as those of the victim's family, and the CBI. Roy, a former civic volunteer with the

Kolkata Police, was held guilty under Sections 64(rape), 66 (punishment for causing death), and 103(1) (murder) of the Bharatiya Nyaya Sanhita (BNS).

mercy petition by March 18: SČ askš Centre way you decide it so that it could facilitate

Monday asked the Centre to take a decision by March 18 on the mercy petition of death row convict Balwant Singh Rajoana, convicted in the 1995 assassination case of then Punjab chief minister Beant Singh.

"We are granting you time by way of a last chance. Either you take a decision or otherwise we will hear it on merits," a bench headed by Justice B R Gavai told Solicitor General Tushar Mehta, who appeared for

The bench, also comprising Justices Prashant Kumar Mishra and KVV iswanathan, was hearing Rajoana's plea seeking directions to commute his death sentence to life term due to the "inordinate delay" in deciding his mercy petition.

At the outset, Mehta referred to the sensitivity involved in the matter and said the mercy petition was under consideration. He requested the bench to grant six

weeks time. Rajoana's counsel told the bench that he has spent around 29 years in jail.

"We will hear it on merits on March 18," the bench said, adding, "By then, if you can take a decision, well and good. Either us. Otherwise we will hear it (plea seeking directions to commute death sentence) on merits".

Take decision on Balwant Singh Rajoana's



Mehta said the matter relates to murder of a sitting chief minister.

On November 25 last year, the Centre had told the apex court that there was sensitivity involved in the matter related to the mercy petition of Rajoana.

While hearing the petition on November 18 last year, the apex court had put on hold its order asking President Droupadi Murmu's secretary to place before her the mercy petition of Rajoana for consideration.

After the order was passed in the morning on November 18, 2024, the solicitor general had urged the bench that it should not be given effect as there were "sensitivities" involved in the issue.

Mehta had then told the top court that the file was with the home ministry and not the President.

On September 25 last year, the top court sought responses from the Centre, the Punjab government and the administration of the Union Territory of Chandigarh on Rajoana's

The then Punjab chief minister and 16 others were killed in a blast at the entrance of the civil secretariat in Chandigarh on August 31, 1995. A special court sentenced Rajoana to death in July 2007.

In his plea, Rajoana has sought the apex court's direction to the respondent authorities to commute his death sentence "due to inordinate delay" in its execution and in deciding the "mercy petition filed on his behalf".

The plea said consequentially, a direction be issued for his release.

On May 3, 2023, the apex court refused to commute his death sentence and said

RDD Cleans Roadside Solid Waste at Bazipora; **Locals Demand 'Rock Park' to Attract Travellers**

BANDIPORA: A recent video shared by Kashmir Convener on its social media platform showcasing solid waste being dumped at one of the beautiful stretches of Bandipora-Srinagar Road near Bazipora has prompted swift action from the Rural Development Department (RDD), Block

On Saturday morning the Kashmir Convener shared a video of Bazipora village along Srinagar Bandipora road wherein the solid waste was dumped turning the road ugly for visitors.

The department, under the directions of the Assistant Commissioner Panchayats (ACP) Bandipora, immediately intervened and cleared the accumulated waste and initiated measures to prevent further littering.

In a statement issued by the RDD, Officials said the issue of waste accumulation at these locations on Srinagar-Bandipora road is matter of concern, however, it is important to clarify the circumstances leading to this situation.

Officials said the identified spots are located along the roadside, and unfortunately, travelers commuting from Bandipora and beyond have developed a habit of indiscriminately disposing

High Drug Prices: So Who Is to Blame?

he price of medicines in the country is being decided by the doctors themselves and not by the government. Doctors get the brands made according to their liking. They fix the price. The MRP of medicine of Rs. 38 is being increased to Rs. 1200. This is just an example; this is being done in all medicines. Experts believe that in 20 years, the medicine business will reach Rs. 40 thousand crores to Rs. 2 lakh crores. They consider this to be the big reason for the big game in MRP. From 2005 to 2009, medicines were being sold at 50 percent MRP. If the MRP was Rs. 1200, then it was given to the dealer for Rs. 600. Now doctors are getting the MRP decided according to their liking. However, according to the rules, doctors do not decide the rates of medicines. The rates of medicines are decided by the companies that make medicines. Many factors are involved in fixing the rates of medicines. Traders make good profits on medicines.

Retailers offer a maximum discount of 20-25 percent on branded medicines. Generic medicines offer a discount of 50-70 percent. Generic medicines are cheaper because they do not have to undergo expensive tests. While buying medicines, there should be a QR code on the medicine wrapper. The QR code on the medicine wrapper gives the name of the medicine, brand name, manufacturer information, manufacturing date, and expiry date. For information about medicines or their ingredients, one can ask a doctor or pharmacist. But for those medicines that are outside the control of the government, the National Pharmaceutical Price Authority works under the Ministry of Health of the Government of India to monitor arbitrary drug quality and MRP. The government controls the MRP of the medicine through the Drugs Price Control Order. Along with fixing the maximum price for essential and life-saving medicines, the DPCO is also responsible for making medicines affordable and accessible to patients.

The medicines that the government brings under DPCO have their MRP under control, but medicines of hundreds of formulas are still out of the government's control, whose MRP is being arbitrarily fixed. The government's guideline regarding the increase in the prices of medicines is that the MRP can be increased only by 10 percent in a year. But the companies are changing the names of the products and making the MRP as per the demand of the doctors every year. The companies fix the MRP as per their own convenience by changing different divisions and brands.

Medicines are supplied in the country from pharma factories. In this game of companies and doctors, companies, for their profit, ignore the rules and not only agree to make medicines according to the doctors, but also fix arbitrary prices. Not only this, deals are made with these companies on mobile. That is why doctors and hospitals across the country are getting their own medicines made and selling them at arbitrary prices. Doctors and hospitals are getting their own medicines made and using micro-pilots. This determines the expiry time. If the quality of micro pilot in the medicine is reduced a little, the margin will

increase, but the expiry time will be reduced. The reason behind this is that the government has no guidelines regarding material and expiry. The expiry date is also decided by the companies. There is a little strictness regarding the medicines that are under

over-the-counter drugs that can only be sold in pharmacies must be sold at exactly the same price in all pharmacies. Therefore, the prices of drugs do not fluctuate between pharmacies, meaning it does not matter which pharmacy you choose to fill your

and the patient does not have to buy an injection worth Rs. 300 for twelve thousand.

It is a serious issue that the companies that manufacture, import, or sell the medicine determine the prices of the medicine. The rules state that prescription-only drugs and types of prescription. Not only this, the rules should be strictly enforced on drug manufacturing companies to set the same price of every salt as per the rules of the Government of India, no matter what the brand is. The price should be on the salt and not on the brand so that the black marketing of doctors and companies is curbed

GMC Anantnag bans outside food, introduces diet facility for patients

Anantnag: To enhance patient care and uphold hospital decorum, the administration of Mirza Mohammad Afzal Begh Memorial (MMABM) Associated Hospital, Government Medical College (GMC) Anantnag, has prohibited outside food for patients while introducing a dedicated diet facility tailored to their medical needs.

A hospital official told that this decision is aimed at improving hygiene, discipline and overall care standards within the hospital.

He said attendants are now allowed to visit patients strictly between $3:00\,\mathrm{pm}$ and $4:30\,\mathrm{pm}$, adding that this restriction ensures minimal disruptions to patient care and helps medical staff focus on their duties efficiently.

"The hospital now provides four meals daily, from breakfast to dinner, specially prepared to meet the nutritional and medical needs of patients. Attendants can access food from outside facilities such as the hospital canteen," he said.

To ensure hygiene and prevent health hazards, patients are no longer permitted to bring outside food into the wards, the official said, adding that the use of polythene bags within hospital premises has been strictly banned to maintain cleanliness and align with eco-friendly practices.

The measures were introduced following concerns about improper hygiene and issues such as rodent infestation, which were exacerbated by food brought



from outside.

The hospital's Incharge Security Officer has been directed to enforce these rules diligently, with strict action to be taken against any violations.

The administration has urged patients, attendants and staff to cooperate with the new measures, saying these changes aim to create a safe and conducive environment for patient recovery.

"This initiative ensures patients receive hygienic and nutritionally balanced meals while also contributing to better hygiene and discipline within the hospital," the official said.

JK Govt to import 900 high-quality Sheep from Australia

Srinagar: In a bid to meet the rising demand for meat in Jammu and Kashmir, the state government has approved the import of 900 sheep from Australia under the Integrated Agriculture Development Program (HAPD).

The initiative, with a budget of Rs 26 crore,

focuses on two high-yield breeds, Dorper and Texel, renowned for their superior meat production capabilities.

As per the details available with news

as per the details available with news agency—Kashmir News Observer (KNO), the Jammu and Kashmir government has decided to import 900 high-quality sheep from Australia to meet the increasing demand for meat in the region.

These sheep, belonging to the Dorper and Texel breeds, are known worldwide for their superior meat production. The initiative is part of the Integrated Agriculture Development Program (HAPD) and comes with a budget of Rs 26 crore.

The plan aims to make the state self-sufficient in meat production, reducing dependency on imports.

Currently, Jammu and Kashmir consume

approximately 15 lakh sheep annually, with 41% of the demand being met through imports from other parts of the country, costing the



state Rs 1,400 crore. The new project is part of a broader Rs 329 crore, five-year plan to boost wool and mutton production while cutting down on imports.

Official sources informed KNO that the imported sheep will undergo a thorough quarantine process, spending one month in quarantine in Australia before being transported to India, where they will stay in dedicated quarantine centers for another two months.

Acenter has already been set up in Rajbagh Srinagar, Kathua- Jammu, and the sheep will later be housed at government sheep rearing farms in Reasi. Out of the 900 sheep, 450 Dorper sheep will be allocated to the Jammu division, while the same number of Texel sheep will go to the Kashmir division.

Dorper sheep, originally from South Africa, are known for their high fertility, adaptability to different climates, and rapid muscle development.

Lambs of this breed can grow to 35-40 kilograms in just four months, with adult sheep weighing up to 90 kilograms.

Texel sheep, a Dutch breed from the Netherlands, are equally prized for their exceptional muscle development.

They have smooth heads and legs, short height, broad faces, black noses, and small ears, making them ideal for meat production.

Reports inform that a team of six sheep farming experts from Jammu and Kashmir will soon leave for Australia to oversee the selection and transportation process—(KNO)

In the movies, heart attacks always happen in the most dramatic fashion, with the patient crushing under severe pain in their chest, at the site of their heart. But in reality, a heart attack could happen with not-so-evident signs. This makes it all the more risky,

Study and Health Professionals Follow-up Study (1988–2018). They were asked to answer a questionnaire

for the American Heart Association.

What did the researchers find out?

The participants were from the Nurses' Health adults who exercised 2X to 4X the recommended amount might lower their mortality risk by as much as 31%," the American Heart Association (AHA) has captioned a social media post on the study and the importance of physical activity.

32% deaths worldwide happen due to heart issues

One of the leading causes of deaths in the world, heart diseases claim close to 18 million lives annually. Most of the deaths associated with heart diseases are due to heart attacks and strokes.

Heart diseases also account for premature deaths. The World Health Organisation (WHO) says, one third of these deaths occur prematurely in people under 70

Out of the 17 million premature deaths (under the age of 70) due to noncommunicable diseases in 2019, 38% were caused by heart diseases.

In the latest report on top causes of death worldwide, the WHO had said that heart diseases were the number one killer among all non-communicable diseases.

What do other research studies say on the importance of exercise on heart health?

This is not the first time a study has talked about the effect of physical activity on heart health; though it might be one of the first studies done on such a massive scale and over a longer duration.

As per a 2010 study: More activity is associated with a lower risk of developing cardiovascular disease when compared to less physical activity. Although there may be a threshold over which activity levels convey greater risk, only those who are totally sedentary (i.e., "weekend warriors") or who have pre-existing

Apart from this, hypertension, diabetes, high cholesterol also influence heart diseases. "In addition, drug treatment of hypertension, diabetes and high blood lipids are necessary to reduce cardiovascular risk and prevent heart attacks and strokes among people with these conditions," the global health agency has said.

Things to do

The symptoms associated with heart diseases are too subtle to be observed. Only when it poses a risk to your health, does it become visible.

However, if you have a history of heart disease running in the family you need to be extra careful about your health. Also, those who have diabetes and/ or high cholesterol should also be careful about heart

Apart from these factors lifestyle habits like drinking, smoking or having sedentary life can also influence the occurrence of heart complications to a large extent.

Additionally, diet also plays a crucial role. Always try to portion your meal with an exact amount of nutrients and vitamins. Include a portion of seasonal fruits and vegetables on your food plate.



Vomiting

Nausea may also be accompanied by stomach pain. Some people may even experience vomiting. When you vomit, the contents of your stomach are forced up through the food pipe and out of the mouth. Vomiting is not healthy and you should see your doctor.

People may often dismiss these signs as symptoms of flu. However, even if similar, pay attention to your body and you may feel that this does not feel flu-like

Study says 150 minute of workout per week can lower risk of death; know details

A large scale study has revealed interesting facts

An extensive study in which more than 116,000 people had participated and were studied for over 30 years has found that exercising for even 150 minutes a week can lower the risk of death by a large extent.

The researchers found that physical activity, even in moderate duration, reduced the risk of all cause

The study saw a dip in mortality risk in those people who were engaged in physical activities 150-599 minutes per week. "Participants reporting 2 to 4 times above the recommended minimum of long-term leisure-time activity (150-299 minutes per week) or moderate activity (300-599 minutes per week), had 2 to 4% and 3 to 13% additional lower mortality," says

"The nearly maximum association with lower mortality was achieved by performing ≈150 to 300 min/wk of long-term leisure-time VPA, 300 to 600 min/wk of long-term leisure-time MPA, or an equivalent combination of both," the study found.

What do experts say?

"When it comes to exercise, more might be better. A new study found that people who followed the recommendations for physical activity lowered their risk of dying from any cause by as much as 21%. But

health conditions are at risk for acute CV events with sudden, vigorous-intensity physical activity. "The gradual introduction of activity combined with physician evaluation prior to starting an exercise program may mitigate these risks," the study suggests.

A 2003 study published in Circulation journal of AHA stressed on the risk that a sedentary lifestyle poses on the human heart. "A sedentary lifestyle is one of the 5 major risk factors (along with high blood pressure, abnormal values for blood lipids, smoking, and obesity) for cardiovascular disease," the study said and had suggested walking, golf playing, calisthenics, gardening, cycling, swimming and climbing hills among various physical activities one should do.

What are the risk factors?

There are several risk factors for heart diseases. Overuse of tobacco, consumption of more salt, less consumption of seasonal fruits and vegetables, no physical activity, and overdrinking of alcohol are the risk factors associated with heart disease.

'The effects of behavioural risk factors may show up in individuals as raised blood pressure, raised blood glucose, raised blood lipids, and overweight and obesity,"

White or pink guava: Which is healthier?

xperts always suggest that seasonal fruits be added to one's diet. But, it must be noted that some fruits have many varieties, each having its own set of health benefits. One such fruit is the guava — which comes in pink and white varieties. Taking to Instagram, dietitian Shikha Kumari listed the benefits of having guava, and also the differences between the two.

Some of the health benefits of the light green, mildly sweet, and tangy fruit are:

*Helps to lower blood sugar levels. *Boost heart health.

*May help relieve painful symptoms of

menstruation.

*Extremely good for the digestive system.

*Good for weight loss.

*May have an anti-cancer effect. *Helps to boost your immunity. *Is good for your skin.

Besides these benefits, guavas are also a good source of iron, calcium, and phosphorus, said Tanvi S Chiplunkar, senior dietician at Bhatia Hospital Mumbai, adding that guava is a "good source of dietary fibre" which is useful in maintaining blood

sugar levels in diabetic people.

Now, let's find out which one should you pick "Pink guava has more water content, less sugar, less starch content and vitamin C, and less seed or is even seedless. On the other hand, white guava has more sugar, starch, vitamin C and more seed. The white-fleshed guava is high in antioxidants, but the red-fleshed variety has even higher," said Kumari.

She added that pink guava contains naturally occurring class of organic pigment called carotenoid, which gives carrots and tomatoes their distinct red colour. The concentration of caroteniod vary from

species to species depending upon which the colour of guavas also range from light pink to deep pink. The carotenoid content of white guava, on the other



hand, is insufficient to impart colour to its pericarp (pulp). Apart from above mentioned reason, white and pink guava also slightly vary in their taste, said

Agreed Chiplunkar and added that ripe guava or the pink ones should be avoided if you are suffering from regular cold and cough. On the other hand, raw ones are recommended to be taken to reduce mucous formation.

Pink guavas are frequently marketed as 'super fruits' as they are high in vitamins A and C, as well as omega 3 and omega 6 poly unsaturated fatty

acids and dietary fibre. It is high in fibre and is beneficial to diabetics, said Dr Archana Batra, nutritionist, and certified diabetes educator.

What is the best way to consume them? It is best to have vitamin C-rich fruits as a whole so that you do not leave a cut piece for a long time in the open, advised Dr Rohini Patil, nutritionist, MBBS, and CEO of Nutracy Lifestyle. "Otherwise, its vitamin C content starts to decrease," she said. What should you keep in mind when buying

Best to buy small to medium-sized guavas such that you can eat one guava completely in one sitting, said Dr Patil.

Look for a guava that is free of blemishes, cuts, or bruises, as these can affect the flavour. "When purchasing guava, consider its quality and also know that many types of adulteration occur in guava, such as hard guava, green guava, desi guava, and so on. So, try to buy guava from a reputable store and pay attention to its quality. Use your fingers to gently squeeze the fruit to check for ripeness. You can also smell the fruit to get an idea about its sweetness," said Dr Batra.

Speaking to local news agency KNO, MLA Budhal laved Igbal Choudhary said the government initially believed the first death was due to food poisoning and only took the situation seriously after the second fatality.

"Three related families suffered the most as they lost a majority of their members," he said Choudhary said. He assured residents that the government is now fully engaged in the investigation.

The MLA said no new illnesses have been reported in the village, and the situation is under control. He urged locals to remain patient while investigations continue.



Kraigg Brathwaite Laments Inability To Adapt To Spinning Conditions

Brathwaite did not ignore the elephant in the room, but did not hide behind it, either. He said straightaway that Pakistan "prepared a dry spinning pitch from day one", while acknowledging it was their right to do so, and challenging both his batters and his bowlers to adapt to it better in the second Test.


"We expect the same type of pitch in the second Test and we've got to come better," Brathwaite said at the post-Test press conference. "It was a difficult pitch to bat on for sure. But it's their decision how they want the pitch. We've just got to come good." What encouraged Brathwaite was West Indies' ability to, for the most part, match their hosts toe-to-toe. While Sajid Khan and Noman Ali found themselves in the $wickets, the \, best \, bowling \, figures \, of \, the \, Test$ belonged to West Indian left arm spinner Jomel Warrican, whose figures of 7 for 32 in the second innings are the third best ever by a visiting bowler in a Test in Pakistan. With the bat, too, West Indies' efforts of 137 and $123\,weren't\,worlds\,removed\,from\,Pakistan's$ second innings score of 157, with a first innings fifth wicket stand of 141 between Saud Shakeel and Mohammad Rizwan the sharpest point of difference.

SINGAPORE: The Singapore Badminton Association (SBA) is set to hire former India international Anup Sridhar as its new singles coach, as per media reports here on Monday.

Sridhar, who has coached top singles players such as Lakshya Sen and PV Sindhu, will work under the "guidance" of South Korean coach Kim Ji-hyun, the Channel

Kim will continue to be the singles head coach for both men's and women's teams, with Sridhar offering "additional $support", said\,SBA's\,vice\text{-}president\,of\,business\,development$ and communications David Tan.

"Our national team is made up of players at different development stages and world-ranking levels, and therefore have different coaching, training and competition needs. We are looking to address this by bringing in more coaches with different abilities," he explained.

"With this in mind, SBA had advertised for the position of an additional singles coach whose credentials include a minimum of five years' experience within a national badminton team structure with a primary focus on singles."

"Sridhar has also impressed us with his in-depth comprehensive analysis of the strengths and shortcomings of many top players on the tour at the moment. And this knowledge will be most useful to our national team," he said.

A former singles player, Sridhar captained India's Thomas Cup team in 2006 and 2008. He represented his country at the 2008 Beijing Olympics, and was the country's top-ranked men's singles player between 2005 and 2008.


