SC asks Delhi police to reply on Tahir Hussain's plea for interim bail

NEW DELHI: The Supreme Court on Tuesday asked Delhi police to respond to a plea filed by former councillor and Delhi riots accused Tahir Hussain who has sought interim bail to campaign for the upcoming Delhi assembly polls.

A bench of Justices Pankaj Mithal and Ahsanuddin Amanullah asked the Delhi police counsel to come prepared and argue the matter on the next hearing.

"Suppose, tentatively, we feel persuaded that he makes out a case for regular bail, then why not we should give at least interim?" said the bench.

It went on, "If we are satisfied at this stage on merits that some case is made out then why not interim? He is in jail for 4 years 10 months. He is only an instigator and very same allegation of instigation is in nine cases in which he has been granted bail. You can't shut your eyes to that."

The hearing was posted on January 22. Senior advocate Siddharth Aggarwal, appearing for Hussain, submitted the former councillor was in custody for 4.10 years and inciting a mob during the 2020 Delhi riots was the only allegation against him.

The top court was informed that Hussain faced FIRs in 11 cases and was granted bail in nine matters.

He was arrested in the case on March



The court was further informed that charges were framed after three years of Hussain's custody and 115 witnesses were cited by the prosecution, of which only 22 have been examined. The main accused have already been

granted regular bail, he added. Referring to the chargesheet, the top

court noted his presence and said, "Your involvement is very much there." "We have to consider it, time for interim

bail is expiring," it said.All such persons should be barred from contesting elections, the top court remarked hearing the case recently. The Delhi High Court on January 14 granted custody parole to Hussain to file



bail from January 14 to February 9 to fight the polls, saying the gravity of allegations against Hussain, being the main perpetrator in the violence, resulting in the death of several persons, could not be overlooked.

The high court said about 11 FIRs were registered against him in connection with the riots and he was admittedly in custody in a related money laundering case and UAPA case. The senior counsel counsel appearing for Hussain argued fighting elections was a complicated process, which required him to not only file his nomination by January 17 but also open

a bank account and campaign.

Maintaining that contesting elections was not a fundamental right, the police had alleged that Hussain who was the "main conspirator" and "funder" of the February 2020 riots could complete formalities and fight polls on custody parole.

Violence broke out in northeast Delhi on February 24, 2020, leaving 53 dead and several injured.

According to the prosecution, on February 26, 2020, complainant Ravinder Kumar informed the Dayalpur Police Station that his son Ankit Sharma, posted in the Intelligence Bureau, was missing since February 25, 2020. Sharma's mortal remains were reportedly recovered from Khajuri Khas nullah in the riot-affected area and his body bore 51 injuries.

Hussain, in the bail plea, said he spent 4.9 years in jail and though the trial started in the case, only 20 of the 114 prosecution witnesses were examined so far.

Pleading he had suffered a long incarceration, Hussain said the fact that several witnesses were still left to be examined meant the trial wouldn't be over soon.

The co-accused, his plea said, allegedly involved in the riotous mob and committing the offence of murder were granted bail by the high court.

NEW DELHI: In a scathing attack on Prime Minister Narendra Modi, the Congress on Tuesday said "outsourcing



ARTO Bandipora Under Fire Over Repeated Delays in Driving Tests Locals accuse officials of negligence, rude behaviour

BANDIPORA: The residents of Bandipora are growing increasingly frustrated with the Assistant Regional Transport Office (ARTO) Bandipora as driving tests have been repeatedly postponed for over a month.

Since late December 2024, no driving tests have been conducted, and the scheduled tests have now been deferred for the fifth time this week, sparking widespread resentment among the aspirants.

Locals have expressed anger over the continuous delays, citing disruptions to their plans and accusing the ARTO office of negligence. Besides this, locals said they have not been guided properly by the officials in the ARTO office as they have rude behaviour with the visitors and don't give satisfactory answers.

"I planned to travel to Delhi after completing my driving test in December, but the repeated rescheduling has thrown my plans into disarray," said a frustrated local resident who studies in New Delhi. "I had to return to Delhi now and most probably will miss the test entirely due to the inefficiency of the ARTO officials and district administration in general"

Visitors to the ARTO office also complained about the rude behaviour of staff and the lack of accountability. "Before planning to return to



university in Delhi, I tried to contact the ARTO office but officials in the office were so rude as if I had committed a blasphemous act by inquiring about the delay in the driving test," he added.

"When we visit to inquire about the test schedule, the officials either ignore our concerns or give vague responses. Their attitude shows

no regard for public inconvenience. They get irritated by asking questions as if they are not accountable to the public," another resident said.

Locals urged the Deputy Commissioner to conduct a workshop for the officials so that they are sensitized and taught how to deal with people in office. "A special session needs to be conducted for officials and officers of ARTO Office for behavioural change and to teach them how to deal with the public politely," urged the aspirants.

Several other visitors also confirmed the allegations of rude behaviour by ARTO officials. "Few Weeks ago, I was told my approved driving license couldn't be printed due to a lack of cartridges and PVC material. However, my friend received his license the same day. I am convinced that he got it after paying extra money to get the DL but to me they lied," he alleged.

Another person from Bandipora said that when he visited the concerned dealing assistant in the ARTO office regarding the printing of my vehicle documents, the concerned official surprisingly said he didn't have papers available in the office.

"Later I came to know that the same had been dispatched for 10 days and the dealing assistant failed to give a satisfactory answer to my query,' he added.

In response to allegations, the ARTO Bandipora attributed the delays to the absence of a Driving Inspector, which has rendered the office unable to conduct tests. "Our inspector was transferred recently and no new replacement has been sent to the office that has forced us to postpone the tests"

Meanwhile, Deputy Commissioner Bandipora, Manzoor Ahmad Qadri, denied receiving complaints about the issue but assured action. "I will look into the matter to ensure the problems are resolved promptly," he told Kashmir Convener.

The ongoing delays and allegations of malpractice have prompted residents to demand immediate intervention from higher authorities to address the inefficiency and restore the ARTO office's accountability.


Republic Day-2025 celebration arrangements finalized at Handwara



Regularization, Express Resentment Over Cabinet's Inaction

SRINAGAR: The Chairman of the All J&K Water Testing Laboratories Staff Association, Mohsin Atta Bhat, has expressed strong resentment over the recent Cabinet meeting's failure to address the regularization of contractual employees.

In a statement issued to Kashmir Convener, Bhat stated that water testing employees, many of whom have served for decades on meager salaries, are eagerly awaiting regularization, a commitment outlined in the National Confer-

ence (NC) manifesto. He highlighted that these employees had been recruited through proper procedures and have consistently provided dedicated service while maintain-

ing high qualifications.



"The most pressing issue is the regularization of temporary and contractual employees, particularly those who have crossed the upper age limit and are struggling to make ends meet," Bhat said.

Drawing a comparison to the NC-Congress regime's previous term, where contractual and contingent employees were regularized under the Special Provision Act 2010 (SRO 255), he questioned why the same provision was not being extended to J&K's contractual employees who were recruited through proper selection procedures.

He further added that water testing employees were appointed according to central government guidelines, which include provisions for regularization and honorarium. However, he noted, the government has adhered strictly to recruitment and monitoring guidelines but ignored the provisions for regularization and honorarium, which he described as a grave injustice.

Bhat also pointed out that in 2023, the Additional Chief Secretary of the Jal Shakti Department had recommended a 50% honorarium increase for these employees, which is still pending approval from the Finance Department, causing severe hardships for the staff.

He appealed to the Additional Chief Secretary (Jal Shakti Department) to intervene and push for the approval of the honorarium file with the Finance Department on a priority basis. Furthermore, Mr. Bhat urged the trade union leaders of J&K to prioritize this issue before government authorities, emphasizing that if their legitimate demands remain unmet, they will be forced to take to the streets in protest.

Lastly Bhat appealed to Chief Minister Omar Abdullah, to convene a special Cabinet meeting to discuss and recommend the regularization of contractual employees, particularly water testing employees, in fulfillment of the NC party manifesto.

Negligence or what: On the negligence of fire safety

he tragic fire at a hospital in Jhansi, Uttar Pradesh, which claimed the lives of 11 newborns, highlights the failure of fire safety measures in India's public institutions. Despite the National Building Code (NBC) and Fire Safety and Prevention Rules, many hospitals do not comply with these regulations. This highlights the urgent need for better fire safety enforcement and significant upgradation of infrastructure to prevent future loss of lives. Challenges in ensuring fire safety in public institutions Fire safety implementation is flawed. Corruption and lack of proper monitoring in obtaining fire no objection certificates (NOCs) cause many hospitals to fail to comply with prescribed fire safety rules. According to the National Disaster Management Authority (NDMA), many hospitals bypass regulatory checks, resulting in unsafe structures that do not meet fire safety standards.

Inadequate infrastructure and planning: Improper planning and poor construction often result in fire hazards in public institutions, especially hospitals. The Kolkata AMRI Hospital fire incident (2011) exposed serious flaws in structural planning, such as blocked escape routes and inadequate fire exits, which contributed to a large number of deaths. Lack of awareness and training, such as medical staff and fire safety personnel, are often not adequately trained in fire prevention, emergency evacuation, or firefighting techniques. A fire at a COVID-19 facility in Mumbai (2020) revealed a lack of preparedness, with hospital staff unable to handle fire emergencies due to inadequate training and awareness. Many hospitals, especially in rural and semi-urban areas, lack the financial resources to upgrade fire safety infrastructure or purchase adequate firefighting equipment. The National Crime Records Bureau (NCRB)'s Accidental Deaths and Suicides in India (ADSI) report recorded over 7,500 fire accidents in 2022, resulting in 7,435 deaths, reflecting the dire consequences of poor enforcement.

Many hospitals lack dedicated evacuation routes, fire retardant materials, and other necessary infrastructure to guard against fire hazards. The Uphaar Cinema fire (1997), which killed 59 people, was aggravated by inadequate exit points, highlighting the need for robust evacuation planning as prescribed by the NBC and NDMA guidelines. Variations in the implementation of fire safety standards across different states and union territories in India create regional disparities. Measures to address these challenges are to strengthen monitoring and regulation. Ensuring robust monitoring of fire safety norms and making fire safety audits mandatory for all hospitals can improve compliance. The NDMA guidelines for fire safety in public institutions should be enforced more stringently, with regular inspections and penalties for non-compliance. Hospitals should invest in modern fire safety infrastructure, including fire alarms, sprinklers, and fire suppression systems.

The fire safety measures at AIIMS, Delhi, which include advanced fire detection and suppression systems, can serve as a model for other hospitals. Regular fire safety drills and com-

prehensive training programs for hospital staff on emergency procedures are essential. Book Review: Story Of Struggle & Success





He laid emphasis on collaborative frameworks in restoration practices to conserve architecture of the identified sites on heritage patterns.


Dr Bilal remarked that protecting Srinagar's architectural heritage is essential for cultural continuity and tourism promotion besides religious aspects.

Contours of a Visionary Mind Dr. Maroof Shah's Intellectual Legacy: Bridges Mysticism, Philosophy and Modernity

Rajouri deaths

Home Minister Amit Shah, led by a directorlevel officer from the Ministry of Home Affairs on the second consecutive day spent hours collecting samples and interacting with villagers and surviving family members.

Initial investigations, according to the officials, ruled out a communicable bacterial or viral disease, focusing instead on neurotoxins found in the samples of victims.

Authorities also sealed a local spring after discovering traces of pesticides or insecticides in its water.

Talking to reporters after meeting the families of the victims the Chief Minister said that till now investigators have not been able to establish the reason behind mysterious deaths in the hamlet but efforts are on to ascertain the cause of deaths. "The government's priority is to stop this cycle of deaths and that it should not go beyond 17," he said, adding, "Since the day we have got the information, officials of Health and other departments have been working to understand the cause behind these deaths."

"Tests were done, and we reached the conclusion that there was no bacteria or virus that caused these deaths," he said, adding, "All these deaths have taken place in three families. "But, we are yet to find the reason behind these deaths. Since it's not a disease, Police are also involved in it and they have formed a team to investigate the matter.

The Central Government team is also there, and together we will look into the reason behind these deaths." the Chief Minister said.

He said that the government is fully committed to uncovering the cause of the tragic deaths, with multiple agencies actively involved in the investigation. Security beefed

Pant unveiled as LSG captain, says he will give the franchise '200%'

ishabh Pant has vowed to "give 200%" to Lucknow Super Giants (LSG) after being officially unveiled as the franchise's captain for IPL 2025. As ESPNcricinfo had reported earlier, Pant was set to be named captain after being bought at the pre-season auction for a record INR 27 crore (USD 3.21 million approx.).

"Thank you to LSG family for showing the faith in me," Pant said, alongside team owner Sanjiv Goenka and mentor Zaheer Khan, in Kolkata on Monday. "I will give my 200% and that's my commitment to you. I will try whatever is in my power to repay the faith you have shown. Looking forward to have a new beginning with new energy and just have a blast out there, and have lots of fun."

Pant takes over from KL Rahul, who led the franchise for its first three seasons before going back into the auction this time around. Pant moves to LSG after a long stint with Delhi Capitals - he was with the franchise since 2016, took over its captaincy in 2021 and led all through barring the 2023 season, when he was recuperating from a serious car accident.

With LSG, he has a chance to build on the team's previous three seasons of moderate success; they made two playoffs in a row before missing out in IPL 2024.

"Yes this is a new team and a new set-up but my ideology of captaining a side doesn't change," Pant said. "But as a cricketer you are [always] trying to add to your captaincy. If you give confidence and trust in a player,

he will do things you can't even imagine. That's the ideology we will try to have. We will give them trust, clear communication and lay out what role we have for them.

Kohli available for **Delhi's Ranji Trophy** game starting **January 30**

welve years after he last featured in India's premier domestic first-class tournament, Virat Kohli is set to return to the Ranji Trophy. Kohli confirmed his availability to play in Delhi's last round of group-phase matches, against Railways, from January 30 to February 2. The development was confirmed to ESPNcricinfo by Delhi head coach Sarandeep Singh.

Kohli was a conspicuous absence in the squads for the penultimate round of group-phase matches, starting from January 23, when Delhi play Saurashtra in Rajkot. Both Rishabh Pant and Ravindra Jadeja confirmed they would play this match, but Kohli was ruled out after he informed the BCCI medical staff that he was still recovering from neck pain, for which he had taken an injection on January 8, three days after the Border-Gavaskar Trophy ended in Sydney. Several other India players will also feature in the January 23 round of games, including Rohit Sharma, Shubman Gill and Yashasvi Jaiswal.

While reviewing India's recent run of defeats in Test cricket, against New Zealand followed by Australia, the BCCI in coordination with the team leadership group comprising head coach Gautam Gambhir, Test and ODI captain Rohit, and chairman of selectors Ajit Agarkar laid down various rules including making it mandatory for centrally contracted players to feature in domestic cricket. If not on duty elsewhere, a player can opt out only with prior permission of the selection panel head, the BCCI said.

It could not be confirmed if Kohli has told the Indian team management and Agarkar yet about him playing the January 30 round of Ranji games. If that match goes the distance, finishing on February 2, it would be a mere three days between that and the start of the ODI series against England on February 6. Kohli is part of the India squads for the England series followed by the Champions Trophy, where India play their first match on February 20.
