# Supreme Court refers to another bench pleas of RBI, others related to writing off AT-1 bonds of Yes Bank

**NEW DELHI**: The Supreme Court on Wednesday referred to another bench the pleas of the Reserve Bank of India and others challenging a Bombay High Court order that quashed a decision of the Yes Bank administrator to write off additional tier 1 bonds worth Rs 8,415 crore as part of a bailout.

Additional Tier 1 (AT-1) are perpetual bonds issued by banks to increase their capital base and they are riskier than traditional bonds having higher interest rates. The RBI can ask a bank to cancel them if the bank is in trouble.

Abench comprising Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and KV Viswanathan said it will not hear the four pleas filed against the high court's decision. Without assigning any reason, the CJI said the pleas will now be heard by a bench headed by Justice A S Oka after a week. A bench headed by the then CII D Y Chandrachud (since retired), on March 3, 2023, had issued the notices to Axis Trustee Services Ltd on as many as four petitions filed by the RBI and others against the high court judgement.

The top court had also extended the stay on the operation of the high court order, quashing the decision of the Yes Bank administrator to write off AT-1 bond worth Rs 8,415 crore as part of the bailout in March 2020.



The cases were not listed for hearing before the bench after the first hearing on March 3, 2023.

The high court had on January 20, 2023 quashed the decision of the Yes Bank on March 14, 2020 to write off the bonds noting the administrator did not have the authority to take such a decision.

The top court, however, had assured the AT-1 bond investors that it would try to find out some kind of solution to the financial trouble being faced by them after senior advocate Mukul Rohatgi, appearing for Axis Trustee Services Ltd, said the invested money has become "zero" for no fault of theirs.

"It was the top officials of the bank who brought down the bank...Our money has are institutional investors. Some people invested their hard earned money. What wrong did we commit? Why should we

suffer," Rohatgi had said. Solicitor General Tushar Mehta, appearing for the RBI, and senior advocate Kapil Sibal, representing the Yes Bank, had said the PSU banks agreed to bailout and infused money in Yes Bank after it was decided to write off AT-1 bonds.

The Yes Bank had said that these were non-convertible, perpetual bonds yielding high interest at the rate of 9.5 per cent and they can be written off to save the bank.

The top court had said it might use its extraordinary power under Article 142 of the Constitution to find some solution for the bond holders.

The high court, while quashing the decision of the Yes Bank Administrator had, however, said its decision will be in abevance so the central bank and Yes Bank may appeal against it in the apex court.

The high court had in its judgment said the Final Reconstruction Scheme of the Yes Bank issued by the Reserve Bank of India did not engulf within its fold writing down/off the AT-1 bonds.

"The final scheme sanctioned by the Central government did not contain the clause or provision for writing down AT-1 bonds," it had said. The high court had further held when the RBI prepared the draft scheme for reconstitution of the bank, it had invited suggestions and objections and it appears the petitioners had raised objection to the writing down of AT-1 bonds and even suggested their conversion into shares.

The high court had, however, stayed its order for a period of six weeks.

The petitions before the high court had also sought directions against National Securities Depositories Limited and Central Depository Services to take steps to reverse the effect of any accounting, entries, noting, write-offs, cancellations, or any such steps that may have been undertaken pursuant to the impugned decision to write off the bonds.

### **Hearing Deferred Again Due To Lawyers' Strike**

SULTANPUR (UP): The hearing in the defamation case against Congress MP Rahul Gandhi was adjourned again due to the continuing strike of lawyers.

Plaintiff Vijay Mishra's counsel Santosh Kumar Pandey said the special MP-MLA judge Shubham Verma set January 30 as the next date of hearing to complete the cross-examination in the case.

Mishra, a local BJP politician, filed a defamation complaint against Gandhi in 2018 in the court alleging that during the Karnataka elections, the Congress leader made an offensive remark about BJP leader Amit Shah which hurt his sentiments.

The case was pending for five years, and when Gandhi failed to appear, the court issued a warrant in December, 2023, summoning him.

While Gandhi surrendered in court in February, 2024, his statement was recorded on July 26, 2024.

The special magistrate granted him bail on two sureties of Rs 25,000 each.

During his appearance in court, Gandhi claimed innocence and said a political conspiracy was being plotted against him.



The court subsequently directed the plaintiff to present evidence.

Though a hearing was scheduled on December 16, 2024, it was deferred due to the judge's absence. On January 2, 2025, when the crossexamination was not completed, the court set the next date for January 10, 2025. However, the hearing was rescheduled for January 22, 2025 due to the lawyers' strike.


### **HDFC Bank Reports Robust Financial** Performance for Q3 and **Nine-Month Period Ending** December 31, 2024 MUMBAI:: HDFC Bank Limited announced its financial

results for the quarter and nine months ending December 31, 2024, following approval by its Board of Directors. The results, prepared under Indian GAAP and subjected to a limited review by statutory auditors, reflect strong growth across key metrics.

The Bank reported consolidated net revenue of ₹652.8 billion for the third quarter, with a profit after tax (PAT) of ₹176.6 billion. This represents a year-on-year growth of 13.1% after adjustments for trading gains, prior year provisions, and tax credits. For the nine-month period, the consolidated PAT stood at ₹519.6 billion. Earnings per share for the quarter reached ₹23.1, and the book value per share as of December 31, 2024, was ₹656.6.On a standalone basis, HDFC Bank's net revenue for the quarter grew to ₹421.1 billion, a 6.3% increase from the previous year. Net interest income rose by 7.7% to ₹306.5 billion, supported by a core net interest margin of 3.43%. Other income, which includes fees, commissions, and foreign exchange revenue, amounted to ₹114.5 billion. The Bank maintained a cost-to-income ratio of 40.6%, with operating expenses increasing to ₹171.1 billion. Provisions for the quarter were lower at ₹31.5 billion, contributing to a PAT of ₹167.4 billion, reflecting a 13.6% adjusted growth year-on-year.

HDFC Bank's balance sheet remained strong, with total assets rising to ₹37,590 billion. Deposits grew by 15.8% yearon-year to ₹25,638 billion, with CASA deposits contributing 34.0%. Advances under management reached ₹26,276 billion, with retail loans showing a 10.0% growth, while corporate loans witnessed a decline.

### **Kejriwal unveils 7-point** 'manifesto' for middle class, says they are victim of 'tax terrorism'



NEW DELHI: A national convenor Arvind Kejriwal on Wednesday announced a seven-point "manifesto" for the country's middle class, saying they have been neglected by successive governments and are a victim of "tax terrorism".

In a video message on Wednesday, he said the iddle class is the real superpower of the Indian economy but has long been ignored and exploited solely for tax collection. Kejriwal announced the seven-point charter aimed at addressing the concerns of the middle class.

The demands included raising the education budget from the current 2 percent to 10 percent and capping private school fees. He also proposed

make quality education accessible to all.

The A chief stressed the need for an increase in healthcare spending, suggesting a rise to 10 percent of the GDP, along with the removal of taxes on health insurance premiums.

Kejriwal also called for an increase in the income tax exemption limit from ₹7 lakh to ₹10 lakh, citing the heavy financial burden on the middle class.

Another demand was the removal of GST on essential goods, which Kejriwal argued disproportionately affects middle class households. He also advocated for more robust retirement plans, including free healthcare for senior citizens in both private and government hospitals.

Additionally, he urged the central government to reinstate the 50 percent concession on train fares for senior citizens, which was discontinued in recent years. Kejriwal criticised political parties for reducing the middle class to what he described as a "slave mindset" since independence. He pledged that A MPs would raise the voice of the middle class in upcoming parliamentary sessions, vowing to make their issues a central focus of the politic discourse. The announcement comes just weeks before the Delhi Assembly elections scheduled for February 5, with results to be declared on February 8.

The Aam Aadmi Party, which won 62 of the 70 assembly seats in 2020, is seeking a third consecutive term.

## Kolkata medic's rape-murder case: CBI to seek death sentence in **HC for Sanjay Roy**



**NEW DELHI**: The CBI will file an appeal before the Calcutta High Court, seeking death sentence for Sanjay Roy, who was sentenced to "life imprisonment until death" by a Sealdah court in the rape-cum-murder case of an on-duty doctor at RG Kar Medical College and Hospital, officials said Wednesday. The agency received a legal advice suggesting that the case may be categorised as the "rarest of rare", deserving capital punishment, they said. The agency is likely to file the appeal against the Sealdah court order as possible with detailed arguments in favour of capital punishment, they said.

The agency's plea seeking death penalty for Roy was turned down by the trial court, where Additional District and Sessions Judge Anirban Das said that the crime did not fall under the "rarest of the rare" category.

"The CBI prayed for the death penalty. The defence lawyer prayed that a jail term be given instead of the death penalty. This crime does not fall under the 'rarest of the rare' category," the judge said on Monday while sentencing Roy. "I am sentencing you to life imprisonment, meaning till the last day of your life, for causing injury during the act of committing rape on the victim that led to her death...," he told Roy. The West Bengal government has already approached the high court, challenging the verdict and seeking death penalty for Roy. The CBI has opposed the state's right to file an appeal in the case, claiming that as it was the prosecuting agency. it had the right to appeal on the grounds of inadequacy of the sentence.

### **RSF Sounds Alarm Over Dire Conditions for Afghan Journalists in Pakistan**

Reporters Sans Borders (RSF) has raised serious concerns about the worsening plight of Afghan journalists exiled in Pakistan, who face police harassment, arbitrary arrests, and threats of deportation.

RSF has urged the Pakistani government to guarantee their safety and uphold

"The visa renewal fee of \$100 per person places a heavy financial burden on journalists, many of whom are already struggling to make ends meet".

In recent weeks, multiple Afghan journalists have reported being detained, harassed, or threatened with deportation.



international principles of non-refoulement.

"Afghan journalists, forced to flee the Taliban to save their lives, are now living in extreme anxiety under recurring threats of arrest and deportation. The Pakistani government must take immediate action to ensure their safety and allow them to extend their visas for resettlement," said Célia Mercier, Head of RSF's South Asia Desk.

According to RSF report the situation has become particularly dire as Pakistani authorities have reduced visa durations for Afghan refugees to just one month, with renewal processes mired in complex bureaucracy.

Police raids targeting Afghan refugees in Islamabad and surrounding areas have intensified, reportedly as a response to strained relations between the Taliban regime and the Pakistani government.

One journalist, who wished to remain anonymous, was deported to Afghanistan after being detained in Islamabad. Others have recounted chilling experiences of police raids, detention in holding centers, and fines that they are unable to pay.

Several Afghan journalists shared their experiences with RSF under anonymity. A iournalist in Islamabad described how police conduct door-to-door searches to identify refugees without valid visas, often leading to immediate deportation. "In the past, visa extension applicants weren't harassed, but now even those in the process of renewal are targeted," they said.

Another journalist shared the ordeal of being detained with his wife and children: "My wife's visa had expired, but she was

Despite this, we were taken to a deportation camp and spent the night in fear for our children who were left at home. We were released after pleading with the police chief but fined \$400 for the visa delay, an amount we cannot afford. We are living in constant fear."

In another case, a journalist and their family were detained despite applying for a visa extension. "I was released because of my children's young age, but my husband was deported to Afghanistan, where his life is in grave danger," they said.

RSF has established a support network for exiled Afghan journalists and is urging relevant authorities to provide these media professionals with dignified living conditions and facilitate their resettlement in permanent host countries.

Pakistan, ranked 152nd out of 180 countries in RSF's 2024 World Press Freedom Index, faces growing criticism for its treatment of refugees, particularly Afghan journalists who fled their homeland to escape Taliban persecution.

RSF's appeal underscores the urgent need for Pakistan to uphold its international obligations and provide these journalists with the protection and support they desperately

power failures, particularly in rural and remote areas", Sakeena maintained.

equipments to handle exigencies. "Establish a swift replacement and repair mechanism for transformers to minimise disruptions and mitigate impact of

the Minister asked the officers to expedite pending maintenance and upgradation works on the power infrastructure across the district. She highlighted the need for long-term planning and a robust strategy to address recurring issues in the power sector. Sakeena Itoo further asked the officers for

augmentation of receiving stations in the district as the existing receiving stations are overloaded. She directed the officers

to upgrade and increase number of receiving stations in the district under RDSS scheme.

While reviewing several issues raised by general public of the district, the Minister called upon the officers for reduction of sanctioned load to people living in far off areas as they face frequent electricity cuts due to adverse weather conditions. She further advised the officers to register their power connections as per the electricity utilised so that the burden of electricity bills on them is reduced.

During the meeting, the Deputy Commissioner Kulgam briefed the Minister about the overall power scenario of the district.

## Crime Branch Books 6 Including Bank Employee For 1.34 Cr Jobs Fraud In Army, J&K Bank

**Jammu:** Crime Branch (CB) has booked six accused persons including a J&K Bank employee for duping 15 candidates of Rs. 1.34 crores on the pretext of providing jobs in Territorial Army and I&K Bank.

Two written complaints with same contents were received in Crime Branch wherein the complainants namely Jugal Kumar S/o Sain Dass R/o Village Shahzad Pur Ramgarh Samba and Gopal Chand S/o Amir Chand R/o Village Rajpur Jatan Tehsil Ramgarh District Samba and others alleged that (1) Tarsem Singh S/o Balbir Singh &; (2) Balbir Singh S/o Khazan Singh both residents of Dhyansar W.No. 02, Bari Brahmana, District Samba fraudulently told the complainants about the vacancies in sports category in Territorial Army and also demanded money from them and the

complainants transferred the amount through cheques, online and cash modes in their favour as per their demand.

Thereafter, the above-mentioned persons prepared fake call letters for those purported to be related with the joining of the complainants in the Territorial Army and also put the fake signatures and stamps of senior officers.

When the complainants went for their joining as per the joining letters, they were not allowed to join and then they realised that fraud was committed with them. The original qualification certificates as well as the other documents are still lying in the

possession of accused persons and they refused to return the same.

The accused have received Rs. 09 lakhs per head from candidates by fraudulent means.

Another written complaint lodged by Sahil Choudhary S/o Sultan Hussain R/o Dabber Potha, Tehsil Nowshera,

District Rajouri with Anti- Corruption Bureau, Jammu which was got enquired by ACB through SSP Srinagar and SSP Rajouri was received in Crime Branch (EOW) Jammu through PHQ & CHQ in which the complainant alleged that Sunny Sharma S/o Om Parkash R/o village



Laroka Tehsil Qila Darhal at present Ward No.4 Near Tehsil Office Nowshera, Rajouri and Bisharat Hussain Mirza S/o Faquir Mohd. R/o Jamola, Manjakot, Rajouri came to Nowshera and met the complainant accompanied by his grandmother Shah Begum. Both accused persons brought the complainant and his grandmother under their influence and assured that they would provide permanent appointment of the complainant in the J&K Bank as Class IV employee for which the complainant would have to pay Rs. 8.00 Lakhs.

The accused persons further assured that they would receive the said money from the complainant only after they would handover the appointment order to

The complainant and his grandmother were convinced

by the accused persons.

The accused persons after sometime introduced the complainant and his grandmother to two other persons namely Majid Ali R/o Srinagar (employee in J&K Bank Ltd. Hari Singh High Street Branch Batmaloo, Kashmir) and Imran Tantray R/o Srinagar who asked the complainant to come to Srinagar for his appointment. Thereafter the complainant along with his grandmother went to Srinagar where the complainant met with both accused persons Majid Ali and Imran Tantray.

During the stay of complainant and his grandmother in Srinagar, the accused persons compelled the complainant to make payment as agreed between them in the accounts provided by accused persons.

The complainant made bank transactions of the amount of Rs. 7.90 Lacs in the accounts provided by the accused persons. On receipt of the said whole payment, accused Majid Ali called the complainant and handed over the copy of appointment order for the post of Banking Attendant at The Jammu and Kashmir Bank

Limited, Business Unit: Dalhori Rajouri to the complainant. Thereafter, the complainant went to J&K Bank Ltd.

Branch Dalhori, Rajouri for his joining where the complainant informed by the said Bank Branch Head that the said appointment order

is fake and frivolous and no such appointment order

Senior Superintendent of Police Crime Jammu, Benam Tosh confirmed that two cases viz. Case FIR No. 07/2025 and FIR No. 08/2025 have been registered at P/S EOW, Crime Branch Jammu and investigation is underway. (ANB)

2. Perennial Philosophy in the Postmodern World: Enigma of Osho

This study situates Osho's teachings within the framework of perennial philosophy, exploring their relevance in addressing the fragmentation of postmodern consciousness. Dr. Shah critically analyzes Osho's version of postmetaphysical thought and new age spirituality and alerts us to the dangrs in this libertine spirituality and fuzzy philosophy. While highlighting limitations of all is ok spirituality of New Age Guru Osho, he underscores the enduring relevance of perennial wisdom in tackling existential crises, calling for an integrated approach that bridges ancient insights with contemporary sensibilities. He conckudes that "His philosophy of ego though informed by traditional Islamic thought is

uniquely his and approaching the problem of evil from such a perspective is unprecedented in Islamic history."  $3. Muslim\,Modern is m\, and\, the\, Problem\, of\, Modern\, Science$ 

Dr. Shah navigates the complex relationship between Muslim modernist thought and the paradigms of modern science in this thought-provoking work. He critiques the uncritical adoption of scientific positivism while emphasizing the compatibility of Islamic epistemology with authentic scientific inquiry. Advocating for a dialogical engagement between faith and reason, he envisions a synthesis that not only respects religious convictions but also enriches scientific understanding. . It is an important contribution in application of the perennialist approach to Muslim modernism and its appropriation of modern science. It reorients the debate on Islamization of knowledge by juxtaposing otherwise divergent approaches of [postmodernism and perennialism). Certain popular modern works on Islam and Science have been scrutinized from the perennialist viewpoint. Engaging with works of Harun Yaha, Zakir Naik, Fatehullah Khan, Wahidudin Khan, Abdul Bari Nadvi, Ziaudin Sardar, Maurice Buccaille, I.R. Faruqi and postmodern philosophers of science, it criticizes Muslim modernist approach to the question of modern science which assumes overall compatibility of Islam and modern scientific worldview. The author



critiques demythologizing, rationalist (as distinguished from intellectualist), reductionist, evolutionist, secularist orientation of modern scientific thought.

4.Revisiting Sufism

Dr. Shah's exploration of Sufism is both a scholarly and spiritual journey into the heart of Islamic mysticism. Amidst debates on orthodoxy, late origins, and alien influences on Sufism and charges from ethico-legal and political standpoints, the author points out self understanding of Sufism as a path to reclaim wonder and beauty calls for attention. The author argues that Sufism should interest everyone though for salvation it is not a requirement. He presents it as universally treasured aspirations of mankind involving "openness to the other, doing everything as it should be ideally done/with an eye on beauty, sincerity of purpose, science of stations/virtues, freedom, propriety, giving everything its due. The book clarifies key charges - ""deviation from the Revealed Norm and alien origins/ influences, indulgence in moral/spiritual transgressions, ecstasies or airy abstractions - against it. The key debates surrounding Kashmir's Reshi-Sufi legacy are sought to be addressed as well

5. Revisiting God Debate

This book frames God debate in terms that should concern everyone - "longing for beauty, commitment to truth, call of conscience, joy of contemplation, obligation to sacrifice for the other, grandeur of nature, the mystery and wonder of life, the pull for the numinous and the poetry or ecstasy of being, reverence for the saint and the discontent with the given" and presents God as a Question. It seeks to show that "major philosophers including Heraclitus, Plato Hegel, Spinoza, Bradley, Kierkegaard, Nietzsche, Wittgenstein, Heidegger, Whitehead, Derrida, Levinas, great Judeo-Christian-Muslim and other religious or traditional philosophers, major artists and writers, Eastern and Western, all fundamentally share something of what has been called as mystical view of God or transcendence." Putting religious and secular approaches to God in dialogue, the book constitutes "an invitation to enjoy fellowship of God for all and sundry and so-called believers and non-believers.

Challenges and Critiques of Dr. Shah's Vision

1)Shah's works pose challenges for contemporary readers. The profound interdisciplinary nature of his thought demands a familiarity with a wide range of intellectual traditions, which can make his writings appear inaccessible. Moreover, his integration of Western existentialism and Islamic mysticism, while enriching, invites critical engagement with the tensions and contradictions that arise from this synthesis. These challenges, however, are not shortcomings but invitations for deeper engagement, encouraging readers to grapple with the complexities of his thought and uncover its transformative potential.

2)His emphasis on shared spiritual values across religions, drawing parallels between Islamic thought and other spiritual traditions, raises concerns about the potential dilution of the unique aspects of individual faiths. Focusing too much on universal values, Shah risks reducing the richness of distinct religious identities to generalized spiritual truths. While his work advocates for interfaith dialogue and the recognition of common spiritual concerns, there is a tension between the desire for unity and the preservation of religious particularities.

3)Shah's integration of Sufi and philosophical elements within Islamic thought highlights the depth and diversity of Islamic spirituality. By focusing on spiritual transformation rather than literal legalistic interpretations, he draws attention to the mystical dimensions often overlooked in modern Islamic scholarship. However, his approach leans too heavily on the esoteric, potentially underrepresenting the pragmatic and legalistic aspects of Islam. Nonetheless, Shah's approach to integrating mysticism within mainstream Islamic discourse is a substantial contribution that broadens the interpretive possibilities within Islamic studies.

4) While Dr. Shah's thought is intellectually and spiritually compelling, it also faces several challenges. One of the main issues lies in the fundamental differences between Islamic and Western philosophical frameworks. Western existentialism, for example, is often grounded in individualism and autonomy, while Islamic philosophy traditionally emphasizes community, submission to God, and the primacy of Divine will. This divergence creates a tension within Shah's work, as he attempts to integrate the individualistic focus of existentialism with the collective and theocentric worldview of Islam.

However, It may be argued that this view may risk diluting unique aspects of individual faiths, potentially reducing distinct religious identities to generalized values. His universalism invites readers to reconsider boundaries but also faces the challenge of balancing universal values with particular religious identities.

6) This synthesis also raises questions about the extent to which existentialist themes like self-realization and personal freedom align with Islamic teachings. Critics may argue that while existentialism emphasizes the self as the ultimate arbiter of meaning, Islamic thought requires a balance between personal agency and submission to God. Shah's attempt to blend these perspectives can be seen as an intellectual challenge that requires careful navigation to avoid misrepresenting either tradition.

7)Dr. Shah's engagement with Western thought is significant, as he bridges Islamic and modern intellectual traditions, making Islamic philosophy relevant to contemporary audiences. By positioning Islamic mysticism as a response to existential concerns, he effectively presents it as a timeless spiritual system. However, his reliance on Western philosophy might overshadow distinctively Islamic concepts, potentially reshaping Islamic thought in ways that align with Western frameworks. Despite these critiques, Shah's synthesis is innovative, showing that Islamic spirituality has much to contribute to global philosophical discourse

Critics, however, might view his critique as too idealized, perhaps underestimating the need for adaptability in modern contexts. MLA Budhal, Javed Iqbal Choudhary said the situation is of serious concern and that the government is making all-out efforts to manage the crisis. Principal, GMC Rajouri, Dr Amarjeet Singh Bhatia said all fatalities exhibited brain involvement and nervous system damage. "Among nine admitted patients, five have recovered, but recovery becomes challenging once the brain is affected," Dr Singh said, adding that preventive measures and public awareness campaigns are being prioritised to curb further risks.

The inter-ministerial team, constituted by Union Home Minister Amit Shah and led by a directorlevel officer from the Ministry of Home Affairs, continued its investigation for the third consecutive day. Experts from the Ministries of Health, Agriculture, Chemicals, and Water Resources, as well as forensic departments from Chandigarh and Lucknow, are

The District Magistrate of Rajouri has declared Badhaal as a containment zone. He has issued orders to prohibit all public and private gatherings.

The affected families have been categorised into three containment zones to ensure continuous monitoring and prevent further spread:

Containment Zone 1: Homes of families where deaths have occurred will be sealed, with no entry allowed unless authorised. Containment Zone 2: Close contacts of affected

persons will be shifted to GMC Rajouri for health Containment Zone 3: All households in Badhaal village, with staff deployed to monitor

food consumption. Designated officials have been tasked with overseeing food distribution to families in containment zones. Logbooks will document every instance of food consumption, with police personnel monitoring compliance.

### **Comprehensive surveillance**

with safe food and water to the households in the affected localities.

Designated officers are tasked with maintaining a log book with three daily entries documenting food distribution and consumption to safeguard public health and contain the spread of the situation.

The area has already been declared as the containment zone with implementation of comprehensive surveillance measures and imposition of Section 163 of the BNSS for immediate compliance.

To contain the situation and prevent further escalation, the area has been divided into 3 containment zones which include the locality of families which suffered deaths. The affected houses have been sealed and entry

having contacts with the affected families. Further, on the direction of Divisional

Commissioner Jammu, Deputy Commissioner Abhishek Sharma ordered immediate relocation of close contacts and high-risk contacts of affected families from Badhaal Village to Nursing College and Government Medical College (GMC) Rajouri.

The decision forms part of a proactive approach to ensure the safety and well-being of the community amid prevailing concerns.

The Animal and sheep Husbandry Department has been tasked with deploying officials to manage and take care of domestic animals left behind in the village, ensuring their safety and proper upkeep.

The district administration is working round the clock to provide all necessary assistance and appeals to the public to cooperate fully with the containment measures.

The Minister also emphasised long term strategy for reducing dependence on external wood supplies and enhancing self-sufficiency. He also reviewed the enforcement actions including closure orders, environment compensations and compliance improvements. He said that significant focus should be given towards achieving Clean Air Action Plans in major urban centres.

While reviewing the forest protection measures, Rana said that forest fire prevention and management mechanisms have gained added significance due to the adverse climatic conditions and mitigation measures need to be taken beforehand.

He also directed the officers for optimum utilisation of available resources for revenue generation and sustainable livelihoods created through eco-tourism and forest recreation.

Discussions were also held on progress in developing high quality planting material through advanced research and capacity building programs for forest officers and frontline staff.

Rana said that saplings of important species should be raised every year for supply to the forest department and other user agencies for coverage of forest area.

During the meeting, detailed presentation was given highlighting the achievements of various wings of the department.

## Rahane backs Rohit to 'get a big one' on Ranji return

umbai captain Ajinkya Rahane has backed his team-mate Rohit Sharma to "get a big one" as the India Test captain returns to the Ranji Trophy after low returns in his last eight Tests this season. In the three Tests in Australia and five at home before that, Rohit managed only 164 runs from 15 innings to average a dismal 10.93.

Rohit now returns to the domestic cricket -although likely for one round before the ODIs against England-along with many other India Test players such as Rishabh Pant, Ravindra Jadeja, Shubman Gill, Yashasvi Jaiswal and possibly Virat Kohli.

"What is important is he is hungry, he is determined to do well." Rahane said of Rohit on the eve of Mumbai's next fixture starting on Thursday. "I am sure once he gets in, he will get a big one.

"He batted really well yesterday [in] a couple of [net] sessions, so it's part and parcel of a player's career. I am really confident about Rohit.

"Rohit has always been relaxed. Even playing at the international level, his character is similar. His attitude is pretty much relaxed. He knows his game really well so, no one has to tell him what he needs to do.

"Once he gets in, I'm sure he will do well. He has never changed, which is a very good thing."

After the coming round in which Mumbai host Jammu & Kashmir at home, Rohit will captain India against England in a three-match ODI series starting on February 6 followed by



the Champions Trophy.

"I think he's only playing this game; not sure about the next game," Rahane said of Rohit's availability. "His inputs in the next four days will be really important."

Mumbai also have Jaiswal for the upcoming round, although he was among India's better batters on the tour of Australia, with a knock

of 161 in Perth at the start of the series and twin half-centuries in Melbourne. Rahane said the return of Rohit and Jaiswal would add a lot of value in the dressing room too.

"As a team, [and] individually, players are going up to them [and] asking questions, learning from them," Rahane said. "Once they are on the field, I am sure the players will

watch them and they'll learn a lot of things

Rohit and Jaiswal are expected to open together for a star-studded Mumbai line-up that will also see Shreyas Iyer, Shivam Dube  $and \, Shardul \, Thakur \, along \, with \, other \, domestic \,$ stars such as Shams Mulani, Siddhesh Lad and Tanush Kotian.
