# **Police Can't Serve Accused Notice Via** WhatsApp, Other Electronic Means: SC

**NEW DELHI:** The Supreme Court has said police cannot serve notices to accused persons through WhatsApp or other electronic modes under the Criminal Procedure Code or Bhartiya Nagrik Suraksha Sanhita, 2023.

A bench of Justices M M Sundresh and Rajesh Bindal directed all states and union territories (UT) to issue appropriate directions to police for issuing notices under Section 41 A of CrPC, 1973 or Section 35 of BNSS, 2023 only through the mode of service permitted under the law.

"All the states/UTs must issue a standing order to their respective police machinery to issue notices under Section 41-A of CrPC, 1973/Section 35 of BNSS, 2023 only through the mode of service as prescribed under the CrPC, 1973/BNSS, 2023," the bench said on January 21.

The President will address both the Houses of Parliament assembled together in the Lok Sabha chamber on Friday and Finance Minister Nirmala Sitharaman will present the General Budget on Saturday.

The Finance Minister will table the Economic Survey on Friday when both Lok Sabha and Rajya Sabha will

convene briefly after the President's address. Lok Sabha has provisionally allotted two days (February 3-4) for discussion on the Motion of Thanks to the President's address, while Rajya Sabha has earmarked three days for the debate.

### extradition of 26/11 Mumbai terror attacks mastermind Tahawwur Rana

NIA team likely to visit USA soon for

NEW DELHI: A team from the National Investigation Agency (NIA) is likely to visit USA very soon to complete the formalities for the extradition of Tahawwur Rana, who is wanted in India for his role in the 26/11 Mumbai terror attacks, sources said.

The move is learnt to be taken considering the US Supreme Court's recent decision rejecting a review petition filed by Rana challenging his extradition to India. The decision has cleared a significant legal hurdle, allowing Indian authorities to accelerate the process of bringing him to justice.

As per sources, a team of Inspector General



and Deputy Inspector General rank officers are likely to visit the USA by the end of this month, the move regarding it has been shared with the Ministry of Home Affairs as well as the Ministry of External Affairs.

Rana, a former doctor and businessman, is a Canadian citizen of Pakistani origin. He is accused of facilitating the reconnaissance activities of David Coleman Headley, the main planner of the 26/11 Mumbai attacks.

He allowed Headley to use his immigration business as a front to travel to India and identify potential attack targets. Rana was arrested in 2009 in Chicago by the FBI for his role in a Pakistan-supported terror network. He was convicted in the US for supporting the Lashkar-e-Taiba (LeT), the terror group behind the attacks, but acquitted on charges directly related to the Mumbai attacks.

Police said Bagga Singh and Puskaran Singh are op-eratives of US-based terrorist Happy Passia.

A hand grenade and two pistols have been recovered from their possession.

### Countdown For ISRO's 100th **Mission Begins At Sriharikota**

SRIHARIKOTA, (ANDHRA PRADESH): The 27-

hour countdown for ISRO's historic 100th mission from this spaceport, launch of a Navigation satellite onboard a GSLV rocket commenced on Tuesday, sources in the space agency said. Also, this would be the first mission for ISRO Chairman V Narayanan, who assumed office on January 13.

The Geosynchronous Satellite Launch Vehicle (GSLV) with indigenous Cryogenic upper stage in its 17th flight, carrying the navigation satellite NVS-02 is scheduled for lift-off at 6.23 am on January 29 from the second launch pad here.

The navigation satellite is the second in the series of the Navigation with Indian Constellation (NavIC) aimed to provide accurate position, velocity and timing to users in the Indian sub-continent as well as to regions about 1,500 km beyond the Indian land mass.

"The 27.30 hour countdown commenced at 02.53 am on Tuesday," multiple sources told PTI.

The 50.9 metre tall GSLV-F15 follows the GSLV-F12 mission which successfully carried navigation satellite NVS-01, the first of the second generation satellites on May 29, 2023.

NavIC comprises five second generation satellites-NVS-01/02/03/04/05 envisaged to augment NavIC base layer constellation with enhanced features for ensuring continuity of services.



The NVS-02 satellite designed and developed by the UR Satellite Centre weighs about 2,250 kg. It has navigation payload in L1, L5 and S bands in addition to ranging payload in C-band like its predecessor NVS-01.

The key applications the satellite would be used for are terrestrial, aerial and maritime navigation, precision agriculture, fleet management, location based services in mobile devices, orbit determination for satellites, Internet-of-Things (IoT) based applications, emergency and timing services, ISRO said.

### FS Misri in Beijing India, China to resume Kailash Mansarovar Yatra, share hydrological data

**NEW DELHI** : India and China have decided to resume the Kailash Mansarovar Yatra this year, and have also agreed to hold an early meeting of the Expert Level Mechanism to discuss resumption of provision of hydrological data and cooperation on trans-border rivers, following talks between Foreign Secretary Vikram Misri and Chinese Foreign Minister Wang Yi in Beijing.

Foreign Secretary Misri visited Beijing on January 26-27 for a meeting of the Foreign Secretary-Vice Foreign Minister mechanism between the two sides held on January 27.

As agreed between Prime Minister Narendra Modi and Chinese President Xi Jinping at their meeting in Kazan on October 23, the two sides reviewed the state of India-China bilateral relations comprehensively and agreed to take certain people-centric steps to stabilize and rebuild ties, a statement said.

In this context, the two sides decided to resume the Kailash Mansarovar Yatra in the summer of 2025; and will discuss the modalities for doing so as per existing agreements. They also agreed to hold an early meeting of the India-China Expert

Level Mechanism to discuss resumption of provision of hydrological data and other cooperation pertaining to trans-border rivers.

The two sides agreed to take appropriate




measures to further promote and facilitate people-to-people exchanges, including media and think-tank interactions. They agreed in principle to resume direct air services between the two countries;

the relevant technical authorities on the two sides will meet and negotiate an updated framework for this purpose at an early date.

The two sides recognize that 2025, being the 75th anniversary of the establishment of diplomatic relations between India and China, should be utilized to redouble public diplomacy efforts to create better awareness about each other and restore mutual trust and confidence among the public. The two sides will conduct a number of commemorative activities to mark this anniversary.

The two sides took stock of the extant mechanisms for functional exchanges. It was agreed to resume these dialogues step by step and to utilize them to address each other's priority areas of interest and concern. Specific concerns in the economic and trade areas were discussed with a view to resolving these issues and promoting long-term policy transparency and predictability.During his visit, Foreign Secretary called on Member of the Politburo of the Central Committee of the Communist Party of China, Director of the Office of Central Commission of Foreign Affairs and Foreign Minister Wang Yi, and Minister of the International Department of the Communist Party of China Liu Jianchao.



# Pahalgam to get gondola facility to boost year-round tourism

Drag lift for Aru Valley to promote winter sports, adventure tourism: Official

Srinagar: Pahalgam, one of Kashmir's most iconic tourist destinations, is set to receive a stateof-the-art gondola service, designed to rival the renowned Gulmarg Gondola. The proposed cable car project aims to enhance the region's tourism potential and attract visitors year-round, particularly during the winter months.

According to details obtained by the news agency-Kashmir News Observer (KNO), the proposed aerial route will span approximately 2 kilometres, connecting Yatri Nawas to the scenic meadow of Bai Saran, which is surrounded by snow-capped mountains and dense pine forests.

An official from the J&K Tourism Development Corporation (JKTDC) said the Detailed Project Report (DPR) is in its final stages, with the Board of Directors expected to make a decision soon. "While a few No Objection Certificates (NOCs) from forest and other concerned departments are still pending, efforts are underway to expedite the process." the official added.

The project, designed with environmental



sustainability in mind, ensures no deforestation will occur during construction. A drag lift is planned for Aru Valley to promote winter sports and adventure tourism, which will further enhance the region's appeal as a hub for adventure activities, the official said.

"These initiatives are expected to transform Pahalgam into a year-round tourist destination," he added

Local stakeholders, including hoteliers and travel agents, have warmly welcomed the move. Uzair Ahmad, a local hotelier, told KNO, "Pa-

halgam sees a steady flow of tourists during the summer, but winter months witness a significant decline. Facilities like the gondola and drag lift will keep Pahalgam vibrant throughout the year."

He said most hotels in the area currently lack central heating systems, as many remain closed during the winter due to low tourist numbers. "If the winter footfall increases, hoteliers can upgrade facilities, which will benefit the local economy," Ahmad added.

The gondola project is being described as a "game-changer" for Pahalgam by local authorities and stakeholders. It is expected to reduce congestion at Gulmarg by offering tourists an alternative adventure site while establishing Pahalgam as a premier destination for both summer and winter activities.

The drag lift at Aru Valley is particularly aimed at promoting winter sports, attracting adventure enthusiasts and hosting potential sporting events in the future.

With the completion of these projects, Pahalgam is set to see a boost in tourist footfall, particularly during the winter months-(KNO)

# 21st century innovations in teaching

With training moving even farther into the future, everything about research has seemed to have gone overboard and teachers have to run as fast into a culture full of changes and demands with relation to the learning process of their members. A chalk and talk approaches no more cuts it in a world driven by technology, creativity, and critical thinking. We ought to embrace innovative verbiage of teaching whereby curiosity, collaboration, and lifelong procedures happen rather concurrent within young minds in order to make learning stick.

1. Activity based learning: Activity based learning can be one of the most powerful ways to keep students interested in the class. I found it very interesting because, when I first used it in my class, the enthusiasm changed. Instead of listening passively, they would be an active participant.

For instance, explaining mathematical concepts with the help of puzzles, games, and solving real life problem solving scenarios. It makes the learning fun for them and hence, retains their information.

2. Tech infused learning: We are the digital generation and do not have an option but to integrate technology with learning. There is no place for textbooks for students when Smart boards, educational apps, and virtual classrooms are available.

I have used interactive quizzes, storytelling apps, and even some online simulations where one can make a lesson more interactive. For example, in a history lesson, a virtual tour of the ancient world could be given via Virtual Reality to take students through another era, making learning much more immersive.

3. Flipped classroom: The flipped classroom model reverses the traditional approach. Instead of teaching concepts in class and giving homework later, the students learn it at home, through videos, articles, or presentations. Class time is then used for discussions, problem solving, and application based activities.

I noticed that when I implemented this strategy, students were better prepared to come to class and were eager to clarify doubts, and more so, they were more involved in group activities. 21st Century Innovations in Teaching

Education has been an inevitable journey into a pretty future; research has always been moving forward and so far necessitated the educators to run. They need to run even faster through cultion, immediate feedback, and a positive learning atmosphere.

5. Personalized learning: Each child has his/ her unique set of characteristics and, thus, the same teaching method cannot work for all of them. Personalized learning helps students to learn at their own pace and time based on the areas in which they are both strong and poor. By using AI powered tools and adaptive learning platforms, we can do classes with personalized assignments, keep numbers on the progress and



tural shifts and make huge demands on them, and on the community members from the context of the learning process. No more chalk and talkonly world in the midst of so much emerging technology, creativity, and critical think. It's a new script of teaching that has to offer a time for the curiosity, collaboration, and life procedures happening simultaneously as it is in the young mind, in order for the learning to stick.

4. Gamification: Gamification is a very effective engagement strategy. By adding points, badges, leader boards, and interactive games, we can make even the most difficult subjects fun.

I remember using a math quiz competition in my class where students earned points for correct answers. Their excitement and motivation were remarkable. Games encourage healthy competiprovide targeted help. I saw myself that students gave more importance to their studies and eventually work better if they get individualized attention

6. Experiential Learning: Students will understand the principles when they get to see them. The experiential type of learning is the one which includes trips to actual places, the students making real experiments, and other activities related to the topics they learned in the classroom.

As one example of such activity is an environmental science subject, students may vividly do such things as visiting a local conservation site which is used to show the way to become more sustainable. Real world experiences help students understand the relation between theory and practical concepts.

7. Storytelling: Stories can be a tool for entertaining, enlightening as well as educating. Whether one is teaching literature, history or even science subjects, using storytelling as a tool can make content easily understood and memorable.

I have frequently utilized the narration of true events to make it easy for students to understand difficult concepts. A simple story that tells about a scientist's struggles and attainments can be the reason for physics to become more appealing as a subject. Through storytelling, a learner develops a strong emotional connection.

8. Mindfulness and emotional learning: Learning is not just acquiring academic knowledge and memorizing facts; it is about mastering emotional intelligence and well-being. Practicing mindfulness to imagine inserting a few minutes each day, or even during class, for relaxation and sharing. The method, which can also include gratitude journals, meditation, and deep breathing exercises, improves student concentration, resilience, and positive thinking. I have witnessed the outcome of mindfulness exercises in my school, which gave me the idea of my research. I saw the children were able to concentrate better and were less worried and were more respectful to others. A person is happier and more balanced in relationship to his or her emotions when he or she can concentrate on the material he or she is learning. Embracing change for a brighter future

As educators, we carry the mantle of shaping minds for the young and preparing them for the future. Traditional ways are wonderful, but we have to innovate as educators to truly engage with 21st century learners by experimenting with new teaching techniques.

There have been confirmations that the utilization of activity based learning methods has created exciting learning environments. Sustainable learning centers don't just make one learn and retain knowledge, but inspire, empower, and nurture lifelong learners. The concepts are the newest in the teaching industry, so why don't we, educators, take it up and begin teaching in a fun, meaningful, and impactful ?



Availability and administration of vaccines have altered the turn of events a great deal this time. But that has not ended the pandemic, only taken the bite out of the disease in a small but significant way.

So, apart from medical intervention, this time around, people are banking a great deal on their immunity, to fight back any possible infection. Varying reports have been emerging, some saying the Omicron variant brings about mild (milder) symptoms as compared to earlier variants like Delta, etc.

What remains the baseline though is that it is one's immunity that will see one sail through. Take a look at these 8 steps that the Harvard Health (https://www.hsph.harvard.edu/ nutritionsource/nutrition-and-immunity/) experts say we must follow to keep our immune system strong and in peak fighting shape.

#### 8 steps to stronger immunity:

Eat a balanced diet: Include a platter of rainbow coloured fruits, vegetables, lean proteins, whole grains, and plenty of water. A Mediterranean Diet is one option that includes these types of foods. No need to hunt for the exotic. Regular tropical fruits available in India are potent in antioxidants. Have them sliced instead of juiced, retain the fibre, and have them fresh.

Ask your doctor about supplements: A deficiency of single nutrients can alter the body's immune response. Animal studies have found that deficiencies in zinc, selenium, iron, copper, folic acid, and vitamins A, B6, C, D, and E can alter immune responses. These nutrients help the immune system in several ways: working as an antioxidant to protect healthy cells, supporting the growth and activity of immune cells, and producing antibodies. Lack of proper supply of nutrients through diet exposes us to a greater risk of bacterial, viral, and other infections. If a balanced diet is not readily accessible, taking a multivitamin containing the RDA for several nutrients may be used.

Don't smoke (or stop smoking if you do): Research (https://www.ncbi.nlm.nih.gov/pmc/articles/PMC5352117/)



shows that cigarette smoking is associated with numerous diseases and poses a serious challenge to the current healthcare system worldwide. Smoking impacts both innate and adaptive immunity and plays dual roles in regulating immunity by either exacerbation of pathogenic immune responses or attenuation of defensive immunity. Why would you want to smoke or continue the habit if it puts you directly in the path of danger?

Moderate your consumption of alcohol: If you are already a drinker, and if your doctor recommends that you can continue to drink, bring down your consumption. Research (https://www.ncbi.nlm.nih.gov/pmc/articles/PMC4590612/) has established that there is an association between excessive alcohol consumption and adverse immune-related health effects such as susceptibility to pneumonia. In recent decades, this association has been expanded to a greater likelihood of acute respiratory stress syndromes (ARDS), sepsis, alcoholic liver disease (ALD), and certain cancers; a higher incidence of postoperative complications; and slower and less complete recovery from infection and physical trauma, including poor wound healing.

Perform moderate regular exercise: Research shows that Acute Respiratory Infections (ARIs) are caused by respiratory viruses and bacteria, being the most infectious disease in humans. Despite the lack of accurate data on how physical activity improves the immune response against the new coronavirus, there is evidence of lower rates of ARI incidence, duration and intensity of symptoms and risk of mortality from infectious respiratory diseases in individuals who exercise at high levels appropriate. Furthermore, different studies suggest that regular physical exercise is directly related to decreased mortality from pneumonia and influenza, improvements in cardiorespiratory function, vaccine response, metabolism of glucose, lipids and insulin.

Get adequate sleep: Aim for 7-9 hours of sleep nightly. Try to keep a sleep schedule, waking up and going to bed around the same time each day. Our body clock, or circadian rhythm, regulates feelings of sleepiness and wakefulness. Work-From-Home and continuous use of digital screens have rendered our boy clocks disturbed and out of rhythm with nature. Harvard report says that if we maintain a consistent sleep schedule, it can help balance the circadian rhythm so that we can enter deeper, more restful sleep.

Aim to manage stress: According to SimplyPsychology (https://www.simplypsychology.org/stress-immune.html), when we're stressed, the immune system's ability to fight off antigens is reduced. That is why we are more susceptible to infections. The stress hormone corticosteroid can suppress the effectiveness of the immune system (e.g. lowers the number of lymphocytes) and also propel us towards unhealthy behaviour such as drinking or smoking. It is said that one must learn to manage stress but frankly, that is easier said than done. All the same, Harvard experts advise that you must try to find some healthy strategies that work well for you and your lifestyle-whether that be exercise, meditation, a particular hobby, or talking to a trusted friend. Another tip is to practice regular, conscious breathing throughout the day and when feelings of stress arise. Learn Pranayam -- the Yoga of breathing techniques -- available through certified experts online on videos. It doesn't have to be too long-even a few breaths can help. If you'd like some guidance, try this short mindful breathing exercise.

Wash hands throughout the day: Especially ever since the COVID-19 pandemic spread across the world, most of us have adopted healthier lifestyles, mindfully. Sanitise your hand with a good quality alcohol rub prescribed by medics if no water and soap is available. Otherwise, the best option is to wash your hands several times a day, especially when coming in from outdoors, before and after preparing and eating food, after using the toilet, after coughing or blowing your nose.

# Is arsenic safe? Study says it may clog arteries

environmental exposure to low levels of the toxic metals arsenic, cadmium and titanium appears to increase the risk of plaque buildup in arteries in the neck, heart and legs. The study has been published in the 'Arteriosclerosis, Thrombosis and Vascular Biology Journal'

Traces of metal may enter the body through contaminated soil that infiltrates food, through rinking water, air pollutants or tobacco smo There is strong evidence that toxic metals, such as arsenic and cadmium, are cardiovascular risk factors. Arsenic and cadmium are often found in tobacco and food, while arsenic is also found in water. Titanium exposure is mainly derived from dental and orthopaedic implants, screws, pacemaker encasings, cosmetic products and some foods. "Metals are ubiquitous in the environment, and people are chronically exposed to low levels of metal," said lead investigator of the study Maria Grau-Perez, M.Sc., of the Institute for Biomedical Research Hospital Clinic de Valencia INCLIVA in Valencia, Spain, and a PhD candidate in the department of preventive medicine, public health and microbiology at the Universidad Autonoma de Madrid, in Spain. "According to the World Health Organization, 31 per cent of the cardiovascular disease burden in the world could be avoided if we could eliminate environmental pollutants," she added. Atherosclerosis developed when fatty deposits, or plaque, build up in the arteries causing them to narrow, weaken and stiffen. Depending on the arteries affected, it can lead to a heart attack, stroke, angina, peripheral artery disease or kidney disease. Prior research on the impact of metal exposure on atherosclerosis has traditionally centred on the carotid arteries, the major arteries in the neck. This study focused on subclinical atherosclerosis -- before symptoms are present -- and examined the impact of metal exposure on the carotid, femoral and coronary arteries. Previous research suggested that imaging of the femoral artery, which is the main artery supplying blood to the lower body, may lead to earlier detection of atherosclerosis. Researchers evaluated 1,873 adults (97 per cent men) in the Aragon Workers Health Study. The study participants worked at an auto assembly factory in Spain and ranged in age from 40 to 55. Researchers measured participants' environmental exposure to nine toxic metals -- arsenic, barium, uranium, cadmium, chromium, antimony, titanium,

research has found that vanadium and tungsten -- and the exposure's atherosclerosis. association with the presence of subclinical atherosclerosis in the carotid, femoral and coronary artery regions. The study explored the potential role of individual metals and metal mixtures on the development of atherosclerosis.

During the participants' annual occupational health visits between 2011 and 2014, socioeconomic and health information for each participant were recorded, including

education level, smoking status and medication use. Each person in the study had a medical examination to measure body mass index, blood pressure, blood glucose levels, cholesterol levels, triglyceride levels and more. The analysis found:

1. Older study participants had higher levels of most of the metals measured in the urine. 2. The few female participants in the study had higher metal levels compared to men when levels were measured in the urine.

3. Adults who had smoked at any time showed higher levels of arsenic, cadmium, chromium and titanium than the people who had never smoked.

4. Higher levels of arsenic, cadmium, titanium, and potentially antimony were associated with a higher probability of having subclinical

"This study supports that exposure to toxic metals in the environment, even at low levels of exposure, is toxic for cardiovascular health," said study co-author Maria Tellez-Plaza, M.D., PhD, a senior scientist at the National Center for Epidemiology and the Instituto de Salud Carlos III in Madrid, Spain.

"The levels of metals in our study population were generally lower compared to other published studies. Metals, and in particular arsenic, cadmium, and titanium, likely are relevant risk factors for atherosclerosis, even at the lowest exposure levels and among middle-aged working individuals," she added.

The study included a very specific population of mostly men in one area of Spain, so the results may not be completely extrapolated to women or other populations worldwide. Additional research is needed to understand the mechanisms involved in the development of atherosclerosis based on associations to metals.

Arms and shoulder rotations: You can do this exercise in the following steps

Stand straight and stretch your arms wide apart.

Rotate your arms on the axis in circles while keeping them straight. Do rotations of 5 and change the direction of rotation.

Do another 5 rotations in the opposite direction.

Bring your arms down and rotate your shoulders.

Engage the shoulder and neck muscles.

Do rotations of 5 and change the direction of rotation.

Do another 5 rotations in the opposite direction.

**Chest expansions:** You can do this exercise in the following steps: Stand straight with your hands joined and stretched straight forward. Open your arms wide apart and stretch them sideways Make sure your arms are straight. Repeat the steps at least 15 times.

Initial investigations suggest that the deaths may be linked to the consumption of contaminated food or water. Law enforcement agencies are exploring the possibility of any criminal angle to the incident to rule out deliberate contamination or foul play.

Authorities have intensified surveillance in the region, while medical teams continue to monitor the health of affected persons. Health officials are coordinating with toxicology experts to ensure a swift response to any emerging symptoms.

# **Head to replace Konstas** as opener against Sri Lanka



ravis Head will replace Sam Konstas at the top of Australia's batting order for the first Sri Lanka Test despite the teenager's heroics in the triumphant India series.

Captain Steven Smith would not rule out finding a place for Konstas elsewhere in the order for the match that begins in Galle on Wednesday, with a vacancy now open at No.5.

Konstas impressed in his first two Tests to help Australia secure a first series win over India in a decade. But Head's supreme efforts as an opener on the previous subcontinent tour in 2023 were enough to win him the spot next to Usman Khawaja.

Head averaged 55.75 runs across two-anda-half Tests replacing David Warner on that

India tour, two years ago. "He did really nicely in India against the new ball. He put spinners under pressure immediately and we know how well he hits the seam as well if they come with that," Smith said. "It's going to be good fun watching him."

Konstas's inexperience appears to have worked against him in the selection conversation, with the 19-year-old embarking on his first subcontinent tour. Smith said Australia would have to select its XI with the conditions in mind

"He stands the seam up really nicely, hits good areas. Whether it's him opening the bowling with Mitchell Starc or a spinner opening, there's always plenty of options there," Smith said. "There's lots of considerations: Two fast-bowlers, one fast-bowler. Couple of spinners, three spinners, two spinners, allrounders.'

"Just playing what's in front of us, it's quite different to back home on the surfaces we've been playing on there where it's very pace dominant," he said. "We'd imagine this is going to be quite spin dominant."

Specialist opener Konstas, Nathan Mc-Sweeney, Cooper Connolly and Josh Inglis appear to be fighting it out for the middleorder vacancy created by Head's promotion.

Inglis is uncapped at Test level but has averaged 72.60 across three matches for Western Australia this summer and would bring a similar positive intent to Head. McSweeney averaged only 14.40 on a tough assignment in his first three Test matches, facing Indian pace ace Jasprit Bumrah out of position as an opener. The South Australia captain batted in the middle order in his 30 Sheffield Shield appearances and made an unbeaten 127 earlier in the summer. Uncapped 21-year-old Connolly appears the longest odds with only four first-class games to his name but is rated highly within the Cricket Australia hierarchy.

Connolly and McSweeney each provide part-time off-spin options - advantageous on a Galle wicket that could turn from day one.

"We'll have another look at the wicket and from there we'll name the team at the toss," Smith said. "We've got all the options available to us. We'll see how we go."

Australia won't rule out taking two frontline quicks and two spinners rather than three spinners, despite expectations of a turning wicket. Scott Boland and Sean Abbott are both pace options but Smith is equally confident in medium-pace allrounder Beau Webster taking the new ball alongside veteran quick Starc.

### **Adil Rashid marshals** defence as England stay alive in series

England 177 for 9 (Duckett 51, Varun 5-24) beat India 145 for 9 (Hardik 40, Overton 3-24) by 26 runs

ngland kept the T20I series alive with a 26run win in Rajkot, Jofra Archer, Brydon Carse and Jamie Overton sharing seven wickets alongside a masterful spell from Adil Rashid to help break India's ten-match run without defeat in home conditions.

After being inserted for the third match in a row, Eng-



land's total of 171 for 9 looked a little light - particularly from a position of 83 for 1 in the ninth over. Ben Duckett made his first T20I fifty as an opener but the middle order was blown away by Varun Chakravarthy and it needed some belligerent hitting from Liam Livingstone, who made 43 off 24 with five sixes, to keep them afloat. An unbroken stand of 24 for the last wicket between Rashid and Mark Wood was the second highest of the innings.

India had crept over the line by two wickets in the second match of the series, Tilak Varma's unbeaten 72 guiding them to a target of 166. But he fell to Rashid for 18 off 14 - his first T20I dismissal in five innings - as India sank to 85 for 5 in the face of more tenacious defence from England's pace-heavy attack.

India only managed to score two boundaries off the bat between the seventh and 15th overs, with Rashid's immaculate analysis of 4-0-15-1 key to suffocating the innings. After battling his way to 23 off 27, Hardik Pandya finally broke the shackles by hitting sixes off Wood and Archer - but when he was dismissed by Overton for 40 off 35, caught at long-off, India's lingering hopes of burgling the chase went with him.

Mohammed Shami, playing his first match for India since the 2023 ODI World Cup final, was eighth man out as the hosts limped through their 20 overs nine down - beaten in a T20I on home soil for the first time since November 2023.
