Central govt plans ropeway for Amarnath pilgrims

SRINAGAR: The Central government has announced plans to establish ropeway connectivity at 18 major religious and tourist destinations across India, including a ropeway connecting Baltal to the Amarnath shrine in Jammu and Kashmir.

The news agency—Kashmir News Observer (KNO) has learnt that the government is seeking proposals from consultants to prepare detailed project reports (DPRs) for these developments. The proposed 11.6-kilometre ropeway will link Baltal with the Amarnath shrine.

The initiative, as per the government, aims to improve accessibility and provide a convenient travel option for visitors to these sites. Currently, pilgrims undertake a lengthy trek from Baltal or Pahalgam

or rely on helicopter rides, which may not always be available. The new ropeway will reduce travel time and offer an alternative route, allowing visitors to enjoy views

of the surrounding landscape.

This project is expected to ease the journey for a wider range of pilgrims, including children, the elderly, and those with mobility issues, making the annual Amarnath Yatra more accessible to thousands of devotees.In 2024, the Amarnath Yatra commenced on June 29 and concluded on

No New Illness Case **Reported In Six Days**

JAMMU: No new illness case was reported in six days from a remote village in Jammu and Kashmir's Rajouri district which was shaken by the unexplained deaths of 17 people belonging to three families between December 7 and January 19, an official said on Wednesday.

He said the district administration under the supervision of Rajouri Deputy Commissioner Abhishek Sharma, is continuing with the intensive preventive care for the well being of the Badhaal village.

To mitigate the situation and prevent further casualties, 87 families comprising 364 individuals were shifted from the village to three isolated centres in Rajouri — Government Nursing College, Government Boys Higher Secondary School and Government Medical College

SC Strikes Down Domicile-Based Reservation for PG Medical Courses

NEW DELHI: The Supreme Court on Wednesday ruled that providing domicile or residencebased reservation for admissions to postgraduate (PG) medical courses within the State Quota is unconstitutional, as it violates the right to equality under Article

14 of the Constitution of India. The ruling came in the case of Tanvi Behl v. Shreya Goyal, as reported by Bar and Bench.

A Bench comprising Justices

Hrishikesh Roy, Sudhanshu Dhulia, and SVN Bhatti emphasized that merit alone should determine admissions to PG medical courses.

"We are all domiciled in India,

and there is no provincial domicile, etc....This gives us a right to pursue trade across India. The benefit of reservation in education to those who reside in certain areas can be given only in MBBS in some cases. But reservation at a higher level on the basis of residence is violative of Article 14," the Court ruled, according to Bar and Bench.

However, the Court clarified that the judgment will not affect reservations already granted under the residence-based category.

The ruling stemmed from a 2019 reference by a two-judge Bench, which had sought clarity on the constitutional validity of domicile-based reservations for PG medical courses. The Court addressed three key questions

'Predicted 5-day wet spell vital for Kashmir's agricultural sector'

SRINAGAR: Chief Scientist of Sheri Kashmir University of Agriculture and Science Kashmir (SKUAST-K) Dr Rehana Rasool on Wednesday said the predicted wet spell from January 29 to February 5 is vital for the agricultural sector in the Valley.

Talking exclusively to the news agency-Kashmir News Observer (KNO), Dr Rasool said, "If the wet spell occurs, it will help lower temperatures and ensure water reserves for May and June. It's a crucial factor in stabilizing the climate." "The previous snowfall (in last week

of December 2024), following months of drought, did not retain much moisture, making the current precipitation vital for the agricultural sector," she said,

adding, "The unusually warm temperatures recorded in Kashmir during the past few days in the crucial winter phase can lead to an early bloom, which may negatively impact the crop yield."

Legal Vacuum

SC Asks Centre To Setup Panel To Safeguard Domestic Workers' Rights

directed the Centre for a legal framework to provide a safeguard to domestic workers observing their exploitation and a "legal vacuum" over the protection of their rights.

In the opinion of a bench of Justices Surya Kant and Uiial Bhuvan, for now.

there seemed no effective legislative or executive action to enact a statute, which could provide solace to millions of vulnerable domestic workers across the country.

"The simple reason for this harassment and rampant abuse, which seems to be prevalent throughout the country, is the legal vacuum which exists vis-à-vis the rights and protection of domestic workers," the court said. Indeed, domestic workers in India remain largely unprotected and without any comprehensive legal recognition. As a result, they frequently endure low wages, unsafe environments, and extended hours without effective recourse, it added.

The court directed the Ministry of Labour and Employment along with the Ministry of Social Justice and Empowerment,

the Ministry of Women and Child Development, and the Ministry of Law and Justice, to jointly constitute a committee comprising area experts for a legal framework meant for the benefit, protection and regulation of the rights of domestic workers.

The composition of the expert committee, said the bench, was left to the wisdom of the Centre and its ministries concerned.

"It will be appreciated if the committee submits a report within a period of six months, whereupon the Government of India may consider the necessity of introducing a legal framework which may effectively address the cause and concern of domestic workers," it added.

After the verdict was pronounced, Justice Surya Kant said the court planned to monitor the progress once the panel filed its report.

In his plea filed through advocate Rajeev Kumar Dubey, Malik challenged the Uttarakhand High Court decision refusing to compound and quash the FIR despite the complainant's

domestic help reportedly saying she was not wrongly confined or trafficked by the scientist, a senior citizen.

The bench said it was an incontrovertible fact that the demand for domestic workers was mounting in India, given the rapid urbanisation and development.

"While any avenues for employment being

demand, this indispensable workforce has also been the most vulnerable to exploitation and abuse," it said.

In its opinion, domestic workers often belonged to the marginalised communities, such as SC, ST, OBC, and EWS and were compelled to undertake domestic work due to financial hardship or displacement, further reinforcing their vulnerability.

For the bench, it was abundantly evident from the present appeals,

the torture and exploitation of the complainant for several years by individuals who forcibly trafficked her to differing cities, promising a better life that never materialised.

The purported placement agency which employed the complainant "continually leeched

helpless, it added.

The bench referred to various international norms and standards on the issue.

Justice Surya Kant, who authored verdict, said the court not only acknowledged the vulnerability of domestic workers but also strove to provide them extensive protection and parity with other

The verdict pointed to a "degree of lacunae" in legislative frameworks, safeguarding and protecting the rights of domestic workers.

It said aside from the absence of any legislation protecting their interests, domestic workers were excluded from existing labour laws.

"These, inter alia, include statutes such as the Payment of Wages Act 1936, Equal Remuneration Act 1976, Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, Juvenile Justice (Care and Protection of Children) Act, 2015, etc," the court said.

Given the lack of specific protection covering domestic workers in India, the court said it was a solemn duty and responsibility to intervene, exercise the doctrine of parens patriae and forge the path leading to their proper welfare.

"In a catena of decisions, this court has repeatedly stepped in and laid down interim guidelines to protect vulnerable groups who were utterly unprotected due to legal gaps," it added.

That being said, the court found it appropriate to lay down an interim legal code to govern the working conditions of domestic workers.

It was cognisant of the fact that ordinarily, the judiciary should "not stray too far out of bounds" and expressly interfere in the legislative domain.

"The democratic setup of this country may be likened to a tripartite machine, fuelled by the doctrine of separation of powers, without which it's functioning shall surely come to a grinding

Stampede At Maha Kumbh, Adityanath Says Some Devotees Seriously Injured

MAHAKUMBH NAGAR: A stampede broke out at the Sangam area of the Maha Kumbh early Wednesday as crores of pilgrims jostled for space to take a holy dip on the occasion of Mauni Amavasya, with Chief Minister Yogi Adityanath saying some devotees were "seriously injured".



The incident took place between 1 am and 2 am when some devotees climbed over the barricades at Akhara marg, he said.

"Between 1 am to 2 am, at the akhara route where arrangements were made for the Amrit Snan of the akharas, some devotees crossed over the barricades and were critically injured. They were immediately rushed to hospital where treatment was promptly ensured," he said after a high-level meeting in Lucknow.

Adityanath also said that Prime Minister Narendra Modi, Union Home Minister Amit Shah and BIP chief IP Nadda had called him up since morning to take stock of the situation.

He added that a consensus has been reached with the akharas that they would take the holy dip only after the crowd pressure has decreased at the ghats.

"I have personally spoken to Akahara Parishad heads and other seers, including Maha Mandaleshwars and the respected saints have politely agreed to let devotees take the dip and only after the crowd pressure decreases they will take the dip," the CM said.

"Our first priority is to ensure safety of devotees," he said, adding "the situation in Prayagraj is under control but the crowd pressure is still there".

Oceans Warming Four Times Faster Than In 1980s, Study Finds

NEW DELHI: A new study has found that the rate at which oceans are warming has become four times faster as compared to the last four decades.

Published in the journal Environmental Research Letters, the study showed that ocean temperatures are rising at 0.27 degrees Celsius per decade during 2019-23, compared to 0.06 degrees Celsius every decade in the late 1980s. If the oceans were a bathtub of water,

then in the 1980s, the hot tap was running slowly, warming up the water by just a fraction of a degree each decade," lead author Chris Merchant from the University of Reading, UK, said."But now the hot tap is running much faster, and the warming has picked up speed. The way to slow down that warming is to start closing off the hot tap, by cutting global carbon emissions and moving towards net-zero,' Merchant explained."The underlying rate of change of GMSST (global mean sea surface temperature) rises in proportion with Earth's energy accumulation from 0.06 (Celsius per decade) during 1985-89 to 0.27 (Celsius per decade) for 2019-23," the authors wrote. They explained that the accelerated warming of oceans is driven by a growing imbalance in the Earth's energy — whereby energy from the Sun being absorbed by Earth is more than that escaping back to space.

The manifesto also promises financial assistance of Rs 8,500 per month for one year to educated unemployed youth. The party also proposed launching 100 Indira canteens



As such, rendering those springs unfit for human consumption."

"Now, through the medium of this notice,



general public of District Ganderbal and rural Srinagar where spring water is used for drinking purposes by locals at their own level, are requested to refrain from using spring water for drinking purposes and instead use tap water only till further instructions, please," the notice reads, adding," However, if at all spring water is to be used, it is advised to use it only after prolonged boiling."



Yes, we do need salt in our body and it should come naturally from food (fruit and vegetables)

Stop adding table salt, avoid salty preparations from the market .We don't need more than 2.3gm/day (1/4 teaspoon) of Sodium per day which is equivalent to 5gms of common salt per day

SURGERY, ANAESTHESIA MAY AFFECT MEMORY

WASHINGTON: Turns out, surgery and anaesthesia can slightly affect memory of patients.

According to a new study, patients may score slightly lower on certain memory tests after having surgery and anaesthesia.

In the study of 312 participants who had surgery and 652 participants who had not (with an average age in the 50s), surgery between tests was associated with a decline in immediate memory by one point out of a possible maximum test score of 30 points.

Memory became abnormal in 77 out of 670 participants with initially normal memory comprising 18 percent of those who had had surgery compared with 10 percent of those who had not.

No differences in other measures of memory and executive function were observed between participants having and not having surgery.

Reduced immediate memory scores at the second visit were significantly associated with the number of operations in the preceding nine years. Working memory decline was associated with longer cumulative operations.

Dr Kirk Hogan, the senior author said, "The cognitive changes we report are highly statistically significant in view of the internal normative standards we employ, and the large sample size of the control, or non-surgery, population. But the cognitive changes after surgery are small--most probably asymptomatic and beneath a person's awareness".

"The results await confirmation both in followup investigations in our own population sample after more surgeries in ageing participants, and by other investigators with other population samples", Dr Hogan further explained.

Dr Hogan noted that it is too early to recommend any changes in clinical practice regarding prevention, diagnosis, management, and prognosis of cognitive changes after surgery.

The findings from the study are published in the journal Anaesthesia.

VITAMIN D LEVELS CAN NOW BE MEASURED WITH YOUR HAIR



Researchers have found that vitamin D can now be measured by human hair, paving the way for improved diagnosis of deficiency of the sunshine vitamin.

With over a billion people estimated to be affected, vitamin D deficiency — a risk factor for depression, cardiovascular disease, inflammation, diabetes and cancer — has reached epidemic proportions worldwide.

While traditional blood analysis captures the levels at a single time point, in contrast, hair, which grow at approximately one centimetre per month, could reflect vitamin D status over several months, capturing the large seasonal differences in the levels.

"The study presents the idea that vitamin D is being deposited continuously in the hair as it grows, more might be deposited at times when vitamin D concentration in the blood is high, and less when it's low," said lead author Lina Zgaga, Associate Professor at Trinity College Dublin. "Therefore, a test based on the hair sample might

be able to give doctors a measure of vitamin D status over time — if hair is long enough, this even might be over a few years," Zgaga added.

The findings were published in the journal Nutrients. However, further research is needed to establish the exact relationship between vitamin D concentration in the blood and in hair over time.

There is also a need to investigate different factors that might affect vitamin D levels in hair, the most obvious ones being hair colour and thickness, or use of hair products such as hair dye, Zgaga said.

The discovery could also have other applications as hair (along with teeth) are some of the longest lasting surviving biological materials after death and thus it could be possible to assess the vitamin D status of historical populations – Elizabethans, Vikings, Celts, Romans, ancient Chinese, Egyptians, the researchers said.

LOSE WEIGHT FOR LIFE, THIS surprising workout can melt fat forever

hen it comes to health and wellness, weight loss is a common goal. From going keto to intermittent fasting and breaking a sweat – there is a lot that people do. However, more than this, there are many who struggle to find out the best way to lose weight and then sustain the results in the long run; because dropping kilos is one thing, and then retaining it is another. Hormone therapy may reduce stooped posture for women

WASHINGTON: Turns out, an exaggerated stooped body posture can be cured with hormone therapy for women.

A new North American Menopause Society-study found that hormone therapy (HT) use was associated with a reduction in vertebral fracture risk.

The Women's Health Initiative found that these same benefits may also guard against a woman's risk of developing hyperkyphosis, an exaggerated curvature of the spine that creates a forward-stooped posture.

It is well documented that the

significant declines in estrogen experienced during the menopause transition contribute to an accelerated bone loss. Hormone therapy reverses bone loss and helps prevent fractures.

During the first three years of HT use, bone density has been shown to increase steadily and then is maintained during continued use.

Given that hyperkyphosis is also associated with bone loss and vertebral fractures, the authors of the article "Patterns of menopausal hormone therapy use and hyperkyphosis in older women" hypothesised that HT may also



be effective in helping prevent exaggerated spine curvature, sometimes called dowager's hump.

The study on which the article is based involved more than 9,700 women aged 65 years and older who were evaluated over a 15-year period.

Women who reported continuous or remote past HT use had less pronounced kyphosis by the time they were in their mid-80s than never-users, supporting the argument for HT as a possible early postmenopause treatment for women concerned about their posture and fracture risk.

Beyond its adverse aesthetic effects, hyperkyphosis is associated with the poor physical function, an increased risk of falls and fractures, and earlier mortality.

"Women who reported the early use of HT were less likely to develop age-related kyphosis, and the protective benefits continued even after stopping HT", said Dr. JoAnn Pinkerton, NAMS executive director. "This supports a benefit of prescribing HT close to menopause".

The findings from the study are published in Menopause, the journal of The North American Menopause Society (NAMS).

He pointed out that the major issue is related to Waqf-e-Uzer, where properties used by the Muslim community for years could be at risk due to the removal of legal provisions safeguarding them. Another critical concern is the authority granted to collectors to decide whether a particular piece of land belongs to Waqf or the government, which Mirwaiz described as a serious challenge for the community.

Despite these reservations, Mirwaiz stated that the Muslim leadership is open to discussions on reforms that ensure transparency in Waqf matters, including improving women's representation and making the Waqf system more stable. However, he criticized the way the process is being rushed, urging the government to delay the bill and allow further discussion.

He further remarked that stakeholders have not been adequately consulted and their suggestions have been ignored. "The chapter of the Joint Parliamentary Committee (IPC) is now closed, and the matter is heading to Parliament. It seems a decision has already been made," he added.

Mirwaiz Umar Farooq called upon the broader Indian society to take note of the issue and urged authorities to reconsider the amendments in the interest of protecting Muslim institutions and ensuring justice.

Predicted 5-day



World Cricketers Association calls out 'random and inconsistent' support for Afghanistan women

lobal cricket needs to move away from "random and inconsistent," outbursts of support for Afghanistan's exiled women's cricketers and towards a "systematic global approach." That's the view of the global player body, the World Cricketers Association (WCA) whose CEO Tom Moffat has called the exclusion of women's players in any country "unacceptable."

In the same week that an Afghan Women's XI will come together for the first time to play against a Cricket Without Borders team at the Junction Oval in Australia, Moffat spoke to ESPNcricinfo about possible collective action which he says "doesn't necessarily mean boycotts," but should include both the ICC and individual boards.

"The ICC and national governing bodies run and regulate the game and their tournaments, and have a responsibility to exercise leverage to ensure that the rights of players in our sport, including Afghanistan women's players, are protected and respected," Moffat said. "That doesn't necessarily mean boycotts, there are a number of ways to exercise leverage, but to date the random and inconsistent manner of dealing with it, and of even having the conversation around the world, highlights the need for cricket's governing bodies to implement a more systematic global approach to protecting basic player rights, along with just about every other aspect of the sport."

are no sporting bans in place. Afghanistan remain members of FIFA and the ICC, to name two global bodies and sent a team of three men and three women, who were living in exile and were not recognised by the Taliban government, to last year's Paris Olympics.

Currently, Australia are the only country who have cancelled bilateral engagements against Afghanistan while England have said to play Afghanistan in ICC events, even as calls to boycott those games grow.

In England, a cross-party parliamentary group > wrote to the ECB strongly urging the men's team and officials to, "speak out against the horrific treatment of women and girls in Afghanistan," and to consider not playing Afghanistan in their Champions Trophy fixture on February 26. In response, the ECB CEO Richard Gould called for "a coordinated, ICC-wide approach," which is similar to Moffat's stance.

Similarly, South Africa, who are also grouped with Afghanistan in the Champions Trophy, have received backlash from their sports minister Gayton McKenzie, who compared the Taliban's treatment of women to Apartheid.

Cricket South Africa have actively sought out fixtures against Afghanistan and played them in an ODI series in Sharjah last September and maintain that shunning the men's team will not have a material impact on the situation facing women in Afghanistan. South Africa's stance is important because they have firsthand experience of being banned from the 1970s to 1990s and sporting isolation (along with economic sanctions) was a significant contributor to the fall of Apartheid. However, CSA is of the opinion that it will take more than a cricket boycott to force the Taliban to recognise women's rights.

Geoff Allardice steps down as ICC CEO

eoff Allardice has resigned as chief executive of the ICC after four years in the role, citing a desire to "pursue new challenges". Allardice was appointed chief executive in November 2021, having taken over on an interim basis eight months previously when his predecessor, Manu Sawhney, was suspended. He has worked at the ICC since 2012, initially as general manager of cricket after a previous role with Cricket Australia.

"It has been a privilege to serve as the Chief Executive Officer of the International Cricket Council," Allardice said. "I am incredibly proud of the results we have achieved, from

> enhancing the global reach $of \, cricket \, to \, the \, commercial$ foundation put in place for ICC Members. "I'd like to thank the ICC

Chair, the board of directors and [the] entire cricket community for their support and collaboration over the past 13 years. I believe this is the right time for me to step down and pursue new challenges. Lam confident that cricket

has exciting times ahead, and I wish the ICC and the global cricket community every success in the future."

Allardice's decision to step down coincides with the early days of Jay Shah's term as ICC chair. Shah, the ex-secretary of the BCCI, took over from Greg Barclay on December 1.

"On behalf of the ICC Board, I want to sincerely thank Geofffor his leadership and commitment during his tenure as Chief Executive," Shah said. "His efforts have played a key role in advancing cricket globally. We are truly grateful for his service and wish him all the very best in his future endeavours.'

Allardice, like his predecessor Dave Richardson, maintained a lower profile as CEO than predecessors such as Haroon Lorgator Malcolm Speed, but he was an instrumental administrator within the ICC. In particular, during his stint as general manager cricket he can claim some significant achievements: overcoming the BCCI's early concerns with DRS and ensuring it was implemented as standard across the international game; standardising and implementing the processes around illegal actions; overseeing the creation of the World Test Championship and the (now-defunct) ODI Super League as a means of bringing context to bilateral cricket. In an era in which domestic, cash-rich T20 leagues mushroomed, the latter was an important addition.
