BJP said those facing graft charges will be jailed, but they were inducted in cabinet: Raj Thackeray

Sena chief Raj Thackeray on Thursday attacked the ruling Bharatiya Janata Party, stating the party once said the leaders involved in a multi-crore scam would be put behind bars, but they were instead inducted into the state cabinet.

Speaking at an MNS gathering here, he also expressed doubt over the outcome of the last year's Maharashtra assembly elections, and asked how Ajit Pawar-led Nationalist Congress Party (NCP) won 42 seats just months after it bagged only one seat in the Lok Sabha polls.

"Prime Minister Narendra Modi had said that those involved in a Rs 70,000 crore scam would be put behind bars. But where did they put them? In the cabinet," Thackeray said.

He was referring to PM Modi's speech made in 2023 in Madhya Pradesh, where he raised the issue of alleged irrigation scam in Maharashtra. The BJP targeted Ajit Pawar, who was then the leader of opposition, for his alleged involvement in the scam. However, Pawar later joined the Eknath Shinde-led government in the state and was made deputy chief minister in July 2023.

Thackeray said the BJP once accused many leaders of indulging in corruption, but later joined hands with them and made them chief ministers and ministers.

He referred to the induction of West Bengal leader Mukul Roy into



the BIP (before his return to TMC), B S Yediyurappa's rejoining of BJP in Karnataka, and the party's alliances with leaders like Omar Abdullah, Farooq Abdullah, Mehbooba Mufti and late Mufti Mohammad Sayeed.

In Maharashtra, Radhakrishna Vikhe Patil, Harshvardhan Patil and Narayan Rane, who were once with the Congress, later joined the BJP, Thackeray said.

"BJP leader Kirit Somaiya had made allegations against several leaders, but now these very people are in the cabinet,"

On the criticism over his frequent meetings with BJP leaders, Thackeray said, "Many say I should not meet BJP leaders...I meet people, but I do not sell myself. My Marathi identity remains

Talking about the outcome of the Maharashtra assembly elections, where the Mahayuti alliance secured a thumping victory while the MNS and opposition parties suffered setbacks, he said he remained silent for some time as he was analysing the results.

"On the day of the results, there was an unusual silence across Maharashtra. The kind of celebrations that should have happened did not take place. Even some people from the RSS I spoke to were surprised. One of them jokingly asked me - 'Why is there so much silence? Someone must have won, right?' So what did that silence indicate?" he said.

He asked how Ajit Pawar-led Nationalist Congress Party (NCP) won 42 seats in the assembly polls, while Sharad Pawar's NCP (SP) won only 10.

"Congress secured the most Lok Sabha seats in Maharashtra and Sharad Pawar-led NCP (SP) won 8 seats in the parliamentary polls, but managed to win only 10 assembly seats. On the other hand, the Ajit Pawar-led NCP had won only one Lok Sabha seat, but bagged 42 assembly seats. How is that possible?" he wondered.

Thackeray also cast doubt over certain election results. "MNS had fielded sitting MLA Raju Patil from Kalyan Rural constituency in Thane district. There are around 1,400 voters in Patil's village, he has always received votes from there. But this time, he did not get even a single vote. How is that possible?" he sought to know.

Speaking about allegations against him that he frequently changes his political stand, Thackeray said, "People say I change my stand, but do they even understand what that means? Look at how others have changed sides for their own benefit. The current cabinet mostly comprises leaders who were earlier with Shiv Sena and Congress. They will not be questioned, but you will keep hearing that Raj Thackeray changes his stance."

He also hinted at making internal changes in the MNS, saying a new code of conduct would be introduced to instill

discipline - right from the top leadership to grassroots workers.

Encouraging his supporters not to get discouraged, he said, "I have seen many victories and defeats. But I have never been disheartened by a defeat or got carried away by a victory. I do not want to lead people who are demoralised. If vou want to stand with me, then stand strong. Whatever we have to do for Maharashtra and Marathi people, we will do it. If not today, then tomorrow, but it will definitely happen. That is certain.'

On the controversy surrounding a scene in an upcoming film "Chhava", in which Chhatrapati Sambhaji Maharaj is seen playing 'lezim', Thackeray said the film's director, Laxman Utekar, recently met him to discuss the issue.

"Lezim is Maharashtra's traditional dance. Sambhaji Maharaj may have picked up a lezim at some point, who knows? Even if it is not in the history

it could be in our imagination. But I asked the director whether the song in question was crucial to the film's narrative or just a celebration song. He said it was only to show celebration. So, I asked him if it was necessary to risk the entire film for one song," he said.

After meeting Thackeray, the film director announced that the lezim dance scene would be dropped from the movie.

Nobody above law in country: SC in matrimonial case

NEW DELHI: Nobody is above the law in this country, the Supreme Court on Thursday observed in a dispute between a man and his estranged wife, an IPS officer.

Iustices B R Gavai, Augustine George Masih and K Vinod Chandran made the remark after the man's counsel raised an apprehension that he would be made to suffer all his life for the estranged wife was an IPS officer.



The bench said the parties should settle their disputes in the interest of justice.

"She is an IPS officer. You are a businessman. Rather than wasting your time in the court, you should settle it. We are here to protect you if there is any victimisation," the bench told the counsel.

"Nobody is above the law in this country," it added.

The counsel said his client and his father were jailed in connection with the cases lodged by the woman.

The counsel alleged the estranged wife gave a wrong declaration that no FIR was registered against her but she faced two FIRs on the day she filled a form at the time of joining the police service.

"You are more interested in ensuring that she loses her job," the bench said.

The counsel said it was for the home ministry to take action if she had made any wrong declaration in her form.

"You are not interested in saving your life. You are interested in ensuring that her career goes. Ultimately, in the process of ruining her life, you will also ruin your life," said the court.

The bench observed it was "very clear" the man wasn't interested in settlement and said, "You are not interested in living your life happily. But you are only interested to ruin somebody else life. It is more than clear to us." The bench noted it couldn't force a settlement on the parties if they were unwilling and suggested they settled the disputes.

"If you have any apprehensions, we will take care of that in our order," it added.

The lawyers appearing for both the sides said the parties would sit together and try to find an amicable solution to the disputes.

The bench posted the hearing after two weeks.

One of the pleas filed by the woman in the top court challenged the Allahabad High Court's June 2022 verdict.

The high court discharged the parents of the man in a criminal case lodged by the woman.

Hearing In Rahul Gandhi Defamation Case Deferred To Feb 11

SULTANPUR(UP): Proceedings in a defamation case involving Leader of Opposition Rahul Gandhi, scheduled to take place Thursday, were deferred after the Congress leader's lawyer fell sick.Special Judge Shubham Verma scheduled the next hearing for February 11.

"The delay came after Rahul Gandhi's lawyer, Kashi Prasad Shukla, submitted a medical certificate stating that he was unwell and unable to attend the court proceedings. In response, Judge Verma set the new date for the hearing," Santosh Kumar Pandey, the advocate of Vijay Mishra, who has filed the case against Gandhi, said.

Mishra, a BJP leader from Hanumanganj, filed his petition in 2018 accusing Gandhi of making "derogatory" remarks during the Karnataka elections. Mishra claimed the remarks were offensive and caused him personal harm.

After Gandhi failed to appear in court, a warrant was issued against him in December

He surrendered in the court in February 2024, and recorded his statement on July 26. He was granted bail on two sureties of Rs 25,000 each.

The former Congress president has consistently maintained that the case is part of a political conspiracy against him.

mayor. In a jolt to the AAP-Congress combine, BJP's Harpreet Kaur Babla was elected as the new mayor of the Chandigarh Municipal Corporation after she defeated AAP nominee Prem Lata. Babla secured 19 votes while Lata got 17 votes. No vote was found to be invalid.

The result for the post of mayor was announced by presiding officer Ramneek Congress candidate Jasbir Singh Bunty won the post of

The controversial post, which featured a photograph of Chief Minister Omar Abdullah, claimed that the party had successfully secured a hike in the honorarium for SPOs with the caption: "Another promise fulfilled."

The misleading nature of the post sparked an immediate backlash from netizens, who criticized the party for spreading misinformation and allegedly playing with the sentiments of SPOs. The erroneous post was subsequently removed from

various National Conference-affiliated social media handles, but not before it had drawn significant attention and criticism online.

In response to the controversy, the National Conference issued a clarification, acknowledging the mistake and emphasizing that the claim made in the post was unverified. The party stated, "A recent post concerning SPOs honorarium was put out from various handles connected to the party and

After Massive Revamp Of City Infra, Admin **Continues To Fail Controlling Footpath Encroachments**

SRINAGAR: Newly constructed footpaths across Srinagar are being brazenly encroached upon by shopkeepers and erring vehicle owners, turning pedestrian walkways into personal parking

This growing menace is evident in areas such as Old City, Babademb, Batamaloo, Hazratbal, Nowhatta and Khanyar, where pedestrians are increasingly forced to walk on busy roads, risking their lives.

The Srinagar Municipal Corporation (SMC) has acknowledged the issue and assured strict action against encroachments.

Speaking to the correspondent of 'Associated News Bureau,' the Public Relations Officer (PRO) Idrees Agail Mir of SMC said, "We are conducting continuous drives against footpath encroach-

Despite significant investments in urban infrastructure, including the construction of footpaths to ensure safer movement for pedestrians, many of these walkways are now occupied by vendors, shopkeepers, scrap dealers, and car dealers, particularly in Babademb. The encroachment has not only disrupted

pedestrian movement but also led to frequent traffic congestion, making everyday commuting



a nightmare for residents.

Residents and commuters have voiced their frustration over the issue, calling for strict action against the violators.

Abdul Ahad, a resident of Batamaloo said, "We were happy when the government built proper footpaths, but now they are of no use. Shopkeepers and vendors have taken them over, leaving no space for pedestrians."

In Babademb, the situation is even worse, with scrap dealers and car dealers occupying large sections of footpaths, forcing pedestrians onto the road. Many elderly citizens and children

find it particularly difficult to navigate through these encroached spaces, increasing the chances of accidents.

"Walking to college has become dangerous. We have to navigate through parked vehicles and roadside vendors. Authorities need to take strict action before an unfortunate accident occurs," said Zahid Ahmed Dar, a student.

In fact, in 2024 alone, we have recovered fines amounting to Rs. 2.5 lakh from those who have illegally occupied footpaths. Additionally, we have seized goods from violators."

However, despite these measures, encroachments continue to resurface, indicating that fines and temporary crackdowns might not be enough to deter habitual offenders. The SMC official further stated that operations against encroachers would be intensified in the coming days.

Beyond enforcement, the lack of civic sense among a section of the public remains a pressing concern. While authorities can remove illegal structures and fine violators, sustainable change can only be achieved when people understand the importance of keeping footpaths free for pedestrians.

Chief Encroachment Officer of SMC Syed Batyari while talking with Associated News Bureau stated, "We are on our toes round the clock to remove illegal encroachments from footpaths.

At times, we reach home late to ensure that pedestrian pathways remain unobstructed. However, enforcement alone is not enough—we need cooperation from all quarters. Most importantly, people must develop a sense of civic responsibility. If everyone respects public spaces and follows the rules, our city can be more pedestrian-friendly. Encroachments not only cause inconvenience but also pose serious safety hazards. We will continue our efforts and intensify operations to reclaim footpaths for their intended

"Rules alone won't change anything. People need to develop a sense of responsibility. Footpaths are for walking, not for business or parking," said Abdul Rashid, a local.

For now, the battle to reclaim Srinagar's footpaths continues, with pedestrians hoping for a permanent solution that allows them to walk safely without risking their lives on the city's busy roads. (ANB)

Ways of Seeing: A Critical Analysis of John Berger's Insights on Art and Perception

John Berger's seminal work, Ways of Seeing, profoundly reshapes one's perspectives on art and cognition. Having read this pivotal book briefly, I found its insights refreshing and empowering, fostering newfound confidence in my understanding of the world. Berger's exploration of how we perceive and interpret art is a crucial validation of my experiences and perceptions, leading me to appreciate the multi-layered constructs that shape our everyday lives.

The idea that seeing precedes verbal expression is at the heart of Berger's thesis. This concept implies that our initial, raw observations are then shaped by learned language and psychological frameworks. He argues that viewing the world is more potent than articulating balanced thoughts, suggesting that deep, solitary reflection can yield richer fruits than impulsive reactions. Those who engage in keen observation—not burdened by relentless external influences—are less susceptible to being swayed by dominant narratives. In contrast, individuals overwhelmed by persuasive ideas may succumb to anxiety and frustration. Thus, a mindful approach to perception, where observation precedes judgment, is critical and a path to heightened awareness and consciousness.

Berger also introduces the dichotomy of production versus reproduction in art. An artist's original creation is often a unique reflection of their perception and perspective, whereas reproductions—be it photographs or digital copies—can dilute the essence of the artwork. While the original holds intrinsic value, reproductions diminish its market worth. As technology evolves, art is increasingly commodified, leading to a situation where authenticity is often sacrificed for accessibility. For instance, films that compile various artworks aggravate this dilution, as they compel viewers to engage with multiple pieces collectively, overshadowing the individual significance of any single work. The relentless reproduction of art has resulted in a loss of appreciation for its unique historical and contextual significance, a fact that should make us all feel regretful and reflective.

In the second chapter, Berger meticulously examines gender inequalities reflected in art historically and contemporaneously. Traditional artworks frequently depict women as objects of desire, conditioned by societal expectations placed upon them. This lens highlights the male-dominated narratives that have historically subjugated women's identities and expressions. For instance, the portrayal of nakedness often embodies the male gaze, a term coined by feminist film critic Laura Mulvey, which refers to how visual arts and literature depict the world and women from a masculine point of view, reinforcing the notion that women exist predominantly for male pleasure. Such representations dehumanise women, reducing them to mere vessels of sexual gratification.

Berger's analysis of homosexuality also reveals how perceptions have evolved—or regressed—through time. Some con-

temporaries still view it as a deviation from the norm, while others embrace it as a natural variation of human sexuality. This perception is further complicated by entrenched societal and religious beliefs that perpetuate discrimination and stigma. Even with advancements in understanding, those with rigid preconceptions may resist the acceptance of homosexuality as an inherent aspect of human diversity.

A key aspect of Berger's analysis involves the abstraction present in the representation of women in art. The various body parts depicted in a single painting often amalgamate multiple to those entrenched in traditional power structures. Thus, art has historically functioned as a medium of protest, seeking to convey themes of equality and empowerment, often inciting backlash from ruling classes resistant to change.

Berger also emphasises the commodification of art in capitalist societies. The commodification of art refers to the process of turning art into a commodity, where its value is often dictated by the ruling class, creating barriers for artists from lower socio-economic backgrounds who wish to express their narratives and critiques. This economic stratification in the art

Tariq Ali elaborates on how the government frames military interventions such as those in Iraq and Afghanistan as efforts to establish stability. Yet, they ultimately inflict suffering and chaos on the invaded regions. The American public's perception—shaped by propaganda—creates a dichotomy between the benevolent intentions purported by their government and the destructive consequences of military actions. This contrast illustrates how the same events can be viewed through vastly different lenses, highlighting the importance of context in shaping societal understanding.


The cover of Ali's book, The Obama Syndrome: Surrender at Home, War Abroad, serves as a visual cue for navigating these complex issues. It emphasises the interplay between art, politics, and perception, suggesting that to grasp the implications of modern governance and societal structures truly, one must engage critically with one's observations and the narratives presented to them.

In conclusion, art remains a potent tool for understanding and interpreting societal constructs. However, its accessibility and relevance are often confined to the privileged classes. The narratives embedded within artistic expressions highlight the ongoing struggles against oppression and inequity, yet they are frequently overlooked or misunderstood. The current state of art necessitates a more profound, holistic comprehension. As we navigate the complexities of modern governance and capitalist societies,

it becomes imperative to leverage art as a means of advocacy, employing its power to illuminate the realities and challenges marginalised communities face. Art transcends mere aesthetic appreciation; it serves as a vehicle for fostering empathy, understanding, and social change.

By re-examining both Berger's and Ali's arguments, we can reshape our perceptions, prompting a shift in the collective consciousness towards a more inclusive and equitable society. Art can galvanise action and resist oppression, urging us to confront the structures constraining our understanding and experiences of the world.

Drawing parallels between DeepSeek and Huawei

So DeepSeek has triggered a trillion dollar rethink. Folks are questioning whether we really need tonnes of GPUs and energy to run the infra for AI.

I am especially curious about the sentiment around that \$500 billion AI investment announced a few days ago with authority and swagger. The investment is based on the hypotheses that we will need lots of computing power and electricity.

Billions have been invested on those hypotheses which could potentially be wrong. DeepSeek is therefore a significant moment in the AI trajectory.

Despite the urge to politicise the tech rivalry between China and the US, China hasn't actually produced many tech companies with dominant market share at global level.

There are Baidu, ByteDance, Alibaba, Xiaomi, SenseTime: Major players in their own right but we are not talking any serious challenge to US competitors as yet. Perhaps DeepSeek is the moment. Or perhaps it is too early to draw conclusions.

I want to draw some parallels between DeepSeek and another Chinese success story from the past and highlight what a cost advantage can potentially achieve if executed with experience.

Among the tech competitors emerging from China, telecom industry is familiar with the story of Huawei. Not quite a 'Sputnik moment' or a thunderous entry but a more sustainable impact that the telecom industry has adjusted to.

Let me talk about Huawei a bit.

Huawei has been around since the 80s, started outreach out of China in late nineties, and within a decade thereafter established itself as one of the incumbent telecom vendors internationally.

Huawei started as a PBX manufacturer and had its first US partnership deal with 3Com (later acquired by HP) for datacom products. That was the first time that telecom companies outside China actually heard about Huawei.

As Huawei was scaling its business, China was getting ready for the WTO entry. China was about to open its telecom market and before it did so it went wild with network expansion building as much footprint as possible before the expected foreign investors made entry into its domestic market. The expansion was government driven and created entrepreneurship opportunities on the equipment side as well. Huawei was encouraged and grew as a result.

That growth at Huawei fuelled international ambitions.
We started to see the vendor developing carrier grade communications equipment. For the voice equipment market the announcement of high tier softswitch by Huawei was a wake up call

Like DeepSeek, the USP of Huawei was its cost advantage, an advantage it openly flaunted. Prices per telecom port/line came crashing down from \$30 to \$3. Competitors had to bite the dust. Lucent and Nortel fell in the US. Alcatel and Marconi in Europe. Ericsson and Nokia survived by

to Huawei era. However the experience of companies from preceding tech generation can potentially complement the strengths of new AI startup ecosystem in China.

Chinese Al companies are challenged by the lack of access to Al optimised chips till the ecosystem evolves

Woice Al industry will celebrate, I am sure.

can help bridge the AI divide.

Another area in telecom where DeepSeek might have an impact is Voice Al. The company has not announced voice mode or speech recognition features yet. Once it does, the



virtue of their focus on wireless. If you ask those surviving vendors today, Huawei would be the competitor that keeps them up at night.

The Huawei generation of Chinese tech companies were rightly challenged for being actively promoted by the Chinese government support in scaling their business. But one cannot say the same about DeepSeek generation startups. There is no government subsidy or support to speak of.

To achieve a substantially low cost foundation model that rivals OpenAI is truly a wake up call with a much bigger impact than that achieved by a generation of companies belonging

domestically. Huawei is one of the companies that has a chip offering – optimised for the telecom apps. DeepSeek actually already runs inference on Huawei chips. What are the odds of two challengers to global incumbents from two different generations collaborating on technology?

DeepSeek can significantly lower down the development and operational costs for conversational AI apps developed in telecoms. As in other industry use cases, telcos will have more choice in terms of LLM partnerships. Where the customer scale does not exist – such as the scenarios involving local languages of smaller population groups – low cost models

The emergence of DeepSeek upon the Al landscape echoes the trajectory of Huawei in the telecom industry, underscoring the transformative power of cost efficiency in challenging established global players.

Just as Huawei disrupted the telecom market by slashing costs, DeepSeek seems poised to redefine the AI industry by demonstrating that AI models can be developed and deployed without huge amounts of computing power or energy consumption.


Stout And Tender: Symphonies Of Poetic Realities, Paradoxes, And The Human Condition

"Poetry distils thought and emotion into a transformative force-naming the unnameable, unveiling hidden beauty, and resisting oblivion. Both minstrel and rebel, the poet turns silence into voice, sorrow into strength, and fleeting moments into eternal echoes, where paradox births wisdom and injustice meets its reckoning."

A revered scholar, commentator, public intellectual, author, columnist, teacher, political activist, poet with philosophical reflections and emotional depth, infused with Kashmiri ethos as autobiographical undertones makes Prof. Badri Raina's poetic odyssey "Stout and Tender" poems Pure and Impure an exceptionally brilliant, authentic, profound, evocative, universal and relatable. Raina's collection is an extraordinary confluence of poetic depth, philosophical inquiry, and sociopolitical critique, embodying a rare blend of intellectual rigor, lyrical elegance, and Kashmiri ethos. This collection transcends mere poetic expression, emerging as a transformative meditation on the paradoxes that define existence-strength and fragility, purity and impurity, the personal and the collective, resistance and surrender. Raina's poetic voice resonates with timeless universality, seamlessly weaving autobiographical nuances with the larger historical and ideological currents that shape human destiny. Through his masterful fusion of evocative imagery, biting irony, and profound philosophical inquiry, he reimagines poetry as a space of both personal revelation and collective reckoning, engaging with the burdens



of history, the contradictions of modernity, and the fragile yet enduring hope for justice and renewal. His work is deeply rooted in the mystical, cultural, and intellectual traditions of Kashmir, drawing on its natural rhythms, spiritual heritage, and political upheavals to create a symphony of poetic realities that transcend time, geography, and ideology.

Rooted in the cultural, mystical, and philosophical landscapes of Kashmir, his poetry evokes the transient rhythms of nature-rivers, mountains, shifting seasons-juxtaposed against the disorienting turbulence of modernity. This interplay not only anchors his reflections in the timeless but also serves as a poignant commentary on history, memory, and displacement, blending the serene with the disruptive. Each poem is a microcosm of historical consciousness and existential vulnerability, unmasking the tensions between ideological extremities and the quiet defiance of individual resilience.

Beyond its artistic finesse, Raina's collection serves as a critical lens on the socio-political forces shaping contemporary reality, where economic disparities, political disillusionment, and moral contradictions unfold with piercing clarity. His poetry functions both as personal catharsis and political resistance, exposing the frailties of human existence while championing the pursuit of justice, dignity, and truth. In doing so, he crafts a literary dialectic that is at once deeply personal and universally resonant, a bridge between tradition and transformation.

This collection does not merely reflect the world-it interrogates, disrupts, and reimagines it, It is a critial dialogue with history demanding an active engagement with the intricacies of human consciousness and the socio-political structures that define our age. Each poem functions as a prism through which historical consciousness, existential dilemmas, and moral ambiguity are refracted, compelling readers to question, mourn, resist, and hope in equal measure. Raina's poetry stands at the intersection of literature and activism, philosophy and aesthetics, memory and prophecy, making Stout and Tender an indispensable contribution to contemporary poetic discourse. In a world increasingly fragmented by ideological divides, historical amnesia, and existential uncertainty, his compositions serve as an enduring testimony to the resilience of the human spirit. This collection is not merely a body of work; it is a literary legacy, a defiant affirmation of poetry's role as both an ethical responsibility and a transformative force-one that speaks not just to the present moment but to the eternal truths that define our shared human experience.

A beautifully designed book spans 432 pages, published by Paranjoy facilitated by Authors Upfront (late 2024) with its elegantly adorned hardcover with golden inscriptions bestows radiating glance and turns it into artifact beauty invites admiration. The glowing commendations from distinguished luminaries are both compelling, deeply engaging while as A Preliminary Word is soulful. The title itself encapsulates the essence of the collection, suggesting a duality that permeates not only the poems but also the human condition. "Stout" signifies resilience, strength, and a forthright confrontation with life's challenges, while "Tender" alludes to vulnerability, compassion, and the delicate nuances of human emotions. Raina's ability to navigate these opposing forces with poetic finesse is a hallmark of his craft.

The collection of 251 poems in "Stout and Tender" are thoughtfully organised under 12 insightful subheadings, each hosting nearly 25 or fewer poems. These sections, titled Stabs To The Quick; Truth To Power; Fear, Fig leaves and Freedom;

Part-

Our Children ,Our Bapu Our Land; Home: Remembering the Unforgettable; Soul, Breathe, Break Through; Freez Not, Flow; Wonders in the World: And the Birds Sing: When The Virus Ruled: Adieu, Speculations encompass poems with themes that pierce to the core, speak truth to power, and explore fear, hope, uncertainty,openness , meditative wonder, freedom, and the human spirit with compelling depth and brilliance.

The title itself, Stout and Tender, encapsulates the dualities that underpin human life as a poetic enquiry into the contrasts and co-existence of seemingly opposite forces. Raina's poetry juxtaposes fortitude with sensitivity, demonstrating how resilience often emerges through fragility and how tenderness

thrives amidst adversity. Each poem unfolds as a microcosm of contradictions, compelling the reader to reflect on the inherent tensions within themselves and the world around them. These dualities serve not as opposites but as complementary forces, creating a dialectical framework that challenges binary thinking. In doing so, the collection echoes the philosophical inquiries of great thinkers and poets who have grappled with the complexities of existence, from Rumi's mystical unity to Blake's songs of innocence and experience and others who refuse to settle for simplistic answers. His work compels us to confront our prejudices, question power structures, and strive for a more inclusive ,compassionate and authentic world.

"Pure and Impure" is a lens to explore poetry's transformative power- where the dualities sacred/profane, immanent/transcendent, huaman/divine intertwined, creating a timeless dialogue that mirrors the complexities of human existence with parallel portrayals of interplay in earthly mystical poetry of Rumi, Tagore, Rilke, Iqbal, Dante's Divine comedy; exaltation of sublime in Wordsworth, reconciling with T.S Eliot's Waste land or Peblu Neruda's earthly love, merges the personal with political/ social justice/human rights/ hollow rituals of modernity like Faiz, W.H Audin, Aroundadity Roy, Amrita Pritam, Adonis, pain of exile and displacement akin to Agha Shahid Ali, Mahmoud Darwish, Derek Walcot, Love and Longing like Mirza Ghalib, Kamla

Das, Nizar Qabbani, shares memory and loss with with Sylvia Plath, Elizabeth Bishop, Seamus Heaney etc offer profound insights into human existence transcending cultural and geographical boundaries.

Raina's exploration of the dichotomy between purity and impurity is particularly striking. His poetry critiques the socially constructed notions of purity, which have historically been used as tools of exclusion and oppression. Whether addressing caste hierarchies, gender biases, or racial prejudices, Raina dismantles these constructs with a sharp yet empathetic pen, revealing their arbitrariness and their role in perpetuating inequality. His approach aligns relatively with postcolonial and feminist critiques, as seen in the works of Audre Lorde, Kamala Das, and Chinua Achebe, who similarly used literature to question oppressive structures. Through his embrace of impurity, Raina celebrates diversity and individuality, urging readers to see beyond societal labels and recognize the beauty of the pluralistic human experience.

The opening poem of the collection, Pure Poet, is a masterstroke of intellectual clarity and emotional resonance, distilling poetry's transformative essence into a universal message. It reaffirms poetry as both a mirror and remedy, capable of bridging thought and action, introspection and social engagement. Through a critique of art that lacks purpose, symbolized by the "vase of filigree fine," the poem echoes the legacies of poets like Lal Ded, Rumi, Audre Lorde, and Agha Shahid Ali, who saw poetry as a force for activism and healing. The self-reflective lines challenge the detachment of "purity" and advocate for poetry that is grounded in the realities of human suffering and hope. The poem explores the dualities of beauty and utility, introspection and action, aligning with global traditions of engaged art, from Brecht's political theater to Darwish's resistance poetry. Pure Poet calls for an art that transcends abstraction, reminding us that poetry, when infused with empathy, can illuminate despair, inspire resilience, and guide humanity toward justice. Through its reflections on paradox, the poem encapsulates the complexity of the human experience, offering a space for discovery and reimagining, and reaffirming the timeless power of poetry to challenge conventions and transform the world.

Transformative Poetic Reflection on Human condition through Serendipitous selections

Poetry, in its truest form, is neither a fragile artifact nor an escape-it is fire, water, and breath. "Pure Poet" rejects poetry as a mere "vase of filigree fine," demanding instead a voice that burns, that bleeds into the veins of history, that does not turn away from suffering. This echoes the defiance of Lal Ded, Rumi, and Neruda, whose words were not ornaments but urgent awakenings. Poetry, here, is a rebellion against silence, against the indifference that lets sorrow dissolve unnoticed. The poet does not seek refuge in beauty but wields it as a blade, carving meaning from a world teetering between ruin and revelation.

The land itself breathes in "Mauj Kasheer" and "Land of My Birth," where memory is not nostalgia but resistance. The "simmer of oozing pinewood," the "frozen river by willow's edge," are not mere landscapes but sentient presences, carrying the weight of longing. Like Shahid Ali's snow or Darwish's olive trees, these images hold exile within them, turning geography into a ghost that follows the displaced. Death is not an ending but a homecoming, where the poet's last breath dissolves into the valley's pulse, a reunion beyond time. Kashmir, here, is both wound and womb, an eternal invocation.

Yet time is no gentle river; it erodes. "Those Were the Days" stands at the threshold of a world that has unraveled. The tomato vendor, once the "czar of giving," is reduced to a relic of generosity in a market of vanishing kindness. This elegy for human connection echoes Brecht's lament for a world where even memory is commodified. In "Live and Learn," wisdom bows to "glittering thinginess," the Faustian hunger for possession swallowing depth itself. These are not merely critiques of modernity but existential griefs, where human warmth is bartered away for illusions of progress.

Mysticism rises like a flame in "The Mystics and Their Lyrics," For Neeraj Mattoo where Lal Ded, Habba Khatoon, and Rupa Bhawani are not spectral voices of the past but firewalkers who defied the limits of their age. Their verses, forged in defiance, echo the untamed wisdom of Forough Farrokhzad and Adrienne Rich-women whose words did not beg for space but seized it. Similarly, "Remembering Raj Begum" conjures a voice that refuses to fade, like Keats's nightingale, eternal yet aching with the weight of remembrance.

The world's fevered madness erupts in "Fatal Choice," where noise drowns reason, where hysteria swallows dissent. Orwell's shadow looms, as does Brecht's bitter prophecy-truth is the first to fall when power hungers. This moral disintegration deepens in "Man," where civilization stands like a crumbling edifice, haunted by the ghosts of its own undoing. In "Asifa, My Child," the temple, meant to be sacred, becomes an altar of horror-faith turned into a shroud. The poet refuses to let memory be erased; grief here is resistance, an unyielding pulse against oblivion. The same defiant sorrow runs through "Palestine," where survival itself is an act of war, where an "invincible spine" stands unbowed amidst destruction.

Nature, however, offers its quiet defiance. "A Brook" whispers the wisdom of flowing forward, adapting, while "Cactus" speaks of resilience in barren landscapes. These are not just natural metaphors but spiritual philosophies-endurance shaped by water and stone. "Give Me Back That Spring" juxtaposes human violence with the silent, cyclic wisdom of nature. The Chinar, the swallows, the wrinkled elders-they witness history, but unlike men, they do not betray it.In "My Bulbul Calls," the poet seeks dissolution, longing to "melt into the hills," to become one with the song of existence. This is surrender not to defeat but to something vaster, a mystical absorption akin to Rumi's ecstatic vanishing. Yet, in "Fixing the Problem," the poet's gaze is sharp, dissecting the machinery of oppression, where "fixers" manufacture order at the cost of truth. This is no mere observation but an unmasking of power's brutal choreography. In I just built my paradise, a paradise of the mind, where "inebriate air" blurs reality and crystalline waters gleam with untouched clarity. Intoxication and lucidity entwine, a sanctuary both liberating and disorienting-born of thought, boundless yet fleeting.

At The End poem Raina's verse finds transcendence in the Chinar-his final steeple-where nature and the sacred converge. This rooted symbol of endurance becomes his sanctuary, not in distant heavens but amidst the ordinary. The apostles,

veiled as common people, dissolve the divide between the divine and the mundane, echoing a Sufi-like wisdom where holiness breathes in unnoticed encounters. The poem's quiet profundity lies in this realization: true communion is not sought in grandeur but in the silent witness of nature and the wisdom hidden in everyday lives.

According to official sources, the budget session of the Jammu and Kashmir Assembly is proposed to commence on March 3- the first annual budget presentation for the region in six years.

A proposal to convene the session was recently approved in a cabinet meeting and sent to Lieutenant Governor Manoj Sinha. The final duration of the session will be determined by Assembly Speaker Abdul Rahim Rather, following consultations with the Business Advisory Committee.

For the first time as Finance Minister, Chief Minister Omar Abdullah will present the state budget in the assembly.

During his previous tenure as Chief Minister, Abdullah oversaw the Home, General Administration, and other departments but had not directly handled finance. The budget must be approved before March 31, and while Union Territories typically have shorter budget sessions than states, this session may extend for several weeks.

Currently, the Jammu and Kashmir government consists of six ministers, including the Chief Minister. The Business Advisory Committee will decide on time allocations for key legislative activities, including: Debate on the motion of thanks to the Lieutenant Governor's address, discussions on budgets and grants of various ministries, debates on private members' resolutions and bills and other government business

The last budget for Jammu and Kashmir as a state was presented in January 2018 by then Finance Minister Dr. Haseeb Drabu, amounting to Rs 80,313 crore for FY 2018-19. However, following the dissolution of the assembly in June 2018, the State Administrative Council (SAC) adopted a budget of Rs 88,911 crore for FY 2019-20. From 2020-21 to 2024-25, budgets were presented and passed in Parliament in the absence of an elected assembly. The 2024-25 budget, passed by Parliament, stood at Rs 1,18,728 crore, a slight increase from the Rs 1,18,500 crore budget of 2023-24.

The Omar Abdullah-led government is expected to focus on fulfilling key electoral promises, including 200 units of free electricity for eligible households, Rs 5,000 per month for economically weaker women, 12 free LPG cylinders per year, Expanded ration distribution, Job creation (3 lakh government jobs), Boosting agriculture and horticulture, Promoting tourism and industrial growth.

These guarantees are likely to be key priorities in the budget, and the NC led dispensation will ensure their inclusion in government expenditure plans.

oming from a cricketers' family, the sport is in her DNA but it was New Zealand's loss in T20 World Cup final in 2010 against Australia that made Amelia Kerr want to be a White Fern and win an ICC trophy for her country.

Fourteen years later, she realised her goal of winning an ICC trophy by lifting the women's T20 World Cup in 2024. She also became the first New Zealander to win the ICC Women's Player of the Year award for her splendid show in 2024.

"I was about 11 or 12 when our Tawa college boys team won a tournament in Wellington and I was the captain and the only girl of the team. That was pretty special and then I used to watch White Ferns play on TV," Kerr told a select media in an interaction felicitated by the ICC.

 $"We lost the T20\,WC final in 2010 and from$ that moment I wanted to become a White Fern and change as much as I can and try to achieve that," said Kerr, who was also chosen the ICC T20 Women Cricketer of the Year 2024.

In the 2024 Women's T20 World Cup final against South Africa, her 43 off 38 and 3/24 played a big role in her side's maiden triumph and she was the Player of the Match in the finals.

"It is a very special feeling. As players we don't think about awards too much...but if I look back and reflect, the T20 WC win comes to mind, it was too special," said the 24-year-old

who picked 15 wickets in the T20 World Cup - the most by any bowler in a single edition in tense situations, she gave the credit to her of the tournament.

Coming from a family of sportspersons, Kerr started playing at a young age. She feels that playing cricket with boys has helped her

"As a kid I just loved playing any sport, not just cricket. I wanted to be the best. I played boys' cricket and that really helped me improve my game," said the leg-spin all-rounder who scored 387 runs and took 29 wickets in 18 T20

"I have been like that since I was young. I think a lot of that comes from my family and the messaging we had growing up. My dad said to me once that if I turn to the ground and walking off the field from that day I don't want to know from your reaction if you got a hundred or a golden duck," she said.

Born to former Welington players Robbie and Jo, Kerr's cricketing pedigree goes as far back as her maternal grandfather, Bruce Mur-

Asked how she manages to remain calm ray, the former New Zealand Test batter. Her elder sister Jess, who plays for Wellington, was named in New Zealand's national cricket squad against South Africa in 2020.

> "My role models are within my family and they are very liberal. Cricket is such a fickle game and there would be ups and downs, you have to take the good with the bad. It is so much more than the individual game."

> She hopes that the ICC award and the World Cup inspire youngsters in her small country to look at cricket as a career option. Asked if she tweaked anything in her game,

> she replied in negative. "For me, nothing has changed in my game or the process. Sometimes things go your way and sometimes they don't. I have worked on a

> few things in my bowling," she said. "I want to keep improving. The accuracy in my bowing is potentially developing. I am having more confidence in my bowling to mix up pace as well. In batting, I am looking to improve power and find different ways to score boundaries."

No captain's event or photoshoot before **Champions Trophy**

here will be no official ICC captain's meet or photoshoot ahead of Champions Trophy 2025. The event has traditionally taken place in the host country of an ICC tournament, but it will not be part of the build-up to the Champions Trophy in Pakistan, the first ICC tournament in the country since 1996.

There was no opening ceremony in the build-up to the most recent Champions Trophy - in the United Kingdom in 2017 - though there was a captain's event and official



photoshoot. The PCB said neither the ICC nor the cricket board had ever announced an opening ceremony this time. However, the PCB will host an event in Lahore on February 16, three days out from the first game, to mark the start of the tournament.

A PCB official told ESPNcricinfo the event would be "supported by the ICC" and expected ICC officials present in Lahore at the time would be in attendance.

The PCB said the absence of a captain's press conference and photoshoot was down to logistical concerns. With the tournament being held across four different venues in two countries, and with scheduling clashes for several sides in the build-up to the tournament, the PCB said teams were slated to arrive in Pakistan for the Champions Trophy close to the start of the tournament. Australia do not get to Pakistan until February 19, the day of the opening match.

Incidentally, the ICC did not organise a captains event ahead of the 2024 Men's T20 World Cup, which was played across the Caribbean and the USA. With teams playing warm-up matches in several countries, the ICC instead opted to do the official launch via a lighting projection show that featured all 20 captains beamed onto New York City's Rockefeller Center building.

The development resolves the question of India captain Rohit Sharma's potential presence in Pakistan. Had there been a formal captain's press conference or photoshoot, it would have required Rohit to be present.

Until last week, the BCCI told ESPNcricinfo the issue of Rohit travelling to Pakistan had "not yet been discussed" and was "not on the agenda". As the Indian government had not given permission for their cricket team to travel to Pakistan for the tournament, it was unclear whether they would have done so for Rohit for any captains' event.
