J&K Police gets 9325 cr

SRINAGAR: The Government of India has allocated Rs 9325 crore for the Jammu & Kashmir Police, which is under the administrative control of the Union Home Ministry, in the Union Budget for 2025-26.

Home Affairs' (MHA) demands for grants for 2025-26, Rs 9325.73 crore have been allocated to the J&K Police in the Union Budget. Of this amount, Rs 8897.72 crore has been earmarked for the revenue expenditure and Rs 428.01 crore for the capital expenditure, according to



These budgetary provisions have been made to meet the administrative expenditures of the Jammu and Kashmir Police, which is responsible for maintaining and enforcing law and order and managing traffic in J&K.

Since 2024-25, the J&K Police's budget has been part of the Union Budget. While the Union government has described the takeover of the J&K Police budget as an act of financial benevolence, opposition parties have argued that it indicates J&K will continue to remain under the Union government's control for a longer period.

NIA chargesheets gangster Aman Sahu's brother in Jharkhand coal mine attack case

NEW DELHI: The National Investigation Agency has chargesheeted the younger brother of dreaded gangster Aman Sahu in the Jharkhand Tetariyakhand coal mine terror attack case, the probe agency said in a statement on Saturday.

The attack was perpetrated in December 2020 as part of a criminal conspiracy hatched by members of the Sujit Sinha and Aman Sahu terror gang with the objective of extortion and disruption of the colliery in Jharkhand's Latehar, it said.

Akash Kumar of Jharkhand's Ranchi district has been chargesheeted under different sections of the Indian Penal Code (IPC) and the Unlawful Activities (Prevention)Act, according to the statement issued by the probe agency.

With this, the NIA has filed five chargesheets against 26 accused so far in the case.

The NIA, which took over the probe in



March 2021, found during the investigation that Akash, currently in prison for his involvement in various criminal cases across Jharkhand, was directly involved in the mine attack conspiracy. He was

engaged in harbouring, channelising and investing the terror funds, and in creating infrastructure for the terror gang, it said.

Akash was the financial node of the terrorist gang and had been collecting levy

and extortion money through multiple channels. Using financial layering, he was laundering the extorted funds through various shell firms and other financial entities.

He was also investing the funds in a variety of assets belonging to Aman Sahu and his associates, the statement said.

The Aman Sahu gang has been involved in several heinous crimes in Jharkhand, including bombing, firing, arson, as well as firing on police officers and jail authorities, it said.

It has been involved in disrupting government work and law & order, besides terrorising businessmen and contractors for collecting extortion/levy, according to NIA investigations.

The gang has also forged connections with splinter Naxal organisations and other terror gangs outside the state to further its violent agenda, the NIA said.

Budget is an attempt to 'dupe' people: Kharge

NEW DELHI: Congress president Mallikarjun Kharge on Saturday said the government is busy garnering praises for the Union Budget when the entire country is struggling with problems of inflation and unemployment, and asserted that the Budget is an attempt to "dupe" the people.

He said the Budget is aptly described by the Hindi proverb 'Nau sau choohe khake billi hajj ko chali' (roughly translated to seeking to be pious after committing a number of sins).

In a post on X in Hindi, Kharge said that in the last 10 years, the Narendra Modi government has collected Rs 54.18 lakh crore of income tax



from the middle class, and now the exemption is being given to those earning up to Rs 12 lakh. The finance minister has herself stated

that there will be a saving of Rs 80,000 per year, Kharge said and pointed out that is only Rs 6,666 per month.

"The whole country is struggling with the problem of inflation and unemployment, but the Modi government is bent on garnering false praises," he said.

In this 'announcement-making' budget, Make in India has been changed to National Manufacturing Mission to hide its flaws, Kharge said. "All other announcements are almost like

this. There is nothing for the youth. Modi ji had promised yesterday that he would take a big step for the empowerment of women in this budget, but nothing like that happened in the budget," he said.

No roadmap to double farmers' income and no concession in GST rates on agricultural

"There is no plan for health, education or scholarship for Dalit, tribal, backward class, poor and minority children. There are no reform measures to increase private investment. Their failures have been hidden by saying a few

superficial things on export and tariff," he said. Kharge said that nothing has been done to increase the income of the poor and not a single step has been taken to address the continuously falling consumption.

"Despite skyrocketing inflation, the budget of MGNREGA remains the same. Nothing has been done to increase the income of workers. There is no mention of any reform in the Multiple Rates of GST. To reduce unemployment, there was no talk of creating jobs," he said.

Startup India, Standup India and Skill India, all the schemes, have turned out to be mere announcements, he said.

"Overall this Budget 2025 is an attempt by the Modi Government to dupe the people," the Congress chief said.

International cyber fraud syndicate busted in Chhattisgarh, 4 held for providing mule accounts

RAINANDGAON: Police in Chhattisgarh's Rajnandgaon district have busted an international cyber fraud syndicate with the arrest of four persons who allegedly provided several mule accounts to Cambodia-based scammers and transferred Rs 10 crore from victims of fraud, an official said on Saturday.

One of the accused, Shrenik Kumar Sanghvi (24), a resident of Valsad in Gujarat, allegedly handled the mule accounts and transferred money deposited in them to international scammers through 'hawala' and cryptocurrency, Rajnandgaon Superintendent of Police Mohit Gargsaid.

He said the other three arrested men, Ashutosh Sharma, Shubham Tiwari (26) and Deepak Naredi (27), were all natives of Rajnandgaon district.

The official said the fraud came to light after the accused used the bank account of Rupesh Sahu, who operates a citizen service delivery centre in Rajnandgan, for illegal transactions.

On January 23, Sahu complained to the police that his account with a nationalised bank had been frozen after his friend Ashutosh Sharma allegedly used it for multiple transactions involving money collected through fraud, he said.

Garg said that a first information report was registered against Sharma, who was called for interrogation.

He said Sharma revealed that at the behest of Sanghvi alias Ajay Meher of Guiarat, he. Tiwari, Naredi (Kainandgaon) and other associates provided bank Sanghvi withdrew money in cash,

accounts of Sahu, their family members and other acquaintances for fraudulent activities.

The official said Sanghvi was arrested from Valsad on January 25 and brought cheque and UPI from these accounts and further transferred the same to his Cambodian-based handlers after converting it into cryptocurrency or through hawala," he said.

The official said Sanghavi received



Garg said, "During interrogation, he revealed that he travelled to Cambodia in June 2024 with his other Indian associates, and they visited a call/scam centre operated from a casino there. Sanghvi and others stayed there for a week and provided bank accounts of Indians to scammers in Cambodia who duped Indians in connivance with some Chinese nationals.'

Sanghvi later returned to India and came in contact with the other accused, who provided details of bank accounts, chequebooks, ATM cards, registered mobile numbers, he said.

"Scammers from Cambodia transferred money after duping people online into the mule accounts, and 8 to 9 per cent commission on the transferred amount, while Sharma got 4 per cent commission, and the other two accused got up to Rs 35,000 per mule account, he said.

The official said as per the probe, the accused were involved in transferring Rs 10 crore in 50 mule accounts, and the National Cyber Crime Reporting Portal and Samanvay Portal of the Home Ministry of India confirmed this.

He said the police have also received information about cyber fraud worth crores of rupees in the name of online task completion, providing jobs,

investments in fake companies and matrimonial websites from different parts of the country using these bank

Former Chief Election Commissioner Navin Chawla Passes Away At 79

NEW DELHI: Former Chief Election Commissioner of India, Navin Chawla, passed away Saturday, a senior official of the Election Commission of India said.

Navin Chawla (79), who passed away due to cardiac arrest, was the CEC from 2009 to 2010. He had been an Election Commissioner from 2005. The cremation will be held at the Green Park crematorium at 5 p.m. today (February 1, 2025).

He had been admitted at the Apollo Hospital here for brain surgery, former CECS.Y. Quraishi posted on X.

"Sad to know about passing on of Shri Navin Chawla, former Chief Election Commissioner of India. May his soul rest in peace,"

Mr. Quraishi said. Chawla had joined the Indian Administrative Service in 1969. In the course of his career, he served in the Governments of Delhi, Goa, Puducherry and Lakshadweep

In 2005, he was appointed Election Commissioner. In April, 2009 he took over as Chief Election Commissioner. During his tenure he successfully completed the General Elections

Chawla had a long association with Mother Teresa. He first met her as a young Civil Servant and maintained a life long association with her, helping her with her work.

In 1992 he wrote her biography, entitled "Mother Teresa". Mr. Chawla's interest in the leprosy condition also

resulted in a report on "The Vocational Rehabilitation and Social Re-integration of the Leprosy Affected in India", which was released by Mother Teresa in 1987.

His tenure as Election Commissioner was mired in controversy when then CEC N. Gopalaswami recommended his removal to the government. It was the culmination of differences within the three-member commission on many crucial decisions.

Mr. Gopalaswami's recommendation, which came about three months before he was to demit office as CEC, was based on a petition by the BIP, which had complained against the "partisan" functioning of Mr Chawla.It was, however, rejected by then President Pratibha Patil. The Supreme Court had also dismissed a lawsuit that sought his removal.

Shallabugh Wetland emerging as premier eco-tourism destination in Gbl

Ganderbal: The Shallabugh Wetland Conservation Reserve, sprawling over 1,675 hectares across Srinagar and Gan-



derbal districts, is rapidly turning into a renowned eco-tourism hotspot. With its designation as a Ramsar site on June 8, 2022, the wetland has garnered global recognition for its vital role in preserving biodiversity.

This protected wetland is home to a diverse array of bird species, including the Pintail, Common Teal, Wigeon, Gadwall, Mallard, and the rare Pallas's Fish Eagle. Additionally, Steppe Eagles, Eastern Imperial Eagles, and Yellow-eyed Pigeons, among others, contribute to its status as an avian paradise. An annual bird census, held on February 23 and 24,

provides valuable data to track and monitor these bird populations.

The local community, as per the news agency—Kashmir News Observer (KNO), expressed great pride in Shallabugh Wetland, citing its significance as one of Asia's largest wetlands.

However, residents have raised concerns about staffing shortages, which they feel impact effective management. "While the wetland is thriving with hundreds of thousands of birds, there is an urgent need for more personnel to ensure its proper care,"

said a local.

Wildlife Department officials explained the wetland's importance for migratory birds, noting that each year, vast numbers of birds flock to the site.

"We are committed to safeguarding these

birds, especially during peak migration seasons. We urge hunters to respect the wildlife and refrain from any harmful activities," said an official.

February, in particular, is expected to see an influx of additional migratory birds.

Currently, the bird population is estimated to be between 3 to 4 lakh. To aid during the harsh winter months, the department provides grains to feed the birds and ensures their well-being amid freezing temperatures. "Compared to last year, the number of birds has notably increased," the official added.

The Shallabugh Wetland stands as an exemplary model of community-driven conservation. Local residents, non-governmental organizations (NGOs), and government bodies are working hand in hand to preserve the ecological balance. With its Ramsar status highlighting its global importance, the wetland calls for continued efforts to protect it, ensuring its future as a sanctuary for wildlife and a sustainable eco-tourism destination for generations to come—(KNO)

Exploring the Life and Legacy of Prophet Muhammad (SAW)

ne life and legacy of Prophet Muhammad(SAW) is one that transcends time, geography, and culture. His message, marked by profound spirituality and deep compassion, has influenced billions of lives across the world.

For Muslims, he is the final prophet of Allah, sent to guide humanity to the path of righteousness, peace, and justice. His life story is not just a tale of personal success but a roadmap for how to navigate the complexities of life with virtue, perseverance, and a deep sense of responsibility toward God and fellow human beings. This article delves into the life of Prophet Muhammad (SAW), exploring his early years, his prophethood, and his lasting legacy that continues to shape the world even today.

The Early Life of Prophet Muhammad (SAW)

Muhammad (SAW) was born in 570 CE in the city of Makkah, in present-day Saudi Arabia, into the noble and respected Quraysh tribe. $The \,Revelation: The \,Beginning \,of \,Prophethood$

At the age of 40, while spending time in the Cave of Hira in solitude, Muhammad (SAW) received the first revelation from Allah through the Angel Jibreel (Gabriel). This moment, described in Surah Al-Alaq, marked the beginning of Muhammad's (SAW) mission as the final prophet. He was instructed to "Read" and to spread the message of monotheism—that there is no god but Allah.

At first, Muhammad (SAW) was deeply affected by the experience and sought comfort from his wife Khadijah. Her steadfast belief in him gave him the strength to continue his mission. Over the next 23 years, Muhammad (SAW) would continue to receive revelations that would later form the Qur'an, providing guidance for all aspects of human life, from morality to social justice, from family life to spirituality.

The Early Struggles: The First Years of Prophet-

As Muhammad (SAW) began to preach the message of Islam, he faced strong opposition from the Quraysh leaders in Makkah, who saw his message as a direct challenge to their authority and way of life. They were

particularly resistant to the concept of monotheism, as it threatened their polytheistic beliefs and the lucrative pilgrimage industry built around the Ka'bah, which housed many idols.

Despite the intense opposition, Muhammad (SAW) and his followers continued their mission. The early years of Islam were marked by persecution, with many

In Madinah, Muhammad (SAW) not only served as



Muslims suffering social ostracism, torture, and even death. The Quraysh leaders attempted to bribe Muhammad (SAW) and offered him power and wealth, but he remained resolute in his mission.

One of the most significant events during this period was the Boycott of BanuHashim, where the Quraysh tribe attempted to isolate and starve the Prophet's clan. Despite the hardships, the Prophet Muhammad (SAW) and his followers remained steadfast. This period of suffering and persecution was crucial in shaping the resolve and character of the early Muslim community.

The Night Journey (Isra and Miraj)

In the midst of the hardship and rejection, the Prophet experienced a miraculous event known as Isra and Miraj, the Night Journey and Ascension. According to Islamic tradition, one night Muhammad (SAW) was miraculously transported from the Ka'bah in Makkah to Al-Aqsa Mosque in Jerusalem, and from there, he ascended to the heavens. During this journey, he met various prophets, and Allah granted him the command of the five daily prayers (Salah) for the Muslim community.

The Isra and Miraj was not just a physical journey but also a spiritual elevation, further solidifying the Prophet's role as the leader of all the previous prophets and reaffirming his mission. This event became a source of comfort and inspiration for the Muslims, reaffirming that their Prophet was divinely chosen.

The Migration to Madinah (Hijrah)

After years of persecution in Makkah, the Prophet and his followers were invited by the people of Yathrib a spiritual leader but also took on the role of a political leader and statesman. He established a constitution known as the Constitution of Madinah, which was a document that laid down the rights and responsibilities of all citizens, including Muslims, Jews, and other groups living in the city. It emphasized justice, the protection of religious freedom, and mutual cooperation, marking an important step toward the establishment of an inclusive society.

The Battles and Their Significance

The early years in Madinah were not without conflict. The Muslim community faced multiple military confrontations with the Qurayshand other hostile tribes. These battles, including the Battle of Badr, Uhud, and The Battle of the Trench, were crucial in shaping the Muslim community's sense of unity and resilience.

The Battle of Badr, fought in 624 CE, was a decisive victory for the Muslims, despite being heavily outnumbered. It demonstrated the power of faith and conviction in the face of overwhelming odds. In 628 CE, the Prophet Muhammad (SAW) and the Quraysh leaders signed the Treaty of Hudaybiyyah, a peace agreement that allowed the Muslims to perform pilgrimage in Makkah the following year. This treaty, although seemingly unfavorable to the Muslims, paved the way for the eventual conquest of Makkah.

In 630 CE, after the Quraysh broke the treaty, the Prophet led a large Muslim army to Makkah. The city surrendered peacefully, and Muhammad (SAW) entered Makkah triumphantly, showing mercy and forgiveness to his former enemies. He cleansed the Ka'bah of idols and rededicated it to the worship of the one true God, Allah.

The conquest of Makkah marked the turning point in the history of Islam. With the city now under Muslim control, the faith began to spread rapidly throughout the Arabian Peninsula, and many tribes embraced Islam.

The Last Sermon and Final Years

In 632 CE, during his final pilgrimage, Prophet Muhammad (SAW) delivered his famous Farewell Sermon to the gathered Muslims. In this sermon, he reminded the Muslims of their responsibilities to one another and $emphasized \,the \,equality \,of \,all \,people, regardless \,of \,race,$ ethnicity, or social status. 2. Punjabi, Pashtun and Sindhi: Punjabi people are considering as a largest ethnic group in the Pakistan. The Punjabi originated from the Indo-Aryan ethnic group. The most significant population of the Punjabi people practice Islam as their primary worship.

Multi-disciplinary Research Unit, GMC Srinagar's 4th LRAC meeting highlights achievements

Principal Investigators (PIs) from various departments, including Psychiatry, Physiology, Chest Medicine, Dermatology, Biochemistry, Endocrinology, Gynae & Obs, Surgery, Paediatrics, Neurology, and Medicine, presented reports on eight recently completed or ongoing collaborative research projects. These projects focus on understanding the molecular and pathological basis of diseases, developing targeted treatment approaches, improving diagnostics, and advancing medical technology for better disease management and patient outcomes.

The research has led to 12 recent publications in peer-reviewed indexed journals with an impact factor of 4-5. Research proposals were presented by Pls from various departments for approval, and four proposals from the Departments of Dermatology, Microbiology, and Medicine were approved by LRAC with concrete suggestions. Additionally, it was decided that a compendium of research carried out in MRU-GMC Srinagar would be published annually.

Individuals earning up to Rs 12 lakh annually will not have to pay any income tax under the new tax regime as Finance Minister Nirmala Sitharaman on Saturday gave relief to middle class by raising exemption limit and rejigging slabs.

For salaried employees, this nil tax limit will be Rs 12.75 lakh per annum, after taking into account a standard deduction of Rs 75,000.

Higher exemptions and rejigs have been effected under the new income tax regime.

"I am now happy to announce that there will be no income tax payable up to income of Rs 12 lakh (i.e. average income of Rs 1 lakh per month other than special rate income such as capital gains) under the new regime," the finance minister said.

"The new structure will substantially reduce the taxes of the middle class and leave more money in their hands, boosting household consumption, savings and investment," Sitharaman said in her

As per the rejig, for people earning more than Rs 12 lakh per annum, there will be nil tax for income up to Rs 4 lakh, 5 per cent for income between Rs 4 and 8 lakh, 10 per cent for Rs 8-12 lakh, 15 per cent for Rs 12-16 lakh.

A 20 per cent income tax will be levied on income between Rs 16 and 20 lakh, 25 per cent on Rs 20-24 lakh and 30 per cent above Rs 24 lakh per annum.

A tax payer in the new regime with an income of Rs 12 lakh will get a benefit of Rs 80,000 in tax. A person having income of Rs 18 lakh will get a benefit

A person with an income of Rs 25 lakh gets a benefit of Rs 1.10 lakh.

J&K to bridge its resource gap. An additional Rs 279 crore has been allocated as grants towards the contribution to the Union Territory Disaster Response Fund, and Rs 101.77 crore to meet resource gap funding for infrastructure projects.

The figures available with news agency—Kashmir News Observer (KNO) show that J&K's allocation for the next fiscal is almost Rs 604 crore less than the allocation for 2023-24. As per revised estimates for 2024-25, J&K's allocation has been reduced by Rs 1277 crore. While the allocation, as per budget estimates, was Rs 42,277.74 crore, it has been revised to Rs 41,000.07 crore.

It is worthwhile to mention that Jammu & Kashmir is heavily dependent on Central assistance in Union Territories. Chief Minister Omar Abdullah had himself met Union Finance Minister Nirmala Sitharaman to seek additional assistance of Rs 6000 crore.

The same squad will also play the ODI tri-series against South Africa and New Zealand in the build-up to the Champions Trophy.

The squad confirms what was widely feared within Pakistan: Saim Ayub remains unavailable because of the ankle fracture he sustained during the Cape Town Test. At the time, it was announced he would be out for six weeks, but it was believed his chances of recovering in time for the Champions Trophy were exceptionally slim. Earlier today, PCB chairman Mohsin Naqvi confirmed Ayub's return remained "at least four weeks" away.

Abdullah Shafique's loss of form has cost him a place in the squad. In the recently concluded ODI series against South Africa, which Pakistan won 3-0, he became the first player to be dismissed for a duck in every match of a series. It means Pakistan will go in with a completely different opening pairing, with Fakhar likely to pair up with either Babar Azam or Saud Shakeel, with the PCB citing Babar's success opening in Test cricket as a potential factor to consider.

"Fakhar's opening partner could be either Babar Azam or Saud Shakeel, depending on

Ranji Trophy: J&K camp protest over alleged pitch manipulation

Match delayed after players raises issue, Baroda refutes allegations

Srinagar: The Jammu and Kashmir (J&K) Ranji Trophy team staged a protest against Baroda on Saturday accusing the hosts of tampering with the pitch in their ongoing match. The protest occurred on Day 3 of the crucial Elite Group

A game between the two teams at the Reliance Stadium in Vadodara. The incident caused a delay in the start of play, which was scheduled for 9:30 am but began at 10:55 am instead.

Jammu and Kashmir's players and management raised concerns after noticing a drastic change in the pitch conditions between Day 2 and Day 3. They claimed that the pitch had been balanced during the second day of play, but by the start of Day 3, it had become damp and unpredictable. This made batting significantly harder and led to their protest.

The allegations were made by J&K's coach, Ajay Sharma, who noticed a difference in the color of the pitch. He believed that this change was unusual and suggested it could have been altered overnight. As a result, J&K filed an official complaint with the relevant authorities regarding the state of the pitch.

The protest by the visitors delayed the match, with play starting later than usual.

On the other hand, Baroda denied the accusations, calling them "baseless." A representative from the Baroda Cricket Association explained that the pitch had moisture due to the winter conditions, which caused the surface to be damp.

The representative added that the outfield was also wet, and both the umpires and players were aware of the conditions. According to Baroda, these natural conditions were to blame for the changes in the pitch, not any deliberate action to alter it.

The Baroda official also said that such delays were common in winter and that it was not unusual for matches to be affected by moisture. The Baroda Cricket Association expressed their intention to approach the Board of Control for Cricket in India (BCCI) regarding the allegations made

The match was important for both teams. For J&K, a win would ensure they topped their group, while Baroda needed a victory to advance to the quarter-finals.

Despite the controversy surrounding the pitch, Jammu and Kashmir managed to set Baroda a target of 365 runs—(KNO)
