

PM Modi 'dividing' society, will have no association with those allied with BJP: Sharad Pawar

PUNE: Senior opposition leader Sharad Pawar on Friday accused Narendra Modi of "dividing" the society as he slammed the Prime Minister's campaign speeches and stressed that he will have no association with those allied with the BJP, when asked about the possibility of a post-poll reunion with his estranged nephew Ajit Pawar.

In an interview with PTI, Pawar, considered the architect of the opposition Maha Vikas Aghadi (MVA) in Maharashtra, said the ruling Mahayuti has been using a "tremendous amount of monitory strength", including through cash transfer schemes, to influence the polls following its poor show in the state in the Lok Sabha polls.

But people will reject them, he said. The four-term former Maharashtra chief minister and ex-Union minister was blistering in his criticism of Uttar Pradesh Chief Minister Yogi Adityanath, whose "batengain to katengain" slogan



has drawn criticism from even some BJP leaders and allies like Deputy Chief Minister Ajit Pawar.

The Nationalist Congress Party (SP) president said, "He(Adityanath) is known for these communal expressions. Why give him importance? I don't want to utter even one sentence about him. These are the people who wear saffron clothes and perpetrate communalism. They are doing a disservice to the nation."

Asked about Modi's extensive campaign in which he accused the opposition of dividing the society on caste lines and sought people's unity in favour of the ruling BJP-Shiv SenaNationalist Congress Party alliance, Sharad Pawar hit back.

"He is the prime minister. He is saying certain things. What he says about our associates (allies) is very unfair. He himself is dividing the society. You can see his speeches over the past few days and the issues that he is raising for his political interests," he said.

Pawar said he has witnessed a great amount of "unrest" among people during his extensive campaign.

The prime minister has accused the Congress-Shiv Sena (UBT)-NCP(SP) alliance of seeking to divide society and pursuing appeasement politics, and has called for unity with his call for "ek hain to safe hain".

Ehsaas Foundation Extends Aid To Kashmiri Pandit Families After Devastating Fire



SRINAGAR: In the quiet villages of Purkhoo and Mishriwala, tragedy awaited them as the gigantic fire razed several homes of the Kashmiri Pandit community

To those families, who surveyed the smoldering remains and the charred remains of their homes, there was hope when it appeared through the Ehsaas Foundation-a charity dedicated to supporting everyone who faced crisis.

On hearing the news, members of the foundation, such as Malik Zahoor, Faheem Reshi, Tahir Peerzada, Burhan Nazir, Farash, Umer, and Harris Hameed, got into action to rush assistance to the families. Their action went beyond mere materialistic relief; it was a show of brotherliness-a renewed remembrance of a common bond that ties humankind together in turmoil.

The Ehsaas Foundation volunteers arrived quickly, bringing everything from food to clothing and temporary shelters. But perhaps more momentous than the material support was the emotional respite they could offer. "We knew we needed to be here," $says\,Malik\,Zahoor, representing\,the\,team, "not\,just\,for$ material needs but for solidarity with our Kashmiri Pandit brothers, who have lost so much. This is a time of unity.'

This moving response struck a chord in the community that was ravaged. As one homeowner, Rajesh Koul, whose house caught fire said, "We felt lost and forgotten, but these young men coming to our aid restored our faith. They reminded us we

The Ehsaas Foundation, however, is a reflection of the extent of commitment much beyond social work; it resembles the spirit of Kashmiri brotherhood. Each volunteer formed an important part of the entire exercise whereby every attempt was done to ensure that the instant needs were met with people whose homes and livelihoods were ravaged. Faheem Reshi particularly noted how personal this mission was for him: "This isn't just about delivering aid; it's about strengthening the bonds of our community, especially during times of crisis."

Their outreach, in such a historical backdrop to the communal fabric of Kashmir, where decades of conflict have strained the relations between communities, is exceptionally meaningful as it presents initiatives which act as bridges to further strengthen the relationships and the empathetic ambiance between the communities.

It has dealt with all immediate needs, but the far-reaching effects of this disaster will only be solved after long-term struggle. The Ehsaas Foundation is hopeful that it can continue to offer them support not in a purely materialistic sense but by acting as a platform for them to rebuild their lives. Volunteers are consulting the local leaders in order to help these families attain stability and, slowly, normalcy.

For the house of hope, the future holds promise. It feels that it would inspire more organizations and individuals to raise their hands and come forward. The idea can start from one act of kindness and creates an impact which stirs up others into a crowd of solidarity. "We encourage others to come forward," said Tahir Peerzada. "The spirit of brotherhood does not end there; it begins anew every time we decide

BJP using money garnered from paper leaks to fund **Jharkhand poll** campaign, alleges Soren

RANCHI: Taking a dig at the central

investigative agencies, Jharkhand Chief Minister Hemant Soren on Friday claimed that they were busy probing incidents like "chicken theft" while cases like the examination paper leaks in UP remain untouched at the behest of the BJP.

Soren alleged that the BJP was behind the paper leaks in the states it ruled, and the money it garnered from there was being used to fund its poll campaigns.

"The pomp and show that you are seeing from BJP in Jharkhand elections is all due to the money from paper leaks... ED, CBI, NIA which have started investigating even chicken theft cases these days did not probe paper leaks because it is the BJP that leaks these and with that money, it buys MLAs and MPs post elections,"

Soren alleged in a post on X. "Exam papers were leaked in all BJP- ruled states... MP Vyapam scam claimed several lives. In Jharkhand, we made tough law post one paper leak but BJP went to Raj Bhavan terming it a black law," he alleged.

GRAP-III Restrictions In Delhi As Air Quality Remains 'Severe' For Third Consecutive Day

NEW DELHI: Delhi woke up to GRAP Stage III restrictions on Friday,

as the city's air quality remained in the "severe" category for the third consecutive day, prompting strict measures to curb pollution levels.

According to the Sameer aap, the Air Quality Index at 9 am was recorded in the 'severe' category (400 to 500), with a reading

The CAQM imposed GRAP Stage III as the national capital recorded the worst pollution levels in the country,

with the air quality remaining in the "severe" category for two consecutive days.

Prior to entering the "severe" category, Delhi's air quality had been in the "very poor" range for 14 consecutive days.

It directed the authorities in Delhi-NCR to invoke curbs under stage III of the antipollution plan with immediate effect. The GRAP for Delhi-NCR is divided into four stages of air quality — Stage 1 for "poor" Air Quality Index (AQI) ranging between 201 and 300, Stage 2 for "very poor" AQI of 301-400, Stage 3 for "severe" AQI of 401-450 and Stage 4 for "severe plus" AQI more than 450.

NEW DELHI: The Congress on Friday accused the Centre of going "full throttle" on attempts to deny Adivasis justice and said the Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DAJGUA) was a "full mockery" of the Forest Rights Act, illustrating the government's hypocrisy. The Opposition party also claimed that

DAJGUA, in "typical Manuvadi fashion", only sees these communities as forest-dwelling 'vanvasis' who are 'labhaartis' (beneficiaries), rather than political and economic actors in their own right.

Congress general secretary in-charge communications Jairam Ramesh said today is the 150th birth anniversary of 'Dharti Aaba Bhagwan Birsa Munda', one of the greatest sons of India and a fierce advocate of self-governance and social justice.

"The non-biological PM is in Jamui, Bihar paying lip service to the cause of the Adivasis on this occasion, even as his Government goes full throttle on attempts to deny Adivasis justice," Ramesh alleged



in a statement.

"The Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DAJGUA) - named after Bhagwan Birsa Munda, but a full mockery of the Forest Rights Act-illustrates this hypocrisy," he said.

Ramesh said the Forest Rights Act (FRA 2006) passed by the Manmohan Singh's government was a revolutionary law and it transferred power and authority over forests from the forest department to the gram sabha.

Encroached Roads, Choked Footpaths Worsen Woes for Bandipora Commuters, Pedestrian

BANDIPORA: Footpaths in key areas of Bandipora Market have been overtaken by street vendors, creating traffic and safety issues for the locals while Municipal Council allow vendors to occupy roads around Gulshan Chowk adding to the miseries of

The vendors, selling everything from food items to fruits, have left little room for pedestrians, making it difficult for people to walk safely through these busy areas while equally making the commute difficult for those travelling in cars and public transport.

"Few Years ago the District administration allocated a space for vendors in the Old Bus Stand and marked their spaces also while the Municipal Council Bandipora (MCB) registered them. However, the number of vendors increased again manifold and MCB is charging them 800 per month and giving them impunity to erect their stall anywhere," said Mohammad Abdullah, a resident of Bandipora told Kashmir Convener.

"Walking on the streets has become a challenge because of the vendors occupying the footpaths while lack of parking spaces added to the miseries. "It's not just inconvenient, it's also a safety risk for

With vendors occupying onto the footpaths, and lack of civic sense in parking cars, pedestrians are forced to walk on the roads, often in close proximity to moving vehicles, which increases the risk of accidents.

> Locals said the frequent stops of Matadors in the main Market has also added to the miseries of the people. "From New Bus Stand Nussu upto Nowpora Chowk, Matadors stopover at a dozen locations adding more mess to the traffic".

"It takes far too long to get anywhere because of the congestion caused by these

vendors and illegal and haphazard car parking," one local fumed.

Locals said the many shopkeepers have also added to the misery of the people by occupying footpaths in Main market and Khadim Market that

has also hindered the traffic and pedestrian move-

"Footpaths are meant for walking, not for storing goods. In places like Gulshan Chowk or Khadim market. "There's no space left to walk. It's frustrating, and something needs to be done," said a student, urging authorities to take action".

Local resident Tanveer Ahmad echoed similar concerns, pointing out that shopkeepers also contribute to the problem by placing their goods outside.

"Sidewalks are completely blocked in many areas, leaving people with no choice but to walk on the road," he said.

Despite repeated attempts to contact the Executive Officer of the Municipal Committee Bandipora, no response has been received. Kashmir Convener Will Update Story in digital format whenever MCB responds.

One Moment of Thrill:

A Lifetime of Sorrow

ne scenic roads of Jammu and Kashmir, winding through breathtaking landscapes, have unfortunately become the backdrop for a rise in road accidents involving young, unlicensed drivers. These minors, often motivated by the thrill of speed and peer pressure, overlook the irreversible impact their actions can have. Misuse of vehicles by underage drivers is a growing issue that devastates families, communities, and the lives of innocent bystanders.

The Harsh Reality of Road Accidents

Accidents involving minors have become alarmingly frequent. Families who allow their children occasional access to vehicles, whether to satisfy curiosity or encourage responsibility, are left facing unimaginable grief when these moments of leniency turn tragic. The outcomes are often fatal or result in severe injuries that change lives forever.

Specific Statistics in Jammu and Kashmir

The data on road accidents in Jammu and Kashmir underscores the seriousness of this crisis:

2010-2022: Over a 12-year period, the region recorded 76,942 accidents, resulting in 12,429 deaths and more than 104,983 injuries. These numbers reveal the scale of the issue, with accidents affecting not just drivers but pedestrians and passengers as well.

2022: The Union Territory saw 6,092 road accidents with 805 fatalities. This was an increase from the previous year and highlighted the challenges faced by road safety officials.

2024 (First Nine Months): Recent statistics reveal that in just the first nine months of 2024, 4,457 accidents occurred, resulting in 621 deaths and 6,122 injuries. The month of May alone accounted for 98 fatalities, showing the significant risk of high-traffic periods.

These numbers represent real lives, real families torn apart, and futures lost due to moments of negligence or thrill-seeking behavior.

India faces similar concerns on a larger scale. In 2021, the country recorded over 4,12,432 road accidents, with approximately 10,311 involving drivers without valid licenses, many of whom were minors. Additionally, India ranks among the highest globally in road fatalities, accounting for a staggering 11% of global road deaths despite having only 1% of the world's vehicles.

Families Left in Devastation

The impact of these accidents goes beyond numbers; it affects the very fabric of families. In many cases, road accidents rob families of their sole breadwinners or only children. Losing a primary earner is devastating, plunging households into financial instability and emotional distress. Studies show that:

40% of rural households report at least one death after a road crash, compared to 12% in urban areas.

Low-income families are twice as likely to lose a family member to a road crash compared to wealthier families, underscoring the socioeconomic ripple effects of these

For families that lose a sole breadwinner, the consequences are particularly severe. Beyond the immediate emotional loss, these families face the burden of economic instill accountability, enforcement challenges, combined

hardships, often lacking the resources or social safety nets to recover fully. In regions like Jammu and Kashmir, where economic resources can be limited, the loss of a breadwinner or only child due to a preventable accident places an immense burden on the family, affecting not only their immediate well-being but also their long-term stability.

Role of Indian Laws on Rash and Underage Driving

Indian laws have become increasingly stringent to curb rash driving and prevent underage individuals from operating vehicles, yet the challenge remains significant.

Motor Vehicles Act, 1988: This foundational law governs all motor vehicle operations in India and stipulates



clear rules about licensing. It prohibits individuals below 18 from driving motor vehicles, with an exception allowing 16-year-olds to operate two-wheelers under 50cc with parental consent. Driving without a license is an offense punishable by fines and imprisonment.

Amendment to the Motor Vehicles Act, 2019: In response to rising road accidents, India introduced harsher penalties:

Underage Driving: Parents or guardians allowing their underage children to drive can face fines up to 25,000, imprisonment of up to three years, and their vehicle registration may be canceled.

Rash Driving: Section 279 of the Indian Penal Code classifies rash and negligent driving as a criminal offense. The offense carries a jail term of up to six months or a fine, which the 2019 amendment raised to 5,000 for first offenses.

Dangerous Driving: Dangerous or reckless driving that endangers the safety of others is punishable by up to a year of imprisonment and increased fines of up to 10,000.

Juvenile Justice Act, 2015: Under this act, minors involved in serious offenses, including fatal accidents, can be tried as adults if they are above 16 years. This provision is aimed at deterring underage drivers from engaging in reckless behavior.

While these laws are designed to prevent accidents and

with a lack of awareness, mean they often fall short of sible driving. achieving the desired impact.

The Role of Jammu and Kashmir Police and Parental Responsibility

Jammu and Kashmir Police, along with other government agencies, actively work to curb road accidents by conducting regular enforcement checks, implementing speed restrictions, and running road safety awareness campaigns. However, while these efforts are vital, the main responsibility also rests with parents. It is crucial that parents educate their children about the legal and moral consequences of driving without a license, especially how one impulsive decision can shatter other families and ruin

their own future.

Parents play a pivotal role in instilling awareness in their children. By emphasizing the seriousness of road safety and the potential devastation of reckless driving, parents can encourage responsible behavior from a young age. Understanding the ripple effect their actions have on others is essential; young drivers must realize that their decisions can lead to tragedies, creating permanent voids in families and, in many cases, casting a shadow over their own future.

A Proposed Addition to Indian Laws to Curb

Given the serious impact of underage and rash driving, Indian laws could adopt an additional measure inspired by international practices. One effective approach could be to introduce mandatory driving education and certification programs in schools, focusing on the legal, ethical, and practical aspects of safe driving.

Mandatory Driving Education: A compulsory road safety curriculum for students aged 15–18 could be established in schools. This program would educate young people about: The legal consequences of underage and

reckless driving. Real-life stories of the devastating effects of irrespon-

The skills required for responsible vehicle operation, even as a passenger.

This structured early education would instill a respect for road laws and create a strong foundation for safe driving habits. Students who complete the program would receive a provisional certificate, valid only as a prerequisite for applying for a full driver's license upon reaching legal age. This practice would ensure that they understand their responsibilities before they are legally able to drive.

Implementing Vision Zero Principles in India

Sweden's Vision Zero principles could serve as a roadmap for enhancing road safety in India. While adapting this model may require phased implementation, several elements are well-suited to addressing India's unique

Introduce "2+1" Road Designs: High-speed and accidentprone areas could benefit from "2+1" lanes with median barriers to prevent fatal head-on collisions.

Focus on License Verification and Youth Education: Stricter enforcement of age and licensing regulations. paired with enhanced driver training and ethical education for young drivers, could build a foundation for safer driving habits.

Safety for Vulnerable Road Users: Creating dedicated lanes for pedestrians and cyclists, and improving crossings, would enhance the safety of these groups.

Community Engagement and Awareness: Comprehensive campaigns that emphasize the consequences of reckless driving can be more effective when involving schools, local authorities, and media. The societal buy-in that contributed to Sweden's success is key for long-term impact in India.

Data-Driven Policies: Collecting and analyzing data $on \, accidents, particularly \, those \, involving \, minors, allows \,$ for informed decisions on enforcement and policy adjustments. Data transparency can also help communities understand the scale of the problem and the importance of preventive measures.

A Unified Call to Action

The tragic accidents involving minors in Jammu and Kashmir and across India call for immediate, concerted action. The Jammu and Kashmir Police and local agencies continue to work on curbing this issue through enforcement and education, but parents have a critical role in this effort. It is vital that parents educate their children on the consequences of reckless driving, emphasizing that one impulsive choice can leave lifelong scars on others and cast a shadow on their own future.

The thrill of driving should not come at the cost of lives, and a moment's excitement must never be allowed to end in a lifetime of sorrow. For a family, the loss of a sole child or breadwinner is an irreplaceable tragedy, and each incident serves as a stark reminder of the need for road safety reform. Adopting elements of Sweden's Vision Zero model and strengthening Indian laws with mandatory driving education could be a turning point, making roads safer and giving families reassurance that they won't lose loved ones to preventable accidents.

How Using Social Media Affects Teenagers

ne impact of social media on adolescents has raised serious concerns globally, with debates over whether age restrictions can effectively address its potential harms or lead to unintended consequences. Facilitates interaction and community building with peers and aids social skill development. Pew Research (2023) found that 71% of teens feel more connected through social media. Provides a platform for young people to explore identity and express themselves freely. Social media is a term for internet sites and apps that you can use to share content you create. Social media also allows you to respond to content posted by others. This may include photos, text, reactions or comments posted by others, and links to information.

Online sharing within social media sites helps many people keep in touch with friends or connect with new people, and this may be more important to teens than other age groups. Friendships help teens feel supported and play a role in forming their identity. So, it's natural to think about how social media use may affect teens. Social media is a big part of many teens' daily lives. How big? A clue comes from a survey conducted in 2024 of 13- to 17-year-olds. Based on nearly 1,300 responses, the survey found that 35% of teens use at least one of five social media platforms more than several times a day. The five social media platforms are: YouTube, TikTok, Facebook, Instagram, and Snapchat. Social media does not affect all teens the same way. Social media use is associated with healthy and unhealthy effects on mental health. These effects vary from one teen to another. The effect of social media on mental health depends on a number of factors.

A UNICEF report (2022) shows that social media promotes self-identity in 62% of adolescents. Enables access to vast educational resources and enhances digital literacy and skills. LinkedIn and Facebook provide workshops on digital skills for youth. Creates safe spaces for marginalized groups to find support and understanding, WHO (2022) reports a 20% reduction in social media use increases the risk of cyberbullying by 30%. It helps reduce the risks of predatory behavior and exploitation targeting young users. The National



mental health risks in youth with limited social media exposure. Limits exposure to inappropriate or dangerous content, reducing risks of negative influences. The American Psychological Association (2023) found that

Center for Missing and Exploited Children's 2023 report highlights a 15% increase in cases of online exploitation involving youth. Controls excessive screen time and supports better health and offline engagement. South Korea's regulations on digital media (2021) limit screen addiction among minors.

The unintended consequences of age restrictions are that age verification systems such as age verification are often circumvented, making restrictions difficult to enforce. A U.K. study (2022) shows that 30% of teens bypass age checks with minimal effort. Age restrictions can limit digital education, leaving young people unprepared for responsible online interactions. Restricting access can isolate teens, preventing them from engaging in important social conversations. The 2017 Child Online Protection Framework emphasizes parents' role in digital guidance. Focus on restricting harmful content rather than age restrictions, allowing for safe and moderate use. France's 2022 selective restrictions on content such as gambling and violence protect young people without a complete ban. While age restrictions on social media can provide protection, a balanced approach that combines digital education, parental involvement, and targeted content regulation is more practical for protecting teens while allowing them to benefit from social media responsibly.

Transport Department Warns Parents Against Allowing Minors to Drive

JAMMU: The Jammu and Kashmir Transport Department has issued a stern advisory cautioning parents against allowing their minor children to drive two-wheelers or four-wheelers.

The department highlighted that such actions pose significant risks to public safety and are punishable under the Motor Vehicles Act, 1988.

According to the advisory, guardians or vehicle owners will be held accountable if a juvenile is found driving without a licence. Under Section 199A of the Motor Vehicles Act, violators can face up to three years of imprisonment, a fine of 25,000, and cancellation of the vehicle's registration for 12 months. Additionally, juveniles involved in such offences will be ineligible for a driving licence until the age of 25. The advisory further noted that custodial

sentences for juveniles would be handled under the Juvenile Justice Act, 2000.



The Transport Department urged parents to act responsibly and ensure minors do not drive, stressing that the safety of children and the general public is paramount.

This advisory comes a day after two minors died in a road rage near Tengpora in Srinagar city.

(JKCIP) for Jammu & Kashmir to rejuvenate agriculture sector which entails financing of 100 million USD through International Fund for Agriculture Development (IFAD) over the next 7 years.

In this regard CM requested Ministry of Finance to treat J&K at par with North Eastern States for availing incentives in respect of Externally Aided Project (EAP) loans and making J&K eligible for special lending arrangement under the EAP loans.

He requested the Finance Minister to consider Jammu & Kashmir for funding through the "Special Assistance to States for Capital Investment" scheme under which 50-year interest free loan would be provided to states for capital expenditure.

CM also informed the Finance Minister about the difficult fiscal situation being faced by J&K and requested the Ministry to provide additional central assistance of Rs 6000 crore to bridge the resource gap in the UT budget for FY 2024-25. Over the past few days, Chief Minister Omar Abdullah has held several important meetings with senior leaders and officials of the Government of India to address critical issues affecting Jammu and Kashmir.

Chief Minister during his current visit called on President of India Droupadi Murmu, Vice-President Jagdeep Dhankar and attended Power Ministers' conference chaired by UniMinister of Power to discuss J&K's priorities and challenges in the power sector.

These recent dialogues, culminating in today's meeting with the Finance Minister, reinforces the commitment to advancing the welfare and development of the people of Jammu and Kashmir.

He also criticized the "lateral entry" system for allegedly enabling the induction of RSS-affiliated individuals into top administrative positions.

In a pointed remark aimed at Prime Minister Modi's "Congress Mukt Bharat" rhetoric, Kharge noted that while the BJP aimed for 400-plus seats, it had now become reliant on "two crutches." He also responded to Modi's accusations against Congress, reminding him of the party's sacrifices for the nation and criticizing the glorification of Mahatma Gandhi's assassin, Nathuram Godse, by some BJP supporters. He expressed condolences to the bereaved families and prayed for their strength and resilience. "We ask Allah, the Almighty, to grant patience to the bereaved families and to guide us toward better practices to prevent such tragedies," he added.

Traffic Police: Parental negligence in spotlight

Senior Superintendent of Police (SSP) Traffic Srinagar, Muzaffar Shah urged parents and society at large to take greater responsibility for monitoring and guiding underage drivers.

Speaking to the media persons, SSP traffic highlighted the growing issue of minors driving vehicles without proper training or licensing. "Traffic violations come in many forms, but the involvement of minors in such cases is particularly concerning," he said. "This is not just a legal issue but a societal one, which requires the attention and cooperation of parents."

The SSP said that a focused campaign against minor drivers was underway, with vehicle seizures and on-the-spot actions being enforced. He highlighted the importance of parental vigilance, stating, "If we take care of our children, they will be safe, and so will society."

Appealing to parents, schools and the community to work together to ensure that minors were not allowed to drive unsafely or without proper licenses, the city traffic police chief said, "Accidents like these serve as a stark reminder of our collective responsibility. If we neglect these duties, we jeopardize the future of our children and society."

Among the recent road accidents include a tragic accident at Tengpora bypass in Srinagar on Thursday that claimed the lives of two minors.

Earlier, a 15-year-old boy too lost his life in a horrific road accident near Lawaypora highway, on the outskirts of Srinagar. RTO Kashmir: Legal & societal responsibility

Reacting to the tragic accidents that claimed multiple lives in road accidents, Regional Transport Officer (RTO) Kashmir said he has recommended invoking Section 199A of the Motor Vehicles Act, which prescribes up to 3 years of imprisonment for parents or guardians who allow minors to drive.

"This incident highlights a gap in both parenting and schooling, which play pivotal roles in shaping responsible behaviour," the RTO said. He called for collective efforts from parents, schools, and authorities to instill a culture of road safety and respect for laws.

"While we at RTO will invoke the compoundable Sections of

law like we have done in all such cases in past, this case will be recommended for invoking Section 199A of the Motor Vehicles Act which prescribes imprisonment of erring parents up to three years, awarded by judicial courts," the officer added.

The RTO stressed that beyond legal enforcement, parents must

The RTO stressed that beyond legal enforcement, parents must play a proactive role in ensuring minors do not access vehicles, while schools should inculcate a deeper respect for laws among students.

"We call upon parents to prevent minors from accessing vehicles and commit to intensifying enforcement to avoid such devastating incidents in the future. Let us work together to protect our children and uphold road safety for all," the RTO Kashmir appealed.

Tengpora horrific

of the investigation told the news agency—Kashmir News Observer (KNO) that yesterday's accident at Tengpora Bypass surfaced as an 'illegal car race' between two Thar vehicles, of which one was a modified, stating the investigation has been pressed into the particular case, with questioning on to the owner of the other vehicle.

"It surfaced as a car race between two Thar vehicles. One that met with an accident was driven by minors, and unfortunately 2 died while one of the injured recovered from the vehicle was summoned and counselled along with his parents many times," the top officer said.

According to the officer, one of the vehicles involved was found to be modified. The owner of the vehicle which managed to avoid the crash has been summoned for carrying out the investigations.

"The matter is under investigation," the officer said. "We are exploring whether minors were involved and whether the vehicle involved in the accident had prior violations or modifications that contributed to the incident."

The officer added that the incident has brought attention to rising cases of reckless driving and over speeding among minors. "This issue requires a multi-dimensional effort," the officer said. "Parents, schools, and the community must work together to instill discipline and safety awareness among youth."

The top traffic police cop said they were planning a joint meeting involving stakeholders like district administration, educational institutions, and coaching centers, with an aim to curb such incidents through collective efforts and targeted interventions

Locals in Pulwama thrown into confusion, MS District Hospital Pulwama says error seems unintentional

PULWAMA: After around 181 employees found absent at the District Hospital Shopian during a surprise inspection by concerned Additional Deputy Commissioner, several local urdu dailies have mistakenly written name of District Hospital Pulwama instead of Shopian health facility, thereby causing confusion among people. The news agency CNS learnt that people in Pulwama were astonished after several local urdu newspapers had linked the absence of employees at District Hospital Shopian to District Hospital Pulwama. "We had almost lost our trust reposed in the medical and para-medical staff of District Hospital Pulwama when we got to know from some urdu newspapers that the over 90% staff was absent at the health facility. However, it turned out to be not true later on as the staff was found absent at District Hospital Shopian," said locals in Pulwama. They said



that the seemingly inadvertent mistake of erroneously linking the issue to District Hospital Pulwama had created confusion among the people, whose trust had started to erode in the health facility. Meanwhile, 181 employees among a total of 198 were found absent by Additional Deputy Commissioner Shopian at District Hospital Shopian during his surprise inspection on 13th November's morning. Medical Superintendent of District Hospital Pulwama, Dr. Ab Gani Dar expressed regret over the misreporting in some urdu dailies and called it unfortunate. He also said that the error must have occurred unintentionally.

to bow out of Test cricket at end of England series

m Southee, New Zealand's legendary seam bowler, has announced that he will retire from Test cricket on his home ground in Hamilton next month, at the conclusion of England's tour of New Zealand.

Southee, 35, has claimed 385 Test wickets in 104 appearances to date, second among New Zealanders behind Sir Richard Hadlee (431), and is set to bring his career full circle, having debuted against England as a 19-year-old in Napier in March 2008. He will, however, make himself available for the World Test Championship final at Lord's in June if New Zealand qualify.

He recently played a key role in New Zealand's historic 3-0 series win in India, the first by a visiting team since 2012-13. Though he claimed just three wickets across the first two Tests, these included India's captain, Rohit Sharma, as they were bowled out for 46 in the series opener, and their top-scorer, Sarfaraz Khan, for 150 to the

Southee had handed the Test captaincy over

to Tom Latham prior to that series, and has yet to decide whether he wants to continue his whiteball career into New Zealand's post-Christmas tour to Sri Lanka.

"Representing New Zealand was all I ever dreamed of growing up," Southee said in his retirement announcement. "To play for the Black Caps for 18 years has been the greatest honour and privilege, but the time feels right to now step away from the game that has given so much to me.

"Test cricket holds a special place in my heart, so to be able to play such a big series against the same opponent my Test career began against all those years ago, and on three grounds that are incredibly special to me, seems the perfect way to end my time in the Black Cap.

In a storied career, Southee will be remembered as New Zealand's most prolific bowler in international cricket, with 770 wickets across formats to date, ahead of Daniel Vettori (696). No other bowler in international cricket has matched his feat of reaching 300 Test wickets, 200 ODI wickets and 100 T20I wickets.

His career-best performance of 7 for 33 came in the ODI format, a famous display against England at Wellington in the 2015 World Cup, which helped to propel his side to the first of two consecutive appearances in the World Cup final. And though New Zealand missed out on both occasions, agonisingly so in 2019, Southee was instrumental in their long-awaited slice of ICC silverware. At Southampton in June 2021, he claimed second-innings figures of 4 for 48 in their World Test Championship final victory over India.

He will also be remembered for his improbable batting prowess, with a total of 93 Test sixes to date-second only to Brendon McCullum among New Zealanders, and by a distance the highest ratio of sixes for any player with more than 2000 Test runs to his name. Nine of those came in his maiden Test in 2008, when he struck 77 not out in the fourth innings, still his highest score in Tests.
