







J&K private hospitals threaten to withdraw from SEHAT scheme by Mar 15

SRINAGAR: The Jammu and Kashmir Private Hospitals and Dialysis Centre Association has raised serious concerns over the future of the Avushman Bharat SEHAT scheme, warning that they may stop providing free treatment under the programme unless urgent reforms are introduced.



In a letter addressed to the CEO of the State Health Agency (SHA), J&K, accessed by the news agency-Kashmir News Observer (KNO), the association said that following extensive deliberations, they have concluded that the current contract-set to expire on March 15, 2025—is no longer viable under existing terms.

The letter highlighted several key grievances arising from the 9th Governing Council Meeting held on January 19, 2025, where certain decisions were made that the association considers detrimental to private healthcare providers. "The reservation of four surgical procedures for public hospitals, a 10% reduction in UT-specific incentives, and the implementation of HBP 2.2 instead of HBP 2022 are not in our interests. These measures are anti-private sector and will push many hospitals to the verge of bankruptcy, given that we have already been suffering for the past ten months," the letter stated. The association also expressed concern that the meeting failed to address longpending payments, interest on delayed reimbursements, or the review of unjustified deductions and claim rejections dating back to 2022. A member of the association told KNO that the government's plan to exclude key surgeries such as gall bladder surgeries, hemorrhoids, appendectomies and fissure surgeries from the scheme and restrict them to government hospitals is a concern."These surgeries constitute around 50-60% of total surgical cases.



SRINAGAR : REC Limited has announced robust financial results for the third quarter of FY25, with a 23% increase in net profit and an interim dividend of Rs 4.30 per share. The company's continued growth across all verticals, strategic interest rate adjustments, and efficient financial management have contributed to this impressive performance.

REC reported a standalone net profit of Rs 4,029 crore for Q3 FY25, up from Rs 3,269 crore in the same quarter last year, reflecting a 23% growth. The company's net interest income also saw a 19% rise, reaching Rs 4,930 crore from Rs 4,153 crore. Revenue from operations

The rally indicates Pakistan's involvement with terrorist organisations to fuel unrest in the region.Notably, Union Home Minister Amit Shah recently shared that after the abrogation of Article 370, terror incidents in J&K have reduced by 70 per cent.

UCC Cannot Become Political Instrument To Keep Country In Permanent Polarisation: Cong

NEW DELHI: The Congress on Thursday said a uniform civil code as envisaged in Article 44 of the Constitution can only come about after widespread discussion with the objective of building a genuine consensus and cannot become a political instrument designed to keep the country in a state of "permanent polarisation".

The opposition party's assertion comes days after the BJP government in Uttarakhand implemented the Uniform Civil Code(UCC) in the state and the Gujarat government formed a committee under a retired Supreme Court judge to assess the need for the UCC in the state as well as prepare a draft bill for the same.

Congress general secretary in-charge communications Jairam Ramesh said the Uttarakhand UCC is a poorly drafted piece of legislation that is highly intrusive. "It is not an instrument of legal reform in the slightest as there is nothing that addresses the actual concerns expressed with regard to family law over the last decade. It has been forcibly imposed as an integral part of the BJP's divisive agenda," Ramesh said in a statement.

Noting that the Gujarat government has announced the formation of a panel



to formulate a uniform civil code to be introduced in the state, Ramesh said this comes after the Uttarakhand government recently enforced a uniform civil code in that state that, however, exempts scheduled tribes.The 21st Law Commission appointed by the Modi Government had submitted its 182-page 'Consultation Paper on Reform of Family Law' on August 31, 2018, he said. "Para 1.15 of that consultation paper states the following: 'While diversity of Indian culture can and should be celebrated, specific groups, or weaker sections of

society must not be dis-privileged in the process. Resolution of this conflict does not mean abolition of all differences. "This Commission has therefore dealt with laws that are discriminatory rather than providing a uniform civil code which is neither necessary nor desirable at this stage.Most countries are now moving towards recognition of difference and the mere existence of difference does not imply discrimination, but is indicative of a robust democracy'," Ramesh pointed out. Subsequently, in a press note published on June 14, 2023, the 22nd Law Commission of India notified its intention to examine the subject of a uniform civil code, he said.

"This was being done, the press note clarified, on a reference sent by the Ministry of Law and Justice. However, the 22nd Law Commission was wound up on August 31st 2024 without submitting its report on the uniform civil code. The 23rd Law Commission was announced on September 3rd, 2024, but its composition has not yet been made public," he said.

Ramesh said the Constituent Assembly, while agreeing to what became Article 44 in the Constitution of India, could not have envisaged a large number of uniform civil codes passed in state legislatures in a piecemeal manner.

"Multiple uniform civil codes go against the very idea of what Article 44 states as a uniform civil code throughout the territory of India. A uniform civil code as envisaged in Article 44 can only come about after widespread debate and discussion with the objective of building a genuine consensus," he said. It cannot become a political instrument designed to keep the country in a state of permanent polarisation, Ramesh asserted.

Attempt To Push RSS Agenda **Rahul Slams Govt At Protest Against Draft UGC Regulations**

NEW DELHI: Congress leader Rahul Gandhi on Thursday alleged the UGC's draft regulations on the appointment of teachers and academic staff in universities and colleges was an attempt to push the agenda of the RSS that aimed to achieve its idea of imposing "one history, one tradition, one language" on the country.

Speaking at a protest against the draft University Grants Commission (UGC) regulations organised by the DMK here, the opposition leader in the Lok Sabha said the Rashtriya Swayamsevak Sangh's (RSS) aim was the eradication of all other histories, cultures and traditions of the country.

"That is its starting point and that is what it wants to achieve. It attacks the Constitution because it wants to achieve one idea which is its idea - one history, one tradition, one language on this country," the former Congress chief said.

"This attempt that it is doing with the education system of different states is just another attempt to push its agenda," Gandhi said.

"Each state has its traditions, history, language and that is why I keep saying that, in the Constitution, India is called a 'Union of States', that means all these histories, traditions, languages come together to make India the Union of States and so that is how we have to think about it," he said.

"We have to respect all the languages, all the cultures, all the traditions, all the histories and we have to understand where they are coming from," he said.

The Tamil people have their history, language, traditions, and they have had their struggles, he said.

"Doing this is an insult to the Tamil people and also to all other states where the RSS is trying to impose its hegemony," he said of the UGC's draft regulations.

Samajwadi Party chief Akhilesh Yadav also hit out at the BJP-RSS, alleging that they wanted to take over all the power of state governments.

"They want to make politicians servants of industrialists. We can never support the new education policy... I am supporting all the students here and the decision that you have taken. I am against the NEP (National Education Policy). I am against the BJP," he said.

The Congress has termed the draft UGC regulations on the appointment of teachers and academic staff in universities and colleges "draconian and anti-Constitution", and demanded that those be immediately withdrawn.

Hitting out at the Centre over the draft regulations, the Congress on Wednesday said the justification that the rules had been updated for compliance with NEP, 2020, did not withstand scrutiny and must be rolled back.

Congress general secretary in-charge communications Jairam Ramesh had said the State Higher Education Ministers' Conclave was hosted in Bengaluru by Karnataka minister MC Sudhakar, with six ministers or their representatives



from Karnataka, Telangana, Kerala, Tamil Nadu, Himachal Pradesh and Jharkhand (all-opposition ruled states) adopting a 15-point resolution on the UGC's "draconian" draft regulations.

"The constitutional principle of federalism is sacrosanct and the quality of higher education should be one of the ultimate endeavours of the Union Ministry of Education. NEP, 2020, does not prevail over either and the justification that the rules have been updated for compliance with NEP, 2020, does not withstand scrutiny," he had said.

Ramesh had asserted that these draft regulations must be rolled back immediately.

Opposition Protests Govt's Silence On Deportation Of Indians Staying Illegally In US

NEW DELHI: Several opposition MPs on Thursday slammed the government for the way Indians staying illegally in the United States were deported, questioning the treatment meted out to them.

A US military aircraft carrying 104 illegal Indian immigrants landed in Amritsar on Wednesday, the first such batch of Indians deported by the Donald



Trump government as part of a crackdown against illegal immigrants

The deportees claimed their hands and legs were cuffed throughout the journey and they were unshackled only after landing at the Amritsar airport.

Opposition parliamentarians, including Congress leaders Mallikarjun Kharge, Rahul Gandhi, Priyanka Gandhi Vadra and SP leader Akhilesh Yadav, protested the treatment meted out to the Indians by US authorities by staging a demonstration in Parliament complex. Some of the opposition leaders protested while wearing handcuffs.

Carrying placards like "Humans. Not prisoners", the opposition leaders said they would not tolerate the insult to India and raised slogans against the government like "Indians insulted. India won't stay silent".

"We, the INDIA parties, shall not tolerate the humiliation of Indian nationals.

Modi Government must come out with a detailed statement on the deportation and why did we not send our own planes to bring back the Indians, with dignity and respect, instead of a military plane landing on our soil," Congress president Mallikarjun Kharge said in a post on X.

Sharing a video of a deportee who was narrating his ordeal, Rahul Gandhi said

on X, "Prime Minister, listen to this man's pain. Indians deserve Dignity and Humanity, NOT Handcuffs".

Talking to reporters in Parliament complex, Congress Wayanad MP Priyanka Gandhi Vadra said Prime Minister Modi should answer why such treatment was given to those deported.

"I would say that a lot was talked about PM Modi and (Donald) Trump's friendship. Couldn't we send our plane to get them all back? PM should answer," she said.

"We have been hearing that Modi and Trump are good friends... Why did he allow this to happen? Is this how you treat people, that you send them back in chains. Prime Minister should answer, this is not the way,"

No Proposal At Present To Hike Salaries Of SC, HC Judges: Govt

NEW DELHI: There is no proposal at present to hike the salary and allowances of Supreme Court and High Court Judges, the government said in the Rajya Sabha on Thursday.

The last time their salary, allowances and pensions were hiked was in 2017.

"Presently, no proposal for enhancing pay, allowances and pension etc for the Judges of Supreme Court and High Courts is under consideration of the Government," Law Minister Arjun Ram Meghwal said in a written reply.

He said the pay, allowance and pension in respect of Judges of the Supreme Court and the 25 High Courts are governed by The Supreme Court Judges (Salaries and Conditions of Service) Act, 1958 and The High Court Judges (Salary and Conditions of Services) Act, 1954 respectively.

The salary, pension and allowances of judges of the higher were last revised with effect from January 1, 2016 following the implementation of the 7th Pay Commission recommendation by the government, through an amendment in both the laws.

The chief justice of India (CJI) gets Rs 2.80 lakh per month and judges of the Supreme Court and chief justices of the high courts get Rs 2.50 lakh a month.

Akharas Lower Their Flags, Begin Leaving Maha Kumbh

MAHAKUMBH NAGAR: The Maha Kumbh officially concludes on February 26, but it is time to move on for the 13 akharas that define the essence of the grand congregation. And the first sign of their departure is the lowering of their respective flags.

Following the final 'Amrit Snan' on Basant Panchami on Monday, the akharas have began leaving with a traditional 'kadhi pakoda' meal. The 13 akharas belong to different sects



of 'sanyasis' (worshippers of Lord Shiva), bairagis (followers of Lord Ram and Lord Krishna), and udasins (devotees of the five deities).

Nearly 150 seers of the Bairagi sect's Panch Nirvani Akhara began leaving on Tuesday. About 35 are left. "Once Thakur ji (the deity) is ceremoniously moved, the 'dharma dhwaja' (religious flag) will be loosened," said Mahant Raju Das of Shri Panch Nirvani Ani Akhara, associated with Hanuman Garhi in Ayodhya.

The Naga sanyasis of Juna akhara will start their departure on February 7.

"Our akhara will hold the 'kadhi pakoda' feast on February 7 after which the seers will begin loosening the ropes of the 'dharma dhwaja' and start their departure," Juna akhara's international spokesperson Shri Mahant Narayan Giri told PTI,

He said they will first head to Kashi, where they will stay till Mahashivartri. There, they will participate in a grand procession, visit Kashi Vishwanath, play 'Masane Ki Holi' (a unique Holi celebration among ascetics), and take a ritual dip in the Ganga before proceeding to their respective monasteries and ashrams.





Sources told the news agency Kashmir News Trust that the patient was admitted for a routine ENT procedure, but due to an alleged error, doctors instead carried out an irreversible surgical procedure, leading to the removal of the uterus.

The incident has led to widespread condemnation, with local health officials responding swiftly by sealing the operation theatre and initiating an inquiry.

Authorities said that if the inquiry confirms negligence or malpractice, those responsible could face criminal charges as well as civil lawsuits.

It has also informed that as per latest advisory issued by Kingdom of Saudi Arabia no person will be allowed to perform Haj on Umrah or Tourist Visa. Kashmir has considerably prioritised one of its basic mandates of environmental monitoring and pollution control in the past one year.

All the laboratories in Kashmir Division have been equipped with new machinery and environmental monitoring has been expanded and streamlined covering different aspects like water, air, microbiology and vehicular pollution.

J&K Pollution Control Committee has been monitoring the performance of all 10 Common Sewage Treatment Plants (CSTPs) operational in Kashmir Division having a combined capacity of 68.0 MLD (million litres per day), with the particulars of designed capacity, utilisation and quality of influent and effluent. Besides, the performance of all individual industrial STPs and Effluent Treatment Plants (ETPs) like those installed in hotels, hospitals and other water polluting industrial units are under constant observation.

Besides, important water bodies like Dal Lake, River Jhelum, Lidder, Sindh and wetlands are being constantly monitored for their water quality viz a viz parameters like DO, BOD, COD, Phosphates and pH.

In this regard, the capacity of JKPCC water laboratory located in Rajbagh Srinagar has been enhanced in terms of new monitoring and analysis equipment. During the current financial year (April 2024 to January 2025) total 1394 water samples were collected and analysed for various physicochemical parameters.

To study parameters like total coliform and faecal coliform in these water bodies, JKPCC has streamlined and improved the capability of its microbiology laboratory by installing latest equipment and increasing the manpower. During the present financial year, total 865 samples were collected and analysed.

JKPCC also regularly monitors the air pollution levels at its stations spread across Kashmir division with parameters being studied including PM 2.5, PM 10, NOx and SOx.

At present, 23 air quality monitoring stations are operational in Kashmir division while installation of 14 more stations in different districts of Kashmir valley is in the pipeline. A stateof-the-art Continuous Online Air Monitoring Station (COAMS) is already functioning in the Rajbagh campus of JKPCC which monitors and displays the air pollution levels in real time. During the present financial year, total 5303 air quality monitoring samples were analysed.

LICORICE TEA MAY HAVE HARMFUL SIDE EFFECTS, SAYS STUDY



Excessive consumption of licorice tea – a popular herbal beverage – may have health risks such as high blood pressure and reduced potassium levels, researchers claim.

According to a case study, published in CMAJ (Canadian Medical Association Journal), consuming tea made from licorice root resulted in severely elevated blood pressure in an 84-yearold man. "Excessive amounts of some herbal products can have harmful side effects," said Jean-Pierre Falet from the McGill University in Canada. "Products containing licorice root extract can raise blood pressure, cause water retention and decrease potassium levels if consumed in excess," said Falet. According to the researchers, the patient visited the emergency department for a high-blood pressure emergency.

His blood pressure was severely elevated, and he was suffering from a headache, light sensitivity, chest pain, fatigue and fluid retention in the calves.

After admission to hospital and treatment, the patient, who had a history of high blood pressure, told physicians he had been drinking one to two glasses daily of homemade licorice root extract called "erk sous" for two weeks prior.

Licorice tea is popular in the Middle East and parts of Europe, and erk sous is especially popular in Egypt during Ramadan.

"Physicians should consider screening for licorice root intake in patients with difficult-to-control hypertension," said Falet.

MEDITATION: A BOON IN THE AGE OF STRESS

WASHINGTON: Offlate, the people are increasingly adopting mindfulness and meditation as part of their daily routine to acquire peace of mind.

The benefits of mindfulness and meditation have been further highlighted by Bob Roth, CEO of David Lynch Foundation in his book named Stength in Stillness: The Power of Transcendental Meditation. "My memory was better, my sleep was better and I was less at unease after adopting the transcendental meditation", he writes.

The book further includes notes from celebrities including Oprah Winfrey, Gwyneth Paltrow and Russell Brand about how does the meditation offers clarity and focus.

According to Lynch, the meditation provides a sense of calm which no pharmaceutical company could duplicate.

The ways of experiencing mindfulness could vary as some experience it while scrubbing each utensil, or while lying in the bed or by simply noticing how the body feels.

The meditation does need not to have a formalised way of practice.

ABC news anchor Dan Harris also wrote a book, named 'Meditation for Fidgety Skeptics', in which he shared his own experience to highlight the benefits of meditation.

He further hosts a weekly show named '10 percent Happier', where he chats with celebrities and also layman who practice mindfulness.

Harris started practicing meditation after he confronted an on-air panic attack in 2004.

Another neuroscientist Davidson suggested how to balance between hectic work schedule and practicing meditation.

He suggested that one needs to part from his/her favourite gadgets and technology in order to achieve the benefits of meditation. Also, as one starts practicing meditation, he would be easily able to manage things in spite of being busy.

He further pointed out that more people have now started adopting a strict workout regime as the science has highlighted the benefits of doing workout to maintain a healthy body.

Chemicals in sunscreen may seep into the bloodstream: FDA study

Dermatologists always advise people to apply sunscreen before stepping out in the sun, but the results of a small clinical trial by researchers at Food and Drug Administration in the US have indicated that the UV-blocking chemicals in sunscreens seep into the blood cells. Though, there's no evidence as to what the molecules do inside the body, it is understood to have serious repercussions for sunscreen manufacturers going forward, and may change the options found in drugstore shelves.

"Everyone had always thought that because these are intended to work on the surface of the skin that they wouldn't be absorbed, but they are," mentioned Theresa Michele, director of the FDA's division of nonprescription drug products, and coauthor on the FDA-funded study. Her team found that it took only a few hours after the application of sunscreen for the photoprotective chemicals to infiltrate the bloodstream. The results, published in the journal JAMA, document that the researchers saw the same patterns in all 24 of the volunteers they recruited -12 men and 12 women, who were randomly assigned to apply one of four available sunscreens: two sprays, a lotion, and a cream. The participants applied their potions four times a day for four days to 75 percent of their bodies, roughly the skin visible in a bathing suit. For those four days, and three days after, researchers collected blood every few hours to be analysed for the presence of avobenzone, oxybenzone, octocrylene, and ecamsule which made for 30 samples in all.They discovered that while it took only a few hours for the UV-blocking chemicals to spike over the target, for three of the four formulations, those levels remained elevated through the end of the

decades ago, before anyone suspected they could be absorbed into the body. But now, thy suspect that it could be a problem if they do seep into the bloodstream.

However, it is understood that the effects on internal tissues would require more research in the long-term exposure and absorption of such chemicals in children and infants with their smaller ratio of body surface to overall size.

The research team also pointed out that it is required that the research move out of humidity-controlled confines to real-world environments, for example, a hot, sandy beach.

Similar research in India has suggested for a long time that sunscreens are more a luxury than a conscious need.

Women are less likely to be diagnosed with minor strokes than men when they show up in emergency rooms, claims a new study.

"Men were more likely to be diagnosed with transient ischemic attack (TIA) or minor stroke, and women were 10% more likely to be given a non-stroke diagnosis, is often a warning sign of another stroke. TIAs can also be associated with a permanent disability.

"Ourstudyalso found the chance of having another stroke or heart attack within 90 days of the diagnosis was the same for women and men," added senior author Dr Shelagh Coutts.



The fact that these sun-filtering molecules do penetrate into the circulation system does not on its own mean that such ingredients are unsafe. "There might be nothing, and that would be great," said Kanade Shinkai, a dermatologist at UC San Francisco and editor in chief of JAMA Dermatology.

"But the problem is that we just don't know." The bottom line, she said, is that although the evidence is irrefutable that the sun causes skin cancer, scientists know a lot less about sunscreen chemicals' relative risks and benefits.

Like other over-the-counter drugs, the FDA are trying to study sunscreens to make sure they don't mess up people's hormones, affect their reproductive systems, or cause cancer. Such safety testing has never been done on the active ingredients in sunscreen, because those chemicals were approved "It is important to have stringent safety assessment of their potential to produce local toxicity, such as irritation, sensitisation, phototoxicity, acutetoxicity, dermalabsorption/ penetration, sub-chronic toxicity, genetic toxicity, carcinogenicity and photocarcinogenicityetc.forthe sunscreen chemicals in this country," said a 2013 paper 'Safety and regulatory issues on sunscreen products in India' by Sujit Kumar and Roop Narayan Gupta from the Department of Pharmaceutical Sciences, Birla Institute of Technology, Mesra, Ranchi, Jharkhand.

They also stated that SPF rating for cosmetic products and drugs needs to be fixed and guidelines for label claims on these products should be developed.

Meanwhile, results of another study from 2008 titled 'Efficacy Study of Sunscreens Containing Various Herbs for Protecting Skin from UVA and UVB Sunrays' said, "scientifically verified that herbs are having enough potential to protect skin from harmful sun rays and it is worthwhile for consumers to use herbal sunscreens". for example, migraine or vertigo, even though men and women were equally likely to report atypical stroke symptoms," said Dr Amy Yu, lead author of the study.

According to the study published in the Journal of JAMA Neurology, men and women equally described atypical stroke symptoms such as dizziness, tingling or confusion which are not commonly thought of as related to stroke. Typical symptoms of astroke are sudden weakness, face drooping, or speech difficulties.

A TIA occurs when there is a temporary interruption of blood flow to the brain and

Researchers say while further study is needed, it is possible that patient reporting of symptoms, interpretation of symptoms by clinicians, or a combination of both, could explain the discrepancy in diagnosis among men and women.

"What's important to recognize in stroke is that the brain has so many different functions and when a stroke is happening, people can feel different things beyond the typical stroke symptoms. Accurately diagnosing TIA and stroke would change a patient's treatment plan and could help prevent another stroke from happening," concluded Yu.

Scientists identify new possibility for untreatable blood cancer

NEW DELHI: Scientists have discovered a new biomarker that could help to unlock the medical mystery behind

an untreatable blood cancer. QIMR Berghofer Medical Research Institute's Immunology

in Cancer and Infection senior scientist Professor Mark Smyth and clinician researcher Dr Kyohei Nakamura worked with colleagues in France to make the discovery about multiple myeloma.

Multiple myeloma grows in the bone marrow. The study

found a particular molecule called IL-18 suppressed the immune system to help create a bone marrow environment where the cancer was more likely to grow.

The study analysed the impact of IL-18 on 152 patients with multiple myeloma and found strong evidence that high levels of the molecule were associated with poorer survival.

Professor Smyth said IL-18 was responsible for promoting the immune suppressive function of a particular kind of white blood cell (granulocyte) in the bone marrow.

He said the resulting suppression hindered another kind of immune cell, known as a T cell, from doing its job of finding and destroying cancer cells.

"IL-18 has traditionally been recognised as a growth factor for immune cells because it was thought to promote the activity of the white blood or 'natural killer' cells that protect us from infection and cancer," he said.

"We've turned that thinking on its head with our discovery

that IL-18 is actually a pro-tumour factor, which causes virtually the opposite effect.

"IL-18 is critical in the progression of multiple myeloma by enabling one part of the immune system to suppress another." Professor Smyth said bone marrow IL-18 levels were a potential biomarker for predicting a person's disease prognosis as well as a potential target for new multiple myeloma treatments.

"Our research shows IL-18 could be an independent prognostic factor, which is very significant," he said.

"Practically speaking, the higher a person's IL-18 levels in the bone marrow, the greater the likelihood their immune system is suppressed. That means their prognosis is not as good."

Dr Nakamura said the findings could one day influence the way patients were treated for multiple myeloma. "If a person's prognosis is not as good because they have higher levels of IL-18 in the bone marrow, a doctor might choose to treat the patient more aggressively," he said. Dr Nakamura said the discovery was vital to building a better understanding of what caused inflammation in the bone marrow that leads to the development of multiple myeloma.

"Multiple myeloma creates a really inflammatory microenvironment inside the bone marrow," he said. "We want to understand the molecular processes underpinning that inflammation.

"This will help us to determine whether this biology is unique to the bone marrow and multiple myeloma, or whether it is also present in other cancers."

Dr Nakamura said there was even potential to one day work with pharmaceutical partners interested in targeting IL-18 with a unique antibody or small molecule inhibitors. He said a test for IL-18 in the bone marrow of patients would need to be performed at the point of diagnosis by taking a fluid sample from inside the bones.

An official informed the news agency-Kashmir News Observer (KNO) that the incident occurred when a vehicle carrying apple boxes was signalled to stop at the Naka set up by security forces in Baramulla. "I have seen the reports of excessive use of force and harassment of Makhan Din in police custody in Billawar leading to his suicide and the death of Waseem Ahmed Malla, shot by the army under circumstances that are not entirely clear. Both these

incidents are highly unfortunate and should not have happened," Abdullah said in a post on 'X', adding, "J&K will never be completely normalised and free of terror without the cooperation and partnership of the local population. "Incidents like these risk alienating the very people we need to carry with us on the road to complete normalcy," he said, adding, "I have taken up these incidents with the Union Government and insisted that both be inquired into in a time-bound, transparent manner.

They've also lost their last three matches and their best batter, Joe Root, to national duty, so SEC can consider themselves favourites to reach a third final, if not the title itself.

While they are a franchise that has often billed themselves as the epitome of an outfit that relies on team efforts, there was one individual who cannot be ignored: Marco Jansen.

Even before the match, he was already the leading wicket-taker for this season, and in SA20's history, and what we might call the only genuine allrounder in this tournament. None of the other bowlers who have taken 10 wickets or more have come close to scoring even 100 runs - Mujeeb Ur Rahman is closest with 55-and, naturally, none of the batters who have scored 100 runs have taken 10 wickets. In the Eliminator, Jansen also became the

level with Paarl's Bjorn Fortuin. He removed

Jansen did not find himself among the wickets again and the accolades from the Eliminator will go to others but his 12-ball 23, and his role in the 53-run sixth-wicket stand that ultimately proved match-winning with Aiden Markram, deserves special mention and got it from Markram. "It's small chip-ins (with the bat) that help us a lot," Markram

Jansen was in in the 17th over, when Tristan Stubbs was bowled by Imran Tahir, and SEC were 131 for 5, with a target under 170 still within JSK's grasp. They scored 15 runs off the next 11 balls and were 146 for 5 with two overs to go. Arguably, JSK made a tactical blunder by bringing back Lutho Sipamla, whose first three overs had cost 44 runs, but in the absence of many other options, they chose to back a player who has been good for them through the tournament.

Jansen made sure he had an ending to

sent Sipamla's first ball for six and then took 16 more runs off four balls he faced in that over, including ending it with another six. In total, 21 of Jansen's 23 runs came off the five he faced from Sipamla and his contribution pushed SEC over 180.

"His attitude to win is unmatched," David Bedingham told ESPNcricinfo before the Eliminator. "If you ask him if he went for 100 runs and took zero wickets in a Test match and scored a couple of ducks, I don't think he'd care unless we won. His desire to win is why he is who he is. It also helps that he's super talented. He's seven foot tall, he bowls quick, he bats well so that also helps. But I think it's his desire to win that makes him so special."

Markram echoed the idea that contributing to the team is the most important thing to Jansen. "He's a very quick learner and he absolutely hates losing. He just gets fired up every time he plays and he's marrying that fired up energy with better smarts," Markram said.

There's also something else Jansen does before every game which may actually be the secret to his success. "He eats a triple-decker pizza before every game on the bus," Markram said. "And a Coke. That's not a joke."

Stoinis makes shock decision to retire from **ODIs, out of Champions** Trophy

ustralia allrounder Marcus Stoinis has announced his immediate retirement from ODI cricket, ruling Ahimself out of the upcoming Champions Trophy. Stoinis, 35, will now focus on T20 cricket and remains available for Australia in that format. He scored 1495 runs in 71 ODIs at an average of 26.69 with a best of 146 not out against New Zealand in Auckland in 2017, and also took 48 wickets at 43.12 apiece.

"Playing ODI cricket for Australia has been an incredible journey, and I'm grateful for every moment I've had in the green and gold," Stoinis said. "Representing my country at the highest level is something I'll always cherish.

"This wasn't an easy decision, but I believe it's the right time for me to step away from ODIs and fully focus on the next chapter of my career. I've got a fantastic relationship with Ron [Andrew McDonald] and I've hugely appreciated his support. I'll be cheering the boys on in Pakistan."

Stoinis was part of the 2023 ODI World Cup squad and played an important role with the ball against Pakistan, when Australia began their fightback from a poor start to the tournament and ended it as champions.

However, he played only one more ODI after that World Cup, against Pakistan earlier this season, and did not receive a Cricket Australia contact last year, but was earmarked to play a role at the Champions Trophy in the absence of the injured Cameron Green.

"Stoin has been such a pivotal part of our ODI setup for the past decade," McDonald said. "Not only has he been an invaluable player but also an incredible person to have in the group. He is a natural leader, an exceptionally popular player and a great person. He should be congratulated on his ODI career and all of his achievements."

Stoinis recently played three matches for Durban's Super Giants in the SA20, where he suffered an injury in his second outing, on the back of the BBL with Melbourne Stars.
