NEET-UG To Be Conducted On May 4: NTA

NEW DELHI: The medical entrance exam NEET-UG will be conducted on May 4, the National Testing Agency (NTA) announced on Friday.

The application process for the the National Eligibility-cum-Entrance Test (NEET)-UG began on Friday and will conclude on March 7. It is the largest entrance exam in the country in terms of the number of candidates appearing for the test.

In 2024, a record more than 24 lakh candidates took the exam. The NTA conducts the NEET every year for admission into medical colleges. A total of 1,08,000 seats are available for MBSS course. Approximately 56,000 of them are in government hospitals

and about 52,000 in private colleges. Admissions to undergraduate courses in Dentistry, Ayurveda, Unani and Siddha also utilise the results of the NEET for admission.

Budget session 2025-26

Depts To Submit Money Bills For Approvals In Advance To Raj Bhavan

SRINAGAR: In a significant move, the Jammu & Kashmir Government has directed departments to submit money bills at least 21 days in advance for necessary approvals to the Lieutenant Governor's secretariat.

Ahead of the budget session, the Department of Justice, Law and Parliamentary Affairs has directed departments to submit money bills for necessary approvals 21 days in advance to Raj Bhavan for LG's recommendation.

"For proposals requiring the Lieutenant Governor's recommendation under Section 36 of the Jammu and Kashmir Reorganization Act, 2019, departments must submit them at least 21 days in advance for necessary approvals," reads the circular issued by the department, a copy of which is in possession of news agency—Kashmir News Observer (KNO).

Under the said provision of the Act, any bill or amendment related to taxation, government financial obligations, or appropriation of funds from

the consolidated fund can only be introduced in the Legislative Assembly with the prior recommendation of the Lieutenant Governor.

Access to judiciary has been 'weaponised' to promote anti-national sentiments: Dhankhar



BENGALURU: Vice President Jagdeep Dhankhar said on Friday that in recent years access to the judiciary has been "weaponised" in a way that is not happening in any other country.

He was speaking at the inauguration of the third edition of the Karnataka Vaibhava Literature and Cultural Festival held in Ranebennur, Haveri district.

Dhankhar said the divisive forces operate in different ways. "They have adopted new paths, and on many issues, you will see them turning to the judiciary".

"I am concerned because our Constitution has given every individual

a right within the judicial system. And what is that right? The right to seek the shelter of the court. But in recent years, money has been used to fuel

anti-national sentiments," he claimed. He further stated, "The forces challenging the nation and attempting to create a clash between nationalism and regionalism must be met with a strong response.

They seek to undermine our cultural heritage." Emphasising the need to preserve the nation's cultural philosophy. Dhankar said, "On this day, when I look to one side, I see India's progress through the eyes of the world and the people living within

They are like the feathers of a peacock dancing in the rain... But when I look at the peacock's feet, I become worried, forced to reflect, and then I feel the need for our cultural philosophy. We are trying to cut the very branch on which we thrive, on which we sit." Expressing deep concern over attempts to influence the electoral process within the country, the Vice President said, "In the country with the oldest democracy, the strongest democracy, the most progressive democracy, and the most vibrant democracy-and constitutionally the only country in the world with a democratic system at every level, be it village, city, state, or nation-there is an attempt to influence our electoral process in a manner it should not be influenced.

Referring to India's economic progress, he said, "The world's leading institutions, such as the IMF, World Bank, and others, state that if there is any shining star in the world for investment, opportunities, and showcasing talent, it is India. India is considered a global favourite destination for investment and opportunities."

ACB Serves Notice To Kejriwal Over Claims Of BJP Poaching AAP Candidates Ahead Of Delhi Poll Results

NEW DELHI: The Delhi Anti-Corruption Branch (ACB) on Friday served a legal notice to AAP chief Arvind Kejriwal, seeking details and evidence regarding his allegations that the BJP attempted to bribe his

accusing the BJP of offering bribes to 16 AAP candidates to switch sides.

The notice asks Kejriwal to confirm whether the tweet was made by him and provide



party candidates ahead of the Delhi Assembly election results.

The legal notice comes just a day before the counting of votes is scheduled to take place for the Delhi Assembly elections held on February 5.

The notice, delivered at Kejriwal's 5, Ferozeshah Road residence, has intensified the political tensions between AAP and the BJP, with the former calling it a politically motivated

The ACB's notice specifically

detailed information on the alleged poaching attempts.

It also seeks the names of the 16 candidates who received phone calls, the phone numbers of those who contacted them and any supporting evidence to substantiate these claims.

"Provide the evidence and proof to support the claim/ allegations of the offer of a bribe levelled by you and your party members on various media/ social media platforms," the ACB notice reads.

The notice also warns of potential legal action, asking Kejriwal to explain why those spreading such allegations should not be prosecuted for creating "panic and unrest" among the people of Delhi.

"Explain as to why an appropriate legal action should not be taken against the persons spreading such information on media/social media platforms, which is tantamount to creating panic and unrest situations amongst the people of Delhi," the notice reads.

Earlier, high drama unfolded as AAP strongly criticised the ACB's action, calling it an attempt to intimidate the party ahead of the election results.

AAP's legal cell chief Sanjeev Nasiar alleged that the ACB initially had no legal notice and was sitting outside Kejriwal's house without clarity on their

"They did not have any legal notice at first. After one-anda-half hours, they served us with a notice. This drama is orchestrated by the LG office in collusion with the BJP. The officers were under pressure," Nasiar claimed.

Hospital admissions worth Rs 1.19 lakh cr authorised under AB-PMJAY: JP Nadda

NEW DELHI: A total of 8.59 crore hospital admissions worth Rs 1.19 lakh crore have been authorised under the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) as on January 1, Union Health Minister J P Nadda said on Friday.

Underlining that steps are taken for prevention and detection of different kinds of fraud in the implementation of the scheme, he said suitable actions, including de-empanelment of 1,114 hospitals, levying penalty worth Rs 122 crore on 1,504 errant hospitals and suspension of 549 hospitals have been taken against fraudulent entities.



In a written response to a question in Lok Sabha, he said the National Anti-Fraud Unit (NAFU) has been established at National Health Authority and works in close coordination with State Anti-Fraud Units (SAFU) to investigate and take joint action against issues related to fraud and abuse.

Further, any claims by empanelled hospitals found to be suspicious by NAFU are withheld until proper scrutiny by SAFU teams, including field verification where necessary.

As on February 4, nine doctors and 71 hospitals have been suspended under the scheme in Gujarat. Additionally, two hospitals have been de-empanelled and one hospital has been blacklisted.

Can't Drag Family Members In Domestic Violence Cases In Sweeping Manner: SC



NEW DELHI: Observing domestic violence cases need to be handled with utmost sensitivity, the Supreme Court on Friday said family members of an accused cannot be implicated without specific charge in the criminal case in a sweeping manner.

A bench of Justices B V Nagarathna and N Kotiswar Singh said in matrimonial disputes, emotions run high, and there may be a tendency to implicate other members of the family who do not come to the rescue of the complainant or remain mute spectators to any alleged incident of harassment. "In criminal cases relating to domestic violence, the complaints and charges should be specific, as far as possible, as against each and every member of the family who are accused of such offences and sought to be prosecuted, as otherwise, it may amount to misuse of the stringent criminal process by indiscriminately dragging all the members of the family," said the court.

The observations reflected in a judgement

that quashed the criminal proceeding against the family members against whom a woman filed a domestic violence case aside from her in laws.

The Telangana High Court had refused to quash the proceedings against the maternal aunt and cousin of the main accused.

The top court said it couldn't constitute a criminal act without there being specific acts attributed to the family members.

When tempers run high and relationships turn bitter, there is also a propensity to exaggerate the allegations, which does not necessarily mean that such domestic disputes should be given the colour of criminality, it added. "There may be situations where some of the family members or relatives may turn a blind eye to the violence or harassment perpetrated to the victim, and may not extend any helping hand to the victim, which does not necessarily mean that they are also perpetrators of domestic violence.

Fire At Camp In Maha Kumbh Mela, None Injured

MAHAKUMBH NAGAR: A fire broke out at the ISKCON camp in Mahakumbh Nagar on Friday and quickly spread to over a dozen nearby camps, leaving them gutted, officials said.

No casualties have been reported. Chief Fire Officer Pramod Sharma told PTI that the blaze was reported at 10.35 am after which around a dozen water tenders were rushed to the spot.

"Upon receiving information about the fire at the ISKCON camp in Sector 18, fire tenders were immediately dispatched. The fire was contained fully in half an hour," he said.

The fire spread to over a dozen nearby camps, causing significant damages. Officials said the cause of the fire and the damage incurred due to it were being

SRINAGAR: Jammu and Kashmir Bank customers had to face tremendous hardships as the mobile banking has gone for a toss from the last two days, thus leaving the customers to lurch at

According to the news agency—Kashmir News Observer (KNO), the customers of J&K Bank said that the mobile banking application (MPay)&GPay and Other Digital services are lying defunct from the last two days after the fresh version of the application was updated.

"We have never witnessed such a situation in the past as it is for the two consecutive davs that I am not able to use mobile banking," Suhail Ahmad, a businessman from Srinagar said.

He added that the users are not even able to log into it. "We are surprised to see that the authorities concerned don't even bother to fix the error for the betterment of the users," he said.

Another customer informed KNO from Ganderbal, Agib Rasool that they are being forced to spend a lot of time visiting the banks for their work, which otherwise was possible to be done at home. "We want the concerned authorities to fix the errors at earliest," he said.

Many of the netizens have also expressed their resentment and highlighted their sufferings due to the defunct mobile banking application.

"IK Bank puts digital transaction facilities includ-

back to withdrawals, cheques, pay in slips for transaction now," a netizen wrote in his Facebook post

"While heading to the petrol pump today, my Gpay & Mpay decided to act up, I had my ID card on



hand to make it through! It's very unfortunate that JK Bank doesn't provide us with the necessary facilities," a netizen wrote.

"JK Bank's non-functional services (both Mpay Delight and JKBank UPI) have failed me for two days, causing repeated embarrassment, Now, while paying my water bill, it disappoints me yet again,two back-to-back embarrassments for I&K Bank, First at the salon when UPI didn't work, and now when I tried sending money to someone, I failed again because the receiver's bank is #JKBank. Despite charging unnecessary and frequent fees, their servers are always down." Gaznafar wrote on X.

Pulmonologists calls for regulating mobile phone usage to prevent addiction, mental fatigue

SRINAGAR: Renowned pulmonologist Dr Naveed Nazir Shah has called for regulating mobile phone usage, particularly among children and the elderly, to prevent addiction and mental exhaustion.

Kashmir, the noted pulmonologist said that respiratory illnesses are common due to the region's climatic conditions. "Cold and dry air in winter often worsens symptoms such as cough, breathlessness, chest tightness and wheezing, particularly for individuals with pre-existing respiratory conditions like



Speaking to the media in Srinagar, Dr Naveed, according to the news agency-Kashmir News Observer (KNO), acknowledged the importance of the digital revolution, noting that mobile phones and the internet have become essential for official work, studies, and communication. However, he warned that excessive screen time is leading to addiction, affecting not only children but also retired individuals who spend prolonged hours on their devices.

He highlighted the growing influence of artificial intelligence, saying that an overreliance on AI-driven content is contributing to mental fatigue. Urging parents to monitor their children's screen time, he recommended the use of parental controls to track online

Dr Naveed underlined the importance of balanced mobile usage and called for greater awareness of the potential harms of excessive screen exposure, especially among individuals under 18.

Addressing health concerns specific to Jammu and

asthma, bronchitis, and chronic obstructive pulmonary disease (COPD)," he said.

These respiratory issues, Dr Naveed said, are due to multiple factors, including climatic conditions, smoking and high pollen concentrations due to Kashmir's greenery. "During the spring season, pollen levels in the atmosphere rise significantly, leading to a higher incidence of allergic diseases," he said.

With winter coming to an end and spring approaching, Dr Naveed cautioned that allergy-related issues will likely increase. He advised patients to follow their doctor's recommendations carefully, saying that adhering to treatment protocols can help keep symptoms under control and prevent severe complications.

"We often see patients seeking treatment only when symptoms appear. However, those suffering from chronic respiratory conditions should follow a continuous treatment regimen, just like diabetic and hypertensive patients do," he added—(KNO)

Police arrest 3 peddlers in Anantnag, Shopian



FDCL Employees Deprived of Pay Commission Benefits and Allowances, Demand Urgent Government Intervention

JAMMU: Employees of the Forest Development Corporation Limited (FDCL), formerly known as the Forest Corporation, are facing severe financial hardships due to the non-implementation of successive pay commissions and the denial of essential allowances.

Despite its conversion into FDCL in 2019, employee benefits have seen no improvement, leaving the workforce struggling with low wages and stagnant career growth.

While employees of other government corporations have received pay commission benefits, FDCL employees remain excluded. The 6th Pay Commission (2010) and 7th Pay Commission (2016) were implemented for government employees, and with the 8th Pay Commission now in place, FDCL workers have yet to receive a single pay revision since the corporation's restructuring in 2019.

Aggrieved employees said, adding to our distress, FDCL employees said they are also deprived of child allowances, making it difficult for them to afford basic educational necessities for their children. Additionally, SRO-43 cases, pending since 2019, remain unresolved, leaving many deserving employees and their families in uncertainty.

Another major concern is the stagnation in career growth. Despite FDCL operating with only 1,300 employees, the majority belonging to Class-IV categories, many workers have remained in the same positions since 1990. The Departmental Promotion Committee (DPC) has not convened since 2013, depriving employees of long-overdue promotions.

The financial hardships faced by FDCL employees have led to growing frustration, with workers demanding immediate government intervention. They have urged authorities to implement the 8th Pay Commission, provide child allowances, resolve pending SRO-43 cases, and conduct the DPC to grant promotions.

FDCL employees have warned that if their demands are not met soon, they will intensify protests and consider legal action to secure their rightful dues. The government is now under pressure to address these grievances before the situation escalates further.

43 judicial posts vacant in J&K, Govt informs Parliament

SRINAGAR: The Union government has informed Parliament that Jammu and Kashmir currently has 43 vacant positions in district and subordinate courts.

The figures were presented in response to a query regarding pending cases in courts and judicial vacancies across the country by the Minister of State (Independent Charge) of the Ministry of Law and Justice; and Minister of State in the Ministry of Parliamentary Affairs, Arjun Ram

According to official data, the sanctioned strength of judicial officers in Jammu and Kashmir stands at 322 as of February 3, 2025. Of these, 43 positions remain unfilled.

Over the past five years, the number of sanctioned positions has increased. In December 2020, the sanctioned strength was 296, with 41

By December 2021, the sanctioned strength rose to 300, while vacancies increased to 59. In December 2022, the sanctioned strength reached 314, with 91 vacancies. By December 2023, the number of sanctioned posts had increased to 317, with 94 vacancies.

The latest data shows that while the sanctioned strength has grown to 322, the number of vacant positions has decreased to 43.

J&K gets three herbal garden projects worth 7.42 crore, Centre informs Parliament

SRINAGAR: The Government of India (GoI) informed Parliament on Friday that Jammu & Kashmir has been sanctioned three herbal garden projects in the past three years.

The Minister of State (Independent Charge) for the Ministry of AYUSH, Prataprao Jadhav, according to the news agency-Kashmir News Observer (KNO), said that these projects aim to promote medicinal plant cultivation, boost research, and strengthen the region's traditional medicine ecosystem.

The Government Unani Medical College, Ganderbal, Islamic University of Science and Technology, Awantipora, and Government College of Education, Jammu, have been selected for this initiative.

Between 2021-22 and 2024-25, the Union Territory (UT) of J&K received rupees 7.42 crore for herbal garden projects. The funding has shown an upward trend over the years, indicating increased government focus on this sector.

In 2021-22, rupees 1.83 crore was allocated, followed by rupees 1.12 crore in 2022-23. The amount increased to rupees 1.48 crore in 2023-24 and reached its highest in 2024-25 at rupees 2.99 crore.

Jammu & Kashmir submitted nine proposals for herbal gardens, of which three were sanctioned, resulting in an approval rate of 33 per cent, the minister said—(KNO)



Economic Determinism in Marriage: The Role of Hypergamy and Hypogamy in Kashmir

arriage is a pivotal social institution, traditionally characterised as the union of two individuals, most often of opposite sexes. However, it is essential to acknowledge that the concept and practice of marriage have experienced remarkable transformations across different cultures and regions worldwide. The legalisation of same-sex marriage in numerous countries signifies a critical expansion of the marriage definition to incorporate unions between same-sex couples, illustrating an increasing acceptance of diverse sexual orientations. This institution transcends the romantic relationship between partners; it also intertwines the lives of their respective families, significantly influencing social dynamics and fostering community ties. This interconnectedness underscores a universal principle: marriage is not only a binding agreement between partners but also encompasses their broader familial networks, thereby affecting the social fabric of the community at large.

My primary focus in this exploration is to delve into the concepts of hypergamous and hypergamous marriages, especially within the cultural and social milieu of Kashmir. We must establish clear definitions for these two distinct terms to investigate this topic thoroughly. Hypergamy refers to the practice where an individual, typically a woman, chooses to marry someone of a higher socioeconomic status. This decision is often motivated by the desire to elevate one's social standing and improve life circumstances within the community. Conversely, hypogamy involves marrying someone of lower socioeconomic status, which may result in a perceived downward shift in social standing for the marrying partner. The core difference between these two marriage types frequently resides in the intentions and motivations of those involved—whether an individual seeks to enhance their social status or marry for more personal, cultural,

Understanding these intentions becomes paramount as it illuminates the socio-economic factors and cultural norms that mould marital choices in Kashmir. It also provides insight into how these practices affect relationships and broader societal structures within the region. For example, suppose a young man aspires to marry a woman who is seen as possessing a higher socioeconomic position within society. In that case, this scenario falls into the category of a hypergamous marriage. In contrast, if he aims to unite with a woman from a lower socioeconomic background, this union is categorised as hypergamous.

In pursuing this analysis, I plan to employ deductive reasoning, drawing from various case studies to illustrate the correlations between success and divorce rates as they relate to these two marriage systems. By examining the underlying motivations and outcomes associated with hypergamy and hypogamy, I aim to provide a more profound understanding of how these marriage practices influence personal relationships and societal dynamics in Kashmir. This exploration will highlight the implications of socioeconomic status on marital stability and contribute to a broader dialogue regarding the evolving nature of marriage within the region's rich cultural tapestry.

Upon reviewing several case studies, I have deduced that when a man marries a woman of higher socioeconomic status, she often does not receive the same level of social acceptance or treatment from the man's family and relatives. For instance, if a woman possesses advanced qualifications and holds a job, this scenario can raise pointed questions about the couple's compatibility, reflecting traditional beliefs about gender roles. In the context of Kashmir, many women who contribute income do not regard this as a liability impacting family support; traditionally, family's survival rest with the male. Nevertheless, many women

This dynamic may prompt men to adopt more conservative, traditionally masculine attitudes driven by the perception of their subordination regarding financial contributions. In conservative enclaves of Kashmir, the more progressive mindset exhibited by these women can be viewed unfavourably, often resulting in judgment regarding a man's masculinity and social standing. This ongoing tension between traditional expectations and the modern realities of marriage invites more profound reflection on the changing cultural landscape in Kashmir and the evolving roles of both men and women within it.

In various case studies examining marital dynamics, it has become apparent that issues often arise between couples after marriage, despite their initial compatibility during the pre-marital phase. This phenomenon is particularly notable within Kashmiri families, where traditional values and economic considerations significantly influence marital relationships. A typical scenario occurs when a woman pursues higher education and secures a job with a salary more significant than her husband's. Such

KUMBH: The Scientific Form of Creation and Destruction

The word Kumbh means Kalash (sacred pot). which symbolizes infinity and emptiness. Infinity is eternal, and the foundation of creation lies in particles. Everything in existence—whether solid, liquid, or gas—is composed of particles. A particle itself is made up of multiple molecules. In recent times, modern science has discovered the "God particle," known as the Higgs boson, through an experiment conducted in a 27-kilometer-long tunnel. However, thousands of years ago, the Vedas had already described a similar concept in the form of the Brahma particle.

The Nasadiya Sukta, found in the oldest Veda, the Rigveda, explores ancient human curiosity about the origins of the universe. It states that before creation, there was nothing—neither sky, earth, nor water. The verse compares Brahma to Hiranyagarbha (the golden womb) and explains that before creation, only Brahma existed, and everything emerged from him. Following the Vedas and Upanishads, the Puranas further elaborate on the cyclical nature of time, detailing the beginning and end of different Yugas (ages). According to the Puranas, one day of Brahma is equivalent to 4.32 billion years, which constitutes a Mahayuga

(great age) consisting of four Yugas. At the end of each Mahayuga, a cosmic deluge occurs, erasing civilizations and knowledge, paving the way for a new cycle of creation.

The concepts of creation and destruction are fundamental to current scientific theories regarding the origin of the Earth. The Earth's formation and transformation, including the development of continents, oceans, mountains, and plains, involve continuous cycles of creation and destruction. Over the past 150 years, modern science has traced the Earth's early formation to a massive landmass known as Pangaea and an oceanic expanse called Panthalassa. Due to natural geological forces, Pangaea experienced stress, tension, and contraction, eventually breaking apart and forming two major landmasses: Gondwanaland in the south and Angaraland in the north. Through gradual shifts, the present-day continents, oceans, rivers, and lakes emerged. Subsequent natural processes led to the formation of essential resources such as water, air, vegetation, minerals, and energy, sustaining life. Modern science acknowledges this as a gradual evolutionary process.

The Indian Knowledge Tradition

In Indian philosophical and spiritual traditions, the dual forces of creation and destruction are often represented as divine and demonic energies. This cosmic struggle is metaphorically described as Samudra Manthan (churning of the ocean). According to this legend, the great churning at the depths of the ocean (Panthalassa

in scientific terms) produced the Amrit Kalash (nectar of immortality), which sustains life. Thus, in Indian tradition, the Kalash is regarded as a source of creation and is an integral part of every sacred ritual.

The battle between divine and demonic



forces for the Amrit Kalash signifies the balance of opposing energies in the universe. From a scientific perspective, the universe exists within this perpetual interplay of creation and destruction. This cosmic struggle is commemorated through the Kumbh Mahotsav (Kumbh festival). The act of bathing in the sacred confluence of the Ganges during the Kumbh Mela has a strong scientific basis. The major bathing dates align with specific planetary alignments, particularly the positions of the Sun, Earth, and other celestial bodies. The festival begins with Snan Yoga on Makar Sankranti, marking the Sun's northward movement (Uttarayan).

The Kumbh Mela, held every 12 years, is

directly connected to the movement of celestial bodies. According to mythology, it took 12 days for the gods to transport the Amrit Kalash to

heaven. Since one divine day is equivalent to one human year, the cycle of the Kumbh aligns with this celestial timeframe. Einstein's theory of relativity supports this concept, emphasizing the variation of time with different frames of reference.

Ancient texts mention that the Sun, Moon, and Saturn played key roles in protecting the Amrit Kalash. Scientifically, the occurrence of the Kumbh is determined by the relative positions of these celestial bodies. The four main Kumbh Mela locations—Prayagraj, Haridwar, Nashik, and Ujjain—are chosen based on these astronomical calculations.

Scientific studies suggest that water is highly responsive to atmospheric vibrations, cosmic

energy, and local environmental conditions. Since the human body is composed of approximately 70% water, these natural vibrations influence our overall well-being. Ancient Indian sages had profound knowledge of liquid crystals and their electromagnetic properties. At Kumbh Mela sites, the Ganges water contains biologically active substances that exhibit liquid crystalline properties, enabling it to reflect specific wavelengths of light.

Moreover, the Ganges possesses remarkable self-purifying abilities. The presence of bacteriophages prevents harmful bacteria like E. coli from thriving in its waters. Minerals such as sulfur and phosphorus, naturally found in the river, have the ability to absorb atmospheric oxygen, keeping the water fresh for extended periods. This scientific phenomenon supports the belief that bathing in the Ganges during Kumbh enhances physical and spiritual well-being. The alignment of the Sun, Jupiter, and Moon during the Kumbh period creates positive magnetic effects, further contributing to overall health.

The Kumbh Mela is not merely a religious festival but a phenomenon deeply rooted in scientific principles. The alignment of celestial bodies, the impact of cosmic energy on water, and the self-purifying properties of the Ganges all contribute to its significance. Ancient Indian wisdom, as recorded in the Vedas and Puranas, aligns closely with modern scientific discoveries, reinforcing the idea that the cycles of creation and destruction are fundamental to the universe.

In the movies, heart attacks always happen in the most dramatic fashion, with the patient crushing under severe pain in their chest, at the site of their heart. But in reality, a heart attack could happen with not-so-evident signs. This makes it all the more risky,

32% deaths worldwide happen due to heart issues

One of the leading causes of deaths in the world, heart diseases claim close to 18 million lives annually. Most of the deaths associated with heart diseases are due to heart attacks and strokes.

Heart diseases also account for premature deaths. The World Health Organisation (WHO) says, one third of these deaths occur prematurely in people under 70

Out of the 17 million premature deaths (under the age of 70) due to noncommunicable diseases in 2019, 38% were caused by heart diseases.

In the latest report on top causes of death worldwide, the WHO had said that heart diseases were the number one killer among all non-communicable diseases.

What do other research studies say on the importance of exercise on heart health?

This is not the first time a study has talked about the effect of physical activity on heart health; though it might be one of the first studies done on such a massive scale and over a longer duration.

As per a 2010 study: More activity is associated with a lower risk of developing cardiovascular disease when compared to less physical activity. Although there may be a threshold over which activity levels convey greater risk, only those who are totally sedentary (i.e., "weekend warriors") or who have pre-existing

Apart from this, hypertension, diabetes, high cholesterol also influence heart diseases. "In addition, drug treatment of hypertension, diabetes and high blood lipids are necessary to reduce cardiovascular risk and prevent heart attacks and strokes among people with these conditions," the global health agency

warns the WHO.

The symptoms associated with heart diseases are too subtle to be observed. Only when it poses a risk to your health, does it become visible.

However, if you have a history of heart disease running in the family you need to be extra careful about your health. Also, those who have diabetes and/ or high cholesterol should also be careful about heart



Feeling nauseated

You may also experience mild indigestion and other gastrointestinal problems before having a heart attack. Older people, who are typically more prone to digestive issues, are more likely to dismiss these signs of heart attack as heartburn or any other food-related problem.

Nausea may also be accompanied by stomach pain. Some people may even experience vomiting. When you vomit, the contents of your stomach are forced up through the food pipe and out of the mouth. Vomiting is not healthy and you should see your doctor.

People may often dismiss these signs as symptoms of flu. However, even if similar, pay attention to your body and you may feel that this does not feel flu-like

Study says 150 minute of workout per week can lower risk of death; know details

A large scale study has revealed interesting facts

An extensive study in which more than 116,000 people had participated and were studied for over 30 years has found that exercising for even 150 minutes a week can lower the risk of death by a large extent.

What did the researchers find out?



The researchers found that physical activity, even in moderate duration, reduced the risk of all cause

The study saw a dip in mortality risk in those people who were engaged in physical activities 150-599 minutes per week. "Participants reporting 2 to 4 times above the recommended minimum of long-term leisure-time activity (150-299 minutes per week) or moderate activity (300-599 minutes per week), had 2 to 4% and 3 to 13% additional lower mortality," says a health report.

"The nearly maximum association with lower mortality was achieved by performing ≈150 to 300 min/wk of long-term leisure-time VPA, 300 to 600 min/wk of long-term leisure-time MPA, or an equivalent combination of both," the study found.

What do experts say?

"When it comes to exercise, more might be better. A new study found that people who followed the recommendations for physical activity lowered their risk of dying from any cause by as much as 21%. But health conditions are at risk for acute CV events with sudden, vigorous-intensity physical activity. "The gradual introduction of activity combined with physician evaluation prior to starting an exercise program may mitigate these risks," the study suggests.

A 2003 study published in Circulation journal of AHA stressed on the risk that a sedentary lifestyle poses on the human heart. "A sedentary lifestyle is one of the 5 major risk factors (along with high blood pressure, abnormal values for blood lipids, smoking, and obesity) for cardiovascular disease," the study said and had suggested walking, golf playing, calisthenics, gardening, cycling, swimming and climbing hills among various physical activities one should do.

What are the risk factors?

There are several risk factors for heart diseases. Overuse of tobacco, consumption of more salt, less consumption of seasonal fruits and vegetables, no physical activity, and overdrinking of alcohol are the risk factors associated with heart disease.

"The effects of behavioural risk factors may show up in individuals as raised blood pressure, raised blood glucose, raised blood lipids, and overweight and obesity,"



White or pink guava: Which is healthier?

xperts always suggest that seasonal fruits be added to one's diet. But, it must be noted that some fruits have many varieties, each having its own set of health benefits. One such fruit is the guava — which comes in pink and white varieties. Taking to Instagram, dietitian Shikha Kumari listed the benefits of having guava, and also the differences between the two.

Some of the health benefits of the light green, mildly sweet, and tangy fruit are:

*Helps to lower blood sugar levels.

*Boost heart health.

*May help relieve painful symptoms of

menstruation.

*Extremely good for the digestive system. *Good for weight loss.

*May have an anti-cancer effect.

*Helps to boost your immunity.

*Is good for your skin. Besides these benefits, guavas are also a good source of iron, calcium, and phosphorus, said Tanvi S Chiplunkar, senior dietician at Bhatia Hospital Mumbai, adding that guava is a "good source of dietary fibre" which is useful in maintaining blood sugar levels in diabetic people.

Now, let's find out which one should you pick "Pink guava has more water content, less sugar, less starch content and vitamin C, and less seed or is even seedless. On the other hand, white guava has more sugar, starch, vitamin C and more seed. The white-fleshed guava is high in antioxidants, but the red-fleshed variety has even higher," said Kumari.

She added that pink guava contains naturally occurring class of organic pigment called carotenoid, which gives carrots and tomatoes their distinct red colour. The concentration of caroteniod vary from

species to species depending upon which the colour of guavas also range from light pink to deep pink. The carotenoid content of white guava, on the other



hand, is insufficient to impart colour to its pericarp (pulp). Apart from above mentioned reason, white and pink guava also slightly vary in their taste, said

Agreed Chiplunkar and added that ripe guava or the pink ones should be avoided if you are suffering from regular cold and cough. On the other hand, raw ones are recommended to be taken to reduce mucous formation.

Pink guavas are frequently marketed as 'super fruits' as they are high in vitamins A and C, as well as omega 3 and omega 6 poly unsaturated fatty acids and dietary fibre. It is high in fibre and is beneficial to diabetics, said Dr Archana Batra, nutritionist, and certified diabetes educator.

What is the best way to consume them? It is best to have vitamin C-rich fruits as a whole so that you do not leave a cut piece for a long time in the open, advised Dr Rohini Patil, nutritionist, MBBS, and CEO of Nutracy Lifestyle. "Otherwise, its vitamin C content starts to decrease," she said. What should you keep in mind when buying

Best to buy small to medium-sized guavas such that you can eat one guava completely in one sitting, said Dr Patil.

Look for a guava that is free of blemishes, cuts, or bruises, as these can affect the flavour. "When purchasing guava, consider its quality and also know that many types of adulteration occur in guava, such as hard guava, green guava, desi guava, and so on. So, try to buy guava from a reputable store and pay attention to its quality. Use your fingers to gently squeeze the fruit to check for ripeness. You can also smell the fruit to get an idea about its sweetness," said Dr Batra.

He noted the expansion of the railway network, highlighting how connectivity had gradually improved from Pathankot to Jammu, then to Udhampur and Katra, with plans for the train to reach Srinagar this year. However, he said that apprehensions over Jammu's economy must be addressed from the adverse effects of shifting trade patterns, ensuring that the region continues to thrive as a commercial hub.

On tourism, the Chief Minister emphasized that Jammu had immense potential, particularly in religious and pilgrimage tourism. He said, "If marketed and promoted effectively, Jammu province can become India's top destination for religious tourism." Railway officials said a lot of passengers used to complain frequently that IRCTC staff did not offer them food even if they wanted to pay only because they had not opted for it during ticket booking.

"Often it happens that you do not select a pre-paid food option at the time of booking but circumstances arise during the journey that you want to purchase food. In such cases, the IRCTC staff refused to offer food even on paying its cost to such passengers.

"Now, as a policy matter, we have decided that non-optee passengers can also avail safe and quality food in the train," a railway official said.

The Board's circular urged IRCTC to take all necessary measures to ensure service of good quality hygienic food to the passengers in trains.

"Further, to avoid any inconvenience to passengers, IRCTC should ensure sale through trolleys within the regulated timings and no vending will be allowed after 2100 hrs (9 pm) or dinner service whichever is earlier," the Board said. (Agencies)

After a high level meeting of Union Forest Minister Bhupender Yadav and JK Forest Minister Javed Rana held last week, MoEFCC moved promptly and expedited Phase-III clearance of the projects on 1st February and accordingly JK Forest Department has approved diversion of requisitioned forest land subject to compensatory afforestation.

It is pertinent to mention that Javed Ahmed Rana, had recently met Union Forest Minister in New Delhi and urged him to expedite the clearance of pending cases under the Forest Conservation Act related to Jal Jeevan Mission, awaiting Phase-III clearance at the regional office, so that water infrastructure projects in forested areas can be implemented without further delay. The Union Minister had acknowledged the concerns raised and assured full cooperation from the central government.

To expedite completion of Jal Jeevan Mission that aims to provide tap water connection to every household, six projects that have been cleared included Water Supply Schemes Chigla Balota, Chakal, Tikri, Kund, Chatrari besides improvement and augmentation of WSS Lalli.

The other schemes for which approval has been granted for use of forest land included WSS Mand, Kaghote, Jadsarkote, Krimchi Deli Chak, Malhar, Katti and Demnote-Radnote in Udhampur Forest Division.

In Doda Forest Division, seven projects that gained clearance included WSSs Hanch Malna, Seel, Tantna, Aul Ugad, Mohalla, Jathali, and Jojote and three projects in Bhaderwah Forest Division including WSS Thalela, Southa and Puneja. The projects that have been cleared in Ramnagar Forest Division included WSS Balandh, Jandrari.

The Forest (Conservation) Act (FCA) 1980, a crucial law to conserve forests and biodiversity in India, requires obtaining prior clearance from the central government for any project or activity that involves clearing forest land. The Act helps in striking a balance between development and environmental protection by ensuring sustainable use of forest resources.

To prevent ecological imbalance and ensure sustainable growth, the government has initiated Compensatory Afforestation (CA) efforts against the forest diversion proposals and more than 21 hectare of degraded forest land will be covered under CA.

Forest Minister, Javed Rana, while commenting on the development said that the government is committed to provide safe and adequate drinking water through individual household tap connections and the forest clearance is a step in that direction.

Emphasizing the importance of these projects in addressing the water needs of the twin districts and other areas, he said "the forest clearance for these projects demonstrate our commitment towards fulfilling our objective of complete implementation of JJM in Jammu and Kashmir. We are dedicated to fostering growth in a way that benefits every section of society.'

He directed the authorities to undertake aggressive compensatory afforestation to arrest any ecological imbalance, ensuring sustainable growth and infrastructure development.

SRINAGAR: Sakshi Gupta, Principal Economist HDFC Bank while reacting to the RBI move said that in the inflation-growth trade-off the RBI tilted towards supporting growth by cutting the policy rate by 25bps today.

Australia have until February 12 to finalise their Champions Trophy squad, and they will have to make at least four changes to the initial 15-man squad they had named on January 13. Apart from Cummins and Hazlewood, they are also without Mitchell Marsh, who is grappling with a back injury and was ruled out of the tournament on January 31, and Marcus Stoinis, who announced on Thursday that he would be retiring from ODI cricket, removing himself from the Champions Trophy squad as a result after being selected in the original 15.

February 12 is also the day when Australia play the first of two ODIs against Sri Lanka in Colombo. They have added three quicks, Sean Abbott, Spencer Johnson and Ben Dwarshuis for those two games as well as legspinner Tanveer Sangha, spin-bowling allrounder Cooper Connolly and batter Jake Fraser-McGurk.

It's possible that two of the three quick bowlers could get into the Champions Trophy squad while Fraser-McGurk appears to be the like-for-like replacement for Marsh given he has not been bowling much recently in ODI cricket and was locked in to bat at No. 3. Connolly could be the replacement for Stoinis but there is now only one seam-bowling allrounder, Aaron Hardie, left in the current

It's a catch 22 situation for out-of-form Rohit: **Ashwin**

NEW DELHI: Former India spinner Ravichandran Ashwin feels it's a "catch-22 situation" for an out-of-form Rohit Sharma, and believes it's high time for the India skipper to silence his critics by letting his bat do the talking ahead of the upcoming Champions Trophy.

Rohit, who had dropped himself from the final Test of the Border-Gavaskar Trophy in Australia owing to poor form, scored just two runs in the first ODI against England in Nagpur on his return to international cricket after a month.

"This is not easy. If you look at it from Rohit's point of view, then obviously, it is frustrating for him. He wants to concentrate on the series. He thinks that I've done well in this format and I'd like to continue.

"I'm going into the tournament with a lot of confidence on the back of the One-Day tournaments that I've played." Ashwin said on on his YouTube channel.

"But people will ask questions. The ones who are watching will obviously ask. It's a catch-22 situation. You can't stop these questions. When will they stop? When he performs," he added.

Rohit has scored just 166 runs in his last 16 innings across formats.

"But as a cricketer, I understand what Rohit is going through. It's not easy. I pray that he does well and scores a century in this series," Ashwin said.

India won the first ODI against England in Nagpur by four wickets on Thursday. The second ODI will be played in Cuttack on Sunday.

Ashwin, meanwhile, was full of praise for Ravindra Jadeja, insisting that the all-rounder was "more gifted"

In the first ODI, Jadeja returned with impressive figures of 3 for 26 from his nine overs and later remained unbeaten on 12 off 10 balls while chasing the target.
