Sonia Gandhi Demands Govt To **Conduct Population Census At Earliest**

Sonia Gandhi on Monday asked the government to complete a population census at the earliest, claiming that around 14 crore people in the country are being deprived of the benefits under the food security law.

In her maiden Zero Hour intervention in the Rajya Sabha, Gandhi said beneficiaries under the National Food Security Act (NFSA) are being identified as per the 2011 Census, and not the latest population

The senior Congress leader called the NFSA introduced by the UPA government in September 2013 a landmark initiative aimed at ensuring food and nutritional security for the country's 140 crore population.

The legislation, Gandhi said, played a crucial role in protecting millions of vulnerable households from starvation, particularly during the Covid-19 crisis. She also said that the quota for the



beneficiaries is still determined based on the 2011 Census, which is now well over a decade old.

The National Food Security Act, 2013, provides for coverage of up to 75 per cent of the rural and up to 50 per cent of the urban population for receiving highlysubsidised foodgrains under the Targeted Public Distribution System (TPDS), which according to 2011 Census comes to about 81.35 crore.

At present, the government provides 5 kg of free foodgrains per person per month under the food security law.

independent India, the decennial census has been delayed by more than four years. It was originally scheduled for 2021, but there is still no clarity as to when the census will be conducted," she said.

Gandhi also claimed that the Budget allocations show that the updated census is unlikely to be conducted this year.

Around 14 crore eligible Indians are thus being deprived of their rightful benefits under the NFSA, she said.

"It is imperative that the government prioritises completion of the census as soon as possible and ensures that all deserving individuals receive the benefits guaranteed to them under the NFSA. Food security is not a privilege. It is a fundamental right," the former Congress chief said.

The period for distribution of free foodgrains under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) has been extended for five years from January 1, 2024.

Come say hello to Army's 'pet' project at Aero India 2025

BENGALURU: If you are curious to see how robotic dogs, also referred to as mules, work, just head to India Pavilion at Aero India 2025, till February 14 at Yelahanka Air Force Station, Bengaluru.

A pet project of the Indian Army, four-legged robotic prototypes have been making waves in the Republic Day and Army Day parades in the past year.

One of the handful of companies that have been exploring that space is a veteran-run Delhi-based defence startup, Deftech & GreenIndia Private Limited (DGPL).

DGPL's robotic dog/mule, Trakr, a quadruped robot that could manoeuvre through various terrains is participating at the Aero Show 2025.

"We got lucky because we got a direct invitation as we won the Innovation for Defence Excellence (IdeX) challenge in 2023 (launched by Prime Minister Modi in 2018 to foster innovation and technology development in defence and aerospace)," said Wing Commander Anshul Jain (Retd.), General Manager (Business Development)

Speaking to PTI, Jain said that they developed the technology together with Noida-based Addverb Technologies, which is backed by Reliance Industries.

Govt's 'U-Turn' On Amending **CNLD Act Aimed At Appeasing** French, US Firms: Cong

NEW DELHI: The Congress on Monday alleged that the Modi government's announcement that it will amend the Civil Liability for Nuclear Damage Act 2010 was a "U-turn" aimed at appeasing French and American companies since Prime Minister Narendra Modi is travelling to these two countries over the next

Congress general secretary in-charge communications Jairam Ramesh recalled that on February 8, 2015, the Ministry of External Affairs issued a booklet called 'Frequently Asked Questions and Answers on Civil Liability for Nuclear Damage Act 2010 and related issues'.

"Q3 said the following: 'Has India agreed to amend its Civil Liability for Nuclear Damage Act of 2010 (CNLD Act 2010) and the CNLD Rules of 2011? If not now, would they be amended in the future?' The Answer given to this Question by the Modi Govt then was the following: 'There is no proposal to amend the Act or the Rules.'," Ramesh said on X.

On February 1, 2025, the Finance Minister in her Budget speech announced that this Act will be amended,

"The U-turn has been done clearly to appease French and American companies since the PM is travelling to these two countries over the next four days," Ramesh alleged and pointed out that negotiations with these



companies have been going on for over 15 years.

"The Civil Liability for Nuclear Damage Act, 2010, was passed after considerable discussion both in and out of Parliament. As Leader of the Opposition in the Rajya Sabha, the late Arun Jaitley, had played an important role in crafting this law," the Congress leader said.

Large Number Of Devotees Head To Kashi, Ayodhya After Holy Dip At Sangam



PRAYAGRAJ/VARANASI/AYODHYA: Undeterred by challenges, lakhs of devotees thronging the Maha Kumbh for a holy dip at the Sangam are now heading towards Kashi and Ayodhya, officials said.

According to government data, an average of 1.44 crore people are taking a holy bath at the Maha Kumbh every day.

Dr Sushma, who arrived in Prayagraj from Ranchi with her son on Monday, told PTI, "After taking a dip in the Sangam and visiting the fair, we will head to Kashi for Lord Shiva's darshan and later proceed to Ayodhya."

Similarly, 74-year-old Ketari Devi from Ara, Bihar, said, "We saw on TV and mobile that this Maha Kumbh is happening after 144 years. After taking a holy dip, we will visit Kashi. Despite the huge crowd, we hope that we will get his darshan."

Nishant Abhishek, who travelled from Mumbai, added, "We've heard that apart from Prayagraj, Kashi and Ayodhya are also witnessing heavy crowds. But this is a rare opportunity to visit all the three places during Maha Kumbh. We will also go to Ayodhya."

ACP (Traffic) Shailendra Singh said that a significant number of devotees are heading towards Varanasi and Ayodhya after their visit to the Maha Kumbh. ADCP (Traffic) Kuldeep Singh said that compared to the 2019 Kumbh, the crowd this time is much larger even on regular days, leading to frequent traffic congestion.

Due to the heavy rush outside the Prayagraj railway station, the Northern Railway's Lucknow division has temporarily closed it for passenger movement from 1:30 pm on February 9 to midnight on February 14, an official statement said.

However, eight other railway stations in the Maha Kumbh area continue to operate regular and special trains.

As per government figures, over 44 crore devotees have taken a dip at the Triveni Sangam till February 9. On February 10, by 10 am, over 63 lakh devotees had performed the ritual bath.

On key bathing days, the footfall has been record-breaking. On January 13 (Paush Purnima), was 1.70 crore while on January 14 (Makar Sankranti) it was 3.50 crore, and 7.64 crore (highest so far) took dip in the Sangam on Mauni Amavasya.

With an average of 1.44 crore people taking a dip daily, authorities are managing an unprecedented surge of pilgrims in the holy city.

Over 1.02 crore people have taken holy dip in the Sangam till 4 pm, which included over 10 lakh Kalpwasis and 91.94 lakh pilgrims. The total number of devotees taking dip in the Sangam till date since the start of the Kumbh Mela has crossed 44 crore.In Varanasi, a large number of devotees returning from the Maha Kumbh are arriving to visit the Kashi Vishwanath temple, leading to massive crowds across the city.

Due to the heavy rush, authorities have imposed restrictions on the movement of four-wheelers in several areas, and vehicles from outside the city are being halted at designated parking zones on the outskirts, officials said.

District and police officials are conducting regular patrols, while CCTV cameras and drones are being used to monitor sensitive and crowded areas, said DCP (Kashi Zone) Gaurav Banswal.

Multiple 'rain baseras' (temporary shelters) have been set up across the city for visiting pilgrims, he added.DCP(Varuna Zone) Chandrakant Meena said that traffic diversions have been implemented at key locations to manage congestion.

External vehicles are being stopped outside the city, with parking facilities arranged on all major routes leading to Varanasi.

Tirupati Laddu Adulteration Row: 4 Arrested Suspects Sent To Judicial Custody Till Feb 20



Tirupati Laddu Adulteration Row: 4 Arrested Suspects Sent To Judicial Custody Till Feb 20

New Delhi, Feb 10: A Tirupati court on Monday sent the four accused arrested in connection with the alleged adulteration of laddus offered as 'prasadam' at the Sri Venkateswara Swamy Temple to judicial custody till February 20, officials said.

The CBI-led SIT arrested Vipin Jain and Pomil Jain, former directors of Bhole Baba Dairy, Apoorva Chawda from Vaishnavi Dairy and Raju Rajasekharan from AR Dairy which supplied dairy products to prepare the famed sweets, they said.

The arrested people were produced before a Tirupati court on Monday which sent them to judicial custody till February 20, they said.

According to sources, the special investigation team (SIT) constituted on the Supreme Court orders had found serious violations at every step of ghee supply, leading to the arrests.

The officials alleged that Vaishnavi Dairy officials secured tenders under the name of AR Dairy to supply ghee to the temple and were also involved in creating fake records to manipulate the tender process.

The SIT unearthed that Vaishnavi Dairy had falsely claimed that it sourced ghee from Bhole Baba Dairy while the authorities noticed that the latter did not possess the capacity to meet the temple board Tirumala Tirupati Devasthanam's demand, sources said.

On the orders of the Supreme Court, the Central Bureau of Investigation (CBI) set up a fivemember SIT in November last year to investigate the allegations of the use of animal fat in making the laddus that are offered as 'prasadam' to the devotees at the Sri Venkateswara Swamy Temple

The team comprised two officers from the central agency, two from the Andhra Pradesh Police and one from the Food Safety and Standards Authority of India (FSSAI), they said.

In its October 4, 2024, the apex court, after hearing the petitions by BJP leader Subramaniya Swamy and YSRCP Rajya Sabha MP YV Subba Reddy among others, said the probe into the allegation of using animal fat in making the laddu would be conducted by the SIT and will be supervised by the CBI director.

Andhra Pradesh CM N Chandrababu Naidu in September claimed that animal fat was used in preparing Tirupati laddus during the previous YS Jagan Mohan Reddy-led regime in the state, triggering a massive political row.

During an NDA legislative party meeting in the southern state in 2024, Naidu alleged that the erstwhile YSRCP government did not even spare Sri Venkateswara temple and used substandard ingredients and animal fats to make the laddus.

The allegations sparked a massive controversy across the country.

SRINAGAR:In a major fillip to Kashmir's famed handicrafts, the Handicrafts and Handloom Department, Kashmir, is on the verge of commissioning a modern Common Facility Centre (CFC) for Yarn Dyeing in the premises of Indian Institute of Carpet Technology (IICT) at



Constructed at a cost of ₹.2.59 Cr, the CFC shall adhere to all international norms and will dye different types of raw materials used in the handicrafts and handloom sector and go a long way in further improving the quality of craft products and boosting its saleability in niche global markets.

In a statement released here today, a spokesman from the Handicrafts and Handloom Department, stated that CFC will use chemical dyes which shall be 100% Azo-free and have all necessary plant and machinery installed, such as dyeing machines with different capacities, ranging from 5kg to 20 kg, for dyeing of silk, woollen, cotton and viscose yarn. "It will also have Water Softening System, Dryers, Hydro Extractors, Washing Machines and 02 Mini Boilers along with Effluent Treatment Plant," he added. The spokesman further stated that the CFC shall also have a Dye House catering to a daily capacity to dye 250 kg of silk, wool and cotton, all in hank form, in different types of dyeing machines. "The CFC shall also provide natural dyeing facility to 07 kg of Pashmina per day through Soft Flow Dyeing Machine," he added. The spokes man advised the concerned stakeholders to approach Director IICT for availing the dyeing facility for all types of yarn in hank form against nominal rates.

Kejriwal's AAP Falls, BJP Rises: What Led to the Shift?

Delhi, being the capital city, has always been under national and political scrutiny, particularly due to the governance model promised by Arvind Kejriwal's Aam Aadmi Party (AAP). However, after a decade in power, AAP faced mounting challenges, leading to a political shift where the Bharatiya Janata Party (BJP) reclaimed control after nearly three decades. The downfall of the Kejriwal-led government can be attributed to several key factors, including governance fatigue, corruption allegations, economic mismanagement, and failure to deliver on crucial promises.

Furthermore, the opposition's national-level coalition, the INDIA bloc, failed to shield AAP from its declining public trust. Despite positioning itself as an alternative to the BJP, AAP's inability to fulfill its commitments became a key reason for its electoral setback.

1.INCUMBENCY AND GOVERNANCE FATIGUE

When Arvind Kejriwal entered politics, he positioned himself as an activist challenging the system, with little prior experience in governance. His promises of clean and efficient administration resonated with voters, helping him defeat traditional political parties in Delhi. However, after ten years in power, AAP struggled to maintain its image as a party of change. The longer a party stays in power, the more it faces scrutiny, and Kejriwal's government was no exception.

Governance fatigue set in as many of AAP's flagship initiatives stagnated or fell short of expectations.

Kejriwal's leadership, which thrived on confrontation with the central government, started appearing counterproductive. Voters increasingly saw his constant conflicts with the LG and BJP-led Centre as obstacles to effective administration.

While AAP initially positioned itself as a pro-people government, it failed to transition from activism to sustainable governance, which contributed to its declining appeal.

2.CORRUPTION ALLEGATIONS: AAP'S ANTI-CORRUPTION **IMAGE TARNISHED**

AAP was built on the promise of transparency and zero corruption, but multiple corruption allegations damaged its clean image. The Delhi liquor policy scandal became a turning point:

The arrests of Kejriwal and senior AAP leaders over corruption charges in the liquor licensing scam severely impacted the party's credibility.

While AAP dismissed the allegations as politically motivated, the legal troubles, combined with a lack of strong defense,

For a party that rose to power on an anti-corruption plank, these developments reinforced public perception of hypocrisy, leading to a credibility crisis.

3.FINANCIAL MISMANAGEMENT: THE ECONOMIC BURDEN OF AAP'S FREEBIES

AAP's governance model relied heavily on subsidies for electricity, water, and education, but concerns over fiscal sustainability grew over time.

 $Reports indicated \, a \, decline \, in \, Delhi's \, revenue \, collection \, from \,$ 5.4% to 3.9% of GDP under AAP, making the economy increasingly dependent on central grants.

The 10,000 crore loan proposal from the National Small Savings Fund raised alarms over excessive borrowing and mis-

4.DECIINE IN EDUCATION STANDARDS: AAP's FLAGSHIP'S REFORM UNDER SCRUTINY

One of AAP's biggest claims to success was its education reforms, but closer analysis revealed severe shortcomings.

Between 2013-14 and 2017-18, government school enrollment dropped by 8%, contradicting AAP's claims of progress. Class 10 pass percentages plummeted from 98.81% to 68.90%,

raising doubts about the so-called "education revolution." Infrastructure improvements were showcased, but learning outcomes remained stagnant, failing to justify the massive spending on education.

The gap between perception and reality in education reforms hurt AAP's credibility, especially among middle-class voters.

5.INFRASTRUCTURE AND PUBLIC SERVICES: DEVELOP-MENT PROMISES UNMET

Despite being in power for a decade, AAP failed to resolve long-standing infrastructure issues, leading to widespread public dissatisfaction.

Kev Failures: Yamuna Cleaning: Kejriwal promised to clean the Yamuna by 2025, but pollution levels remained alarmingly high, with

little visible improvement. Air Pollution Control: Despite launching the Odd-Even scheme and distributing anti-smog guns, Delhi's air pollution remained among the worst in the world.

Traffic Congestion: The city's traffic jams worsened, and AAP's failure to integrate better public transport solutions only aggravated the problem.

Women's Safety: Despite campaigning on women's safety, crime against women continued to rise, with no substantial improvement in policing or surveillance.

While AAP promised a model city, Delhi's infrastructure and pollution crisis told a different story, frustrating both residents and businesses.

6.EROSION OF SUPPORT AMONG KEY VOTER GROUPS

AAP initially built its strong voter base among lower-income groups, Dalits, and auto-rickshaw drivers. However, recent elections saw a significant decline in their support.

Dalit voter backing fell from 53% in 2020 to 44%, indicating

Auto-rickshaw drivers, who were once strong AAP supporters, shifted loyalty due to unmet promises regarding fare

regulation and permits. The middle-class, once enthusiastic about AAP's governance, turned away due to deteriorating infrastructure and rising taxes. The erosion of these key voter blocs made it easier for BJP

7.BJP'S STRAEGIC CAMPAIGNING AND MODI FACTOR

The BIP played an aggressive and strategic campaign, targeting AAP's weaknesses effectively:

The Modifactor played a crucial role, with the Prime Minister's

popularity influencing urban voters. BJP highlighted AAP's corruption scandals and governance failures, shifting the narrative away from its own shortcomings.

The promise of better coordination between Delhi's administration and the Centre under BJP resonated with voters who were tired of constant conflict.

While BJP did not have a strong Chief Ministerial face, its centralized campaign strategy, backed by Modi's appeal, proved

CONCLUSION: A Political Shift with Long-Term Implications The downfall of AAP and the resurgence of BJP in Delhi signify a major shift in public sentiment. Several factors played a role in this transformation:

Incumbency fatigue and governance challenges weakened

Corruption scandals tarnished AAP's anti-establishment appeal. Failures in infrastructure, pollution control, and public services led to rising public frustration.

BJP's aggressive campaign and Modi's influence helped turn the tide in its favor.

This guilt may arise from historical injustices, war crimes, discrimination, or systemic oppression. It can apply to nations, ethnic groups, religious communities, or any collective entity.

While individuals within the group may not have personally committed the wrongdoing, they may still feel accountable due to their association with the collective identity. Addressing collective guilt is crucial for fostering healing, social justice, and reconciliation. One of the most effective ways to do so is by taking collective responsibility—a proactive approach where the responsible group, community, or leader acknowledges past injustices and takes action to rectify them.

Examples of Collective Guilt 1. Indian Context

Caste-Based Discrimination and Dalit Op-

The historical oppression of Dalits (formerly "Untouchables") has led to collective guilt among progressive upper-caste individuals and institutions.

Example of Collective Responsibility: In 2022. King Philippe of Belgium expressed deep regret for his country's brutal colonial past in Congo, marking a significant step toward accountability.

Ways to Address Collective Guilt Ef-

1. Taking Collective Responsibility One of the most impactful ways to address collective guilt is for the responsible group, community, or leadership to acknowledge the wrongdoing and actively work to correct it. This includes public apologies, policy changes, and reparative measures.

Example: The German government actively supports Holocaust remembrance events and museums to educate future generations.

Example: Australian Prime Minister Kevin Rudd (2008) formally apologized to the Aboriginal community for the "Stolen Generations" policy, where Indigenous children were forcibly removed

2. Formal Apologies and Acknowledgment Governments and institutions must officially recognize past wrongs and apologize to affected

Example: Canada formally apologized for the mistreatment of Indigenous people in residential schools in 2008

3. Reparations and Compensation Financial or material reparations can help affected communities recover from historical

with integrated solar panels. "It has been my dream since 2009 to establish BISA and create a unique solarpowered vehicle," said Mir, who transitioned from mathematics to engineering in pursuit of his passion. However, his journey was far

from smooth. "In my first attempt, I converted a car to run on hydrogen gas, but due to technical challenges, I later transitioned it to an electric vehicle," he explained.

Realizing the limitations of traditional



electric vehicles. Mir further refined his innovation to harness solar energy. "I delved deep into solar technology research, studying numerous journals and working tirelessly day and night to bring this vision to life," he added. Mir's design journey involved extensive study of luxury car aesthetics from the 1950s to modern-day models, ensuring RAY combined both style and state-of-the-art functionality. The car's aerodynamic shape minimizes wind resistance, enhancing overall performance, while its dual power system—a combination of solar energy and a rechargeable battery-ensures it can function effectively even in cloudy or snowy conditions.

"Ifully self-funded this venture, spending over 20 lakh to complete my dream project," Mir shared. Despite initial interest from Mahindra Group Chairman Anand Mahindra, a potential collaboration fell through due to technical constraints.

The five-seater vehicle features a charging port near the rear boot, but unlike conventional electric cars, RAY charges itself even in less favorable weather conditions. "This car isn't just about solar energy; it's about redefining how we think of sustainable transportation," Mir emphasized. (KINS)

high cholesterol increases your risk of heart disease and heart attacks.

Make following lifestyle changes to reduce cholesterol. 1. Lose weight

Be determined to reduce weight and bring it to normal. Well carrying some extra pounds – even just a few — contributes to high cholesterol. Losing as little as 5 to 10 percent of your body weight can help significantly reduce cholesterol levels.

Start by taking an honest, thorough look at your eating habits and daily routine. Sometimes we eat without being hungry, take a walk instead. As the saying goes, eat food like a medicine otherwise you will end up eating medicine like food.

If you pick up fast food for lunch every day, pack something healthier from home. If you're sitting in front of the television, try munching on carrot sticks instead of potato chips as you watch.

Take time and enjoy rather than "devouring" your food. Don't eat mindlessly.

And look for ways to incorporate more activity into your daily routine, such as using the stairs instead of taking the elevator. Take stock of what you currently eat and your physical activity level and slowly work in changes.

2. Eat heart-healthy foods

It is never too late. Even if you have years of unhealthy

eating under your belt, making a few changes in your diet can reduce cholesterol and improve your heart health.

Choose healthier fats. Saturated fats, found in red meat and dairy products, raise your total cholesterol and low-density lipoprotein (LDL) cholesterol, the "bad" cholesterol. As a general rule, you should get less than 7 percent of your daily calories from saturated fat. Instead, choose leaner cuts of meat, low-fat dairy and monounsaturated fats - found in olive, peanut and canola oils - for a healthier option.

Eliminate trans fats. Trans fat can be found in fried foods and many commercial baked products, such as cookies, crackers and snack cakes. CONSUME LESS OIL

Limit the cholesterol in your food. Aim for no more than 300 milligrams (mg) of cholesterol a day — less than 200 mg if you have heart disease or diabetes. The

most concentrated sources of cholesterol include organ meats, egg yolks and whole milk products. Use lean cuts of meat, egg substitutes and skim milk instead.

Select whole grains. Various nutrients found in whole grains promote heart health. Choose whole-grain breads, whole-wheat flour and brown rice.

Stock up on fruits and vegetables. Fruits and vegetables are rich in dietary fiber, which can help lower cholesterol. Snack on seasonal fruits. Experiment with veggie-based casseroles, soups and stir-fries. If you prefer dried fruit to fresh fruit, limit yourself to no more than a handful (about an ounce or two). Dried fruit tends to have more calories than does fresh fruit.

Eat foods rich in omega-3 fatty acids. Omega-3 fatty acids can help lower your LDL ("bad") cholesterol. Some types of fish — such as salmon, Other good sources of omega-3 fatty acids include walnuts, almonds and ground flaxseeds.

3. Exercise on most days of the week

Whether you're overweight or not, exercise can reduce cholesterol. Better yet, moderate physical activity $can \, help \, raise \, high-density \, lipoprotein (HDL) cholesterol,$ the "good" cholesterol. Remember that adding physical activity, even in 10-minute intervals several times a day, can help you begin to lose weight. Just be sure that you can keep up the changes you decide to make. Consider:

Taking a brisk daily walk during your lunch hour Riding your bike to work

Swimming laps

Playing a favorite sport

To stay motivated, join an exercise group. And remember, any activity is helpful. Even taking the stairs instead of the elevator or doing a few sit ups while watching television can make a difference.

4. Quit smoking

If you smoke, stop. Quitting may improve your HDL cholesterol level. And the benefits don't end there. Just 20 minutes after quitting, your blood pressure decreases. Within 24 hours, your risk of a heart attack decreases. Within one year, your risk of heart disease is half that of a smoker. Within 15 years, your risk of heart disease is similar to someone who never smoked.

5. Stop alcohol

Although moderate use of alcohol has been linked with higher levels of HDL cholesterol — but the benefits aren't strong enough to recommend alcohol for anyone who doesn't already drink. Drinking too much alcohol can lead to serious health problems, including high blood pressure, heart failure and stroke and many cancers Stop alcohol it leaves no organ un affected.

'I really broke it down into pieces' - Rohit reflects on comeback innings

ohit Sharma hasn't been in great form in Test cricket. But in ODIs, a format India haven't played a lot of over the past year, he remains one of the best in the business. A seven-ball 2 in the first ODI against England might have raised fears ahead of the Champions Trophy, but the 90-ball 119 in the second on Sunday in Cuttack should soothe some nerves. He might not say it in so many words, but Rohit did admit after the game that he "really enjoyed being out there, scoring some runs for the team." Not something he has done a lot of late.

"I really broke it down into pieces about how I wanted to bat," Rohit said in the post-match presentation after collecting his Player-of-the-Match award. "It's a 50-over format, a little longer than T20 format and a little shorter than Test cricket obviously - a lot shorter than Test cricket - but obviously you still need to break it down and assess what you need to do at regular intervals and that is what I kept doing. It was important for a batter who gets set, needs to bat as deep as possible and that was my focus."

Rohit's lack of runs in international cricket has been talked about a lot. In the last 12 months, he averages 23.70 in Test cricket, and that comes down to 10.93 since September 2024. On Sunday, though, he was in his element, playing the sort of innings that has made him a giant in the format.

"Looking at the pitch, when you play on black soil, [the ball] tends to skid on a bit, so it's important that you show the full face of the bat when you're batting initially," he said about his approach. "Once I got into my innings, I understood what they were trying to do: bowling into our body and trying to not give any room, keeping it on the stumps.

"And that's where I prepared my plan as well, what I wanted to do with those kind of deliveries, trying to access the gaps which were there. It's about understanding what you want to do as a batter and... obviously got very good support from [Shubman] Gill to start with and then Shreyas [Iyer] as well."
