NEW DELHI: Union Home Minister Amit Shah on Friday said the airstrikes were a fitting reply to Pakistan after the Pulwama attack that killed 40 Central Reserve Police Force (CRPF) personnel on this day in 2019.

Addressing the conclusion of the 38th National Games, Shah, according to the news agency-Kashmir News Observer (KNO), paid tributes to the CRPF personnel. He said the airstrikes that followed the Pulwama attack were Prime Minister Narendra Modi's "clear message" to terrorists.

"The airstrikes were a fitting reply," he said, adding that it sent a message to terrorists worldwide not to target our security forces or borders.

Shah added, "On this day in 2019, we lost 40 of our jawans in Pulwama. Their sacrifice strengthened the security of our borders. I pay my

heartfelt tribute to them. The airstrikes that followed were a strong response



from Prime Minister Narendra Modi against terrorism."

J&K sees 79% deficit rainfall

MeT Predicts No Significant Weather Activity Till February 18

SRINAGAR: With no forecast of any weather activity in Jammu and Kashmir, all the districts across the Union Territory have recorded a large

deficit of rainfall in the last one and a half months. Kathua tops the list with 97 per cent deficiency from January 01 to February 12, 2025.

According to details obtained by the news agencyKashmir News Observer (KNO), J&K has recorded a deficit rainfall of 79 per cent as against the normal precipitation of 140 mm, the rainfall of just 29.8 was recorded during the period.

As per the data, Jammu has recorded a deficit rainfall of 94 per cent while Udhampur and Samba districts have recorded a deficiency of 92 per cent each.

Srinagar, the summer capital of Jammu and Kashmir, has recorded a deficit rainfall of 82 per cent during the period while seven other places including Shopian, Reasi,

India Rules Out Third Party Role In Its Border **Row With China**

WASHINGTON: India has virtually ruled out any role for a third party in its border dispute with China after US President Donald Trump suggested that he was ready to extend support if it helps in the resolution of the lingering issue between the two neighbours.

At a media briefing, Foreign Secretary Vikram Misri said on Thursday (Friday IST) that New Delhi has always adopted a bilateral approach in dealing with these issues.

As a matter of long-held policy, India has been maintaining that there is no role for any third party in any of its bilateral issues or disputes with any country. "Your question about the offer to mediate between India and China, I think, I suspect you know the answer to this question," he said when asked about Trump's offer. "Whatever issues we have


NEW DELHI: India's medieval period was characterised by "maritime neglect" which happened due to historical circumstances and as a result its naval prowess began to fade, exacting a "huge toll", former president Ram Nath Kovind said on Friday.

However, the country's maritime heritage was not completely lost even during this "maritime dark age", he said while delivering a lecture hosted by the think-tank National Maritime Foundation (NMF) at Manekshaw Centre here.

"India's maritime heritage is a testament to its long-standing relationship with the sea, encompassing trade, culture and naval prowess. This rich legacy has significantly influenced our nation's history and its interaction with the wider world," he said.

The roots of India's maritime activities are about 5,000 years old and trace back to the Indus Valley civilisation, Kovind said.

"Our coastal heritage played such a defining role in our civilisation, social culture and economic history. In this light,



it is hard to believe that our medieval period was characterised by maritime neglect," he said.

This maritime neglect happened due to "historical circumstances", the former president said, without naming any dynasty or rulers of this era.

"During the medieval period, various

land-based empires gained prevalence. Many of such rulers had origins in landlocked regions and were more focused on managing vast land territories. Our collective consciousness started to overlook the sea as an avenue of power and prosperity. As a result, slowly but surely our naval prowess began to fade," Kovind lamented.

"For India, a historical maritime nation. this period... was indeed an anomaly. Nonetheless, this neglect of the maritime domain exacted a huge toll. It was one of the reasons why such huge land empires fell so easily to the European trading companies," he added.

The Vice Admiral KK Nayyar Memorial Lecture 2025, hosted by the maritime thinktank, was attended by Navy Chief Admiral Dinesh K Tripathi, former Navy chief and NMF's chairman Admiral (retd) Karambir Singh, senior officials of the Navy, scholars and several college students, besides the family members of the late vice admiral.

Kovind said Vice Admiral Nayyar was an excellent maritime strategist and a visionary who planted the seeds of naval research and strategic thinking across several institutions in India.

In his address, the former president also cited archaeological sites like Lothal, located about 400 km southwest of Ahmedabad in Gujarat, where excavations have unveiled an ancient "sophisticated dockyard".

The PIL also sought directions to all the district courts to issue notice to the complainants or victims at the time of taking of cognisance to enable them to exercise their right to be heard and participate



in pre-trial criminal proceedings.

While referring to an apex court verdict and the Code of Criminal Procedure amendments, the high court said there were sufficient rights given to the victim or complainant to effectively participate in pre-trial and trial proceedings if they so elected.

It had also referred to the Delhi High Court rules and said it was clear that a party to a criminal case was entitled to obtain copies of the record of the case upon filing of an application.

UPSC cheating case: SC extends protection to Puja Khedkar till March 17

NEW DELHI: The Supreme issued notice to the Delhi government Court on Friday extended till March 17 protection from arrest to former IAS probationer Puja Khedkar, accused of cheating and wrongly availing OBC and disability quota benefits in the civil services examination.

Abench of Justices BV Nagarathna and Satish Chandra Sharma directed



Khedkar to cooperate in the investigation.

During the hearing, Additional Solicitor General SV Raju sought rime to file reply in the matter.

Senior advocate Siddharth Luthra, appearing for Khedkar, submitted that police were not calling her for investigation and she was willing

The top court directed the ASG to file reply within three weeks.

The apex court on January 15 had

and the Union Public Service Commission (UPSC) on Khedkar's plea seeking anticipatory bail.

Khedkar is accused of misrepresenting information in her application for the UPSC civil services examination, 2022, for availing reservation benefits.

She refuted all the allegations

While dismissing her anticipatory bail plea, the high court found a strong prima facie case against Khedkar and said an investigation was needed to unearth the "larger conspiracy" to manipulate the system, and allowing the reprieve would adversely impact it.

"Anticipatory bail plea is dismissed. Interim protection from arrest is vacated," the high court said.

Khedkar was granted an interim protection from arrest when the high court issued notice on her anticipatory bail plea on August 12, 2024, and it was extended from time to time.

The high court observed the UPSC examination is the most prestigious test and the case was a classic instance of fraud committed on a constitutional body and the society.

The anticipatory bail plea was opposed by the Delhi Police counsel and the complainant, the UPSC, in the high court.

Constitutional Crisis In Manipur Forced Imposition Of President's Rule: Congress deny his direct responsibility for

NEW DELHI: The Congress on Friday said the imposition of President's rule in Manipur is a direct admission of the failure of the BJP governments at the Centre and the state, and asked Prime Minister Narendra Modi to apologise to the people there. In a post on X, Congress

president Mallikarjun Kharge said there is a Constitutional crisis in Manipur that forced the imposition of President's rule. "Narendra Modi ji, It is your party which has been ruling at the Centre for 11 years. It is your

party which was ruling Manipur

for 8 years. It is the BJP which was

responsible for maintaining Law

& Order in the state. "It is your government which is responsible for National Security and border patrol. The imposition of President's rule by YOU, suspending YOUR own party's government is a direct admission on how YOU failed the



people of Manipur," Kharge said. He said the government has imposed President's rule not because it wanted to, but because there is a Constitutional crisis in the state, as none of the NDA MLAs are willing to accept the

"baggage of your incompetence". 'Your "Double Engine" ran over the lives of the innocent people of Manipur! High time you now step in Manipur and listen

to the pain and trauma of the

suffering people and apologise to them. Do you have the courage of conviction?" Kharge asked.

The Congress chief said the people of Manipur will not forgive Prime Minister Modi and his party. Congress leader Rahul Gandhi said on Thursday that the imposition of President's rule in Manipuris a belated admission by the BJP of their complete inability to govern in Manipur.

"Now, PM Modi can no longer

Manipur," he said in a post on X. "Has he finally made up his

mind to visit the state, and explain to the people of Manipur and India his plan to restore peace and normalcy?" Gandhi asked. President's rule was imposed

in strife-torn Manipur on Thursday and the state assembly put under suspended animation, days after Chief Minister N Biren Singh resigned from his post that led to political uncertainty in the northeastern state.

The Manipur assembly, which has a tenure till 2027, has been put under suspended animation, according to a notification issued by the Ministry of Home Affairs. Singh, who was heading the BIP government in Manipur, resigned as chief minister after

nearly 21 months of ethnic violence that has claimed over 250 lives so far.

During Parole, MP Er Rashid Advocates for Lolab-Bandipora Road, in Meeting with Gadkari

NEW DELHI: Member of Parliament Er Rashid, during his two-day parole, met Nitin Gadkari, Minister of Road Transport and Highways of India, in the Parliament Chamber on Thursday and dis-



cussed some key developmental issues of North Kashmir.

An official spokesperson said the meeting focused on key infrastructure demands crucial for the development of North Kashmir. He said the parliamentarian from north Kashmir urged the minister to approve the construction of Lolab Bandipora road that shall link the Lolab Valley with Bandipora district and shorten its distance to reach Srinagar.

Spokesperson said he highlighted the need for Lolab-Bandipora road connectivity, linking the Lolab Valley with Bandipora district, as well as the Takipora Lolab-Sopore road, which would enhance regional connectivity and facilitate better trade and transport.

During the discussion, Er Rashid strongly advocated for the construction of the Karnah, Machil, and Gurez Tunnels, stressing their critical importance as these regions remain cut off from the rest of the country for nearly six months every year due to heavy snowfall. He emphasized that these tunnels would provide all-weather connectivity, improving the socio-economic conditions of the people and strengthening national integration.

Additionally, Responding to these demands, Minister Nitin Gadkari confirmed that the process for the Karnah Tunnel has already begun and assured that the other proposed tunnels and interdistrict road networks would be taken up with the Defence Ministry for further consideration.

District Hospital Admin Snoops on Patients, Staff; Massive Privacy Breach Sparks Outrage

BANDIPORA: In a shocking violation of privacy, the Medical Superintendent of District Hospital Bandipora, Dr. Masrat Iqbal, has allegedly turned the hospital into a surveillance zone, spying on doctors, staff, and even patients through illegally installed audio-visual CCTV cameras.

The unauthorized surveillance has triggered widespread outrage, with many calling it an attempt to snoop on employees and eavesdrop on confidential medical discussions.

According to official sources, Dr. Iqbal di $rected \,to\,in stall\, audio-enabled\, cameras\, across$ the hospital without following due procedure to avoid getting caught. CCTVs have also been installed in highly sensitive areas such as the minor operation theatre, casualty ward, emergency doctors' room, Sick Neonatal Care Unit (SNCU), medicine ward, LSCs, post-operative ward, COPD ward, registration section, and the drug counter.

The move has raised alarm among doctors and paramedics, who argue that such surveillance compromises patient confidentiality and staff privacy.

A doctor (name withheld) recounted a disturbing incident recently where he was

discussing a highly personal medical issue—the removal of an abscess from a female patient's breast only to later discover that the entire conversation had been heard in the Medical Superintendent's office through the spy cameras. Enraged by the violation, the doctor confronted Dr. Iqbal, condemning the illegal and unethical practice.

"This is not just CCTV surveillance for security purposes. This is an outright breach of doctor-patient $confidentiality. Nowhere \, else \, in \, the \, country \, is \, patient$ privacy compromised in such a shameful manner," said a furious doctor.

Hospital employees are equally distressed. "Every conversation we have, even about personal matters, is being recorded in the MS's office. The next day, the entire hospital is gossiping about it. How can we work under such conditions?" said an agitated staff member.

Another employee added: "Instead of focusing on patient care, the administration seems more interested in spying on doctors, patients and staff. Are we criminals?'

Adding to the scandal, sources revealed that the CCTVs were procured in violation of government norms. Instead of following the mandatory procurement process via the Government e-Marketplace (GEM) Portal, the hospital authorities bought the cameras from the open market, allegedly to benefit a "blue-eyed" vendor.

"Apart from being a gross violation of privacy, this is a clear case of corruption. Who authorized these purchases? Who was benefited by procurement of equipment? This needs a thorough inves-



tigation," a hospital insider alleged.

With mounting anger among doctors and paramedics, hospital staff are now demanding immediate removal of these unauthorized surveillance cameras, strict action against those responsible, and an independent probe into the illegal procurement

The incident has raised serious ethical and legal concerns, prompting calls for government intervention before patient trust in the healthcare system is irreparably damaged.

Medical Superintendent Dr. Masarat Iqbal stated that he aims to ensure doctors' punctuality and closely monitor them to improve healthcare services. "Some doctors are unwilling to perform their duties. I am strictly enforcing staff attendance, which is not sitting well with certain individuals," he said.

However, he could not justify the need for audioenabled CCTVs when attendance could have been monitored through video surveillance alone.

When asked whether CCTVs could be installed in emergency and casualty wards, he evaded the question, instead stating that he plans to shift the emergency ward to another location. "I personally monitor the CCTV footage, and no one else has access

Dr. Qayoom conducted a meticulous sector-wise review, covering education, healthcare, horticulture, handicrafts, milk processing, sports, IT infrastructure and women-centric projects, underlining their significance in fostering socio-economic

DDC said the imperative of proposing projects that not only serve the broader community but also mitigate the reliance on rented accommodations for schools.

He urged the concerned departments to prioritize the development of robust, long-term infrastructure that fosters sustainability, enhances the quality of education and ensures a more stable and conducive learning environment for students.

Discussions in the health sector focused on strengthening both hospital infrastructure and AYUSH facilities to improve healthcare services.

The District Development Commissioner underscored the necessity of enhancing medical facilities under PMJVK to ensure better accessibility and quality healthcare for the local population.

Regarding Handicrafts as the Nodal Department for skill development, the DDC suggested establishing integrated infrastructure that includes training centers along with dedicated selling facilities. The scheme covers augmentation of transformation capacity at Lakadia Pooling Station in Gujarat State for evacuation of Power from RE Power Generators. The estimated cost of the project is around Rs. 512.58 Crore.

Commissioner Secretary IT reviews implementation of National e-Vidhan App in J&K

JAMMU: Commissioner Secretary, Information Technology (IT), Saurabh Bhagat, today chaired a high level meeting to review implementation of National e-Vidhan Application (NeVA) in the Union Territory.

The Commissioner Secretary assessed various aspects of implementation of NeVA including conducting training programs for MLAs, Assembly staff and nodal officers from various departments, provisioning of high speed connectivity in Jammu and Srinagar Assembly complexes and procuring the necessary hardware and related items.

He underscored the commitment of I&K administration to modernise legislative processes while ensuring successful implementation of NeVA. A detailed action plan has been outlined to ensure timely execution of the project, with all necessary support and resources being made available, he added.

The meeting was apprised that NeVA is a workflow system hosted on NIC's MeghRai Cloud, designed to facilitate the smooth conduct of legislative proceedings. It will assist the Chair of the House in managing legislative sessions efficiently, enable members to perform their duties digitally and promote a paperless legislative ecosystem in line with the 'Go Green' initiative. Launched in March 2020 as a Mission Mode Project under the theme 'One Nation, One Application,' NeVA aims to transform all state legislatures into digital platforms.

Pertinently, the Law Department has been designated as the nodal department for NeVA implementation in J&K. Efforts are underway to ensure seamless adoption of NeVA across the Union Territory, with key developments including infrastructure upgradation, capacity building and procedural refinements for transition towards a fully digital legislative framework.

It was informed in the meeting that, so far, 25 state legislatures have signed MoUs for NeVA implementation, with funds released to 22 legislatures. Among them, 14 have successfully adopted the platform and are conducting legislative business digitally. Besides, the NeVA Cloud Infrastructure has been enhanced to ensure seamless and uninterrupted legislative sessions across the states and the UTs.



Doctors Should

Education Sakina Itoo, former Chief Minister Dr. Farooq Abdullah, Secretary H&ME Dr. Syed Abid Rashid, Jammu West MLA Arvind Gupta, Principal & Dean of GMC Jammu Dr. Ashutosh Gupta, Chairman JK Medical Council Dr. Muhammad Saleem Khan, senior professors, doctors, faculty and students.

Omar Abdullah highlighted his government's commitment to improving healthcare accessibility across Jammu and Kashmir.

"Our challenge is to make healthcare more easily accessible. Professor Gupta pointed out the excessive pressure on GMC Jammu's emergency services, which stems from the fact that healthcare in peripheral areas is not of the required standard. This forces people to flood into cities," he noted. He emphasized that the solution lies in improving healthcare infrastructure in rural areas.

"The way to reduce this pressure is not just by expanding our infrastructure in Jammu but by strengthening facilities in peripheral areas. There was a time when we only had GMC Jammu and GMC Srinagar. Now, we have GMCs at the district level," he said.

Speaking about MediCon-2025, the Chief Minister acknowledged its importance in fostering debates and discussions on key medical issues.

"There are all sorts of debates surrounding the topics that MediCon can address. The good thing is that students are involved through SRDC," he said.

He also highlighted that participants will earn 11 credits through MediCon, which will encourage greater engagement and enthusiasm.

"I hope the futuristic advancements in medical science will be part of our discussions—how much technology is beneficial, how much human contact should be replaced by machines. While some tasks may be better performed by AI, there are things that only human beings can do," he added.

Touching on the ethical dimensions of modern medical trends, Omar Abdullah raised concerns about the intersection of medicine and profit-driven healthcare.

"Where do we draw the ethical line in medicine? Is there such a thing as too much ethics? Does the pursuit of profit in medical care conflict with ethical responsibilities? Should hospitals treat patients as a means of revenue generation?" he asked.

He also noted the pressure on doctors working in corporate hospitals, where their performance is measured not by the number of patients they treat but by the revenue they generate.

Delving into the future of robotic surgery and Artificial Intelligence (AI) in medicine, the Chief Minister highlighted both the potential and concerns surrounding these advancements.

"One trend that seems to be catching on is the use of robotic surgery. Principal GMC Jammu mentioned that Al could one day take over medical procedures. Honestly, I can't imagine a scarier prospect than entrusting my life entirely to a machine. At the end of the day, there is immense value in human contact,

and that's where doctors—who literally do God's work—play an irreplaceable role," he said.

He praised doctors for their dedication and lifelong learning. "You pull people back from the jaws of death. You give hope where all hope seems lost. You stand by patients and their families at their most vulnerable moments—whether in recovery or in times of loss," he said.

"As doctors, you never stop learning. You are always adapting to new techniques, medicines, and treatment methods. But no machine can replace the human touch when a doctor delivers a diagnosis or a prognosis. Patients and their families hold on to every word a doctor says," he added.

Chief Minister also acknowledged the growth plans for GMC Jammu and expressed his intent to contribute

"Theresolution brought by Lone calls for condemning all actions of August 5, 2019 in the strongest terms and seeks the restoration of the pre-August 5, 2019 constitutional position," they said, adding that the resolution has been submitted in the Legislative Assembly secretariat.

In the last assembly session, the National Conference-led government had brought a "mild-worded" resolution on the issue of special status. "This Legislative Assembly reaffirms the importance of the special status and constitutional guarantees, which safeguarded the identity, culture, and rights of the people of J&K, and expresses concern over their unilateral removal," the NC-led resolution read.

It further stated that the assembly "emphasizes that any process for restoration must safeguard both

national unity and the legitimate aspirations of the people of [&K."

While all Kashmir-based opposition parties, including PDP and PC, had accused NC of bringing a "watered-down" resolution on the issue, the Congress had said that the resolution only seeks the restoration of statehood and doesn't call for the reinstatement of Article 370

6 Kg Heroin Seized in Rajouri

RAJOURI/JAMMU: Jammuand Kashmir Police on Friday seized six kg of narcotics, believed to be high-grade heroin worth over Rs 30 crore in the international market, from a village near the Line of Control in Rajouri district, officials said.

The recovery from Sair Bhawani village in the Nowshera sector was made on the disclosure of the arrested kingpin of the racket Jaswinder Kumaralias Sonu, a resident of Lamberi who was arrested 10 days ago following an investigation of a case registered last year, officials said.

They said two more accused, Ashok Kumar and Sanjay Kumar of Sair Bhawani, were also arrested during the operation, taking the total number of those arrested to five and the recoveries to 11.3 kg of narcotics. Terming the operation a "significant breakthrough", a

Latham, Mitchell fifties take NZ to tri-series title after bowlers restrict Pak

New Zealand 243 for 5 (Mitchell 57, Latham 56, Naseem 2-43) beat Pakistan 242 (Rizwan 46, Agha 45, O'Rourke 4-43, Santner 2-20) by five wickets

espite injuries to Lockie Ferguson, Ben Sears, Matt Henry and Rachin Ravindra, New Zealand clinched the tri-series title in Karachi and sounded out a warning to the hosts, five days before they meet again in the Champions Trophy opener at the same venue. In the absence of the senior quicks, Will O'Rourke stepped up admirably with a four-wicket haul, while the spinners, led by Mitchell Santner, straightjacketed Pakistan in the middle overs, limiting them to 242.

The batters then completed the demolition job on a two-paced surface, chasing the target with 28 balls and five wickets to spare. After Devon Conway and Kane Williamson set the platform with a 71-run partnership for the second wicket, Daryl Mitchell launched from there in the middle overs, befuddling Pakistan's spinners with his variety of sweeps -including the reverse. He struck up an 87-run stand with Tom Latham, which highlighted New Zealand's dominance in the middle overs, before Michael Bracewell and Glenn Phillips sealed the deal.

It was Phillips who had kicked off the triseries with an unbeaten 106 off 74 balls, his maiden ODI century, against Pakistan, before Kane Williamson reminded the world of his genius with an unbeaten century of his own in New Zealand's second game of the tri-series against South Africa. Having bagged ducks in

those two games- and also against Sri Lanka in with his most economical ten-over spell in Auckland last month - Latham made a timely return to form, and re-established himself as New Zealand's first-choice wicketkeeper-batter with his 56 off 64 balls.

Latham had benefitted from multiple reprieves - he was dropped by Shaheen Shah Afridi off his own bowling on 15, and then by Saud Shakeel at square leg on 29. Earlier, when he was on 13, legspinner Abrar Ahmed pinged him on his pad and wasn't given out lbw. Pakistan missed a trick by not going for a review, with ball-tracking indicating that it had pitched in line and would have crashed into the stumps.

Abrar, Pakistan's specialist spinner, lacked penetration, and was taken for 67 in his ten overs. In stark contrast, New Zealand's premier spinner Santner was unhittable, coming away with 2 for 38 in his ten overs

The first powerplay was a portent for Pakistan's go-slow. They played out 48 dots in the powerplay, in which they managed 48 for 2, and failed to hit a high tempo through the innings. After taking a sequence of short balls away from Fakhar Zaman with his sharp angle from over the wicket, including two off-side wides, O'Rourke brought a fuller one back into the opener and had him chipping a catch to square leg for 10 off 15 balls.

The new ball did a lot more under lights, with Naseem Shah and Shaheen Shah Afridi using the swing and seam movement on offer to apply pressure on Conway and Williamson. In the first powerplay during the chase, the broadcaster put up a graphic showing the average swing achieved during the two innings. New Zealand's seamers had generated 1.5 degrees of swing, and Pakistan's 2.4 degrees.

ICC Champions trophy: Winners to receive prize money of USD 2.24 million

he International Cricket Council (ICC) on Friday announced a 53 per cent hike in its Champions Trophy prize money pool with a winners' share of USD 2.24 million for the upcoming edition in Pakistan and UAE. The runners-up will receive half the amount, USD 1.12million (INR 9.72 crore), while each losing semi-finalist will take home USD 560,000 (INR 4.86 crore). The total prize pool has increased to USD 6.9 million (Rs 60 crore approx).

"The substantial prize pot underscores the ICC's ongoing commitment to investing in the sport and maintaining the global prestige of our events," ICC chairman Jay Shah said in a statement ahead of the tournament starting February 19.

Each group stage win would worth over USD 34,000 (INR 30 lakh) for the victorious team. Teams finishing in fifth or sixth place will receive USD 350,000 each (INR three crore), while the seventh and eighth-placed sides will take home USD 140,000 (INR 1.2 crore).

Additionally, all eight teams will receive a guaranteed USD 125,000 each (INR 1.08 crore) for participating at the event.
