NEW DELHI: Stating that the Jammu & Kashmir police should now prioritize safeguarding citizen rights, Union Home Minister Amit Shah on Tuesday directed the Union Territory administration to ensure the full implementation of three new criminal laws by April 2025.

Shah, who chaired a high-level review meeting on the implementation of these laws in Jammu & Kashmir, noted that with the decline in terror activities and improvement in the security scenario in the region, the police should now prioritize safeguarding the rights of its citizens.

Shah, who reviewed the implementation of the laws in the presence of LG Manoj Sinha and Chief Minister Omar Abdullah, asked the UT administration to ensure the full implementation of the three new criminal laws, made under the leadership of Prime Minister Shri Narendra Modi, by



The three criminal laws—Bharatiya Nyaya Sanhita, the Bharatiya Nagarik Suraksha Sanhita, and the Bharatiya Sakshaya Act—came into effect on July 1, 2024. These laws replaced the Indian Penal Code, Code

of Criminal Procedure, and Evidence Act. According to the news agency—Kashmir News Observer (KNO), Shah said that for the full implementation of the new laws,

The comment sparked backlash, with many drawing parallels to former CM Mehbooba Mufti's infamous "toffee and milk" remark, which has haunted her politically

When asked whether Omar's praise could, $like\,Mufti's\,statement, remain\,a\,political\,tag\,for$ years to come, Ruhullah said that sunshine during Chilai Kalan was not something to celebrate.

He said that Kashmir's winters are meant for snow, and an absence of it is unnatural and ominous. "If, during Chilai Kalan, we see the sun instead of snow, it is not a blessing-it is God's wrath." Ruhullah refused to justify Omar's remarks and added, "Only he can explain why he said that."

SRINAGAR: Renowned earth scientist and Vice-Chancellor of the Islamic University of Science and Technology (IUST) Prof Shakeel Romshoo on Tuesday said that snowless winters during the past five years have pushed Kashmir to the brink.

In an exclusive interview with the news agency-Kashmir News Observer (KNO), Prof. Romshoo said that the Kashmir has experienced a significant decline in snowfall over the past five years, particularly during the peak winter season. This has led to the current alarming situation. "Snowfall is a major source of water for Kashmir's population. With the pervasive lack of snow, rivers,



tributaries, and streams are drying up. This could severely impact the tourism sector, horticulture, and food security systems in Kashmir, with far-reaching economic implications," Prof. Romshoo said. Asked about the drying up of the Achabal water

stream, Prof. Romshoo explained that geological factors could be at play. The mountains from which these streams originate are shallow, and their flow is sustained by snow accumulation."

Mission YUVA Accomplishes Baseline Survey Of Over 1.1 Cr People • CS terms exercise crucial in shaping

roadmap to tackle unemployment

JAMMU: Chief Secretary, Atal Dulloo, today convened a meeting with all the stakeholders to assess outcomes of amonth-long baseline survey conducted under Mission Yuva Udyami Vikas Abhiyan (YUVA) aiming identification of potential entrepreneurs and challenges faced by the existing enterprises in J&K.

The survey, carried out digitally from Ist of January this year, encompassed whole adult population of the UT residing in both rural and urban areas.

The mammoth exercise was accomplished with the help of nearly 18,000 investigators and 800 supervisors who visited around 23.64 lakh households in different districts of J&K to identify the potential entrepreneurs (PEs).

Dulloo, while making observations about this survey, remarked that carrying out such a massive exercise in record time is commendable. He termed it crucial for determining a roadmap to deal with the unemployment issue in the region. He impressed upon the concerned to come up with a comprehensive report based on the insights made in the survey. He advised for stacking the data so that the relevant stacks are used by the Universities and research institutions for completing research papers over the same subject matter.

The Chief Secretary also advised the developers to separately categorise the self employment schemes from social security and others. He stressed on making provision of scheme advisor in the YUVA application so that the potential entrepreneurs are guided as per their strengths and area of interest.

He reiterated the significance of augmenting the institutional structure envisaged under this scheme so that the handholding of applicants is done to transform them into successful entrepreneurs.

Mallikarjun Kharge on Tuesday termed as ironical the claim of Finance Minister Nirmala Sitharaman that the Indian economy is giving good returns, and said a "visionless" Modi government has tanked the economy and ruined the lives of Indians.

"Nothing can be more ironical than Modi Sarkar's FM saying that our Economy is delivering 'Good Returns', he said in a

Kharge said Rs 45 lakh crore has been wiped out from the Indian stock markets so far in 2025 and Nifty 50 firms have shown the worst quarterly profit growth in five years.

"Foreign Investors have sold over Rs 1.56 lakh crore of stocks since October last year, including nearly Rs 1 lakh crore in 2025 itself, which has led to wiping out wealth of small and medium investors," the Congress chief said.

"Rupee at 87, means Trade Deficit is sky-high. Imports have risen by 62.21 percent in the last 5 years. The Modi Government's Trade policy is disastrous for India," he said.



Drawing a comparison, Kharge said export growth during the 10 years of UPA government from 2004 to 2014 grew by 549.36 percent while during the 10 years of Modi government from 2014 to 2024 exports grew by 24.72 percent (Till April-Nov 2024).

"The Modi Government has forgone a Corporate Tax revenue of Rs 10 Lakh Crore in past 10 years, in anticipation that they

will create jobs, but 8 out 9 companies that have benefitted from the cut in Corporate taxes have REDUCED Jobs," he said.

The Congress chief also said India is staring at a global Tariff war,

"Our Manufacturing Sector is drowning, Make in India and PLI Schemes have failed, vouth unemployment has NO solution. Price Rise is extinguishing savings, Consumption is falling and there is no respite from Budget,

Rupee has depreciated by 43% in the past 10 years and forced oil-gas buy would burden our import bills," he said.

"A visionless, rudderless and policyless Modi Sarkar has tanked the Indian Economy, ruining the lives of Indians," Kharge charged.

Seeking to assuage concerns over foreign institutional investors (FII) selling Indian equities lately, Sitharaman on Monday attributed the action to profit booking.

She said the Indian economy is one where the investors are bagging better returns which leads to profit booking.

"FIIs also go out when they are able to or in a position to book profits. Indian market today, Indian economy today, has an environment in which investments are also yielding good returns and profit booking is also happening," she said.

It can be noted that FIIs have sold over Rs 1.56 lakh crore of stocks since October last year, including nearly Rs 1 lakh crore in 2025 itself, which has led to a sharp correction on the indices and wiping out investor wealth.

SC Slams States, UTs For Not Filing Status Reports

Tuesday pulled up several states and union territories for not filing status reports over the implementation of the domestic violence law



while allowing them four more weeks subject to the payment of Rs 5,000 as costs.

A bench of Justices B V Nagarathna and Prasanna B Varale took note when the petitioner's counsel said several states and UTs did not file their status reports despite the top court's direction."The counsel for the respective states have sought for some more time to file status reports. Hence, four more weeks are granted to file status reports subject to payment of cost of Rs 5,000 to the Supreme Court mediation centre," the bench said. The bench noted Andhra Pradesh, Arunachal Pradesh, Himachal Pradesh, Madhya Pradesh, Maharashtra, Meghalaya,

NEW DELHI: The Supreme Court on Odisha, Telangana, West Bengal and Assam were among the defaulters.

UTs of Dadra and Nagar Haveli and Daman and Diu, Jammu and Kashmir, Ladakh and Lakshadweep also did not file the status reports, it was further informed.

"Pay cost of Rs 5,000 and file it. If you don't file it, next time it will double," said Justice Nagarathna. The bench posted the matter on

In its December 2 2024 order, the apex court said the status report had to be filed with regard to implementation of the Protection of Women from Domestic Violence Act, 2005.

On January 17, the top court extended the time for filing of the status reports by the states and UTs till February 14. While hearing the matter in November last year, the apex court said the prayers in the petition were essentially for the implementation of the 2005 law. While issuing notices, the top court said the obligation for the implementation of the law not only rested with the Centre but also with the respective state governments. The plea sought directions to the authorities for the proper enforcement and implementation of the provisions of the 2005 Act aside from directions for adequate appointments.

Defence industry in India at cusp of massive expansion: Defence secy

NEW DELHI: The defence industry in India is at the "cusp of a massive expansion", Defence Secretary Rajesh Kumar Singh said on Monday even as he suggested that public-private-partnership would be "critical" in making the country a hub for advanced manufacturing in the sector.

In his address at a defence conclave here late evening, he also said the intention of the Government is to build a "technologically advanced" and "combat-ready force" that can effectively address the "complexities of modern warfare".

The event was hosted by Axis Bank to bring together different stakeholders, including Government officials, industry members, financial institutions, among others under one roof.

Singh said the conclave fosters collaboration among different stakeholders from the defence industry ecosystem, including those who would finance them. Creating a unified platform for discussions on 'Atmanirbhar Bharat', empowering the defence ecosystem is a "critical issue" right now, he added.

"It is an ongoing effort which we sort of need to continue to focus on. It is also in line with our priorities of modernising and reforming the defence ecosystem in our quest for 'Atmanirbharta' or strategic self-reliance," the defence secretary said.

He recalled that the Ministry of Defence recently declared 2025 as the "year of reforms", saying the objective is to make systems and procedures more efficient, streamlined in order to deliver timely outcomes.

No extension of Maha Kumbh: Pravagrai DM

MAHAKUMBH NAGAR (UP): Prayagraj District Magistrate (DM) Ravindra Mandar

on Tuesday categorically denied rumours circulating on social media regarding an extension of the Maha Kumbh Mela due to heavy crowds. Dismissing these claims, he clarified that the schedule of the event is determined on the basis of religious "muhurats" (auspicious timings) and remains unchanged.

The Maha Kumbh will conclude on

February 26, in accordance with its predecided schedule. Mandar said.

"According to (Uttar Pradesh) Chief Minister Yogi Aditvanath's instructions. the administration is ensuring a smooth travel and other arrangements for all the devotees. There is no proposal from the government or the district administration to extend the mela dates. Pilgrims should

not pay heed to such misinformation," he said. The DM asserted that all necessary arrangements are in place for the remaining days of the Maha Kumbh to facilitate hassle-free bathing at the Triveni Sangam.

The administration is also focused on traffic management to maintain a balance between the movement of devotees and normal life in Prayagraj, he said.

Disrespectful For PM, HM To Have Made Midnight Decision To Appoint New CEC: Rahul NEW DELHI: Congress leader Rahul exacerbated the concerns of hundreds of Election Commission.

Gandhi on Tuesday said it is "disrespectful" and "discourteous" for the prime minister and home minister to have made a midnight decision to select the new CEC when the process of selection is being challenged in the Supreme Court.

The government late on Monday night appointed Gyanesh Kumar as the new Chief Election Commissioner (CEC), hours after the meeting of the prime minister-led selection committee in which the Leader of Opposition in Lok Sabha asked the government to defer the meeting in view of the Supreme Court hearing in the matter.

Gandhi also presented a dissent note to the panel, of which Home Minister Amit Shah is also a member.

The Supreme Court on Tuesday said it would on February 19 take up on "priority basis" the pleas against the appointments of the chief election commissioner (CEC) and election commissioners (EC) under the 2023 law.

In a post on X, Gandhi said, "During the meeting of the committee to select the next Election Commissioner, I presented a dissent note to the PM and HM, that stated: The most fundamental aspect of an independent Election Commission free from executive interference is the process of choosing the Election Commissioner and Chief Election Commissioner".

"By violating the Supreme Court order and removing the Chief Justice of India from the committee, the Modi Government has millions of voters over the integrity of our electoral process," he also said in his post while sharing his dissent note. Gandhi said as the Leader of Opposition, it

is his duty to uphold the ideals of Babasaheb



Ambedkar and the founding leaders of the nation and hold the government to account.

"It is both disrespectful and discourteous for the PM and HM to have made a midnight decision to select the new CEC, when the very composition of the committee and the process is being challenged in the Supreme Court and is due to be heard in less than

forty-eight hours," he also said. In his dissent note presented before the panel, Gandhi cited the speech of BR Ambedkar while speaking in the Constituent Assembly in June 1949 to discuss the setting up of an independent Election Commission, where he had warned about executive interference in India's democracy and the affairs of the

Gandhi said in a judgement on March 2, 2023, the Constitutional Bench of the Supreme Court ordered the appointment of the CEC and election commissioners should be undertaken by a committee comprising the prime minister, Leader of Opposition and Chief Justice of India.

"The Supreme Court judgement reflected the larger concern among hundreds of millions of voters over the integrity of our electoral process. This is also reflected in public surveys that show a continuing decline in trust of voters in India's election process and its institutions.

"Unfortunately, soon after the Supreme Court order, the Government of India notified a legislation in August 2023 that bypassed the spirit and the letter of the Supreme Court's order," he said.

Gandhi said the government legislation reconstituted the committee to appoint the CEC and Election Commissioners to include the prime minister, Leader of Opposition and a Union Cabinet minister to be appointed by the prime minister and removing the chief justice from the committee.

"This is in flagrant violation of the letter and spirit of the Supreme Court order," he noted.

He said this government order was subsequently challenged by a public interest litigant and the Supreme Court has indicated its intention to take up this matter on February 19, 2025, which was less than forty-eight hours away.

Abandoned Hospital in Gund Jahangir Becomes Shelter for Addicts

Nine Years On, NTPHC Gund Jahangir Remains Incomplete; Residents Demand Action

CONVENER NEWS DESK

BANDIPORA: The residents of Gundjahangeer village in Hajin Sonawari area of north Kashmir's Bandipora district are unhappy with the authorities over the stalled construction of a much-needed hospital building.

For nine years, the project has remained incomplete, leaving the area's 12000-plus residents without adequate medical facilities and forcing them to travel longer distances for treatment.

"The construction of the New Type Primary Health Center (NTPHC), initiated in 2016, has been inexplicably halted," said Zahoor Ahmad Bhat, a local

He added that this inaction has had a severe impact on patients, who must endure considerable hardship and travel long distances even for minor

Zahoor Bhat further alleged that DDC Chairman Abdul Ganie Bhat has neglected the village and its



needs, claiming that funds were inappropriately allocated to NC workers for personal gain. He stated that despite bringing the issue to the DDC Chairman's attention multiple times, no action has been taken.

Bhat appealed to Lieutenant Governor Manoj Sinha to intervene and investigate the matter, demanding strict action against those misusing government funds.

Another local resident, Fayaz Ahmad Shahri, raised concerns over the deteriorating state of the abandoned building, which, he claimed, has become a haven for drug addicts. "Crores of rupees have been spent on this project, yet it appears to have been a complete waste of money," he lamented.

Shahri also said that the inade-

quacy of the existing Primary Health Center (PHC), citing its small size and severe shortage of doctors. Residents feel the government is simply ignoring their plight.

"They should complete the construction work immediately so that we can finally have access to proper healthcare," he urged.

The residents claim they have repeatedly raised this issue during government initiatives like 'Back to Village,' but despite repeated assurances, no tangible progress has been made.

They are now appealing to the Lieutenant Governor's administration and the deputy commissioner Bandipora to intervene and address their long-standing grievances urgently.

Meanwhile, Deputy Commissioner Bandipora, Manzoor Ahmad Qadri, stated that the NTPHC project in Gundjahangeer is facing funding issues, which have placed it in the "languishing" category. He assured that work will resume as soon as the necessary funds are released.

Sajad Lone Slams **Bureaucracy Over Delays in Issuing Certificates, Seeks CM's Intervention**

"Some officers are scared to issue certificates. Do we really need such officers? If they are scared, they should go and rest at home. That should be the message. Shape out or ship out," he wrote. [KNT]

Discrepancies in Lab **Reports in Bandipora Put Patient Health at Risk**

BANDIPORA: Serious concerns have been raised over the accuracy and reliability of medical laboratories in Bandipora, as multiple reports of inconsistent test results and poor infrastructure emerge.

A recent personal investigation by a local resident revealed alarming discrepancies in Complete Blood Count (CBC) test results from different labs in the district. The patient put discrepancies of various lab reports on social media and expressed concern over the same.

Each lab provided varying reports, casting doubt on the credibility of these diagnostic centers and raising serious risks for patient health.

Apart from inconsistent results, many of these labs are reported to be operating in substandard conditions, lacking heating systems and proper arrangements for essential diagnostic equipment like analyzers. The poor infrastructure and inadequate maintenance further exacerbate concerns about the accuracy of test reports.

Residents urged the concerned authorities to conduct immediate inspections of these labs, focusing on equipment quality, maintenance standards, hygiene, and the accuracy of test reports. They emphasize that ensuring trustworthy and high-standard medical testing facilities is crucial for public health and patient safety.

Locals calls for urgent intervention to regulate and improve diagnostic services, preventing further distress for patients who rely on these tests for critical medical decisions.



Furthermore, the meeting was informed that 64 Panchayats have been declared 'Nasha Mukt,' and wild cannabis spread over 300 kanals of land was destroyed last year. Farmers were encouraged to cultivate alternative crops on such land to discourage illegal cultivation.

The Police Department was instructed to maintain strict surveillance on drug peddlers, ensuring that all movable and immovable property of offenders is seized immediately.

Pampore's Tribal Villages Get Drinking Water After 30 Years, Thanks to 9.7 Crore JJM Project

Pampore: A wave of joy swept across the tribal villages of Bathina, Batdalaw, and Bajnari as their decades-long struggle for drinking water finally came to an end with the completion of a 9.7 crore lift water supply scheme under the Jal Jeevan Mission (JJM).

For over 30 years, the absence of a reliable water source had forced villagers—especially young girls—to spend five to six hours daily fetching water from distant areas, severely impacting education and overall well-being. Many families had even migrated due to the severe water crisis.

Residents extended their gratitude to the PHE Sub-Division Pampore, Deputy Commissioner Pulwama, the J&K UT Government, and the Central Government for ensuring clean drinking water reaches their homes.

Talking to Kashmir Convener, Mohammad Iqbal Bajjad, a resident of Gujjar Basti Bajnadi, expressed heartfelt appreciation to the authorities for making the Bajnadi-Bathan-Batdalaw water supply scheme operational. He recalled the immense hardships faced by villagers, particularly school-going girls who had to walk 7 kilometers daily to fetch

"With no springs or natural water sources, we were entirely dependent on tanker services, which often couldn't reach us due to bad road conditions. Now, with this scheme in place, our daughters can focus on education instead of carrying water all day," he said. Another resident, Rivaz Ahmad, expressed deep gratitude to the J&K Government and the PHE Department for addressing their 30-year water crisis. He

rupees 9.7 crore. It has been designed for a population of approximately 3,875 people. Under this scheme a total of



recounted the severe health implications on children and the community's past reliance on contaminated sources near cement factories.

"This is a historic day for us. Two of these three villages belong to the ST (Scheduled Tribe) community, and they have suffered for decades. Now, with clean water at our doorsteps, our quality of life will significantly improve," he said.

Assistant Executive Engineer (AEE) Sub Division Pampore, Er. Mudasir Mushtaq Untoo, told Kashmir Convener that the Bajnadi, Bathan, and Batdalaw water supply scheme is a lift scheme that has been completed in four stages.

He explained that the source of the scheme is a tube well, and the total cost of the project is 203 households in Bajnadi are being connected, 361 households in Batdalaw are being covered and 214 households in Bathan are being provided with water supply.

He further stated that, so far, the following civil works have been completed. Three service reservoirs have been constructed, three sump tanks have been built and two pump houses have been established. Approximately 27 kilometers of pipeline distribution has been completed.

Today, the testing of the system was successfully conducted, and for the first time, the villages of Bathan, Bajnadi, and Batdalaw are receiving water under this scheme, which has been implemented as part of the Ial Ieevan Mission.



IN A STRESSFUL JOB CAN IMPACT DEPRESSION RISK

A recent study done by a team at the University of Michigan published this month in the New England Journal of Medicine found that the more hours a person works at a stressful job each week, the more their risk of depression increases.

The researchers looked at data on more than 17,000 first-year medical residents over 11 years, training at hospitals across the United States. They found that working 90 or more hours a week was linked to three times the increase in depression symptoms when compared to those working 40 to 45 hours a week.

The study found an average symptom increase of 1.8 points on a standard scale for those working 40 to 45 hours versus 5.2 points for residents working more than 90 hours. At the beginning of the first year of residency, only 1 in 20 met the criteria for moderate to severe depression.

The study also found a higher percentage of the group who worked the increased hours also had more frequent scores high enough to qualify for a diagnosis of moderate to severe depression when compared with people working fewer hours. Residents reported working on average between 65 and 80 hours per week.

The study brings the link between mental health concerns and working long hours in a stressful job to light as national organizations, such as the National Academy of Medicine and the Association of American Medical Colleges, try to figure out how to handle the increased rates of depression in health care professionals.

The results of the study highlight a clear need to further reduce the number of hours residents work each week on average.

Why are more hours worked equated with increased rates of depression and more severe depression?

The study suggests strongly that reducing the amount of hours at work would reduce the number of residents who develop diagnosable depression.

Tess Brigham, MFT, BCC, a life coach and family therapist based in San Francisco, CA thinks this happens because "work is stressful and constant stress on your body impacts you in many ways."

She says, "If you're working all the time, you have little or no time to manage your stress or improve your mood."

Dr. Jennifer Crall, Ph.D., a licensed psychologist based in Quakertown, PA says, "You just don't have the same time for self care. You don't have as much time to sleep, eat well, exercise, or have a social life."

Hours worked and depression

While the study examined first year medical residents, the study authors believe that if similar studies were done in other high-stress, high-workhour jobs they would show similar negative effects on mental health.

Brigham believes that the number of hours worked may account more for the increased risk of depression than the stressful nature of the job.

She says, "Even if your job is less stressful, the long hours and the limited social/fun time you have available is going to impact you negatively. There

was a reason why we went from working 6 days a week to 5 days a week - because eventually even the best employees lose focus and steam when they hit a certain amount of hours. Even if you have the easiest job in the world, if you are stuck inside,

behind a desk, working away from the people you love, you're going to start to feel depressed.'

Crall agrees. "You need the time to take care of yourself and do things to lower cortisol levels and increase serotonin. Your body needs those things to keep itself healthy. When most of your life is spent at work, you don't have that time"

How can a person manage their stress when they work a lot of hours?

While major organizations are still sorting out how to handle the increased rates of depression in healthcare professionals, anyone in a stressful job with long hours can work towards better mental

Cralls says, "Setting boundaries at work is key.

It may not be possible to give yourself a break or take a day off, but you can learn how to set mental boundaries and leave work at work."

She continues saying, "This might mean saying no to extra things at work or learning how to build up some walls so you are not taking work personally and carrying that stress with you when you leave.'

....DIFFERENT TYPES OF DEPRESSION

It's important to learn about the different types of depression and what form of depression you suffer from, so you can find the right treatment option for you.

1. Major Depressive Disorder

Major depressive disorder (MDD) is a mood disorder in which a person experiences most of the following symptoms for more than two weeks:

Low mood

Lack of interest in activities that were previously

enjoyable (known as anhedonia) Weight loss or weight gain

Changes in sleep

Feelings of worthlessness, despair, and guilt

Trouble concentrating Suicidal thoughts

2. Dysthymia

Dysthymia (persistent depressive disorder) is a mild, long-lasting type of depression.

People suffering from dysthymia experience symptoms that are less severe than those felt by MDD patients.

The difference is that they experience these symptoms for much longer: two years or more. When you have dysthymia, you're always "down."

Since dysthymia symptoms last for so long and may not majorly impact your life, you may not even realize you have the condition.

You might think it's normal to feel how you've been feeling.

Dysthymia can be treated with a combination of these options:

Psychotherapy

TMS treatment

Antidepressant medication

Lifestyle changes, like improved diet, regular exercise, and restful sleep

3. Bipolar Disorder

Bipolar disorder is a type of depression in which a patient swings between periods of abnormally elevated mood (mania) and depressive episodes. When the periods of mania are extreme, this is

called hypermania.

This can significantly impact your everyday functioning.

Hypermania sometimes requires hospitalization and can affect your grip on reality. Hypomania, on the other hand, is a less severe form of mania.

During the manic phase of bipolar disorder, you may feel intensely euphoric. It's common to have:

Lots of energy Wild ideas

Ambitious plans

There is a tendency to act impulsively, spending money on things that are out of your budget or you wouldn't normally buy.

When experiencing mania, people will not feel like eating or sleeping and will talk quickly.

They can also become easily irritated or agitated. Since bipolar disorder includes periods of mania. as well as depression, treatment is different than it is for MDD, which doesn't include mania.

A psychiatrist may recommend that you take a mood stabilizer, like lithium.

This helps prevent the intense highs and lows associated with bipolar disorder. Talking therapy can also help you recognize what triggers your mania and depression and better manage your symptoms.

4. Psychotic Depression

Psychotic depression is when a person struggling with depression also experiences psychosis. Psychosis is when you lose touch with reality. Signs and symptoms of psychosis include:

Delusions (false beliefs and perceptions) Hallucinations (seeing or hearing things that are not present in reality)

Agitation

Confusion Paranoia

Disorganized thoughts and speech, shown by switching topics erratically

change the attitude of police personnel and the administration and create awareness about the new laws among citizens. "He said that optimum use of technology should be made to ensure speedy justice under the three new criminal laws," reads an official handout issued by the Ministry of Home Affairs (MHA) after the meeting.

Shah added that there is an urgent need to use the provision of Trial in Absentia in the Union Territory. The Union Home Minister stressed the need to fix the responsibility of police officers to expedite the process of filing chargesheets. He said that every police station in Jammu and Kashmir should maximize the use of the National Automated Fingerprint Identification System (NAFIS). He also emphasized that 100% training of investigating officers regarding the provisions of the new laws should be ensured at the earliest.

The Home Minister said that decisions on provisions related to terrorism and organized crime should be taken only after thorough scrutiny at the level of Superintendent of Police. He added that strict monitoring is required to ensure that these provisions under the new laws are not misused.

Shah commended the Jammu and Kashmir administration and government for their satisfactory work towards the implementation of the new criminal laws despite difficult circumstances. He stated that the progress of implementation should be reviewed on a monthly, fortnightly, and weekly basis at the level of the Chief Minister, Chief Secretary, and Director General of Police, respectively.

The meeting was attended by the Union Home Secretary, Chief Secretary and Director General of Police of Jammu and Kashmir, the Director General of the Bureau of Police Research and Development (BPRD), the Director General of the National Crime Records Bureau (NCRB), and other senior officials from the Ministry of Home Affairs (MHA) and the UT administration.

Application Of New

"The meeting discussed the shortcomings and the areas to work upon for the smooth implementation of the three laws in Jammu and Kashmir," Abdullah said.

The home minister (Shah) said in the meeting that so far a similar exercise has been completed for 11 states and UTs, he added.

"In case of Jammu and Kashmir, so far, the implementation of the new laws has been by and large successful except a few instances. These issues will be addressed," Abdullah said.

The chief minister added that while the implementation of the new laws was "not the responsibility" of the elected government, but it was important that people were made aware about their contents and proceedings as those are populated.

He also noted that over the past two years, more than 12 lakh migratory birds have been recorded in Kashmir's wetlands, reaffirming their global ecological importance.

Altaf Hussain, Wildlife Warden, Wetlands Kashmir, and Coordinator of Wular Conservation and Management Authority (WUCMA), expressed satisfaction that most of Kashmir's major wetlands currently hold sufficient water levels to sustain migratory birds.

He highlighted that interventions such as the construction of regulatory gates at Hokersar, in collaboration with the Irrigation and Flood Control Department, have significantly improved water retention in the Hokersar wetland.

He further noted that Hokersar's water levels are now higher than they have been in the past decade, ensuring a more stable and suitable habitat for migratory birds.

The Asian Waterbird Census 2025 will cover 25 key wetlands, including four Ramsar sites—Hokersar, Haigam, Shallabugh, and Wular Lake—each serving as a critical habitat for thousands of migratory birds.

The census will be carried out under strict supervision by trained personnel from the Wildlife Department, WUCMA, Forest Protection Force, and the Forest Department.

Teams of experts and volunteers will systematically record bird species, count populations, and document behavioral patterns to ensure accurate data collection.

Following the field survey, avian experts will analyze the collected data, compiling a comprehensive report on species diversity, population trends, and overall wetland health.

This report will be instrumental in shaping future conservation policies and wetland management strategies.

Owais Farooq Mir, Coordinator, Wular Conservation Authority, expressed gratitude to all participants, emphasizing that the census is directly linked to the long-term preservation of Kashmir's wetlands, which play a crucial role in maintaining ecological balance and supporting biodiversity.

As the Asian Waterbird Census 2025 unfolds, conservationists and wildlife officials remain committed to protecting these vital ecosystems and ensuring the continued survival of migratory bird populations.

"This is the first time in decades that we have stayed connected with the rest of the valley throughout winter. Usually, by this time, our roads are buried under feet of snow," said Ahmadullah Khan, a resident of Gurez while speaking to the news agency—Kashmir News Observer (KNO).

"While it has made travel easier and allowed us to continue agricultural activities, it also feels unnatural. We are worried about water shortages in the coming months," he added.

According to locals, the lack of snowfall has impacted traditional winter activities, particularly the famous snow cricket tournaments in Gurez Valley, which have been cancelled due to the absence of snow in many areas.

"I have never seen Gurez like this in my lifetime," said Muzaffar Ahmad, another resident. "For the first time, we are witnessing a less snowfall trend," he added.

The unusual weather pattern has raised concerns about water scarcity, as these areas rely on snow-fed springs and streams. Khan said that many regions have started experiencing reduced water availability.

Top-ranked Sinner reached a deal with WADA on Saturday to accept a ban that will have him back playing in time for the French Open in May without having to miss a single Grand Slam tournament. That came after the International Tennis Integrity Agency had decided not to suspend Sinner for what it judged was accidental contamination by a banned anabolic steroid last March.

The short ban for Sinner came after five-time Grand Slam champion Iga Swiatek accepted a one-month suspension in November after testing positive for a banned substance that she said was accidentally consumed because of a contaminated nonprescription medication. Both bans are much shorter than what other athletes in tennis and in other sports have normally received in similar cases.
