Speaking at the inauguration of the SATTE exhibition at Yashobhumi here, Abdullah highlighted J&K's rich and diverse offerings beyond its famous tourist spots like Gulmarg and Pahalgam or religious pilgrimage to Mata Vaishno Devi and Amarnath shrines.

Govt forms SIT to probe double murder in Kathua

JAMMU: Government on Wednesday formed a six-member Special Investigation Team (SIT) headed by a superintendent of police to probe the recent murder of two men in a remote village in Kathua district of Jammu and Kashmir, officials said.

Bodies of Roshan Lal, 45, and Shamsher, 37, were retrieved from the banks of a stream in Batheri village in Billawar on February 16 The postmortem report of the bodies revealed that they had been strangled to death.

Police have not ruled out terrorist involvement in the double murder so far. A joint anti-terrorist operation by police, army and paramilitary forces is also underway in the nearby forests over the past couple of days. However, any breakthrough has eluded the investigators till date, the officials said,



"If forced, we can be aggressive also with Pakistan": Army Chief

Speaking in an exclusive interview with ANI, the Army Chief suggested that India is now aggressive enough to respond if Pakistan provokes us.

"Now what has happened from 2014, if you see, that both sides have generally understood that we mean business. And India has said very clearly that we will be assertive in our communication. And if required, we can be aggressive also. So, what you have just spoken about, it was a kind of an indication that look, if you force us, then we will be aggressive enough to communicate our intent," he said.

General Dwivedi also stressed the impact of the abrogation of Article 370 in August 2019 in Jammu and Kashmir, noting that the number of terrorists and the recruitment of locals have significantly gone down, and people no longer have "confusion" over identity. 'JK is Expected To Face 29% Un-Served Annual Energy By 2034-35

SRINAGAR: In an awful revelation, authorities have said that Jammu and Kashmir may face 29 percent of 'forced load shedding' of annual power in the year 2034-35.

Besides, the authorities have further projected that in the coming ten years, the Compound Annual Growth Rate (CAGR) of power demand is likely to increase by more than four percent in Jammu and Kashmir and Ladakh.

SRINAGAR: Experts and environmental science specialists have highlighted the ongoing decrease in water resources in Jammu and Kashmir, saying the issue was due to a combination of natural and human-induced factors.

They said snowfall and rainfall in Jammu and Kashmir have decreased by 29 per cent in 2024, a trend consistent since year 2020, adding that the reduction in precipitation has resulted in lower snow and rain accumulation, which directly affects the re-filling of groundwater sources.

Dr Sami Ullah Bhat, Coordinator of Environmental Science at Kashmir University, speaking to the news agency—Kashmir News Observer (KNO), said the decrease in

NIA Arrests 3 Men For Leaking Sensitive Defence Information To Pakistani Intelligence Operatives

NEW DELHI: The NIA has arrested three men for leaking sensitive information to Pakistan-based intelligence operatives, the anti-terror federal agency said on Wednesday.

Theywere sharing sensitive information about Indian defence establishments at Karwar Naval Base and Kochi Naval Base, the National Investigation Agency (NIA) said in a statement.

While Vethan Laxman Tandel and Akshay Ravi Naik were picked up from Uttara Kannada district in Karnataka, Abhilash P A was arrested from Kochi in Kerala, the agency said.

All three accused persons arrested on Tuesday with the assistance of local police were found to have been in contact with Pakistan Intelligence Operatives (PIOs) through social media, it said.

As per NIA investigations, they were sharing sensitive information about Indian defence establishments at Karwar Naval



Base and Kochi Naval Base and were receiving money from PIOs in exchange for the information.

ere A total of eight people have been arrested so far in the case, including these three, the statement said. NIA has so far chargesheeted five persons, including two absconding Pakistani operatives, in the case that was originally registered by the Counter Intelligence Cell, Andhra Pradesh in January 2021.

NIA investigations have revealed that Pakistan national Meer Balaj Khan and one Akash Solanki – who has been arrested – were involved in the espionage racket related to leaking of sensitive vital information about the Indian Navy as part of an anti-India conspiracy, it said.

Another absconding PIO, Alven, and two others –

Manmohan Surendra Panda and Amaan Salim Shaikh — have also been chargesheeted by the NIA. The agency took over the case in June 2023.

The anti-terror agency will continue its probe in the case to unravel the espionage conspiracy by Pak-based and other antinational elements, the statement said. (Agencies)

NEW DELHI: A mechanical engineer from IIT-Roorkie who has served as the chief secretary of Haryana, Vivek Joshi on Wednesday assumed charge as an election commissioner. At 58, Joshi is one of the youngest members to be a part

of the poll panel. According to the law governing the appointment of

CEC and ECs, the chief election commissioner and other election commissioners will hold office for a term of six years from the date on which they assume office or till they attain the age of 65 years, "whichever is earlier".Born on May 21, 1966, Joshi will turn 65 in May 2031, but as per the law, his term



in the poll panel will end on February 18 of that year.

While CEC Gyanesh Kumar will demit office on January 26, 2029, the other election commissioner, Sukhbir Singh Sandhu will retire in July 2028.

Joshi could possibly supervise the conduct of the Lok Sabha elections in 2029 as the next CEC.

Joshi is a 1989 batch officer of the Indian Administrative Service of the Haryana cadre.

He has served as the chief secretary of Haryana and Secretary, Department of Personnel and Training and Department of Financial Services in the central government.

Earlier in his career, he served as the Registrar General and Census Commissioner and as member secretary of the Fifth State Finance Commission of Haryana.

Hailing from Uttar Pradesh, Joshi is a mechanical engineer from IIT-Roorkee. He has a Masters in International Business from

EU envoys approve more sanctions against Russia to mark third anniversary of its war on Ukraine



BRUSSELS: European Union envoys have approved a new raft of sanctions against Russia, with the measures set to enter into force next week on the third anniversary of its full-scale invasion of Ukraine, a top EU official and diplomats confirmed on Wednesday.

The move comes with the Europeans sidelined from US-led talks to end the

war. The EU has slapped several rounds of

Some 70 vessels believed to be part of the shadow fleet will be added to more than 50 already listed.

EU Commission President Ursula von der Leyen, whose services drafted some of the measures for consideration, welcomed their prospective adoption by the 27-nation bloc's ambassadors.

"The EU is clamping down even harder on circumvention by targeting more vessels in Putin's shadow fleet and imposing new import and export bans. We are committed to keep up the pressure on the Kremlin," she said in a social media post. Almost 50 Russian officials will be targeted, joining a list that already includes Putin, several of his associates and scores of lawmakers, while dozens more entities face sanctions. Among the measures are restrictions on 13 Russian banks and 3 financial institutions, the diplomats said. The sanctions would also place restrictions on the use of 11 ports and airports in Russia that the EU considers are being used to help Moscow bypass an oil price cap and other measures already imposed by the bloc.



NEW DELHI: The Congress on Wednesday said Prime Minister Narendra Modi has already declared the Adani issue to be a personal matter and asked whether he would oblige the US Securities and Exchanges Commission's (SEC) request in the ongoing probe against the business group.

The opposition party's assertion came after the SEC told a federal judge in New York that its efforts to serve its complaint on Gautam Adani and Sagar Adani in the alleged bribery scheme are "ongoing". This included a request for assistance to the Indian authorities.

Congress general secretary in-charge communications Jairam Ramesh said the SEC has just informed a New York district court that it has sought the assistance of the Modi government to serve complaints on the violations of US laws by Gautam Adani and some of his

to Adani figured in the talks, Modi said at a joint media briefing with Donald Trump in Washington last week: "India is a democracy and our culture is 'Vasudhaiva Kutumbakam'. We consider the whole world as one family. I believe every Indian is mine."

"Two prominent leaders of two countries never discuss such individual issues," he said.

The SEC submitted a status update Tuesday to Judge Nicholas Garaufis at the United States District Court, Eastern District of New York, regarding its efforts to serve its complaint on Gautam Adani and Sagar Adani. sanctions on Russia since President Vladimir Putin ordered his troops into Ukraine in February 24, 2022. More than 2,300 officials and entities – usually government agencies, banks and organizations – have been hit.

The diplomats confirmed approval of the sanctions — the 16th package of measures including travel bans, asset freezes and trade restrictions — on condition that they not be named. The measures are still not entirely finalised until EU foreign ministers endorse them on Monday, allowing them to enter force.

Among the latest sanctions are measures targeting Russia's so-called " shadow fleet " of ships that it exploits to skirt restrictions on transporting oil and gas, or to carry stolen Ukrainian grain.

Trade bans on some chemicals and aluminum are also included.

PM Modi and Trump Forge a New Dawn in U.S.-India Relations

Prime Minister Modi's visit to the United States not only deepened the strategic alliance between the two nations but also set in motion a cascade of initiatives that promise to reshape the geopolitical landscape for decades to come.

In a dazzling display of strategic vision and personal rapport, Prime Minister Narendra Modi's recent visit to the United States in February 2025 has set the stage for an era of renewed cooperation and transformative partnerships between two of the world's most influential democracies. Against the backdrop of an increasingly complex global landscape, the visit showcased a masterclass in diplomacy, marked by high-level meetings, landmark agreements, and an inspiring confluence of ideas that spanned defence, trade, technology, energy, and cultural exchange.

At the heart of this historic journey was the much-anticipated meeting between Prime Minister Modi and President Donald J. Trump in Washington, D.C. In an atmosphere that was as congenial as it was consequential, the two leaders not only reaffirmed the bedrock of the India-U.S. Comprehensive Global Strategic Partnership but also demonstrated a genuine personal rapport that resonated far beyond policy papers and strategic memos. Saudi Arabia's Future and Trump's Plan about Gaza: The Final Solution

As of February 17, 2025, Saudi Arabia's Vision 2030 is progressing rapidly, with over 18,000 projects planned to reshape the country's economy. The initiative, led by crown prince Mohammad bin Salman, aims to reduce dependence on oil and expand sectors such as tourism, technology, and entertainment. One of the latest developments includes partnerships with countries like Pakistan, which is exploring opportunities to send skilled labor to support Saudi Arabia's growing infrastructure and development projects. The kingdom is also focusing on sustainable energy, artificial intelligence, and smart city projects to position itself as a global economic leader. If successful, Vision 2030 will significantly boost employment, foreign investment, and innovation in the region.

In parallel, President Donald Trump has introduced a highly controversial plan regarding the Gaza strip. The proposal involves the U.S. taking control of Gaza, relocating its over 2 million Palestinian populations to neighboring countries, and transforming the area into a commercial and tourism hub. Israeli Prime Minister Benjamin Netanyahu has expressed support for the idea, while Arab nations, including Egypt and Jordan, have rejected it, citing concerns over forced displacement and regional instability. The plan has sparked significant debate, with critics arguing it violates international law and could further escalate tensions in the Middle East. President Donald Trump's proposal to take control of the Gaza strip and relocate its Palestinian population has elicited strong reactions globally. Israeli Prime Minister Benjamin Netanyahu has expressed commitment to the plan, emphasiz-

In the United States, the proposal has sparked intense debate. While the Trump administration defends the plan as a necessary shift in Middle East policy, critics argue it constitutes a violation of international law and could exacerbate regional conflicts. The situation remains fluid, with diplomatic efforts ongoing to address the myriad concerns raised by this unprecedented proposal.

The Saudi Ministry of Foreign Affairs reiterated the Kingdom's unwavering commitment to the establishment of an independent Palestinian state, emphasizing that such a position is "firm" and "non-negotiable." This stance reflects Saudi Arabia's long-standing support for Palestinian Sovereignty and rights.

In response to the proposal, Saudi Arabia has engaged in active diplomacy to address the potential regional implications. U.S. Secretary of State Marco Rubio recently visited Riyadh to discuss the plan and its possible consequences. During these talks, Saudi officials expressed concerns that forced displacement of Palestinians could lead to increased instability in the Middle East. The kingdom is also participating in an emergency Arab summit aimed at formulating a unified response to the proposal, underscoring its commitment to regional stability and solidarity with the Palestinian cause.

President Donald Trump's proposal to assume control over the Gaza strip and relocate its Palestinian inhabitants has ignited significant international and regional controversy. European nations, including Spain, France, and the United Kingdom, Slovenia, Poland, Belgium, and Germany, have expressed strong opposition to any forced displacement of Palestinians, emphasizing the importance of adhering to international law and supporting a two-state solution. In response to Israeli Defense Minister Israel Katz's suggestion that countries critical of Israel's actions should accept displaced Gazans, Spanish Foreign Minister Jose Manuel Albares reaffirmed that "the land of Palestinian Gazans is Gaza," rejecting external directives.

Within the Middle East, Arab nations have

unanimously rejected the proposal, citing concerns over regional stability and the rights of the Palestinian people. Egypt is formulating its own plan to reconstruct Gaza without displacing its residents, focusing on establishing secure areas and collaborating with international partners for infrastructure rehabilitation. This initiative underscores a collective regional effort to counter proposals perceived as undermining Palestinian sovereignty and exacerbating tensions in the region.

Conclusion

Saudi Arabia's firm stance against the displacement of Palestinians positions it as a key diplomatic player in shaping the region's future. As the Kingdom continues its Vision 2030 economic reforms, it also seeks to balance its growing ties with the West while maintaining solidarity with the Palestinian cause. Saudi Arabia's leadership in the Arab world will likely influence in the Arab world will likely influence broader regional policies, especially as it participates in diplomatic initiatives to counter Trump's Gaza plan. Its role in upcoming negotiations may determine whether a peaceful resolution, aligned with international law. can be achieved.

For Gaza, the future remains uncertain. If the U. S. and Israel push forward with plans for forced relocation, tensions could escalate, leading to long-term instability. However, regional efforts, including Egypt's reconstruction proposal, offer an alternative path that prioritizes Palestinian sovereignty. The outcome will largely depend on international diplomatic efforts and the willingness of global powers to enforce a fair solution.

State Taxes Department Kashmir Intensifies Inspection Drive to Curb GST Violations

SRINAGAR: Following the directions of Commissioner State Taxes J&K, P.K. Bhat, State Taxes Department Kashmir has intensified its enforcement efforts against taxpayers involved in sale suppression and tax evasion by launching a large-scale inspection drive across the Kashmir division.

Based on intelligence inputs generated through advanced AI tools such as Business Intelligence and Fraud Analytics (BIFA), E-Way Bills Portal, Field Enforcement teams, information received from various wings of the department and extensive taxpayer scrutiny, the department, under the supervision of Additional Commissioner, State Taxes (Administration & Enforcement) Kashmir, Parvaiz Ahmad Raina, conducted massive first of its kind inspection, search, and seizure drive in Srinagar, Budgam and Anantnag districts of the valley.

The drive aims to curb fraudulent activities, including fake Input Tax Credit (ITC), willful tax evasion, tax fraud, fake invoicing, and non-compliance with GST provisions with an aim to safeguard the revenue of state exchequer. Eight teams comprising of more than 70 officials constituted by Additional Commissioner, led by State Tax Officers, simultaneously inspected multiple business establishments in Srinagar, Budgam and Anantnag, verifying documents, stock registers, bill books, and physical stock positions to detect GST violations. Meanwhile, several documents were seized for further investigation. Speaking on the enforcement action, Additional Commissioner stated, "The inspections are part of our ongoing enforcement activities. Eight dedicated teams involving more than 70 officials have been deployed to carry out these inspections across the division, targeting dealers involved in sale suppression, fake ITC claims, and fraudulent invoicing." He further added that the primary objective is to create a fair and transparent tax environment where compliant taxpayers are protected, and unfair trade practices are curbed.

SRINAGAR: Commissioner Secretary, Information Technology, Saurabh Bhagat, today held a meeting at Civil Secretariat to review various aspects of Aadhaar generation and updation in Jammu and

The meeting was attended by Iftikhar Hussain Chauhan, Director Finance, IT Department; Meenakshi Vaid, Additional Secretary, ITD; Malika Raina, Under Secretary, ITD; Sh. Shoaib Khan, State Project Manager, UIDAI, J&K and other officers and officials.

The meeting was informed that J&K in collaboration with the Unique Identification Authority of India (UIDAI) organises Aadhaar camps across all districts regularly. Further, in order to facilitate Aadhaar generation for newborns using verified birth certificates, Aadhaar enrollment facilities have been established in hospitals too.

Pertinently, for Aadhaar updation, UIDAI has launched a campaign across all districts of Jammu & Kashmir, urging Aadhaar holders to update their demographic details, biometrics, mobile number and supporting documents. The importance of keeping Aadhaar details such as name, age, date of birth, biometrics and other records, updated, was stressed upon in the meeting.

To support this effort of Aadhaar generation and updation, UIDAI, in collaboration with departments like School Education Department, ICDS Poshan, Banks and the Department of Posts, has established over 1000 Aadhaar centers in the Union Territory.

More centers are being set up to make the process more accessible to the residents.

The residents who received their Aadhaar over 10 years ago and have not updated their details are advised to update their Aadhaar so as to avoid its suspension. Updates can be completed online or offline at the nearest Aadhaar center by submitting any proof of identity and address.

During the meeting, the Commissioner Secretary underscored the significance of Aadhaar as a document for accessing government services and benefits. He urged upon the residents, particularly those who have not updated their Aadhaar in over a decade, to update their demographic details, biometrics, and supporting documents. He also appealed the parents to ensure their children's Aadhaar biometric details are updated at the age of 5 and 15 to keep their Aadhaar active.

The Commissioner Secretary laid emphasis on the need that all departments should work collaboratively with IT Department and UIDAI to further intensify efforts to achieve 100% Aadhaar saturation in the UT, expeditiously.

Saurabh Bhagat further instructed the concerned officials to intensify outreach programs and provide adequate resources to facilitate Aadhaar updates for the residents of the region. Meanwhile, the Commissioner Secretary also highlighted the importance of Aadhaar authentication in various services and schemes for Good Governance and Direct Benefit Transfer to the eligible beneficiaries.

Sleep to Clean Your Brain And Prevent Neurodegeneration

Rainwashing, more scientifically known as brain waste clearance, is a processduring which harmful waste products, so called "biological trash", is removed from your brain. This is crucial for optimal brain functioning and to lower the risk of neurodegenerative diseases such as Alzheimer's disease, Parkinson's disease and dementia, which are associated with buildup of suchharmful waste products. Only recently scientists discovered that your brain is cleaned only when you are sleeping.

Waste products build up in the body and brain throughout the day

First you might be wondering what needs to be cleaned and removed here? What is "biological trash"?

Throughout the day all cells in our body produce leftover molecules and metabolites due to cellular activity. There is also cellular debris and other harmful toxic molecules that get into our body from the surrounding environment. Moreover, due to various internal and external factors such as our genetic predispositions and UV exposure, certain proteins in our body might change their structure, lose their normal function and become harmful. All of these molecules need to be removed from our body to avoid health problems and disease.

Brain has a different system to clean waste products than the rest of the body

Our body has a wonderful "cleaning system" that removes such "biological trash" and detoxifies our tissues, called the lymphatic system. It consists



of specific lymphoid organs, such as thymus, bone marrow and lymph nodes, lymphatic vessels and a fluid called lymph that circulates throughout our body and removes excess fluid and waste products.

However, not even a single trace of the lymphatic system is detected inside our brain. This is rather surprising as the brain is the most active organ of our entire body and therefore is likely to produce most waste products. In 2012 a groundbreaking study was published which showed that our brain has a different kind of waste clearance system than the rest of the body.

The study described the anatomical pathways and the working principle of the brains' waste disposal system, which was given the name of the glymphatic system. Apparently, the brain uses a system of tunnels that are formed around the brain's blood vessels by special brain cells called the astrocytes. Astrocytes belong to a group of so-called glial cells, hence the name glial + lymphatic = glymphatic. A special brain fluid called the cerebrospinal fluid flows in these tunnels and then through our brain, collecting waste from around the brain cells and then draining it out of the brain and out of our body.

Brains' waste disposal system is ON when we sleep

Another groundbreaking study was released just a year later in 2013 which showed that waste

products from the brain are removed almost only during sleep. Scientists injected a green dye into the brain of mice after which half of the mice went to sleep and the other half stayed awake. After two hours scientists checked how much of the green dye was left in the brains of these mice.

Surprisingly, brains of mice which stayed awake were still full of the green dye, while the brains of the ones that slept barely had any trace of green dye. These results indicated that substances are removed from the brain much faster during sleep when compared to being awake.

Now many studies in various animal species including humans support the finding that our brains are cleaned from harmful molecules almost exclusively during sleep. For example, a 2018 study with 20 healthy adults showed that a single night of no sleep is associated with significant increase in levels of a specific brain waste product, a protein called amyloid-beta.

A 2021 study investigated how well an externally delivered molecule is cleaned from the brain if you sleep compared to if you don't sleep. Scientists delivered a special molecule called contrast agent into the brains of patients. Half of them were allowed to sleep and half were asked to spend one night not sleeping. When scientists scanned the brains of these 2 groups of patients, they found higher levels of the contrast agent in the no-sleep group compared to the group that slept. This means that even one night of sleep deprivation impairs brain waste clearance.

Too little sleep increases the risk of neurodegenerative diseases

Build-up of certain waste products in the brain is associated with increased risk of neurodegenerative diseases, such as Alzheimer's, Parkinson's diseases and dementia. Now we know that our brain is cleaned and waste products removed when we are sleeping. This would mean that if we don't get enough sleep, we expose ourselves to higher chances of neurodegenerative diseases.

For example, one study examined nearly 8000 people and found that people who slept six hours or less per night in their 50s and 60s were 30% morelikely to develop demential aterin life compared to those who slept 7 hours or more every night.

Another study investigated nearly 700 individuals who due to their genetic make-up were at risk of developing Alzheimer's disease. Researchers found that better sleep reduced the likelihood of developing clinical Alzheimer's disease and even reduced the amount of harmful proteins in the brain.

A recent 2020 study showed that sleep disturbances early on can even forecast how much of the harmful protein amyloid-beta will accumulate in a person's brain. The worse people sleep, the more likely they are to end up having larger amounts of amyloid-beta in their brain which is known to increase the risk of neurodegenerative diseases.

The build-up of waste products in our tissues is a physiological process that happens due to cellular activity. As long as these waste products are efficiently removed, we should not worry. Now we know that our brain has a different kind of waste disposal system than the rest of our body, which interestingly is ON only when we sleep. Therefore, make sure to get enough sleep every night to keep your brains "clean" (literally), and to reduce your risk of developing neurodegenerative diseases!

Study Finds Way to Help Teenagers Get More Sleep

Following a long summer of late nights and even later mornings, it can be hard for teenagers to readjust to a school schedule in the fall. A disturbed sleep schedule and lack of sleep can lead to fatigue, poor performance in school, and changes in mood and focus. Therefore, supporting teens and finding ways to help them get more sleep is crucial.

Although preliminary, the study's findings suggest that light therapy is a promising intervention for sleep problems in teenagers. It's also non-invasive, relatively low-cost, and could be easily implemented at home.

The importance of sleep

Restorative sleep is critical for health. During sleep, the body rests and repairs itself. It's also when the brain consolidates memories and new information.

The benefits of a good night's sleep are especially important for teenagers, who are still growing and developing. They need a minimum of 8 to 10 hours each night.

Without enough sleep, the risk of chronic health conditions issues increases. These include:





establish a baseline. Then, they received bright light therapy for 2.5 hours on the 2 weekend mornings. Bright light therapy, also known as phototherapy, is similar to sunlight. Exposing the eyes to intense but sale amounts of light for a specific and regular length of time resets the internal clock and helps shift the circadian rhythm. The therapy involves sitting in front of a light box for a predetermined amount of time. The participants gradually advanced their weeknight bedtime to 1 hour earlier than baseline during the first week and 2 hours earlier during the second week. They also received personalized time management plans-Sleep RouTeen-to help facilitate earlier bedtimes. The control group who didn't follow the same light therapy protocol slept as usual and had no evening time management plan. The weekday sleep onset time and duration were measured with sensors. Ultimately, the researchers shifted the teenagers' bedtime by 1.5 hours and increased total sleep time by 1 hour each night through the intervention. Plus, the teens felt less tired, irritable, and worried and had improved concentration and alertness. The authors noted that the participants with late circadian clocks shifted their sleep by up to 2 hours earlier. However, those with an earlier circadian clock didn't shift their bedtime but benefited from the behavioral support of time management to increase sleep duration.

Women are more likely to have sleep issues than men — creating the need to catch up on sleep. Women are also more prone to developing various sleep disorders such as insomnia and restless legs' syndrome. Let's review the most common sleep issues that tend to affect women more than men.

Heart disease; Kidney problems; High blood pressure; Diabetes; Stroke; Obesity.

Sleep deficiency also contributes to mental health problems like anxiety and depression, moodiness and irritability, impaired judgment, and increased accidents and injuries. Although getting enough sleep is critical, around 7 in 10 high school students in grades 9

to 12 don't get enough sleep on school nights.

Teenagers and sleep issues

The teenage years are a time of significant physical and emotional changes. Teens also experience changes in their sleep biology, meaning they tend to go to bed and wake up later.

The reason is a shift in the body's 24-hour circadian rhythm — the internal process that regulates the sleep-wake cycle. As a result, teens may develop delayed sleep phase syndrome (DSPS).

DSPS is a common condition that's accentuated during adolescence when there are two competing forces — the pressures of a school schedule and the need to go to bed early and the biological changes in the body. The result is that many teenagers are sleep-deprived.

How light therapy could help

The conflicting relationship between the shift in circadian rhythm and the need for an early night's sleep prompted researchers' interest in light therapy. In the Sleep study, they tested a 2-week intervention focusing on the circadian system and using various behavioral measures. The aim was to help teenagers maintain a better nighttime routine.

The researchers recruited adolescents who typically had late bedtimes and less than 7 hours of sleep each night. For 2 weeks, the participants followed their normal sleep pattern to

Changing sleeping patterns

The research findings suggest that it's possible to change the sleep patterns of young adults with DSPS by manipulating their exposure to light and providing time management strategies.

One significant advantage of light therapy is that it's safe and easy to administer at home. There are various personal light-therapy tools available. , hamin ast (If there is paradise on this earth, it is here, it is here, it is here), Abdullah explained the cultural concept of 'nazar' (evil eye), suggesting that the region's beauty has often been overshadowed by challenges.

He reminisced about the significance of J&K in Indian culture, mentioning that no honeymoon was complete without a stay on the houseboats of Dal Lake, and that Bollywood films often featured the region's picturesque landscapes including mustard fields or from the snow-capped mountains of Kashmir.

However, the chief minister said that "Jammu and Kashmir is not resting on its laurels or trying to sell you a sob story...Jammu and Kashmir has something for everyone...Jammu and Kashmir is the right place now for any investment in the tourism industry".

Abdullah asserted that J&K is a year-round destination, suitable for pilgrims, wedding celebrations, adventure seekers, and those looking to unwind in a scenic environment.

"Jammu is known as the city of temples, and there is significant potential for heritage and border tourism. Places like Gurez, once relatively unknown, are now among the fastest-growing tourist areas," he said.

"...Kashmir border tourism on the Line of Control with Pakistan, whether we talk about Tangdhar, Machil, Karnah or Keran, these areas are seeing increasing numbers of visitors. J-K is about new meadows like Bangus and Doodhpathri," he said.

The chief minister also referred to the potential of adventure tourism and said rafting in rivers, skiing in mountains, water skiing in Dal lake and Mansbal lake are yet to be fully explored.

"I have often said J-K is heaven on earth long before Kerala became the God's own country. Please look at J-K as a destination for your next holiday, for your next visit, or for holding your conference or seminar," he said.

Abdullah pointed out the region's increasing focus on wellness and sports tourism, referencing upcoming marathons planned for the area.

Highlighting improvements in connectivity, Abdullah noted that direct rail links between Kashmir and the rest of the country are expected to be operational soon.

"Travelling to Kashmir has become significantly easier than in the past when there were only a few flights connecting Delhi and Srinagar. Today, there are direct flights from various cities, and soon, rail connectivity will further enhance accessibility," he added.

CS For Framing

The Chief Secretary issued several key directives regarding framing of incentive based policy for digitization of valuable manuscripts lying with the public. Observing the current status of different architecture and heritage conservation projects, the Chief Secretary asked the department of Archaeology & Archives to intensify the restoration efforts, ensuring visible progress on ground. The department was also impressed upon to utilize released funds effectively to meet project deadlines.

As far as the cultural revitalization of Mubarak Mandi Heritage Complex (MMHC) is concerned, the Divisional Commissioner, Jammu, was directed to transform MMHC into a culturally vibrant space by organizing cultural evenings in collaboration with the Academy of Art, Culture & Languages.

The Chief Secretary also emphasized upon the need for adaptive reuse of restored structures at MMHC. He tasked the Department of Archaeology with developing a robust reuse plan for restored structures at MMHC. He noticed that failure to repurpose these structures would undermine the restoration efforts made so far. He maintained that keeping such structures idle would render them into dilapidation which is highly unacceptable.

Regarding engagement of Transaction Advisor (TA) for heritage hotel at MMHC, the Chief Secretary advised the concerned to approach the Finance Department seeking their guidance on engaging TA for the adaptive re-use of this valuable heritage property. This included the proposed heritage hotel, to be developed under the Public Private Partnership (PPP) model on a Design, Build, Finance, Operate and Transfer (DBFOT) basis for development of sustainable tourism in the Jammu city.

In order to promote the region's cultural heritage, the Chief Secretary called for instituting awards recognizing outstanding contributions in preserving J&K's cultural identity. He also suggested holding painting competitions highlighting the lives and contributions of saints like Lalla Ded to educate younger generations and inculcate in them the aesthetic value of our significant heritage and traditions prevalent here in the past.

The Chief Secretary reviewed the progress made in formulation of Detailed Project Report (DPR) for modernization of SPS Museum, Srinagar, and instructed its finalization within 15 days. He emphasized upon taking up this work for execution in the upcoming summer season.

Latham and Young centuries hand New Zealand thumping victory

New Zealand 320 for 5 (Latham 118*, Young 107, Phillips 61, Naseem 2-63) beat Pakistan260 (Khushdil 69, Babar 64, O'Rourke 3-47, Santner 3-66) by 60 runs

akistan had to wait for nearly three decades for a global tournament to return to their country, but New Zealand spoiled their party on the opening day of the Champions Trophy, handing the co-hosts a 60-run loss in Karachi. In a short, sharp tournament, where each team plays just three group-stage games, a defeat like this might jeopardise Pakistan's chances of making the semi-finals. Will Young and Tom Latham were the architects of their team's victory, both batters scoring outstanding hundreds to set up the dominance that followed but there was also a little bit of luck.

Two balls into the game, Fakhar Zaman suffered an injury while chasing a cover drive from Young and was forced off the field for large parts of the first innings. As result of the time spent off the field, Fakhar, whose big hitting is exactly what was necessary for a big chase, could not open the batting in their pursuit of 321. And when he came out to bat at No. 4 - Pakistan were 22 for 2 in ten overs at the time - he was visibly hampered while running between the wickets. New Zealand's offspinners, Michael Bracewell and Glenn Phillips, kept hiding the ball away from his reach and made life even more difficult for him. Fakhar's tortured stay eventually ended when Bracewell bowled him with a non-turner



for 24 off 41 balls. Just like Fakhar, most of the Pakistan batters failed to get out first gear, including Babar

Azam who needed 81 balls for his fifty. New Zealand's attack was depleted by the injuries to Lockie Ferguson and Ben Sears, but their

It was Pakistan's lowest score in the first ten overs since March 2019 and third lowest in the history of the Champions Trophy. There would be no way back for them, despite late blows from Khushdil Shah, who hit 69 off 49 balls, and the lower order. Pakistan were ultimately bowled out for 260 in the 48th over.

spinners made up for that on a pitch that offered turn and variable bounce. The spinners were so good that New Zealand didn't need Nathan Smith, their third seamer, until the 31st over. By then Pakistan's asking rate had almost touched ten an over. New Zealand were also depleted by the injury-enforced absence of Rachin Ravindra, but Young and Latham scored tone-setting hundreds before Glenn Phillips provided an electric finish. In all, New Zealand plundered 113 off their last ten overs to finish with 320. That total, however, had looked so far away when New Zealand were reduced to 40 for 2 in the ninth over and then 73 for 3 in the 17th over. That's when Young got together with Latham to repair the early damage and then boss the middle overs.

Young has spent much of his international career on the fringes. He might not have played this game had Ravindra been fit and despite his maiden international hundred away from home, he might make way for Ravindra once the allrounder recovers. In Kane Williamson's absence, Young had emerged as the Player of the Series in New Zealand's historic 3-0 sweep of India in India but was left out for Williamson in New Zealand's very next Test against England at home. However, whenever Young gets an opportunity, he's ready to take it, like he demonstrated once again on Wednesday.

After Devon Conway was undone by a carrom ball from mystery spinner Abrar Ahmed for 10 and Williamson fell for his first singledigit ODI score in six years, in the next over, Young reined himself in and saw off challenging spells from Abrar and Naseem Shah.
