J&K Govt Committed To Holding Panchayat, Urban Local Body Polls: LG

JAMMU: The Jammu and Kashmir government is committed to strengthening Panchayati Raj Institutions and urban local bodies by ensuring timely elections at all levels. Lieutenant Governor Manoj Sinha said on Monday.

The Jammu and Kashmir Local Bodies Dedicated Backward Classes Commission, established in June 2023 to conduct empirical studies on Other Backward Classes (OBC) representation, submitted its final recommendations to the government last week, brightening the outlook for polls to local bodies.

Municipal bodies, panchayats and block development councils in the Union Territory have been without elected representatives for more than a year.

Acted swiftly to prevent panic after Maha Kumbhstampede: Yogi

LUCKNOW: Uttar Pradesh Chief Minister Yogi Adityanath on Monday said his government acted swiftly to control the situation after the January 29 stampede at the Maha Kumbh in Prayagraj, ensuring timely medical aid for victims while preventing widespread panic.

Addressing a gathering of Indian Institute of Management (IIM) and Indian Postal Service officials in Lucknow, Adityanath said, "We did not allow the incident to be excessively highlighted, as eight crore devotees and sadhus were present in Prayagraj and the Kumbh Mela area at the time, and panic could have worsened the situation."

At least 30 devotees were killed and 60 others injured in the stampede at the Sangam ghat on Mauni Amavasya, a key bathing day of the Maha Kumbh. Adityanath noted that apart from millions of devotees, seers and sadhus from 13 Akhadas were

also scheduled to take the ritualistic 'Amrit Snan' (holy dip) that morning.

He explained that two major challenges often arise in such events – determining the bathing order among the Akharas, which has historically



led to disputes, and ensuring the ritual proceeds smoothly at the scheduled time of 4 AM. Despite the tragedy, all Akhadas were prepared

- to go ahead with the 'snan', but the administration
 - intervened to postpone the event. "I personally requested them to delay the ritual

to manage the situation," Adityanath said, adding that officials closely monitored the crowd, evacuated the Sangam area by noon, and ensured the 'snan' resumed by 2:30 PM.

He underscored the importance of effective crisis management, stating, "In difficult situations, many people panic and give up, but we must develop the strength to make firm decisions with patience and control."

The chief minister also emphasised the importance of effective coordination among stakeholders, including devotees, sadhus and administrative officials.

"I personally initiated dialogues to maintain order and ensure smooth execution of the event," he said.

The Maha Kumbh, held once every 12 years, attracts millions of pilgrims from across the world, making crowd management a critical challenge for authorities.

This year, over 66 crore pilgrims attended the religious event, according to the Uttar Pradesh government.

NEP will not impose Hindi, TN's claim unfounded, political: Education Minister Pradhan

NEW DELHI: Union Education Minister Dharmendra Pradhan on Sunday asserted that the New Education Policy would not impose Hindi on states and Tamil Nadu's opposition had "political reasons" behind it.

"We have never said in NEP 2020 that only Hindi will be there; we have only said that education will be based on mother tongue, in Tamil Nadu, it will be Tamil," Pradhan told reporters here.


The comments by the Education Minister come amid a tiff between the Tamil Nadu government and the Centre over the implementation of NEP and the three-language policy.

"I don't want to answer to the political ambitions of few people. NEP 2020 is focused on different languages of India, be it Hindi, Tamil, Odia, or Punjabi. All the languages have equal importance. In Tamil Nadu, few are opposing because of politics," Pradhan said.

SC agrees to examine plea over blocking of social media content

on Monday agreed to examine a plea over issue of blocking of social media accounts or content without



"I am not on either X, Y or Z," he said. The bench said an identifiable

person, who was not given a notice and was aggrieved, could approach the court.

The plea said there were numerous instances of websites, applications and social media accounts being blocked without a notice or an opportunity to be heard.

"The blocking rules, 2009, in their present form, effectively allow the respondents to block online content posted by citizens without providing any rationale and without affording any chance for the owner or poster of the content to be heard," it said.

The 2009 rules, the plea said, also mandated all complaints and requests made for blocking of content were to be kept confidential.

"This position of law results in a citizen being deprived of their fundamental rights under Article 19(1)(a) and 21 of the Constitution and confronted with the (metaphorical)

'inscrutable face of a sphinx'," it said. Meghwal calls for safer digital space for women, urges vigilance against cyber crimes

Sumbal Court Sentences Man to 1-Year Jail, **Rs 12 Lakh Fine in Cheque Bounce Case**

BANDIPORA: A local court in Sumbal convicted and sentenced a man to one year of simple imprisonment and imposed a 12 lakh fine in a cheque bounce case under Section 138 of the Negotiable Instruments (NI) Act.

Judicial Magistrate 1st Class Sumbal, Rahila Rashid, delivered the sentence after finding Ghulam Hassan Bhat of Kathpora Hajin guilty of issuing a dishonored cheque to the complainant, Bashir Ahmad Dar of the same village.

The case, filed in 2017, involved financial transactions where the accused failed to honor his legal obligations resulting in cheque bounce.

While the defense argued for leniency, citing that the offense was financial in nature and not one of moral turpitude, the complainant's counsel stressed that dishonoring a cheque undermines public trust in financial transactions and called for strict punishment.

After considering both sides, the court ruled that a balance needed to be maintained between deterrence and compensation. The judge ordered

the convict to serve a one-year jail term and pay 12 lakh in compensation to the complainant. The convict has been directed to serve the sentence at District Jail Pulwama.



Counsel for the convict Advocate Tariq M Shah submitted that offense carries a maximum punishment of two years imprisonment or fine up to twice the cheque amount or both, so Court may take a lenient view while deciding the quantum of sentence the offense under Section 138 NI Act is not one involving moral turpitude, violence, or grave threat to public safety.

"It is a financial dispute that essentially arises from a commercial transaction or business dealings, and hence, the primary objective of the law is to ensure compensation rather than punitive punishment".

Advocate Shah further submitted that the Supreme Court has repeatedly held that in cases under Section 138 NI Act, the primary focus should be on compensating the complainant rather than punishing the accused with imprisonment and section 138 should be guided by principles of proportionality, ensuring that the complainant receives the due amount rather than merely punishing the

drawer of the cheque. However, Counsel for complainant Advocate Jalal-Ud-Din prayed for stringent punishment, considering the circumstances of the case and the

legislative intent behind Section 138 NI Act. "A lenient approach would defeat the purpose of the law and encourage financial defaulters to misuse the process, leading to loss of trust in commercial transactions. The dishonor of a cheque is not merely a financial dispute but an act that shakes public confidence in negotiable instruments," complaint submitted before the court.

Counsel for complainant stated that Section 138 NI Act aims to deter unscrupulous drawers who issue cheques without sufficient funds.

"A strict sentence will act as a deterrent against future offenders who might otherwise exploit the leniency of the law. The convict has failed to honor their legal obligation despite being given opportunities to clear the dues. The convict's conduct showed a deliberate attempt to evade liability, warranting a stricter sentence," he prayed before the court.

After hearing both the parities, court observed that a balance must be struck between deterrence and compensation. "While the offence does not warrant the maximum sentence, mere imposition of a fine would not serve the ends of justice given the convict's conduct," court observed and sentenced for simple imprisonment of one year. Additionally, the convict was directed to pay a fine of 12,00,000/-(Rupees Twelve Lakhs) as compensation towards the complainant.

Hajin Residents Protest Against Water Shortage

HAJIN, BANDIPORA: Amid the holy month of Ramadhan, Hajin town in North Kashmir's Bandipora district is facing an acute shortage of drinking water, leaving thousands of residents distressed.

Locals including women on Monday took to the streets and blocked the road near the main market to press for their demands.

They accused the district administration and concerned authorities of failing to provide an adequate water supply to the town, which has a population of nearly 20,000.

According to residents, the issue arose after a road cave-in damaged the water supply pipes. Despite the passage of several days, the authorities have yet to restore the supply, leaving people without access to drinking water.

The protesters urged the district administration to take immediate steps to repair the damaged pipelines and restore the water supply to prevent further inconvenience during the sacred month.

"Authorities are ignoring our grievances, forcing us to fetch water from wells and rivers for our daily household chores," a local resident said.

"It has been 13 days since our taps ran dry, yet no action has been taken," another resident lamented, adding that the crisis has made fasting even more difficult.

"During Ramadhan, water consumption increases, especially during Sehri and Iftar. It is extremely challenging to observe fasts without a proper water supply," they added.

Residents have appealed to the authorities to address the crisis at the earliest to ease their hardships during this holy month.

Talking to Kashmir Convener, Tehsildar Hajin Abdul Wasi-ul-Rouf Deva, assured that the water crisis would be resolved soon. He said that water has already been supplied to the affected areas through three water tankers on a routine basis.

Meanwhile, Junior Engineer (JE) of the Public Health Engineering (PHE) department assured this reporter that the water supply would be restored within two days.

"We are laying new pipes from tomorrow to ensure the water supply is restored in Hajin," he said.

Heavy Snowfall Paralyzes Gurez Valley: Roads Closed, **Exams** Postponed

BANDIPORA: A fresh wave of heavy snowfall has blanketed the Gurez Valley in North Kashmir's Bandipora district, leading to the closure of the crucial 85-kilometer Gurez-Bandipora road.

The heavy accumulation of snow at Razdan Pass necessitated the road closure, disrupting daily life and isolating the valley.

The valley continues to experience intense snowfall, affecting regions including Dawar, Kanzalwan, Bagtore, Niru, and Tulail. Snow accumulation varies, with Markoot reporting 10-12 inches, Bagtore and Kanzalwan 11-13 inches, and Tulail a substantial 18-20 inches. In response, the district administration has initiated snow clearance operations to restore vital connectivity.

Further compounding the disruption, the Principal of Government Degree College (GDC) Gurez announced the postponement of the BG1st semester (Batch 2024) examination, originally scheduled

"Illegal Mining Mafia Destroys Twin Sports Stadiums in Bandipora" Nasir Khuehami Seeks CM's Intervention

BANDIPORA: Alleged illegal sand mining to train and compete. has devastated two major sports stadiums in Bandipora–Baba Kareeme Sports Stadium and Adnan Sports Stadium—leaving behind barren pits where athletes once trained, Student leader Nasir Khuehami alleged on Sunday.



In a statement issued to Kashmir Convener, Khuehami said the rampant mining, carried out in broad daylight, has sparked outrage, with Jammu and Kashmir Students Association National Convenor urging Chief Minister Omar Abdullah to intervene immediately.

Khuehami expressed deep anguish over the destruction, stating that both stadiums, once vibrant centers for cricket and football, have been reduced to ruins due to unchecked sand extraction. Goalposts have been shattered, cricket pitches worth lakhs have been destroyed, and the stadium boundaries have been erased. The unregulated use of JCB machines and tractors has turned these fields into excavation sites, depriving thousands of young players of a place for today, March 3, 2025. This decision was made following verbal orders from the Controller of Examinations, University of Kashmir.

"The revised date for the postponed examination will be announced separately," an official told, "Students are advised to stay updated with official notifications from the college administration."

Deputy Commissioner Bandipora, Manzoor Ahmed Qadri, addressed the situation, stating, "Since vesterday, we have experienced moderate snowfall in the plains of Bandipora and heavy snowfall in the hilly areas. The Essence of Islam: Harmonizing Devotion with Universal Welfare

Islam from Salam (salama), in its primary sense, means to be tranquil, at rest, to have done one's duty, to have paid up, to be at perfect peace; striving after righteousness; in its secondary sense, to surrender to Him with whom peace is made.The noun derived from it means peace, greeting, safety ,salvation.The essence of the ethical principles involved and embodied in Islam is summarised in the second chapter of the Koran:" There is no doubt in this book- a guidance to the pious, who believe in the Unseen, who observe the prayers, and distribute (charity) out of what we have bestowed on them; and who believe in that which we have commissioned thee with, in that we commissioned others with before thee, and who have assurance in the life to come; -these have received the direction of their Lord."

The bases on which the Islamic system is founded are; a belief in the unity, immateriality, power, mercy and supreme love of the creator; 2) charity and brotherhood among mankind; 3) subjugation of the passions; 4) the outpouring of a grateful heart to the Giver of all good; 5) accountability for human actions in another existence. Appeal is made to the inner consciousness of humanity. The divine love and mercy of Allah enfolds creation. There are five most fundamental qualities for being truly religious without which one can claim to be religious but hardly qualify to be one, These are 1) Constant quest for truth; 2) to be humble 3) to be compassionate 4) to be transcendent invision 5)to be against myopic and imperfect establishment. The Auther of the Kashshaf thus sums up the essence of the Islamic teaching :"Seek again him who drives you away; give to him who takes away from you; pardon him who injures you; for Allah loveth that you should cast into the depth of your soul the roots of His perfection." Zamakhshari (the kashaf).

Islam, as a universal and timeless faith, transcends the confines of ritualism to embrace a comprehensive vision of spiritual and societal well-being. Rooted in the divine revelation of the Qur'an and exemplified by the life of the Prophet Muhammad (peace be upon him), it offers a holistic framework for individual transformation and collective welfare. The essence of Islam lies in its emphasis on justice, compassion, and balance, ensuring that acts of worship are deeply integrated with the service of humanity. However, contemporary practices often reflect an overemphasis on external rituals, such as repetitive pilgrimages and lavish mosque constructions, at the expense of addressing critical societal needs like poverty, education, and healthcare. This dissonance calls for an urgent reexamination of Islamic teachings, where the core ethos of "all-sided welfare of all" is revived. By exploring Qur'anic injunctions, Hadith guidance, jurisprudential wisdom, historical precedents, and cross-cultural parallels, this study seeks to illuminate Islam's profound call for compassion and justice, offering rare and transformative insights that challenge prevailing paradigms and inspire a realignment with its true spirit.

The Qur'an profoundly articulates the essence of Islam as a harmonious integration of faith, justice, and universal welfare. True righteousness, as outlined in Surah Al-Baqarah (2:177), transcends ritualism, emphasizing belief in Allah and acts of compassion toward the needy, orphans, and society's vulnerable. This verse encapsulates the comprehensive nature of Islamic ethics, where belief in Allah is intricately tied to acts of charity and justice. Islam demands justice without bias (4:135) and stresses equality, as reflected in the principle of universal brotherhood (49:13). Wealth is not to be hoarded but shared for societal upliftment (9:34-35; 59:7), with charity likened



to seeds that multiply manifold (2:261). The Qur'an inspires balance between worldly and spiritual pursuits (28:77) while reminding humanity of their accountability for even the smallest deeds (99:7-8). It promotes forgiveness, compassion (3:134; 42:40), and reflection on divine wisdom (39:9; 47:24), urging believers to align devotion with active service for the collective good. These timeless teachings embody Islam's universal vision of justice, equity, and moral responsibility, uniting spiritual devotion with a commitment to the welfare of all. Similarly the teachings of the Prophet Muhammad (peace be upon him) emphasize a profound balance between devotion to Allah and service to humanity, showcasing Islam's holistic approach to universal welfare. Similarly, the Prophet Muhammad (peace be upon him) emphasized that the highest form of worship lies in serving humanity, stating, that "The best of people are those who are most beneficial to others" (Al-Mu'jam Al-Awsat, Hadith 5787), and underscored the importance of caring for neighbors, declaring, "He is not a believer whose stomach is filled while his neighbor goes hungry" (Musnad Ahmad, Hadith 14494). Compassion and mercy were central to his message, as he affirmed, "Allah will not show mercy to him who is not merciful to others" (Sahih Bukhari, Hadith 6013). The Prophet encouraged acts of justice and charity, teaching that "The most beloved of deeds to Allah is to make a Muslim happy, to relieve him of hardship, to forgive his debt, or to feed his hunger' (Tabarani, Al-Mu'jam Al-Kabeer, Hadith 13646). He further emphasized the value of simplicity, warning against extravagance, and reminded that "Wealth does not decrease by giving in charity" (Sahih Muslim, Hadith 2588). Social service was regarded as a spiritual act, with the assurance that "Whoever fulfills the needs of his brother. Allah will fulfill his needs" (Sahih Bukhari, Hadith 2442), and fairness in dealings was paramount, as he advised, "Pay the worker his wages before his sweat dries" (Sunan Ibn Majah, Hadith 2443). These timeless Hadiths highlight the Prophet's call for sincerity in faith, social equity, and the fulfillment of collective responsibilities, demonstrating Islam's enduring vision for individual and societal well-being.

The Prophet(pbuh) said: Ostentation is a sort of polytheism(shirk) and the reason as explained by al-Ghazali, is that when he said:if somebody worships for Ostentation is a worship of one's self not of Almighty Allah.In the charter of humanity uttered by prophet pbuh above the Jabal ar Rahman, he reminded;constant redistribution and circulation of the private wealth to intended beneficiaries as prescribed by the Quran (9:60) to avoid accumulation in the hands of few(hoarding)which called by jurists as zakat or fiscal duty or ibadat maliyah (worship of Allah by means of property).The Prophet pbuh used to spend the sadaqat on orphans, weaklings and poors: till they earn their livelihoods by themselves.

The essence of religion, particularly Islam, as envisioned by Mulla Sadra, Syed Nursi, Meister Eckhart, Schuon, alongside other key mystics who have emphasized the harmonization of devotion with universal welfare, from earliest to more recent times, include Rabia al-Adawiyya, Fudayl ibn Iyad, Al-Ghazali, Ibn Arabi, Rumi, Bahauddin Naqshband, Shah Waliullah al-Dihlawi, and Ibn Ata Allah al-Iskandari. These figures have significantly contributed to the understanding that spiritual devotion is inherently tied to the welfare of humanity, advocating for compassion, justice, and love in both personal and collective contexts.Ibn Khaldun's thought demonstrates that Islam's true essence lies in the integration of individual devotion with social welfare, where ethical governance, justice, and resource management create a harmonious, flourishing society. His insights provide a time-

less framework for aligning spiritual commitment with the collective good, ensuring sustainable progress and justice for all. Nasr's "The Heart of Islam" emphasizes that devotion to God in Islam is intrinsically linked to social responsibility, justice, and compassion, offering practical guidance for the welfare of humanity. Similarly, Sayyid Qutb's "Fi Zilal al-Qur'an" asserts that Islam provides a dual framework of personal devotion and societal justice, applying Qur'anic teachings to foster global welfare.

Despite these clear directives, a concerning trend of ritualism has emerged in many Muslim communities. Repetitive non-obligatory pilgrimages, such as multiple Umrahs within short intervals, are often undertaken while pressing societal needs remain unmet. Reports suggest that billions of dollars are spent annually on such pilgrimages, yet many neighbors, relatives, and fellow citizens languish in poverty, unable to afford basic necessities like food, education, or healthcare. The Prophet (peace be upon him) warned against such neglect, asserting, "He is not a believer whose stomach is filled while his neighbor goes hungry" (Musnad Ahmad). This profound hadith underscores that devotion to God is hollow if it is divorced from empathy and responsibility toward others.

A similar imbalance is evident in the construction of extravagant mosques, Consider the millions spent on extravagant house constructions, extravagant mosques, ostentatious life style, wasteful spending, disregard for responsible use of resources, non-obligatory pilgrimages versus the unmet needs of the poor, the uneducated, ailing patients, poor parents craving for their daughter marriage ,widows suffering ,people in debt and the homeless. millions spent on them could transform lives if redirected. Balance, justice and compassion are fundamentals in Islam. While the architectural beauty of mosques is celebrated, their functionality often remains limited. Historically, mosques were centers of learning, charity, and social reform, serving as community hubs that addressed diverse needs. The Prophet's mosque in Madinah, simple yet profoundly purposeful, stands as a testament to this ethos. In contrast, many modern mosques prioritize aesthetics over utility, with millions spent on elaborate structures that do little to alleviate the struggles of the poor or the marginalized. The responsible use of resources in Islam is a holistic concept that integrates spiritual, social, and environmental dimensions. Rooted in divine guidance, it promotes a balance between consumption and conservation, ensuring justice and compassion for all. By embracing these principles. Muslims can contribute to a sustainable and equitable world, embodying the Qur'anic vision of being "a just community" (Surah Al-Baqarah, 2:143) and fulfilling their role as stewards of the Earth.This extravagance not only contradicts the simplicity of the Prophet's example but also represents a misallocation of resources that could be better used to address urgent societal challenges.

Charity and economic justice, central pillars of Islam, are also frequently overlooked. The Qur'an repeatedly commands Muslims to redistribute wealth to ensure societal equity, stating, "And establish prayer and give zakah and bow with those who bow [in worship and obedience]" (2:43). Zakat, Sadaqah, and Khairaat are mechanisms designed to uplift the disadvantaged and reduce economic disparity. However, contemporary statistics reveal that these obligations are often neglected or poorly implemented. A study by the Islamic Development Bank found that less than one-third of eligible Muslims pay Zakat effectively. This failure exacerbates poverty, leaving millions to suffer needlessly while resources remain hoarded by the affluent. Crab Mentality: How Envy And Fear Hold Us Back As A Society

In societies worldwide, a troubling pattern persists when individuals strive for success, innovation, or personal growth, they are often met with resistance—not just from systemic barriers, but from their peers. This phenomenon, sometimes referred to as crab mentality—derived from the way crabs in a bucket pull each other down rather than allowing one to escape—reveals an inherent human struggle between individual aspiration and collective insecurity.

But why does this happen? What drives people to discourage, mock, or obstruct those who seek progress? And more importantly, how can we counteract this tendency to create a culture of support and encouragement instead?

The Psychology of Pulling Others Down At its core, the tendency to undermine others stems from a mix of psychological, social, and cultural factors:

Envy and Insecurity – When someone achieves something we desire but haven't attained ourselves, it can trigger feelings of inadequacy. Rather than addressing our own shortcomings, it's often easier to diminish the accomplishments of others.

Fear of Change – People are naturally resistant to change, and when others break norms or challenge the status quo, it can feel threatening. This is why innovators often face pushback before they are celebrated.

Social Comparison Theory – Psychologist Leon Festinger proposed that individuals determine their own self-worth based on comparisons with others. When someone excels, it can make others feel like they are falling behind, leading to resentment.

Cultural Conditioning – In collectivist cultures, those who stand out may be seen as disrupting harmony, while in hyper-competitive environments, success is often framed as a zero-sum game—where one person's win is perceived as another's loss.

Historical and Real-World Examples

Throughout history, those who sought progress have often been met with ridicule or suppression: Global Examples

Galileo Galilei, who championed heliocentrism, was condemned by the Church and placed under house arrest for challenging existing beliefs. Marie Curie, despite her groundbreaking discoveries in radioactivity, faced discrimination and skepticism simply because she was a woman in science.

Nikola Tesla, an inventor ahead of his time, struggled with financial and social obstacles, partly due to rivals undermining his work.

Modern Entrepreneurs & Creators, such as Elon Musk and Jeff Bezos, are often mocked or criticized—not always for valid reasons, but sometimes out of resentment toward their success. Indian Examples

Dr. B.R. Ambedkar – Despite being a key architect of the Indian Constitution and a champion of social justice, Ambedkar faced immense opposition from the upper caste-dominated political

class. His advocacy for Dalit rights was met with

hostility, and even today, his contributions are sometimes undermined.

Srinivasa Ramanujan – The self-taught mathematical genius was often dismissed in India before gaining recognition in England. Many in his



homeland doubted his unconventional methods rather than supporting his brilliance.

Rakesh Sharma – India's first astronaut had to fight against bureaucratic and political skepticism before representing the nation in space.

Kiran Bedi – As India's first female IPS officer, she faced severe opposition from male colleagues and superiors who tried to pull her down rather than support her efforts for police reforms.

Dhirubhai Ambani – The founder of Reliance Industries was often ridiculed for being an outsider to traditional business elites, Many tried to block his rise rather than learning from his innovative business strategies.

MaryKom&P.T. Usha – Both legendary athletes faced discouragement and lack of institutional

support despite bringing glory to the nation. The same pattern persists today, where many young athletes struggle against an unsupportive system.

Vikram Sarabhai & ISRO Scientists – When India first embarked on its space journey, many within the country mocked the ambition, dismissing it as unrealistic. Today, ISRO is a global leader, proving the naysayers wrong.

In the digital age, this phenomenon manifests in the form of cancel culture, cyberbullying, and social media negativity, where people actively seek to bring down rising figures, often for minor faults.

Impact on Personal & Social

Progress

The consequences of this negative behavior are profound:

Personal Growth is Stifled – People who face constant discouragement may abandon their ambitions out of fear or frustration.

Innovation is Slowed – Society loses out when potential visionaries are silenced before their ideas can take root.

Toxic Work & Social Environments – Competitive workplaces or social circles driven by jealousy lead to stress, burnout, and lack of trust. A Cycle of Negativity – When people are held back, they in turn hold others back, creating a self-perpetuating culture of mediocrity.

Solutions: Building a Culture of Support & Encouragement

To break free from this destructive cycle, we must actively cultivate an environment that rewards ambition and supports those who seek to improve:

Celebrate Others' Successes – Instead of feeling threatened by someone else's achievements, use them as motivation to grow.

Practice Constructive Criticism – Instead of tearing others down, offer insights that help them improve.

Create Supportive Networks – Surround yourselfwith people who uplift rather than discourage. Develop a Growth Mindset – Understand

that success is not finite; others' wins do not mean your loss.

Educate & Raise Awareness – Schools, workplaces, and communities should promote values of encouragement and collaboration.

Conclusion: Choosing Growth Over Envy History shows that societies thrive when they nurture rather than suppress talent. By shifting our mindset from competition to collaboration, we can foster an environment where progress is not hindered by negativity but propelled by collective encouragement.

others who reported higher levels of parenting stress had less synchrony in brain activity with their child than those who reported lower levels of parenting stress, researchers have found.

Excessive parenting stress can block maternal sensitivity, lead to reactions that punish the child and negatively affect the parent-child relationship for the long term.

Our study shows that parenting stress may very well weaken mother-child communication early in the process of social interaction. Our observations likely stem from the stressed mother's reduced ability to share her child's perspective" said study senior author Gianluca Esposito, Assistant Professor at Nanyang Technological University, Singapore.

This inability to appreciate the child`s viewpoint may reduce the quality of parental engagement and undermine the mother-child relationship in the long run," Esposito said.

According to the study, when the parent and child show highly similar brain activity in the same areas of the brain i.e. greater synchrony, it suggests that both are highly tuned in to each other's emotional states.

The study published in the journal Scientific Reports, analyzed the brain activity of 31 pairs of mother and children from Singapore while they were watching children's animation clips together.

The researchers used functional Near-infrared Spectroscopy NIRS) caps as a non-invasive way to measure brain activation based on blood concentration levels in the brain.

Before starting the experiment, mothers answered a questionnaire that aims to measure parenting stress. The mother-child pairs then wore the fNIRS caps with

the child sitting on the mother's lap while both watched animation clips from 'Brave', 'Peppa Pig' and 'The Incredibles' together.

The research team compared the mother's and child's brain activity to calculate brain-to-brain synchrony and found that for those parents reporting higher levels of parenting stress, the degree of mother-child synchrony in part of the prefrontal cortex was diminished, compared to those parents reporting lower stress who had better synchrony.



The results showed that half (50.8 per cent) of the people who completed a 10-week programme were able to successfully quit smoking, while 91 per cent reportedly reduced their smoking.

"This shows that physical activity can be a successful smoking-cessation aid and that a community-based programme might offer that. Because doing it on your own is very difficult," said lead author Carly Priebe, postdoctoral student at UBC

The findings were detailed in the journal Mental Health and Physical Activity. In all, 168 smokers from across Canada registered for the 2016 Run to Quit programme, and 72 of them stuck it out until the final week, when 37 participants had their claims of quitting verified by carbon-monoxide testing.

The weekly sessions included classroom time divided between running instruction and strategies for quitting smoking, plus an outdoor walking/running component that progressed toward a five-kilometre run.

Participants had access throughout the programme to one-on-one phone counselling via the national quit-smoking line.

The programme also showed improvement in participants' mental health, as well as a reduction of nearly one-third in their average carbon monoxide level.

Endometriosis may up risk of complications in pregnancy

NEW YORK: Pregnant women with endometriosis -- a chronic gynecologic disease -- are at greater risk for a host of complications during pregnancy and at delivery, including preterm birth and cesarean section, a study has shown.

The study showed that women with endometriosis had higher risks of miscarriage, preterm birth, and placenta previa.

The condition was associated with the birth of infants who were small for their gestational

There was no association, however, between endometriosis and gestational hypertension or preeclampsia.

Such pregnancies should be closely monitored by obstetricians for these complications, the researchers stressed.

"Endometriosis is known to alter a woman's physiology in a way that could interfere with a number of stages of pregnancy," said Vincenzo Berghella, Professor at Thomas Jefferson University in Pennsylvania.

"From causing inflammation at the endometrium, to resisting the action of progesterone during implantation and throughout the pregnancy, there are a number of ways that endometriosis may affect the normal course of pregnancy," Berghella added. Endometriosis -- a disorder in which tissue that normally lines the uterus grows outside

the uterus -- affects 10 per cent of women worldwide.

It is often diagnosed in the early reproductive years and is associated with endometrial tissue that travels and lodges in other parts of the body. Some of the symptoms include dagger-like abdominal pain, infertility and painful intercourse.

Diet easily affects quality of sperm, find researchers

esearchers have found a study that sperm is affected by diet and its results appear rapidly. The research also gave new insights into the sperm process which, in the long term, can continue to assess sperm values by modern testing methods.

The study published in 'PLOS Biology' was found by researchers at Linkoping University who fed healthy young men a high sugar diet. Anita Ost, a senior lecturer in the Department of Clinical and Experimental Medicine at the University, and also the head of the study said: "We see that diet influences the motility of the sperm, and we can link the changes to specific molecules in them. Our study has revealed rapid effects that are noticeable after one to two weeks."

Many environmental and lifestyle factors, including obesity and related diseases, may affect sperm quality, such as type 2 diabetes, are well-known risk factors for poor sperm quality.

Epigenetic anomalies, which influence physical properties or rates of gene expression, are of concern to the research group which conducted the new study, even if the genetic material, the DNA code, is not altered. In some cases, such epigenetic changes will contribute to the transmission of properties through the sperm or egg from parent to parent.

In an earlier study, researchers have shown that male fruit flies that had eaten excess sugar shortly before the patient became overweight more often produced offspring.

Scientists have hypothesized that RNA

processes, but it is too early to tell whether they do in human beings. The new study was initiated by the researchers to investigate whether high consumption of sugar affects the RNA fragments in human sperm.

The study examined 15 normal, non-smoking young men, who followed a diet in which they were given all food from the scientists for two weeks. The diet was based on the Nordic Nutrition Recommendations for healthy eating with one exception: during the second week, the researchers added sugar, corresponding to around 3.5 litres of fizzy drinks, or 450 grammes of confectionery, every day. The sperm quality and other indicators of the participants' health were investigated at the start of the study, after the first week (during which they ate a healthy diet), and after the second week (when the participants had additionally consumed large amounts of sugar).

One third had poor sperm motility at the beginning of the test. Motility is one of several factors influencing the quality of sperms, and that of the general population was the proportion of people with low sperm motility studied. The authors were surprised to learn that the motility of sperm of all participants during the research had become natural.

"The study shows that sperm motility can be changed in a short period, and seems to be closely coupled to diet. This

sperm fragments may engage in epigenetic has important clinical implications. But we can't say whether it was the sugar that caused the effect, since it may be a component of the basic healthy diet that has a positive effect on the sperm," said Anita Ost.

The scientists have also observed that the tiny RNA fragments associated with sperm motility also changed.

They now plan to carry on the research explore and whether there is a connection between male fertility and RNA sperm fragments.

Sadhna Top and Razdan Top have received a snowfall of one feet while Zojila pass and Sonamarg have received a snowfall of 10 inches today, said an Independent Weather Forecaster, Aadil Maqbool.

As per the details, Gulmarg recorded a snowfall of 8 inches while Doodhpatri recorded 7 inches of snow. Peer ki Gali recorded 8 inches of snow while Sinthan top recorded 10 inches of snowfall till today, he said, adding that light snow was also reported in some plains of Shopian, Baramulla, Kupwara and Bandipora.

Director Meteorological department (MeT), Dr Mukhtar Ahmad said that the generally dry



weather is expected from tomorrow till March 09, adding that a fresh spell of rain and snow is expected from March 10 to 12.

Moreover, the MeT has issued an advisory, predicting a possibility of landslides, rockfall, shooting stones and mudslides over vulnerable places.

It advised the tourists, travellers and transporters to follow administration and traffic advisory and asked farmers to suspend irrigation & other farm operations till 4th March.

"If you see his current form, and I always believe in current form-it's vital and when you look at his body language, his self-confidence and his own ability and when you look at oppositions like New Zealand, Australia, South Africa that are left in this tournament, not many sides have played too much of him or seen enough of him."



Real Kashmir defeats Inter Kashi 3-1 to stay in **I-League title race**

KALYANI, WEST BENGAL: Real Kashmir Football Club (RKFC) kept their I-League 2024-25 title hopes alive with a commanding 3-1 victory over Inter Kashi at the Kalyani Stadium West Bengal on Sunday evening.

The win propelled them to 29 points from 17 matches, just two points behind joint leaders Inter Kashi and Churchill Brothers, who both have 31 points.

Inter Kashi started the game on the front foot, with Domingo Berlanga and Bryce Miranda orchestrating early attacks that tested Real Kashmir's defense. However, the visitors absorbed the pressure well and gradually took control, imposing their physical presence before asserting tactical dominance.

The breakthrough came in the 37th minute when Ocran Idan delivered a delicate chip into the box for Abdou Karim Samb. He made no mistake this time, executing a brilliant first-time volley over goalkeeper Arindam Bhattacharya to put Real Kashmir ahead.

Then Real Kashmir pressed further and nearly doubled their lead when Karim Samb headed over from a corner. However, they did not have to wait long, as Paulo Cézar found the net in stoppage time of the first half. Rising highest to meet a curling free kick from the left, he got the faintest of touches, guiding the ball past Bhattacharya to give his team a comfortable 2-0 lead at halftime.

Inter Kashi struggled to respond and lacked creativity in the final third. Their best chance came late in the game when Bijoy V headed over from close range. They eventually pulled one back in the fifth minute of stoppage time through Spanish substitute Mario Barco, raising hopes of a dramatic finish.

However, Real Kashmir responded almost immediately. From the restart, Lalramsanga found Gnohere Krizo inside the box, and the Ivorian forward displayed quick footwork before slotting the ball into the bottom corner, sealing a crucial three points for the visitors.
