Rashid's regular bail application is currently pending before the court. The second part of Parliament's budget session would

begin on March 10 and end on April 4.

The judge on September 10 granted interim bail to Rashid to enable him to campaign for the assembly elections in Jammu and Kashmir.

J&K Records 30% Excess Rainfall In 5 Days MeT predicts more precipitation from Mar 10

SRINAGAR: Jammu and Kashmir has recorded 30 per cent above the average precipitation in the past five days, thereby increasing the water level in the river Jhelum and other streams.

As per the data accessed by the news agency-Kashmir News Observer (KNO), against the average rainfall of 25.4mm, Jammu and Kashmir has recorded a rainfall of 33mm from March 1 to 5.

The highest precipitation was recorded in Bandipora with details revealing that the station recorded 68% rainfall above than the average precipitation.

As per the data, nine stations including Srinagar, the summer capital of J&K, Budgam, Baramulla, Doda, Kupwara,



Pulwama, Rajouri, Shopian and Udhampur recorded excess rainfall, which varies from 20% to 59% above than the normal rainfall.

Power demand increases by nearly '80 MWs' in Kamadhan

SRINAGAR: In Kashmir valley, the power demand has increased by nearly 80 Megawatts (MWs) of power in the ongoing holy month of Ramadhan during peak hours.

A top official of Power Development of Power Development Department (PDD) informed the news agency-Kashmir News Observer (KNO) that the power demand has increased from the past four days by nearly 80 MWs in comparison to previous month.

The official said, "As of now in Ramadhan, the power supply and demand is touching at least 1900

1900 MWs of power." "On an average, there used to be a peak power demand of 1800

MWs. Yesterday, we delivered over

Row over Abu Azmi's remarks: UP CM Adityanath slams Samajwadi Party for 'idolizing' Aurangzeb

LUCKNOW: Uttar Pradesh Chief Minister Yogi Adityanath on Wednesday launched a $scathing\,attack\,on\,the\,Samajwadi$ Party, accusing it of glorifying Mughal ruler Aurangzeb while disregarding India's cultural and spiritual heritage.

"It is unfortunate that the Samajwadi Party considers Aurangzeb as its ideal. Even Aurangzeb's father, Shah Jahan, wrote in his autobiography that he wished no one would ever have such a wretched son," Adityanath



said in the Legislative Council.

His scathing attack comes

in Maharashtra over Samajwadi Party (SP) MLA Abu Azmi's remarks.

Azmi was on Wednesday suspended from the Maharashtra Assembly till the end of the ongoing Budget Session over his remarks eulogising Mughal emperor Aurangzeb.

The chief minister criticized the Samajwadi Party's deviation from the principles of socialist leader Dr Ram Manohar Lohia, who upheld India's cultural unity

despite being a political rival of the Congress.

"I want to tell my friends in the Samajwadi Party – even if you do not take pride in India's heritage, at least follow the ideology of the leader whose name you use for political gain," Adityanath said.

Quoting Dr Lohia, Adityanath added, "Lohia believed that India stands on three pillars - Lord Ram, Lord Krishna and Lord Shiva. As long as Indians revere these great figures, nopowerintheworldcanstopIndia from remaining India."

"BJP-led Centre pays lip service to Tamil for votes," alleges CM Stalin CHENNAI: Tamil Nadu Chief Minister M K union government allotted Rs 2,435 crore to

Stalin on Wednesday alleged that the BJP-led union government paid mere lip service to Tamil language for the sake of votes and dubbed the ruling party at the Centre as Tamil's "enemy."

Writing to party workers as part of his series on the theme of "all-time opposition to Hindi imposition,"

Stalin recalled DMK founder leader C N Annadurai's views on the issue. Decades ago, Anna had said that the party's objective is not to oppose Hindi, but to get equal recognition to Indian languages including Tamil.

While the BJP claims that Prime Minister Narendra Modi held Tamil in high esteem and that the 3-language formula is for the growth of languages of the states, the difference in allocation of funds for Tamil and Sanskrit would make it pretty clear that they are "enemies" of Tamil, Stalin alleged.

Rs 167 crore was allotted to Central Institute of Classical Tamil. Fund allocation and expenditure has increased manifold for the promotion of Sanskrit and Hindi. Equity in technology needed for true gender parity: Smriti Irani

NEW DELHI: Former Union minister Smriti woman or woman confronting man. It is Irani on Wednesday underscored the urgent need for ensuring equity in technology for



true gender parity.

Speaking at the Indo-American Chamber of Commerce Conference on Women Empowerment, Irani highlighted the systemic biases embedded in AI systems and called for a collective effort to address these disparities.

She urging the stakeholders to prioritize digital equity as a cornerstone of women's empowerment.

"In the age of AI, it is not man confronting

humanity confronting what AI will do to us," Irani said.

She pointed to a research, which revealed that out of 133 AI systems around the world, 44% of AI systems are not gender-inclusive.

Irani shared a striking example of gender bias in AI-driven financial systems.

"A woman with the same income, tax returns and financial standing as her husband was offered a credit limit 10% lower than his. Another woman's credit limit was set 20 times lower than her husband's despite identical financial profiles," she said.

The former minister also drew attention to the psychological manipulation of women through AI-driven consumer behaviour.

"Seventy-two per cent of content purchased by women is algorithmically designed to encourage higher spending on consumer durables and perishables, while they are 33% less likely to receive investment advice online," she noted.

Irani urged for a deeper study of consumer behaviour in the digital age, particularly its impact on women.

ing entrepreneurial mindsets among students.



Scheduled Power Shutdown Announced in Several Areas for Maintenance Work

SRINAGAR: The Kashmir Power Distribution Corporation Limited (KPDCL) has announced scheduled power shutdowns in multiple areas across the Kashmir region to facilitate essential maintenance and augmentation work on power infrastructure.

According to the Chief Engineer, Distribution, KPDCL, the shutdown of the 33KV Nehalpora-Markundal line will be observed to upgrade the



existing 0.1 ACSR to 0.2 ACSR. As a result, Receiving Stations at Markundal, Naidkhai, Shahgund, and Aglar will remain off, affecting power supply to Naidkhai, Markundal, Sumbal, Ankhul, Gundboon, and adjoining areas from 10:00 AM to 03:00 PM on March 8 and March 10.

Similarly, for the installation of newly procured panels and oil topping of power transformers, the 33KV Cherpora-Achabal line will remain under shutdown, impacting Receiving Stations at Cherpora, Uttersoo, Deethu, and Chittergul. Power supply to Cherpora, Uttersoo, Deethu, Chittergul, and nearby areas will be affected from 08:00 AM to 03:00 PM on March 10.

Additionally, augmentation work, including the charging of a 1x6.3 MVA Power Transformer, will require the shutdown of the 33KV Ashajipora-Dialgam line. This will impact the 33/11KV Receiving Station at Dialgam, leading to power outages in Dialgam, Shichen, and Brinty from 08:00 AM to

03:00 PM on March 8.

Meanwhile, emergency stabilization work by ED-Baramulla will necessitate the shutdown of the 33KV Sheeri-Baramulla-1st line, impacting Receiving Stations at Baramulla-1st and Kanlibagh. Areas including Baramulla Main Town, DC Office, Kanlibagh, Sangri, and nearby locations will experience power outages from 10:00 AM to 03:00 PM

> To replace damaged wooden poles with new ST poles, the 33KV Nihalpora-Pattan-Amargarh line will be under shutdown, affecting Receiving Stations at Pattan, Palhalan, and Hamray. Power supply to Pattan, Zangam, Burn, Nihalpora, Pattan Hospital, Palhalan, Hamray, Wanigam, and adjoining areas will be disrupted from 10:00 AM to 03:00 PM on March 10.

33KV Wanganpora-Soura line on March 8 for dismantling of a damaged four-pole tower near Aiwa Bridge, This will affect Soura, Zoonimar, Nowshera, and portions of 90 Ft Road from 10:00 AM to 12:00 Noon.

33KV Alusteng-Nagbal line on March 9 to facilitate the installation of SMDB and pole erection for isolators. Areas including Shuhama, Bakura, Darend, Nagbal, Fatehpora, Gadoora, Tulbagh, and Chundina will be impacted from 11:00 AM to 02:00

implementation, particularly for landless beneficiaries listed under Awaas Plus.

The Secretary reiterated the importance of convergence with MGNREGA to provide unskilled wages for housing construction, reinforcing the government's commitment towards improving rural living conditions.

While reviewing the Annual Action Plan (AAP) 2025-26 of the Jammu and Kashmir Rural Livelihoods Mission (JKRLM), the Secretary emphasized that its primary objective is to strengthen self-

employment opportunities, financial inclusion and skill development for rural women. He stated that the plan focuses on expanding Self-Help Groups (SHGs), providing access to credit and promoting both farm and non-farm livelihood activities across the Union Territory.

A key highlight of the plan was the "Lakhpati Didi" initiative, designed to empower rural women by enhancing their earning potential through skill development and entrepreneurship.

The Secretary said that the strategy included regular training programs, workshops, leadership development initiatives and financial literacy sessions to help SHG members build sustainable livelihoods.

To promote financial inclusion, he said that the AAP outlines efforts to open bank accounts for all SHG members, provide 100% insurance coverage under PMJJBY and PMSBY and facilitate credit linkages with the banks. He said that the convergence approach remains a crucial aspect of the AAP, with interdepartmental coordination ensuring that SHGs benefit from various government schemes.

The meeting also reviewed the plan for Himayat, a skill development program aimed at providing employment opportunities for the youth of Jammu & Kashmir.

The focus remains on expanding training programs, improving skill development initiatives and ensuring better placement opportunities for trainees, thereby equipping them with the necessary tools to secure sustainable livelihoods.

The Secretary emphasized the importance of meticulous planning and execution to achieve the goals set forth in the AAP 2025-26. He urged all scheme heads to work collaboratively to ensure successful implementation of the schemes, ultimately leading to the socioeconomic upliftment of rural communities in Jammu & Kashmir.

The proposed Annual Action Plan 2025-26 will be submitted for approval in the upcoming Empowered Committee meeting scheduled in New Delhi on March 10, 2025 in the Ministry of Rural Development.

Several WSSs completed, others under progress in SMVD constituency Concerted efforts underway

Concerted efforts underway to address water scarcity caused by rainfall deficiency: Javed Rana



Srinagar: Minister for Jal Shakti, Javed Ahmad Rana, said that 35 WSSs have been either completed or under progress in different areas of Shri Mata Vaishno Devi (SMVD) constituency to facilitate portable water facility to the people.

The Minister was replying to a question raised by MLA, Baldev Raj Sharma, in the Legislative Assembly.

He added that 91 PANI SAMITI Committees have been constituted in SMVD Constituency under JJM, comprising elected members of the Panchayat Raj Institutions, community leaders, school teachers, Anganwadi workers, ASHA workers and others and it has to have at least 50 percent representation of women

He said that there is no slackening in monitoring by the Pani Samitis and there are regular reviews being held by District Jal Jeevan Missions (DJJMs) headed by the respective District Development Commissioners.

The Minister said that the rainfall recorded about 79% deficiency, as per data by the ending February this year, resulting in depletion of most of the Spring sources.

He said that some important measures being taken up to tackle scarcity of water in SMVD constituency included awareness among the general public about judicious use of water and avoiding wastages.

Besides, channelization of local nallahs has also been proposed at some sources by diverting the flow to recharge the springs.

He said that several measures like protection and development of the sources, deployment of additional water and focus on water conservation, rain water harvesting, ground water recharge, rejuvenation of traditional bodies and afforestation are being taken up to address the issue.

He also informed that the present status of drinking water demand and supply in the SMVD Constituency (rural areas) is 11.85 lakh gallons per day against the water availability of 10.49 lakh gallons per day.

The Minister stated that all the pipes including GI, DI and HDPE are being used as per the site requirement and their suitability. He said that the HDPE pipes are one among the non-metallic pipes recommended by the CPHEEO manual and advised by NJJM, for use in transmission of water under various WSSs.

He said that the concerned technical field staff monitors the work on a regular basis at the site. Apart from the District Project Management Units (DPMUs), there is a Third Party Inspection Agency for monitoring the quality of works, he added.

Replying to a supplementary, the Minister said that a strict inquiry would be conducted in case of failure of Pani Samitis, fixing the responsibilities accordingly. Besides, focus shall be given on fixing loopholes, if any, in execution of JJM works.

JJM completes 24 WSSs in Beerwah Constituency: Javed Rana



Srinagar: Minister for Jal Shakti, Javed Ahmad Rana, informed the House that 38 Water Supply Schemes had been approved under Jal Jeevan Mission for Beerwah Constituency, of which, 24 have been completed, so far.

The Minister was replying to a question raised by MLA, Dr Shafi Ahmad Wani, in the Legislative Assembly.

The Minister said that work on the rest of the

14 schemes is in progress and will be completed within the stipulated time. The total estimated cost of the schemes was 113.19 crore, of which, 64.29 crore have been expended.

Javed Rana also provided physical and financial details of all the Water Supply Schemes that

have been completed or are under execution in Beerwah constituency.

The Minister informed that Mazhama, Gondipora, Kandura and Zanigam villages have been proposed to be covered under Jal Jeevan Mission while Kawoosa and Check-Kawoosa villages have been proposed to be covered under NABARD scheme. The schemes for Gondipora and Kandura villages have been completed, while the others are at different stages of completion. All these schemes are expected to be completed during the next financial year, subject to availability of funds, the Minister stated.

Regarding augmentation of water supply to towns in the constituency, the Minister informed that augmentation of water supply to Magam and Beerwah towns stand approved under AMRUT 2.0 and steps are afoot to complete the same as early as possible.

Javed Rana informed the House that Jammu and Kashmir has experienced rainfall deficit during the last year leading to drying up of various springs that led to delay in operationalisation of schemes in certain areas.

02 Medical shops put on show cause notice, operation of 01 disallowed at Shopian

SHOPIAN: A team of officials from the Drugs Control department today conducted inspection of medical shops in various villages of Shopian district including Kumdalan Nagisharan, Hajipora, Chakoora, Dangam and Kaprin.

11 ATFs functional in Kashmir, 09 in Jammu for treatment, rehabilitation of drug addicts: Sakeena Itoo

Srinagar: Minister for Health and Medical Education, Social Welfare and Education, Sakeena Itoo, while terming drug abuse as an issue of grave concern, said there is dire need to work collectively for eradication of this societal menace plaguing Jammu and Kashmir. The Minister said this while replying to a starred

question raised by MLA, Mubarak Gul, in the Legislative Assembly here today. While giving details regarding the treatment and

rehabilitation facilities, the Minister said that 11

Addiction Treatment Facilities (ATFs) are functional in Kashmir division and 9 ATFs in Jammu division. She further informed that OPD services are functional in all 20 districts while IPD services are available in all 9 GMCs, catering to the healthcare

needs of both male and female patients. She also informed that Psychiatrists are available

in all the GMC's of J&K.

Reflecting on the Training and Monitoring efforts of the government, the Minister said that 25 Medical Officers (12 from Jammu and 13 from Kashmir) have been trained by NIMHANS, Bengaluru and deputed to their respective districts to strengthen treatment facilities at de-addiction centres.

She also informed that surveillance has been strengthened by data collection on a daily basis using

google sheets for real time reporting to monitor trends and measure the impact of interventions. The Minister informed the house that after the

The Minister informed the house that after the initiation of Nasha Mukht Abhiyan since September 2022, the registration of new cases has shown



decreasing trend which indicates some level of control or improvement in detecting and managing the affected victims.

She also informed the house that several policy level measures have been initiated like Adoption of Drug De-Addiction Policy, Constitution of State Level Policy Implementation Monitoring, Divisional Level Drug De-addiction and Monitoring besides constitution of District Level Drug De-addiction and Monitoring Committees to tackle drug addiction as

well as drug trafficking in J&K.

The Minister further informed that the government has established a dedicated call centre Tele MANAS to facilitate the drug victims seeking treatment.

Giving details on awareness activities, the Minister informed that IEC activities, seminars, workshops and programmes are being conducted regularly in schools, colleges and universities in coordination with the district administrations, NGOs, volunteers and other allied agencies regarding ill effects of drug and substance abuse.

The Minister also informed that the health department, in collaboration with J&K bank, has successfully launched the project "Najaath" on drug abuse dedicated to Prevention and Treatment of Tobacco and Drug Addiction, in Jammu and Pulwama districts in November 2023.

She added that the Najaath aims to raise awareness among individuals, families and communities about the harmful effects of tobacco and drug addiction besides the available resources for prevention, treatment

At the outset, District Manager CSCs provided an overview of the CSC operations and the services offered.

It was informed that there are 528 sanctioned CSCs in the district, out of which 378 are active, with at least one CSC available in each Gram Panchayat.

Additionally, 13 CSC touch points have been established in government offices across the district.

DC directed the Coordinator CSC Kulgam to open more CSCs in the remote areas of the district. He emphasized on making the earliest and discontinue the CSCs which are non functional

People Who Travel More Are Healthier, Study Says

What did the study entail?

Whether it's driving to your state's impeccable be a chortaking a flight to Switzerland,traveling is always exciting and adventurous. The research, published in the Journal of Transport& Health, found that there was a difference in overall health of those who travel and those who do not.

Individuals who were limited to get out of their hometown, or even had limited exposure to traveling than they preferred, had inferior health. The research team set traveling as getting outside at least 15 miles away from one's local region. They gathered 2,747 individuals from the North of England and studied their overall health and relationship with traveling.

The particular region of England is known for having one of nation's worst health results, $reason\,being\,its\,lack\,of\,sufficient\,transportation$

During the research, participants were given five questions regarding traveling:

"I travel beyond my local area less often than I would ideally like to" "I travel to fewer places (e.g., cities or towns

outside my local area) than I would ideally like

"I travel to places that are nearer than the ones I would ideally like to go" "Itravel by public transport to places I would

ideally like to go by car" "I travel by car to places I would ideally like

to go by public transport" They were then asked to answer these five questions from a scale of one to five.

What did the survey find?

From the survey, researchers found that those who had the luxury to travel outside of their local region, meaning at least 15 miles from home, and those who did it often, overall reported having better health.

The correlation between traveling and health became stronger in those aged 55 years or older. Dr. Paulo Anciaes, the lead author of the study, said prior research confirmed how

travel can benefit individuals due to an increase in more opportunities, such as career benefits or educational advantages.

Anciaes and his team claimed those who had limited traveling opportunities had poorer health, due to a lack of social interaction and ability to explore. Habitual travel wasn't directly related to one's health, but more associated with not having the opportunity to participate in social interactions. Social interaction was directly linked with one's overall health and

satisfaction.

According to South University, social interactions are beneficial as it supports both emotional and physical wellbeing.

Social interaction is crucial to humans, as it creates a community for us to participate in and build relationships. Some ways to build social relationships can include volunteering at a local community, joining a group, or even utilizing technology to stay connected with



On asking about the power generation, the official said, "Power generation has slightly increased due to the recent rainfall."

"As of now, the lower Jhelum power plant in Kashmir region is producing 90 MWs on an average," the official said.

Pertinently, KNO in previous week reported that Jammu and Kashmir is currently relying on more than 85 percent of coal and solar power amid acute deficit of hydro power generation.

Officials of PDD department had claimed that local hydro power generation from the local power plants have reduced by nearly 90 percent.

An official had informed that "At present Jammu and Kashmir is 85-90 percent dependent on coal and solar energy that is being procured from the other states because as of now we don't have a local power generation."

"In winters the local hydro power generation of Jammu and Kashmir power plants has reduced by almost 90 percent and in order to cater the requisite power demand, we need to have a base power availability that we procure from outside states. The energy is coal based energy," the official

Bandia pora Produces 85,000 Metric Tons of Milk Annually, 90% **Consumed Locally: Govt**

"15,000 Liters of Milk collected Daily from 102 Dairy cooperatives"

BANDIPORA: The Jammu and Kashmir government on Wednesday said that Bandipora district produces 85,000 metric tons of milk annually, with 90% of the production being consumed locally and the remaining milk being processed and marketed through different channels.

The information was shared in response to MLA Bandipora Nizamuddin Bhat's question in the J&K Assembly regarding animal and sheeprearing initiatives in the district.

According to the government, 15,000 litres of milk per day are collected from 102 dairy cooperative societies by JKMPCL and processed at the Chashma Shahi Milk Processing Plant. 8,000 to 10,000 litres per day are also processed by local units or transported to Srinagar and other districts, where it is either sold directly as loose milk or processed by private dairy companies.

Addressing the initiatives taken to promote animal and sheep rearing in Bandipora, the government said that various schemes are in operation. The Integrated Dairy Development Scheme (IDDS) provides incentives for setting up dairy units, milk processing, and marketing. Similarly, the Integrated Poultry Development Programme (IPDP) offers subsidies for broiler and layer farms, mother units, and free-range poultry farms, along with poultry meat processing incentives. The Integrated Sheep Development Scheme (ISDS) supports beneficiaries in establishing sheep and goat units on a subsidy or participatory basis.

Under the Holistic Agriculture Development Programme (HADP), various sub-projects, including Dairy Development, Poultry Development, Mutton Project, and Fodder Project, are being implemented.

The government informed the Assembly that 2,237 cases have been approved in Bandipora under these initiatives. Under the National Livestock Mission, subsidies of up to 50 lakh are also provided for establishing sheep and goat units, trade and supply.

On the issue of animal health, the government said that extensive vaccination campaigns are being conducted to protect livestock from various diseases. As part of an eradication strategy, Footand-Mouth Disease (FMD) vaccinations are being carried out, alongside vaccinations for Lumpy Skin Disease (LSD), Brucellosis, Hemorrhagic Septicemia (HS), Black Quarter (BQ), Sheep Pox, Enterotoxemia



(ET), and Peste des Petits Ruminants (PPR) under the Centrally Sponsored Schemes (CSS) ASCAD

To improve veterinary healthcare services, Mobile Veterinary Units (MVUs) have been deployed in the district, providing doorstep services to farmers. These units can be accessed through the toll-free number 1962. The government also informed that veterinary mobile camps are set up in upperaltitude areas during seasonal livestock migration.

Artificial Insemination Centers across the district provide high-quality genetic breeding services, and awareness and fertility camps are conducted to educate farmers on disease prevention and best animal husbandry practices.

On bovine trade, the government said that Pashudhan Melas are being organized to help farmers select and purchase elite dairy animals within the Union Territory. Cattle dealers are also granted permission to transport livestock from outside Jammu and Kashmir, ensuring smooth

It may look illogical from outside but for Gambhir they were minor pieces in the grand plans of keeping the players "out of the comfort zone" to extract the best out of them.


