

## **CM Omar to unveil** J&K Budget today



**Mubashir Alam JAMMU**: After a gap of seven years,

Jammu & Kashmir's annual budget for 2025-26 will be presented in the Legislative Assembly on Friday by Chief Minister Omar

Abdullah, who is also serving as finance minister of the Union Territory.

As per the news agency–Kashmir News Observer (KNO), J&K's annual financial statement of expenditure for 2025-26 and the supplementary statement of expenditure for 2024-25 will be presented in the House by Omar Abdullah tomorrow after the conclusion of question hour.

This will be for the first time since 2018 that the budget of J&K will be presented in the Assembly. After imposition of central rule in Jammu & Kashmir in 2018, the budget documents of the UT were tabled annually in the Parliament by the Union Finance Minister.

It is for the first time in history that the CM would unveil the budget in the Assembly.



# Verdict upholding ED powers: SC to decide on its reconsideration in April

NEW DELHI, Mar 6: The Supreme Court on Thursday said it would in April decide if its 2022 verdict upholding the Enforcement Directorate's powers to arrest and attach property under the Prevention of Money Laundering Act needs reconsideration.

A bench of Justices Surya Kant and N Kotiswar Singh said a three-judge bench was supposed to hear the matter and it was wrongly listed before it.

Solicitor general Tushar Mehta, appearing for the Centre, agreed with the bench and asked it to post the hearing in April late or May first week.

Senior advocate Kapil Sibal, appearing for the petitioner, said the matter ought to be heard expeditiously by a three-judge bench.

Justice Surya Kant said he ordered listing the matter before a three-judge bench on the administrative side and wondered how it came before

## PM Modi has forgotten his guarantee of cleaning Ganga, his govt only cheated Maa Ganga: Kharge

NEW DELHI: Hours after Prime Minister Narendra Modi offered prayers at the winter abode of Goddess Ganga in Uttarakhand, Congress chief Mallikariur Kharge took a swipe at him on Thursday, saying the government has only "cheated" 'Maa Ganga' in the name of cleaning the river.

Modi offered prayers at Mukhwa temple in Uttarkashi district in the morning. Mukhwa is located on the way to the Gangotri temple dedicated to Goddess Ganga. Her idol is moved to Mukhwa temple from Gangotri Dham every year after the closure of its gates for winter.

In a post in Hindi on X, Kharge said, "Modi Ji had stated that 'Maa Ganga had called him' but the truth is that he has 'forgotten' his guarantee of cleaning the Ganga!" The Namami Gange scheme was launched nearly 11 years ago under which Rs 42,500 crore was to be used by March 2026, he said. "But the answers to questions in Parliament show that only Rs 19,271 crore have been spent till December 2024." "That is, the Modi government has not spent 55 per cent of the funds of the Namami Gange scheme. Why so much indifference towards Maa Ganga?" Kharge posed.

Addressing a rally in Harsil after praying at the Mukhwa temple, the prime minister said he feels blessed to visit Goddess Ganga's



winter abode. "I think Maa Ganga has adopted me. It is her blessings that took me to Kashi and gave me an opportunity to serve the people," he said.

Hitting out at Modi over the issue of cleaning the Ganga, Kharge said, "In 2015. Modi ji had urged our NRI friends to contribute to the Clean Ganga Fund.

Rs 876 crore has been donated to this fund till March 2024, but 56.7 per cent of it has not been used yet. Around 53 per cent of this fund has been donated by government undertakings." A November 2024 reply to a question in the Rajya Sabha shows that 38 per cent of Namami Gange projects are still

pending, the Congress president pointed out.

He claimed 82 per cent of the total allocated funds were to be spent to build Sewage Treatment Plants (STPs) but 39 per cent of those have still not been completed. Those that are completed are not even operational. Kharge claimed.

Referring to a reply given by the government in Rajya Sabha, he said that in Uttar Pradesh 75 per cent of the drains that were supposed to go to STPs have been discharging their effluents directly into the Ganga.

Asserting that 3513.16 MLD sewage was being dumped into the river, Kahrge said, "Rules have not been followed in 97 per cent of the STPs. (November 2024)." "Bihar – 46 per cent of STPs are not operational; rest do not meet faecal coliform levels (October 2024). West Bengal:

40 STPs not functional; 95 per cent do not meet NGT norms; 76.16 per cent do not comply with MoEF norms (March 2024)," he said.

In November 2024, the National Green Tribunal expressed strong displeasure over the administration's "failure" to maintain the cleanliness of the Ganga in Varanasi, Modi's parliamentary constituency, the Congress chief said.

#### **Pro-Khalistan Extremists Target** EAM Convoy In London, India Reacts

LONDON/NEW DELHI: A man from a small group of protesters chanting pro-Khalistan slogans outside Chatham House attempted to breach the security perimeter as External Affairs Minister S Jaishankar left the think tank in London, drawing condemnation from India over the provocative activities of this "small group of separatists and extremists".

The group waving separatist flags was barricaded and monitored by a significant police presence outside the venue on Wednesday night, with officers rushing to restrain the man as he ran past the barricade in an attempt to block the path of the minister's car pulling at an Indian flag. He was swiftly taken aside by Metropolitan Police officers and no arrests have been reported so far.

"It is shameful that this attack comes when Dr S Jaishankar is on a UK tour and had just completed a successful meeting with UK Foreign Secretary David Lammy where they discussed bilateral ties," said community organisation INSIGHT UK, posting footage of the incident on social media. The Ministry of External Affairs (MEA) in New Delhi condemned the incident of the security breach and called on the UK government to "live up to their diplomatic obligations".

"We have seen the footage of a breach of security during the visit of the external affairs minister to the UK," MEA spokesperson Randhir Jaiswal said in New Delhi. "We condemn the provocative activities of this small group of separatists and extremists. We deplore the misuse of democratic freedoms by such elements. We expect the host government in such cases to fully live up to their diplomatic obligations," he said. Earlier, during his session at Chatham House, the EAM was asked about human rights concerns pertaining to India.

#### **Domestic Violence** Survivors May Soon Get To Stay At Govt-Run **Centres For 10 Days**

NEW DELHI: The Centre is planning to double the duration for which domestic violence survivors can seek temporary shelter at One-Stop

Centres from five to 10 days, Women and Child **Development Minister** Annapurna Devi said.

Speaking to reporters on the sidelines of an event on Wednesday night, Devi said under special circumstances the survivors can stay in such centres for up to 15 days.

One Stop Centres

(OSC) are intended to support women affected by violence, in private and public spaces, within the family, community and at the workplace.

According to the present legislation, women affected by violence along with their children (girls of all ages and boys up to 8 years of age) can avail themselves of a temporary shelter at the OSC for a

For women requiring long-term shelter, OSCs make arrangements with Swadhar Greh which are managed or affiliated with government or NGOs.

### Cong cites IMF report to slam govt; calls for boosting consumption, rationalising trade policy

NEW DELHI: Citing an IMF report to flag "tepid" private investment growth in India, the Congress on Thursday said the way out of the current "economic slump" requires measures to boost consumption, enhancing of policy predictability, and rationalising trade policy.Congress general secretary in-charge communications Jairam Ramesh said the International Monetary Fund (IMF) has devoted an entire section to "Reigniting Private Investment in India" in its just-released annual India Article IV Consultation Report.

"Somewhat unusually, it is a strong-if implicit-critique of the Modi government's policies and actions," he said in a statement.

"The report underscores the tepid private investment growth in India, noting that 'private corporate investment has been sluggish especially compared with historical averages.' Notably, the situation is only getting worse, since 'nominal investment growth by private corporates appears to have decelerated further from 21 percent in 2022/23 to 13 percent in 2023/24'," he said. Our statement on the IMF's recently-released report on reigniting private investment in India. The IMF's observations underline the INC's consistent and repeated demands for measures to boost consumption, enhance policy predictability, and rationalise trade policy pic.twitter.com/ojgSLfppOM

Jairam Ramesh (@Jairam\_Ramesh) March 6, 2025Specifically, investment in machinery and equipment – critical for expanding production capacity - has consistently fallen as a percentage of GDP, Ramesh pointed out.

Worryingly, the IMF notes that capacity utilisation in manufacturing reached only



75.8 percent in July-September 2024, and that most firms expected production capacity to be adequate to meet demand within the next six months, he said.

This moderation of production expectations in manufacturing reflects the larger and much-commented-on slowdown in consumption growth, Ramesh said.

"Without adequate money in the hands of consumers, they are able to demand fewer goods and services. Manufacturing firms are unable to utilise their existing production capacity and therefore have no reason to invest in further growth," he contended.

Noting that the IMF states that Foreign Direct Investment in India has underperformed its expectations in recent years, Ramesh said India's share in global FDI has decreased, falling to about 2 percent in 2023 from about six-and-a-half percent in 2020.

The IMF notes that this is partly due to the Modi Government's incoherent trade policy -which can be best characterised as maintaining an open-door policy for China, and protectionism for the rest, he said.

"This has led to India getting the worst of both worlds, with investors unwilling to produce for export markets due to the fear of retaliatory protectionism and being unwilling to invest for domestic consumption due to the threat of Chinese dumping," Ramesh argued.

The IMF also attributes much of the much-proclaimed increase in labour force participation rates to growth to selfemployment and unpaid family work, he said. As the Congress has been consistently pointing out, this shows a worrying decline in the quality jobs in recent years, Ramesh said.

He said the IMF also highlights a disturbing

trend – a rise in agricultural employment which diverges from the typical development path of labour shifting toward industry and services."This economic distress is the direct consequence of the Modi government's policies such as demonetisation, the flawed implementation of GST, which is crying out for reform," he claimed. The IMF report makes clear that the gap between government rhetoric and economic reality remains the key challenge in reviving India's private investment, he said."The failure to deal with the fundamentals and a relentless emphasis on a handful of politically-connected monopolists have led to this abject failure," he alleges.Ramesh asserted that the Congress has consistently argued that the way out of India's current economic slump is three-fold.

He called for measures to boost mass consumption and kick-start real wage growth out of their decade-long stagnation. The Congress has also called for economic policy predictability, with fewer knee-jerk policy decisions, an end to tax terrorism, and a move away from the Most Favoured Businessmen policy of the last decade, he said.



Tobacco consumption is the major cause of preventable death and illness. It kills half of its users prematurely, especially in their reproductive age. It is a major risk factor for many chronic diseases, including Cancer, Cardiovascular Disease (CVD), Diabetes, Lung Diseases, Stroke, Infertility, Blindness, Tuberculosis (TB), Oral Cavities etc. The exposure to second-hand Smoke or passive smoking causes numerous health problems in infants, children and adults. Spitting of tobacco products leads to spread of swine flu, pneumonia, gastrointestinal diseases, posing a potential risk of transmission of TB as well as nuisance to the public.

There are two forms of tobacco – "Smoking Tobacco", such as cigarettes, bidi, Ganja, hookah, cigars etc. and "Smokeless Tobacco" such as Khaini, Jarda, Gutkha etc. New and emerging electronic products (e-cigarettes and like products) have created new challenges. Electronic nicotine delivery systems (ENDS) and electronic non-nicotine delivery systems (ENNDS), commonly known as e-Cigarettes, do not contain tobacco and may or may not contain nicotine, but are harmful for health. The combustion of tobacco releases carcinogen, like benzene and formaldehyde, which damages lung cells and DNA, leading to cancer.

According to the report of the Global Adult Tobacco Survey India (2016-17), about 33.2 crore population of adults (28 % of all adults) above 15 years age group use tobacco in Bharat, out of which 10 crore are smokers, 20 crore are smokeless tobacco users and 3.2 crore are of both users. As per the Global Youth Tobacco Survey (2009), 14.6 % of students aged 13 to 15 use tobacco. In Bharat, more than 13 lakh people lose their life every year due to tobacco consumption. It leads to social and economic costs too.

People's Representatives Institutions (PRI) have pivotal role and responsibilities in implementing the laws, rules and regulation to control the tobacco consumption.

Children and adolescents are the future of any nation. Hence, it must be mandatory to make our educational institutions tobacco free. As per report of GYTS and GATS, there is significant tobacco use among adolescents and youngsters. Hence a guideline has been released in 2008 for "Tobacco should designate one or more Tobacco Monitors from among teachers, staffs and/or students from class-IX onwards. The monitor must not be tobacco user. The institution should ensure that no Tobacco product is sold inside the premises and within a radius of 100 yards. Fine should be imposed on tobacco user if found. The institutional authority should help tobacco users to quit tobacco by encouraging them to avail Quitline services and mCessation.

Tobacco monitor should remain vigilant about the tobacco substitutes such as e-Cigarettes and the like devices such as Heat-Not-Burn Devices, the school assembly.

Although several laws, rules and other prohibitory measures are prevalent in the country to save the lives of people from Tobacco consumption, but these acts and rules are just lip services. If Government is really sensitive towards a healthy and Nasha-Mukt Bharat, then the production of all intoxicating products including tobacco should be completely banned and its factories should be sealed; otherwise, the numerous fashionable control programmes and initiatives will be a misuse of public money and human resources.

Srinagar: Around 3000 posts are lying vacant in the Health Department in Jammu division, data has revealed.

According to the details accessed by the news agency–Kashmir News Observer (KNO), as many as 2999 posts of doctors and paramedics are vacant in all 10 districts, excluding GMCs, of Jammu division.

In district Jammu, 127 medical and 522 paramedical posts are vacant, in Doda 99 medical and 160 paramedical, in Poonch 120 and 173, Rajouri 106 and 147, Ramban 75 and 73, Kishtwar 77 and 89, Reasi 126 and 366, Kathua 153 and 171, Samba 165 and 126 and in Udhampur 92 medical and 125 paramedical posts are vacant. At GMC Kathua, 131 posts of doctors and professors, nine associate professors, 15 assistant officers, it is stated that recently in the month of professors, 10 CMOs/LMOs, 39 associate hospital November, 2024, 365 candidates were appointed as medical officers in the J&K Health & Family

Welfare (Gazetted) Services. Out of which 13 medical officers were posted in district Kathua further strengthening the medical/health care facilities at grass root level," she said.

The department is also in the process of operating a wait list in respect of 91 selected Medical Officers, whose services will also be utilized in the Un- deserved areas across the UT of J&K," she said.

"Besides, 181 numbers of posts of Medical Officers are still to be received from Jammu and Kashmir Public Service Commission. Upon receiving the selections, the selectee doctors will be posted at the health institutions experiencing

#### **3 Solid Waste Management Plants** approved for DooruVerinag : Sakeena Itoo

**Srinagar:** Minister for Social Welfare, Sakeena Itoo, informed the House that the Municipal Committee Dooru /Verinag distributes twin household dustbins among all households to segregate waste at the source, along with installation of twin bins in commercial areas for segregated collection of garbage in twin towns of Anantnag district.

The Minister was replying on behalf of Chief Minister, Omar Abdullah, to a question raised



by G A Mir in the Legislative Assembly.

The Minister said that for collection of waste from the households and commercial establishments, 08 Hoppers are deployed regularly and the waste is subsequently transported to the Material Recovery Facility Plant at Verinag, where it is further segregated into dry waste and wet waste separately. The dry waste is processed in the MRF center which is then recycled and sold out, while the wet waste is put into the compost pits for generation of organic compost.

The Minister informed that 8 hoppers, 25 tri-cycles and one truck laden with sucker have been procured for Dooru and

Verinag while as the department intends to procure machinery including weight bridge, baling machine and shredder for improvement in sanitation and waste management segregation. The Minister, while replying

to a supplementary, stated that three Solid Waste Management Plants of 4 TPD each have been approved for MC Dooru-Verinag. Besides, one Solid Waste Management Plant of 4 TPD is functional at Veering where the dry waste is processed at

The Minister further said that under SBM (U) scientific processing of the Municipal Solid Waste in the small and medium Towns of J&K has been undertaken.

She said that the establishment of 78 Solid Waste Management centers (WMCs)/ Material recovery Facility (MRF) along with compost pits has been approved. She added that construction work in 52 locations has been undertaken, of which, 33 Waste Management Centers/MRFs and 30 compost pits have been completed, while the work in 19 more sites of WMCs/MRF and 22 compost pits is under progress.

Further, she informed that bio-remediation of legacy waste at the dumping sites like Bhagwati Nagar, Kathua, Samba, Udhampur, Tral, Bijbehara, Pahalgam, Anantnag and Tangmarg has been completed and 3.88 lakh MT legacy waste has been bioremediated.

She apprised that the work has been awarded for bioremediation of 6.16 lakh MT legacy waste at Kot Bhalwal by IMC, 2.98 lakh MT by DULBK and 1.20 lakh MT for 7 ULBs of DULBJ. Besides, the tender has been floated for bio-remediation of 11.00 lakh MT legacy waste

at Achan, Srinagar, she added. Regarding housing facilities, the Minister said that PMAY-Urban 2.0 has been launched in September 2024 to address the housing needs of EWS/LIG and MIG income categories by providing financial assistance for construction/purchase of houses through different verticals of the scheme in the next 5 years. If a balanced diet is not readily accessible, taking a multivitamin containing the RDA for several nutrients may be used.

Don't smoke (or stop smoking if you do): Research (https://www.ncbi.nlm.nih.gov/pmc/articles/PMC5352117/)



shows that cigarette smoking is associated with numerous diseases and poses a serious challenge to the current healthcare system worldwide. Smoking impacts both innate and adaptive immunity and plays dual roles in regulating immunity by either exacerbation of pathogenic immune responses or attenuation of defensive immunity. Why would you want to smoke or continue the habit if it puts you directly in the path of danger?

Moderate your consumption of alcohol: If you are already a drinker, and if your doctor recommends that you can continue to drink, bring down your consumption. Research (https://www.ncbi.nlm.nih.gov/pmc/articles/PMC4590612/) has established that there is an association between excessive alcohol consumption and adverse immune-related health effects such as susceptibility to pneumonia. In recent decades, this association has been expanded to a greater likelihood of acute respiratory stress syndromes (ARDS), sepsis, alcoholic liver disease (ALD), and certain cancers; a higher incidence of postoperative complications; and slower and less complete recovery from infection and physical trauma, including poor wound healing.

Perform moderate regular exercise: Research shows that Acute Respiratory Infections (ARIs) are caused by respiratory viruses and bacteria, being the most infectious disease in humans. Despite the lack of accurate data on how physical activity improves the immune response against the new coronavirus, there is evidence of lower rates of ARI incidence, duration and intensity of symptoms and risk of mortality from infectious respiratory diseases in individuals who exercise at high levels appropriate. Furthermore, different studies suggest that regular physical exercise is directly related to decreased mortality from pneumonia and influenza, improvements in cardiorespiratory function, vaccine response, metabolism of glucose, lipids and insulin.

If you'd like some guidance, try this short mindful breathing exercise.

Wash hands throughout the day: Especially ever since the COVID-19 pandemic spread across the world, most of us have adopted healthier lifestyles, mindfully. ### Is arsenic safe? Study says it may clog arteries

environmental exposure to low levels of the toxic metals arsenic, cadmium and titanium appears to increase the risk of plaque buildup in arteries in the neck, heart and legs. The study has been published in the 'Arteriosclerosis, Thrombosis and Vascular Biology Journal'.

Traces of metal may enter the body through contaminated soil that infiltrates food, through drinking water, air poliutants or tobacco smoke There is strong evidence that toxic metals, such as arsenic and cadmium, are cardiovascular risk factors. Arsenic and cadmium are often found in tobacco and food, while arsenic is also found in water. Titanium exposure is mainly derived from dental and orthopaedic implants, screws, pacemaker encasings, cosmetic products and some foods. "Metals are ubiquitous in the environment, and people are chronically exposed to low levels of metal," said lead investigator of the study Maria Grau-Perez, M.Sc., of the Institute for Biomedical Research Hospital Clinic de Valencia INCLIVA in Valencia, Spain, and a PhD candidate in the department of preventive medicine, public health and microbiology at the Universidad Autonoma de Madrid, in Spain. "According to the World Health Organization, 31 per cent of the cardiovascular disease burden in the world could be avoided if we could eliminate environmental pollutants," she added. Atherosclerosis developed when fatty deposits, or plaque, build up in the arteries causing them to narrow, weaken and stiffen. Depending on the arteries affected, it can lead to a heart attack, stroke, angina, peripheral artery disease or kidney disease. Prior research on the impact of metal exposure on atherosclerosis has traditionally centred on the carotid arteries, the major arteries in the neck. This study focused on subclinical atherosclerosis -- before symptoms are present -- and examined the impact of metal exposure on the carotid, femoral and coronary arteries. Previous research suggested that imaging of the femoral artery, which is the main artery supplying blood to the lower body, may lead to earlier detection of atherosclerosis. Researchers evaluated 1,873 adults (97 per cent men) in the Aragon Workers Health Study. The study participants worked at an auto assembly factory in Spain and ranged in age from 40 to 55. Researchers measured participants' environmental exposure to nine toxic metals -- arsenic, barium, uranium, cadmium, chromium, antimony, titanium,

research has found that vanadium and tungsten -- and the exposure's association with the presence of subclinical atherosclerosis in the carotid, femoral and coronary artery regions. The study explored the potential role of individual metals and metal mixtures on the development of atherosclerosis.

During the participants' annual occupational health visits between 2011 and 2014, socioeconomic and health information for each participant were recorded, including

atherosclerosis.

5. Arsenic and cadmium appeared to be most closely associated with increased plaque levels in the carotid arteries; cadmium and titanium are of greater concern for the femoral arteries; and titanium, and possibly cadmium and antimony, are of more concern for the coronary arteries.

6. Arsenic may be more toxic for the arteries when found in combination with cadmium and titanium.

education level, smoking status and medication use. Each person in the study had a medical examination to measure body mass index, blood pressure, blood glucose levels, cholesterol levels, triglyceride levels and more. Urine samples were collected to assess metal exposure from air, water and food. Researchers performed carotid and femoral ultrasounds, as well as coronary calcium scoring tests.

The analysis found:

1. Older study participants had higher levels of most of the metals measured in the urine. 2. The few female participants in the study had higher metal levels compared to men when levels were measured in the urine.

3. Adults who had smoked at any time showed higher levels of arsenic, cadmium, chromium and titanium than the people who had never smoked.

4. Higher levels of arsenic, cadmium, titanium, and potentially antimony were associated with a higher probability of having subclinical

"This study supports that exposure to toxic metals in the environment, even at low levels of exposure, is toxic for cardiovascular health," said study co-author Maria Tellez-Plaza, M.D., PhD, a senior scientist at the National Center for Epidemiology and the Instituto de Salud Carlos III in Madrid, Spain.

"The levels of metals in our study population were generally lower compared to other published studies. Metals, and in particular arsenic, cadmium, and titanium, likely are relevant risk factors for atherosclerosis, even at the lowest exposure levels and among middle-aged working individuals," she added.

The study included a very specific population of mostly men in one area of Spain, so the results may not be completely extrapolated to women or other populations worldwide. Additional research is needed to understand the mechanisms involved in the development of atherosclerosis based on associations to metals

Stand straight and stretch your arms wide apart. Rotate your arms on the axis in circles while keeping them straight. Do rotations of 5 and change the direction of rotation. Do another 5 rotations in the opposite direction. Bring your arms down and rotate your shoulders. Engage the shoulder and neck muscles. Do rotations of 5 and change the direction of rotation. Do another 5 rotations in the opposite direction. **Chest expansions:** You can do this exercise in the following steps: Stand straight with your hands joined and stretched straight forward. Open your arms wide apart and stretch them sideways

Make sure your arms are straight. Repeat the steps at least 15 times.

As per the calendar issued by the Legislative Assembly secretariat, there will be general discussions on the budget on March 8, 10, and 11. The Finance Minister, who is also the Chief Minister, will conclude discussion on the budget on March 11 with his reply.

All eyes are on the budget given commitments made by National Conference in its manifesto for the 2024 assembly elections

commitment made to the people of Jammu & Kashmir.

"Over the next five years, we will fulfill every single promise we made in our manifesto, from A to Z. Unlike others, we will stand by our commitments," he said, indirectly targeting the BJP for failing to keep its past promises.

He also reminded the House of the assurances given in previous years regarding the withdrawal of cases against individuals booked during the 2016 protests. "Many were told their cases would be withdrawn, yet those cases still exist. We will ensure justice is done," he said.

Countering the BJP's repeated justification that Article 370's removal was necessary for J&K's progress, Abdullah demanded evidence to support this claim.

"You list projects like Ring Road, IITs, AIIMS, and highways, but tell me-which one was impossible before August 2019? Was there any project that could not have been done under Article 370?" he asked.

He pointed out that many of these initiatives were planned or initiated before 2019. "If Article 370 was truly an obstacle, give us just one example of a project that couldn't have happened otherwise. Otherwise, stop misleading people," he asserted.

Omar Abdullah also took a strong stand against the continued use of the Public Safety Act (PSA), accusing the BJP-led administration of misusing it to detain people indefinitely without trial.

"If you are keeping people in jail for years under PSA alone, it means you have no evidence to prosecute them. If they are what you claim-stone pelters, OGWs-then why don't you charge them in court? Why preventive detention?" he asked.

Citing his own experience, he added, "You imposed PSA on me because you had nothing else against me. And today, 400 people remain detained under PSA simply because the government has no real case against them."

Abdullah also refuted BJP's claim that political reservations had improved representation for marginalized communities, particularly Gujjars.

"Before political reservations, we had nine Gujjar MLAs. Today, we have only six. If your goal was to empower the community, why has their representation gone down instead of increasing?" he questioned.

He said that dialogue with Pakistan is the domain of the Ministry of External Affairs. "Some people here advocated dialogue with Pakistan, but they should understand it is not the domain of the Assembly. The MEA knows when to hold talks with Pakistan," he said.

Sharma also stated that entire Kashmir politics is now revolving around the BJP, with parties blaming each other for being their proxies



### Southee, Philander back Shami's call to revoke ban on usage of saliva on ball

urged the ICC to rescind the ban on using saliva to shine the ball, in a bid to bring the art of reverse swing back into play.

"Wearetrying[togetreverseswing], but the usage of saliva on the ball is not allowed," Shamitold reporters after India's four-wicket win over Australia in the Champions Trophy semi-final. "We keep appealing that we should be allowed to use saliva so that we can bring reverse swing back into the game and it becomes interesting."

The ban on using saliva to polish the ball was first put into place in May 2020 during the Covid-19 pandemic, as a temporary measure. Then, in September 2022, the ICC made the ban permanent.

Shami has urged the ICC to reconsider their decision now. He has also got the backing of two former international bowlers in Vernon Philander and Tim Southee, who feel reverse swing is definitely missing in the game, especially on batter-friendly surfaces.

"That was a rule brought around Covid with the virus going around the world, but I think as a bowler, you want to have a slight advantage," Southee said on ESPNcricinfo's Match Day. "We see the game going the way it's going and seeing sides score 362 and more often than not over 300 in this format. I think there needs to be something in the bowlers' favour, and whether that's a little bit of saliva, then yeah, I don't see why they

ohammed Shami has couldn't afford to get that back in." Philander felt that the use of saliva and

reverse swing could have come in handy for South Africa in the Champions Trophy semi-final against New Zealand, particularly



in the later half of the innings. New Zealand amassed 362 for 6 in their 50 overs.

"If we look at the state of that ball, I mean towards the back end, it was really scuffed up, and I think had you used the saliva [to polish one side of the ball], the element of the reverse swing might have come into play," Philander said. "So it certainly does play a part. You can get it to shine up and you use the elements to swing it a little longer.

"I'd like to see that element being brought back into the game because I think it's needed as well. I mean, especially in ODI cricket where we see batters really dominating,

especially when you play on surfaces like we've just seen in Pakistan as well where it's really batter friendly."

Southee felt that the use of saliva to polish one side of the ball and induce reverse swing makes even more of a difference in red-ball cricket than in white-ball.

"I think the ball only swings initially for a few overs [in white-ball cricket]. But with the red ball, you are able to bring it back and obviously sweat can be limited at times in various parts of the world, whereas saliva you're able to obviously have access to it from a number of sources and in all parts of the world," he said. "I think there is an advantage to having saliva on the ball, probably more so in red-ball cricket than white-ball cricket."

Are there any other advantages of using saliva to polish the ball instead of sweat?

"With the South African team, we were always trying to keep the ball as dry as possible," Philander said. "The minute you start erring on the side of sweat, I think you start wetting both sides of the ball. Your hands get sweaty, especially when you play in hot, humid conditions.

"Saliva was definitely the preferred method of shining the ball. In the longer run in the scheme of things, I'd like to see that being brought back. As far as sweat is concerned, I do feel that it's difficult to control the amount of sweat you put on the ball, [especially when] you start sweating obviously heavily."

"We are trying [to get reverse swing], but the usage of saliva on the ball is not allowed," Shami told reporters after India's four-wicket win over Australia in the **Champions Trophy semi-final.** "We keep appealing that we should be allowed to use saliva so
