## CM Omar announces committee to devise framework for regularization of Daily Wagers

“This is a humanitarian issue, not just a financial issue”

**JAMMU:** Chief Minister Omar Abdullah today announced to constitute a committee under the chairmanship of Chief Secretary Atal Dulloo to devise a roadmap for the regularization of daily-rated wagers.

Replying to the discussion on Budget 2025, the Chief Minister said, “Through this House, I am announcing the formation of a committee under the Chief Secretary, with the Additional Chief Secretary to the CM, Commissioner Secretary GAD, Planning Secretary, and Law Secretary. Within six months, we will finalize a framework, determine the exact number of daily wagers, and legally and financially assess how they can be regularized. Then, the policy will be discussed here in the next budget.”

Speaking about the plight of daily wagers, the Chief Minister emphasized that this is not



merely a financial issue but a humanitarian and social concern. Referring to the use of force against protesting daily wagers in Srinagar and

Jammu, he remarked, “What happened to them yesterday, I do not want to repeat. But I must ask—why did the situation reach this stage?”

He recalled that during his previous tenure as Chief Minister, his government had initiated a framework for regularizing daily wagers. However, he noted that the 2014 elections and the devastating floods had disrupted these plans. Taking a dig at the opposition, he questioned their inaction, stating, “What did you (the opposition) do? I reviewed past budget speeches from your tenure and found no mention of daily wagers except in the fourth budget speech, where you vaguely spoke about ‘sustainable livelihood.’” He further pointed out that even after the issuance of SRO-520, only 577 daily wagers were regularized.

Challenges in Regularization

The Chief Minister highlighted that, over the past decade, opposition which were in power then failed to address the issue, despite having both state

## India, Bharat or Hindustan, call it by whichever name you prefer: CM Omar

**JAMMU:** Asserting that this country is known by its three names — Bharat, India and Hindustan — Jammu and Kashmir Chief Minister Omar Abdullah on Tuesday said citizens may call it by any name that resonates with them.

Responding to a question on the comments made by RSS General Secretary Dattatreya Hosabale, who insisted at a function that if the country's name is Bharat, it should exclusively be called that, Abdullah said, “We call it Bharat. We call it India. We call it Hindustan. We have three names. Whichever name resonates with you, you can call it that.

Speaking to reporters outside the Assembly, he said, “It is the ‘Constitution of India’ and the ‘Reserve Bank of India’. Why is that? That



question should be asked. If the country's name is Bharat, shouldn't it have been called only that?”

Pointing out that both ‘Bharat’ and ‘India’ are written on the Prime Minister's plane, he added, “It is called the Indian Air Force and the Indian Army. But we also speak from the perspective of Bharat.”

J&K per capita income remains below national average: Economic Survey

**SRINAGAR:** The per capita income (PCI) of Jammu and Kashmir has remained below the national average with UT's PCI estimated to be 1,54,703 in 2024-25 in comparison to the national average of 2,00,162.

The PCI is a measure of the amount of money earned per person.

As per the Economic Survey 2024-25, the PCI of J&K at current prices is estimated to attain a level of Rs 1,54,703 in 2024-25 (advance estimates) as compared to national level per capita income of Rs 2,00,162 in 2024-25.

The Economic Survey report however states that the per capita income of J&K at current prices is anticipated to grow at a rate of 10.6 percent in 2024-25 as compared to all-India growth of 8.7 percent.

## LG orders remittance in life imprisonment to three convicts

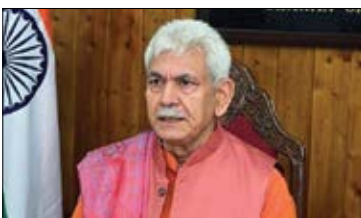

**SRINAGAR:** Jammu & Kashmir Lieutenant Governor Manoj Sinha today ordered remittance in life imprisonment to three convicts who were arrested under sections 302, 34, 201 of Ranbir Panel Code earlier.

A notification issued by J&K Home department on the directions of Lieutenant Governor reads, “In exercise of the powers conferred under Section 473 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023 read with S O 2506 (E) of 2024 dated 28 of June 2024 of the Ministry of Home Affairs, Government of India, the Lieutenant Governor is pleased to order that the remaining term of imprisonment of the life convict prisoners, mentioned in the Annexure to this notification, shall be remitted with effect from the date of issuance of this notification, subject to the conditions”.

According to notification the convicts

have been directed to maintain peace, stay away from indulging into any unlawful activities, refrain from intimidating any member or relative of the victims' family, ensure their presence before authorities once



in six months, and furnish legal formalities required for the premature release before jail authorities.

Besides the concerned police stations have been directed to keep watch on their activities, and in case of any violation their release shall be cancelled.

## GoI reiterates its commitment to make J&K terror free

**NEW DELHI:** The Government of India on Tuesday reiterated its commitment to make Jammu & Kashmir terror-free by eliminating terror networks, dismantling financing mechanisms and preventing infiltration.

In a written reply to the Lok Sabha, Minister of State for Home Affairs, Nityanand Rai, outlined key measures proposed in the Budget to enhance internal security, including steps specifically focused on J&K.

“The government plans to modernize law enforcement by integrating new criminal laws into a digital system, enhancing crime prevention, and improving criminal investigations. Also, mobile forensic labs will be deployed in every district, and state forensic labs will be modernized to strengthen

evidence-based policing,” the reply stated.

“To bolster cyber security, the Indian Cyber Crime Coordination Centre (I4C) will be expanded, along with cyber fraud



mitigation centres and a National Cyber Threat Intelligence system to counter digital threats,” it added. “Border security is also a key focus, with plans for

## 28,996 new ration cards issued under Food Security Act in J&K: Govt

**SRINAGAR:** The Jammu and Kashmir government on Tuesday informed that the Department of Food, Civil Supplies & Consumer Affairs (FCS&CA) has issued 74,071 new ration cards since September 2022, ensuring the inclusion of left-out households.

In response to a question by MLA Rajiv Jasrotia, the minister incharge, as per news agency—Kashmir News Observer (KNO), said that government has taken consistent measures to bring all left-out eligible families under the Public Distribution System (PDS).

“Since the transition to the Ration Card Management System (RCMS) in September 2022, 28,996 new ration cards have been issued



under the National Food Security Act (NFSA) and 45,075 under the Non-Priority Household (NPHH) category, ensuring that eligible households are not deprived of benefits,” the department stated.

The government also said that the distribution network

currently consists of 6,630 sale outlets, including Fair Price Shops (FPS) and Government Sale Centres.

It said that it is contemplating the opening of new Fair Price Shops (FPS) under the Jammu and Kashmir Targeted

# Pay Salary, Benefits To Consumer Body Members Sans Delay: SC To States



**NEW DELHI:** The Supreme Court has directed all state governments to immediately pay the salary and perquisites of the chairpersons and members of the state and district consumer redressal bodies as

per existing rules. A bench of Justices Abhay S Oka and N Kotiswar Singh also directed the Centre to take a call on amending the Consumer Protection (Salary, allowances and conditions

of service of President and Members of the State Commission and District Commission) Model Rules, 2020. "We direct all the state governments to ensure that without prejudice to various contentions raised in this group of cases, salary and perquisites as per existing state rules shall be immediately paid to the chairpersons/ members," the bench said. In case there was no decision from the Government of India on the prospective amendment, the court said, it would "consider exercising power under Article 142 of the constitution". The top court in the March 5 order said, "In the event compliance is not made by some of the state governments, the parties concerned are free to hand over a note to that effect to the learned amicus curiae so that the court can pass an appropriate order." The bench was hearing a plea related to the salaries and service conditions of the members of consumer fora.

## Court Directs Registration Of FIR Against Arvind Kejriwal For 'Misusing' Public Money

**NEW DELHI:** A court here on Tuesday directed Delhi Police to register an FIR against AAP leader and former chief minister Arvind Kejriwal and others for allegedly



misusing public money in putting up large hoardings in the national capital. "This court is of the considered opinion that the application u/s 156(3) Cr.P.C. deserves to be allowed. Accordingly, the concerned SHO is directed to register FIR immediately under section 3 of Delhi Prevention of Defacement of Property Act, 2007 and any other offence that appears to have been committed from the facts of the case," Additional Chief Judicial Magistrate Neha Mittal said. The complaint filed in 2019 alleged that Kejriwal, then Matiala MLA Gulab Singh (AAP) and then Dwarka A ward councilor Nitika Sharma "deliberately misused public money by putting up large-sized hoardings" at various places in the area.

## Drone Dropping Of Arms In Punjab: 6 Terrorists Linked To Khalistan Zindabad Force Get Life Term

**NEW DELHI:** A special NIA court in Mohali has sentenced six terrorists linked to proscribed Khalistan Zindabad Force (KZF) to life imprisonment for smuggling explosives and arms through drones in Punjab for launching a terror attack in 2019.

Besides the KZF, the convicts are also linked to designated individual terrorists – Germany-based Gurmeet Singh alias Bagga and Pakistan-based Ranjeet Singh alias Neeta, officials said Tuesday.

Three other persons have been sentenced to 10 years of rigorous imprisonment in the case by the National Investigation Agency (NIA) special court, they said.

"While Akashdeep Singh, Balwant Singh, Harbhajan Singh, Balbir Singh, Maan Singh and Gurudev Singh have been sentenced to life imprisonment, accused Shubhdeep Singh, Sajanpreet Singh and Romandeep Singh have been sentenced to 10 years

rigorous imprisonment (RI) for their roles in the case," an agency found that the



NIA spokesperson said in a statement. The court has also imposed fine on all convicts, the statement said. The spokesperson said the court found the accused guilty under various sections of Indian Penal Code, anti-terror Act UAPA, Arms Act and Explosives Substances Act in the case, linked with the proscribed terrorist organisation KZF. The NIA had taken over the investigation from Amritsar police in October 2019.

convicts were involved in collecting, transporting and smuggling huge caches of arms, ammunition, explosives, communication devices and fake Indian currencies into India via drones by Germany-based terrorist Bagga and Pakistan-based terrorist Neeta. "The explosives, arms, etc were drone-dropped at specified locations in Punjab's Tarn Taran district at various intervals during the months of August and September, 2019," the statement said.

## Govt ready to include farmers in PM Kisan Samman Nidhi who are not part of it yet: Agri minister

**NEW DELHI:** The government is ready to provide Rs 6,000 annual cash benefit under the PM Kisan Samman Nidhi to all eligible farmers who are not part of it yet, Union Agriculture Minister Shivraj Singh Chouhan said in the Lok Sabha on Tuesday. He asked all state governments to cooperate with the Centre in identifying such farmers and ensuring their inclusion in the scheme. "If anyone is left behind, please help us include all of them under the PM Kisan Samman Nidhi. We will ensure that such farmers also get the past instalments," Chouhan said during the Question Hour. All eligible beneficiaries must possess at least one piece of land, get eKYC done and register themselves at the PMKISAN portal, the minister said. He added that the fund is directly transferred to the bank accounts of the beneficiaries in three equal instalments of Rs 2,000.

"We will ensure that all of these farmers get their dues without even a single day of delay," he said while asserting that the Narendra Modi government is committed to the welfare of the farmers.

Replying to a question related to Tamil Nadu, he said the central government does not discriminate against any state. "As a union minister) I have so far visited Tamil Nadu twice. Once for the work related to the agriculture ministry and the other for the works of the rural development ministry. In both occasions, neither the state agriculture minister nor the rural development minister came for the meeting," he said.

Chouhan said he was ready to visit Tamil Nadu

again to discuss farmers' issues. "We are committed to serving the people of Tamil Nadu. We have deep respect for the people of Tamil Nadu," he said. PM Kisan is a central sector scheme with 100 per cent funding from the Government of India.



Operational since December 1, 2018, an annual income support of Rs 6,000 in three equal instalments is provided to all land-holding farmer families under the scheme.

State governments and Union Territory administrations identify the farmer families that are eligible for the support as per scheme guidelines.

The last instalment of PM Kisan Samman Nidhi was disbursed on February 24 when a total of Rs 22,000 crore was given through the Direct Benefit Transfer (DBT) system to the bank accounts of 9.8 crore farmers, including 2.41 crore women farmers, across the country. (PTI)

## Siddaramaiah requests PM to implement price deficiency payment scheme for red chillies in Karnataka

**BENGALURU:** Chief Minister Siddaramaiah has written to Prime Minister Narendra Modi and Union Agriculture Minister Shivraj Singh Chouhan requesting for implementation of price deficiency payment scheme under Market Intervention Scheme for red chillies in Karnataka. In the letter, he expressed deep concern for the lakhs of red chilli farmers in Karnataka, particularly in the Kalyana Karnataka region, who are facing an "unprecedented crisis" due to the drastic fall in market prices. The Chief Minister noted that the Government of India has



approved the Price Deficiency Payment (PDP) scheme under the Market Intervention Scheme (MIS) for Red Chillies (Guntur

Variety) in Andhra Pradesh, fixing the Minimum Intervention Price (MIP) at Rs 11,781 per quintal with coverage for up to 25 per

cent of production. "While this is a welcome step, the distress faced by Karnataka's red chilli farmers remains unaddressed," he stated in the letter dated March 10. Siddaramaiah highlighted that in Karnataka, the cost of production for Guntur variety of red chillies (Rain fed) has been assessed at Rs 12,675 per quintal by the Karnataka Agricultural Price Commission. "However, farmers are forced to sell their produce at distress prices as low as Rs 8,300 per quintal in markets like Sindhnanur.

## Wular Lake Still Major Fish Producer, Says J&K Govt

Says production crosses 4500 MT in 2023-24; 5200 Fishermen rely on Wular for livelihood

**SRINAGAR:** The Jammu and Kashmir government on Tuesday refuted the claims that the deterioration of Wular Lake has adversely impacted the fishermen community, stating that the lake continues



to contribute nearly 60% of Kashmir's total fish production. The Minister In-Charge, Forest, Ecology & Environment Department in reply to a query raised by MLA Nizam-Ud-Din Bhat, as per the news agency—Kashmir News Observer (KNO) informed that the fish catch from Wular Lake has shown a consistent increase over the past three years. The minister, while dismissing the claim of adverse impact, said the fresh water lake supports the livelihood of around 5200 registered fishermen. As per the data accessed, in 2021-22, the total fish catch stood at 2941.68 metric tonnes (MT), comprising 779.76 MT of local fish and 2161.92 MT of carp. The following year, 2022-23, the fish catch increased significantly to 3826.39 MT, with 818.25 MT of local fish and 3008.14 MT of carp. The highest production was recorded in 2023-24, reaching 4593.861 MT, with 1215.25 MT of local fish and 3378.611 MT of carp, the data suggests, indicating a positive trend in fish production—(KNO).

## Rs 16.89 cr flood protection works for Ningli Nallah under execution: Jal Shakti Minister

**JAMMU:** Minister for Jal Shakti, Javed Ahmad Rana, today informed the House that flood protection works worth Rs. 16.89 crore, approved under NABARD for Ningli Nallah, are currently under execution.



The Minister was replying to a question raised by Irshad Rasool Kar in the Legislative Assembly. The Minister informed that a DPR for an amount of Rs. 44.85 crore has been prepared and shall be part of the shelf of projects to be taken up under NABARD funding for modernization of Zaingeer Canal. Besides, one work has been completed under FMP Phase II and one work is under execution under UT Capex. He said that the survey for framing of DPR for the Khursi Nallah D/s National Highway (Sopore constituency) has been completed and DPR will be framed accordingly. He informed that WSS Zaingeer, WSS Shiva (proposed) and WSS Saidpora (proposed) are partly dependent on Zanageer canal as the source, WSSs Mazbugh, Checkpora Nowpora, Nowpora Kalan, Bohripora Sheeraz Colony, Bohripora Hamdanabad and Sidiq Colony and Model Town, Wadoora and Nathipora are dependent on Pohru Nallah as the source while WSSs Takiybal Wagub (under execution) and Sharkwara Rural are dependent on Ningli Nallah as the source. He said that the DPRs are based on a detailed survey that included assessment of quantum and quality of the source. He said that in these schemes, provision of rapid sand filtration plants has been kept to meet the BIS 10500 quality parameters. Besides, surface water has been taken as a source that has sufficient discharge capacity thus ensuring sustainability. While sharing details of expenditure, the Minister said that an amount of Rs. 3.80 crore has been expended for maintenance and upkeep of various Nallahs of Sopore Constituency under various schemes like FMP Phase II UT Capex, M&R and PRI grants besides NABARD.

## Govt orders mocked: Teacher refuses to teach, CEO office offers cover in Bandipora

**SRINAGAR:** Despite clear government orders directing all attached teachers to return to their schools, a teacher from High School Chanpal Chittbandi, a tribal area in Bandipora district, continues to skip classes and report to the Chief Education Officer (CEO) office instead. The teacher, assigned to teach Class 10 English, was earlier on an unauthorised deputation at the CEO office for a long time. Last month, the Director of School Education Kashmir (DSEK) ordered his return to the school. However, sources say the CEO office overruled the Director's order, allowing the teacher to return to office duties rather than fulfilling his teaching responsibilities. Students at the school have raised concerns, alleging that the teacher only marks attendance in the morning and then leaves. "We see him in the morning for attendance, but after that, he disappears," said a Class 10 student. Another student asked, "Why does our teacher stay in the CEO's office while we sit here without an English class? Do students

in tribal schools not deserve proper education?" A third student added, "We have no choice but to study on our own. Every day, he comes, signs in, and leaves. This is not fair."

This situation comes despite DSEK's February 22, 2025 order mandating that all attached teaching staff return to their parent institutions. To ensure compliance, the government

has now tasked District Vigilance Officers (DVOs) with personally monitoring the implementation of these directives and submitting a report by March 15. While the order applies to all teaching and non-teaching staff, concerns have been raised about selective enforcement. In Bandipora district, multiple Cultural Coordinators are reportedly still working in offices instead of schools, allegedly with approval from Zonal Education Officers (ZEOs). The District Cultural Coordinator remains stationed at the CEO office, despite the detachment order. Local residents and education activists have criticized these irregularities, questioning why a teacher from a tribal school was selected for an office role while teachers from town schools with surplus staff could have been assigned instead.



## Stranded and Forgotten: How ATD 2023 is Failing Hardzone Teachers

**Bandipora:** The Annual Transfer Drive (ATD) Policy 2023, introduced to ensure fair and structured teacher transfers, has turned into a nightmare for hundreds of teachers who were assured relocation from hard zones to soft zones after one year of service. However, despite fulfilling their mandated tenure, these teachers remain stuck in some of the harshest terrains of Jammu and Kashmir, with no clarity on their return. The policy, initially welcomed for balancing teacher deployment, is now being criticized as a failed promise that has left many teachers feeling betrayed by the education department's inaction. Teachers serving in areas like Gurez and other hard zones have raised serious concerns about delays in their transfers, questioning whether the system is truly committed to fairness. Speaking anonymously to Kashmir Convener, a teacher, currently stationed in Hardzone Gurez near Line of Control (LoC), voiced his deep anguish. "The officials at the helm have displayed incompetence and a breach of trust. If the ATD policy states 'one year in a hard zone,' then one year must mean exactly that. They can't play foul with teachers who upheld the policy in good faith."

Another teacher, also from Zone V Gurez, echoed similar sentiments, emphasizing the unfair advantage enjoyed by those with bureaucratic and clerical backing. "Unlike others, we didn't manipulate the system with fake medical certificates or political connections. We followed the rules. And yet, we are still here, as if we are mere numbers on a list, as if our families and personal lives do not matter."

The teachers said, after completing their tenure they approached and knocked at every possible door – Ministers, Principal Secretaries (Education), Directors (Education), and Chief Education Officers – in hopes of a timely transfer. Reassurances were given—words that have now begun to resemble mere folklore. "Before winter vacations," they were told, "your transfers will be processed

and by last week of February, 2025, it'll be completed." But winter has come and gone, and the promised transfers are nowhere in sight. For these stranded teachers, the situation has taken an absurdist turn, much like Samuel Beckett's Waiting for Godot, where the promised change remains a distant, elusive dream. As days stretch into months, they are left wondering: Are their transfers even possible? Or is this yet another chapter of systemic neglect and broken promises? What remains undeniable is that the ATD Policy, once envisioned as a fair and transparent mechanism, has now become a source of endless suffering. The question now looms large—will the authorities finally act, or will these teachers continue to be lost in the bureaucratic maze, waiting for justice that never arrives?

## DSEK Cancels Teacher Attachments, Vigilance Officers to Monitor Compliance

**SRINAGAR:** Following the orders of repatriation of all teaching staff deployed or attached for administrative works, the government has directed the District Vigilance Officers to personally monitor the implementation of the government orders for strict compliance. DSEK had earlier issued orders on 22nd February last month directing all teaching staff deployed or attached for administrative works in different offices or departments to return to schools with immediate effect. However reports suggest that such orders issued from time to time are not implemented on ground following which a fresh directive was issued. "In continuation to this office order dated 22/02/2025, it is hereby ordered that District Vigilance Officers/Additional District Vigilance Officers shall personally monitor the implementation of instructions regarding repatriation of all teaching staff deployed or attached for administrative works in different offices or departments and non-teaching staff working outside parent departments," reads the order by DSEK. The DVOs have been asked to submit compliance reports in respect of officials belonging to their respective districts on the devised format to DSEK not later than 15th of March. The order mandates that all attached teachers return to their original places of posting, reinforcing the need for educators to focus on classroom teaching rather than administrative tasks. In Bandipora district, multiple Cultural Coordinators are reportedly working in offices instead of schools, allegedly with the approval of Zonal Education Officers (ZEOs). The District Cultural Coordinator remains stationed at the CEO's office, despite the detachment order. Official sources said while the directive applies to all teaching and non-teaching staff, it does not explicitly mention Cultural Coordinators, raising concerns over loopholes in enforcement. With Vigilance Officers actively monitoring the situation, Locals are hopeful that the Education Department will take swift action to ensure full compliance and prevent further misuse of teacher attachments.

## Nizam-ud-din Bhat Raises Concern Over Wular Lake's Deterioration, Calls for Immediate Action

**BANDIPORA:** MLA Bandipora Nizam-ud-din Bhat has expressed dissatisfaction over the government's replies to his questions in the Legislative Assembly regarding the conservation of Wular Lake. The government established the Wular Conservation and Management Authority (WUCMA) to oversee the lake's protection but effective measures were not implemented in previous years, leading to the current crisis. Bhat stressed the urgent need for concrete steps to preserve Wular's ecological balance and support those dependent on it. In response to Bhat's question, the government acknowledged that Wular contributes nearly 60% of Kashmir's fish production. However, the fishermen population lacks proper infrastructure and basic amenities. The deterioration of Wular has directly impacted fishermen, affecting their livelihoods. Bhat stressed the need for focused development efforts in both urban and Wular-adjacent areas. He urged the government to expedite Wular's restoration and ensure fishermen receive necessary support. He expressed hope that strong policy decisions and timely action will help revive the lake and safeguard livelihoods. With Wular's critical role in Kashmir's ecosystem and economy, Bhat's appeal has brought renewed attention to the urgency of preservation efforts.

## Block Public Health Unit being developed at CHC Sumbal: Sakeena Itoo

**JAMMU:** Minister for Health and Medical Education, Sakeena Itoo, while replying to a question raised by Hilal Akbar Lone on criteria for upgradation of Community Health Centre (CHC) Sumbal to Sub-District



Hospital level, today informed the House that CHC Sumbal is not feasible for its upgradation to Sub District Hospital as per IPHS 2022 norms. She apprised that as per IPHS 2022 guidelines, the districts with a population of less than 5 lakh and a functional District Hospital (DH) do not qualify for a Sub District Hospital (SDH). She also informed that SDH Davar, Gurez, has been sanctioned in the district for being a snowbound area. The Minister also informed the House that around 14 healthcare facilities are catering to the primary healthcare services. He said that CHC Sumbal is well equipped in terms of manpower, machinery, equipment, infrastructure, dialysis unit, medical and emergency equipment serving as a critical healthcare hub in Bandipora district. She further informed that the Block Public Health Unit (BPHU) is also being developed at CHC Sumbal under PM-ABHM which will be an important linkage for the latest healthcare facilities. The Minister also informed that the department is focusing on consolidation of existing health institutions by way of strengthening the manpower, infrastructure and services in the existing healthcare institutions, rather than upgradation.

## Budget 2025: A Ray of Hope or Another Year of Despair for J&K's Youth?

"A land flourishes when its youth thrive, but when dreams turn into disillusionment, the future stands on shaky ground."

As the echoes of Chief Minister Omar Abdullah's maiden budget for Jammu and Kashmir resonate across the region, the people find themselves at a familiar crossroads—one filled with hope yet shadowed by skepticism. The 1.12 lakh crore budget for 2025-26 has been presented as a vision for progress, offering free electricity to Antyodaya families, free transport for women, increased pensions, and incentives for tourism and industries. These measures, though commendable, barely scratch the surface of the deeper crisis plaguing the region—the desperation of its educated youth.

Jammu and Kashmir is home to thousands of highly qualified yet jobless youth, many of whom have dedicated years to education with the hope of securing dignified employment. The harsh reality, however, remains unchanged. Unemployment is not just a statistic; it is a psychological crisis. It breeds frustration, depression, substance abuse, and, in some cases, rebellion against the very system that was supposed to uplift them. While the budget promises economic development, it largely remains silent on the most pressing demand of the youth—employment.

One of the most glaring contradictions in this scenario is the existence of thousands of vacant posts in government departments while the number of unemployed graduates continues to rise. From education to healthcare, administrative services to public infrastructure, critical departments are suffering from severe staff shortages, yet young aspirants wait endlessly for recruitment processes that either remain stalled or move at a snail's pace. Many schools and colleges across J&K function without adequate teaching staff, forcing students to suffer due to a lack of qualified educators. At the same time, thousands of qualified candidates who have cleared eligibility tests such as NET, SET,

and Ph.D. remain unemployed. What is stopping the government from filling these vacancies?

A glaring example of this crisis is the plight of Bachelor of Dental Surgery (BDS) graduates. Since 2008, not a single government job has been announced for BDS doctors. While the government proudly established dental colleges, the graduates of these institutions have been left to struggle in a system that has offered them no space. Many have now crossed the age limit for government jobs, yet there has been no initiative to address their concerns. This is not just limited to dentistry—many other fields face the same neglect. In several departments, while a few posts are advertised, they resemble the classic case of "ek anaar, soh bimaar"—one opportunity for hundreds of desperate candidates.

Similarly, healthcare institutions lack doctors, paramedical staff, and support personnel, despite an army of medical graduates waiting for placements. The same is true for engineering, agriculture, and administrative services. The government's reluctance to expedite job recruitment is widening the trust deficit between the youth and the administration. What is the purpose of a budget if it does not acknowledge and address the grievances of the very generation that will shape the future?

While Mission YUVA claims to generate 4.25 lakh jobs through entrepreneurship over five years, the youth of J&K need more than just ambitious figures on paper. They require immediate employment opportunities, transparent recruitment processes, and an end to delays and bureaucratic red tape. There is a growing sentiment among young people that they are being pushed towards private sector alternatives without being given a fair shot at government jobs, which remain one of the few stable employment avenues in the region.

The frustration of unemployed youth is no longer just a personal struggle; it is a ticking time bomb for society. Depression, anxiety, and suicidal tendencies are on the rise among educated youth who see no future despite their qualifications. has driven many young minds toward antisocial activities, further destabilizing the region. Many young professionals, despite their deep-rooted love for their homeland, are forced to seek opportunities outside J&K. This leads to an exodus of talent, weakening the state's intellectual and economic future.

A state cannot thrive on freebies and subsidies alone; it must empower its citizens through employment, economic security, and self-reliance. The youth do not seek charity—they seek opportunity, dignity, and recognition of their hard work. Without substantial government job recruitment, the very foundation of this budget remains weak. The government must take immediate steps to expedite recruitment processes, ensure transparency in hiring, and strengthen mental health support for students and job seekers.

CM Omar Abdullah's budget, though presented with optimism, must translate into tangible results. The educated youth of J&K cannot be kept waiting any longer. Their aspirations must not be sacrificed at the altar of political rhetoric. A budget is not just about numbers; it is about restoring faith, delivering justice, and ensuring that no young mind feels abandoned. If this administration truly seeks to bring change, let it begin with jobs, dignity, and hope—not just promises.

History will not remember the allocations of this budget, but it will remember whether it truly uplifted the youth or let them drown in despair. The choice is in the hands of the policymakers, but the consequences will be borne by the people. May wisdom prevail.

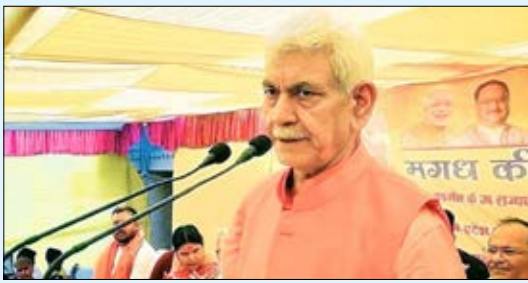

## Anti-encroachment drive on prime lands in Jammu city, 30 structures demolished

**Jammu:** The Jammu Development Authority (JDA) on Tuesday launched an anti-encroachment drive and reclaimed a significant portion of prime land worth crores of rupees in the outskirts of Jammu city by demolishing dozens of structures, an official said.

"A massive demolition drive was conducted by JDA officials in the Rangoor area of Sidhra following the directives of Vice Chairman Pankaj Kumar Sharma with active support from the administration and police," said a JDA spokesman. He said the drive aimed to remove illegal structures and encroachments from JDA properties. "This initiative is part of

JDA's ongoing efforts to reclaim unlawfully occupied land and ensure its proper utilisation for the city's planned development," he added.

The demolition drive, led by Garbi Rashid, director of land management at JDA, successfully demolished a total of 30 plinths and an under-construction residential building across various areas in Rangoor-Sidhra, he said. "Approximately 25 kanals of JDA land were recovered from encroachers", the spokesman said. Vice Chairman Pankaj Kumar Sharma directed the installation of JDA signboards and commencement of fencing on the reclaimed land. He warned against encroachment and

trespassing on JDA lands, saying that strict actions would be taken against violators.

"The demolition targeted several locations where encroachers had erected structures, hindering the utilisation of the land for public projects and development," Sharma said. The JDA has urged the public to cooperate and avoid illegal encroachments. "The drive received a strong support from residents concerned about illegal occupation of prime land in the area," the spokesman said. The JDA also assured ongoing monitoring and protection of the reclaimed land to prevent future encroachments, with stringent enforcement measures in place.

When it comes to longevity, one of the most famous ways to achieve it is by following a Mediterranean diet. This routine is deemed effective for obese, diabetic, heart patients, or people with any other form of comorbidity. It stresses eating more plant-based foods and limiting reliance on meat. However, this isn't where it ends; the world's longest-living people do not just stick to the Mediterranean diet. Instead, they follow some more rules to live a disease-free and long life. Keep reading.

**Rely on plants:** The world's longest-living people have a great deal of reliance on plant-based foods. From fruits to vegetables, nuts, and seeds, they practice abstinence from intake of meat like beef and pork or eat them very rarely in small quantities. This is the complete opposite of a standard western diet.

**Drink wine every day:** Ironically, the world's longest-living people are known to drink red wine every day but in moderate quantities. People living in the Blue Zones drink less than five ounces of wine each day – one or two small glasses. Red wine is a rich source of antioxidants and has often been associated to a healthier heart. When one goes overboard with wine, then the risk of health problems like high blood pressure and cholesterol can also spike considerably.

**The 80 per cent rule:** The Japanese island of Okinawa falls in the Blue Zones that are believed to have some of the healthiest and longest-living people in the world. The 80 per cent rule was established in the same place where people believe in eating until they are 80 per cent full and leave space for 20 per cent. Similarly, they follow the rule of eating the smallest meals in the evening and not snacking much throughout

the day. Striking a balance: The world's centenarians not only cook healthy food and stick to a balanced diet but also believe in focusing on the community and spirituality. Experts believe

Exercise is a must: People residing in the blue zones do not necessarily believe in spending time at gyms or investing in workout classes. Instead, they include other techniques of movement in their routine that include biking, gardening, and walking to stay fit.

**LONDON:** A recent study suggested that while vitamin D2 has a questionable impact on human health, vitamin D3 could balance people's immune systems and help to fight against viral infections such as COVID-19. A collaborative study was done by the Universities of Surrey and Brighton in which researchers investigated the impact of vitamin D supplements D2 and D3. The study was published in the journal 'Frontiers in Immunology'.

The research has taken on the activity of genes in people's blood for over a 12 week period. Contrary to widely held views, the research team discovered that both types of vitamin D did not have the same effect. They found evidence that vitamin D3 had a modifying effect on the immune system that could fortify the body against viral and bacterial diseases.

Professor Colin Smith, lead author of the study from the University of Surrey, who began this work while at the University of Brighton said, "We have shown that vitamin D3 appears to stimulate the type I interferon signalling system in the body - a key part of the immune system that provides the first line of defence against bacteria and viruses. Thus, a healthy vitamin D3 status may help prevent viruses

and bacteria from gaining a foothold in the body."

"Our study suggests that it is important that people take a vitamin D3 supplement, or suitably fortified foods, especially in the winter months," he added.

Although some foods are fortified with vitamin D, like some breakfast cereals, yoghurts, and bread, few naturally contain the vitamin. Vitamin D3 is produced naturally in the skin from exposure to sunlight or artificial ultraviolet UVB light, while some plants and fungi produce vitamin D2.

Many people have insufficient levels of vitamin D3 because they live in locations where sunlight is limited in the winter, like the UK. The Covid-19 pandemic has also limited people's natural exposure to the sun due to people spending more time in their homes.

Professor Susan Lanham-New, co-author of the study and Head of the Department of Nutritional Sciences at the University of Surrey said, "While we found that vitamin D2 and vitamin D3 do not have the same effect on gene activity within humans, the lack of impact we found when looking at vitamin D2 means that a larger study is urgently required to clarify the differences in the effects. However, these results show that vitamin D3 should be the favoured

Projects under the CDF must be completed within one year. In areas with limited working seasons, such as high-altitude regions, the DDC, with the MLA’s approval, may extend the timeline, allowing work to be completed within two working seasons, but not exceeding two years.

The scheme encourages MLAs to recommend projects with costs not exceeding 10 lakh per work, although higher-value projects may be considered for certain infrastructure investments, provided they are completed within the specified time.

A wide range of development activities will be supported, including the construction and upgradation of government buildings such as schools, hostels, libraries, and sanitation facilities, as well as the provision of computers for educational institutions. The fund will also support the construction of roads, irrigation facilities, power infrastructure, and housing upgrades for the underprivileged.

The government aims to make a significant impact on the local infrastructure by allowing projects such as: Construction and upgradation of roads, including approach roads and link roads, with funding upto Rs 15 lakh. Projects for water table recharging, irrigation, and drainage, with support up to Rs 20 lakh.

Strengthening power infrastructure with a budget of up to Rs 50 lakh.

Assistance for housing upgrades for tribal and BPL populations, with funding of up to Rs 20 lakh for each project.

This initiative also focuses on improving rural areas by allowing the creation of kachha roads where local needs dictate.

To ensure proper utilization of funds, the scheme, as per KNO, includes provisions for strict oversight. Payments for completed works will be made only after the necessary verification and the successful completion of a Defect Liability Period (DLP), if applicable.

The scheme, according to KNO, also emphasizes the importance of efficiency, requiring that at least 80% of the allocated funds be utilized within the financial year.

In cases where the prescribed threshold is not met, funds will be withheld until the target is achieved, and future allocations will be contingent upon meeting these goals.

Certain projects will not be eligible for funding under the CDF, including office or residential buildings for government departments, memorials, creation of posts, or any kind of revenue expenditure. The

funds will not be used for works related to places of worship either.

By giving MLAs the autonomy to choose projects and ensuring proper monitoring, the CDF scheme aims to foster a more localized and responsive approach to development. This initiative represents a significant step forward in empowering elected representatives to directly contribute to the growth and well-being of their constituencies

Gol reiterates

Quoting the popular song ‘Sare Jahan Se Achha, Hindustan Hamara’ (Our Hindustan is better than the whole world), the Chief Minister said, “We say this too, it is a different name. You can call the country by whichever name you prefer.”

The trio had been awarded life imprisonment of over 14 years, over 16 years and over 14 years respectively.

J&K per capita

“In the most recent years (2023-24 to 2024-25), J&K has shown robust growth in PCI, outpacing the national growth rate,” the report notes.

“J&K’s per capita income has also seen a steady increase, indicative of improving economic conditions and rising living standards. In 2024-25, the per capita income of J&K is estimated to be 1,54,703 compared to the national average of 2,00,162. The

growth in per capita income reflects the positive impact of economic diversification and the region’s focus on enhancing productivity across all sectors,” reads the Economic Survey.

The per capita income of Jammu and Kashmir has witnessed significant growth, increasing by approximately 148% between 2014-15 and 2024-25, according to data from the UT government’s Planning Department.

Even though the J&K’s PCI remains below the national average, as per the 2024-25 Economic Survey the gap has been narrowing, as the ratio of J&K’s PCI to India’s PCI has risen from 71.9% in 2014-15 to nearly 77.3% in 2024-25.

Furthermore, the PCI figures show that J&K’s per capita income offers a better view in comparison to the northern states from 2019-20 to 2023-24 period with

UT’s per capita income registering a compound annual growth rate of 8.3 percent which is higher than that of Punjab (6.22 percent), Delhi (6.74 percent), and Himachal Pradesh (6 percent).

‘Monitor anti-national

# Sodhi, Sears, Seifert return in Bracewell-led NZ squad for home T20Is against Pakistan

Allrounder Michael Bracewell will captain a different looking New Zealand T20I squad for the five-game series against Pakistan at home that starts on March 16. Seven members of New Zealand's silver-medal winning Champions Trophy squad have been selected for the series while those with IPL commitments were not considered.

The series will mark Bracewell's second series as New Zealand captain, having led the side during the tour of Pakistan in April 2024. "Mitch Santner's done a great job since taking over as white-ball captain and I'll really just be trying to build on his good work and create an enjoyable environment for the guys to perform in," Bracewell said in an NZC statement. "Pakistan are always a dangerous short-form side with lots of power and pace and we know they'll be hurting after an early exit in the Champions Trophy."

Among the players selected for the series are Ben Sears, the fast bowler who has recovered from his hamstring injury, and Ish Sodhi, who missed the recent home series against Sri Lanka. Kyle Jamieson and Will O'Rourke have been included for the first three games only, with the selectors managing the workloads of the pacers from the Champions Trophy.

Matt Henry, who injured his shoulder in the Champions Trophy semi-final, has been selected for the last two T20Is - subject to fitness - while Finn Allen, James Neesham and Tim Seifert have also been included after confirming their availability, if selected, for the build-up series to the 2026 T20 World Cup.

Daryl Mitchell and Mark Chapman will have a bigger responsibility with the bat as Devon Conway, Rachin Ravindra and Glenn Phillips are all unavailable due to the IPL.

"We're certainly starting to narrow our sights on the ICC T20 World Cup in India next February and March," selector Sam Wells said.

Lockie Ferguson and Santner will also miss the series with the IPL starting March 22. Kane Williamson opted out of selection; he has PSL commitments, starting from April 11, with Karachi Kings. ## New Zealand fast bowler Ben Sears signs for Yorkshire

Ben Sears, the New Zealand fast bowler, has signed for Yorkshire for the 2025 season, and will arrive in time for their second County Championship game of the season, against Worcestershire at Headingley.

Sears, 27, has impressed with his raw pace for New Zealand, including in his only Test to date, against Australia in 2024, when he claimed five wickets at Christchurch, including 4 for 90 in the second innings. He had previously made his T20I debut against Bangladesh in 2021.

He will be joined at Headingley by his fellow New Zealand quick Will O'Rourke, who has signed for the T20 Blast, while the club has also drawn comparisons with his compatriot, and former Yorkshire overseas player, Lockie Ferguson.

"I can't wait to get over to Headingley and start playing with the guys," Sears said. "Some of the signings made already are exciting and I hope I can add to that."

"It's important to set the tone early in any season. We have some big games in that first block, and I'll be ready to get the team off to the best start possible."

Head Coach Anthony McGrath said: "Ben is a real talent who can get some extra bounce when he bowls. In that early section of the year when pitches can be greener or slower, he'll be a real handful and I'm excited to get him over and start working with him."

Gavin Hamilton, General Manager of Cricket added: "To attract such talented bowlers like Ben to the club is testament to the lure of Yorkshire across the globe. Ben is an exciting talent and will provide the squad with an extra element that will be crucial this season."

"We're thrilled he has signed and look forward to welcoming him to Headingley in April."
