The Office of Chief Minister J&K wrote on X, "No new liquor vends are being advertised or allotted by my government. TV channels & news portals should immediately stop peddling

The statement reiterated that the number of wine shops (JKEL-2 vends) remains unchanged at 305 since FY 2023-24, with 291 in Jammu and 14 in Kashmir. It further clarified that the ongoing e-auction process pertains to the existing vends, with 271 already allotted and 34 set for re-auction on March 17, 2025.

# Five new railway surveys underway in J&K, others remain stalled: GoI

Doubling of Banihal-Baramulla rail line on govt's priority list

NEW DELHI: The Union government on Wednesday confirmed that five new railway survevs are underway in Jammu and Kashmir, while other projects remain stalled.

Replying to a question by MemberParliament(MP)Mohmad Haneefa in the Lok Sabha, Railway Minister Ashwini Vaishnaw said, "The Srinagar-Kargil-Leh rail plan was dropped due to high costs and low demand, and the Jammu-Poonch line remains stalled over feasibility concerns. Also, the Banihal-Baramulla rail line doubling has been prioritized by the government."

The minister, as per the news agency–Kashmir News Observer (KNO), clarified that there are no immediate plans to conduct a survey for a rail link between Ganderbal in Kashmir and Kargil in Ladakh, despite the strategic importance of the region.

He said the railway projects are planned and executed based on factors such as traffic projections, operational requirements and overall funding availability rather than on a district or Union Territory

Leh rail line was conducted in 2016-17. "The proposed 480-km route was estimated to cost rupees 55,896 crore. However, the project was not pursued further due to low traffic projections," he said.

Vaishnaw further informed that another railway project, the Bilaspur-Manali-Leh rail line, has been identified as a strategic line by the Ministry of Defence. He said the survey for this 489-km project has been completed, and a Detailed Project Report (DPR) has been prepared. The estimated

districts of Jammu and Kashmir continue to remain without railway connectivity, with no immediate plans to construct a rail line from Reasi-Katra to Rajouri on a priority basis.

Replying to another question by MP Mian Altaf Ahmad, the minister said that railway projects are sanctioned and executed based on feasibility, traffic projections and financial viability, rather than on a district or state-wise basis.

This is not under the purview of the elected government (in J-K) and the intelligence on the basis of which it has taken place has not been shared with us," Abdullah told reporters here after the culmination of the fifth edition of the Khelo India Winter Games.

However, Abdullah said, "On principle, we have never been in favour of such decisions".


"Since the Mirwaiz was released from house arrest, I have not seen any objectionable statement from him, but we do not have any information

### 3,962 Skype IDs, 83,668 WhatsApp Accounts **Used For Digital Arrest Blocked So Far: MHA** to raise awareness about RBI, and other law enforcement

**NEW DELHI**: The Ministry of Home Affairs (MHA) on Wednesday informed the Rajya Sabha that its Indian Cyber Crime Coordination Centre (I4C), a specialized wing, has identified and blocked more than 3,962 Skype IDs and 83,668 WhatsApp accounts involved in

digital arrest scams. According to the MHA, these fraudulent accounts were allegedly used to deceive individuals by impersonating law enforcement officials and coercing victims into transferring money.

Union Minister of State for Home Sanjay Bandi Kumar provided this information on behalf of the MHA while responding to a query from Dravida Munnetra Kazhagam MP Tiruchi Siva.

The I4C, in collaboration with the Department of Telecommunications (DoT), has launched a caller tune campaign

# Unsafe to convict on suspicious dying statement sans corroborative evidence: SC

was not safe to convict on the basis of a suspicious dying declaration in the absence of corroborative evidence and acquitted a man of his wife's murder.

A bench of Justices Sudhanshu Dhulia and Ahsanuddin Amanullah said a dying declaration was an important piece of evidence and a conviction could be made by relying solely on it as it held immense importance in criminal law.

"However, such reliance should be placed after ascertaining the quality of the dying declaration and considering the entire facts of a given case,"

The apex court, therefore, acquitted a man convicted for allegedly murdering his wife by setting her ablaze in September 2008.

The bench said the trial court convicted him on the basis of his wife's dying declaration.

"In other words, if a dying declaration is surrounded by doubt or there are inconsistent dying declarations by the deceased, then courts must look for corroborative evidence to find out which dying declaration is to be believed," the



bench said in its March 4 verdict.

Courts, the bench said, were required to act cautiously in such matters.

"In cases where the dying declaration is suspicious, it is not safe to convict an accused in

the absence of corroborative evidence," it said. It came on record that the victim gave two statements that were "totally different" from her subsequent testimonies,

including the one made before the judicial

Investigation, the bench said, also ruled out the angle of dowry harassment.

The order observed the relations between the families of the accused

and the woman had soured and a couple of

years the woman's death,

the man's brother had filed an assault case against his father-in-law and brother-in-law. While allowing his appeal, the bench set aside

a Madras High Court's February 2012 order that had upheld his conviction and life sentence for the alleged offence of murder.

According to the prosecution, the woman succumbed to burn injuries in a hospital three weeks after being set on fire by the husband. The couple lived in Tuticorin with its minor son.

The apex court observed the woman told the police in the hospital the fire was due to an accident in the kitchen.

However, three days later, the police recorded another statement of the victim in which she claimed her husband set her on fire by pouring kerosene.

### PM Modi providing free foodgrains to 80 cr people in systematic way: Pralhad Joshi

**NEW DELHI**: The UPA government introduced a food security law in 2013 haphazardly eying next year's general elections, but it was Prime Minister Narendra Modi who took the initiative to provide free foodgrains to 80 crore people in a systematic way, Union Minister Pralhad Joshi said on Wednesday.

The Union food minister made the remark in the Lok Sabha when Congress member Praniti Shinde said the National Food Security Act, 2013, which aimed to provide subsidised foodgrains to the poor, was the brainchild of her party's leader Sonia Gandhi.

"The Congress brought the food security act in 2013 only because of the election. It was introduced in a haphazard manner. Even rules under the act were not framed," Joshi said.

He said when the NDA government assumed charge after the 2014 Lok Sabha polls, Prime Minister Narendra Modi took the initiative to ensure free foodgrains to the poor as he understands their pain.

"Now Prime Minister Modi is providing free foodgrains to 80 crore people in the country," the Union minister said.

He also said that people's life was made easy by the Modi government with the introduction of the 'One Nation, One Ration Card' scheme under which a beneficiary can avail free foodgrains anywhere in the country, irrespective of the state he or she belongs to.

## 'JeM Operative' Accused Of Conducting Recce Of Hedgewar Memorial Moves HC For Bail

NAGPUR: An alleged Jaish-e-Mohammed operative accused of conducting a reconnaissance of the memorial of RSS founder Dr K B Hedgewar in Nagpur in 2021, has moved a bail application in the Bombay High Court, claiming that there was no evidence against him.

The accused, Raees Ahmed Sheikh Asadulla Sheikh, a resident of Jammu and Kashmir, moved the Nagpur bench of the high court on March 11 after his bail plea was rejected by a trial court.Jammu tourismJammu tourism guide

Sheikh is currently lodged in Nagpur Central Jail. Sheikh allegedly conducted a recce of Dr Hedgewar Smruti Mandir, the memorial of the Rashtriya Swayamsevak Sangh (RSS) founder, located in Reshimbag area of Nagpur on September 15, 2021. Sheikh had failed to conduct a recce

of the RSS headquarters located in Mahal area of the city. Sheikh's lawver Nihalsingh Rathod submitted the bail application in the high court, contending that there was no evidence to prove that Sheikh was conducting a recce of the concerned places.


Sheikh's activities do not fall under the purview of the Unlawful Activities (Prevention) Act (UAPA), his lawyer argued in the court.

Government pleader Devendra Chauhan told the court that there was ample material to show that accused Sheikh was associated with the banned terrorist organisation (JeM). His activities were in furtherance of a future terrorist

of a terrorist act under the UAPA, he said. "The purpose of the act (recce) was not to wait till the outcome of the final action, but even preparatory actions

After getting concrete evidence from Jammu and Kashmir police and intelligence agencies, a case under relevant sections of the UAPA was registered against Sheikh at Kotwali police station.

### Hajin Residents Decry Irregular Door-to-Door **Waste Collection**

Hajin: Residents of Hajin town have raised concerns over the irregular door-to-door waste collection, alleging that the inconsistency has caused them immense inconvenience.

Despite paying monthly charges to the Municipal Committee (MC)

Hajin, locals claim that the waste collection vehicles do not operate daily across all wards, leaving many areas unattended. They further criticized the lack of a fived selection. criticized the lack of a fixed schedule, stating that the collection staff arrives at random hours and often fails to cover all designated



"If they do not streamline the waste collection timing, we will stop making payments," said an aggrieved resident, highlighting the growing frustration among locals.

Residents also alleged that the collection vehicles sometimes arrive as late as 11 AM, only covering one or two wards before leaving, neglecting other areas.

"There is no proper mechanism in place. The route of the waste collection vans is not fixed, and they either arrive at random hours or do not come at all," another resident claimed.

The residents have urged the concerned authorities to take immediate action to streamline the waste collection process and ensure a consistent and reliable system to maintain hygiene and sanitation in the town.

They argue that the current transfer system is unfair, disregards teacher welfare, and hampers the effective implementation of the National Education Policy (NEP) 2020. Many teachers transferred to difficult terrains like Gurez face severe climatic conditions, cultural barriers, and linguistic challenges that impact the quality of education. NEP 2020 emphasizes teaching in the mother tongue to enhance learning outcomes, but the ATD policy often disregards this aspect by not prioritizing local teachers. Non-local teachers struggle with dialects and cultural nuances, making it harder to engage students effectively. The affected teachers are urging authorities to introduce policy revisions that allow those from Zone 5 to serve in their home zones for at least a decade. This would ensure continuity in education and foster a better learning environment. Additionally, frequent postings in distant areas create undue hardships, affecting teachers' morale, well-being, and efficiency. A balanced transfer system—ensuring shorter tenures in remote zones or providing more home postings would be more sustainable and beneficial for both educators and students. As ATD 2024 approaches, teachers hope their grievances will be addressed. The Education Ministry must take immediate steps to align transfer policies with NEP 2020's vision. Any reform that aims to improve education must be practical and responsive to ground realities. A well-thought-out transfer policy would not only enhance the quality of education in remote regions but also ensure that teachers remain motivated and committed to their profession. The government must act now to protect both teachers' rights and students' learning experiences.

Scholarly research highlights the efficacy of socio-emotional learning (SEL) programs. A meta-analysis of SEL initiatives in over 213 schools globally reveals a 13% improvement in academic performance alongside reduced anxiety and behavioral issues. These findings underscore the symbiotic relationship between emotional well-being and intellectual achievement. Finland's education model exemplifies this integration. By prioritizing student autonomy, mental health, and teacher training in emotional education, Finland has fostered a generation of well-rounded individuals capable of tackling complex societal problems.

Singapore's educational reforms further illuminate the transformative power of holistic education. The Ministry of Education has implemented initiatives like the Applied Learning Program (ALP) and Life Skills Program (LSP), emphasizing real-world problem-solving, resilience-building, and ethical reasoning. These efforts have equipped students not only with academic knowledge but also the soft skills required to excel in a volatile global economy.

A compelling success story comes from Bhutan. where Gross National Happiness (GNH) is prioritized over GDP. Schools incorporate mindfulness practices, environmental stewardship, and life skills education. This holistic approach has significantly reduced youth stress levels while fostering a sense of purpose and community. Similarly, in the United States, the Chicago-based CASEL framework has helped schools integrate SEL into their curricula. leading to enhanced student engagement and reduced dropout rates.

Incorporating ethical career guidance is equally crucial. Studies by UNESCO reveal that students who receive mentorship in ethical decision-making are more likely to pursue careers aligned with societal welfare. For instance, Germany's vocational education and training (VET) system, which combines classroom learning with apprenticeships, embeds ethical considerations in professional training. This approach has not only reduced youth unemployment but also instilled a sense of responsibility and purpose among young professionals.

The Indian education system, though traditionally exam-centric, has seen pockets of innovation. Schools like Rishi Valley in Andhra Pradesh emphasize value-based education, blending academic rigor with life skills and emotional development. Inspired by the teachings of Jiddu Krishnamurti, these schools have cultivated students who excel academically while contributing meaningfully to their communities.

Data from UNICEF and the World Economic Forum highlight the urgency of these reforms. In a survey of 15-24-year-olds across 21 countries, 45% reported feeling unprepared for the workforce. However, those who had participated in life skills and resilience programs reported higher confidence

### **Kashmir Women Cricket Team Leaves for Maharashtra Tour**




