NEW DELHI: As the Lok Sabha was briefly adjourned amid opposition protests after Prime Minister Narendra Modi's statement on the Mahakumbh, Leader of Opposition Rahul Gandhi on Tuesday said the LoP should be allowed to speak according to the democratic structure but is not given permission in "new

Gandhi also said the prime minister

should have paid homage to those who lost their lives in the January 29 stampede at the Mahakumbh in Prayagraj.

The Lok Sabha was briefly adjourned till 1 pm on Tuesday following protests by opposition members over Modi's remarks on the success of the Mahakumbh, which was held from January 13 to February 26.

Many opposition members rose from their

"I wanted to support what he was saying. Kumbh is our tradition, history and culture. There was also a complaint that he did not pay homage to those who lost their lives (in the stampede in the Mahakumbh)," Gandhi told reporters outside Parliament.

"The other thing I wanted to say is that the youth that went to the Kumbh need another thing from the PM, they need employment. The prime minister should speak on employment," the Congress leader said.

Asked if he was not allowed to speak, Gandhi said, "We are not allowed to speak. According to the democratic structure, the LoP should be permitted to speak, but is not given permission, but this is new India."

Describing the Mahakumbh as an important milestone, Modi told the Lok Sabha that the event was a befitting response to those who questioned India's capability to organise such a large congregation.

He said the entire world witnessed the grandeur of India during the Mahakumbh and the religious gathering reflected the spirit of rising India.

Over 68 lakh cancer treatments done under PMJAY, majority in rural areas: Nadda

treatments worth over Rs 13,000 crore have been performed under the Ayushman Bharat health insurance scheme, with 75.81 per cent of them undertaken in rural areas, Union Health Minister J P Nadda said on Tuesday.

Of these, more than 4.5 lakh treatments worth over Rs 985 crore were undertaken for "targeted therapies" against cancer, with 76.32 per cent of their beneficiaries coming from rural areas, Nadda said responding to a question in Parliament.

The benefits, he said, were accorded under the Centre's Pradhan Mantri Jan Arogya Yojana (PMJAY).

He said that an initiative for screening, management and prevention of noncommunicable diseases, including cancer, has been rolled out in the country under the National Health Mission.

Under the scheme, people suspecting they have cancer can also call in for expert opinion from district and tertiary care hospitals.

In PMJAY, treatment for several types of cancers, including breast, oral and cervical, is provided under more than 200 packages with more than 500 procedures of medical oncology, surgical oncology, radiation oncology and palliative medicine.

Of these, 37 packages are related to targeted therapies such as chemotherapy

NEW DELHI: More than 68 lakh cancer for CA Breast, metastatic melanoma, chronic myeloid leukaemia, Burkitt's Lymphoma, and CA Lung, the minister informed.

Those suffering from cancer and are below the poverty line can also avail of a one-time financial assistance of up to Rs 15



lakh, provided under the Health Minister's Cancer Patient Fund (HMCPF).

The minister said that the scheme provides for the sale of generic medicines at 50 per cent to 80 per cent price of branded medicines through Janaushadhi Stores and the 217 **AMRIT Pharmacies.**

A total of 289 oncology drugs are given at half the market price.

Nadda said that the government had in

the budget announced it would set up 200 day care cancer centres at district hospitals in 2025-26.

Under the National Programme for Prevention and Control of Non-Communicable Diseases (NP-NCD), 770 district NCD clinics, 233 cardiac care units, 372 district day care centres, and 6,410 NCD clinics at community health centres have been set up, he said.

In addition, 19 state cancer institutes and 20 tertiary cancer care centres have been set up in different parts of the country to provide advanced cancer care.

Cancer treatment facilities have been approved in all 22 new AIIMS with diagnostic, medical, and surgical facilities, he said.

Two such centres where advanced cancer treatment is provided are the National Cancer Institute in Jhajjar, Haryana, with 1,460 beds, and the second campus of Chittranjan National Cancer Institute in Kolkata, which has 460 beds.

There are 372 District Day Care Centres providing chemotherapy across the country, Nadda said.

The minister said that under the Department of Atomic Energy, Tata Memorial Centre has two units/hospitals in rural and semi-urban locations, the Homi Bhabha Cancer Hospital in Sangrur in Puniab, and the Homi Bhabha Cancer Hospital in Muzzafarpur in Bihar. (PTI)



How to build and keep an audience for your journalism project



Did being laid off, frustrations with the limitations of traditional newsrooms, or uncovering an underreported issue motivate you to launch your own newsletter, podcast or website?

No matter what your catalyst was, how ambitious your vision is or how great of a journalist you are, your project won't have an impact if no one

"High-quality content is crucial to sustaining a readership," said Fernanda Braune Brackenrich, U.S. editor of audience engagement at the Financial Times. "But it doesn't matter how good your content is if no one can find it."

At larger newsrooms, audience engagement teams collaborate with reporters and editors before a story goes live – strategizing how, when and where to publish it, then refining it based on performance. Independent project founders, however, often handle everything themselves.

"I've heard that a news startup endeavor should split its time [into] a third marketing, a third editorial and a third business development," said Cadence Bambenek, co-founder and editor-in-chief of the climate solutions newsletter, Hothouse.

Since launching in 2020, Hothouse has gained 5,500 subscribers. For the past two years, Bambenek has run it mostly on her own. "When personal life events impacted me, they impacted Hothouse, too." After an earthquake destabilized her housing situation, keeping the newsletter running mattered more than pushing for growth.

For reader-funded projects, expanding and sustaining reach is also essential to financial viability. "Revenue is always the biggest challenge," said Jamie Wareham, founder of QueerAF, a nonprofit LGBTQIA+ publisher primarily supported by paying members.

"An editor told me to stop pitching — and I'm quoting - 'gay stories' because there was no 'money' or 'audience' in them," said Wareham. To test that claim, he launched Queer AFin 2016 as a podcast, later expanding it into an award-winning, newsletter-first publication that invests in emerging LGBTQIA+talent.

Cultivating a following isn't just about visibility – it makes your journalism sustainable and influential.

Below, Bambenek, Braune Brackenrich and Wareham offer practical advice on how to do so. Find your niche and commit to it

One of the biggest mistakes independent journalists make is shifting the focus too often. "Pick a niche and stick to it. Work out your goal and stick its trajectory.

You can get to know your audience by looking at analytics, surveying them or asking for feedback. Establish a sustainable schedule

Publishing on a weekly cycle often builds stronger engagement than fortnightly or monthly, but only

long-term growth, Wareham wrote in a recent article. They can steer editorial decisions, too. Readers often highlight stories no one else is covering, creating a cycle in which engagement drives content and content fuels engagement.

Offering valuable resources, such as QueerAF's Trans+ History Week page, can also attract new





with it," suggested Wareham. It's tempting to jump between ideas or pivot too soon when something isn't working. While refining is important, give your project time to grow.

Before launching publicly, test your content and format, and once you're live, commit to the long game. "It takes a really long time to grow anything anywhere, especially media products," said Wareham. Understand your audience

Before publishing, put yourself in your audience's shoes. Ask yourself:

- · When and where do they get news?
- What format fits their lifestyle?

"If you're launching something for an audience [that] lives in big cities, for example, you should account for commute time," said Braune Brackenrich. "That's a good time for people to check their phones and read, listen or watch something."

Let these insights guide when and how you publish, and remember that first-rate journalism is essential for building a readership.

"I did a deep dive on our audience recently, and Hothouse's readers are frequently high-level decision-makers," said Bambenek. "I have no hope in retaining their attention if I don't keep up the quality of the articles and insights that readers have come to expect."

Understanding who reads Hothouse - what

if it's realistic for you. "You're gonna have to do it every week. So make sure it's something that you really love," said Wareham. QueerAF's newsletter goes out every Saturday morning as a recap of the weekly news. "That means my busiest day is Friday,"

Before committing to a schedule, ask yourself:

- Is this sustainable for me?
- Will it still work months or years from now? Use social media with purpose

"I would recommend focusing on one social media channel to concentrate your efforts. Present your content in different ways, mixing links, photos and videos," Braune Brackenrich suggested.

She noted that while social referral traffic has declined, posts from individual accounts – rather than business pages – have been less affected. Amplifying your work under your name can drive more engagement than solely relying on an outlet's presence. Invest in relationships

Directly interacting with your audience creates loyalty and strengthens word-of-mouth marketing. "Spending lots of time on [building] relationships - which doesn't always feel like it has a tangible outcome - makes people more likely to support QueerAF when we make the ask in either a public or a direct way," said Wareham.

These "non-scalable actions" are critical for

subscribers. "That was more of an evolution rather than a clear plan at the start," Wareham admitted. But the page became a tool for growth.

Join the conversation

Since her audience is more likely to engage with in-depth analysis than quick-hit social media content, Bambenek streamlined Hothouse's presence by publishing exclusively on Substack, which offers discovery tools to attract new subscribers.

"I think it has saved me a headache to focus on making high-quality articles and publishing them on one platform instead of letting my attention get divided," she said.

But as the newsletter nears its fifth year, Bambenek is reconsidering how to promote the project. "At a certain point, you do a disservice to the work if you don't put in the effort to assert it correctly and proudly in the conversation it's in dialogue with."

Speaking at events, joining industry discussions and engaging on social media are opportunities to join the conversation and build connections.

Examining the importance of independent journalism for students in the U.S



International and U.S. journalists, university faculty and students, and foundation and media leaders came together recently in Washington, D.C., to address a critical gap in educating young Americans on the role of a free press in demo-

The International Center for Journalists (ICFJ), Freedom Forum and Vanderbilt University organized the immersive two-day event, which was hosted at Freedom Forum's headquarters, with support from Lumina Foundation. It featured opening remarks from Jason Rezaian, director of press freedom initiatives for The Washington Post, followed by roundtable and small group discussions. The event, which included about 50 people, culminated in recommendations for future collaborations.

To encourage open discussion, the event was held under the Chatham House Rule, which allows participants to share out what was said but without attribution.

Here are five takeaways from the conversation. (1) International journalists have perspectives and experiences that are important for U.S. journalists - and all Americans - to hear.

In a conversation moderated by Rezaian, journalists from outside the U.S. described the increasingly repressive tactics they have faced amid democratic backsliding in their countries. Roundtable attendees said hearing from journalists who have navigated closing societies was eye-opening, especially amid growing concerns about press freedom in the United States.

In the most oppressive countries, independent journalism is essentially a crime punishable by jail. In others, the State has taken control of major media and universities. Elsewhere, reporters face growing threats of physical violence and "lawfare," or legal attacks designed to silence their reporting.

"[Government actors] don't want you to exist, so your sole existence as an independent journalist is an act of defiance against them," one exiled journalist said of his home country

Participants shared how they have adapted to these immense challenges. For example, in countries without independent universities, news outlets are now the training ground for the next generation of journalists. Journalists also talked about educating their audiences on how to access news sites online, amid government efforts to block them, and equipping citizens to gather information on the ground when reporters have had to flee. One emphasized the importance of journalists networking and resource-sharing: "If one media outlet is destroyed, there has to be another who will replace you."

(2) It's harder than ever to 'practice disagreement' on campuses. And that's just one of the challenges facing student journalists.

University students in attendance described the reluctance students feel today to share their opinions and even report on hot-button topics, for fear of reprisal from their peers and future harm to their careers. It can even discourage students from working in journalism and other public service jobs, participants said. "Educational institutions have the responsibility to show people that they can take the courageous path, which is the path of public service, that they can say things that are unpopular - unpopular to other students, unpopular to the administration, unpopular to the board," one student said.

Harassment from fellow students was just one challenge student journalists cited at the roundtable. Animosity from administrators and ongoing struggles with funding were others, even as student publications play an increasingly important role for communities with no other local

"Our student publication has been operating

in debt for years," one student said. Participants suggested integrating media education into K-12 curricula and establishing support networks and communication channels for student journalists to connect with one another. Students also said they would benefit from more support pushing back on censorship and accessing public records, two issues that are integral to promoting press freedom at colleges and universities.

(3) Reaching audiences is hard, but not impossible – and news creators are leading the way.

Journalists are searching for ways to build audiences, at a time of declining trust in media and a fractured information landscape. Media consumers tend to trust and return to sources that

offer confirmation bias, participants noted, and the stakes are high: "People don't use news to develop their worldview so much as they consume news to affirm their worldview," one participant said.

To build trust, news outlets need to commit to deeply understanding their audiences. "If we don't know who we are serving, then it is really hard to serve them well." said one media founder from outside the U.S., adding that journalists can learn from news content creators. "They have a monopoly on reaching the people we need to reach," she said. The successful ones create feedback loops with their followers and employ metric-driven strategies that optimize social media algorithms.

Journalists also face well-orchestrated campaigns casting them as enemies of the people - propaganda that is challenging to combat. International journalists suggested that news outlets adopt "radical transparency" and take the time to cover the stories of people's lives, so that audience members see themselves represented accurately and fairly. asks students to use AI tools and then provide a critique of the responses they receive. Students described using ChatGPT like Wikipedia - an information source that should be corroborated. And one professor shared that one of her students was interviewed for a job by an AI bot.

The group discussed how AI use will evolve. Citing a mapping exercise her organization conducted, one attendee said society is currently in "the efficiency phase," with people using these tools to make existing tasks more efficient. Eventually we will have a fundamentally different information economy – one we don't even have the language for today. The transformation will be bigger than with social media, she said.

Along the way, there will be "signals" that we are moving from the efficiency phase to a transition phase to a new ecosystem phase: For example, when we start using AI to address entirely new problems created by the evolving technology.

In this context, it is vital to bring technologists who are building AI tools into rooms "like this one," one participant said. Others raised how important it is for college journalism programs to take an interdisciplinary approach, exposing students to data science and more.

(5) Preparing the next generation of journal-

ists requires some radical rethinking. Young journalists today encounter limited job prospects and pay, as news outlets face continued financial hardship. Unlike earlier generations of reporters, they also enter the profession at a time of heightened distrust in media, online violence against journalists and advancements in artificial intelligence that are transforming

how news outlets operate. Attendees touched on all these issues, but also noted just how much young people have to offer the profession and the broader public. Young reporters are adept at storytelling in today's digital environment. As student reporters, they also fill gaps in coverage, by providing accountability reporting on their universities to national audiences and local news for the extended com-

munities off campus. Roundtable attendees emphasized the need to update curricula to, for example, equip young journalists to protect themselves from threats, collaborate with data scientists and other technologists, and understand the business side of the profession. Participants discussed the importance of immersive, hands-on experience for student journalists and of connecting U.S. students to international journalists to learn from their experiences and insights.

A smaller working group on the second day explored what that could look like, including. for example, reporting collaborations between student journalists in the U.S. and exiled media that operate near universities. Like student media, exiled media often serve local communities in the U.S. - the diaspora.

These efforts and others – such as bringing international journalists to university communities for a speaker series, for example – would not only better prepare student journalists, but deepen understanding of press freedom and the role of the First Amendment to the larger university communities and beyond.

If any damage is found after construction or during the maintenance period then it is being rectified by the Contractor, he added.

The Minister was replying on behalf of the Deputy Chief Minister to a question raised by Pawan Kumar Gupta in the Legislative Assembly.

He said that the roads being executed in Udhampur West Assembly Constituency under NABARD are in good condition and no substandard material has been used in PMGSY/NABARD roads.

However, the Minister informed that the blacktopping done on 7 km road from Kainthgali Block Boundary Udhampur to Bariote Upto Moungri, currently under construction, was removed and Wet Mix Macadam was re-laid when the authorities noticed defect in this entire 7 km road. He said that, as the weather improves,



50 mm thick Bituminous Macadam and 20 mm OGPC will be re-laid and whole rectification would be done by the concerned contractor.

The Minister informed the House that various contractors have been served notices for repairing defects and damages of roads during DLP. He said that the roads to be repaired under the Defect Liability Period (DLP) included road projects from Garhi to Gathiyal Morh, LO23-NH1A Km 63rd to Gandala, Gandala to Narore, Kainthgali Bariote Km 20th to Jesserkote, Moungri to Ladda, Kainthgali Bariote km 44 to Lali and Mir to Saroffti. The notices have been issued to the Contractor for restoration of the damages and defects in these roads to facilitate seamless connectivity to the people.

The Minister said that the NRIDA arranges third party technical assessment and external Quality Assurance by deploying National Quality Monitors, whose responsibility is to verify that the UT's Quality Management is adequate in implementing the road infrastructure works.

Keeping the road safety measures in view, crash barriers have been installed at various vulnerable spots on a number of roads, added the Minister.

Pearls Of The Parrot Of India-Abul Hasan Yamin-U-Din Amir Khusro

bul Hasan Yaminuddin, better known as Amir Khusrau (1252-1325) after being decorated with the title of Emir by one of his patrons, had the unique distinction of being a soldier, courtier, sufi, poet, litterateur, and music maestro. And he introduced the ghazal poetry form to India. Khusrau was probably a pioneer too in the art of the poem-riddle, called paheli. He was also a fine poet, with compositions both in the high Persian of the court and in the rough Hindi of the North Indian countryside. Khusrau is also said to have invented gawwali and is also credited by some historians with inventing sitar and the tabla. Some say he invented the khayal and tarana styles of singing. As such he is said to have laid the foundations of Hindustani music.

Although the details of his life and works remain uncertain to a considerable extent, we have much that helps us construct his figure in various avatars that he richly represented. It has been generally agreed upon that after suffering the onslaughts of Chengez Khan, his father, a Turk chieftain, migrated to India during the reign of Shamsuddin Altutmish who gave him a high position in his army. Khusrau was born in 651 Hijra corresponding to 1253 C.E. in Patiali in Etah district of Uttar Pradesh where his father had settled. Some have recorded his year of birth 1255 and still some mention it as 1254. Amir Saif ud-Din and Bibi Daulatnaz had three boys, including Khusrau, and a daughter as their firstborns. His father's influence allowed him to become fluent in Turkish, Persian, Arabic, Islam, and Sufism. He was called Tuti-i Hind ("Parrot of India"). This "compares the eloquent poet to the sweet-talking parrot. It also highlights his canonical stature as a poet of Persian," according to the Encyclopaedia of Islam. While he was just eight years old, Amir Saif ud-Din Mahmud died in an army action in 1260 after which his mother brought him to Delhi to live with his maternal grandfather who also passed away when he was only twenty years old. Khusrau was a gifted child. He studied poetry and wrote poems since he was nine years old . According to the introduction to his Divan "Garatul Kamal" he began composing verses from twelve years of age whereas "Sairul Awaliya" mentions that he began it when Hazrat Nizam ud din Auliya left Delhi to settle at Patiali. He would present the verses to his Murshid who would do the necessary corrections.

An extremely intelligent and resourceful person who honed many skills of poetry and courtly manners, he did not find it difficult to seek his source of sustenance when he was left on his own to do so. Beginning in the reign of Sultan Balban of the Slave (Mamluk) Dynasty, he served two Mamluks, three Khiljis and two Tughlags, variously as a court poet, soldier, royal historian and noble. During his lifespan of 72 years, Khusrau spent almost 60 years in the courts of as many as ten distinct Delhi Sultans like Malik Alauddin Kashlu Khan alias Malik Chhajju, Bughra Khan, Khan Mohammad, Sardar Hatim Khan, Kaikobad, Jalaluddin Firoze Khilji, Alauddin Khilji, Qutbuddin Mubarak Shah, Giasuddin Tughlaq and Mohammad Tughlaq. Khusrau was given the title "Amir" by Jalal ud din Firoz. He was respected and loved in his court. He was given the title "Mushaf-dar" for his effort.

Khusra created Tuhfat and published it as Tuhfat us-Sighr (The Gift of Childhood), his first divan, in 1271. It contained poems that were composed between the ages of 16 and 18. Reaching thirty he composed his second Divan known as "Wastul Hayat".He composed an eulogy or funeral verses (Marsiya) on the death of his patron Sultan Mohammad Qaan prince of Balban who was killed while fighting Tatars under in 1285 at Multan.It is said that Amir Khusro was taken as a captive by the Tatars after this battle though some claim his period of captivity as long as two years. This eulogy got much fame among the contemporary Persian lovers. In 1289 he composed his first historical masnavi "Qirun Saidain" and in 1291 the second historical Masnavi "Miftha ul Futuoh" which forms part of his third Divan "Garatul Kamal". In "Garatul Kamal" he showers praise on India and its people. "Qirun Saidain" comprising of nearly four thousand verses depicts the contemporary political, cultural, social aspects of Delhi as also its arts and crafts. The events have been presented in verses in such a beautiful manner that it is regarded as a chronicle carrying significance of a primary source as well as a literary masterpiece. It is said that his Hindi verses numbered around one lac but due to the vicissitudes of the time these have not been preserved barring some songs, riddles, kah mukriyan and Dohae which were and are most popular among the common masses. Even though he held high positions in several courts, it did not hinder his spiritual urge and interest and he remained a devoted disciple of Hazrat Nizamuddin (RA). There is an interesting story regarding Khusro being initiated as a disciple of his Murshid. It is reported that his father and brother accompanied him to the khanqah of Hazrat Nizamuddin (RA). Reaching the place he sat outside the room whereas his father and brother went inside. Khusro composed the following extempore verse

Tu aan shahi ki ber aiwan qasrat kabutar ger nishanand baz gardud Garaibi mustemandi ber der aamed biyayed anderoon ye baz gaerdud

Translation: Your spiritual abode is so towering that if a pigeon rests there, it turns out to be a falcon; I as a poor seeker has come to your door, shall he enter there or return back.

The Sheikh is said to have replied the would be disciple through this verse

Biyayed anderoon marde haqeeqat ki ba ma yek nafs hamraz gardud ager aan boud ay mard nadaan az aan rahi ki aamud baz gardud

Translation: One must enter inside if he is the seeker of Reality so that he gets close to me and secrets are re-

If he is unwise,he must return the way he came. Khusro sought his spiritual training and strength from his Murshid Hazrat Nizamuddin, and at whose feet he lies buried. Khusrau, as Nizamuddin and other Sufis, was from all accounts free from religious bigotry. Nizamuddin belonged to a Sufi spiritual order, and ran a khanaqah, or monastery, in what is now the heart of today's New Delhi (the entire neighbourhood is still called Nizamuddin).

People from every faith thronged the shrine, as they do even today. Khusrau wrote of his abiding love for his spiritual master, Nizamuddin. In this vein Khusrau is portrayed as a bride whose heart, personality and identity have all been surrendered upon a single glance by the groom, 'Nizaam'. He had so much love for his master and his belongings that once a person came to Hazrat Nizamuddin (RA) and begged for something. The Sheikh had nothing in possession at that time. He gave him his slippers. Khusro was on a tour and he happened to stay in the same Sarai where this man having the slipper of the Sheikh was lodged. Seeing the slippers, Khusro gave the entire belongings to the person and purchased these slippers. Legend has it that when Sufi Saint Hazrat Nizamuddin Aulia (1238-1325) died, his most devoted disciple Amir Khusro mourned his spiritual master's death in a couplet which is part of folklore in a disciple's devotion to his master: "Gori sovay sei par, mukh par dare kes/chal Khusro ghar aapne, saanjh bhaee chahu des Translation: (The fair maiden rests on a bed of roses, her face covered with a lock of hair/Oh Khusrau, let's return home now, the dusk settles in the four corners of the world).

Khusrau was a very prolific author and poet of rare distinction. He is widely respected as a Persian, Hindavi, and Rekhta poet who evolved a unique diction and an inimitable language, beyond the apbhransha, for his literary expression. He assigned a new role to human speech which is evident from the astounding variety of nearly a hundred works he produced in poetry and prose that broadly include several divans, mathnawis, treatises, and other compositions. He chose Persian as his preferred language for poetry composition. He also wrote about 500,000 verses in other languages, including Turkish, Arabic, Braj Bhasha, Hindavi, and Khadi Boli. His Persian verses alone account for around four lac verses. Though the number of his works cannot be ascertained for sure, nor can the authenticity of works ascribed to him be determined with any confidence, he remains an iconic poet on account of the works available from different sources. Amir Khusro diverted his attention from the court to concentrate on his legendary works. Every night before the king, melodious females would shout the ghazals that Amir Khusro had written in fast succession to music.

He composed a quintet (khamsa) during the reign of Aauddin Khilji using 5 masnavis: The first khamsa "Matla-ul-Anwar," or "Growing site of luminosities," had 3320 stanzas composed in 1299. This was written with Sufi, mystic and ethical themes in fifteen days. This was followed by "Khusrau and Shirin," another masnavi, having 4000 stanzas. Another masnavi, "Laila Majnun," containing 2660 verses describing a love story too, was penned down

compiling this Mathnavi, he lost his mother as well as his brother. As a result this work depicts the pain of love and the melancholy of departing.

The fourth enormous masnavi, "Aina-e-Sikandari," having 4500 verses, was composed in 1300 C.E. and describes Alexander the Great's audacious deeds. The fifth masnavi, "Hasht Bihisht," comprising of 3350 verses was written in 1302 and the beloved disciple presented it to his loved Murshid(master)Hazrat Nizam udd din (RA).This masnavi composed in the style of "Haft Paikar" of Nizami Gunjavi and "Shahnama" of Firdousi, is related to King Bahram Gur's events and presents stories in a beautiful style. Besides the court atmosphere of this Iranian king, Khusro introduces folktales told by seven princesses described in an enchanting style. Most famously, Khusro appears to be the first writer to have added The Three Princes of Serendip as characters and the story of the alleged camel theft and recovery . Alauddin Khilji was incredibly pleased with his works and showered him with honour. Even the great Persian literary icon Moulana Jami says that no other work than the "Hasht Bihisht," compares fairly with the Khamsa of Nizami.

Continuing his literary journey, he composed "Khaza'inul-Futuh" (The jewels of success) in 1311. It describes Alauddin's construction projects, military campaigns, and governmental structures.

This was followed by Masnavi "Dool Rani Khizir Khan" in 1315 C.E. sketching the love affair between Khizir Khan, the prince of Alauddin Khilji and Dool Rani, a princess of

the Raja of Gujarat. Amir Khusrau wrote a masnavi titled "Nuh Sipihr" (Nine Skies) on Qutub uddin Mubarak Shah Khilji that details the events of his reign, dividing its poetry into nine divisions, each segment designated as a different sky. In its third section, he wrote a detailed account of India's surroundings. It includes the seasons, plants, and fauna, as well as its ideas, traditions, ethos, and researchers. "Afzalul Fawaid" was penned down in 1319 which contains the Malfuzat (discourses) of Hazrat Nizam uddin besides completing "Aijaz Khusrvi". Prior to his death in 1325 C.E. he wrote his fifth Masnavi "Tughluq Nama and the fifth DivanDivan"Nihayat-ul-Kamal".On the birth of Qutubuddin Mubarak Shah's son, he set up the child's horoscope, based on which some predictions were made. The masnavi "Saqiana" contains this horoscope. Amir Khusro became

a significant figure in poetry due to each of these efforts.

The literary works of Khusrau are of vital significance as far as the factual information with historical relevance is concerned. The later historian Ziauddin Barani quotes Khusrau on many occasions to confirm some of the major points of view on the contemporary events. In many works Barani's assertion was supplemented by the facts provided by Amir Khusrau. It is interesting to see Khusrau becoming eloquent where Baran chooses to remain silent. Looking from this point of view, the works of Amir Khusrau and his contemporary writers are of great importance to us as historians. From the prism of modern history-writing, Khusrau was not writing history. He was merely penning down the events with his own interests, comfort, superfluities, additions, omissions, slips, exaggerations and experiences. But while doing this, he has left a huge amount of data behind, which is of extreme importance for the researchers of modern historians. His style is full of exaggerations and metaphorical descriptions, but the facts of history are given with tolerable fidelity. The present day student of history has to bear in mind his biases and favours and then look at his masnavis to reconstruct the history of the Sultanate.

Moving beyond literature, Khusrau also made his contribution to music. His connections to several sultans allowed him to visit and reside in different parts of India, exposing him to various regional customs. This made it easier for him to incorporate many musical influences. He created ragas, developed khayal, tarana, qaul, and qawwali. Qawwali music, which incorporates tabla, sitar, Tarana, and Sufi music, was created by Khusrau.

He helped India get to where it is today thanks to his writing and singing talents. His words still inspire sufi shrines across the subcontinent. Khusrau produced a variety of poetry and songs, some of which were about his spiritual master Hazrat Nizamuddin Auliya (RA). Even though he left for the eternal world, his melodies revere-beat, echoed throughout the subcontinent which still motivate us.

Amir Khusrau created the stringed instrument known as the sitar. It has a long neck and a body shaped like a gourd. It is used in Hindustani classical music. A plectrum is used to pluck the strings of the sitar. A well-known inventor, Khusrau is primarily recognised for creating the threestringed sitar and also invented tabla, the two instruments that clearly distinguish and characterise Indian music from others. He changed the name of the triple-stringed Tritantri Veena to a Sehtaar as numerous veena varieties became available in India. Because of its Persian ancestry, the Sehtaar later came to be known as the sitar. Tarana and Trivat are also said to have been invented by Khusrau. To

in the same year. It is said that while Khusro was busy in quote philosopher and musicologist Jaidev Singh says: A song is referred to as a Tarana in Persian. Khusrau created Tarana entirely on his own.

> Khusrau indeed had Nirgit songs utilising uk-akaras and p-akaras, nonsensical terms, as an example (mnemonic syllables of the mridang).

> At least since the reign of Bharat, these songs have been popular. Nonetheless, the Nirgit tended to utilise harsh consonants. Two changes were made to this style of vocal music by Khusrau. Originally, he introduced largely soft-consonant Persian nouns. Second, he ordered these words so that they made sense. He also supplied a few Hindi words to complete the sentence. Only Khusrau's intellect could have combined these sentences to produce any sense. His successors could not accomplish this, and the Tarana was just as meaningless as the ancient Nirgit.It is said that Khusrau invented the Tarana approach as he tried to imitate Gopal Naik's presentation in Raag Kadambak. Khusrau issaid to have devised the Tarana method after spending six days in concealment. He studied Gopal Naik's performance using meaningless phrases (mridang bols).

> Amir Khusrau is also said to have composed riddles. Some of the riddles passed down in Khusro's name deal with ideas that weren't even created during his lifetime, such as the hookah. There is considerable debate over whether Khusro was the genuine author of the riddles attributed to him. The collection consists of 286 riddles, divided into six categories 'supposedly based on the structure of the riddle and the response.' Many specialists of the subject presume that Khusro is the inventor of these puzzles even though they are "in the style of the common people." The puzzles make use of Matrika meters.

> Khusrau is extremely remarkable for defining the various forms and genres of literature and arts as the domains where the sublime and the plebeian could meet together and complement each other. He wrote on a variety of subjects that include patriotism, liberalism, integration, folk life, and the religious values of living that emerge with a fine blending of social norms and cultural practices, as well as dialects and dictions.

> His Khaliq-e-bari, the world's first printed dictionary, features Persian and Hindi words.

> $One of the famous \, ghazals \, of \, Khusrao, mostly \, presented$ as a qawali, describes a unique phenomenon. Even the first line of it points to a destination which the writer claims was beyond his knowledge.

emonies in the laamakan(beyond space); Mohammed (SAW) was the light of the gathering, where I was in the night.

Khusro is one of the leading figures who have focused on the cultural history, language, flora and fauna of the Indian subcontinent. Amir Khusrau has stood for a major cultural icon in the history of Indian civilization for almost seven hundred years. The contribution of Amir Khusrau as a poet, musician, courtier and historian in Delhi Sultanate is remarkable. He was proud to be an Indian and his literary works are reflecting the great patriotism and upholding the diversity of India.

Khusrau has praised the Indian languages, including Hindi (which he calls Hindavi). He wrote many playful riddles, songs and legends which have become a part of popular culture in South Asia. He was also an accomplished musician and took part in religious musical gatherings (Sama) organized by the famous Sufi saint, Nizamuddin Auliya. Amir Khusrau as a Muslim was able to draw upon a vast treasure-house of Muslim folk and religious lore and was able to enhance the Indian Muslims' sense of belonging to a universal culture; they could identify themselves as not merely a local immigrant sect. Khusraus' love for India shows that the Turkish ruling class was no longer prepared to behave as a foreign ruling class, and that the ground had been prepared for a cultural rapprochement between the people living in India irrespective of religious or regional belongings. The writtings of Khusro did light the candle of love and affection which illuminate the dark corners and the Sufi circles derive much from it for their journey on the path of eternal Truth.

Rehman, who was wanted by the Indian security agencies for several deadly terror attacks in Jammu and Kashmir, including the killings of seven civilians in Rajouri in January 2023 and nine pilgrims in Reasi in June 2024, was gunned down along with his bodyguard in an attack by gunmen in the Jhelum area of Punjab province in Pakistan on Saturday evening.

Considered the most trusted handler of LeT founder and 26/11 Mumbai terror attack mastermind Hafiz Saeed. Rehman infiltrated into the Jammu region in early 2000 and exfiltrated in 2005. He had a wide network of overground workers (OWGs) in Poonch and Rajouri through his old contacts, the officials said.

so-called technical shortcoming, was "typecast", and had his contract torn up within months of being a World Cup hero but Shreyas Iyer was indefatigable through it all, trusting his sincerity and uncomplicated mind to steer him through.

The result of the perseverance has been pleasing, to put it mildly. The 30-year-old has built himself into one of India's most consistentnumber four batters in recent times and was declared a "silent hero" by his captain Rohit Sharma after the team's Champions Trophy triumph a few days ago.

"Maybe, the perception was created or maybe I was typecast. "An athlete needs to constantly evolve as the sport keeps changing its dynamics. I am glad I kept a positive frame of mind, and trusted my process," he said.

Last year, he sustained a back injury during the home Tests against England and then lost his central contract after showing up for his then IPL franchise Kolkata Knight Riders' training instead of Ranji Trophy duties after his recovery.

He was also India's top-scorer in the Champions Trophy, finishing with 243 runs in five games.

"Ifeel I belong to the No.4 position. Whether it was in the 2023 World Cup or now in the Champions Trophy, I enjoyed the most coming as No.4. It gives me a sense of belonging and and that's where I am able to flourish."

Shaheen Shan Afridi then bowled a maiden to start New Zealand's innings. But Seifert and Allen hit seven of the next 12 balls for sixes as New Zealand launched an assault which helped them clinch the match and a 2-0 series lead with 11 balls remaining.

Seifert and Allen hit five sixes apiece as New Zealand sped towards its target. After the scoreless opening over Allen cleared the boundary on the first, third and sixth balls of the second over, then Seifert struck sixes from the first two and the last two deliveries of the next over as New Zealand raced to 44-0.

New Zealand began its innings needing 136 runs from 90 balls. By the end of the five-over power play that target had been reduced to 70 runs from 60 balls. New Zealand was 87-2 when Allen followed Seifert to the pavilion in the seventh over.


