States show high per capita for development, say 75% population BPL for subsidies: SC

NEW DELHI: The Supreme Court on Wednesday said states showed a high per capita growth when asked to highlight the development index but claimed 75 per cent of their population was below poverty line when it came to subsidies.

A bench of Justices Surya Kant and N Kotiswar Singh said the benefit of subsidies should reach the genuine beneficiaries.

"Our concern is that are benefits meant for the genuinely poor persons percolating to those pockets who do not deserve it? Ration card has become a popularity card now," said Justice Surya Kant.

The judge went on, "These states just say we have issued these many cards. There are some states who when they have to show their development they say our per capita income is growing. And then when we talk of BPL, they say 75 percent of the population is BPL. How can these facts be reconciled? The conflict is inherent. We have to ensure that benefits reach the genuine beneficiaries."

The hearing related to a suo motu case initiated during the COVID19 pandemic to address the miseries of migrant labourers.

Advocate Prashant Bhushan, appearing for some intervenors, said the anomaly stemmed from the inequalities in the income of people.

"There are a handful of people, who have huge wealth as compared to other population and per issuance of ration cards, there are no political elements

The poor migrant workers, who are registered in the e-shram portal of the government, need to be given free ration and the figure was around eight crore people, Bhushan said.

Justice Surya Kant said, "We hope that in the

Bhushan said the Centre did not conduct the 2021 Census and was continuing to rely on data from the 2011 Census as a result around 10 crore people, requiring free ration, remained out of the BPL categories.

appearing for the Centre said the government was giving free ration to around 81.35 crore people under the National Food Security Act and another 11 crore people were covered by another similar scheme.

The bench adjourned the matter and asked the Centre to file its response on the status of free ration distributed to the poor.

On December 9, last year, the top court frowned upon the freebie culture and stressed on the need to create job opportunities and capacity building for migrant workers.

It was surprised when the Centre informed the court that 81 crore people were being given free or subsidised ration under the National Food Security Act of 2013."It means only the tax-payers are left out," it then said.Bhushan had contended that directions were issued by the top court from time to time to all states and union territories to issue ration cards to migrant workers for availing free ration provided by the Centre.

On November 26, last year, the top court flagged the difficulties surrounding the distribution of freebies and said Covid times were different when distressed migrant workers were provided the relief.

In a judgment on June 29, 2021, and subsequent orders, the top court passed a slew of directions to the authorities asking them to undertake welfare Additional solicitor general Aishwarya Bhati, measures, including giving ration cards to all migrant

workers, who were in distress during the COVID-19 pandemic, registered with the e-shram portal.

The portal is a comprehensive national database of unorganised workers launched by the Union Ministry of Labour and Employment with the primary aim of facilitating the delivery of welfare benefits and social security measures to the country's unorganised sector workers.

On September 2, last year, the top court asked the Centre to file an affidavit giving details about compliance with its 2021 judgement and subsequent directions on providing ration cards and other welfare measures to migrant workers.

The Centre previously said it was providing ration to all those people who were eligible under the National Food Security Act. The top court, in the 2021 judgement, termed as "unpardonable" the Centre's "apathy and lackadaisical attitude" towards creating the national database for unorganised workers and ordered its commencement by July 31, 2021, for the registration of all migrant workers and providing them with welfare measures.

It had ordered the states and union territories to frame schemes for providing free dry ration to them till the pandemic lasted while asking the Centre to allocate additional foodgrains and directing the department concerned to "allocate and distribute food grains" to migrant labourers". (PTI)

Defamation case SC extends order, exempts Shivraj Singh **Chouhan from personal** appearance

NEW DELHI: The Supreme Court on Wednesday extended its earlier order exempting Union Agriculture Minister Shivraj Singh Chouhan from personal appearance before a trial court in connection with a criminal defamation case lodged against him by Congress MP Vivek Tankha.

Tankha, also a senior advocate, has alleged that the union minister and BJP state president V D Sharma and former minister Bhupendra Singh carried out a "coordinated, malicious, false and defamatory" campaign against him for political mileage, accusing him of opposing OBC reservation in the 2021 Panchayat election in Madhya Pradesh. A bench comprising Justices MM Sundresh and

Rajesh Bindal deferred to March 26 the hearing on a plea of Chouhan and two other BJP leaders. The top court was hearing the appeal of Chouhan against the October 25 order of the Madhya Pradesh High Court refusing to quash the defamation case.

Govt To Announce New Toll Policy Soon, Will Give Reasonable Concession To Consumers: Gadkari

NEW DELHI: Union Road Transport and Highways Minister Nitin Gadkari on Wednesday said the government will soon announce a new policy for toll charges on national highways, offering a reasonable concession to consumers.

Replying to queries in Rajya Sabha, the minister asserted that the government is spending a lot on building road infrastructure and therefore toll charges are necessary.

"It is the policy of the department that when you want good road, you have to pay for it," Gadkari said. In Assam, he said the government plans to make expenditure of Rs 3 lakh crore.

"We are making a lot of big roads, four lanes, six lanes. I am making a lot of bridges from the Brahmaputra. We are raising funds from the market. So without a toll, we cannot do it. But still, we are very considerable. We are only charging toll on four lanes, not on the two-lane paved shoulder."

Dhankhar on Wednesday opined that there should be a structured discussion on freebies and subsidies in the House as there is an urgent need for a national policy to help put all government investments to the larger good.

Responding to the demand made by Samajwadi Party's Ram Gopal Yadav for increasing the funds, which Members of Parliament have at their disposal for developmental projects and schemes in their respective constituencies to Rs 20 crore a year from the current Rs 5 crore during the zero hour, Dhankhar said he would be open to a structured discussion on the issue if the government and the opposition agree.

Electoral freebies, such as free electricity and water, subsidised



cooking gas, and cash handouts to certain groups like farmers and women, have often been criticised as something that may lead to unsustainable financial burdens on the government, distort public resources, and undermine long-term development goals.

"On placatory mechanisms, on appeasement, which is often known as freebies, this House needs to deliberate. I will be open to a structured discussion after consulting the Leader of the House and the Leader of the Opposition," he said.

The country can grow only if money is available for capital expenditure, he said.

Capital expenditure or capex is expenditure for creating assets such as infrastructure that yield long-term returns for the economy. In contrast, freebies are revenue expenditures that do not contribute to the creation or acquisition of fixed assets.

"Electoral process is such that these have become electoral allurements and thereafter the governments that came in the saddle, found themselves very uncomfortable, so uncomfortable that they wanted to revisit their thoughts," he said.

"There is an urgent need for a national policy so that all investments of the government in any form are used in a structured manner for the larger good." If the leaders of both sides agree, there can be a discussion, he said adding this is a very serious issue. The comments assume significance as many states faced challenges in funding electoral freebies, particularly due to the financial strain they place on state budgets. States like Punjab have faced financial constraints in meeting poll promises. Dhankhar then touched upon the issue of subsidies. "Subsidies, if required in areas like the farm sector, should be direct.



For 21 years ReT Teacher betray students to 'please' bureaucrats in Bandipora

• DESK relieved the teacher; DC office called back Teachers, Locals appeal LG Sinha, CM Omar to intervene, Investigate

BANDIPORA: A teacher here in North Kashmir Bandipora district has been deceiving students for the last 21 years just to please the bureaucracy for the reasons best known to him.

Arsullah Habib Bhat appointed as teacher under Rehbar-e-Taleem Scheme at Primary School Aragam in the year 2004 in Aragam habitation of Banipora with Salary about 13 Lacs annually has never attended the school but has managed to get himself attached in Chief Education office or Deputy Commissioner's office since decades, what the people say, to gain 'the personal interests for his self-betterment'.

Arsullah, according to officials, spent a few months in his school, and then never attended the school for which he was appointed under the ReT scheme.

Surprisingly, the teacher was rewarded many times without attending any single class, even the department in 2021 sent him to complete a B.Ed course, a move intended to enhance his teaching skills

Locals said that they do not know when he last attained the school, but he is still drawing his salary from enlisted as the teacher of the same school which he never attended. "We saw him first time in the first week of March this year in the school after he was relieved by the Director School Education recently" a local said, adding " he later again abandoned the school for unknown reasons"

Officials said that Arsullah has managed to appease a few well connected persons who in deception managed to his attachment in the Deputy Commissioner's office. They said that the teacher in question is now habitual to please other officers and officers just to get his means done.

Pertinently Directorate of School Education Kashmir(DSEK) cancelled deputations of all teachers who were deputed in different offices on nonteaching recently the valley but for Arsullah Baht the DESK order means but Arsalah Bhat again deceived his officers and managed to attach himself in the Deputy Commissioners Office.

ment order by issuing new deputation orders for the same teachers for non-teaching duties.

After Hue and Cry though other teachers were relieved; Deputy Commissioner Bandipora Office issued fresh order for a Regularised Rehbar-e-Taleem Teacher Arsullah Habib giving him charge of Coordinator for IEC Campaign against Drugs-the job that otherwise was to be done by the Department of Information and Public Relations (DIPR).

DC Bandipora in an order No 2390-92 dated 05/03/2025 designated Habib as coordinator for successful implementation of IEC campaign Against Drugs. Surprisingly the Order by DC Bandipora reads that, "teacher shall remain stationed in the office of CEO Bandipora and shall be responsible for coordination between different departments and reporting before DC Bandipora on Daily Basis".

"If Admin needed a Coordinator for IEC Campaign, District Information Officer Bandipora or the subordinate staff would have done a fantastic job as they have earlier lead many vital media campaigns including Back to Village, COVID Awareness Campaign, Swachh Bharat, Vikshit Bharat and other successful campaigns but God knows what special feature they found in a particular teacher who is being kept away from school since the day he was appointed," several officers told Kashmir Convener wishing not to be named.

A large number of teachers told Kashmir Convener that language of the order speaks volumes about the intentions of the administration that is providing undue support to such illegal and unethical practices. After alleged resentment from the DSEK, DC

Bandipora modified the orders on 11th March ordering that tasks assigned to the said teacher shall be in addition to his own duties.

However despite that, the teacher has not attended a single class since then- the allegations verified by the Kashmir Convener. Students at PS Aragam said they saw the teacher once before morning assembly and then he left the school.

Official sources in CEO office told Kashmir Convener that a team lead by Deputy Chief Education Officer Bandipora m District Vigilance Officer and other concerned Cluster head visited Primary School Aragam but found the teacher absent. "We were expecting he will resume the duty now, but surprisingly he comes in the morning to mark his attendance and returns to his home or DC Office," locals of Aragam revealed.

"Even if the Government needed a teacher to run the campaign, there are a dozen teachers in the department with Mass Communication Degrees but they are doing their job in schools".

Primary School Aragam, a school located in a tribal area, needed a dedicated teacher to uplift the students and provide them with quality education. Instead, Mr. Arsullah found ways to remain outside the classroom since the day of his appointment. Official sources said Habib has never attended his school but has managed to get non-teaching assignments in the CEO Office or DC Office.

Officials said the purpose of this training was to create a better, more skilled teacher. Ironically, instead of contributing his newly acquired skills to teaching, the department continued to assign him non-teaching roles.

"This raises an important question: if the government invests so much in training a teacher, why is that training wasted by keeping him away from the classroom," officials told Kashmir Convener.

hePrimeMinister'sYoungAuthorsMentorship Scheme (YUVA) has entered its third edition, aiming to nurture young literary voices and document India's diverse heritage. While the initiative is commendable for fostering creative writing, providing financial support, and amplifying young voices, it also raises critical questions about its inclusivity, long-term impact, and accessibility. At its core, YUVA 3.0 is an ambitious effort, offering mentorship, financial assistance of ₹50,000 per month, and opportunities for selected authors to publish and present their works globally. The focus on themes such as Indian Knowledge Systems and the Contribution of the Indian Diaspora aligns with the government's vision of Ek Bharat, Shreshtha Bharat. However, the selection process remains a concern, as it may favor those with access to better education and resources, limiting opportunities for aspiring writers from marginalized backgrounds and regional language communities.

A key challenge for YUVA's sustainability is the postpublication trajectory of these young authors. While their books are published and translated into multiple languages, their market reach remains uncertain. Unlike mainstream publications, these works often lack commercial promotion and widespread availability. Without robust distribution channels, these books risk becoming government-endorsed literary projects rather than widely-read works.

Additionally, the absence of continued support raises concerns about whether YUVA is creating lasting careers in literature or just offering a short-term boost. The government must consider expanding the program beyond a one-time mentorship, integrating it with mainstream publishing, digital platforms, and literary networks to ensure sustained growth for these young authors.

While YUVA has successfully ignited enthusiasm for literary expression, it must address gaps in inclusivity, accessibility, and long-term literary engagement. If refined and expanded, it has the potential to transform India's publishing landscape, ensuring that young voices from all backgrounds find their rightful place in global literature. However, if it remains limited to select participants with constrained outreach, it risks becoming yet another symbolic initiative rather than a true literary movement.

What started with protests demanding accountability for a young woman's killing in police custody, soon transformed into the most widespread revolt in Iran since the 1979 revolution. Iranians from all walks of life are claiming their basic human rights and demand fundamental political change. While the protests themselves are largely led by women, and the majority of those out on the streets belong to Iran's Generation Z below the age of 25, the movement itself has seen backing from broad society. This includes workers' strikes in support of their demands. The uprising and the regime's response have deepened the rift between Iran's society and the government, which loses legitimacy by the day.

Iranians continue to protest the regime in various forms. Persisting acts of civil disobedience range from chants of "death to the dictator" from people's homes in cities' residential areas at nights to individual and creative forms of protest. including more and more women refusing to comply with mandatory headscarves in public. Especially in western Kurdish or south-eastern Sistan and Baluchistan regions, thousands continue to protest in the streets even when facing harsh repression. In the Baluch city Zahedan. for example, people continue to protest by the thousands every Friday, even though the city has experienced some of the harshest, most violent and deadliest responses by government forces.

Three characteristics in the nature of these protests distinguish them from previous movements.

First, the revolt is in essence truly feminist. As engrained in the claim of "woman, life, freedom", demonstrators demand fundamental political change and the full realization of human and women's rights. The protests have been womenled and, for the first time, addressed issues such as violence against women. This has also led to a strong emphasis on marginalized perspectives and to the revolt's intersectional character as being youth-driven, spanning across social classes and ethnic minorities, and stretching from urban to rural areas. Even more so, whilst the regime tried

ing the regime's narrative, the Persian majority has begun to develop a better understanding for the country's (ethnic) minorities.

Second, the protests are feminist also in the way they are organized. They are a peaceful, collective, and leaderless movement that is organized in a decentralised way, thus responding to specific grievances in different localities while uniting under the "woman, life, freedom" umbrella. The revolt practices creative resistance, using social media and tech against the regime. The leaderless character stems from cross-societal backing of protests and renders their societal impact even wider, making them more difficult to suppress. At the same time, it creates the challenge that there is no clear political alternative to organize around.

Third, the revolt takes place amidst a precarious socio-economic situation. Iran has been in a politico-economic. social. and environmental crisis for years marked by rising poverty, increasing unemployment, raging inflation, and skyrocketing prices. As a consequence, many Iranians struggle to meet their basic needs. This is due to widespread corruption, government mismanagement including of the countries' natural resources like water. and a particularly strict sanctions period following the U.S. withdrawal of the nuclear agreement in 2018. This economic calamity has hit women and marginalized groups hardest.

The last point is critical, as the economic situation both stabilizes the regime adds to the protesters' grievances at the same time.

Iranian activists and diaspora civil society representatives have underlined the fundamental nature of the demonstrators' demands. Under the - originally Kurdish - slogan of "Woman, Life, Freedom", people are asking for their basic human rights and political freedoms to be respected and implemented. From this derive a number of protesters' needs that, if met, can help the revolt to be successful.

Iran's constitution claims to guarantee at least some of these rights and freedoms, and the Islamic Republic is even party to international human rights instruments that uphold equality for women and non-discrimination. However, the reality is plainly different: the qualification of such rights 'in accordance with Islamic principles' in fact enshrines systemic discrimination, and the realization of equal rights and tangible political and societal changes. It is a remarkable qualifier of these protests that they also address issues



like violence against women, which previously was a taboo topic in Iranian society.

Substantially, there are three broad categories of short-term civil society demands: those asking to address specific human rights cases and humanitarian needs; those calling for not just moral, but also material support for the revolt; and those demanding justice for crimes committed and seeking to stop the violent crackdown. The last point will be separately dealt with in the next section on accountability.

Every life matters. Therefore, while there is understandable hope that an overthrow of the current regime would in due course bring about a more peaceful and rights-respecting society, addressing individual cases of the regime's massive human rights violations remains a top priority. Consequently, Iranian and international human rights organisations draw international attention – if necessary, in urgent procedure – to imminent executions and to the fate of those having received a death sentence. They call for the release of prisoners, especially women's and human rights defenders as well as journalists, but also of the many minors that have been detained. Some, like Human Rights Activists in Iran, updated their grim tallies on a daily basis, after having corroborated the countless clues they receive from family members, friends, and fellow activists.

The Islamic Republic has had a track record of using excessive and lethal force and repression to quell political unrest. To name only the more recent examples after the 2009 Green Movement of protests against a rigged election, the regime faced down protests in 2017/18 that were initially directed at the government's failed economic

calendar month in which they started. From these experiences, the regime compiled

a (metaphorical) "playbook" that it put into action

once Supreme Leader Ali Khamenei had signalled his full backing of the security forces. It exists of three main elements: the use of indiscriminate force, violent and arbitrary arrests, and the throttling of internet service across the country.

Following an early order to "confront mercilessly ... any unrest", the police and special forces used life ammunition without regard for civilian lives. To this

they later added the tactic of shooting protesters, in particular women, into their faces, breasts, legs, and genitals with shotguns, so as to inflict maximum pain and long-lasting mutilation. Within weeks, the death toll rose to the hundreds of protesters with a gruesome share of 13 percent of minors being killed. A large part of which occurred in the Kurdish and Baluchi provinces in the country's Northwest and Southeast, respectively. The most deadly crackdown has come to be known as "Bloody Friday" in Zahedan on September 30, when Baluchi human rights groups have listed almost 100 people who were killed by the regime that day. In December 2022, the regime started to execute, sometimes publicly, alleged protesters convicted of the vaguely circumscribed and disputed offense of "war against god", or moharebeh.

Whereas the arbitrary use of force is a wellestablished practice of the regime, weaponized sexual violence marks a relatively new laver to the security forces' response. Numerous cases of sexualized torture, rape, and other forms of sexual assault in prisons have been documented as the protests wore on. This clearly gendered element shows how the authorities aim to break the protesters' resistance by returning those mentally and physically maimed women and men back into society. In this context, the announced pardon of those arrested by the thousands looks less like an act of clemency and more like a calculated move to finally quell the revolt.

Furthermore, the judiciary has been systematically abused. By 8 February 2023, 777 citizens had been brought to trial and convicted of alleged crimes directly related to their participation in nationwide protests. At least 44 defence lawyers

resulted in convictions based on confessions. often extracted under torture. All this amounts to deliberate abuse of formal criminal proceedings, according to the UN Human Rights Commissione. The sheer number of convictions handed down by the judiciary in the space of a few months underlines once again that the judiciary serves as a counter-insurgency tool and that orderly procedures are completely lacking.

Throughout the months-long revolt, access to the internet has been highly restricted, so that people inside the country had difficulties communicating with one another as well as with the outside world. This is highly alarming, not least because of limited access of international human rights organisations and media, the information provided by Iranians through social media and online services is often the only source to track the regime's violent repression. Over time, this has obviously also created huge economic damage, as companies could not process transactions. Again in mid-January 2023, the regime blocked mobile internet access for two days, ostensibly to limit the potential for cheating in university entrance exams but more likely to conceal a crackdown in Zahedan, the capital of Baluchistan province. Together with the confiscation of devices like smartphones of protesters and the now pervasive digital surveillance, the frequent and long-lasting internet shutdowns amount to the advanced use of technology in the name of repression.

The regime has also resorted to hacking the devices of activists, journalists, and politicians that work on Iran and the Middle East more broadly. Actively launching large-scale social media campaigns using fake accounts, it has tried to steer and manipulate the debates both online and offline. And while the war on social media seems to be fought from many sides, not just Iran, it appears to be a constant feature that women commentators are the prime target. This violence also continues beyond the virtual space as the regime threatens and targets activists as well as women and human rights defenders around the world, including in the European Union.

Fertilizers, pesticides allowed to Valley only after proper standard testing: Javed Dar

3010 samples of pesticides, 1065 of fertilizers collected for testing during 2024-25

Jammu: Minister for Agriculture Production, Javed Ahmad Dar, today informed the House that the consignments of fertilizers are allowed to move to Vallev only after the samples test as standard.

The Minister was replying to a question raised by Hilal Akbar Lone in the Legislative Assembly. He informed the House that there is an established mechanism for sampling of the products batch-wise in respect of Fertilizers at Udhampur Rack, being tested from the quality Control Lab at Jammu and the consignments are allowed to move to Valley only after the samples test as standard. He said that there is one check point at Lower Munda where the documents of consignments are checked and the source is verified. He added that the sale is allowed only after the samples test as standard. In addition, the samples are being taken at random from stocks of the wholesalers and retailers, which too are tested and in case the samples test as below standard, prosecution is launched against the wholesalers/ dealers/ retailers, he added. The Minister said that a similar procedure is being adopted in respect of the pesticides for proper testing before its sale to the farmers. He said that the Agriculture Production Department has an Enforcement Directorate at UT level and Law Enforcement Agencies at District level, which are vigilant to any complaints regarding substandard pesticides and fertilizers. Sharing the details, the Minister said that 3010 and 1065 samples of pesticides and fertilizers respectively have been collected for testing during 2024-25 accordingly.

They appreciated the update to the India-New Zealand Air Services Agreement and agreed to encourage their carriers for commencement of direct (non-stop) flight operations between the two countries.

Political, defence and security cooperation:

The Prime Ministers recognised the significance of parliamentary exchanges and encouraged regular visits of parliamentary delegations between the two countries.

The Prime Ministers acknowledged the shared history of sacrifice of Indian and New Zealand service personnel who fought and served alongside one another around the world over the past century.

The Prime Ministers welcomed sustained progress in defence engagements, including through participation in military exercises, staff college exchanges, regular port calls

by naval ships, and exchange of high-level defence delegations. They recalled that the Indian Naval sailing vessel Tarini made a port call at Lyttelton, Christchurch, New Zealand in December 2024. They also referred to the upcoming port call in Mumbai by the Royal New Zealand Navy Ship HMNZS Te Kaha.

Both Leaders welcomed the signing of the India-New Zealand Memorandum of Understanding for Defence Cooperation. This will further strengthen bilateral defence cooperation and establish regular bilateral defence engagement. Both sides noted the need for ensuring the safety and security of sea lanes of communication and agreed there needs to be regular dialogue to discuss enhancement of maritime safety.

New Zealand welcomed India joining the Combined Maritimes Forces. Both Leaders welcomed advancement in defence ties during New Zealand command of Command Task Force 150.

Both Leaders appreciated the regular training exchanges of officers, including at Defence Colleges on reciprocal basis. Both sides agreed for enhanced capacity building cooperation.

Prime Minister Luxon expressed New Zealand's interest in joining the Indo-Pacific Oceans Initiative (IPOI). Prime Minister Modi welcomed New Zealand into this partnership with like-minded countries which seek to manage, conserve and sustain the maritime domain. Further cooperation as maritime nations is also being explored between India and New Zealand with discussions taking place between experts on the National Maritime Heritage Complex (NMHC) which is being established at Lothal, Gujarat.

Cooperation in science & technology and disaster management:

The two Leaders noted the significance of research, scientific connections, technology partnerships and innovation as an important pillar of the bilateral partnership and called for exploring such opportunities in mutual interest.Both sides stressed the need for stronger collaboration to develop and commercialize technologies in identified areas through closer collaboration between businesses and industries. The two sides recognized the challenges for their economies presented by climate change and the transition to low emissions climate resilient economies. Prime Minister Luxon welcomed India's leadership in the International Solar Alliance (ISA) and reiterated New Zealand's strong support as a member since 2024. Prime Minister Modi welcomed New Zealand joining the Coalition for Disaster Resilient Infrastructure (CDRI), which aims at making systems and infrastructure resilient in order to achieve the objectives of the Sustainable Development Goals (SDGs), the Paris Climate Agreement and the Sendai Framework for Disaster Risk Reduction. The two Leaders welcomed work towards a Memorandum of Cooperation on earthquake mitigation cooperation between relevant authorities of India and New Zealand, which would facilitate inter alia exchange of experiences in earthquake preparedness, emergency response mechanism, and capacity building. Education, mobility, sports and people to people ties: Both Prime Ministers agreed that there exists great potential to further strengthen the growing education and community links between India and New Zealand. They encouraged academic institutions of both countries to build future-oriented partnerships focused on areas of mutual interest including in areas of science, innovation, new and emerging technologies. The Leaders encouraged the creation of further opportunities for Indian students seeking quality education programmes in New Zealand. They noted the significance of skill development and mobility of skilled personnel to support expanded engagement in sectors, including science, innovation, and new and emerging technologies. The two Leaders agreed, within the context of the trade agreement negotiations, which the Leaders have agreed to launch, to also launch negotiations on an arrangement facilitating the mobility of professionals and skilled workers between the two countries, while also addressing the issue of irregular migration.

Education Cooperation Arrangement between the Indian Ministry of Education and the New Zealand Ministry of Education. This Arrangement will facilitate the continued exchange of information on India's and New Zealand's respective education systems as the basis for strengthening the bilateral education relationship.

The Leaders noted that India and New Zealand enjoy close sporting links, particularly in cricket, hockey and other Olympic sports. They welcomed the signing of the Memorandum of Cooperation on Sports to foster greater sporting engagement and collaboration between countries. They also welcomed the "Sporting Unity" events planned in 2026, to recognise and celebrate 100 years of sporting contact between India and New Zealand.

The Prime Ministers acknowledged the importance of robust systems of traditional medicine in India and New Zealand, and welcomed discussions between experts, including science and research experts, on both sides to understand and explore possible areas of cooperation, including through sharing of information and best practices and visits of experts.

Both Prime Ministers noted the growing interest among New Zealanders in Yoga and Indian music and dance, as well as the free observance of Indian festivals. They encouraged further promotion of bilateral ties including through music, dance, theatre, films, and festivals.

Cooperation in regional and multilateral fora:

Both Prime Ministers reaffirmed their commitment to supporting an open, inclusive, stable and prosperous Indo-Pacific where sovereignty and territorial integrity are respected.

The Leaders noted cooperation between India and New Zealand in various regional fora, including ASEAN-led fora such as the East Asia Summit, the ASEAN Defence Ministers' Meeting Plus and the ASEAN Regional Forum. The Leaders reaffirmed the importance of these regional bodies and ASEAN centrality for furthering security and prosperity of the Indo-Pacific region and emphasised the importance of all parties maintaining peace and stability in the region.

Both Leaders emphasized on the importance of an effective multilateral system, centered on a United Nations that is reflective of contemporary realities, as a key factor in tackling global challenges. The two sides stressed the need for UN reforms, including of the Security Council through expansion in its membership, to make it more representative, credible and effective. New Zealand endorsed India's candidature for permanent membership in a reformed UN Security Council. The two sides agreed to explore the possibility of extending mutual support to each other's candidatures at the multilateral fora.

Both Leaders emphasized the importance of upholding the global nuclear disarmament and non-proliferation regime, and acknowledged the value of India joining the Nuclear Suppliers Group in context of predictability for India's clean energy goals and its non-proliferation credentials.

Both Leaders reaffirmed their firm support for peace and stability in the Middle East and welcomed the agreement for the release of hostages and ceasefire of January 2025. They reiterated their call for continued negotiations

Mumbai attack of November 26, 2008, terrorism in any form is unacceptable. Strict action must be taken against those responsible for such attacks. We will continue to cooperate in combating terrorism, separatist, and extremist elements. In this regard, we have also shared our concerns about anti-India activities by certain illegal elements in New Zealand. At the invitation of the Prime Minister of India, Shri Narendra Modi, the Prime Minister of New Zealand, Rt Hon Christopher Luxon, is on an Official Visit to India on 16-20 March 2025. Prime Minister Luxon, who is on his first visit to India in his current capacity, is visiting New Delhi and Mumbai, and is accompanied by Hon. Louise Upston, Minister for Tourism and Hospitality, Hon. Mark Mitchell, Minister for Ethnic Communities, and Sport and Recreation, and Hon. Todd McClay, Minister for Trade and Investment, Agriculture, and Forestry, and a high-level delegation comprising of officials, and representatives of businesses, community diaspora, media and cultural groups.

Prime Minister Luxon was accorded a warm and traditional welcome in New Delhi. Prime Minister Modi held bilateral talks with Prime Minister Luxon. Prime Minister Modi will inaugurate the 10th edition of the Raisina Dialogue on 17 March 2025 in New Delhi with Prime Minister Luxon as the Chief Guest delivering the Inaugural Keynote Address. The Prime Minister laid a wreath at Raj Ghat The Leaders called for greater two-way investment, reflective of the ongoing strong momentum in bilateral cooperation.

The Prime Ministers agreed to enhance the trade and investment relationship between India and New Zealand to realise its untapped potential and to contribute to inclusive and sustainable economic growth.

The Prime Ministers welcomed the launch of FTA negotiations for a balanced, ambitious, comprehensive, and mutually beneficial trade agreement to achieve deeper economic integration. The Leaders agreed that a comprehensive trade agreement offers a significant opportunity to enhance trade and economic cooperation. By leveraging each country's strengths, addressing their respective concerns, and tackling challenges, a bilateral trade agreement can foster mutually beneficial trade and investment growth, ensuring equitable gains and complementarities for both sides. The Leaders committed to designate senior representatives to steer these negotiations to resolution as soon as reasonably possible.

Within the context of FTA negotiations, the Leaders agreed to discussions between respective authorities on both sides to explore early implementation of cooperation in the digital payments sector.

The Prime Ministers welcomed the signing of the Authorized Economic Operators Mutual Recognition Arrangement (AEO-MRA) under the aegis of the Customs Cooperation Arrangement (CCA) signed in 2024, which would facilitate easier movement of goods between the two countries by our respective trusted traders through close cooperation between customs authorities, thereby boosting bilateral trade.

The Leaders welcomed new cooperation on horticulture and forestry, including: the signing of the Memorandum of Cooperation on Horticulture which would enhance bilateral cooperation by promoting knowledge and research exchanges, development of post-harvest and marketing infrastructure; and the signing of a Letter of Intent on

to secure a permanent peace, which includes the release of all hostages and the rapid, safe and unimpeded humanitarian access throughout Gaza. They called for disrupting of terrorism financing networks and safe havens, dismantling of terror infrastructure, including online, and bringing perpetrators of terrorism to justice swiftly. The two leaders agreed to cooperate in combating terrorism and violent extremism through bilateral and multilateral mechanisms.

The two Prime Ministers noted with satisfaction the progress in ongoing bilateral cooperation and reaffirmed their commitment to further strengthen and deepen the bilateral partnership for mutual benefit as well as for the benefit of the Indo-Pacific Region. They called for exploring the potential to deepen bilateral engagement and explore new avenues of cooperation, including in the fields of green and agriculture technologies.

Prime Minister Luxon thanked Prime Minister Modi and the Government and the people of India for the warmth and hospitality extended to him and to the members of his delegation during his Official Visit to India. Prime Minister Luxon invited Prime Minister Modi to undertake a reciprocal visit to New Zealand.

SRINAGAR: The Jammu and Kashmir government has announced the establishment of the 'Chief Minister's Public Services and Outreach Office' within



But, obviously, it is on a day-to-day basis. He is in good spirits. Not having him is a challenge. He is one of the best bowlers in the world and he has been a fantastic profor us for many years.

"We'll have to wait or find an opportunity for someone else to step up. That's how I see it. It gives us an element of trying a few things and see how things work. The early part of the season allows us to do that."

Bumrah has played all his IPL cricket for MI, starting in 2013 and picking up 165 wickets in 133 matches over the years. The only IPL season he missed since he started playing was in 2023, when he had a back injury.

The MI squad has Trent Boult, Deepak Chahar, Reece Topley and Corbin Bosch (replacement for Lizaad Williams) as the other frontline quicks, along with captain Hardik Pandya, the allrounder, and the uncapped Ashwani Kumar, Satyanarayana Raju, Arjun Tendulkar and Raj Angad Bawa. Bumrah's absence could force a rethink of MI's bowling plans, since Boult and Chahar are predominantly powerplay bowlers, leaving them short of proven T20 experience in the death.

Shreyas lyer wants to 'mark' himself at No. 3 in **IPL 2025**

Shreyas Iyer, the new Punjab Kings captain, has expressed his intention to bat at No. 3 during IPL 2025. Iyer recently proved to be India's point of difference at No. 4 during their unbeaten run to the Champions Trophy title in Dubai and earlier in IPL 2024, when he captained Kolkata Knight Riders to the title, he had primarily batted at the same position. Occasionally, he had also slid down to No. 5 or No. 6 to suit the needs of KKR last season.

"We already know that IPL is an integral part of Indian $cricket.\,And\,IfI\,would\,want\,to\,mark\,myselfat\,some\,position$ in T20, it would be No. 3," Iyer said at a press conference. "And that's what I'm focusing at. I wouldn't say that we are planning and thinking about what number I will be batting.

"This time I'm quite clear about that position. And I'm going to be focusing on that number. As long as the coach approves of me."

Iyer will reunite with coach Ponting after the pair had some success at Delhi Capitals, helping them make the playoffs from 2019 to 2021, including the final in 2020. PBKS splurged INR 26.75 crore (USD 3.18 million approx) on Iyer, making him the second-most expensive player at an IPL auction.

"If you look back at the auction, I think it was pretty clear to everyone who I wanted as my captain," Ponting said. "And we got what we wanted. I was desperate to work with Shreyas again. We had a great working relationship at Delhi over a long period of time. He's one of the best players that I've worked with. He's a great human being. He's an IPL-winning captain. You couldn't ask for much more.

"We've got the best leader that we could possibly hope for. And we've had a lot of great times and success together. I think we understand each other really well. As you know, the captain-coach relationship in any team is vital."

In IPL 2024, PBKS had managed to win just one of their seven home games across Mullanpur and Dharamsala, and finished second from bottom. Ponting is hoping to remedy that and find ways to win at home this season.
