JAMMU: Asserting that militancy in Jammu and Kashmir cannot be finished without the support of people, Chief Minister Omar Abdullah on Monday said his government is extending support to the Union Home Ministry to ensure the security situation remains peaceful in the union territory.

"Though it (security) is directly not our $responsibility, I\,am\,repeatedly\,saying\,that\,militancy$ cannot be finished without the support of the people. The elected government is making attempts and is supporting (Lt Governor) to keep situation under control and maintain peace," the chief minister told reporters outside assembly here before the start of the day's business.

He was responding to a question on the ongoing anti-terrorist operation in Sanyal near International border in Hiranagar sector of Kathua district.

"Such things have happened in the past as well and as far as my information is concerned, no contact was established (with terrorists). The search and cordon operation launched on the basis of suspicious

Reviewing transfer of Planning functions to Finance Deptt: CM Omar

JAMMU: Chief Minister Omar Abdullah informed the Legislative Assembly today that the decision to shift the Planning Department's functions to the Finance Department is under review, and any necessary changes will be implemented accordingly.

The Chief Minister made this statement while responding to a supplementary question from Javid Hassan Beig.

He reiterated that he had already mentioned during the budget and grants discussion that the functions of the Planning Department were being transferred to the Finance Department, and the government is now reviewing the decision to determine if any modifications are needed. Regarding another supplementary question on the General Provident (GP) Fund, the Chief Minister acknowledged that employees sometimes experience delays in receiving their disbursements.

"This occurs when the treasury position becomes constrained. However, we are making every effort to ensure that employees receive their GP funds as quickly as possible," he assured the House.

Informing the House about the House that funds for all departments status of GP Fund disbursement, the in the I&K Government are allocated



Chief Minister stated that Rs 5,476 crore has been paid as GPF during the 2024-25 financial year.

As the Minister in charge of both Finance and Planning, Chief Minister Omar Abdullah clarified that the allocation of funds-whether for Revenue Expenditure or Capital Expenditure-falls under the purview of the Finance Department in accordance with business rules and statutory norms.

HC allows virtual hearing for migrant litigants amid security concerns

JAMMU: The High Court of Jammu & Kashmir and Ladakh ruled that the petitioners in a long-standing land dispute case, who are migrants from Kashmir, can attend hearings virtually due to security concerns.

The petitioners had sought the transfer of their case from the Srinagar Wing to the Jammu Wing of the High Court, citing threat perception. However, the court declined the transfer request, instead directing the Srinagar Wing to facilitate virtual hearings.

As per the news agency-Kashmir News Observer (KNO), the case revolves around a 17-kanal land dispute in Shopian, initially ruled in favor of respondents 4 to 7 through an allegedly fraudulent compromise decree in the Munsiff Court,

The decree was later set aside, and the case was transferred to the Jammu court due to the security concerns of the petitioners, who had migrated from

After nearly two decades of litigation, the suit was dismissed on November 16, 2023, and possession of the land was handed back to

Chief Justice Tashi Rabstan acknowledged the threat perception that the petitioners face, stating that the security situation in Kashmir had previously iustified transferring the



the petitioners on February 14, 2024.

Following this, the respondents challenged the dismissal order in the Srinagar Wing of the High Court, prompting the petitioners to seek a transfer back to Jammu, citing the same security concerns that had initially led to the case's

Property rased for 'anti-India slogans': SC seeks Maharashtra body's reply on contempt plea

Monday directed a Maharashtra authority to respond to a man's plea for initiating contempt action against it after he and his family members were booked by police and his properties were demolished for allegedly raising anti-India slogans during a cricket match.

A bench of Justices B R Gavai and Augustine George Masih issued the notice and posted the hearing after four weeks.

The petitioner, who hails from Sindhudurg district in the state, has claimed his house and shop were demolished on February 24 following an FIR against him, his wife and his 14-year-old son for allegedly raising anti-India slogans during the India-Pakistan Champions Trophy match, which India won the previous day.

The plea, filed by Kitabulla Hamidulla Khan, sought directions for initiating contempt proceedings against the chief officer and administrator of the Malvan Municipal Council arguing the action was in violation of the apex court's November 13, 2024 verdict on demolition of properties.

The top court judgment laid down pan-India guidelines and barred demolition



of properties without a prior showcause notice and 15 days' time to the aggrieved party to respond

The plea, filed through advocate Fauzia Shakil, said the case illustrated an "egregious contempt" aside from how the state machinery violated the guidelines with impunity.

The FIR alleged at around 9.15 pm when the complainant was going to his friend's house, the petitioner's son raised

an anti-India slogan while watching the cricket match, the plea said.

The petitioner and his minor son were taken to the police station at midnight and the boy was allowed to go after four -five hours, it added.

While the petitioner and his wife were sent to jail, the plea said the authorities on February 24, demolished his tin shed scrap shop and house calling them illegal structures.

arbitrary, illegal, and malafide. It is relevant to note that in the process of demolition, the municipal officers also damaged a vehicle of the petitioner," it added.

Though the man and his wife were granted bail on February 25 by a judicial magistrate, the plea said the chain of events clearly depicted the demolition action was punitive. "The time gap between the petitioner and his family members being arraigned as an accused and demolition of the scrap shop and home makes it apparent that the punishment of demolition inflicted by the respondent contemnor and other officials was inflicted on account of them being arraigned as an accused in a frivolous case filed by the complainant," it claimed.

The right to housing or shelter is a fundamental right as held by the apex court in several judgments and forms an integral part of the rights guaranteed under Article 21 of the Constitution, the plea added."The state and its officials cannot take arbitrary and excessive measures against the accused or the convict without following the due process as sanctioned by law," the plea said.

Rajya Sabha Chairman Holds Meeting With Nadda, Mallikarjun Kharge To Discuss NJAC Issue

Dhankhar on Monday held a meeting with Leader of the House J P Nadda and Leader of the Opposition Mallikarjun Kharge for a structured discussion in the Upper House of Parliament on the issue of judicial accountability and the NJAC Act.

The two leaders held closed-door consultations with Dhankhar in his chamber. The meeting began at 11.30 am.

The Rajya Sabha chairman had earlier written to both Nadda and Kharge for the meeting, a source said.

The meeting was held in reference to the observations Dhankhar made in the House on March 21 while responding to the points raised by Congress leader Jairam Ramesh over the recovery of cash from the residence of a high court judge.

Dhankhar had referred to the mechanism for judicial appointments after the passage of the National Judicial Appointments Commission (NJAC) Act in 2014. The legislation was struck down by the Supreme Court later. He had told the Rajya Sabha, "You all will recollect the mechanism which was passed by this House with near unanimity, with no dissension, only one abstention in the Rajya Sabha, all political parties converging and going in for the initiative of the government."

"I wish to find out the status of that which emanated from Indian Parliament made sacrosanct by the endorsement of 16 state assemblies in the country and signed by the Hon'ble President under article 111 of the Constitution," he had said.

"That historic legislation endorsed by this Parliament with unprecedented consensual support unknown to the parliamentary history of this country dealt with the malaise very severely. If the malaise had been dealt with perhaps we would not have countenanced such kind of issues. What bothers me is that the incident happened and did not immediately surface," the chairman had further observed.

Dhankhar had further said that he would "get in touch with the Leader of the House and the Leader of the Opposition, and find a mechanism for a structured discussion during the course of the session subject to their agreement."

India Will Be Destroyed If RSS Takes Control Of Education: Rahul Gandhi

NEW DELHI: The country will be destroyed if the RSS takes full control of the education system, Leader of Opposition Rahul Gandhi said on Monday.

The former Congress chief said the INDIA bloc constituents may have some slight differences in its ideologies and policies but they can never compromise on the



education system of the country.

"One organisation wants to destroy the future and the education system of the country. The name of that organisation is the Rashtriya Swayamsevak Sangh. If the education system goes into their hands, which is actually happening slowly, this country will be destroyed. No one will get jobs and the country will be finished," Gandhi said at a protest organised by affiliate student organisations of the INDIA bloc, against the National Education Policy.

"Students organisations must tell students that the vice chancellors of Indian universities are dominated

by the RSS. In the coming time, state universities' VCs will be appointed on the recommendation of the RSS. We have to stop this," he said at the protest held at Jantar Mantar.

Gandhi recalled that last week Prime Minister Narendra Modi made remarks on the Maha Kumbh in Parliament and asserted that the PM should have also spoken about unemployment and inflation.

"The prime minister does not speak a word about unemployment, inflation and education system. Their model is to hand over all resources to Adani and Ambani and hand over institutions to the RSS." Gandhi said.

To the agitators, he said, "You are students of the INDIA bloc, there may be some differences in our ideologies and policies but we

compromise on the education system of the country. We will fight this fight together and push back

Last month, Gandhi participated in a protest against the draft University Grants Commission (UGC) regulations organised by the DMK here

He alleged that the UGC's draft regulations on the appointment of teachers and academic staff in universities and colleges were an attempt to push the agenda of the RSS which aims to impose "one history, one tradition, one language" on the country.

CBI Arrests NHAI GM, 3 Others **Over Graft Charges**

NEW DELHI: The CBI has arrested a general manager of the National Highways Authority of India (NHAI) and three others, including a general manager of a private company, in connection with alleged bribery of Rs 15 lakh, officials said on Monday,

Ramprit Paswan, the accused general manager of the NHAI, had allegedly sought the bribe of Rs 15 lakh for "extending undue favours in processing and passing of the bills related to the contracts/works of the NHAI"



the CBI said in a statement.

"Searches conducted in this regard have led to recovery of Rs 1.18 crore cash (approx.)," it said.

The CBI had booked 12 accused, including six public servants of the rank of chief general manager and general manager (GM) and other senior ranks of the of the private company, including its two GMs, besides one other private contractor and unknown other public servants and private persons in connection with the bribery case

The CBI raided the meeting place between the accused GM and the employee of a private company where both were caught immediately after the bribe was exchanged, officials said.

Searches were conducted by the CBI at the residential and official premises of the accused at Patna, Muzaffarpur, Samastipur, Begusarai, Purnia, Ranchi and Varanasi which led to recovery of Rs 1,18,85,000/ (approx.), several incriminating documents and digital devices," the statement said.

Dar-ul-Uloom Raheemiya Hosts One of Kashmir's Biggest Itikaf Gatherings

Volunteers work tirelessly to serve those in isolation for prayer, fasting



SRINAGAR: More than 900 men have gathered at Dar-ul-Uloom Raheemiya, one of the largest Islamic seminaries in north Kashmir's Bandipora district, to observe Itikaf during the last ten days of Ramadan

The seminary, known for its long-standing tradition of hosting large Itikaf gatherings, has become a hub for spiritual seekers from across the

Itikaf is a spiritual retreat observed during the last ten days of Ramadan, where a Muslim secludes themselves in a mosque or a designated prayer space at home for women to focus entirely on worship, prayer, remembrance of Allah and other

According to the institution's management, every Iftar and Sehri at Dar-ul-Uloom Raheemiya, around 230 "Tramis" (plates) of food are prepared,



each serving four people. Volunteers ensure the timely distribution of meals, allowing nearly 900 Itikafis to break their fast and eat together in an organized manner.

The large-scale gathering at Dar-ul-Uloom Raheemiya is not just about worship but also about community participation, with volunteers

playing a crucial role in supporting those observ-

Many locals, known as Khadims (helpers), dedicate themselves to ensuring that the participants, or Itikafis, have everything they need. From preparing meals for Sehri (pre-dawn meal) and Iftar (evening meal) to maintaining cleanliness in the seminary, the volunteers work tirelessly behind the scenes.

Shahid Ahmad, a local volunteer, has been assisting in Itikaf arrangements for the past five years. "Serving those in Itikaf is a blessing for us," he says. "We wake up before Sehri to prepare food and ensure that everything is ready on time. It is tiring, but the satisfaction we get from serving others makes it worthwhile."

The seminary sees a structured daily routine during these ten days, with prayers, Quranic recitations, and religious discussions filling the schedule. Volunteers like Muneeb Hussain, a 30-yearold from Bandipora, say the sense of brotherhood during this time is unparalleled.

"People from different places come here, but we all work together as one family. During Iftar, we ensure everyone gets their meal in time, and seeing them break their fast peacefully makes all our efforts worth it," he said.(KNO).

Kilshay's Forgotten Refugees: No Electricity, No Roads, No Aid

GUREZ: More than seven decades after migrating from Pakistan during Partition, the refugee residents of Kilshay village in north Kashmir's Gurez valley say they continue to live in hardship,



with little to no development in their area.

Deprived of basic facilities such as electricity, roads, and healthcare, the villagers claim their condition has remained unchanged since 1997, despite repeated appeals to the government for

Speaking to the news agency-Kashmir News Observer (KNO), the residents allege that while other refugee groups across India have received government aid, they have been largely ignored. "We were uprooted from our homes and brought here decades ago, but it feels like we are still refugees, struggling for survival," says Rahim, a resident of Kilshay.

"Despite the hardships, we have been left to fend for ourselves without any special government package," he said.

Kilshay, a remote refugee village in Gurez, lacks even the most essential infrastructure. With

no proper electricity supply, villagers remain in darkness, relying on oil lamps and firewood. "Every evening, our children struggle to study under dim candlelight. In winters, we are cut off completely," said Fatima, another resident. "It feels like we are stuck in time."

Road connectivity is another major challenge. Without proper transportation facilities, residents are forced to carry the sick and elderly on their shoulders for miles to the nearest healthcare centre.

"Every time someone falls ill, we have to trek through difficult terrain just to reach a doctor,' said Mohammad Khushi, a local activist said. "Imagine carrying a sick person through snow and mountains. It's heart-breaking."

"We have seen refugee communities elsewhere get government aid, housing, and financial assistance, but we have been given nothing," says Abdul Qadeer, an elderly resident.

"Why are we being treated differently?". The residents also urged the government to recognize their plight and take immediate action. (KNO).

BANDIPORA: The Forest Training School been in any other part of the country, it would at Chittarnar, Bandipora, is set for a significant upgrade following official sanctioning, marking a major step forward in forestry education and environmental conservation in Jammu



and Kashmir.

The Kashmir Forest Training School, located in Chitternar, Bandipora, is one of India's oldest forestry training institutions, established in 1911 during the tenure of Mr. W.H. Lovegrove, the Conservator of Forests of Jammu and Kashmir from 1907 to 1915.

The school was founded to impart basic forestry training to in-service junior rank forest officers, including Foresters, Deputy Foresters, Forest Guards, and Watchers.

Over the Century, it has played a crucial role in strengthening Jammu and Kashmir's forest management and conservation efforts, having trained lakhs of Foresters and Forest Guards. However, Bandipora residents have been demanding its upgradation to a college level if not university level. "Had this intitute

have been upgraded to a university. We demand at least a college status to the institute," locals have reiterated.

An official spokesperson of Congress in Bandipora said the long-awaited development is credited to the persistent efforts of MLA Bandipora, Nizam-ud-din Bhat who has raised it with the Chief Minister and the ongoing Assembly Session wherein the government has assured its upgradation.

"This initiative will enhance training standards and open up career opportunities for our youth while fostering greater environmental awareness," said a senior Forest Department official.

Indian Army, J&K Police Recovers Major Arms, Ammunition, Narcotics Haul in Poonch

JKCA Sub-Committee Faces Scrutiny Over Supreme Court Claims, **Allegations of** Mismanagement

The discovery of war-like stores further raises concerns

JAMMU: The Jammu and Kashmir Cricket Association (JKCA), operating under a Sub-Committee since June 2021, is facing growing criticism over claims that the Supreme Court upheld its newly drafted constitution. A review of court proceedings indicates that these assertions are misleading, as the matter remains pending, with the next hearing scheduled for March 25, 2025.

Cricketers and stakeholders have accused the Sub-Committee—comprising former Delhi cricketer Mithun Manhas, two political figures, and Majid Yaqoob Dar—of undermining democratic

governance in JKCA. They allege a lack of grassroots cricket, mismanagement of funds, and arbitrary decisions that favor select individuals.

Concerns have also been raised over extravagant expenditures on travel and hotels, while cricketing infrastructure and player development remain neglected. Several young cricketers have accused Majid Dar of biased conduct, restricting access to training facilities for some while granting privileges to others. Additionally, Dar faces an ongoing age-fraud investigation by the Crime Branch, raising further questions about his role in administration.

Former players and coaches are now demanding the reinstatement of an elected JKCA body, emphasizing the need for transparency and the revival of club-level cricket. The upcoming Supreme Court decision is expected to be pivotal in determining the future of cricket governance in Jammu and Kashmir.

Soil Health Card

The Soil Health Card (SHC) Scheme, introduced to promote balanced fertilization and improve soil fertility, has shown promising results in reducing fertilizer overuse and enhancing agricultural productivity. However, its implementation and adoption challenges continue to hinder its full

Studies by National Institute of Agricultural Extension Management (MANAGE) and the National Productivity Council highlight a 9% reduction in urea use, 7% decrease in phosphate fertilizers, and a 20% increase in potassium application—a shift towards balanced nutrient use. Moreover, farmers adopting SHC recommendations saw an 8-10% cost saving on fertilizers and a 5-6% increase in crop yields. Yet, despite these gains, widespread awareness and accessibility issues remain a concern, particularly among small and marginal farmers.

To enhance SHC adoption, the government has revamped the SHC portal, introduced a mobile app, integrated QR-coded soil sample collection, and onboarded soil testing labs for real-time data access. However, ground-level outreach efforts must be strengthened. While over 7 lakh demonstrations and 93,000 farmer training programs have been conducted, many farmers still lack access to soil testing facilities or do not fully understand SHC recommendations.

A critical gap lies in customized, localized advisory services. Krishi Vigyan Kendras (KVKs) and Agricultural Technology Management Agencies (ATMAs) must increase farmer engagement through personalized guidance, ensuring easier interpretation and adoption of SHC recommendations. Additionally, state governments must expand doorstep soil testing services to reach farmers in remote areas. The Soil Health Card Scheme has laid a strong foundation, but to make balanced fertilization a norm rather than an exception, better implementation, farmer education, and accessibility improvements are crucial. If effectively scaled, the SHC scheme can be a game-changer, leading to sustainable agriculture, higher productivity, and long-term soil conservation—critical for ensuring India's food security and environmental health.



A Century of Conflict: Why Peace Remains Elusive in Israel-Palestine?

Since 2021, violence between Israelis and Palestinians has steadily intensified, with ongoing clashes in Jerusalem, the West Bank, and Gaza. The May 2021 conflict, triggered by tensions in Jerusalem's Sheikh Jarrahneighborhood and confrontations at the Al-Aqsa Mosque, escalated into an 11-day war between Hamas and Israel. Israeli airstrikes caused widespread destruction in Gaza, killing over 250 Palestinians, including many civilians, while Hamas and other Palestinian factions launched thousands of rockets at Israeli cities, resulting in 13 deaths and extensive damage. The ceasefire that followed was fragile, with tensions remaining high.

In the years that followed, Israeli military operations in the West Bank, particularly in Jenin and Nablus, intensified as part of a crackdown on Palestinian militant activity. These operations often led to armed confrontations, resulting in the deaths of militants and civilians alike. Settler violence against Palestinian communities in the $West\,Bank\,also\,surged, with\,attacks\,on\,Palestinian$ villages and destruction of property. The Israeli government's policies, including settlement expansion and demolition of Palestinian homes, further fueled Palestinian anger and frustration.

Palestinian militants, including Hamas and Islamic Jihad, responded with attacks on Israeli soldiers and civilians, perpetuating the cycle of violence. Gaza experienced periodic flare-ups, with Hamas and Islamic Jihad launching rockets into Israel, prompting Israeli airstrikes that further devastated Gaza's already fragile infrastructure. By 2025, the situation had worsened, with no meaningful progress toward a lasting peace, and both sides entrenched in a cycle of violence that showed no signs of abating. The lack of a political horizon, combined with growing despair among Palestinians and heightened security measures by Israel, ensured that tensions remained high, with

the prospect of renewed violence never far away. In late 2022, Benjamin Netanyahu returned to power after forming a coalition government that included far-right and ultra-nationalist parties, such as Otzma Yehudit and Religious Zionism. This coalition pushed an aggressive agenda that prioritized expanding Israeli control over the

states, including the United Arab Emirates, Bahrain, Morocco, and Sudan. While these agreements promised economic benefits and increased security cooperation, they largely sidelined Palestinian concerns. Arab states, once vocal advocates of Palestinian statehood, prioritized their own economic and security interests, leaving the Palestinians increasingly isolated on the diplomatic front. Public opinion in these Arab nations often remained sympathetic to the Palestinian cause, but their governments focused on strengthening ties with Israel, contributing to a growing sense of Palestinian abandonment.

West Bank and imposing stricter measures on Palestinians. Netanyahu's government rapidly approved plans for expanding settlements and legalized previously unauthorized outposts, significantly altering the landscape of the West Bank. These actions were condemned internationally but proceeded unabated, further entrenching Israeli control over Palestinian territory and undermining the prospects for a two-state solution.

The government also imposed severe restrictions on Palestinian movement and economic activity, tightening military checkpoints and increasing security operations in Palestinian towns. In addition, punitive measures, such as home demolitions and the revocation of residency permits, were used against Palestinians accused of involvement in violence. The combination of settlement expansion, settler violence, and military operations fueled Palestinian resentment and resistance, intensifying the cycle of violence.

Domestically, Netanyahu's government pursued controversial judicial reforms aimed at limiting the power of Israel's judiciary, sparking one of the largest protest movements in Israeli history. Hundreds of thousands of Israelis took to the streets, fearing that the proposed reforms would undermine democracy and erode the system

By 2025, Netanyahu's policies had deepened divisions both within Israeli society and between Israelis and Palestinians. While the protests reflected widespread concern about the future of Israeli democracy, they did not translate into a more moderate approach toward the Palestinian issue. Instead, the government's hardline stance fueled further unrest and made prospects for peace increasingly remote.

Palestinian politics remained deeply fragmented in the years following 2021, with internal divisions weakening the Palestinian leadership and eroding public trust. The Palestinian Authority (PA), led by Mahmoud Abbas, continued to lose legitimacy due to widespread corruption, inefficiency, and its failure to prevent Israeli settlement expansion. Abbas, in power since 2005, postponed elections multiple times, citing security concerns and internal divisions, but this only deepened frustration among Palestinians. The younger generation, disillusioned with the PA's inability to achieve meaningful progress toward statehood, increasingly viewed the leadership as disconnected from their daily struggles. Calls for elections and political renewal went unheeded, leaving Palestinians feeling voiceless and powerless.

against Israel, its governance in Gaza was marked by economic hardship, high unemployment, and deteriorating living conditions. Meanwhile, in the West Bank, new militant groups, such as the Lions' Den, emerged in cities like Nablus and Jenin, challenging both Israeli forces and the PA's authority. These groups attracted support from disillusioned youth who saw armed resistance as the only viable response to Israeli policies and the PA's perceived failures.

Popular frustration boiled over in spontaneous protests across Palestinian territories, with demonstrators calling for a new political direction that could effectively confront Israeli occupation and address Palestinian grievances. Demands for reform, unity, and resistance gained momentum, but the entrenched leadership of both the PA and Hamas resisted meaningful change. As divisions deepened, the Palestinian political landscape remained paralyzed, leaving the population caught between ineffective leadership and worsening conditions on the ground.

Diplomatic efforts to restart the Israeli-Palestinian peace process remained at a standstill, with $global\,attention\,shifting\,toward\,other\,international$ crises. The war in Ukraine, rising tensions in the Asia-Pacific region, and growing competition

Drug Control Deptt conducts inspections in Herman, Shopian

SHOPIAN: The Drug Control Department, in coordination with officials from the Revenue and Police Departments, conducted extensive inspections of medical establishments in Herman, Shopian, to ensure compliance with drug regulatory norms.

During the inspection, the records of Schedule Hand H1 drugs were thoroughly scrutinized on the spot. It was observed that all the checked firms had adopted a computerized billing system, ensuring transparency in sales and inventory management. However, two firms were served on-spot notices for violations of certain license conditions, and they have been directed to take corrective measures immediately. Additionally, nine drug samples were lifted during the drive to ascertain the quality and efficacy of medicines being supplied to the public.

The collected samples will undergo rigorous testing at designated laboratories to ensure compliance with safety and quality standards.

Also Pharmacists and drug retailers were urged to adhere strictly to prescribed guidelines, maintain proper records, and cooperate with enforcement agencies to prevent any misuse of drugs.

243 Doctors, Paramedics deployed in Ramnagar Constituency: Sakeena Itoo

Selection process for 181 Medical Officer underway with JKPSC

Jammu: Minister for Health and Medical Education, Sakeena Itoo, said that out of 252 sanctioned posts of Doctors, Paramedics, Non-Gazetted, 142 have been filled up and an additional staff of 101 Doctors and Paramedics have been deployed under the National Health Mission to improve healthcare in remote areas of Ramnagar Constituency.

The Minister was replying to a question raised by Dr. Sunil Bhardwaj in the Legislative Assembly.

The Minister informed the House that, out of 365 newly appointed Medical Officers, 17 have been posted in Udhampur while selection process for 181 Medical Officer posts is still underway with the Jammu and Kashmir Public Service Commission (JKPSC). "Once the selections are received, the appointed doctors will be assigned to health institutions experiencing severe staff shortages" she added.

The Minister informed that in addition to this, the department is also in the process of operating the waitlist for 91 selected Medical Officers. She said that, additionally, 292 vacancies in non-gazetted, paramedical categories from the Directorate of Family Welfare and 290 from the Directorate of Health Services have been



referred for recruitment to the Jammu and Kashmir Services Selection Board to strengthen the healthcare in the region.

Regarding Ramnagar Constituency, the Minister informed that 51 health institutions have been sanctioned with 19 in government buildings, 29 in rented buildings and 3 in other departmental buildings.

The Minister said that construction and repair work on nine institutes was initiated, out of which, six have been completed and three are under execution. Additionally, initiatives like e-Sanjeevni, Tele-radiology, Tele-Manas and implementation of National Health Mission schemes, Pradhan Mantri ABHIM and PMJAY-SEHAT are strengthening the healthcare services immensely for the UT populace, the Minister

The Minister said that Jammu and Kashmir, with 554 NTPHCs as of now, is among the top in health institution density in the country, according to the Ministry of Health and Family Welfare's 2023 report. The region is working on consolidation of existing health facilities with over 4,200 health institutions across primary, secondary and tertiary levels. The creation and upgradation of health institutions will follow the IPHS-2022 guidelines, which serve as the benchmarks for developing or upgrading the existing healthcare facilities.

Current massive storms and hurricanes and flooding in the United States' Florida, North Carolina and other states and massive flooding and storms in other parts of the world—Mother Earth—is warning us that unless humanity acts soon to curb the GHG, this beautiful planet of ours will be uninhabitable by the end of this century or long before. The earth and its atmosphere, oceans and rivers are getting polluted and getting warmer and warmer year after year. As per The New York Times—Jan. 10, 2023-last 8 years were the hottest on record. There is no question about it. In its entire history, humanity has never faced a threat of this magnitude ever before. Thousands of scientists around the world have agreed on this. Governments around the world are trying to agree to jointly combat this threat to humanity. But we don't know if they

But it should be noted that while India ranks high among emitters, when you factor in population to look at per capita GHG emissions, the highly populated country ranks significantly lower than the other top 10 emitters. Additionally, India is the only G-20 country that has fulfilled its commitments under the Paris Agreement on environment.

Collectively, this group of nations account for over two-thirds of global GHG emissions. The world cannot successfully fight climate change without significant action by the top 10 emitters.

Since reporting began in 1990, the energy sector — including generation of electricity and heat, as well as end uses in buildings, transportation, manufacturing and construction — remained the largest contributor to GHG emissions over any other sector, representing 76% of global emissions in 2019.

According to the findings published in the Lancet Journal and reported by The Guardian of UK (October 30, 2017), health of millions of people around the world is being damaged by climate change. Air pollution is causing millions of early deaths every year, with 800,000 deaths annually related solely to coal burning.

January 2024 – A new World Economic Forum report, published earlier this year, warns that by 2050 climate change may cause an additional 14.5 million deaths and \$12.5 trillion in economic losses worldwide. Millions of eco-refugees will be forced to encroach on neighboring countries. Despite the stark findings, there is still time for global stakeholders to take decisive, strategic action to counter these forecasts and mitigate the health impacts of climate change globally.

Floods were found to pose the highest acute risk of climate-induced mortality, accounting for 8.5 million deaths by 2050. Droughts, indirectly linked to extreme heat, are the second-highest cause of mortality, with an anticipated 3.2 million deaths. Heat waves take the highest economic toll at an estimated \$7.1 trillion by 2050 due to the loss in productivity. Excess deaths attributed to air pollution, caused by fine particulate and ozone pol-

lution are expected to be the largest contributor to premature death with almost 9 million deaths a year.

In a report dated March 1, 2022, from the UN's Intergovernmental Panel on Climate Change (IPCC), researchers from 67 countries warned that warming is putting a large portion of the world's biodiversity and ecosystems at risk of extinction, even under relatively conservative estimates. Never before has an IPCC report — considered the gold standard for climate science — revealed in such stark detail how

climate change is harming nature.

What ails and affects the wildlife ails and affects us, the authors wrote. Humans are inextricably dependent on many species that are in jeopardy from rising temperatures, whether they're animals that pollinate crops, filter rivers and streams, or feed us. In the US alone, for example, more than 150 crops depend on pollinators, including nearly all fruits and grains, and climate change puts them at risk.

If the planet warms by 1.5 degrees Celsius — which is almost certain — up to 14 percent of all plants and animals on land will likely face a high risk of extinction, according to the report. The outlook becomes graver if temperatures rise even further; with 3 degrees of warming, for example, up to 29 percent of species on land could face extinction.

Sixth Mass Extinction: Our planet has experienced five previous mass extinction events, the last one occurring 65.5 million years ago which wiped out the dinosaurs from existence. Experts now believe that we're in the midst of a sixth mass extinction.

Unlike previous extinction events caused by natural phenomena, the us humans. It is driven by human activity, mainly (though not limited to) unsustainable land, water and energy use. Currently, 40% of all land has been converted for food production. Agriculture is also responsible for 90% of global deforestation and accounts for 70% of the planet's freshwater use, devastating the species that inhabit those places by significantly altering their habitats. It's obvious that where and how the food is produced is one of the biggest human-caused threats to species extinction and our ecosystems. To make matters worse, unsustainable food production and consumption are major contributors to greenhouse gas emissions that are causing atmospheric temperatures to rise,

wreaking havoc across the planet. The current climate crisis is causing everything from severe droughts to more frequent and intense storms. It also exacerbates the challenges associated with food production that stress species, while creating conditions that make their habitats inhospitable. Increased droughts and floods have made it very difficult to maintain crops and produce sufficient food in various regions. The intertwined relationships among the food system, climate change, and biodiversity loss are placing immense pressure on our planet. (C- Counter

Additionally, a top up up to 10 Kg is also being provided to an eligible household in PHH category under J&K Government run scheme of PMFSS, he added. The Minister said that there is also a proposal in the Annual Financial Statement of 2025-26 to provide additional free food grains in the context of AAY households only. He said that the Department does not maintain any updation lists of the beneficiaries, however, complete details of the beneficiaries under all the groups are available on RCMS portal, which is in public domain and can be accessed at rcms.jk.gov.in.

To stay relevant, I have to adapt as well: M S Dhoni

is the back-room decisionmaker in Chennai Super Kings despite handing over captaincy to Ruturaj Gaikwad, the talismanic Mahendra Singh Dhoni said he is instead focussed on reinventing himself and his strokes to "stay relevant" in the IPL.

Speaking to 'JioStar' after CSK's four-wicket $win\, over\, Mumbai\, Indians\, in\, their\, lung-opener$ on Sunday night here, Dhoni spoke about the team dynamics under Gaikwad, his own form and also the regional commentary being done in the ongoing league.

"...batsmen are now willing to take risks. They believe that with proper cricketing shots, they can play big strokes, and at the same time, they are improvising with their shot selection...whether it's a reverse scoop against a fast bowler, a sweep, or a reverse sweep against a pacer.

"I am no different, I have to adapt as well. This is what is required of me for where I am batting. You have to try and stay relevant,"

"The way we played T20 in 2008 and the way we played IPL last year, it's very different. Earlier, there was a lot of turn in the wickets. Wickets were two-paced. Now, India's wickets have become much better; they are more batter-friendly," he explained.

The 43-year-old, under whom CSK won five IPL titles, handed over the leadership to Gaikwad at the beginning of the 2024 season. He said although he discusses things with

Quick timing, great hands, good vision: **Hayden praises Dhoni** after stumping of Suryakumar

CHENNAI: Mahendra Singh Dhoni's lightning-quick reflexes behind the stumps to get rid of Suryakumar Yadav during an IPL match here have left former Australian opener Matthew Hayden gushing about the former Indian captain's abilities, despite not being in his prime.

Dhoni, 43, is nearing the end of his career, having hung up his international boots five years ago and playing just as a player for the Chennai Super Kings after leading the team to five IPL titles.

However, Dhoni showcased his brilliance once again on Sunday when he whipped off the bails in an instant off Noor Ahmad's delivery, sending Suryakumar back to the pavilion.

"He (Dhoni) was on fire," Hayden, the former Australia batter and Dhoni's team-mate at CSK till 2010, said on ESPNcricinfo's T20 Time Out.

"I mean Noor Ahmad was firing down the leg side and it was just a movement across the ball. They're difficult when you're sitting there sort of partially obscured by

The stumping of Suryakumar (29) was a crucial moment in the game as CSK broke a 51-run stand and eventually restricted Mumbai Indians to 155/9. CSK chased down the target with four wickets in hand and five balls to spare at Chepauk.
