JAMMU: The Jammu & Kashmir Government informed the Legislative Assembly on Saturday that only 23.54 percent of hydropower potential of the Union Territory has been harnessed so far.

In a written reply to a question of MLA Eidgah Mubarak Gul, as per news agency-Kashmir News Observer(KNO), Minister in-charge Power Development Department, Omar Abdullah, revealed that J&K has estimated hydropower potential of 18000 megawatts.

Out of which, 14867 megawatts of hydropower have been identified, the CM said, adding that 11283 MWs of hydropower have been identified in Chenab Valley, 3084 MWs in Jehlum basin and 500 MWs in Ravi basin.

The minister further informed the House that only 3540.15 MWs (23.54 percent of identified potential) have been harnessed till date.Of which 2250 MWs have been harnessed in the Central sector, 1197. 4 MWs in the >>SEE ON P-7

Child labour declined in India's incense stick industry, claims report by NGOs

NEW DELHI: A new study by coalition of child rights NGOs has claimed that child labour in India's incense stick manufacturing industry has found a significant decline in the employment of underage workers.

The research, conducted across Bihar, Karnataka, and Andhra Pradesh, highlighted progress in eradicating child labour from the sector. However, concerns were raised regarding children engaged in home-based work under unregulated conditions.

The study, undertaken by the Just Rights for Children Alliance in collaboration with multiple NGOs, revealed that 82 per cent of respondents did not witness any child labour in their localities.

 ${\it Only 8 \, per \, cent \, reported \, seeing \, children}$ engaged in incense stick (agarbatti) manufacturing, with a total of 31 children identified across the surveyed states – 13 in Andhra Pradesh and 18 in Karnataka.

"The incense stick industry has made remarkable progress in eliminating child labour, thanks to heightened awareness, policy interventions, and stricter regulations. However, we must remain vigilant, as pockets of child labour persist, particularly in home-based settings," the



report stated.

The study surveyed a total of 153 respondents across three states, selected based on literature review and local NGO insights.

The sample included shopkeepers, tea sellers, labourers, and local residents, ensuring diverse perspectives on the prevalence of child labour in the industry. The survey method enabled researchers

to gauge community awareness and direct observations regarding the employment of children.

According to the findings, 77 per cent of the observed child labourers worked in home-based production rather than formal workshops, making regulation

and monitoring more challenging. Additionally, 85 per cent of these children were engaged in packaging incense sticks, a task requiring minimal skill but drawing vulnerable children into the workforce.

The study also sheds light on the working conditions of these children. About 92 per cent of them reported

working between five to eight hours daily, with 77 per cent earning less than Rs 5,000 per month.

Despite India's legal framework prohibiting child labour, enforcement remains a challenge. The Child Labour (Prohibition and Regulation) Act,

1986, and its 2016 amendment prohibit employment of children under 14 in all occupations, except for assistance in family enterprises.

The incense stick industry, which employs over two million workers nationwide, is primarily a home-based sector, with women constituting 80 percent of the workforce. Karnataka alone accounts for 60 percent of agarbatti production, with labourers earning meager wages for their work.

While the decline in child labour in the industry is a positive development, the report emphasizes the need for continued monitoring, stricter enforcement of labour laws, and enhanced rehabilitation measures for affected children."It is essential to sustain this progress through collective action from government agencies, civil society organizations, and industry

Farmers burn Punjab CM's effigies in villages Against Their Eviction From Shambhu, Khanauri

CHANDIGARH: The Kisan Mazdoor Sangharsh Committee (KMSC) said on Saturday that it has burnt the effigies of the AAP Government in villages of Punjab against the eviction of farmers from the Shambhu and Khanauri border points by the state police.

Meanwhile, a few farmer leaders paid a visit to their imprisoned colleagues, including Sarwan Singh Pandher, in the Patiala jail.

They said around 125 protesters are lodged in the Patiala jail, 150 in the Nabha jail and 40 in the Sangrur jail.

"We met farmer leaders, including women, in the Patiala jail. They said they are in high spirits and that the fight is on," farmer leader Guramneet Singh Mangat said.

In a crackdown on Wednesday, several farmer leaders, including Pandher and Jagjit Singh Dallewal, were detained by the Punjab Police as they were returning from a meeting with a central delegation led by Union Agriculture Minister Shivraj Singh Chouhan in Chandigarh.

Meanwhile, KMSC leader Sukhwinder Singh slammed the Aam Aadmi Party (AAP) Government for detaining the farmer leaders and evicting the protesters from Shambhu and Khanauri.

He demanded that the detained farmers be released. He also claimed that several belongings of farmers at the Shambhu and Khanauri border points between Punjab and Haryana were missing following the police action.

Singh said the effigies of Punjab Chief Minister Bhagwant Mann were burnt in villages on Saturday and this would continue for the next couple of days. "We will intensify our agitation," he said.



Delhi Police busts illegal Bangladeshi immigration racket; 8 held, six deported

busted an illegal immigration network, arresting eight Bangladeshi nationals and as many Indian accomplices, who were facilitating their unlawful stay in south Delhi, an official said on Saturday. Six other immigrants were deported via the

Foreigner Regional Registration Office (FRRO), while four more are under scrutiny, he said.

During the crackdown, police uncovered a fake identity document syndicate and a crossborder money laundering racket that routed

funds to Bangladesh through digital payment apps. Some of the immigrants had even enrolled their children in local schools, he added.

"The network allegedly helped Bangladeshi migrants enter India illegally and provided them with shelter, employment, and forged Aadhaar, PAN, voter ID cards, and even Indian passports," Deputy Commissioner of Police (DSP) (South) Ankita Chauhan said.

Among those arrested was Md Alamgir (34), who came to India in 2007 and worked as a scrap dealer. He had married an Indian woman and had two children, aged 13 and 9. His younger brother, Md Jewel Islam (27), arrived in 2021 and was also engaged in the scrap trade, the officer said.

Another accused, Md Rejaul, had been living in India since 2000 and had obtained an Indian passport, allowing him to travel between India and Bangladesh frequently. He allegedly used his travels to transport money and other goods, Chauhan said.

Police also identified Kamruzzaman, who entered India in 2014 and was working as a delivery agent for an online food delivery platform using forged identity documents, he said.

Meanwhile, Mohammad Nadeem Sheikh was employed as a cleaner and sweeper in Delhi and Md Latif Khan (37), a resident since 2015, worked as a ragpicker and frequently remitted money to

NEW DELHI: Delhi Police claimed to have Bangladesh through informal channels, he added. The DSP further said that Md Mizanur Rehman (43), who came to India in 2022, was working as a scrap dealer in Kotla Mubarakpur, while Rabiul (25), who arrived the same year, was employed as a hospital attendant in Defence Colony.

Apart from the illegal immigrants, several Indian nationals who played a crucial role in assisting them, were arrested, police said.

The key figure behind the identity forgery syndicate was Md Moinuddin, who operated a



computer shop in Delhi and was responsible for manufacturing fake birth certificates and other documents, they said.

The forged papers were then used to create Aadhaar, PAN, and voter ID cards, which in turn allowed the immigrants to access jobs and Government services, they added.

Police said that Moinuddin worked closely with three Aadhaar enrollment agents -?Zulfiqar Ansari, Javed, and Farman Khan – who used their official authorization to register the illegal immigrants into the government database.

Investigations also revealed the financial aspect of the racket, with two licensed forex agents, Manwar Hussain and Nimai Karmakar, who allegedly managed the transfer of illicit funds to Bangladesh, DCP Chauhan said.

Hussain, who worked at Dargah Hazrat Nizamuddin, collected money from illegal Bangladeshi migrants and facilitated its transfer through a hawala-like system, he said.



PAMPORE: Police Station Pampore swiftly acted on a theft complaint and successfully recovered a stolen JCB machine while apprehending the person involved in the crime.

As per officials, on Saturday morning, Parvaiz Ahmad Wani, son of Mukhtar Ahmad Wani, a resident of Qazigund Kakapora, filed a complaint stating that during the intervening night of March 20-21, 2025, unknown burglars stole his JCB excavator (Registration No. JK18A-1871) parked at a petrol pump in Kadlabal Pampore, po-

JAMMU: Minister for Jal Shakti, Javed Ahmad Rana, today said that Watlab Receiving Station has been upgraded from 1x6.3 MVA to 2x6.3 MVA under PMDP and completed in 2019. The Minister was replying on behalf of Chief Minister, Omar



Abdullah, to a question raised by Irshad Rasool Kar.

He said that the upgraded Watlab Receiving Station has been supplying power to the Warpora area through the 11KV Warpora feeder, however, with increasing load demand, the feeder load reaches 460 Amps during the peak hours. He added that to address this, the department has initiated a fresh technical feasibility survey to assess the need for a new Receiving Station at Warpora and a decision on the new Receiving Station will be taken based on the survey outcome.

He said that the 10MVA 33/11KV Receiving Station at Warpora was initially proposed as part of a prospective plan.

The Minister said that Electrical infrastructure development is underway under various centrally sponsored schemes like PMDP/RDSS. He said that some areas of Sopore Town (Model Town, Court Road, Galabad) have been completed and 24x7 power supply is being provided there. He said that there has been an appreciable improvement in power supply hours, quality of supply in completed areas and work is in progress for the remaining feeders and planned shutdowns are being availed for execution of works safely, with prior information to the public.

He said that once the project works are completed and the loss level of feeders decreases to the desired level, the feeders will qualify for 24x7 power supply.

The Minister said that the work on shifting/re-aligning the entire 33 KV line is not being covered under any existing projects. However, a separate tap line was taken up from Substation Sopore-1 to River crossing under the Centrally Sponsored Scheme R-APDRP Part-B to partly shift the line.

Soil Health Card

The Soil Health Card (SHC) Scheme, introduced to promote balanced fertilization and improve soil fertility, has shown promising results in reducing fertilizer overuse and enhancing agricultural productivity. However, its implementation and adoption challenges continue to hinder its full potential

Studies by National Institute of Agricultural Extension Management (MANAGE) and the National Productivity Council highlight a 9% reduction in urea use, 7% decrease in phosphate fertilizers, and a 20% increase in potassium application—a shift towards balanced nutrient use. Moreover, farmers adopting SHC recommendations saw an 8-10% cost saving on fertilizers and a 5-6% increase in crop yields. Yet, despite these gains, widespread awareness and accessibility issues remain a concern, particularly among small and marginal farmers.

To enhance SHC adoption, the government has revamped the SHC portal, introduced a mobile app, integrated QR-coded soil sample collection, and onboarded soil testing labs for real-time data access. However, ground-level outreach efforts must be strengthened. While over 7 lakh demonstrations and 93,000 farmer training programs have been conducted, many farmers still lack access to soil testing facilities or do not fully understand SHC recommendations.

A critical gap lies in customized, localized advisory services. Krishi Vigyan Kendras (KVKs) and Agricultural Technology Management Agencies (ATMAs) must increase farmer engagement through personalized quidance, ensuring easier interpretation and adoption of SHC recommendations. Additionally, state governments must expand doorstep soil testing services to reach farmers in remote areas. The Soil Health Card Scheme has laid a strong foundation, but to make balanced fertilization a norm rather than an exception, better implementation, farmer education, and accessibility improvements are crucial. If effectively scaled, the SHC scheme can be a game-changer, leading to sustainable agriculture, higher productivity, and long-term soil conservation—critical for ensuring India's food security and environmental health.

Rural Women's Careers: Challenges and Opportunities

In rural India, the career situation of women becomes even more challenging after marriage. Due to traditional thinking, lack of education, and unavailability of opportunities, many women are not able to remain financially independent after marriage. However, change is now coming through self-help groups (SHG), rural entrepreneurship, and government schemes. For example, women are running small businesses through Sakhi Mandal and self-help groups. Many women started their own businesses with the Pradhan Mantri Mudra Yojana. Due to the Digital India initiative, women are now doing online business. Women are moving ahead in dairy, tailoring, embroidery, gardening, and agriculture-based businesses.

The effect of marriage on women's careers

According to the report, only 20% of women

believe that they face career obstacles due to marriage and children. Workforce participation of women above 30 years of age in India is only 18%, while this number is 78% for men.

Indra Nooyi managed to maintain her career despite being married. In her book "My Life in Full," she has explained how she balanced her family and career and how companies need to create supportive workplaces for women. Kiran Mazumdar Shaw (founder of Biocon) built her biotech company despite marriage and society's expectations. According to her, women can successfully pursue their careers even after marriage if they get support from their family. Tennis star Serena Williams returned to the game even after motherhood and won many titles. She broke the myth that the only option after becoming a mother is to quit a career.

Bhagat Singh's Forgotten Notebook: Insights from a Revolutionary Mind

n the occasion of the martyrdom day of Bhagat Singh and his comrades Sukhdev and Rajguru, let us briefly explore Bhagat Singh's jail diary. This diary, similar in size to a school notebook, was given to Bhagat Singh by jail authorities on September 12, 1929, with an inscription stating "404 pages for Bhagat Singh." During his imprisonment, he made notes in this diary based on 43 books written by 108 different authors, including Karl Marx, Friedrich Engels, and Lenin. He took extensive notes on history, philosophy, and economics.


Bhagat Singh's focus was not only on the struggle against colonialism but also on issues related to social development. He was particularly inclined toward reading Western thinkers. Moving beyond nationalist narrow-mindedness, he advocated for resolving issues through modern global perspectives. This global vision was something only a few leaders of his time, such as Mahatma Gandhi, Jawaharlal Nehru, and Dr. B.R. Ambedkar, possessed.

In 1968, Indian historian G. Deval had the opportunity to see the original copy of Bhagat Singh's jail diary with Bhagat Singh's brother, Kulbir Singh. Based on his notes, Deval wrote an article about Bhagat Singh in the periodical People's Path, where he mentioned a 200-page diary. In his article, G. Deval noted that Bhagat Singh had made annotations on topics like capitalism, socialism, the origin of the state, Marxism, communism, religion, philosophy, and the history of revolutions. He also suggested that the diary should be published, but this did not materialize.

In 1977, Russian scholar L.V. Mitrokhov came across information about this diary. After gathering details from Kulbir Singh, he wrote an article that was later included as a chapter in his book Lenin and India in 1981. In 1990, Lenin and India was translated into Hindi and published by Pragati Prakashan, Moscow, under the title Lenin Aur Bharat.

On the other hand, in 1981, G.B. Kumar Hooja, then Vice-Chancellor of Gurukul Kangri, visited Gurukul Indraprastha near Tughlaqabad, Delhi. The administrator, Shaktive h, showed him some historical documents stored in the basement of the gurukul. G.B. Kumar Hooja borrowed a copy of this notebook for a few days, but he was unable to return it as Shaktive h was murdered shortly after.

In 1989, on the occasion of the martyrdom day of March 23, some meetings of the Hindustani Manch were held, attended by G.B. Kumar Hooja. There, he shared information about this diary. Impressed by its significance, Hindustani Manch announced the decision to publish it. The responsibility was given to Bhupendra Hooja, editor of the Indian Book Chronicle (Jaipur), with support from Hindustani Manch General Secretary Sardar Oberoi, Prof. R.P. Bhatnagar, and Dr. R.C. Bharatiya. However, it was later claimed that financial difficulties prevented its publication. This explanation seems unconvincing, as it is unlikely that the educated middle-class individuals mentioned above could not afford to print a few copies at a time when costs were relatively low. It is more plausible that they either failed to recognize its importance or simply lacked interest. Around the same time, Dr. Prakash Chaturvedi obtained a typewritten photocopy from the Moscow archives and showed it to Dr. R.C. Bharatiya. The Moscow copy was found to be identical, word for word, with the handwritten copy retrieved from the basement of Gurukul Indraprastha. A few months later, in 1991, Bhupendra Hooja began publishing excerpts from this notebook in the Indian Book Chronicle. This was the first time Shaheed Bhagat Singh's jail notebook reached the readers. Alongside this, Prof. Chamanlal informed Hooja that he had seen a similar copy in the Nehru Memorial Museum, Delhi. In 1994, the jail notebook was finally published in book form by Indian Book Chronicle, with a foreword written by Bhupendra Hooja and G.B. Hooja. However, neither of them was aware that the original copy of the book was with Bhagat Singh's brother, Kulbir Singh. They were also unaware of G. Deval's article (1968) and Mitrokhin's book (1981). Furthermore, Dr. Jagmohan Singh, son of Bhagat Singh's sister Bibi Amar Kaur, never mentioned this jail notebook. Similarly, Virendra Sandhu, daughter of Bhagat Singh's brother Kultar Singh, wrote two books on Bhagat Singh, but she too did not reference this di $ary. \, This \, suggests \, that \, Bhagat \, Singh's \, family \, members$ were either unaware of the notebook's existence or had no interest in it. Although Kulbir Singh possessed the diary, he never attempted to share it with historians, publish it as a book, or release it in newspapers. His financial condition was not so dire that he could not afford to publish it himself.

It is unfortunate that Indian historians neglected To obtain more books, he persistently wrote letters to this significant historical document, and it was first Jaidev Gupta, Bhau Kulbir Singh, and others, requesting them to send him reading material.

"Wherever the lower class exists, I am there; wherever criminal elements are, I am there; if anyone is imprisoned, I am not free." He also made notes on the freedom struggles of Rousseau. Thomas Jefferson, and Patrick Henry, as well as on the inalienable rights of man. Additionally, he recorded the famous quote by writer Mark Twain:

"We have been taught how horrifying the beheading of people is. But we have not been taught that the death wrought by the lifelong imposition of poverty and tyranny upon all people is even more dreadful."

To understand capitalism, Bhagat Singh made numerous calculations in this notebook. At that time, he recorded the inequality in Britain - one-ninth of the population controlled half of the production, while only one-seventh (14%) of the output was distributed among two-thirds (66.67%) of the people. In America, the wealthiest 1% held \$67 billion in assets, whereas 70% of the population possessed only 4% of the assets.

He also quoted a statement by Rabindranath Tagore in which the Japanese people's lust for money was described as "a terrifying threat to human society." Furthermore, he referenced bourgeois capitalism by drawing from Maurice Hillquit's Marx to Lenin. Being an atheist, Bhagat Singh recorded under the heading "Religion the Proponent of the Established Order: Slavery" that "in the Old and New Testaments of the Bible, slavery is endorsed, and God's power does not condemn it." While trying to understand the causes behind the emergence of religion and its functioning, he turned to Karl Marx.

In his writing titled Attempts at the Synthesis of Hegel's Philosophy of Justice, under the heading "Marx's Thoughts on Religion," he writes:

"Man creates religion; religion does not create man. To be human means to be part of the human world, the state, and society. The state and society together give rise to a distorted worldview of religion ... '

His approach appears to be that of a social reformist, aimed at overthrowing capitalism and establishing classical socialism. In his notebook, he has included several quotations from the Communist Party's manifesto. He also recorded the lines of the anthem The Internationale. In Friedrich Engels' work, through quotations concerning revolution and counter-revolution in Germany, he is seen opposing his comrades' superficial revolutionary ideas.

In the country, a series of mob lynchings-executions carried out by crowds-in the name of religion, caste, and the cow have begun, and the references he raised from T. Paine's Rights of Man remain relevant even today. In his notebook, it is written: "They learn these things from the very governments under which they live. In return, they impose upon others the very punishment to which they have become accustomed... The impact of the brutal scenes displayed before the masses is such that it either dulls their sensitivity or incites a desire for revenge. Instead of reason, they construct their own image based on these base and false notions of ruling over people through terror."

Regarding "natural and civil rights," he noted, "It

which remained in power for the longest time, showed no curiosity about Bhagat Singh's intellectual and ideological


contributions to the freedom movement. Their ideological differences with him might have been the reason why they never focused on researching Bhagat Singh's thoughts and actions.

After establishing the Bhagat Singh Research Committee, Bhagat Singh's nephew, Dr. Jagmohan Singh, and Professor Chamanlal from JNU's Indian Languages Center compiled and published the writings of Bhagat Singh and his comrades for the first time in 1986 under the title Bhagat Singh Aur Unke Sathiyon Ke Dastavej. Even in that publication, there was no mention of the jail notebook. It was only in the second edition, published in 1991, that it was referenced. Currently, the third edition of this book is available, in which the two scholars have undertaken the invaluable task of adding several rare pieces of information and presenting them to the readers

The notes taken by Bhagat Singh in this notebook clearly reflect his perspective. His restless yearning for freedom led him to transcribe the thoughts of Byron, Whitman, and Wordsworth on liberty. He read Ibsen's plays, Fyodor Dostoevsky's renowned novel Crime and Punishment, and Victor Hugo's Les Misérables. He also read the works of Charles Dickens, Maxim Gorky, J.S. Mill, Vera Figner, Charlotte Perkins Gilman, Charles Mackay, George de Hesse, Oscar Wilde, and Sinclair.

In July 1930, during his imprisonment, he read Lenin's The Collapse of the Second International and "Left-Wing" Communism: An Infantile Disorder, Kropotkin's Mutual Aid, and Karl Marx's The Civil War in France. He took notes on episodes from the lives of Russian revolutionaries Vera Figner and Morozov. His notebook even contained verses from Omar Khayyam.

On page 21 of his notebook, he wrote the quote by American socialist Eugene V. Debs:



is man's natural rights alone that form the basis of all civil rights." He also recorded the words of the Japanese

BuddhistmonkKokoHoshi:"It is only appropriate for a ruler that no person should be tormented by cold or hunger. When a person does not even have the basic means to live, he cannot uphold moral standards."

He provided references from various authors on subjects such as the aim of socialism (revolution), the aim of world revolution, social unity, and many other issues. Bhagat Singh's associates have noted that while in prison, he wrote four books. Their titles are: 1. Autobiography, 2. Revolutionary 3. Movements in India, 4. The Ideals of Socialism, 5. At the Doorstep of Death. These books were destroyed after he was released from prison, out of fear of reprisals from the British authorities.

Bhagat Singh's outlook was directed toward building a just, socialist Indiafree from casteism, communalism, and inequality-in the post-independence era. His writings and articles clearly indicate this vision, and the prison notebook stands as evidence of his profound study. Bhagat Singh's prison notebook, $is not only a \, record \, of his \, revolutionary$ thoughts and intellectual pursuits but also a testament to his enduring legacy in the struggle for freedom.

The notebook reveals his meticulous reflections on various subjects-from natural and civil rights to the inherent inequalities of his time. It also highlights his profound analysis of social, political, and religious issues, emphasizing his vision for a just and egalitarian society.

UT sector and 92. 75 MWs in Independent Power Producers of mode.

As per the reply, J&K, NHPC manages six projects, J&K State Power Development Corporation 13 projects and Independent Power Producers (IPP) 12 projects.

The Minister also disclosed that erstwhile state of J&K has an estimated solar power potential of 111 GW with the majority of this potential concentrated in Ladakh UT.

The Minister said that due to the land-intensive nature of mega-sized solar power projects, their development in the Union Territory of Jammu & Kashmir has not been possible.

He said the identification of feasible land banks-requiring 500 acres for a 100 MW solar park-at single locations is challenging because of the region's topography.

However, he added that rooftop solar power plants with a cumulative capacity of 75 MW have been installed across the Union Territory under various programmes of the Ministry of New & Renewable Energy.

Govt to set up

"The process for its decommissioning as per the Central Electricity Authority (CEA) Guidelines for the retirement, up-rating/de-rating of conventional generating units has already been initiated and shall culminate soon," the chief minister said, adding that after fulfilling all the conditions, a formal request to the CEA shall be made for dropping GT-Pampore from the list of conventional generating units.

Highlighting the reasons for its decommissioning, Abdullah said the plant has been defunct since 2012 and its machinery is in a non-operational state for a prolonged period, thus deteriorating beyond useful repairs.

"It cannot be operated in the present condition and the revival of the gas turbine will have huge financial implications. Gas turbines have a very high cost of generation of the order of Rs 30 per unit, which renders the power generated unsaleable," he said

Abdullah pointed out that there is a countrywide push towards renewable energy.

"The vacant land of the project has been found suitable and proposed for the development of a solar power plant of 10 MW capacity," he said, adding that there is a plan to utilise the area under the gas turbine for the development of the solar power plant (not a solar park, which is usually for larger-scale developments) by the Jammu and Kashmir Power Development Corporation Limited (JKSPDC).

SKIMS continues

The government claimed that recruitment of gazetted and non-gazetted staff of SKIMS Soura was transferred to the Public Service Commission and Services Selection Board, in the interest of patient-care and to make the recruitment process transparent, time –bound and merit-based.

and State Level have been NABL accredited for a robust water quality monitoring mechanism," he added. Field Testing Kits (FTKs) have been distributed among the local

communities for conducting tests of water samples on their own, for which more than 37000 women have been trained for use of FTKs.

We support T20 leagues in new territories but nothing on table yet in Saudi Arabia: IPL chairman

earing two decades of existence, brand IPL has become stronger than ever and doesn't see any threat from the growing number of T20 leagues globally, its chairman Arun Dhumal said on Saturday as he steered clear of the speculation swirling around an event backed by Saudi Arabia.

Speaking to PTI as the league enters its 18th edition, Dhumal said the BCCI supports the rise in number of T20 leagues globally, especially in unchartered territories like Saudi Arabia, Europe and the USA. He feels the growth will eventually help the game ahead of the 2028 Los Angeles Olympics where cricket will be played.

"There is no point discussing something on the basis of speculation. There is nothing on the table for discussion with everyone (all stakeholders). And as far as my knowledge goes, there is no infrastructure as of now in Saudi Arabia that can cater to a tournament of this scale.

"So, there is no point discussing speculative stories," said the IPL chairman.

Plenty has been reported in international media about the oil-rich Saudi Arabia foraying into cricket over the last two years but nothing concrete has come out of those speculations. Having said that, Saudi Arabia has been

a sponsor in the IPL and hosted the mega auction last year.
