## J&K Assembly approves budget for 2025-26

Appropriation Bill passed <<<

**JAMMU**: The Jammu & Kashmir Legislative

Assembly on Tuesday approved Rs 1.12 lakh crore budget of the Union Territory for 2025-26, with passage of the Appropriation Bill.


After the culmination of the Question Hour, as per news agency—Kashmir News Observer (KNO), the Assembly passed the Appropriation Bill for 2025-26 (L.A. Bill No. 3 of 2025) introduced by Chief Minister, Omar Abdullah, who also holds the Finance portfolio.

The bill was passed in the absence of BJP members, who had staged a walkout earlier over the issue of daily wagers.

It also passed the Appropriation Bill for the financial year 2024-25 to approve supplementary grants for the current financial year.

The passage of the bills marked the culmination of the process of approval to the budget for next financial year. Chief Minister Omar Abdullah had unveiled Rs 1, 12,310 crore budget for J&K in the Assembly March 07. It was after a gap of seven years that J&K's

### Will give 200 Units Of Free Electricity: CM Omar

JAMMU: Jammu and Kashmir Chief Minister Omar Abdullah on Tuesday said the National Conference government is promise-bound to implement all its election promises

including giving 200 units of free electricity to all households falling under the Antyodaya Anna Yojana (AAY) category.

Abdullah said this in the legislative assembly while replying to a clubbed question by Peoples Conference's Sajad

Gani Lone, BJP's Narinder Singh Raina and independent Shabir Ahmad Kullay.

The chief minister was at his witty best while informing the House that the government will provide free electricity to all AAY households. integrating the scheme with the PM Surya Ghar Muft Bijlee Yojna (PMSGMBY).

"...our concern is milk and which cow gives us milk does not mean anything for us. Our aim is to give 200 units of free electricity to the people and it will be done...we will ensure that there is not much impact on the exchequer," Abdullah said.

The chief minister said he had clarified thrice on the subject in this House – during the discussion on lieutenant governor's address, budget presentation and discussion on grants.

"All the promises in our manifesto will be fulfilled. We are promise-bound to the people.

**JAMMU**: The replacement of words "Government of Jammu & Kashmir" with "Government of Union Territory of Jammu & Kashmir" in the State Goods & Services Tax law sparked protests by the Kashmir based opposition legislators in the Assembly on Tuesday, with Peoples Conference president Sajad Gani Lone staging a walkout from the House

of interest on loans are among the components being covered under the package.

He said that construction of 6000 transit accommodations was sanctioned in different districts of Kashmir Valley during December 2015 and work on 5160 flats have been taken up for construction. Of this, 3120 flats have been completed up to ending January, 2025 while the remaining 2040 flats are still under construction. Moreover, the remaining 840 flats are likely to be taken-up shortly.

The Deputy Chief Minister said that the matter of enhancement in relief benefits has been taken up with the Government of India for consideration of enhancement/ grant of full relief benefits in favour of new born babies of Kashmiri Migrants from Rs. 400 per month to Rs. 3250 per month without disturbing the ceiling of Rs. 13000 per family per month. children went missing in

J&K, Ladakh

**SRINAGAR**: Over 5,400 children were reported missing in Jammu & Kashmir and Ladakh between 2016 and 2022, with over 1,500 still untraced, reveals the data accessed by the news agency—Kashmir News Observer (KNO).

In 2016, 1,070 children went missing, including 589 boys and 481 girls. Of these, 766 cases were carried over from previous years, while 304 children—166 boys and 138 girls—went missing that year.

In the same year, 354 missing children were traced, including 164 boys and 190 girls. However, 716 children—425 boys and 291 girls—remained untraced.

In 2017, a total of 725 children were reported missing, including 431 boys and 294 girls. Of these, 614 cases—379 boys and 235 girls—were carried over from previous years, while 111 children-52 boys and 59 girls-went missing that year. In the same, year total of 219 missing children were traced, including 141

# Uproarious scenes in assembly over issues of daily-wagers >>> BJP stages walkout <<<

**SRINAGAR**: The Legislative Assembly on Tuesday witnessed uproarious scenes over protests of daily-wagers with legislators from treasury benches and opposition Bharatiya Janta Party raising slogans against each other.

After the Question Hour concluded, as per news agency-Kashmir News Observer (KNO), Leader of Opposition Sunil Sharma drew the attention of the government towards strike of daily-wagers over their demands

"The strike of daily wagers has triggered a water crisis, and it is unfortunate that there is no response from the government over it", he said.

He said he had also raised the issue in the House on Monday but there has been no response from the government over it.

Responding to LoP Sharma, Deputy Chief Minister Surinder Choudhary accused BJP of failing to resolve their issues in the past 10 years.

"Why were they not agitating

for the past 10 years? We formed a committee within days to resolve the issues of daily wagers. Why

that the government is serious in resolving their issues. "If we were not interested in



to address their grievances in the past 10 years?" he asked.

This led to exchange of heated arguments and sloganeering between BJP and Treasury benches.

## Nithari killings: SC to hear on Apr 3 pleas challenging Surendra Koli's acquittal

**NEW DELHI**: The Supreme Court on Tuesday said it would hear on April 3 a batch of petitions challenging the acquittal of Surendra Koli in the 2006 Nithari serial

The apex court had last year agreed to examine separate pleas, including those filed by the Central Bureau of Investigation (CBI) and the Uttar Pradesh government, challenging the Allahabad High Court's decision acquitting Koli on October 16, 2023.

The pleas were listed for hearing on Tuesday before a bench of Justices B R Gavai and Augustine George Masih.

One of the lawyers appearing in the case mentioned the matter before the bench and requested that the pleas be taken up for hearing next week.

Terming it an "extraordinary case", the counsel said children were going missing in Nithari for about two years and later, the police found several skeletal remains.

The lawyer said that Koli was arrested in the case and was kept in police custody for around 60 days.



"We will grant leave and will have it on some Thursday," the bench said and posted the matter for April 3.

Koli's counsel had earlier told the apex court that evidence against him was a confessional statement, recorded several days after his police custody in the case. One of the pleas in the top court has been filed by the father of one of the victims challenging the high court's verdict.

Koli was awarded death penalty on September 28, 2010 by the trial court. Moninder Singh Pandher and his domestic help Koli were accused of rape and murder of persons, mostly children

from their neighbourhood in Nithari, UP.

death penalty case and said the prosecution had failed to prove their guilt "beyond reasonable doubt" and called it a "botched up" investigation.

Reversing the death sentence given to Koli in 12 cases and Pandher in two cases, the high court said the probe was "nothing short of a betrayal of public trust by responsible agencies".

The high court allowed multiple appeals filed by Koli and Pandher, who challenged the death sentence awarded by a CBI court in Ghaziabad.A total of 19 cases were lodged against the duo in 2007, and the CBI filed closure reports in three cases due to lack of evidence.Koli was acquitted in three of the 16 remaining cases and his death sentence in one case was commuted to life.

The killings came to light with the discovery of the skeletal remains of eight children from a drain behind Pandher's house at Nithari in Noida, bordering the national capital, on December 29, 2006.

## Cash discovery: Allahabad HC lawyers on indefinite strike over transfer of Justice Varma

**PRAYAGRAJ**: The Allahabad High Court Bar Association on Tuesday began an indefinite strike to protest against the proposed transfer of Delhi High Court Justice Yashwant Varma to the high

Leading the protesting lawyers gathered at gate number 3 of the high court, Bar Association President Anil Tiwari told reporters. "This protest is not against any court or judge but against those who have betrayed the judicial system." He added, "Our fight is against those involved in corruption and against a system that lacks transparency. For now. our demand is a reconsideration and withdrawal of the transfer order." The Bar Association had reiterated its opposition to Justice Varma's transfer on Monday and decided to go on an indefinite strike from Tuesday.

Tiwari asserted the association was prepared for an all-out battle on this issue.

"From the very beginning, there has been an attempt to cover up this matter. Today, lawyers across India are fighting this battle. Until a resolution is reached, we will not resume work, no matter the consequences," he said on Monday.

## Political power only way to secure Dalits' welfare: Mayawati

**LUCKNOW**: Bahujan Samaj Party (BSP) chief Mayawati on Tuesday said only political power can bring "good days" for the Dalits

"Winning political power is the only way to bring 'achche din' for Bahujans," the party supremo said at a state-level special meeting of BSP's OBC officials. Mayawati said that the Bahujan community, particularly OBCs, has been severely affected by caste-based and narrow-minded politics.

She claimed that, like Dalits, OBCs have been deprived of their Constitutional reservation benefits due to new policies that have rendered quota ineffective.

Mayawati urged for a renewed and intensified campaign to unite all sections and secure political power to end social discrimination.

"To free themselves from humiliation, all sections of the Bahujan community must unite and strengthen their political power. We must start a new and aggressive campaign at the village level to expose the anti-Dalit and anti-OBC agendas of Congress, BJP, and

She added, "Defeating casteist parties like BJP, Congress, and SP and securing political power is the only effective way for Bahujans



to bring their 'achhe din'." The former Uttar Pradesh chief minister said that OBCs had always been divided and marginalised until the implementation of the Mandal Commission recommendations.

She said it was the BSP that helped them secure their Constitutional right to

Accusing rival parties of conspiring against BSP, Mayawati said, "In 2012, casteist parties worked together to remove BSP from power in Uttar Pradesh. Since then, Dalits and OBCs have suffered under successive governments, and their condition has only worsened." During the meeting, Mayawati also spoke at length about the development work undertaken during her four terms as UP chief minister. She recalled that in 2011, her government had written to then-prime minister Manmohan Singh, demanding a caste-based census.

"Opposition parties have created small caste-based parties and organisations to divide and weaken Bahujan unity. While some leaders of these outfits fulfil their personal and family interests, their communities remain deprived. Only under BSP's banner can the entire community's interests be safeguarded," she asserted.

Mayawati alleged that all major political parties - Congress, BJP, and SP - were equally responsible for misleading and exploiting Dalits and OBCs.

Col assault incident: Army calls for fair

**CHANDIGARH**: The Army on Tuesday called for a fair and honest investigation in a transparent and time-bound manner to punish the guilty in the Colonel Pushpinder Singh Bath assault incident.

Bath accused 12 Punjab Police personnel of assaulting him and his son over a parking dispute on the intervening night of March 13-14 in Patiala. On Monday, he filed a plea in the Punjab and Haryana High Court seeking transfer of the probe to the CBI or another independent agency.

"We reiterate the need for a fair and honest investigation in a transparent and a very time-bound manner to punish the guilty and restore the faith in the system," Lt Gen Mohit Wadhwa, Chief of Staff, Army Western Command headquarters Chandimandir, said at a joint media briefing here with Punjab's Director General of Police Gaurav Yadav.

Lt Gen Wadhwa said the guilty police personnel should be punished in a timely and exemplary manner so that the incident does not vitiate the atmosphere and affect personnel.

"I would like to assure all that the Indian Army remains fully committed to pursuing



the case to its logical conclusion," Lt Gen Wadhwa added.

DGP Yadav said the Punjab Police reiterates its highest respect to the Indian Army and is committed to maintaining and upholding the dignity of the Army officers.

He said any person who has assaulted the serving Army officer shall be dealt with severely and in accordance with law. The investigations shall be completed swiftly so that the culprits are brought to book soon, said the DGP,

as he talked about various steps taken by the Punjab Police after the incident which includes setting up of a high-level Special Investigation Team headed by a senior Punjab Police officer. Bath, who sought the transfer of the probe

to the CBI or another independent agency, alleged in the plea that a fair investigation was impossible under the Punjab Police.

The Punjab Police last week registered a fresh FIR based on Bath's statement.

A high-level special investigation team has been set up to conduct the investigation in a "fair and expeditious manner".

All 12 personnel have been placed under suspension and departmental proceedings for major punishment have been initiated

# Nepal govt prepares to lower minimum age for marriage from 20 to 18

KATHMANDU: The Nepal government is preparing to lower the minimum age for marriage from 20 years to 18 years or lessen the penalty for child marriage, according to a media report on Monday.



the government concluded that the current age limit of 20 years has only increased rape cases and it is preparing to revise Child Act and the Criminal Code.

Law Minister Ajay Chaurasia said, "The government is working to register the bill in the ongoing session. We are in the final phase of discussions with medical and psychological experts."

Explaining before the Law, Justice and Human Rights Committee of the House of Representatives on Sunday, Minister for Home Affairs Ramesh Lekhak said the government is giving a final touch to the amendment.

The present age limit is not working, it needs to be lowered," he said. "The government was working on two modalities. First, lower the minimum age or second, opt for the Romeo and Juliet law."

The Rome and Juliet law, which is in practice in various states in the US, envisions creating an exception to statutory rape for two young people who do not have a large age gap.

For instance, if the minimum age for marriage is 18, there can be consensual sex between the partners who don't have an age gap more than two or three years.

The Criminal Code says a marriage is concluded or caused to be concluded only when the two parties have attained 20 years of age."A person who flouts the law shall be liable to a sentence of imprisonment for a term not exceeding three years and a fine not exceeding Rs 30,000," says section 173

#### SC To Hear In May Pleas For Implementation Of Its 2006 Verdict On Police Reforms

**NEW DELHI: The Supreme Court Tues-**

day said it will hear in May pleas seeking implementation of its 2006 verdict on police reforms that recommended steps like separation of investigation and law and order duties.

In the 2006 verdict, the top court also passed a slew of directions, that included no ad hoc or interim appointment to the post of Director General of Police (DGP) by the state governments.

The Union Public Service Commission, in consultation with a state government and other stakeholders, will have to prepare a list of three senior police officers and the state can appoint any one of them as DGP. the top court had said.

On Tuesday, lawyer Prashant Bhushan and senior advocate Dushvant Dave told a bench comprising Chief Justice of India Sanjiv Khanna and Justices Sanjay Kumar and KV Viswanathan that the apex court quidelines were being flouted by various state governments.

"There has been rampant corruption in the appointment of police chiefs... rampant." Bhushan said.

"State after state is refusing to comply with the judgment and directions," Dave alleged, adding if these reformatory directions are not implemented then "we will lose

Whereas, the Department has already taken several steps to ensure that certain medicinal preparations containing intoxicating ingredients are sold strictly as per legal provisions; and Whereas, despite strict regulatory surveillance, pilferage of intoxicating drugs (through un-regulated channels) for purposes other than licit use can not be

# WHO Hepatitis data in 2024 based on modelling, not actual surveillance: Govt tells Rajya Sabha

NEW DELHI: The data on hepatitis in the WHO Global Health Report 2024 is based on modelling and not actual surveillance, the Rajya Sabha was informed on Tuesday.

Minister of State for Health Anupriya Patel was responding to a question on whether India ranks second globally in Hepatitis B and C cases with 3.5 crore infections according to the World Health Organisation (WHO) report.

She said that the data presented in the WHO Global Heath Report 2024 is based on modelling and not actual surveillance.

In a written reply she stated that the 2023 Seroprevalence report under the National Program for Surveillance of Viral Hepatitis estimates the prevalence of Hepatitis B and C at 0.85 per cent and 0.29 per cent, respectively.



Based on the data by the National Program for Surveillance of Viral Hepatitis the estimated number of persons likely to be infected with Hepatitis B and C in India is 1.38 crore, she said.

On the government's response and available health infrastructure for managing the disease burden, Patel said that health is a state subject.

However, the Centre has been implementing the National Viral Hepatitis Control Program (NVHCP) since 2018 under the National Health Mission (NHM) to provide diagnostic and treatment services for Hepatitis C, A, and E. The program was expanded in 2019 to include Hepatitis B diagnosis and management, she added.

The minister further said that since Hepatitis B is primarily transmitted from an infected mother to her child, the program mandates screening of all pregnant women.

Newborns of Hepatitis B-positive mothers are administered Hepatitis B Immunoglobulin (HBIG) along with Hepatitis B vaccination under the Universal Immunisation Program (UIP) to prevent disease transmission, Patel said.

The NVHCP also focuses on prevention through awareness campaigns and behaviour change initiatives, she added. Currently, 1,140 existing healthcare facilities (till December, 2024) across the country have been strengthened as treatment sites under the program, where all diagnostic and treatment services are provided free of cost, she said.

### SKUAST-K Team Visits Pampore Villages to Investigate Garlic Crop Disease

**PAMPORE**: The SKUAST-K team visited the villages of Shar Shali and Patalbagh in Pampore Tehsil on Thursday after receiving reports of a disease affecting garlic crops.



Following the directions of Director Extension SKUAST-K, Rihana Habib, a team comprising plant pathologists and vegetable experts inspected the affected areas, interacted with farmers, collected garlic samples, and recommended spraying to prevent the further spread of the disease.

Officials stated that the disease was identified as a basal fungal infection, which has disrupted nutrient absorption in the plants, leading to the withering of the crop. The infection was caused

by excessive moisture retention in the soil.

Furthermore, the team confirmed that they have collected samples, and appropriate treatment will be prescribed to the farmers after laboratory analysis.

Speaking to Kashmir Convener, Professor Zahoor Ahmad Bhat from the Division of PlantPathology, SKUAST-Kashmir, informed that the crop has been affected by a dis-

The farmers visited SKUAST-K and requested us for inspection.

"In response, our entire team arrived here and examined the crop. Initially, it appears that the disease has primarily affected the underground parts of the plants. We collected some samples, and from our preliminary observations, it seems that the disease is caused by root rot. Due to this, the plants are unable to uptake water properly, which has led to yellowing of the leaves," he said.

"We have taken samples for further examination in the laboratory. Based on our initial assessment, it appears to be a fungal infection that has caused the garlic bulbs to rot. After a thorough examination, we will provide the farmers with appropriate recommendations to prevent further spread of the disease," he added.

He also said that condition of the affected plants suggests that their recovery will be extremely difficult.

"However, the remaining healthy plants can be saved if proper recommendations are followed. Plants with minor infections may still recover. Once we identify the specific fungal infection through laboratory analysis, we will provide precise recommendations to the farmers accordingly," he added.


#### Helpicopter Services Suspended Due to Adverse Conditions in Gurez

Rs.10.60 Lakh immediate relief provided to affected families



BARAMULLA: Deputy Inspector General (DIG) of North Kashmir, Maqsood-ul-Zamaan, along with Deputy Commissioner (DC) Baramulla, Minga Sherpa, and Senior Superintendent of Police (SSP) Baramulla, Gurinderpal Singh, visited Mohalla Jala Sahib in Old Town Baramulla to assess the devastation caused by a massive fire.

The massive blaze damaged 17 structures, leaving 29 families affected. Among them, 12 structures were completely destroyed, while five suffered partial damage.

## **Blocked Nose** - Infection, Allergy Or What?

blocked nose, also known as nasal congestion, occurs when the tissues and blood vessels in the nasal passages become swollen with excess fluid or mucus. This can make breathing through the nose difficult. A blocked nose is a common yet uncomfortable condition caused by various factors like infections, allergies, and structural abnormalities. While most cases can be managed with home remedies and medications, advanced treatments offer long-term relief for chronic cases. Proper care, hygiene, and early treatment can prevent complications and improve quality of life.

Causes: Infections: Common cold, flu, or sinus infections. Allergies: Dust, pollen, pet dander, or mold. Irritants: Smoke, pollution, or strong odors. Nasal Polyps: Non-cancerous growths in the nasal passages. Deviated Septum: Misalignment of the nasal wall. Medications: Overuse of nasal decongestant sprays. Hormonal Changes: During pregnancy or thyroid problems. b. Symptoms: Difficulty breathing through the nose, runny nose or thick nasal mucus, sneezing, sinus pressure or headache, reduced sense of smell and taste, snoring and postnasal drip (mucus dripping down the throat).

Treatment: Home Remedies: Steam inhalation, saline nasal sprays, and hydration. Medications: Antihistamines, decongestants, and nasal corticosteroids. Medical Procedures: Surgery for nasal polyps or deviated septum. Allergy Management: Avoiding allergens and taking prescribed medications. If the blocked nose persists for more than 10 days or is accompanied by high fever, severe pain, or bleeding, seek medical advice.

Foods recommended include: Hydrating Foods: Warm soups (chicken or vegetable broth), fresh fruit juices (orange, lemon, or pomegranate) and herbal teas (ginger, mint, or chamomile). Anti-inflammatory Foods: Turmeric, ginger and garlic. Vitamin C-Rich Foods: Oranges, lemon, kiwi and bell peppers. Immune-

"You are raising the apprehension that it won't run but it is yet to start. Let it commence first and then if it fails to work, we will change the scheme. Our aim is to give electricity to the people," he said.

Lone, a former minister, in his supplementary demanded a direct reply whether the government is going to provide free electricity to every household, saying the way it started, 50 years are needed to fulfil the promises of providing 200 units of free power to 25 lakh households.

"I am asking him (CM) what is your name and he is replying what is there in the name because everyone has a name. I want a one word answer, yes or no and also when (you are planning to give 200 free units)," the Peoples Conference legislator from Handwara said.

The chief minister in his response said "my english probably is not better than Sajad sahib, and that is why I do not use much English...two questions were posed, whether we are giving free electricity and when, and so the answer cannot be in one word. How to provide 200 free units of electricity is our responsibility and we will see how to fulfill this".

Earlier, replying to the main question, Abdullah said the government shall provide 200 units of free electricity to all AAY households, integrated with the PM Surya Ghar Muft Bijlee Yojna (PMSGMBY).

"The proposal aims to benefit all households falling under the AAY category by providing them with free electricity up to 200 units, thereby alleviating their financial burden and improving their quality of life," he said, adding this would be done through the RESCO, Utility-Led Aggregation model or any other financially viable model to benefit them.

Regarding electricity bills, Abdullah said the current tariff for domestic consumers ranges from Rs 2.30 per unit (for up to 200 units per month) to Rs 4.35 per unit, which is among the lowest in the country.

In the same year, a total of 183 missing children were traced, including 61 boys and 122 girls. However, 444 children-216 boys and 228 girls-remained untraced. Also, Ladakh recorded 5 missing children, with 1 child traced and 4(1 boy, 3 girls) still untraced.

In 2021, a total of 723 children were reported missing, including 280 boys and 443 girls. But Phillips was most animated when asked about his love for flying, not very surprisingly either.

"Yeah, it's a huge passion of mine. If I wasn't playing cricket and I had all the money in the world growing up, I probably would have ended up being a pilot, to be fair. I love being in the air," said Phillips.

"I love all the procedures around being a pilot, the radio communications, but obviously the handling of the plane itself. And I don't really know why I love it so much, but I think anybody who's into aviation doesn't really know either.

"Obviously, the feeling of flying is something that humans have wanted all the time. So, I guess I'm no different from all those people." The 28-year-old South African-born player,

"So, the other half of it is working my butt off to try and be able to cover all my bases, to go out in the middle and understand that I've

done the work. So if I do drop catches, it's not because I haven't put the effort in," said the Blackcaps all-rounder.
