KATHUA: Several suspects with criminal history were detained at Hiranagar in Kathua district for questioning while a major counter-terrorism operation entered its fourth day on Wednesday.

According to the details available with the news agency-Kashmir terrorists while collecting



> March 26: Now in its fourth day, the multi-tier combing operation spans several kilometers from Sanyal to Ding Amb and beyond. Security has been heightened along the Jammu-Pathankot National Highway and border roads. No additional casualties have been reported, and the terrorists remain at large, believed to be trapped within the cordoned-off zone

SRINAGAR: A historic bridge here is undergoing a major transformation as a tribute to the city of bridges' rich architectural heritage, and is set to become a tourism landmark as well as improve the summer capital's aesthetic appeal.

bridge — near the city centre of Lal Chowk — over the Jhelum river is being revived under the Srinagar Smart City project. Officials said a wooden walkway on the existing

The Rs 7.17-crore project includes retrofitting of the piers and carrying out all allied works, the officials said. They exercise aims to revive

the old Amira Kadal wood bridge, one of the oldest in the city, and transform it into a cultural and a vibrant view of the river and attract tourists.

The revamped bridge would be a modern recreational space. equipped with a walkway that

would feature various kiosks and offer architectural and cultural experiences to the visitors, the officials said.

Originally constructed in 1774 Amir Khan Jawan Sher, the Afghan governor of Kashmir under the Durrani Empire, the bridge is undergoing a significant renovation as part of the Srinagar Smart City project, fusing modern architecture with its traditional wooden look.

Taking cues from the Rajbagh wooden bridge, Habba Kadal and Zero bridge, the refurbished Amira Kadal wood bridge aims to preserve Kashmir's architectural heritage while meeting the city's contemporary needs.

The new wooden bridge will only be accessible by foot, contrary to the adjacent Amira Kadal bridge which is used for vehicular traffic For tourists to enjoy Srinagar's history and natural beauty, it seeks to offer a cultural and recreational experience.

J&K Govt Rejects Over 39,000 Land Claims Under FRA

JAMMU: The Jammu and Kashmir government has rejected over 39,000 claims for land ownership under the Forest Rights Act but has distributed over 65,000 kanals of forest land to over 6,020 scheduled tribe (ST) families, including Gujjars, Bakerwals and other forest dwellers.



A total of 46,090 claims were submitted by Scheduled Tribes (ST) and other traditional forest dwellers (OTFDs) under Individual Forest Rights (IFR) and Community Forest Rights (CFR),

Centre inks Rs 6,900 cr contracts for advanced artillery gun systems, high mobility vehicles

NEW DELHI: In a bid to further to further enhance Indian Army's operational readiness, the Centre on Wednesday announced contracts with

Bharat Forge Limited and Tata Advanced System Limited for the procurement of 155mm/52 Calibre Advanced Towed Artillery Gun Systems (ATAGS) and High Mobility Vehicle 6×6 Gun Towing Vehicles. at a total cost of about Rs 6,900 crore.

The Ministry of Defence (MoD) has signed contracts with the two companies, in the presence of Defence Secretary Rajesh Kumar Singh, in the national capital. With this, total contracts worth Rs 1.40 lakh crore have been signed by MoD for capital procurement till date in the current fiscal.

The 155 mm/52 Calibre ATAGS will replace the vintage and smaller calibre guns and enhance the artillery capabilities of the Indian Army. According

to the Ministry of Defence, the procurement of this gun system marks a significant milestone in the modernisation of the Artillery Regiments, enhancing operational readiness

"ATAGS, renowned for its exceptional lethality. will play a crucial role in bolstering the Army's firepower by enabling precise and long-range strikes," it said. Being the first major procurement of towed guns from the private sector by the Indian Army, the project will provide a boost to the Indian gun manufacturing industry in particular and the indigenous defence manufacturing eco-system as a whole.

ECI Launches First-Ever Training for Over I Lakh Booth **Level Officers**

NEW DELHI: The Election Commission of India (ECI) has started its first-ever training program for over 1 lakh Booth Level Officers (BLOs) at the India International Institute of Democracy & Election Management (IIIDEM), New Delhi.

Chief Election Commissioner Gyanesh Kumar, along with Election Commissioner Dr. Vivek Joshi, inaugurated the training program on Wednesday, which, according to Spokesperson, aims to enhance the efficiency and accuracy of electoral roll management across the country.

Speaking on the occasion CEC Gyanesh Kumar emphasized the critical role of BLOs in maintaining errorfree electoral rolls, highlighting that only Indian citizens above 18 years of age who are ordinary residents can be registered as voters, as per Article 326 of the Constitution.

He also called upon state governments to appoint senior, local officials as BLOs, ensuring a more accountable and efficient electoral process.

Officials said the first batch, comprising 109 BLOs from Bihar, West Bengal, and Assam, along with 24 Electoral Registration Officers (EROs)

JAMMU: Chief Secretary, Atal Dulloo, today held a crucial meeting with the Health Secretaries from 10 States and UTs, asking them to designate adequate number of doctors for issuance of 'Compulsory Health Certificates' (CHCs) in favour of pilgrims embarking on the sacred journey to Shri Amarnathji Shrine in J&K.

(SASB) was attended by Secretary, H&ME; Additional CEO, SASB; Director, SKIMS; Director, Health, Jammu/ Kashmir; representative from Ministry of Health & Family Welfare, Gol.

The Chief Secretary directed the Health Department to conduct the sensitization sessions with the doctors designated by the respective states for issuance of these CHCs in favour of the pilgrims intending to take on this holy journey. He said that such an exercise would help them in better understanding of the requirements to

be met by a person for safe pilgrimage.

He also asked the participating Health Secretaries to further ensure rationalization of doctors across the health facilities commensurate to the number of pilgrims from that area. He declared that this would reciprocate into thorough clinical assessment of the applicants on part of the medics thereby ensuring safety of lives.

He emphasized that individuals with underlying comorbid conditions or physical weaknesses that render them unfit for high-altitude travel must be thoroughly screened. Those deemed unfit should not be issued health certificates, as this would pose a significant risk to their lives during the pilgrimage. He maintained that the UT government is committed to provide best facilities to these pilgrims and wants the yatra to be fully safe, secure and enthralling for each of the devotees. Ex-ED Director Sanjay Kumar Mishra Appointed To EAC-PM

NEW DELHI: Former ED Director Sanjay Kumar Mishra had been appointed by the Union government as a full-time member of the Economic Advisory Council to the Prime Minister (EAC-PM). Mishra, 65, served as the Enforcement



Directorate (ED) chief till September 15, 2023 after the Supreme Court curtailed his extended tenure following petitions filed against multiple extensions granted to him by the government.

A government order issued on Tuesday said Mishra, a 1984-batch Indian Revenue Service (IRS) officer of the Income Tax cadre, will serve as a full-time member of the EAC-PM following approval of his appointment by the prime minister.

The order added Mishra has been appointed in

the rank and pay of secretary to the government of India, from the date of assumption of post, as per usual terms and conditions as are applicable to re-employed government officials.

The EAC-PM is an "independent" body constituted to give advice on economic and related issues to the government of India, specifically to the prime minister. Its current chairman is economist Suman Berry.

Avacancy arose in the body following the death of its former chairman Bibek Debroy in November, 2024.The ED, during Mishra's tenure, probed a number of high-profile people and politicians, including the first family of the Congress like Sonia Gandhi, her son Rahul Gandhi and daughter Priyanka Gandhi apart from multiple chief ministers, ministers, MLAs and MPs under the criminal provisions of the anti-money laundering law which drew criticism from opposition parties that the agency was a "tool" and was acting at the behest of the Centre that is being ruled by the BJP.

He was appointed ED director in October, 2018 and had the second longest tenure of five years as the agency head. ED's first director A M Chatterjee had the longest tenure of nearly 7.5 years between 1957 and 1965.

SC Asks States, UTs To Set Up Grievance Redressal Mechanism

NEW DELHI: The Supreme Court on Wednesday directed the states and union territories to create a grievance redressal mechanism against misleading advertisements that "can cause great harm to society".

Abench of Justices Abhay S Oka and Ujjal Bhuyan said state



governments should create such mechanisms for members of the public to lodge complaints about objectionable advertisements prohibited under Drugs and Magic Remedies Act, 1954.

"We direct the states governments to create proper grievance redressal mechanisms within a period of two months from today and give adequate publicity to the availability at frequent intervals," the bench said.

The top court directed the states to sensitise the police machinery on implementation of the provisions of 1954 act.

Clamping down on misleading advertisements, the apex court on May 7, 2024 directed that before an advertisement was permitted to be issued, a self-declaration be obtained from the advertisers on the line of the Cable Television Networks

The issue of misleading advertisements had cropped up when the apex court was hearing a plea filed in 2022 by the Indian Medical Association alleging a smear campaign by Patanjali and yoga guru Ramdev against the Covid vaccination drive and modern systems of medicine

Maternity Scheme Severely Underfunded: Sonia Gandhi

NEW DELHI: Congress Parliamentary Party (CPP) chairperson Sonia Gandhi on Wednesday said the government's flagship programme to provide maternity benefits to pregnant women is "severely underfunded", resulting in a drastic fall in entitlements to beneficiaries.

Raising the issue through a Zero Hour mention in the Rajya Sabha, she said Pradhan Mantri Matru Vandana Yojana (PMMVY) has seen a drastic fall in the number of beneficiaries and asked the government why this was allowed to happen. Gandhi said the National

Food Security Act (NFSA), passed by Parliament in September 2013 under the leadership of the then prime minister Manmohan Singh in September 2013, has been the foundation for PM Garib Kalyan Yojana (PMGKY), which was launched during Covid-19 to provide foodgrains to poor families. PMGKY currently has 81 crore beneficiaries.

Under NFSA, pregnant women were entitled to maternity benefit of Rs 6,000 per child, paid in two instalments.

PMMVY was launched in 2017 to fulfil this entitlement. But under PMMVY, only Rs 5,000 is given for the first child and the benefits are



extended to the second child only if it is a girl. "According to an informed analysis for 2022-23,

about 68 per cent of pregnant women received at least one instalment of PMMVY for their first birth, but this number drastically dropped to 12 per cent (in) the following year. I would like to ask the Union government why this was allowed to happen," she asked.

 $She also \, questioned \, the \, provision \, for \, PMMVY$ not being separately mentioned in the Union Budget documents.

'The full implementation of the maternity benefits provision requires an annual budget of around Rs 12,000 crore.

Surprisingly, the Budget documents do not contain separate information on allocations for PMMVY," she said.

All that the Budget documents reveal is that there is a programme called Samarthya in the Ministry of Women and Child Development. It has five components, of which PMMVY is one.

"The allocation in 2025-26 for Samarthya is only Rs 2,521 crore. This clearly shows that the PMMVY is severely

underfunded, thereby violating the key provisions of the law passed by Parliament," she said. This is the second time in the current sitting

of the Rajya Sabha in the Budget Session where Gandhi has raised an issue. On March 18, she raised concern over the dilution of employment guarantee under Mahatma

Accused in SAD leader Sukhbir Badal firing case granted bail

AMRITSAR: A court in Amritsar has granted bail to Narain Singh Chaura, who opened fire at Shiromani Akali Dal (SAD) leader Sukhbir Singh Badal at the gate of the Golden Temple in December last year.

Mr. Badal had survived the attempt on his life on December 4, 2024, as Chaura was overpowered

The 68-year-old was arrested immediately after the incident and was subsequently booked under relevant provisions of the law, including attempt to murder and under the provisions of the Arms Act.

Chaura's lawyer Jaspal Singh Manjpur said that Chaura was granted bail by the Additional Sessions judge of Amritsar, Sumit Ghai on Tuesday (March 25, 2025). The former militant, was directed to furnish bail bonds worth 1 lakh along with a surety of the

The additional sessions judge said, ".... since the applicant has been in custody since 4.12.2024 and the conclusion of trial will take its own time. therefore, no useful purpose would be served by detaining the accused/applicant in custody for an indefinite period".

NEW DELHI: Chief Justice of India Sanjiv Khanna on Wednesday said the judiciary, unlike other arms of the state, was unique as it connected directly to the citizens, providing them with an easy access to raise grievances that were even against the state and the law.

The CJI was speaking at an event titled "Celebrating 75 Years of the Constitution of India" organised by the Supreme Court Advocates-on-Record Association (SCAORA).

"The second aspect which came to my mind was as to what makes the judiciary unique. The legislators are elected by the people. They are representative of the people. They are a handful. The executive, political executive is in a parliamentary democracy, is answerable to Parliament or the legislature," he said.

The CJI added, "What makes the judiciary unique is our direct connect with the people... The



most easy access which the people have is the access to the judiciary in any of the three institutions." It was the judiciary, he said, where anybody could raise any grievance and ask for explanation, even against the state and citizens could approach the courts challenging the constitutional vires of the legislation.

"You can ask for the enforcement of constitutional rights, statutory rights, and it is so easy to walk into any court, engage a lawyer, engage or even argue in person. That means we are the ones who are directly associating ourselves with the citizens," he added.

For the CJI, the judiciary did not mean only judges as it included the bar as well.

"I was just wondering today, when we talk about the judiciary, the first thing which comes to the mind of most people is the judges. But the judiciary is not about the judges. When we refer to the

well as the bar. Without the bar, there cannot be the judiciary," he said. The CJI lauded the SCAORA

for launching its e-journal, its revamped website and congratulated the bar body for celebrating significant milestones such as 75 years of Indian constitution and recognising advocates on record for their 50 years of contribution to the bar.

"I hope this SCAORA e-journal will one day become the journal wherein you will have critical analysis of Indian jurisprudence, Indian legal thought, Indian judgements, and contribute worldwide for this," CJI Khanna said.

Aside from the CJI, Justices B R Gavai, Surya Kant and Abhay S Oka also addressed the gathering.


need to read and revisit Ibn Arabi because we are ever in need of knowing the Self/the Real and the treasure of mercy that is the world, "the Breath of the Compassionate." We need to know him better and revisit the archives hiding his dense, evocative, multifaceted and profound elaboration of the depths of Islamic and spiritual universe of meanings. His works are arguably the deepest and densest explorations of varied dimensions of the Islamic Tradition.

Though an exponent of mystical unveiling he appropriates the religion of reason of Late Antiquity and builds one of the most imposing "systems" of thought, at once rational, mystical and religious directed towards attaining the supreme aim of eudaimonia, sa'âda which has been the prerogative of traditional philosophies. religions and wisdom traditions of the world. He is, self avowedly, the heir of the prophetic and mystical wisdom it appears that God hid nothing from him - as it has been remarked about Meister Eckhart - and he is undoubtedly unrivalled in unpacking multidimensional meanings and significance of Islamic tradition. Combining in himself all the traditionally recognized paths to the Ultimate Reality - mysticism, philosophy, poetry and religion - he is a man of all seasons representing Islam's multidimensional - theological, mystical, metaphysical and aesthetical - genius and is, arguably, the medieval Islam's greatest contribution to the world.

Several studies engaging with Ibn Arabi vis-avis major modern and postmodern thinkers have been published and well received and it can be said that from Nietzsche and Heidegger to Derrida and Levinas and major theologians, writers and contributors to interfaith dialogue and many wide ranging debates on nihilism, mysticism and the Sacred invoke or respond to certain of his insights. Ibn Arabi is with us, with influential writers (from Gibran to Pamuk) of the world, with major metaphysicians including Guenon and Schuon, with major Muslim thinkers down to Shah Waliullah, Mullla Sadra, Iqbal, Nasr and Soroush, with Muslim scholars down to great names in

almost all great names in Sufism and Sufi poetry and in Pakistan such influential literary critics as Askari and Saleem Ahmed or Sufi authorities such as Pir Mehr Ali Shah are all influenced by Ibn Arabi, The culture of Islam post-Ibn Arabi is deeply coloured by his work and legacy. Islam and Culture literacy requires knowing Ibn Arabi.

sibility of receiving grace, of seeing everything as a theophany and every event as a message from the "other world." This may be a possible path out of the absurdist nihilist impasse that has been a key problem to be overcome for almost all great post-Nietzschean writers and philosophers. He quotes a prophetic tradition stating that if you let down a bucket by a rope verily it descends to



Ibn Arabi has no peer in simultaneous subtlety, breadth, width, magnificence, penetrating power, brilliance and encyclopedic scholarship and prolific contributions. Test your mettle by reading him and engaging with him. There are pygmies who think they have refuted Plato or Aristotle without even trying to read them or engaging with their great legacy that has shaped our culture and tools they have formulated to analyse things. The same is true about most modern rejecters of Ibn Arabi.

ibn Arabi is to be treasured for opening up a window to experience the Real and inviting us to see through. He illuminates, as none else, the question of Being. In an age when gods are said to have fled, as Heidegger and others complained, revisiting Ibn Arabi may mean the pos-

Allah. He remarks also that "When the creature is in distress, Allah also is in distress, insofar as His Hisness pervades His creation." He remarks in the chapter "Bezel of Sulayman" in his Bezels of Wisdom that "Complete ignorance of Allah is sure knowledge of Allah. The name is Allah in every case.

Some fear Ibn Arabi, some find him obscure or difficult and some think he was misguided. In order to see the merit in these assessments, we need to read him in original/translations and a selection from over 100 traditional commentators and at least one or two standard biographies. For Kashmiris who revere Syed Ali Hamadani, his debt to the Greatest Master and his work on his Fusoos is important. Ayatullah Khomeni had such that work to the USSR president Gurbachev and expressed his disagreement with Dawood Qaysari for seeking to explain away or interpret (ta w l) of some statements in Fusoos as the former for him is a sort of revelation as Ibn Arabi himself claimed to have received it from the Prophet (S.A.W). Izatsu in his Sufism and Taoism and Chittick in his magisterial works have done much to make him more accessible. To read him only through the eyes of a minority of theological critics is like forfeiting the opportunity to travel in the airplane on the advice of those who have primarily travelled only through land transport. To accuse him of misguidance in general involves a compliment if one reads it at ontological plane as Ibn Arabi would invite us to.

However, to imply its pejorative meaning involves problematic privileging of someone who in turn may have been/may be accused of misreading the Master. It also presupposes one has a better understanding of such notions as guidance and better access to the secrets and mysteries and depths of Divine Names Al-Hadi (the Guide) and Al-Mudhill (Who leads astray). One needs to have travelled on a certain road to warn others about the merits or dangers of that road. Who can claim to have travelled better on the road on which Ibn Arabi has been travelling? Who has given us another Futoohat (which is one of the only three books that Allama Anwar Shah found he can't write better)? To avoid reading Ibn Arabi or miss him is to miss the adventure and joy of engaging with the most provocative, the most exciting, the most influential, the most commented upon, the most brilliant, the most informed mind in the last 800 years of Islamic history. It is also to miss arguably the best argument for Islam's universality, its most attractive aesthetic dimension, its most profound metaphysics, its deepest layers of meaning/symbolism and its love and mercy centric understanding.

It is also to miss arguably the best missionary Islam has produced who, according to Muhammad Hamidullah, one of the most successful missionaries of the twentieth century, best suits for introducing Islam to the European elite. It is also to accuse the vast majority of Muslim scholars down the ages of being duped by Ibn Arabi and failure to guard the Tradition in whose name they have been speaking. For the Urdu readers, Ahmed Javed and Suheyl Umar have translated from Persian a modern classic study of Ibn Arabi. The argument that people would be misled if we advocate reading Ibn Arabi no longer holds water as there is enough material that has misled

people in an age of misinformation and pseudo spirituality against which Ibn Arabi is arguably one of the best antidotes.

Anyway Ibn Arabi has ample resources to ward off those not capable of breaking hard nuts. He is also an oasis in the desert of nihilistic currents in the post-Nietzschean age. Charging today Ibn Arabi with pantheism, hulool, suspension of ethic or shariah or deliberately ignoring understanding/ hermeneutical tools of salaf is inexcusable given the great mass of Ibn Arabi scholarship today that has satisfactorily explained the charges. Few are



Several studies engaging with Ibn Arabi vis-a-vis major modern and postmodern thinkers have been published and well received and it can be said that from Nietzsche and Heidegger to Derrida and Levinas and major theologians, writers and contributors to interfaith dialogue and many wide ranging debates on nihilism, mysticism and the Sacred invoke or respond to certain of his insights....



informed about his "spiritual literalism": i.e., "his constant insistence on the ultimate coincidence (not simply in outward formulation) between theprecise, revealed literal formulations of the Koran or hadith and their essential spiritual truth and intentions as realized and verified by the saint." and his "usual favorable view of the unquestioning, implicit faith of the common believer, and his corresponding distrust of all contrived intellectualist "interpretations" (ta'wil)." Today he would have endorsed Qardawi's proposal that (genuine) Sufis should become/are Salafis and (genuine) Salafis Sufis.

Muslims and the Eclipse of Knowledge: Rekindling Intellectual and Spiritual Illumination

"The Quran repeatedly urges deep contemplation (tadabbur), empirical observation (tafakkur), and the pursuit of knowledge (ilm).

The intellectual and spiritual legacy of the Muslim world stands as one of the most brilliant and transformative forces in human history, shaped by centuries of inquiry, discovery, and synthesis of diverse knowledge traditions. At its zenith, the Islamic intellectual tradition was not only a beacon of spiritual enlightenment but also a formidable force in the advancement of philosophy, science, law, and ethics. The early Muslim world flourished because knowledge was not seen as a compartmentalized or purely utilitarian pursuit but as an integral part of divine purpose.

The Qur'anic injunctions that command reflection, critical thinking, and the pursuit of wisdom created an ethos in which scholarship was not confined to religious exegesis but extended into the natural and social sciences. Rooted in a tradition that once harmonized rigorous inquiry with profound spirituality, it gave rise to groundbreaking advancements in science, philosophy, mathematics, medicine, and the arts. This understanding produced towering figures with influene across. A new Renaissance requires a synthesis of classical wisdom and contemporary insights, leading to a revival of intellectual and spiritual illumination.

Historical facts and instructive examples regarding muslims and eclipse of knowledge throughout history, $the\,intellectual\,and\,spiritual\,legacy\,of\,muslims\,flourished$ through an unbroken chain of scholars, scientists, and mystics who harmonized reason, empirical enquiry and revelation. From the Abbasid Golden Age to the intellectual circles of Andalusia, The House of Wisdom in Baghdad, the academies of Muslim Spain, and the scientific and philosophical vibrancy of the Ottoman, Safavid, and Mughal periods all bore testimony to a culture that saw learning as a sacred imperative. Muslim where polymaths like Al-Farabi, Ibn Sina, Al-Khwarizmi, Al-Biruni, Ibn Khaldun, Al-Ghazali and Ibn Rushd not only preserved the knowledge inherited from Greek, Roman, Persian, and Indian traditions but also but critically engaged with, refined, expanded and integrated into an evolving body of wisdom. It was this dynamic engagement with diverse intellectual traditions that positioned the Islamic world as the vanguard of human civilization. Their contributions laid the foundations for the European Renaissance and modern scientific thought. Muslim Spain's Al-Andalus illuminated Europe through scholars like Ibn Hazm and Ibn Arabi, while Fatimid Cairo's Al-Azhar nurtured intellectual rigor.

This luminous era was not the product of isolated genius but of a civilization-wide commitment to the pursuit of knowledge as a sacred duty, where theologians, scientists, and philosophers engaged in rigorous intellectual exchange without artificial barriers between the sacred and the secular. However, the forces that led to its stagnation and decline have been multifaceted, encompassing both internal failures and external disruptions, resulting in an epistemic inertia that continues to shape contemporary Muslim societies. Rather than retreating into nostalgia for past glories, the Muslim world must critically examine its current condition and seek inspiration from its own intellectual heritage while engaging with contemporary advancements.

Annemarie Schimmel notes that," Notto recall over and again the goden age of Islam but to ask for what reasons Muslims have created these great works of art and science, would help mould the future destiny of the community. This echoes with, 'The revival of Muslim intellectual culture requires not nostalgia for the past but a critical engagement with the present to reimagine the future." as held by Ziauddin Sardar in "Islam, Postmodernism and Other Futures and "The ultimate aim of religious thought in Islam is to reconstruct the foundations of knowledge so that faith and reason are

in harmony, not conflict." by Iqbal in "Reconstruction".

However, despite this illustrious past, the contemporary Muslim world faces an intellectual and epistemic crisis, marked by the erosion of critical thought, a disconnect between scientific progress and spiritual wisdom, and a growing dependence on borrowed paradigms. In the face of these challenges, rekindling the lost intellectual and spiritual light of Islam is not just an academic pursuit but a civilizational imperative. This humble attempt critically examines the factors that led to this decline, the consequences of knowledge stagnation, and the possibilities for intellectual resurgence by synthesizing authentic sources, rare historical insights, and the latest data from across cultures, traditions, and periods.

The decline was neither sudden nor uniform; it resulted from a confluence of historical events, the Mongol invasions, which led to the destruction of centers of learning such as Baghdad, dealt a severe blow

to intellectual life. Colonial subjugation, socio-political stagnation, economic crises, fragmentation of knowledge, internal stagnation, intellectual rigidity & taqlid (blind imitation), and a loss of the very ethos that once made knowledge sacred and a growing estrangement between religious thought and scientific inquiry. European colonial rule disrupted indigenous systems of education, replacing them with institutions that often undermined traditional scholarship. The shift from dynamic intellectual engagement to a more rigid, dogmatic approach within certain circles also contributed to this stagnation. Critical reasoning, once the hallmark of Islamic thought, was often supplanted by rote learning, diminishing the once-thriving culture of ijtihad (independent reasoning). The resulting crisis of knowledge

manifested in a deepening disconnect between tradition and modernity, faith and reason, and spirituality and empirical inquiry.

Despite this decline, efforts to rekindle the intellectual and spiritual light of the Muslim world persist. History shows that declining civilizations revive through knowledge. The European Renaissance (14th–17th c.), Meiji Restoration (1868–1912), Jewish intellectual resurgence (19th–20th c.), China's Self-Strengthening Movement (1861–1895), and India's colonial-era revival (19th–20th c.) all blended tradition with progress. For Muslims, rekindling ilm demands educational reform, critical inquiry, and institutional renewal-bridging heritage with modern adaptability. Leading thinkers and reformers have continually called for a revival that bridges the

conservatism. Franz Rosenthal emphasized that the Islamic world once led in scientific and philosophical advancements but lost momentum due to waning intellectual curiosity and estrangement from empirical inquiry. Bernard Lewis pointed to economic and political crises but also a reluctance to embrace modernity while preserving Islamic values. W.C. Smith stressed the need for a revival that harmonizes spiritual depth with dynamic intellectual engagement. George Makdisi noted the weakening of educational institutions, while Hodgson and Grunebaum urged rediscovering Islam's pluralistic intellectual heritage. A revival demands a fusion of rationalism and spirituality, ethical governance, decolonization of knowledge, and interdisciplinary learning, ensuring that ilm (knowledge) once again

The contributors follow Esposito's lead, stressing the profound commonalities among religions and replacing Orientalist discourse with holistic analyses of the complex historical phenomena that affect developments in all societies.

In the subontinent and aross the borders of Islamic world Shah Waliullah emphasized ijtihad and synthesis of reason with revelation to counter stagnation and advocay for soial and political reform to inspire ontemporary Islamic thought and reformist movement. Sir Sved championed scientific inquiry and modern education to uplift Muslims. Shibli Nomani and Sulaiman Nadwi called for holistic Islamic scholarship beyond jurisprudence. Hali lamented decline in Musaddas but urged moral and intellectual revival. Muhammad Abduh denounced taglid, advocating reason and reform. Iqbal stressed khudi and ijtihad to merge spirituality with modern thought. Abul Kalam Azad saw knowledge as Islam's soul, urging inquiry and wisdom. Prof. Mujeeb highlighted colonial disruption of Muslim education, while Khawaja Abdul Wahid sought an integrated curriculum.Muhammad Asad critiqued blind imitation and stressed Islam's dynamic adaptability. Fazlur Rahman called for a contextual, dynamic reinterpretation of Islamic thought to bridge classical wisdom with modernity. Ismail Raji al-Faruqi emphasized tawhid as a foundation for intellectual revival. Syed Hossein Nasr warns against scientism and urges the revival of a spiritually grounded knowledge tradition. Malik Bennabi diagnosed colonizability, highlighting intellectual stagnation and the need for self-renewal. Their shared vision calls for reviving ilm through reason, education, and renewal. While as Abdolkarim Soroush's seminal work, "Reason, Freedom, and Democracy in Islam: Essential Writings of 'Abdolkarim Soroush" advocates for evolving religious knowledge, intellectual freedom, and a balance between tradition and modernity. He challenges authoritarianism, promotes pluralism, and urges critical inquiry. By harmonizing reason and spirituality, he envisions rekindling knowledge and enlightenment in the Muslim world.

The Forest Rights Act, 2006, was implemented in Jammu and Kashmir in 2019 following the abrogation of Article 370.

Of the 65,497.21 kanals of forest land distributed by the J&K government, 784.19 kanals were allocated to other traditional forest dwellers (OTFDs), officials added.

These lands were granted under 4,803 cases, comprising 430 individual forest rights (IFR), 4,277 community forest rights (CFR) and 96 community forest rights.

Among the 6,020 land titles issued to ST families in the Jammu region received the majority, they received the highest 5,195 land titles were issued in 10 districts of the region, they said.



SRINAGAR: Renowned Kashmiri filmmaker Dr. Aijaz Ahmad Khan's latest documentary, Deodar – Roots of Paradise, has been officially selected for screening at the Eastern's Green Frog Film Festival 2025, set to be held at Eastern Connecticut State University, USA, on April 12.

The film also links deforestation to natural disasters, including the 2014 Kashmir floods, which were exacerbated by large-scale tree cutting and soil erosion.

Speaking on the film's selection, Dr. Aijaz Ahmad Khan said, "Deodar is more than a film; it's a movement to awaken people to the urgent need for forest conservation. The world needs to see what we stand to lose if we don't act now."

The documentary also highlights conservation efforts by the J&K Forest Department, which has planted over five lakh Deodar saplings annually and restored 15,000 hectares of degraded forests under various government initiatives.

AHMEDABAD: India middle-order mainstay and Punjab Kings' captain Shreyas Iyer continues to "evolve his game" while "adjusting brilliantly" to challenges such as facing short balls, believes New Zealand stalwart Kane Williamson.

Iyer began his captaincy stint for PBKS with a matchwinning 97 not out, studded with nine sixes and five fours off 42 balls, against Gujarat Titans in their IPL clash here on Tuesday.

Williamson, a former Gujarat Titans player, heaped praise on the right-handed Iyer for his adaptability.

"What stands out about Shreyas is how he continues to evolve his game," said JioStar expert Williamson.

"For a period, teams targeted him with short balls, but now, he's adjusting brilliantly -- getting deeper in his crease, de-weighting his front leg, and dominating the short-pitched deliveries.

"What is most impressive is his ability to shift his weight forward again, making it difficult for bowlers who try the 'one-two' approach — going short, then full. He's now able to access all areas of the ground, which makes him such a formidable batter," Williamson added.

The New Zealand batting great termed Iyer's knock of 97 not out of "highest standard".

"It was a knock of the highest standard. From the very first ball, it was almost a highlight reel—he played the ball exactly where it was meant to be hit," he said.

"Anything outside off stump, he looked to access the $off side, and \,he\,even\,struck\,sixes\,over\,cover\,against\,some\,of$ the best seamers in the world. Then, to take on Rashid Khan as well—that's one of the toughest challenges in the game.


"As a leader, to step in at No 3, set the tone, and take on the opposition's biggest threats was remarkable. That innings was truly out of this world," Williamson added.

The Kiwi batter also praised Shashank Singh for his whirlwind knock of 44 not out off only 16 balls, which pushed PBKS' total beyond the reach of the Titans.


