

NEW DELHI: The Lok Sabha early Thursday passed the contentious Waqf (Amendment)Bill, 2025, after over a 12-hour debate, which saw the ruling NDA strongly defending the legislation as beneficial for minorities, while the opposition described it as "anti-Muslim".

The Bill was passed after all amendments moved by the opposition members were rejected by voice votes. It was passed after a division of votes - 288 in favour and 232 against.

In his reply to the debate, Union Minorities Affairs Minister Kiren Rijiju said there is no place in the world safer than India for minorities and they are safe because the majority is entirely secular.

He said even a minuscule minority community like the Parsis are safe in India and all minorities here live with pride.





minorities are not safe in India. This statement is completely false. There is no place safer than India for minorities. I am also a minority and we all are living here without any fear and with pride," he Sri Lanka. said after the debate on the Bill.

The minister said whenever a minority community faces persecution, it always

comes to India to take refuge and cited the examples of the Dalai Lama and the Tibetan community, minorities of Pakistan, Bangladesh, Afghanistan, Myanmar and

"Minorities of Bangladesh, Pakistan and Afghanistan came to India after facing religious persecution in their respective

countries. How can you say that minorities are not safe in India. Very, very wrong to say this.

"The coming generation will never forgive you. Minorities in India are safe because the majorities of the country are fully secular. This is not the case in Pakistan. Bangladesh and Afghanistan. But still, you abuse us," he said.

Rijiju said, through the Bill, the NDA government is going to unify all minorities in the country. He also highlighted the "wholehearted" support of the Christian community for the Bill.He said a large number of disputes are pending with the Waqf tribunals and through the legislation, the government wants to expedite these cases."We want to expedite the resolution of the disputes in the tribunals. Justice delayed is justice denied. Widows, divorcees, and orphans will be given justice through the Bill," he said.

Amit Shah to visit J&K for three days from April 6



'Adding insult to injury': Cong on LS confirmation of President's rule in Manipur

NEW DELHI: The Congress on Thursday accused the government of "bulldozing" in the Lok Sabha the statutory resolution confirming the imposition of President's rule in Manipur, and said this was "adding insult to injury".

Taking a swipe at Prime Minister Narendra Modi, Congress general secretary in-charge communications Jairam Ramesh said the "frequent flier flies off again".

"This time it is to Bangkok. Look East by all means but why continue to ignore Manipur?" Ramesh said on X.

"And why bulldoze the proclamation on President's Rule in the state at 2AM this morning in the Lok Sabha, leaving just an hour for debate and discussion but just about enough time for the Home Minister's falsehoods, twists, and distortions? This is adding insult to injury," the Congress leader said.

Ramesh's remarks came after the Lok Sabha early Thursday adopted a Statutory Resolution confirming the imposition of President's rule in Manipur.

Replying to a short debate, Union Home



Minister Amit Shah said the government has taken all possible steps to bring back normalcy in the restive northeastern state.

He said there has been no violence in Manipur in the last four months, adding that talks were on with both Meitei and Kuki communities for a peaceful solution.

"By and large the situation is peaceful. As long in the 1990s, over 100 people died. Neither the as people are in camps, I would not say the situation is satisfactory. The government is taking all possible steps to restore peace in Manipur," he said.

The home minister said the ethnic violence in Manipur had started following an order of the state's high court.

"The day the order came, we sent the central forces by air. There was no delay on our part (in taking action)," he said.

He said, so far, 260 people have died in the violence that started in May 2023 and 80 per cent of them lost their lives within the first month.

Shah said he did not want to compare the violence that had taken place during the tenure of the previous governments but wanted to tell the House about the clashes between the Naga and Kuki communities that took place in the 1990s over five years. "Sporadic violence continued for a decade where 750 people lost their lives. There were Kuki-Paite clashes in 1997-98 when 352 people were killed. In the Meitei-Pangal clashes

then prime minister nor the then home minister visited Manipur," he said.

The home minister also said an impression has been given that violence erupted only during the BJP rule, which is not correct.

Earlier, participating in the debate, Congress leader Shashi Tharoor said his party supported the resolution but wanted the restoration of peace and stability in the state.

"End insurgency, restore peace and stability, promote dialogue with each other, promote inclusivity," he said.

The resolution 'Consideration on the Proclamation issued by the President on the 13th February 2025 under article 356(1) of the Constitution in relation to the State of Manipur' was adopted by the House by a voice vote. The violence started after a 'Tribal Solidarity March' was organised against the high court order. There have been many efforts from the central government to bring the warring communities to the negotiating table.

Kharge Says Anurag Thakur's Remarks Damaged His Reputation, Seeks His Resignation

NEW DELHI: The Leader of Opposition in the Rajya Sabha, Mallikarjun Kharge, on Thursday termed the allegations levelled against him by Anurag Thakur in the Lok Sabha baseless, saying the remarks damaged his reputation as he dared the BJP MP to prove them or else resign.

Raising the issue during Zero Hour in the Rajya Sabha, the Congress president said the BJP MP was compelled to withdraw his defamatory remarks made during the debate on the Waqf Bill in the Lower House.

"But the damage has been done," Kharge said. He also sought an apology from Thakur as well as the Leader of the House in Rajya Sabha, J P Nadda, over the issue.

"Yesterday, Anurag Thakur hurled completely false and baseless charges at me in the Lok Sabha. When my colleagues challenged him, he was compelled to withdraw his defamatory remarks. But the damage has been done," Kharge said.

The Congress chief, however, said despite the withdrawal of the remarks, the same did the rounds on media and social media platforms.

Rahul Gandhi Slams Govt Over 'China **Occupying Land', US Tariff Issue; BJP Hits Back**

NEW DELHI: Leader of Opposition Rahul Gandhi on Thursday claimed that China had taken over 4,000 square kilometre of Indian territory and that reciprocal tariffs or import duties imposed by the US would "completely devastate" the Indian economy, as he demanded answers from the government over these issues.

The BJP hit back at Gandhi over his remarks during the Zero Hour in the Lok Sabha, saying "not an inch of land" had been given to China under BIP rule and it was under Congress rule that China had occupied Indian territory.

The ruling party also said it is the country's good fortune that the PM of this country is Narendra Modi before whom the world bows.

Speaking during the Zero Hour, Gandhi slammed the government over the celebration of the 75th anniversary of diplomatic ties by India and China.

"China is sitting on 4,000 square kilometre of our territory. I was shocked some time back to see that our foreign secretary (Vikram

NEW DELHI: Congress Parliamentary tribes and OBC communities. Party chairperson Sonia Gandhi on Thursday termed the Waqf (Amendment) Bill as a "brazen assault" on the Constitution, saying it was part of the BJP's strategy to keep society in a state of "permanent polarisation".

Hours after the Lok Sabha passed the Wagf amendment bill, Gandhi said the bill was "bulldozed" through in the lower house. Addressing party MPs at a meeting of the Congress Parliamentary Party in Samvidhan Sadan here, she also said that the One Nation, One Election Bill is another subversion of the Constitution and the party would strongly oppose it.

"Yesterday, the Wakf Amendment Bill, 2024 was passed in the Lok Sabha and today it is scheduled to come up in the Rajya Sabha. The bill was in effect bulldozed through. Our party's position is clear. The Bill is a brazen assault on the Constitution itself. It is very much part of the BJP's deliberate strategy to keep our society in a state of permanent polarization," Gandhi said.

The Lok Sabha passed the Waqf (Amendment) Bill well past midnight after a 12-hour debate. The Bill was passed after all amendments moved by the opposition members were rejected by voice votes. It was passed after division of votes - 288 in favour and 232 against. The Bill will now come up in the Rajya Sabha on Thursday.

The former Congress president also said their plea for the immediate implementation of the women's reservation bill passed by both Houses two years back continues to be wilfully ignored along with the other demand for one-third reservation for women belonging to scheduled castes, scheduled

for what is right and just, to expose Modi government's failing and intention to turn India into a surveillance state," Gandhi told MPs at the meeting.

All party MPs, including Congress president Mallikarjun Kharge and Leader of Opposition in Lok Sabha Rahul Gandhi, were present at the meeting.

Gandhi also said they have repeatedly been raising the issue of free and fair elections and the need for Parliament to debate the functioning of the Election Commission and its "opaque" rules and procedures, some of which are presently under challenge in the Supreme Court.

Targeting the prime minister, she accused

him of rebranding, repackaging and marketing numerous initiatives taken during 2004-2014 as his own personal accomplishments.

That too needs to be exposed through our own public outreach activities, she asserted.

Speaking on the functioning of both houses of Parliament, she charged that the Leaders of Opposition are not allowed to speak and the treasury benches are often found to be creating disturbance in a bid to not allow the Congress to raise their issues.

"It is a matter of grave concern to our democracy that the LoP in the Lok Sabha is not permitted to speak. Similarly, time and again, the LoP in the Rajya Sabha, Khargeji is also not allowed to say what he wants to say and indeed must say.


"Like you, I have been witness to how the House gets adjourned not because of us but because of the protests by the treasury benches themselves. This is quite extraordinary and shocking designed to prevent the Opposition from raising their concerns that would put the government on the spot," she noted.

Noting that the BJP members aggressively target Congress-ruled state governments, with "total falsehoods", she urged party MPs to be equally aggressive and raise the failures and mis-governance in BJP-ruled states. This will mean much more pointed homework and research on our part, she noted.

Bandipora Police Arrests Youth for Glorifying Separatist Leaders on Social Media

BANDIPORA: Bandipora Police have booked and arrested a person for allegedly glorifying Mohammad Yasin Malik, head of the banned outfit Jammu and Kashmir Liberation Front (JKLF), and other separatist leaders on social media.

An official spokesperson of the Bandipora Police said during routine cyber surveillance and patrolling, the police identified a social media account posting content that promoted militancy and extremist ideologies. The accused, identified as Sajad Naseer Bhat alias Sahil, son of Naseer Ahmad Bhat, a resident of Naidkhai Sumbal, had reportedly uploaded images of Yasin Malik and other separatist figures with the intent to disturb public order.

Following the discovery, police arrested the individual and registered a case under FIR No. 65/2025 at Police Station Sumbal under Section 152 of the Bharatiya Nyaya Sanhita (BNS) and Section 66 of the IT Act. "Further investigation into the matter is underway".

Bandipora Police have intensified monitoring of social media platforms to detect and take action against individuals engaged in spreading extremist content, inciting violence, or attempting to disrupt public order.



"Any attempt to glorify terrorism, promote secessionist ideologies, or spread misinformation against national integrity will be dealt with strictly under the law," a police spokesperson said.

The police have urged social media users to act responsibly and refrain from engaging in activities that violate legal and ethical norms. They have also warned that stringent legal action, including prosecution under relevant laws, will be taken against those misusing digital platforms for unlawful purposes.

Cyber Police Kashmir Cracks Down on 200 Social Media Handles Spreading Anti-National Propaganda

Srinagar: In a decisive crackdown on online anti-national propaganda, radicalization, and the glorification of terrorism, Cyber Police Kashmir has intensified its monitoring and enforcement efforts over the past three months. Adverse

social media handles operating across multiple platforms, including those managed from outside the country, have been identified and targeted through legal and preventive action. During this period, 200



adverse social media handles engaged in spreading misinformation and extremist content have been identified, with 100 of them operating from outside the country. Several of these accounts have been blocked to curb their influence, while legal action has been initiated against key propagators, including multiple FIRs under relevant criminal laws. Security proceedings have also been started against several individuals involved in such activities.

"This crackdown sends a strong message-cyberspace cannot be misused to spread anti-national propaganda or glorify terrorism. We are actively dismantling online ecosystems that pose a threat to security," Iftkhar Talib, SP Cyber Crime Kashmir told Kashmir Dot Com.

At the same time, Cyber Police Kashmir remains committed to counter-radicalization efforts. Many individuals influenced by such online propaganda have been counseled and handed over to their families as part of a de-radicalization initiative.



By spilling their story over the airwaves of the Radio station, they started jolting the sleeping public. It is bringing consciousness among the masses. The film 'Rang de Basanti' blurs the line between art and life, demonstrating that stories can inspire real-world action.

'Rang de Basanti' blends showmanship with soul-searching depth. It empowers us to question our place in the world by recasting patriotism as a fight, not a salute. Chief Secretary Atal Dulloo reviews draft J&K Hydro Power Policy 2025

JAMMU: Chief Secretary, Atal Dulloo, chaired a meeting held to review the draft Jammu and Kashmir Hydro Power Policy 2025, emphasising the Union Territory's significant potential in hydropower generation and its role in economic development.

The Chief Secretary highlighted the vast opportunities in the power sector, stating that Jammu and Kashmir possess immense potential for power generation which can substantially boost the region's economy. He also underscored the necessity of reducing power losses, noting that such inefficiencies constitute a substantial drain on resources.

The draft policy aims to attract the private investment in hydropower generation by revising the existing framework. It proposes categorising hydroelectric projects into two segments: Small Hydroelectric Projects (up to 25 MW) and Large Development Agency (JAKEDA) has been designated Hydroelectric Projects (above 25 MW and up

to 100 MW). The Jammu and Kashmir Energy the Jammu and Kashmir Power Development

Corporation Limited (JKPDCL) will oversee the projects above 10 MW.

The meeting was attended by Principal Secretary Power Development Department, H. Rajesh Prasad; Principal Secretary Finance, Santosh Dattatraya Vaidya; Managing Director JKPDCL, Pankaj Magotra and Managing Director, Jammu Power Distribution Corporation Limited (JPDCL) and JKPCL, Ch Mohd Yasin besides others.

The discussions focussed on finalising the policy framework to effectively harness the Jammu and Kashmir's hydropower potential, aiming to attract private investment and promote sustainable development in the region.

Israel-Palestine Conflict: What Lies Ahead?

The regional and global dynamics surrounding the Israeli-Palestinian conflict have shifted significantly in recent years, with normalization agreements, geopolitical rivalries, and competing national interests reshaping traditional alliances. While new opportunities for cooperation have emerged, these changes have also marginalized the Palestinian issue and complicated efforts to achieve a lasting resolution. Without renewed international engagement and a commitment to addressing the core grievances of Palestinians, the evolving regional order risks entrenching a status quo that perpetuates instability and undermines long-term peace prospects.

Israeli society remains deeply divided on the future of the conflict, with security concerns shaping much of the public discourse. Decades of violence, military operations, and waves of terrorism have instilled a sense of caution and skepticism among many Israelis regarding the prospect of a peaceful resolution. For a significant portion of the population, security remains the top priority, and any agreement that involves territorial concessions is viewed with suspicion. The fear of rocket attacks from Gaza, the potential for renewed violence in the West Bank, and the influence of regional actors such as Iran contribute to a national mindset

generation. Without significant political leadership that can offer a vision for the future, the cycle of mistrust and hostility is likely to persist. However, the resilience of grassroots initiatives suggests that there is still a foundation upon which a future peace could be built. The challenge lies in expanding these efforts beyond the margins and integrating them into a broader political framework that can create meaningful change.

A two-state solution remains the most widely endorsed framework for resolving the Israeli-Palestinian conflict, yet its feasibility appears increasingly distant. For this scenario to materialize, significant political will, domestic consensus, and international support would be required to address the core issues that have plagued past negotiations. Key questions surrounding borders, security arrangements, the status of Jerusalem, and the fate of Israeli settlements in the West Bank would need to be resolved through mutual compromise. A viable two-state solution would involve establishing an independent Palestinian state alongside Israel, with secure and recognized borders. East Jerusalem would likely need to serve as the capital of a future Palestinian state, while arrangements ensuring security for both sides would need to be implemented and enforced over the long term. However, achieving such an agreement would require overcoming deep mistrust, addressing internal political fragmentation among Palestinians, and navigating the growing influence of nationalist and religious factions within Israeli politics. Without strong leadership capable of mobilizing public support and making difficult concessions, the prospect of a two-state solution will remain an elusive ideal. In the absence of political breakthroughs, the status quo of occupation, settlement expansion, and periodic violence is likely

to peace. This scenario envisions continued Israeli control over Palestinian territories without any meaningful progress toward Palestinian statehood. Israeli settlement expansion in the West Bank would continue, further eroding the territorial contiguity necessary for a viable Palestinian state. The division between the Palestinian Authority in the West Bank and Hamas in Gaza would remain unresolved, perpetuating internal Palestinian disunity and weakening the Palestinian national movement. Periodic flare-ups of violence, whether sparked by clashes in Jerusalem or military confrontations in Gaza, would continue to destabilize the region and exacerbate humanitarian suffering. The longer this stalemate endures, the more entrenched the existing power dynamics become, making it increasingly difficult to reverse course. Over time, this reality risks deepening resentment and despair among Palestinians, fueling extremism, and increasing the likelihood of sporadic violence that could spiral out of control.

As settlement expansion continues and the possibility of a two-state solution diminishes, the prospect of a one-state reality becomes more likely. In this scenario, Israel would maintain control over the West Bank and Gaza without granting Palestinians equal rights, leading to accusations of apartheid and growing international condemnation. The continued denial of political rights to millions of Palestinians under Israeli control would raise profound ethical and legal questions, intensifying pressure from the international community to address the inherent inequalities of such an arrangement. Alternatively, a one-state framework based on equal rights for all residents, regardless of ethnicity or religion, could emerge as a potential solution. However, this approach would fundamentally challenge the notion of Israel as a Jewish state, as granting equal

other side, making reconciliation more difficult with each passing to persist, leading to a prolonged stalemate with no clear path hatred and dehumanization. Through initiatives that focus on joint projects, cultural exchanges, and community engagement, these efforts create opportunities for ordinary people to see each other as partners rather than enemies. While these grassroots movements may not generate immediate political change, they lay the foundation for a future where mutual respect and understanding can replace animosity and fear.

Economic cooperation between Israelis and Palestinians presents another avenue for fostering peace and stability. Joint ventures in sectors such as technology, agriculture, and renewable energy have the potential to create shared economic interests that benefit both communities. Economic interdependence can reduce incentives for violence by demonstrating the tangible benefits of cooperation. For example, initiatives that provide Palestinian workers with access to the Israeli labor market or projects that facilitate cross-border trade can help alleviate poverty and improve living standards in Palestinian communities. Additionally, investment in Palestinian infrastructure and economic development can empower local communities and provide alternatives to extremism. However, while economic cooperation is an important tool for building trust and stability, it cannot serve as a substitute for addressing the core political issues at the heart of the conflict. Economic growth and development must be accompanied by a genuine commitment to resolving the political disputes that fuel the conflict, including issues related to borders, security, settlements, and the status of Jerusalem. Without meaningful progress on these fronts, economic cooperation alone will not be sufficient to create lasting peace.

Education plays a critical role in shaping attitudes toward the conflict and building a foundation for long-term peace. Efforts to promote coexistence, tolerance, and mutual understanding in schools can help break the cycle of hatred and mistrust that has persisted for generations. Educational programs that encourage critical thinking, empathy, and an understanding of multiple narratives can challenge deeply ingrained stereotypes and foster a culture of peace. Schools that expose young Israelis and Palestinians to each other's histories, cultures, and perspectives can help cultivate a sense of shared humanity and reduce the appeal of extremist ideologies. Moreover, empowering young people with the tools to engage in dialogue and advocate for peace can create a new generation of leaders committed to reconciliation. Programs that facilitate exchanges between Israeli and Palestinian students, as well as initiatives that promote joint learning and collaborative problem-solving, can contribute to a more open and tolerant society. However, these efforts must be supported by broader societal and political changes that create an environment conducive to peace. Without a supportive political climate and a genuine commitment to addressing the structural inequalities that perpetuate the conflict, educational initiatives alone will struggle to achieve lasting impact.

In addition to fostering dialogue, promoting economic cooperation, and empowering future generations through education, international actors also have a crucial role to play in supporting peace and reconciliation efforts. The international community can provide the necessary political, financial, and diplomatic support to sustain grassroots initiatives, facilitate economic development, and promote educational reforms. Furthermore, international pressure on both sides to adhere to human rights standards, uphold international law, and engage in meaningful negotiations can create incentives for progress. However, external involvement must be balanced with respect for local agency and ownership of the peace process. Sustainable peace cannot be imposed from the outside; it must emerge from within the societies that are directly affected by the conflict.

Ultimately, the path to peace and reconciliation requires a

that prioritizes strength and deterrence over compromise. At the same time, there are segments of Israeli society that continue to advocate for peace and coexistence. Human rights organizations, peace activists, and left-leaning political groups emphasize the importance of dialogue and mutual recognition. However, these voices have become increasingly marginalized as Israeli politics shift to the right, and public sentiment favors policies that emphasize military deterrence over diplomatic engagement. The failure of past peace processes, combined with ongoing settlement expansion and military incursions, has led to widespread cynicism about the possibility of a diplomatic solution. For many, the idea of a two-state solution feels increasingly out of reach, and alternative approaches, including calls for a single democratic state or continued resistance, have gained traction. This disillusionment has also fueled support for grassroots resistance movements, as Palestinians seek to challenge the status quo through protests, civil disobedience, and international advocacy. However, the absence of a unified national strategy has limited the effectiveness of these efforts. The division between the Palestinian Authority in the West Bank and Hamas in Gaza has created political fragmentation that weakens the overall Palestinian struggle. Without a clear vision for the future and a leadership that can rally broad support, the Palestinian national movement remains in a state of paralysis, with no clear path forward. Despite the political deadlock, grassroots movements that promote dialogue and cooperation between Israelis and Palestinians continue to work toward building trust and understanding. Civil society organizations that focus on joint initiatives in education, culture, and economic development offer a glimmer of hope for fostering coexistence. These initiatives, which bring together individuals from both sides to engage in constructive dialogue, challenge stereotypes, and build relationships, demonstrate that people-to-people engagement can help break down barriers. Programs that facilitate business partnerships, educational exchanges, and cultural collaborations have the potential to create shared interests and economic incentives for peace. However, these efforts often face resistance from hardline factions on both sides. Nationalist and militant groups dismiss dialogue initiatives as ineffective or even harmful, arguing that engagement with the other side legitimizes occupation or terrorism. Many activists involved in grassroots peace efforts face social and political pressure, with some being accused of betraying their own people. In addition, the broader political and security environment limits the impact of these movements. When violence escalates, grassroots initiatives struggle to maintain momentum, as fear and hostility overshadow efforts at reconciliation. The lack of political backing for these initiatives also means that their influence remains limited, as they operate on the margins rather than shaping mainstream discourse. The societal perspectives on both sides of the conflict reveal a deep-seated distrust and a growing sense of hopelessness about the future. While some Israelis and Palestinians continue to work toward peace at the grassroots level, the overall trajectory of public sentiment points toward further entrenchment of existing divisions. In both societies, young people are growing up in environments that reinforce narratives of conflict rather than cooperation. Israeli youth are raised with a strong emphasis on national security and military service, while Palestinian youth experience the daily realities of occupation, restrictions on movement, and economic deprivation. These lived experiences shape attitudes toward the

Earlier, making an intervention in the debate, Union Home Minister Amit Shah asserted that a vote bank was being created by intimidating minorities and confusion being spread in the country in the name of the Waqf bill.

"The Narendra Modi government runs on a very clear principle that we will not bring any law for vote bank because law is for justice and welfare of people," he said, adding, "Everyone has the right to follow their religion, but conversion cannot be done for greed, temptation and fear."

He stressed that it has become a fashion to create fear among the people of the minority community.

"It is the resolve of the Modi government that no citizen of this country, irrespective of his religion, will be harmed," Shah said.

He said the non-Muslims in Waqf council and boards are meant purely to ensure the administration of properties in accordance with stated aims.

Shah said if there had not been an amendment in the Wakf Act in 2013, there would have been no need to bring this legislation.

"Elections were due in 2014 and in 2013, the extreme Wakf law was made overnight for the purpose of appeasement. As a result, 123 properties in Delhi's Lutyen's Zone were handed over to the Wakf just 25 days before the elections," he said.

He said a vote bank was being consolidated by intimidating minorities and confusion being spread to strike fear among minorities.

Earlier, there was no provision to include any non-Muslim among those who run religious institutions and the NDA government is not going to do it either, he said.

Congress MP Gaurav Gogoi said the INDIA bloc will oppose the proposed changes to the Waqf law and called the Bill an attack on the basic structure of the Constitution.

He accused the government of misleading Parliament, referencing past discussions on the matter.

"This Bill is an attack on the basic structure of our Constitution, an attack on our federal structure, and has four primary objectives: to dilute the Constitution, to defame minority communities, to divide Indian society, and to disenfranchise minorities," he alleged.

Samajwadi Party chief Akhilesh Yadav claimed that the Bill was a BJP ploy for polarisation following its reverses in the 2024 Lok Sabha polls. He claimed the Bill would send a wrong message to the world and dent the country's secular image.

The Bill will prove to be a "Waterloo" for the BJP as some of its allies might be claiming to support the legislation but inside they are not happy about it, he said.

Participating in the debate, AIMIM chief Asaduddin Owaisi staged a symbolic protest by tearing up a copy of the Bill.

Leader of Opposition in Lok Sabha Rahul Gandhi, in a post on X, called the Waqf Bill a weapon, aimed at marginalising Muslims and usurping their personal laws and property rights.

"This attack on the Constitution by the RSS, BJP and their allies is aimed at Muslims today but sets a precedent to target other communities in the future," he said.

According to the Waqf (Amendment) Bill, Waqf tribunals will be strengthened, a structured selection process will be maintained, and a tenure will be fixed to ensure efficient dispute resolution.

As per the Bill, while Waqf institutions

The Bill proposes that an officer above the rank of collector investigate government properties claimed as Waqf.

It also proposes that non-Muslim members be included in the central and state Waqf boards for inclusivity.

Govt raises

Speech on March 7, in which he announced a series of pro-poor initiatives, including the enhancement of marriage assistance for AAYcategory girls.

The revised scheme will take effect from April 1, 2025.

To ensure transparency and efficiency, the financial aid will be directly transferred to the beneficiary's bank account through the Direct Benefit Transfer (DBT) system before the marriage.

In another major welfare initiative, the J&K government has approved the distribution of additional food grains free of cost to AAY households with four or more members under the Public Distribution System (PDS).

This move aims to strengthen food security for the region's most vulnerable families and fulfills a key commitment made in Budget 2025-26.

Chief Minister Omar Abdullah hailed the initiative as a significant pro-people decision, emphasizing that the government is delivering on its promises. "We are committed to ensuring food security for our most vulnerable families. Under this initiative, all AAY households will receive additional food grains free of cost. Each beneficiary in a family with 4 or more members will get up to 10 kg of food grains, reinforcing our commitment to social welfare," he stated.

Furthering his Government's commitment to women's empowerment, the Chief Minister had also flagged off the Zero-Ticket Travel Initiative-a free Government bus service for women-on April 1 from the Sher-i-Kashmir International Convention Center (SKICC).

Speaking at the launch event, CM Omar Abdullah said, "This initiative will create an environment where women feel empowered to travel freely, without financial constraints. It marks another step towards ensuring gender equality and mobility for women across Jammu and Kashmir." The Omar Abdullah-led Government has fulfilled yet another promise by implementing Zero Stamp Duty on property transfers through Gift Deeds within blood relations. In this regard, the Government of Jammu and Kashmir has issued S.O. 75, dated 27th March 2025, under Section 9(a) of the Stamp Act, 1977, to remit Stamp Duty on such transfers.

The term "Blood Relations" includes parents, siblings, children, and grandparents. This notification has come into force w.e.f. 1st April 2025.

"This is not just assistance-it's our commitment to an inclusive and caring welfare state," Chief Minister Omar Abdullah stated.

Individuals below 60 years of age will now receive 1,250 per month, while those aged between 60

and 79 years will be entitled to 1,500 per month. Senior citizens 80 years and above will receive

a monthly pension of 2,000, ensuring better support for the elderly. As per the order, the government has announced

1,000), and widows 80 years and above will now receive 2,000.

Additionally, the Indira Gandhi National Disability Pension Scheme (IGNDPS) has been revised, with pensions for disabled individuals in the 18-59 years category raised to 1,250, those 60-79 years receiving 1,500, and those 80 years and above now receiving 2,000.

Furthermore, under the Integrated Social Security Scheme (ISSS), which is UT-funded, pension rates have been revised across multiple beneficiary groups. Old Age Pensions have been increased to 1,250

for females aged 55-60 years, 1,500 for those 60-79 years, and 2,000 for those aged 80 years and above.

Similarly, Widow/Divorcee Pensions have been enhanced to 1,250 for widows below 60 years with a legal marriageable age. 1.500 for those 60-79 years, and 2,000 for those 80 years and above.

The Disability Pension has been revised to 1,250 for those below 60 years, 1,500 for those 60-79 years, and 2,000 for those 80 years and above.

A similar structure applies to the Transgender Pension, ensuring increased financial assistance across all age categories.

J-K Chief Minister Omar Abdullah has convened a joint meeting of the coalition legislators in Srinagar on Friday where the issue is likely to be discussed.

"The chief minister has called for a joint legislative party meeting of coalition partners in Srinagar at 11 am tomorrow. The issue of transfers is likely to be discussed although the agenda for the meeting has not been conveyed so far.

"It would have been advisable for the LG to wait a while as the business rules are pending approval. The LG should have been more patient," Gulam Ahmed Mir, national general secretary of the Congress, said.

Mir, who also serves as the leader of the Congress Legislative Party (CLP) in the J-K Assembly, said the government has already proposed the business rules and forwarded them to New Delhi for approval. 'Taking such a step was not advisable," the

Congress leader said. According to the current business rules, Mir said, "transfer of local JKAS officers falls under

the chief minister's domain". "The previous rules stipulated that local JKAS

officers will be handled by the chief minister, while senior officers (IAS) will be transferred by the LG," Mir said.

Mir also said the LG's action, knowing that the business rules proposal is pending approval in Delhi, sent a wrong message about the state of affairs within the J-K administration.

"It has sent a wrong message that everything is not well (within the administration). The LG knew it well that the proposal for business rules is under consideration, yet he took this step," Mir said.

Union Secretary

Earlier, in his presentation, Commissioner Secretary FCS&CA, Zubair Ahmad presented an overview of the functioning of the department with stress on new initiatives and issues flagged by Central Government.

He informed the Union Secretary that the Department is presently providing free and subsidised food grains to 24.76 lac households, comprising 98.81 lac beneficiaries in J&K. While 67 lac beneficiaries are provided free foodgrains every month under PMGKAY, another 31.75 lac beneficiaries are provided food grains at highly subsidised rate in NPHH group.

He also said that the distribution network across J&K is built around 6622 sale outlets and 6390 such outlets are presently working in an online mode. He added that Aadhaar authentication rate of 95% has been achieved in distribution process by now.

He also informed that after achieving 100% Aadhaar seeding, the Department has completed e-KYC of 87% beneficiaries under NFSA and 75% of beneficiaries in Non Priority Households group. He also apprised the Union Secretary that the department has started implementation of Route Optimization Plan in eight districts of J&K on trial basis and complete implementation across all the districts would commence in the month of June,2025.

The Union Secretary was also apprised about the status of implementation of SMART PDS in J&K.

Regarding One Nation-One Ration Card (ONORC), the Union Secretary was informed that till now 1.66 lakh interstate and 29.33 lakh intrastate transactions were made under NFSA alone, taking J&K to 9th position in the country.

Later, Sanjeev Chopra also visited Fair Price Shop at Jhajjar Kotli and interacted with the dealer and the beneficiaries. He advised the officers to undertake updation of mobile numbers of beneficiaries and also emphasized on enhancing the viability of FPSs.

Congress criticises

In a move seen by many as an attempt to take full control of the bureaucracy, the lieutenant governor (LG) ordered the transfer of 48 middle and lowerrung Jammu and Kashmir Administrative Service (JKAS) officers, including 14 additional deputy commissioners and 26 sub-divisional magistrates.

Chief Secretary Asks For Accelerated Execution Of National Highway Projects In J&K

JAMMU Chief Secretary, Atal Dulloo, chaired a high level meeting to assess progress on National Highway projects being executed across the Union Territory.

Emphasising the critical importance of these projects, he issued firm directives to ensure their timely completion while minimising public inconvenience.

The meeting was attended by senior officers including Principal Secretary Agriculture Production Department, Shailendra Kumar; Commissioner Secretary, Forest, Ecology & Environment, Sheetal Nanda; Secretary, Public Works (R&B), Bhupinder Kumar and Divisional Commissioner Jammu, Ramesh Kumar while other officers participated online.

Representatives from key agencies like the National Highways Authority of India (NHAI), National Highways and Infrastructure Development Corporation Limited (NHIDCL) and the Border Roads Organisation (BRO) were also present.

The Chief Secretary reviewed various National Highway projects, examining the individual packages, scheduled completion dates and current progress. He specifically instructed the NHAI to expedite project completion while ensuring that public inconvenience is minimised. "Delays are unacceptable. We must prioritise efficiency and public convenience in equal measure," he asserted.

The review encompassed critical infrastructure projects like Delhi-Amritsar-Katra (DAK) Expressway, four-laning of Banihal Bypass, Srinagar Ring Road, Jammu-Akhnoor National Highway, Chenani-Sudhmahadev Road, Khellani Bypass Tunnel and various projects under Project SAMPARK.

Dulloo scrutinised the physical and financial status of these



projects, emphasising added accountability and swift resolution of any impediments.

Addressing the challenges posed by the region's unique topography, the Chief Secretary emphasised the need for proactive planning. "Weather conditions and natural challenges must be anticipated and integrated into our project timelines to prevent unnecessary delays," he directed the officers.

In a move to prevent resource-related delays, the Chief Secretary directed Director Geology and Mining, Suraj Parkash Rukwal, to conduct field visits and ensure that mining activities do not hinder the project progress.

Furthermore, he discussed the forest clearance issues with Commissioner Secretary, Sheetal Nanda.

Officers from the Roads and Buildings (R&B) Department Kashmir and R&B Pir Panjal also presented updates on their respective projects.

The Chief Secretary also reviewed the progress on Detailed Project Reports (DPRs) and engaged with Deputy Commissioners to identify and address district-specific challenges, particularly those related to land acquisition. Exposure to difficult conditions helped evolution of my T20 batting: Sai Sudharsan

pener B Sai Sudharsan felt exposure to "difficult conditions" during his current stint with IPL side Gujarat Titans has contributed immensely to him evolving as a T20 batter.

Sudharsan played a fine innings of 49 against Royal Challengers Bengaluru in GT's eight-wicket win here on Wednesday night.

"It's my fourth year (in the IPL), so I feel it has given me a lot of experience. I got exposed to a few difficult conditions. I got exposed to a lot of fast bowling in the nets with GT," Sudharsan said in the post-match press meet.

"I feel the most important thing which has helped my evolution or the way I've improved my T20 batting is the game-time I get here and the practice time I get here with the Titans, with the bowlers, all quality international bowlers," he added.

Sudharsan now sits on the second place in the run-markers' chart with 186 runs. The left-hander has made those runs at an average of 62 and at a strike-rate of 158.

"So, I feel that has helped me even from the nets, I would say. I got exposed to a lot of things, a lot of difficult conditions.

"Tve learnt a lot in these three years. I feel it has helped me understand the game better and the basics of the game as well," he said. Flower rues early wickets

ujarat Titans senior batter Jos Buttler admitted that he was "embarrassed" at dropping Royal Challengers Bengaluru opener Phil Salt while keeping in their IPL match here, but he was able to make amends, using the long handle to help his side to an eightwicket win.

Buttler struck and imperious 73 not out off just 39 balls, with his innings marked by creativity and sustained aggression, as GT chased down the target of 170 in 17.5 overs on Wednesday.


GT captain Shubman Gill and Siraj were celebrating even before the ball had reached the keeper, only for Buttler to spill it.
