Amit Shah to arrive in Jammu today for 3-day J&K visit

Will chair Unified Headquarters meeting, visit frontier areas; inaugurate development projects

JAMMU: Union Home Minister Amit Shah would arrive in Jammu on Sunday for a three-day I&K visit aimed at assessing the region's security landscape and inaugurating key development

The visit, originally scheduled for April 7, has been advanced by a day, reflecting the urgency of addressing the evolving security situation in the Union Territory.

MLA Bahu, Vikram Randhawa told the news agency—Kashmir News Observer (KNO) that the Union Home Minister would arrive in the afternoon and would chair two high-level security review meetings and also a meeting of BJP leaders.

"The Home Minister is likely to chair a Unified Headquarters meeting, to evaluate counter-terrorism operations, border security, and infiltration challenges," sources said.

The security review meetings will be attended by Lieutenant Governor Manoj Sinha, top officials from the Ministry of Home Affairs, the Army,



paramilitary forces, Jammu and Kashmir Police, intelligence agencies, and senior civil administration

A key focus will be on strengthening strategies to ensure "zero infiltration" along the Line of Control (LoC) and International Border (IB), a directive Shah

has consistently emphasized in past reviews. "The Home Minister has been regularly reviewing the operations in J&K and has directed that the aim should be that of 'zero infiltration' at the Line of Control and International Border, while dismantling the network of overground workers who support infiltrated terrorists and the narco-network which funds their acts," said an official.

Shah's itinerary, as per KNO, includes a tour of forward areas along the International Border in Jammu to assess security arrangements firsthand and boost the morale of troops stationed there.

He is also expected to meet the families of police martyrs, paying tribute to their sacrifices amid recent encounters, such as the Kathua operation where four police personnel lost their lives combating infiltrating terrorists.

In addition to security-focused engagements, the Home Minister will virtually inaugurate and lay foundation stones for several major development projects across the Union Territory. He will also meet with BJP MLAs

J&K sees decline in child marriage cases over past three years

NEW DELHI: Jammu and Kashmir has seen a decline in child marriage cases in the country over the past three years, according to official data tabled in Parliament.

Despite the decline in numbers, the officials and rights groups urged government for regular vigilance, especially in rural pockets and conflict-affected areas where underreporting

According to data shared by the Ministry of Women and Child Development in the Lok Sabha on Friday, only



five cases were registered in Jammu and Kashmir under the Prohibition of Child Marriage Act (PCMA), 2006, between 2020 and 2022 - one in 2020, two each in 2021 and 2022.

With decline in numbers, the Union Territory of Jammu & Kashmir has been placed at 30th out of 36 states and union territories in terms of reported cases. The neighbouring Ladakh, meanwhile, recorded zero cases in this period.

The source of the data is the Crime in India report published annually by the National Crime

Passport processing drops from 89 to 10 days in Srinagar

SRINAGAR: The time taken to issue passports in Jammu and Kashmir has changed notably over the past five years, with recent years showing a trend

towards more consistent processing.

According to data of the Ministry of External Affairs accessed by the news agency-Kashmir News Observer (KNO), in Jammu, passport processing for normal applications took an average of 4 days in 2020. This figure increased sharply to

62 days in 2021. However, the timeline came down significantly to 6 days in 2022, and stabilized at 11 days in both 2023 and 2024. The data shows no separate Tatkaal category

processing times for Jammu in these years. Srinagar, as per KNO, witnessed a similar trend. The Regional Passport Office there processed normal



passport applications in an average of 3 days in

2020. This changed dramatically in 2021 when the average time rose to 89 days, the highest among

all RPOs in the country that year. The timeline was reduced to 9 days in both 2022 and 2023, and stood at 10 days in 2024. Like Jammu, no separate Tatkaal timelines were recorded for

"That this petition is an abuse of judicial process having been filed without any cause of action. The petitioners have filed the present petition on completely false grounds in an attempt to deceive the Hon'ble Court,"

SC on demolition of 'unauthorised' constructions in Gurugram's DLF phases

asked Gurugram authorities to maintain status quo on a demolition drive in DLF phases 1 to 5 against unauthorised constructions, including residential properties that have been converted into commercial complexes.

A bench of Justices J K Maheshwari and Aravind Kumar was hearing on Friday a plea by DLF Qutub Enclave RWA, which challenged the Haryana government's Town and Country Planning Department's power to raze the properties.

The bench issued notice to the Haryana government authorities and said, "In the meantime, until the next date of listing, status quo, as it exists today, shall be maintained by the parties."

The top court sought the response of the authorities within four weeks.

Senior advocate Indira Jaising and other lawyers, appearing for the Residents Welfare Association (RWA) contended that the DLF residential phases were under the jurisdiction of the Municipal Corporation of Gurugram (MCG) since 2008 and only the civic body had the power to initiate any action, including demolition of properties.

"In view of the order of status quo



passed today, we make it clear that the petitioners shall also not raze any construction," the bench said.

The RWA has challenged a February 13 order of the Punjab and Haryana High Court which directed the authorities to take "prompt action" against unauthorised constructions, alterations and commercialisation in residential zones of DLF areas and sought an action-taken report by April 19.

The high court said in its order, "It is amply clear that a powerful lobby of certain groups/land mafia are ruining the very basic character of the developed colony in active connivance with the local administration/official respondents that too only because the authorities have turned a blind eye and are permitting such illegal and unauthorised constructions/illegal

an alarming rate right under their nose." The petitioners before the high court had sought action in furtherance of a 2018 Action Taken Report (on complaints against the said constructions) as well as a memo issued by the District Town Planner (Enforcement) recommending

developments, which are coming up at

that occupation certificates of owners who razed unauthorised constructions be cancelled and their electricity, water and sewerage connections be disconnected.

The Town and Country Planning Department subsequently issued over 4,000 show-cause notices and ordered restoration of premises of more than 2,000 house owners in the five DLF phases.

Aggrieved by the high court's order, the $RWA\,moved\,the\,apex\,court\,and\,contended$ that the HC issued contradictory orders.

The association submitted that in 2012, the HC clarified that the Town and Country Planning Department had no jurisdiction in matters related to DLF areas.

In February, the court said the same department would have to initiate action against those involved in unauthorised construction, the RWA said.

The RWA submitted that adverse orders were passed against it by the HC without giving it an opportunity to be heard, thus defeating the principle of natural justice.

The Town and Country Planning Department authorities reached the demolition site with enforcement squads on Friday but were restrained by the top court from taking any further action.

Stock market slide Akhilesh Yadav says common people losing money, blames Centre

LUCKNOW: Samajwadi Party chief Akhilesh points or 1.22 per cent to settle at 75,364.69. Yadav on Saturday said it is very important to pay attention to the slump of India's markets as common people are losing their money and this could cause the economy to sink.

In a post on X in Hindi, the former Uttar Pradesh chief minister held the central government responsible for this "double vicious circle" of the economy.

Indian markets plunged on Friday after US President Donald Trump announced sweeping reciprocal tariffs, including 27 per cent on India, to reduce the trade deficit and boost domestic manufacturing.

"It is very important to pay attention to the loss of millions of crores in the country's stock market because the savings and capital of the common people, who have some extra money to invest and with which they buy goods or services and vehicles and land, is being lost.

"These are the things that keep the wheel of buying and selling moving in the market and also the economy. If the money of the common people is lost in the stock market, then both the market and the economy sink," Yadav said in his post.

Investors' wealth dropped by Rs 10 lakh crore on Friday as the BSE Sensex slumped over 900 points to crash below the 76,000 level due to an across-the-board sell-off, tracking weak global

markets amid growing global trade war fears. The 30-share BSE Sensex tumbled 930.67

Tracking the weak trend in equities, the market capitalisation of BSE-listed firms eroded by Rs 9,98,379.46 crore to Rs 4,03,34,886.46 crore (USD 4.73 trillion).

Today, when the youth are investing their savings in the stock market, they are also becoming victims of this uncertainty of the market. This is a very dangerous situation for the future of the



country's capital market, the SP chief said.

"When the youth will suffer losses, they will also shy away from shares and other investments, which will not be a positive signal for the future of the stock market," he said.

On the other hand, Yadav said, there are people who neither have money nor jobs since demonetisation and "recession".

"Such unemployed and helpless people, facing hunger and unemployment, earn their living only with the help of

market activities and dynamism. This is why the fall of the stock market has a very bad longterm effect on their livelihood," he said.

Sitharaman Refutes False Claims That 'One Nation One Election' Will Be Implemented In Next Polls

CHENNAI: Union Finance and Corporate Affairs Minister Nirmala Sitharaman on Saturday dismissed the false propaganda surrounding the 'One Nation, One Election' concept, clarifying that it will not be implemented in the upcoming elections.

Speaking at an event near here, she noted that around Rs 1 lakh crore was spent during the 2024 Lok Sabha elections, and such a massive expenditure could be saved through simultaneous elections.

"If simultaneous elections are held for electing the members of Parliament and Assembly, about 1.5 per cent growth will be added to the country's GDP. In value terms, Rs 4.50 lakh crore will get added to the economy. This is a



black and white example of One Nation One Election' concept", she said.

Sitharaman accused certain parties of "spreading a false campaign" on the 'One Nation One Election' initiative, blindly opposing it.

Sitharaman claimed that the late DMK Patriarch M Karunanidhi had supported the One Nation One Election' concept, but his son and the current Chief Minister (M K Stalin) is not following in his father's footsteps and instead opposing it.

Sitharaman reiterated that the 'One Nation One Election' concept was not someone's "pet" project, but has been planned considering the welfare of the country.

AAP alleges 'education mafia' back in Delhi, slams BJP over fee hike in private schools

NEW DELHI: The Aam Aadmi Party on Saturday launched a sharp attack on the Bharatiya Janata Party-led Delhi Government, accusing it of allowing private schools to arbitrarily hike fees.

Addressing a press conference, senior AAP leader and former Education Minister Manish Sisodia alleged that the BJPGovernment had handed over Delhi's education system to the "education mafia".

"Ever since the BJP Government came to power in Delhi, people have been suffering. Medicines are not available in hospitals, there are long power cuts, and now private schools are looting parents by increasing fees," Sisodia said.

Claiming that several private schools have hiked fees by 20 to 82 per cent, he accused the



Government of inaction.

"Parents are worried. Children are being denied classes if their parents can't pay the increased fees, and the school administration isn't listening. The BJP Government is a silent spectator," he said.

In a post on microblogging site

X, AAP minister Atishi reiterated the allegations and demanded a Central Bureau of Investigation

"Watch through this press conference how Arvind Kejriwal's Government, after coming to power in 2015, stopped private schools from increasing fees

arbitrarily. But as soon as the BIP Government came, these schools again got a free hand to loot," she said.

She questioned how private schools that had not raised fees in a decade were now doing so within a month of BJP's takeover. "Is the BJP Government complicit in this?" she asked.

Earlier on Friday, AAP national convener and former chief minister Arvind Kejriwal also took to X to share a news clipping about fee hike at a private school in Dwarka.

"In 10 years, we didn't allow private schools in Delhi to hike their fees arbitrarily. We ended the education mafia.

Within just a month of their (BJP) Government taking over, the education mafia has returned,"

Govt must keep national interests foremost while formulating strategy on US tariffs: Cong New Delhi, Apr 5: Senior Congress leader based global trade.

Anand Sharma on Saturday termed the imposition of tariffs by the US "unfortunate" and "unilateral" and asked the government to take various political parties and stakeholders into confidence saying national interests should be kept foremost while formulating its strategy. Addressing a press conference here, the former Union minister urged the government to hold consultations with all stakeholders while protecting their interests and also constitute a task force of experts to evolve steps to deal with the issue and monitor the trade.

"What Donald Trump has done is unfortunate and is a big blow to world trade," he noted.

"It is a matter of grave concern. The unilateral imposition of high tariffs by US President Trump has created massive disruption. This is unprecedented. It threatens



to create a major upheaval in all economics. big or small, whether rich and developed countries or the developing and poor countries," Sharma said.

He said Trump's decision has also "turned on its head" the multilateral trade system and delivered a grave blow to the world economy, trade and the WTO, the only organisation which has responsibility to conduct a rule-Noting that there cannot be trade without a rule based system, he alleged what Trump

has done is a violation of all international agreements, rules and principles. "The government should ensure that national interests are kept foremost while taking any decision in reaction to the tariff imposition and it should be taken while

protecting the interests of farmers and

stakeholders," Sharma noted. Sharma said the government should take the country into confidence and there should be consensus and no such decision be taken in haste so that the country should not suffer the consequences of it. Noting that the government should have discussed the issue in Parliament when it was in session, he said it should now speak to all political parties and take them in confidence.

BJP leaders kept trying for Shiv Sena (UBT)'s support on Waqf bill till last minute, claims Raut

MUMBAI: Shiv Sena (UBT) leader Sanjay Raut on Saturday claimed that top Central and Maharashtra BJP leaders were in touch with the Uddhav Thackeray-led party seeking its support for the passage of the Waqf

Raut alleged the legislation was brought by the government to bring corruption into the legal framework and grab Rs 2 lakh crore of land for "dear industrialists of the BJP".

He claimed that the BJP pressured the Naveen Patnaik-led Biju Janta Dal till the last minute to support the bill in Lok Sabha. Though the BJD opposed the bill, it didn't issue any whip to its members and asked them to vote according to their conscience.

"They did the same with us but we didn't agree. Till the last minute, senior BJP leaders from Maharashtra and Delhi were in touch with Shiv Sena (UBT)," the Rajya Sabha member told reporters.

Chardham Yatra Route Split Into Zones For Better Management; Over 6,000 Personnel To Be Deployed

DEHRADUN: The Chardham yatra route has been classified into 15 super zones, 41 zones and 137 sectors for better management of the annual pilgrimage to the four famed Himalayan temples of Uttarakhand, a senior police official said on Saturday.

Inspector General (IG) Garhwal Swaroop on Saturday said more than 6,000 personnel will be deployed along the route to monitor security and transportation arrangements.

Every sector will be spread over a 10-kilometre area, where security personnel will conduct patrolling and perform other duties round the clock, said IG Swaroop, who has been appointed nodal officer

A control room, headed by Superintendent of Police (Traffic) Lokjeet Singh, is being set up at the range office, the IG said, adding that he will personally monitor the security arrangements, traffic, crowd and disaster management preparations.

The Chardham yatra is scheduled to begin on



April 30, with the opening of the Gangotri and Yamunotri temples. Kerdarnath will open on May 2 and Badrinath on May 4.

The IG said yatra control room at the range office will become operational in next five days. A Deputy Superintendent of Police, two inspectors, four subinspectors, one head constable and a constable, besides an in-charge officer, will be deployed in the control room, which will work 24×7.

A special desk will also be set up at the control room to coordinate with other departments, he said. Apart from this, a separate Chardham cell will be formed at the police headquarters under the leadership of Deputy Inspector General of Police (Law and Order) Dhirendra Gunjyal. This cell will collect information related to the entire yatra.

Officers of Additional Superintendent of Police rank will be appointed as route in-charges. Nine officers will look after the yatra arrangements in their respective jurisdictions.

One Deputy Superintendent of Police rank officer has been made dham in-charge at each of the four temples. These officers will monitor facilities and

arrangements for devotees at the temples. Direct monitoring will also be done from the range and police headquarters levels.

The area under CCTV surveillance has also been increased this year, IG Swaroop said.

The total security deployment will include 24 DSPs, 66 inspectors, 366 sub-inspectors, 615 head constables, 1,222 constables, 208 women constables, 926 home guard jawans, 1,049 PRD jawans, nine companies of the Provincial Armed Constabulary and 26 teams of the State Disaster Relief Force.

The IG said traffic director has already started field inspection with his team.

A blue print for the traffic system along the route

has been prepared, he said. On the lines of Rishikesh transit camp, arrangements for the stay of pilgrims to Yamunotri-Gangotri Dhams will be made at Vikasnagar area, under the supervision

of the SP there. A welfare officer will be appointed at the Chardham control room to take care of the food, accommodation and other facilities of the police officers and other support teams, he added.

Congress MLA Nizamuddin reaffirms full support for CM

Calls for unity, slams alleged attempts to defame grand old party at state, national levels

SRINAGAR: Senior Congress leader and MLA Bandipora, Nizamuddin Bhat on Saturday reaffirmed the party's full support to Chief Minister Omar Abdullah and the decisions taken during a recent high-level meeting.

level, the MLA described it as a party that has not only governed the country for decades but also played a foundational role in nation-building. "Congress is not a regional force; it is the largest national opposition and the voice of the people," he said.

MLA Bandipora said a recent meeting held in Delhi was attended only by officially designated district presidents and senior leaders. "Those not invited are not part of the current structure. Indiscipline cannot be tolerated, and saboteurs will not be allowed to dictate terms," he said. Calling for unity within the party ranks, Bhat said, "Congress has stood the test of time and has played a historic role in shaping this state and the country. We won't allow a few miscreants to derail our mission."—(KNO)



Bank in her analysis about the tariff imposed by US has said that India's economy may be headed for turbulent waters as the United States' latest wave of across-the-board reciprocal tariffs sends shockwaves across global trade, posing both threats and opportunities for New Delhi. According to a recent research note by a leading financial institution, the severity of the new tariffs surpasses earlier projections and could drag India's GDP growth by up to 30 basis points, bringing the FY26 forecast down to 6.6%.

With the US facing a rising risk of recession—now estimated at 40%-the spillover could significantly dent Indian exports, not just in goods but also in services. For every 1% drop in global growth, India's GDP could fall by 0.3 to 0.4 percentage points, the report warned. The threat is compounded by a potential influx of cheaper Chinese goods into India, as Beijing redirects oversupply from high-tariff US

Ongoing bilateral trade talks between India and the US could offer some relief. If a trade agreement is reached, India may further easing dependent on how global uncertainties evolve. On the currency front, the Indian rupee appreciated to 85.43 by relatively lower tariffs and a weakening dollar. Analysts now expect the near-term USD/INR range to shift to 84.50-86.00, with limited depreciation pressures compared to other emerging markets. A bigger worry remains the potential fragmentation of global trade into rival blocs centered around the US and China. In such an extreme scenario, the IMF warns global GDP could fall by as much as 7% over the next five years, dealing a long-term blow to export-driven economies

The answer is complex, as AI is not the work of a single individual but rather the culmination of ideas, research, and technological advancements spanning centuries. This article explores the origins of AI, the key figures who contributed to its development, and how it has evolved into the powerful tool we see today.

Early Foundations of AI

The idea of intelligent machines can be traced back to ancient times. Greek mythology, for instance, spoke of automatons—mechanical beings given life by the gods. However, the scientific and mathematical foundation of AI emerged much later. Some of the early thinkers who laid the groundwork for AI include:

1.Theoretical Foundations

Gottfried Wilhelm Leibniz (17th century) – Proposed a mechanical reasoning machine based on logical calculations.

George Boole (1854) – Developed Boolean algebra,

which later became fundamental for computer logic. Alan Turing (1936) – Proposed the Turing Machine, a theoretical model of computation that became the foundation of modern computers. organized by



and senior party leaders on April 6 to discuss the ongoing Assembly Budget Session, resuming on April 7 after a 12-day break, and review the party's performance and the political situation in I&K, sources added.

The Ministry of Home Affairs and the Jammu and Kashmir administration have assured robust arrangements to facilitate this high-profile visit, with a multi-tier security cover in place across Jammu and Srinagar. "We are determined to root out terrorism from Jammu and Kashmir," Shah has reiterated during previous review meetings.

Pertinently, in the last week of January this year Indian Railways had conducted the trial run of the first Vande Bharat train from the Shri Mata Vaishno Devi Katra (SVDK) railway station to the Srinagar railway station.

The train to Kashmir will chug through Anji Khad Bridge, which is India's first cablestayed railway bridge and Chenab Bridge, which is the highest railway bridge in the world. This train has been designed keeping in mind the cold climate conditions of Kashmir.

The completion of the Udhampur-Srinagar Baramulla Rail Link (USBRL) project will significantly

reduce travel time between Katra and Srinagar. The new Vande Bharat Express will cut down the travel time from the current 6-7 hours by road

Referring to recent surrenders, Shah highlighted that over 500 individuals had chosen to abandon the path of violence this year. He assured those who surrendered a place in the mainstream but warned that those persisting in Maoist activities would face resolute action from the security forces.

Schools that were once deserted now resonate with the ringing of bells as children return to classrooms.

"To those still entangled in militancy, persuade your comrades to surrender and join the mainstream. We envision a new generation of professionals emerging from Bastar, Kanker, Sukma, and every corner of Chhattisgarh," he said.

Amit Shah reaffirmed his Bharatiya Janata Party's commitment to the safety and prosperity of villagers, and also emphasised the cultural renaissance underway in Bastar.

As per the Jammu and Kashmir Disaster Management Authority (JKSDMA), currently there are two active forest fire alerts in J&K, with one being of extreme nature and valid till 10 April 2025.

"Extreme Forest Fire Risk is likely to occur over forest area near Purmandal and Kathua, in next 7 days. Dial 112 for emergency help," reads the alert.

Another alert, as per KNO, states, "Very High Forest Fire Risk is likely to occur over forest area near Rajwalta, Kalakote, Samba, Kathua, Lakhanpur, in next 7 days. Dial 112 for emergency help."

Given the heightened fire risk, authorities have also outlined several dos and don'ts to prevent forest fires and ensure public safety.

Among the do's list, it has asked to close windows, vents, and other openings to prevent embers from

"Move animals and valuable goods to safer locations. After adventure activities, ensure that no bonfire or flame is left unattended," read the guidelines. While among the don'ts, it has asked to avoid

smoking near vegetation or forested areas and not to panic in case of a sudden fire. Refrain from entering the forest during a fire incident. With regard to prevention and preparedness

measures, it has asked to keep emergency contact numbers of district fire services and forest authorities readily available. "Immediately inform authorities in case of an

unattended or uncontrolled fire. Never leave a fire unattended in the vicinity of forested areas," read the guidelines. Highlighting the evacuation protocol in case

of fire, the guidelines have asked that in case of an active forest fire, evacuate immediately if instructed by local authorities and protect yourself from flying sparks and ashes.

It has also asked to untie cattle and livestock to allow them to escape safely.

Before Leaving Your House, the guidelines have outlined how to remove combustible materials like firewood, yard waste, gas cylinders, and fuel cans from your yard.

It has also asked not to attempt to outrun the fire and seek refuge in a pond or river if available. "If no water is nearby, lie in a depression with

little vegetation and cover yourself with wet clothes, blankets, or soil. Breathe through a moist cloth to avoid smoke inhalation," read the guidelines.

CS launches

Chairing a high level review meeting following the launch, the Chief Secretary assessed preparedness of the departments for the extensive campaign to be rolled out in every panchayat, Urban Local Body (ULB), educational institutions and major public spaces across the Union Territory.

speed limits. Real-life examples and interactive discussions made the session engaging and informative. "The initiative was well-


received, with the youth actively participating and expressing interest in more such awareness

LUCKNOW: Rookie leg-spinner Digvesh Rathi's ability to consistently hit an immaculate length with subtle variations, such as the off-break and carrom ball, makes him a dangerous bowler, feels former Australian white-ball great Shane Watson. The 25-year-old Delhi spinner Rathi, the break-out star of this IPL season for Lucknow Super Giants, has already taken six wickets at an economy rate of 7.62 with his skipper Rishabh Pant completing his quota in all four games.

"It seemed like he was born to perform on this IPL stage. He wasn't reserved—he was out there, beating his chest, showing confidence, and executing beautifully," Watson told on JioHotstar after LSG defeated Mumbai Indians by 12 runs with Rati getting the 'Player of The Match' award for his 1 for 21 in four overs which included eight dot balls.

In fact, Rathi brought LSG back into the game when Naman Dhir (46 off 24 balls) was looking ominous. He breached Dhir's defence with a carrom ball that turned like an off-break.


