NEW DELHI: The Supreme Court would likely on April 15 hear a batch of pleas challenging the constitutional validity of the Waqf (Amendment) Act, 2025.

Three More Groups In J&K Dissociate From Hurriyat: Amit Shah

SRINAGAR: The Jammu Kashmir Islamic Political Party, Jammu and Kashmir Muslim Democratic League and Kashmir Freedom Front have disassociated themselves from separatists conglomerate

Hurriyat Conference, Union Home Minister Amit Shah announced on Tuesday. Eleven such organisations in Jammu and Kashmir

have shunned separatism so far. Shah asserted that the move demonstrated people's trust in the Constitution.

"Three more organisations, namely Jammu Kashmir Islamic Political Party, Jammu and Kashmir Muslim Democratic League, and Kashmir Freedom Front, disassociate themselves from the Hurriyat. It is a prominent demonstration of the people's trust in the Constitution of India within the valley," he wrote on 'X'.

The announcement came in the midst of the home

minister's three-day visit to Jammu and Kashmir. Shah said Prime Minister Narendra Modi's vision for a united and powerful Bharat stands even more bolstered today, as so far 11 such organisations have shunned separatism, proclaiming unwavering support for it.

Last month several constituents of the Hurriyat Conference announced their disassociation from the separatists conglomerate.

Among the groups which announced their separation from Hurriyat include Jammu and Kashmir People's Movement, headed by Shahid Saleem, Jammu and Kashmir Democratic Political Movement, led by Shafi Reshi, an advocate, and Jammu and Kashmir Freedom Movement, headed by Mohd Sharief Sartaj.

When the groups made the announcement on March 25, Shah had said the unifying policies of the Modi government have "tossed" separatism out of Jammu and Kashmir.

Two days later, two more constituents of Hurriyat Conference - Jammu and Kashmir Tahreeqi Isteqla and Jammu and Kashmir Tahreek-I-Istiqamat — an-

270 posts of assistant surgeons, 1590 paramedics vacant in Kashmir: Govt

SRINAGAR: The government of Jammu and Kashmir said that there are 270 posts of Assistant Surgeons and 1,590 posts of paramedics lying vacant in the Health Department in the Kashmir Division.

Responding to a question by MLA Dr Shafi Ahmad Wani, Health and Medical Education Department Minister Sakina Itoo, as reported by the news agency-Kashmir News Observer (KNO), said the department is in the process of establishing dialysis units at all Community Health Centres (CHCs).

She added that dialysis units will be established at the CHCs of Magam and Beerwah (in Budgam district) in a phased manner.

"Out of the total sanctioned strength of 1,736 Assistant Surgeons, 1,466 are in position and 270 are lying vacant in Kashmir. Regarding paramedical staff, out of the 4,218 sanctioned strength, 2,628 are in position and 1,590 are vacant," Itoo said.

The minister said that the vacancy of medical officers filled during the last two years by way of appointment includes 52 appointments in 2023 and 226 appointments in 2024.

'The upgradation of health centres/institutes is taken up in accordance with the Indian Public Health Standards (IPHS) norms. Feasibility reports are sought from concerned quarters, and if the reports

are in sync with the IPHS norms, proposals will be considered," she said.

Replying to a question by MLA Saif Uddin Bhat,



Omar Abdullah, who is the Minister in charge of Tourism, said the revision/formulation of master plans for Tourism Development Authorities, including Doodhpathri and Tosamaidan Development Authorities, is presently under consideration in the department.

Doctors Warn Of Serious Health Risks As IMD Issues Yellow Alert Amid Spiralling Mercury

NEW DELHI: The mercury has been soaring in Delhi and doctors have warned that exposure to extreme heat can lead to a range of health issues – from mild rashes and muscle cramps due to excessive sweating and salt loss, to serious conditions like heat exhaustion and heatstroke.


Delhi recorded its first heatwave of the season on Monday with the maximum temperature touching 40.2 degrees Celsius. The city is currently under a yellow alert, which will remain in place till Wednesday.

In the India Meteorological Department's (IMD's) colour code, a yellow alert stands for "be aware" and advises people to avoid heat exposure, wear lightweight, light-coloured and loose cotton clothes, and cover their heads.

Under these conditions, vulnerable groups such as children, the elderly, pregnant women, and individuals with pre-existing conditions such as cardiac or kidney disease are at a greater risk.

Dr Mukesh Mehra, senior director (Internal Medicine) at Max Super Speciality Hospital in Patparganj, said extreme heat can overwhelm the body's natural cooling system, leading to severe health consequences.

"Heatstroke, the most serious form of heat-related illness, occurs when the body temperature exceeds 104°F. It often manifests itself with symptoms such as confusion, dry and hot skin, rapid heartbeat, and even seizures. Other signs include




dizziness, headache, nausea, and vomiting," he explained.

"In such conditions, vital organs like the brain and heart may be strained due to reduced cooling and redirected blood flow. Recognising these symptoms early and seeking immediate medical attention is essential to prevent life-threatening complications," Mehra added.

Rajat Sharma, a resident doctor of community medicine at UCMS and GTB Hospital, said exposure to extreme heat on days when temperatures are particularly high can cause a variety of health problems. Apart from heat rash and muscle cramps

caused by excessive sweating and loss of electrolytes, more serious conditions such



life-threatening emergency where the body's temperature regulation fails, leading to confusion, loss of consciousness, and even death in some cases.

Doctors have advised people to stay well-hydrated, avoid stepping out during peak sun hours and wear light, breathable clothes. "If someone shows symptoms of heat-related illness, they should be immediately moved to a shaded or cooler place," Dr Sharma said.

Echoing similar concerns, Dr Mehra stressed the importance of preventive

measures against heat-related illnesses. "As heatwave conditions intensify. prevention is our best protection. Staying hydrated... supports the body's cooling system. People should limit outdoor activities during peak hours, take regular rest if working outdoors, and gradually acclimatize to rising temperatures," he said.

"Being aware of personal risk factors such as age, chronic illnesses, or medications can significantly reduce the chances of developing heat-related complications like exhaustion or stroke," Dr Mehra added.

Dr Ushast Dhir, the director of the Department of Liver Transplant and Hepatobiliary Surgery at Sir Ganga Ram Hospital, said that with the onset of summer, there is an increased risk of exposure to new viral infections and water contamination.

He cautioned that the elderly, children, and diabetics are at a higher risk of heatstroke and should avoid direct sun exposure, especially during the afternoon hours."With rising temperatures, the risk of dehydration also increases. We should stay hydrated with non-caffeinated fluids. Tea, coffee, and carbonated drinks can further dehydrate the body and should be avoided during peak summer months," Dr Dhir advised. Delhi is likely to experience cooler days

Heatwaves Drove 1/3rd Of Rise In India's Power Demand During 2024 Summer: Report **NEW DELHI**: India's cent higher than the previous year. use in India rose from 22 per

electricity demand during the severe heatwave months of April to June 2024 rose by 10.4 per cent compared to the corresponding period the year before, with increased use of air conditioning contributing to nearly a third of the rise, according to a new report released on Tuesday.

The sixth edition of global energy think tank Ember's Global Electricity Review also said heatwaves were responsible for almost a fifth of the increase in global electricity demand in 2024 and were the main reason behind a 1.4 per cent rise in fossil fuel-based power generation.

This led to a 1.6 per cent increase in global power sector emissions, adding 223 million tonnes of carbon dioxide and pushing total emissions to a record high of 14.6 billion tonnes.

Without the heat-related demand, fossil generation would have grown just 0.2 per cent, as clean energy met 96 per cent of the demand growth not caused by hotter temperatures, said the report.In India, electricity demand during April-September 2024 was 6.1 per cent higher compared to the corresponding period in 2023. Ember estimated that 19 per cent of this rise was due to higher temperatures. During the peak heatwave months from April to lune, the demand was 10.8 per

In his opening address at the Extended Congress Working Committee meeting at the Sardar Patel Memorial here, Kharge also said that today, attention is being diverted from the basic issues of the country by indulging in communal division.

"On the other hand, oligarchic monopoly is on the path of controlling the government by capturing the resources of the country," he said, quoting Sardar Patel.

Kharge said organisational strength was important and mere numbers without the organisation was meaningless.

For the last several years, a well-planned conspiracy has been carried out regarding many national heroes, he alleged.

"An atmosphere is being created against the Congress party which has a glorious history of serving and fighting for the country for the last 140 years. This work is being done by those people who have nothing to show as their achievements," Kharge said They have nothing to show as their contribution in the freedom struggle, he said, attacking the BJP-RSS.

"They conspired to show that the relationship between Sardar Patel and Pandit Nehru was such that the two heroes were against each other. While the truth is that they were two sides of the same coin. Many incidents and documents are witness to their cordial relationship," he asserted.

Citing a speech of Sardar Patel in Gujarat Vidyapeeth in 1937, Kharge narrated an incident that during that time Nehru was the president of the Congress and the youth of Gujarat wanted that he be called to campaign in the provincial elections.

"Sardar Patel said on March 7, 1937 that 'The day Gujarat proves its loyalty to the Congress by becoming victorious in this election movement, we will welcome Congress president Nehruji with flowers and welcome him with open hearts'," Kharge said.

"You can understand from this how much Sardar loved Nehruji. On 14 October 1949, Sardar Patel had said in a book for Nehruji that 'No one knows better than me the tireless efforts Nehruji has made for the country in the last two difficult years. During this period, I have seen him grow

old very fast due to the burden of heavy responsibilities," he said.

Kharge said these things are recorded in the public record.

"There was almost daily correspondence between the two. Nehruji used to take his advice on all matters. Nehruji had immense respect for Patel sahab. If he had to take some advice, he himself would go to Patelji's house. For Patelji's convenience, CWC meetings were held at his residence," Kharge said. He asserted that Patel's ideology was

contrary to the ideas of RSS and he had even banned the organisation. "But it is laughable that today the people

of that organisation claim Sardar Patel's legacy," Kharge said.

Mahatma Gandhi and Sardar Patel played an important role in making Baba Saheb Ambedkar a member of the Constituent Assembly, he claimed.

Ambedkar himself had said in his last speech in the Constituent Assembly on November 25, 1949 that "the Constitution

could not have been made without the support of the Congress Party", Kharge recalled.

"But when the Constitution was made, the RSS criticised Gandhiji, Pandit Nehru, Dr. Ambedkar and the Congress a lot. They burnt the effigies of the Constitution and these leaders at Ramlila Maidan. They also said that the Constitution was not inspired by Manuwadi ideals," he said.

The Modi government insulted Gandhi and Baba Saheb by removing their grand statues from Parliament premises and putting them in a corner, he alleged.

"The Home Minister (Amit Shah) mocked Baba Saheb in the Rajya Sabha by saying that 'you people keep saying Ambedkar, Ambedkar, Ambedkar'," he said.

Kharge asserted that the Congress party respects both the Constitution and the Constitution makers and knows how to protect it.

"Sardar Patel Saheb lives in our hearts, lives in our thoughts. We are taking his legacy forward. We have organised this CWC meeting in Ahmedabad at the Sardar Patel Museum with this thought in mind. We pay our heartfelt tribute to him," he said.

Kharge further alleged that today, the BJP and Sangh Parivar people are taking


over institutions associated with Gandhi and handing them over to his ideological opponents.

"They have also taken over Sarva Seva Sangh in Varanasi. You all know what happened in Gujarat Vidyapeeth. Gandhian people and people of the cooperative movement are being marginalised," Kharge alleged."People with such thinking can steal Gandhiji's glasses and stick. But they can never follow his ideals. Gandhiji's ideological legacy is the real capital which only the Congress party has," he asserted.

"This year is the centenary of Mahatma Gandhi Ji becoming the Congress President. In December 1924, the Father of the Nation, Mahatma Gandhi Ji, became the President at the Belagavi Congress session in my home state, Karnataka. We celebrated this centenary in Karnataka on December 26," he said.

Three great personalities born on the land of Gujarat made the name of Congress famous all over the world, he said.

Dada Bhai Naoroji, Mahatma Gandhi and Sardar Vallabh Bhai Patel - all of them were the Presidents of our Congress Party, he pointed out."Gandhi Ji gave us the weapon of truth and non-violence against injustice. This is such a strong ideological weapon that no power can stand in front of it," Kharge said.

Over 30.42 crore unorganised workers have registered on the eShram portal, an initiative by the Government of India designed to support the unorganised workforce. To expand the range of benefits, the eShram portal has been integrated with several government schemes, enabling workers to access a variety of social security services. One of the key features of eShram is its integration with the National Career Service (NCS) Portal, allowing unorganised workers to register using their Universal Account Number (UAN) and search for job opportunities. Additionally, eShram is linked to the Pradhan Mantri Shram Yogi Maandhan (PM-SYM) pension scheme, which offers a monthly pension of ₹3,000 to workers aged 18-40. The government contributes 50% of the scheme's funding, making it an affordable option for workers. Moreover, eShram's integration with the Skill India Digital Portal provides unorganised workers with access to skill development and apprenticeship opportunities, enhancing their employability. In addition to these services, eShram is connected to the myScheme portal, which helps workers discover and access various government schemes based on their eligibility. On October 21, 2024, the Ministry of Labour and Employment launched eShram as a One-Stop-Solution for unorganised labour, aligning with the recent budget announcements. This new platform centralises multiple social security schemes, allowing workers to access all the benefits they are entitled to through a single portal. Currently, 12 central schemes are integrated, including Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Ayushman Bharat, and PM Awas Yojana, among others. This integration of various welfare schemes through eShram is a significant step toward providing unorganised workers with easier access to government services and financial security, reinforcing the government's commitment to their well-being.

We all recall instances when we actually comprehended something. It was not when we read it in a book. It was when we did it ourselves. A science experiment in lab class a field trip to a historical landmark a project done with our hands or even a role play activity can teach us so much more than any paragraph written in a book. Learning is best when we learn through experience. We relate to it. We tie it to our own lives. This is the power of experiential learning.

The NEP 2020 emphasizes the necessity of a transition from rote learning to competency based education. It emphasizes critical thinking creativity and problem-solving skills. These cannot be acquired by just reading a textbook. They need to be applied to real life situations. For instance a student studying ecosystems can learn more by going to a forest seeing plant and animal interactions and thinking about environmental problems. Such experiences produce long lasting knowledge that is much more precious than memorized definitions.

One of the strongest suggestions of the National Curriculum Framework is to make learning enjoyable and fun. Learning must not be a burden. It must be a thrilling experience of discovery. When students are provided with chances to explore experiment and express themselves they learn to love learning.

Freedom To Flourish For Muslim Women: Diversity Of Opinions And Rights Discourse

The Principle of Love

The greatest law is that of love and if we are in doubt regarding any ruling or have to choose between two different interpretations we have to decide on the basis of this old principle: That is to be followed which leads to increase of love of God and love of neighbour.

The Principle of Spiritual Flourishing/Eudomonia

The Prophet's words "By Him in Whose Hand is Muhammad's life, I have not left anything which may bring you nearer to Paradise and take you farther from Hell unprescribed to you, nor have I left anything which may bring you nearer to Hell and take you away from Paradise unforbidden to you" may be seen as an emblem for this idea. What is forbidden by Islam is in principle forbidden by every tradition and every rational moral creature: "Say, My Lord has forbidden only shameful deeds, be they open or secret, and sin, and unjustified greed, and the association with God of that for which He has sent down no authority, and the saying against God of what you don't know" (Quran, 7.33).

In Mukhtasar al-Quduri we find key statements on foundations of the Islamic Shari`ah as consisting in: 1. "Consideration of the welfare of the servants.

and the Hereafter.


2. Connection of regulations to their rationales, and persistence

- of the regulations in the presence and absence of the rationales.
- 3. Gradual, progressive legislation.
- 4. Preclusion of hardship.
- 5.Establishment of justice"

The five fiqhi schools generally agree that "Islamic laws (1) change with the passage of time and with the change of place or circumstance; (2) must avoid harm"(al-Hibri,1997). Jurists agree that Islamic laws "may be discarded if they are based on a cause ('lilah) which itself has disappeared," and "must serve the commonweal" ("public maslaha") Early jurists viewed disagreements among them as a sign of God's mercy, because they "injected Islamic laws with the degree of flexibility necessary for a religion which proclaimed itself suitable for all times, all people and all societies. Thus, hundreds of schools of Ijtihad developed, each best suited to its own community and that community's culture, with its attendant customs and traditions" freedom or not in synch with deeper rhythms of spirit, women can scan diversity of opinions from classical to contemporary times, to choose in the light of all the accumulated experience and wisdom what best leads to their spiritual growth or fulfillment. It is always important to remember that letter killeth and spirit gives life and we worship God who is Freedom. Limiting freedom in the name of blocking the means for less certain or imaginary harm has been compellingly criticized by several scholars including more recently Jasser Auda. Just a quotation will make it clear.

Harm is 'probable' some jurists claimed, 'when a woman travels by herself,' and 'when people use legally-correct contracts with hidden tricks as means to usury.' Again, Malikis and Hanbalis agreed to block jurist Al-Sarakhsi considers Istihsan as "a method of seeking facility and ease in legal injunctions" and is in accords with the Quran (2:183). The Sahaaba in their judgments were not blindly literalists and sometimes (as in case of Umar and Aisha, for instance) seemed to have gone much beyond the imagination of even moderate reformists in subscribing to the spirit, keeping in view purpose and transcending the letter.

Given how little is specified in the Canon and how wide open the world of undetermined, we see mercy in operation. One is usually comfortable with the custom and Islam canonizes custom, so to speak. It is no wonder fiqh, especially Hanafi fiqh could adapt to so many continents or cultures and traditionally Muslims hardly felt difficulty in living by it. The Quranic declaration

Figh is the attempt to think and concretize Shariah and it differs not just from school to school but even from jurist to jurist. Since God wants to save all souls or make the world livable for everyone who agrees not to destroy it for others, and people differ from region to region, from time to time, from stage to stage of their lives, fighadapts accordingly. Figh is open ended – we are invited to exert ourselves in choosing their decisions so that God's intention is fulfilled there are situations where no figh manual comes to our help and we stand naked before God/conscience. It is interesting to find all kinds of opinions within the prescribed limits entertained by Muslim jurists and we find upbringing, politics, theology, considerations of public good etc...

Our task is to fight perception of women as unequal implying disadvantaged or marginalized, to question the assumption that her life mission is exhausted by raising a family (this leaves out not only childless women but 80 percent of time from birth to death that a woman has besides duty of child raising for say few years for fulfilling her human potential or diverse creative and other dimensions. Ibn Rushd had long back asserted the need for involving women in diverse careers as child raising is only one of her prerogatives. Most women who choose to stay at home have nothing to do in the age of gadgets and indulge in various evils or gossiping in their idle time. The classical Islamic period has great record of cases of active participation of women in economy and social life. The idea that women are to be segregated off into secret world devoted wholly to easing children in neither justified nor warranted in Islamic tradition. Bukhari has over a dozen chapters on social life of women and we find women contributing in different walks of life throughout Islamic history. Jurists agree that Islamic laws "may be discarded if they are based on a cause ('lilah) which itself has disappeared," and "must serve the commonweal" ("public maslaha"). One needs to note Fazlur Rahman's point that

the process of questioning and changing a tradition in the interests of preserving or restoring its normative quality in the case of its normative elements-can continue indefinitely and that there is no fixed or privileged point at which the predetermining effective history is immune from such questioning and then being consciously confirmed or consciously changed. This is what is required for an adequate hermeneutical method of the Qur'an (Rahman, 1982:11).

Women's Rights

We may, as illustration, mention a few concrete points that are often raised in FAQs, to show how diverse are choices that women could exercise within the larger limits or range of wide highway of Shariah. Whenever any legal opinion appears constrictive of these means, while others disagreed because the harm is not 'certain' or 'most probable.' For example, in the name of blocking the means, women are prohibited from 'driving cars,' 'travelling alone,' 'working in radio or television stations,' 'serving as representatives,' and even 'walking in the middle of the road'(Auda,2008:41).

God obligates nothing that isn't necessary for our true flourishing and disapproves nothing on the pain of hell that isn't against the laws of moral, intellectual and spiritual flourishing. The true faq his defined by the Imam as "he who does not make people despair of the mercy of God, and does not make them lose hope in the gracious spirit of God." It is in this sense that Ibn Arabi who thought his mission was to declare vastness of mercy of God may be read as true fagih. Jurists who end up sending people to hell for their imagined or real transgressions of this or that manual and who fail to link their formulations or opinions to overarching mercy here and hereafter are not to be trusted. Seek to show or demonstrate in every debatable case where other opinions/interpretations are forthcoming, as far as possible, to any inquirer/critic what Ibn al-Qayyim said:

The Islamic law is all about wisdom and achieving people's welfare in this life and the afterlife. It is all about justice, mercy, wisdom, and good. Thus, any ruling that replaces justice with injustice, mercy with its opposite, common good with mischief, or wisdom with nonsense, is a ruling that does not belong to the Islamic law, even if it is claimed to be so according to some interpretation (Ibn Qayyim, 1973).

Istihsan, validated by majority of jurists, is "a method of exercising personal opinion (ra-y) in order to avoid any rigidity and unfairness that might result from literal application of law" (Kamali, 2004). A major

"Take what is given freely, enjoin what is 'urf (known to be good), and turn away from the ignorant (al-A râf 7:199)" is readily appreciable as universally applicable liberating praxis for every sane moral person. We are asked to enjoin what is known to be good – this encompasses universal ethic.

From various scholarly works on Usul al Fiqh and Maqasid we may note certain points that further strengthen the case for mercy centrism.

• "The majority hold that Ijtihad is liable to error. The minority hold that each of the several verdicts may be regarded as truth on their merit." (Shawkani, Irshad).

• As for the practical rules of Fiqh, most of them are from texts which are speculative in meaning (dhanni dalalah)

• Law isn't absolute and changes with change in context, necessity, circumstances, even person. We know when one's life is threatened, haram can be taken to the extent that life is saved.

• The Prophet discouraged asking questions and companions asked him only 13 questions

We may further note the following points that expand our freedom to choose what impresses our aesthetic or affective or cognitive constitution or navigate amongst diverse options:

• Qiyas has been opposed by Zahiri and some other fuqaha implying freedom for us to choose a course of action.

• God takes a pragmatic view that we are imperfect creatures.

• In the end we are weaned away from taking our agency too literally or seriously. It is grace that finally decides.

• For any particular legal stipulation by jurists that one may appear problematic, remember that there have been equally competent jurists taking other views and besides fuqaha se have philosophers and Sufis etc.) are not conclusive for Ijma. Imam Ghazzali says these verses are indications, not clear Nass on Ijma. Suyuti's interpretation is the same. Al Amidi says, "these give rise to probability (Zann), not positive knowledge". Imam Kashmiri had to read the Quran several times to get some clue in his search for some Quranic basis for Ijma.

Validated by Hanafi, Maliki and Hanbali jurists. Istihsan means to deem something preferable and is a method of "exercising personal opinion (ray) in order to avoid any rigidity and unfairness that might result from literal application of law. Istihsan as a concept is close to equity in western law." Despite disagreement by Imam Shafi, Shii and Zahiri Ulama, majority have accepted Istihsan. We need to note, however, that Istihsan in the sense of setting aside an established analogy in favor of an alternative one that serves the ideals of justice and public interest in a better way, as originally considered by Imam Abu anifah and his main disciples, as Ibn Taymiyyah noted, is "not the form that was denounced by Imam ash-Shâfi i and Imam A mad when they encountered some of the later anafi scholars practicing it. Al-Âmidi (Shâfi i jurist) stated that, notwithstanding his explicit denunciation of isti sân, Imam al-Shâfi i himself resorted to isti sân on several occasions."

• Istihsan and Maslaha are also important sources framed for the fiqh of mercy. The discipline of maqasid is also linked to fiqh of mercy. We may focus more on these in comparison to seeking to find a point of Ijma in our contemporary times. It has been noted that once scholars have differed upon an issue there can never be Ijma in the classical sense of agreement of all scholars by future generations since scholarship is eternal. Historically Ijma has been recorded on very few issues that are no longer object of debate and as such Ijma can't be invoked to stifle contemporary scholarship on new issues that are primarily object of debate between fuqaha or modern critics of medieval fiqh.

President Droupadi Murmu on April 5 gave her assent to the Waqf (Amendment) Bill, 2025, which was passed by Parliament after heated debates in both houses.

The bill was passed in the Rajya Sabha with 128 members voting in favour and 95 opposing it. It was cleared by the Lok Sabha with 288 members supporting it and 232 against it.

The Dravida Munnetra Kazhagam (DMK). Congress MPs Imran Pratapgarhi and Mohammad Jawed, AIMIM leader Asaduddin Owaisi, RJD MPs Manoj Jha and Faiyaz Ahmad, AAP MLA Amanatullah Khan have also filed petitions in the apex court challenging the validity of the Act

clearly revealed the government's intention to take complete control over the administration of Waqf, therefore, sidelining the Muslim minority from managing their own religious endowments.

Articles 25 and 26 of the Constitution ensure freedom of conscience, the right to practice, propagate religion, and the right to establish and manage institutions for religious and charitable purposes, it said.

The plea is settled by advocate MR Shamshad, with advocate-on-record Talha Abdul Rahman representing the Muslim personal law board, through its General Secretary Maulana Fazlur Raheem Mujaddidi.

Jamiat Ulama-i-Hind also filed a petition in the apex court, claiming it was a "dangerous conspiracy" to strip Muslims of their religious freedom.

In its petition, Jamiat said the law was a "direct attack on the country's Constitution, which not only provides equal rights to its citizens but also grants them complete religious freedom".

In its separate plea filed in the top court, Samastha Kerala Jamiathul Ulema, a religious organisation of Sunni Muslim scholars and clerics in Kerala, has claimed the Act was a "blatant intrusion" into the rights of a religious denomination to manage its own affairs in the matter of religion.

Jawed's plea alleged the Act imposed "arbitrary restrictions" on Waqf properties and their management, undermining the Muslim community's religious autonomy.

The petition, filed through advocate Anas Tanwir, said the law discriminated against the Muslim community by "imposing restrictions that are not present in the governance of other religious endowments".

In a separate plea, Owaisi said the bill took away from Waqfs various protection which are accorded to Waqfs and Hindus, Jain and Sikh religious and charitable endowments alike.

'This diminishing of the protection given to Waqfs while retaining them for religious and charitable endowments of other religions constitutes hostile discrimination against Muslims and is violative of Articles 14 and 15 of the Constitution, which prohibit discrimination on the grounds of religion," said Owaisi's plea, filed through advocate Lzafeer Ahmad.

NGO Association for the Protection of Civil Rights also filed a petition in the apex court challenging the constitutional validity of the Act.

AAP MLA Amanatullah Khan sought the law declared as unconstitutional, being violative of "Articles 14, 15, 21, 25, 26, 29, 30 and 300-A of the Constitution". (AGENCIES)

Army steps

Army's Rashtriya Rifles unit based at Bhadarwah has increased surveillance in 15,500 feet high Kailash Kund mountains besides snow covered Seoj Dhar, Padri Galli, Shankh Padder and Chattergalla pass, an army officer said.

He said besides sending in the additional troops to the high altitude passes bordering Kathua, Samba and Udhampur, a high security joint picket is being established at Chattargalla paas, the highest point on Bhadarwah-Pathankot highway located at a height of 10.531 ft above sea level.

"High end night vision electronic gadgets are being used for foolproof security at the high altitude pass that will be jointly manned by Army, CRPF and Special Operations Group of Jammu and Kashmir ' a police officer said Last year on July 11, six security personnel were injured when terrorists attacked their picket at Chattargalla, marking the first terrorist attack in the district in four years. The incident followed several gunfights that left five security personnel and four terrorists dead in 2024.

Raksha Mantri stated that the Comprehensive Strategic Partnership with the UAE is of immense priority for India. Evaluation of AI-Large Language Model applications in final stage: Vaishnaw

NEW DELHI: The evaluation of Al-Large Language Model applications is in the final stage, and over the next few weeks, the government will shortlist entities that will receive funding under the India AI Mission, IT Minister Ashwini Vaishnaw said on Monday.

Vaishnaw was speaking at an event to inaugurate the Vinod Dham Centre of Excellence for semiconductors and microelectronics at Delhi Technological University (DTU).

"The evaluation of the AI LLM (Large Language Model) applications is in its final stage. Within the next few weeks, we should be able to award the first few LLM model teams,

who will then start getting the funding under the AI mission," Vaishnaw said.

The minister in February announced that India will have its own AI platform in the next 18 months, for which the government had invited proposals. It has received 67 applications for the project.

Now, industries have started creating AI applications, and many of them have been recognised by the AI mission, he added.

The DMK moved the top court through its deputy general secretary A Raja and said in a press release, "Despite widespread opposition, the Waqf Amendment Bill, 2025 was passed by the union government without proper consideration of the objections raised by the members of the JPC and the other stakeholders."


He is yet to fire big this season, but Devdutt showed signs of being in his dominant self with a 22-ball 37 against Mumbai Indians here on Monday.

While he was welcomed back with a six over mid-wicket by India teammate Virat Kohli on the first ball, Bumrah couldn't force matters on his own apart from a customary tidy spell as RCB notched up a 12-run win to hand MI their fourth loss in five matches.

"I just spoke to him after the game and he looks in good nick. He's disappointed as well, he wanted a win when he came back but other than that he looks fine. The pace was up, the execution was good," Jayawardene told the media after the match.

Jayawardene defended MI's call to introduce Bumrah late into the attack, saying the team management wanted to ease him into the competition.

"(To have Bumrah back) it just gives us more options," Jayawardene said.

"We (have) got two swing bowlers (and) we need to give them that opportunity first up. Boom (Bumrah) is coming back from a three-month layoff as well, so we just wanted to ease him into the competition," the MI head coach said.

"But he bowled well and and controlled things really well, so the more he starts playing game time, he'll get into it. The last time he was playing a Test match so all of a sudden he's playing a T20 so we need to understand that, but the skills were brilliant," he added.

Jayawardene sounded assured of Bumrah's progress as well as current status in terms of fitness and form.
