SRINAGAR: Union Home Minister Amit Shah has said that no one will be allowed to conspire to spread terror in Jammu and Kashmir.

In a conversation with a national news channel, Shah, said, "We will not let anyone conspire to spread terror in J&K. If anyone tries such things, they will be punished."

The Union Home Minister maintained that national security is a top priority for the Centre and its stand on security and separatism is firm. "We will not compromise, nor will we allow anyone else to do it," he added.

Referring to his recent visit to Jammu and Kashmir, Shah said, "Meeting with Chief



Minister Omar Abdullah was cordial and focused on development and governance.

We have always supported regional governments equally, without any bias."

He reiterated that the Centre is committed to working with J&K's elected

Asked whether a recent terror incident in Kathua was caused by Pakistan-backed infiltration, Shah said, "Infiltration is, of course, backed by Pakistan and not someone else like Russia. And this has been happening for years. But our soldiers and the government are both alert. We will punish them if they try."Pertinently, the Union Home Minister visited J&K for 3-days earlier this week. He met top government officials, political leaders, and security brass during his visit.

Bandipora Police Arrests Eight Members of Banned **Separatist Groups**

BANDIPORA: In a major crackdown on separatist networks, Bandipora Police on Wednesday arrested eight members affiliated with various proscribed organisations for their alleged involvement in promoting terrorism and secessionist activities across the district.

According to a police statement, the arrests were made as part of ongoing investigations into multiple FIRs registered under the Unlawful Activities (Prevention) Act (UAPA) at police stations Bandipora, Sumbal, and Hajin. The operation

In his interaction with the district administration, the Chief Secretary directed the officials to explore


"Govt transforming the military into a technologically-advanced force": Rajnath

SRINAGAR: "Armed Forces must operate iointly and remain future-ready in today's everevolving multi-domain environment where cyber, space & information warfare etc. are as potent as conventional operations," said Raksha Mantri Rajnath Singh while addressing the Armed Forces officers of India and friendly countries during the Convocation Ceremony of the 80th Staff Course of Defence Services Staff College (DSSC), Wellington, Tamil Nadu on April 10, 2025.

Raksha Mantri pointed out that today's global geopolitics is being redefined by three key metrics: a major pivot towards prioritising national security, a technological tsunami sweeping the global landscape, and accelerating innovation. 'Ignored' for entitlements, martyred IAF officer's parents seek change in Govt policy

Squadron Leader Abhimanyu Rai who died in a trainer jet crash feel they were "ignored" for entitlements and honours that went to their daughter-in-law, demanding a change in government policy.

Apilot in the IAF, 33-year-old Squadron Leader Rai died in a plane crash on December 4, 2023 near the Air Force Academy in Hyderabad while training a foreign cadet.

He was flying a Pilatus PC-7 Mark-II aircraft, a trainer jet, with a foreign cadet under his training when it crashed near the Academy killing both of them.

Group Captain Amitabh Rai (retd) and his wife Chitralekha said they lost their only son Abhimanyu in December, 2023 but they have not received even a word of condolence from the government so far.

They feel the policy for such cases needs to be tweaked to accommodate the parents of the martyred bravehearts apart from their wives.

"We know of at least a dozen parents of martyrs who have been ignored when it came to according entitlements, which went exclusively to their wives," Chitralekha told PTI in an exclusive interview here on Wednesday.

"One year and three months have passed since we suffered the worst tragedy of our life, losing our only son in a trainer jet crash near the Air Force Academy in Hyderabad. But we did not receive even a word of condolence to date from either the prime minister or the defence minister," Amitabh Rai said.

"Why should a word of condolence be the exclusive privilege of only the martyr's wife." he asked.

He said in many cases, the wives of



slain or martyred soldiers leave or ill-treat their in-laws after getting compensation and half the pension of their husbands. At times, they even drag them to court to claim their share in their late husband's ancestral property, he claimed.

"The wife of a slain soldier is called a 'veer nari' (brave woman) but not his mother who gave birth to him, brought him up and inculcated in him a love for the country that was strong enough to make him lay down his life for it. Is it fair?" asks Group Captain Rai.

"We know what it takes to groom your son like that and make him a soldier ready to die for his country. But, unfortunately, no one seems to take notice of the fact," says he.

The awareness that their son is not treated as a "martyr" despite having died in the line of duty only deepens their sense

"As his death was not a 'battle casualty', they don't treat our son as a martyr. Our

question is didn't he die for the nation?"

asks Chitralekha.

"My son had even served for one-anda-half years in the prime minister's fleet," Group Captain Rai, who retired from the Indian Air Force (IAF) in 2017 after 32 years of service, said.

The plane crashed during a low-level navigation sortie, says the braveheart's

"My son was a dedicated soldier. The foreign cadet was admittedly weak in memory and slow in learning things. He also lacked confidence and was not keen on continuing with his training.

"He had written all this in a letter to Abhimanyu. But as the passing out parade was near after which he was to be commissioned into the air force of his country, Abhimanyu decided to help him complete his training by taking him on the training sortie during which the jet crashed," his father said.

Asked why his son did not bring the

training to his superiors, Group Leader Rai said maybe he was under pressure.

"He might have been hesitant to take the matter to the higher-ups because diplomatic ties between the two countries are involved. The trainer pilots are under pressure to complete the training process successfully," Rai said.

Training of cadets from friendly countries is done as part of a diplomatic exercise to strengthen ties with them and the resulting pressure comes on the soldiers, he said.

It is an inherent flaw in the system which needs to be addressed, he said.

"An inquiry is underway to ascertain what exactly led to the crash and until that happens, we are assailed by all sorts of doubts about the circumstances at the time of the crash such as whether our son was overworked or under pressure or some error was committed by the weak and ill-confident foreign cadet under training," Rai said.

The Rais visited the crash site in Hyderabad and erected a memorial in the name of their martyred son at their own expense. The couple also visited the foreign cadet's country, met his parents and extended financial assistance to them as a goodwill gesture."We went to meet the parents of the deceased foreign cadet. Our pain was common. We had both lost our sons. My wife and the cadet's mother cried on each other's shoulders," he said.

However, the loss of a son has not deterred Group Captain Amitabh Rai (retd) from training bright young boys free of cost to join the armed forces and serve their motherland with valour.

US suspends additional 26 pc tariff on India till July 9: **White House**

NEW DELHI: The US has announced the arrangements and aligning sufficiently with suspension of additional tariffs on India for 90 days until July 9 this year, according to the White House executive orders.

On April 2, US President Donald Trump slapped universal duties on about 60 countries exporting goods to America and additional steep levies on countries like India, potentially impacting sales of products from shrimp to steel in the world's biggest economy. The move was aimed at cutting its trade deficit and boosting domestic manufacturing.

The US imposed an additional import duty of 26 per cent on India. The tariffs were high on its competitors like Thailand, Vietnam and China. This suspension of tariffs is not applicable to China, including Hong Kong and Macau.

"Effective with respect to goods entered for consumption, or withdrawn from warehouse for consumption, on or after 12:01 a.m. eastern daylight time on April 10, 2025, enforcement of the second paragraph of section 3(a) of Executive Order 14257 is suspended until 12:01 a.m. eastern daylight time on July 9, 2025." the order said.

The second paragraph of Section 3 (a) of the executive order issued on April 2 mentions the implementation of reciprocal tariffs. It includes Annex 1 listing rate of tariffs for different countries.

However, the 10 per cent baseline tariff imposed on the countries will continue to remain in place.

"Since I (President) signed Executive Order 14257, in contrast to the PRC's actions, more than 75 other foreign trading partners, including countries enumerated in Annex I to Executive Order 14257, have approached the United States to address the lack of trade reciprocity in our economic relationships and our resulting national and economic security concerns.

"This is a significant step by these countries toward remedying non-reciprocal trade the United States on economic and national security matters." the order dated April 9 said.

A trade expert said the 25 per cent duty on steel, aluminium (effective from March 12), auto and auto components (from April 3) also continues.

Federation of Indian Export Organisations (FIEO) Director General Ajay Sahai said that semiconductors, pharmaceuticals, and certain energy products are under the exemption category. Commenting on the 90-day deferral of reciprocal tariffs, Indian exporters said the US decision has come as a major relief as it provides a crucial window for pushing the talks on the proposed bilateral trade agreement between India and America.

They said that diplomatic engagement and fast-tracking negotiations for the trade pact will help India deal with these tariffs.

"It is a good decision by the Trump administration. We have been assured by the commerce ministry that the agreement will be finalised at the earliest," FIEO President S C Ralhan said.

Amid a global market meltdown, Trump on Wednesday abruptly backed down on his tariffs on most nations for 90 days but raised the tax rate on Chinese imports to 125 per cent.

In a meeting with industry and exporters on April 9, Commerce and Industry Minister Piyush Goyal asked exporters not to panic and assured them that India is working on the "right mix and right balance" in its proposed trade agreement with the US.

He said the Indian team is working with "speed" but not in "undue haste" to ensure the right outcome for the country.

The two countries are negotiating a bilateral trade agreement (BTA) with an aim to more than double their trade to USD 500 billion by 2023 from about USD 191 billion at present. They are aiming to conclude the first phase by the fall (September-October) this year.

"Wayanad landslide victims served," she said.

government refuses to offer even a loan waiver. Instead, they get mere loan rescheduling and restructuring. This is not a relief. This is a betrayal," she said in a Facebook post.

The Congress MP further said that she and her party "strongly condemn this apathy and stand shoulder to shoulder with our brothers and sisters in Wayanad".

"Their pain will not be ignored. We will raise their voices at every platform until justice is

The Centre's affidavit had come in response to the High Court's query on whether the loans availed by the affected individuals could be waived.

In the affidavit, the Union Finance Ministry had stated that a special meeting of the State Level Bankers' Committee (SLBC) of Kerala was held on August 19

The meeting, which was also attended by Chief Minister Pinarayi Vijayan, decided to extend the applicable relief measures in line with the RBI's Master Directions on Natural Calamities.

According to RBI's master directions, in the event of a natural calamity, the financial relief measures to be adopted include the restructuring or rescheduling of existing loans which would entail a one-year moratorium and the provision of fresh loans.

This affidavit was filed in a PIL initiated by the court on its own in the wake of the Wayanad landslides, aimed at improving disaster prevention and management in Kerala.

A major landslide struck the Mundakkai and Chooralmala regions on July 30 last year, almost completely decimating both areas.

The disaster claimed over 200 lives, left hundreds injured and 32 persons remain missing.

May Nitish become Deputy PM, says Ashwini Choubey

PATNA: Senior BJP leader and former Union Minister Ashwini Kumar Choubey on Thursday voiced a "personal" opinion that Bihar Chief Minister Nitish Kumar should be made the Deputy Prime Minister.

Talking to reporters here, the BJP

leader, who had served in Kumar's Cabinet before moving to the Centre, said he wanted to see the JD(U) supremo as the second Deputy PM from Bihar, after the late Jagjivan Ram.

"Nitish Kumar's contribution to the NDA is tremendous. He has been strengthening the hands of Prime Minister Narendra Modi by playing the role of an anchor in the coalition. It is my personal wish that he be made the Deputy Prime Minister.

"If the wish is granted, Bihar will see the second son of its soil, after Babu Jagjivan Ram, rising to the office", said Choubey. The remarks come in the backdrop of speculations in a section of the media that the 74-year-old JD(U) supremo, who

wants to run for a fifth consecutive term in assembly polls due later this year, may be offered an "honourable exit" by the BJP, which was fed up with playing second fiddle to Kumar in Bihar. BJP leaders like the late Sushil Kumar

Modi have even claimed that Kumar had wanted to become the Vice President and quit the NDA, in 2022, in protest against not being considered for the top Constitutional post. However, remarks of Choubey who

was denied a ticket in last year's Lok Sabha polls, were made light of by the JD(U) as well as the opposition party RJD.

JD(U) MLC and spokesperson Neeraj Kumar cited Union Home Minister Amit Shah's latest interview to a news channel to underscore that "all NDA partners acknowledge the chief minister as the coalition's leader for the upcoming assembly polls".

When 26/11 terror attacks happened, home secy Gupta was in Islamabad for talks

NEW DELHI: When 10 heavily-armed Pakistani terrorists carried out the 26/11 terror attacks in Mumbai, an Indian delegation headed by the then Union home secretary Madhukar Gupta was in Islamabad for bilateral talks to discuss various issues, including terrorism.



On Thursday, after years of efforts by Indian agencies, key accused in the attacks Tahawwur Hussain Rana is being brought to Delhi from the US to face justice in the case.

On November 26, 2008, when the terrorists reached Mumbai, sailing through the Arabian sea from Pakistan, Gupta was in Islamabad attending bilateral home secretary-level talks, what was then named as the 'Composite Dialogue', sources said.

BSF To Undertake Mega IED Detection Drive Along India-Pakistan Border In Punjab

NEW DELHI: The BSF will undertake an anti-IED sweep along hundreds of kilometres of the India-Pakistan border in Punjab following the first-time recovery of such bombs leading to one jawan being injured, official sources said on Thursday.

The force also recently shifted the jurisdiction of about 20.3 kilometres from the total 553 kilometres under its Punjab frontier, headquartered in Jalandhar, to the neighbouring Jammu frontier for "better security coordination" in the riverine areas that run along Pathankot in Punjab.

Pathankot abuts Jammu.

The 2,289-kilometre-long India-Pakistan international border runs from Jammu in the north to Punjab, Rajasthan and Gujarat in the west and the Border Security Force (BSF) is tasked with guarding it.

Its Jammu frontier guards 191.66 kilometres of the international border, apart from 40 kilometres of the Line of Control (LoC) along Jammu and Kashmir. "A massive sanitation drive to find possible improvised

explosive devices (IED) will be undertaken in the Puniab frontier following the incident on Wednesday where two such bombs were recovered from a farming field ahead of the fence in Gurdaspur district. Anti-sabotage checks are already being undertaken at the site where the IED was detected," a senior officer said.



Officials had said this was the first time that an IED was recovered at this strategic and sensitive border, prone to drugs- and weapons-carrying Pakistani drones and infiltration by terrorists. About 70 per cent of the 532 kilometres of the international border in Punjab is cultivable and visited by farmers for tilling of the land, according to the officials. A major portion of this fertile land is ahead of the fence and, hence, the BSF will have to ensure that there are no IEDs hidden there that may hurt troops or farmers or local civilians who frequent these areas, they said. There is a strong suspicion the IED was placed by elements from across the border as the area where it was found was ahead of the fence and that its assembly was of a "military precision", according to the officials.

Unregulated Pilgrim Influx During Char Dham Yatra Dangerous, Warns NGO

Dehradun: A local NGO on Thursday emphasised the need to regulate the number of pilgrims visiting the Char Dham temples daily, warning that uncontrolled influx of devotees could be dangerous.

 $Citing \, media \, reports \, about \, the \, Uttarakhand$ government's decision not to impose any limits on the number of pilgrims visiting the Himalayan temples, Social Development for Communities (SDC) Foundation founder Anoop Nautiyal said it posed a serious risk.

Nautiyal said, "This effectively means that every registered pilgrim would be permitted to visit the shrines. Considering the rising rush of pilgrims with each passing year, regulating the number of pilgrims becomes more important." "Without regulating the number of pilgrims based on the carrying capacity of the holy shrines, a situation of overcrowding and mismanagement could easily arise, posing significant risks to both the pilgrims and the region's fragile environment," he added.

The annual Char Dham Yatra is scheduled to begin on April 30, with the opening of the Gangotri and the Yamunotri temples. Last year, about 50 lakh devotees reached the Char Dham – Gangotri, Yamunotri, Kedarnath and Badrinath — located in the Upper Garhwal Himalayan region.

SDC Foundation is a Dehradun-based NGO working in areas such as climate change, environment, urbanisation and waste management.

Nautiyal said SDC Foundation had consistently urged the government to consider the carrying capacity of the Char Dham sites.

Referring to a detailed report released by SDC Foundation on the Char Dham Yatra in 2024 that lasted for 192 days, he said it documented the number of daily visitors to each shrine over a 28-week period. It included 14 data-driven graphs highlighting 10 key issues, alongside a special feature analysing media coverage and recommendations to



simplify the registration process.

While the government has said all pilgrims would be allowed entry into the shrines, many have found that online registration slots are already full for specific days.

As of now, slots for Yamunotri are already

full until May 18 and slots for only seven days

for Kedarnath remain open. "If there are no restrictions on the number of pilgrims, then why are slots getting booked and why is registration being denied?" Nautiyal

If registration is being restricted despite claims of unrestricted access, it could result in not only disappointment and inconvenience for pilgrims but also create operational difficulties for the government staff and departments involved, he added.

Nautival noted that the government had previously indicated a 60:40 ratio for online and offline registrations.

If pilgrims arrive in Uttarakhand under the assumption that everyone would be allowed, only to be turned away due to the slots being full, it could damage the state's reputation

and create a chaotic situation, he said. "The focus must now shift from celebrating record-breaking numbers to ensuring that the yatra is managed with consideration for the health and safety of pilgrims, preservation of local ecosystems and the welfare of communities that depend on these sacred sites," Nautival said.

"We urge the government and stakeholders

to adopt a more regulated, capacity-based approach to the pilgrim influx. The increased footfall is straining local infrastructure, degrading fragile ecosystems and disrupting the sanctity of the holy places," he added.

The tendency of the state government to widely promote the Char Dham pilgrim numbers as a record is not right. Focusing solely on pilgrim numbers as some sort of a new record undermines the yatra's spiritual and cultural significance, he claimed.

The essence of the Char Dham Yatra lies in its religious and emotional value, connecting devotees to the divine and offering spiritual renewal. When the emphasis shifts to counting pilgrims, it risks reducing this profound experience to a mere statistical achievement, the SDC Foundation founder said.

Dar, a resident of Goripora Barsoo, had been admitted to SKIMS Soura in critical condition a few days ago after the incident occurred in the Frestabal area. He passed away on Wednesday, prompting an outpouring of grief and anger among his col-

The employees gathered at the PDD Sub Office in Pampore to stage a peaceful protest, demanding immediate financial compensation for the deceased's family and a government job for one of the next of kin. Protesters also called for the implementation of long-pending regularization and safety measures for daily wage employees.

Speaking to Kashmir Convener, Mehraj Ud Din Bhat, State Vice President of the All J&K Electric Employmourning the death of our colleague,

who gave 20 years of his life to this department without regularization. He died on duty, and we demand justice — compensation for his family and a government job for one of



his dependents."

Bhat warned that if the department fails to respond, workers will be forced to intensify their protest, including a potential strike. He held the department's leadership — including the Managing Director and the Chief Engineer — responsible for the lack of implementation of promised regularization measures.

"Despite over 450 on-duty deaths and injuries among our ranks, the not blaming the government; the real

betrayal is from within our own department," he added.

He pointed out that under SRO 381, Class IV vacancies can be filled through Departmental Promotion

Freedom To Flourish For Muslim Women: Diversity Of Opinions And Rights Discourse


It seems in any case God can't be interested in contingent cultural issues that get framed differently with religion. What is non-negotiable for a truly serious sincere piety is effort to be loyal to what it is convinced is God's will or stand at ease in the court of conscience. Guilt is something that has disastrous psychological and spiritual costs and should not be allowed until clear evidence. Mere doubt about certain things isn't enough to count as evidence of guilt. Let us note, with Shakespeare's hero, maturity is all. In his book, al-Radd al-Mufhim, Albani who is no feminist, refers to active women at the time of the Prophet and then comments:

These are authentic incidents that firmly prove the state of the women of Salaf (i.e. era of the companions and their followers) in terms of their perfection and magnanimity and good upbringing to the extent that they were capable of doing what they had to do in contribution to good causes. (al-Radd al-Mufhim, 1:155).

It appears that there is evolving a consensus on questioning limiting women to domestic chores and debunking various accusations regarding their capabilities in various domains and higher intellectual and spiritual pursuits. It was Ibn Arabi who recognized and extolled women's spiritual capabilities like none other. Women can't be objectified or reduced to this or that role.

One may here refer to other considerations that further question strong judgmental attitudes of certain fuqaha that however continue to be dominant in public imagination. These considerations include

- Theorizing the link between sin and salvation or otherworldly consequences, if any, of choosing different opinions. The concept of sin that may affect salvation involves intentionality and knowledge that it is forbidden and if we dispute the second condition by offering another possible interpretation that disputed claim of knowledge while recognizing/respecting the horizons or coordinates of Tradition within which interpretation is offered, salvation can't be affected on the analogy of error in ijtihad.
- All the five main schools of thought in Islamic jurisprudence (Hanafi, Maliki, Shafi'i, Hanbali, and Ja'fari), "agree on four basic principles of Islamic law; it changes with time and place, must serve the public interest, should not cause harm, and may be discarded if its cause has faded" (Kharroub, 2015).
- A fundamental rule in Islamic law that "A need that is widespread should be treated as a necessity" and Ghazzali's rule that the higher order necessity should have priority over a lower-order necessity if they generate opposite implications in practical cases.
- Differentiation between means and ends and, as Muhammad Ghazzali, that ends or principles don't expire but means may.
- Shatibi's distinction: "Literal compliance is the default methodology in the area of acts of worship (ibadat), while the consideration of purposes is the default methodology in the area of worldly dealings."
- Mujahidul Islam Qasmi's emphasis on the need for more open view with regard to talfeeq (picking and choosing, when need is felt, legal opinions from various schools/mujtahids) and Ibn Arabi's explanation for the same that it is grounded in Islamic ontology of mercy and should not be construed as conceding ground to nafs parasti.
- What is considered good by Muslims is good in the eyes of God as well as Ibn Masud. Stating that Isthisan is adopting "what is more conforming to common people after abandoning usual way of qiyas."
- And that "it is the very example of the Prophet and his Companions not to imitate them, literally, in the various areas of 'transactions' (muamalat) and rather, to go by the principles and 'maqasid."
 - Ayatullah Shamsuddin's suggestion that Muslims need



to "open their minds to the possibility of 'relative' legislation for specific circumstances, and not to judge narrations with missing contexts as absolute in the dimensions of time, space, situations, and people."

• The point noted in his "Maqasidi al-Shariah: A Beginner's Guide" by Jasser Auda that in certain/many cases at least

Current applications (or rather, misapplications) of Islamic law are reductionist rather than holistic, literal rather than moral, one-dimensional rather than multidimensional, binary rather than multi-valued, deconstructionist rather than deconstructionist, and causal rather than teleological. There is lack of consideration and functionality of the overall purposes and underlying principles of the Islamic law as a whole. Moreover, exaggerated claims of 'rational certainty' (or else, 'irrationality') and 'consensus of the infallible' (or else, 'historicity of the scripts') add to lack of spirituality, intolerance, violent ideologies, suppressed freedoms, and authoritarian regimes (Auda, 2008:53-54).

Now all these points haven't been pressed into the service of securing gender justice and dialogue with Muslim feminists or their Islamist and secular feminist critics. We need trilateral dialogue between Ulama/Islamist women, Muslim feminists and secularists on key questions in order to evolve consensus on what

to do or how to secure the rights of the vulnerable women. Point scoring against one another wouldn't do. Women are suffering on various accounts and they need help for which concrete action and joint work is needed. We can't avoid engaging with religion and religion eschewing secularism and impose certain theological or ideological paradigm. For resolving multiple problems and disempowerment faced by women, all need to come forward and take membership of special groups or communities. These communities would debate and discuss everything that is imposed in the name of certain ideology or theology and evolve common strategies including financial support systems. If all employed or highly educated women contribute daily sadaqah of Rs 10 or 10 percent zakat or 10k soft loan for mobilizing and financing such community strengthening initiatives that take care of women - their debt, their need for seed capital, their food needs, their healthcare exigencies, their legal aid, their counseling for rights and duties especially marriage associated issues – we would soon find new India, new Muslim women whose head is held high and who don't have to suffer from abuses in home and public spaces.

He assessed the current security situation in the Union Territory and devised the future course of action.

"Govt transforming

warfare have become tools that can achieve politico-military aims without a single shot being fired. He added that India faces persistent threats along its borders, which are further compounded by the challenge of proxy war and terrorism emanating from its neighbourhood.

Rajnath Singh also spoke of the impact of the conflict in West Asia and the geopolitical tensions in the Indo-Pacific on the overall security calculus, in addition to non-traditional security threats such as natural disasters and climate change. He covertly facilitated terrorist activities of Hizbul Muzahideen by providing food, shelter and other logistics to the terrorists and played a significant role in aiding, facilitating, guiding and abetting terrorist activities especially in south Kashmir. He used to provide crucial intelligence to the terrorists regarding movement of security forces, helping them to evade capture and launch counter attacks often resulting in casualties among security forces.

Azero tolerance policy has been adopted towards the anti-national elements who have been taking advantage of being in the Government service.

In February this year, LG Sinha had ordered the sacking of three J&K govt employees — a police constable, a teacher and an orderly in the forest department — for their alleged terror links. These three government employees — police constable Firdous Ahmad Bhat, teacher Mohammad Ashraf Bhat and orderly in the forest department Nisar Ahmad Khan — were dismissed from services under Article 311 2(c) of the Constitution of India.

Their termination orders were signed by the LG a day after he chaired a security review in Jammu and directed the police and security agencies to step up anti-terror operations by focusing on not just neutralising terrorists but also dismantling the terror eco-system that includes terror sympathisers, moles and violence mongers embedded within the J&K administration.

Pertinently the services of almost half-dozen employees have been terminated since popular government came into being in the Union Territory of Jammu and Kashmir, while over 70 government employees have been fired by the Lieutenant Governor Manoj Sinha-led administration in the Union Territory for their terror links in the past few years

Police have also seized objectionable materials, pamphlets, and electronic devices including mobile phones from the arrested individuals. Preliminary investigations suggest these individuals were actively engaged in recruiting youth and spreading separatist propaganda despite their parent organisations being banned under the UAPA.

"These individuals were not only promoting extremist ideologies but were also attempting to revive separatist movements by motivating impressionable youth and recruiting new members (Rukuns) into banned outfits," the police stated.

The arrests underline the commitment of Bandipora Police to dismantling terror-support networks and ensuring peace and stability in the region. Authorities reiterated that anyone found furthering separatist or extremist agendas will face strict legal consequences.

"Persons promoting secessionist and separatist ideology will face firm action under the law. Bandipora Police remains committed to ensuring peace and security across the district," the statement added.

A few other petitions are yet to be listed before the bench by the apex court registry.

The Centre, on April 8, filed a caveat in the apex court and sought a hearing before any order was passed in the matter.

A caveat is filed by a party in the high courts and the apex court to ensure that no orders are passed without hearing it.

The central government on Tuesday notified the Waqf (Amendment) Act, 2025, which got the assent of President Droupadi Murmu on April 5 after its passage from Parliament following heated debates in both houses.

The bill was passed in the Rajya Sabha with 128 members voting in favour and 95 opposing it. It was cleared by the Lok Sabha with 288 members supporting it and 232 against it.

The All India Muslim Personal Law Board (AIMPLB), Jamiat Ulama-i-Hind, the Dravida Munnetra Kazhagam (DMK), Congress MPs Imran Pratapgarhi and Mohammad Jawed are other key patitioners

On April 7, a bench headed by the CJI assured senior advocate Kapil Sibal, appearing for Jamiat Ulama-i-Hind, to consider listing the petitions.

The DMK moved the top court through its deputy general secretary A Raja and said in a press release, "Despite widespread opposition, the Waqf Amendment Bill, 2025 was passed by the union government without proper consideration of the objections raised by the members of the JPC and the other stakeholders."

The party said the immediate implementation of the Waqf (Amendment) Act, 2025 infringes and prejudices the rights of about 50 lakh Muslims in Tamil Nadu and 20 crore Muslims in other parts of the country.

The AIMPLB filed the plea in the top court late April 6.

In a press statement, SQR Ilyas, the AIMPLB spokesperson, said the petition strongly objected to the amendments passed by Parliament for being "arbitrary, discriminatory and based on exclusion".

The amendments, it said, not only violated the fundamental rights guaranteed under Articles 25 and 26 of the Constitution of India but also clearly revealed the government's intention to take complete control over the administration of Waqf, therefore, sidelining the Muslim minority from managing their own religious endowments.

Articles 25 and 26 of the Constitution ensure freedom of conscience, the right to practice, propagate religion, and the right to establish and manage institutions for religious and charitable purposes, it said.

The plea is settled by advocate MRShamshad, with advocate-on-record Talha Abdul Rahman representing the Muslim personal law board, through its General Secretary Maulana Fazlur Raheem Mujaddidi.

Jamiat Ulama-i-Hind also filed a petition in the apex court, claiming it was a "dangerous conspiracy" to strip Muslims of their religious freedom.

In its petition, Jamiat said the law was a "direct attack on the country's Constitution, which not only provides equal rights to its citizens but also grants them complete religious freedom".

In its separate plea filed in the top court, Samastha Kerala Jamiathul Ulema, a religious organisation of Sunni Muslim scholars and clerics in Kerala, has claimed the Act was a "blatant intrusion" into the rights of a religious denomination to manage its own affairs in the matter of religion.

Jawed's plea alleged the Act imposed "arbitrary restrictions" on Waqf properties and their management, undermining the Muslim community's religious autonomy.

The petition, filed through advocate Anas Tanwir, said the law discriminated against the Muslim community by "imposing restrictions that are not present in the governance of other religious endowments".

In a separate plea, Owaisi said it took away from Waqfs various protection which are accorded to Waqfs, and Hindus, Jain and Sikh religious and charitable endowments alike.

"This diminishing of the protection given to Waqfs while retaining them for religious and charitable endowments of other religions constitutes hostile discrimination against Muslims and is violative of Articles 14 and 15 of the Constitution, which prohibit discrimination on the grounds of religion," said Owaisi's plea, filed through advocate Lzafeer Ahmad.

NGO Association for the Protection of Civil Rights also filed a petition in the apex court challenging the constitutional validity of the Act.

AAP MLA Khan sought the law declared as unconstitutional, being violative of "Articles 14, 15, 21, 25, 26, 29, 30 and 300-A of the Constitution".

Indian women's hockey team to tour Australia for five-match series

NEW DELHI: The Indian women's hockey team will tour Australia for a five-match series scheduled from April 26 to May 4, Hockey India said on Thursday.

India will open the series with two matches against Australia A, followed by three games against the senior Australian team.

The tour will begin with back-to-back matches against Australia A on April 26 and 27, followed by three high-intensity games against the world No.5 ranked Hockeyroos on May 1.3 and 4.

All fixtures will be held at the Perth Hockey Stadium. The tour will serve as vital preparation ahead of their European leg of the FIH Pro League 2024-25, which kicks off in June.

Ninth ranked India enter the series on a high after a spirited performance against world No.1 Netherlands, securing a 2-2 draw and clinching the bonus point in a thrilling shootout

in Bhubaneswar. India also have recent success against Australia to draw confidence from. In their last encounter during the FIH Pro League 2023-24, India emerged winners 1-0.

Historically, however, Australia hold the upper hand, having won 10 out of the 16 matches played between the two sides since 2013. India have registered three wins while three matches have ended in draws.
