IAMMU: Northern Army Commander Lieutenant General MV Suchindra Kumar on Friday complimented the troops for their swift action in neutralising a terrorist in Kishtwar, and reiterated the army's commitment to keeping the region free

One terrorist was killed in an encounter with security forces in Jammu and Kashmir's Kishtwar district on Friday, while a combing operation is underway in Udhampur district, army officials said.

"Lt Gen MV Suchindra Kumar, Army Commander, Northern Command, commends the White Knight Corps for their swift action and precise execution in neutralising one terrorist in the ongoing operation in Kishtwar," the Northern Command said in a post on X.

"The Indian Army stands by its



commitment to keep Jammu and Kashmir terror-free," Lt Gen Kumar said.

According to the White Knight Corps, the encounter occurred during a search-

and-destroy operation jointly launched by the army and police in the Chatru forest area of Kishtwar district.

During the operation, the security forces made contact with the terrorists.

"The terrorists were effectively engaged, leading to a gunfight. One terrorist has been neutralised so far," the White Knight Corps, or 16 Corps, posted on X.

Search operations are also underway in the Jopher-Marta forest area in Udhampur district, officials said.

Equipped with sniffer dogs and aerial surveillance, multiple security teams are combing the entire forest area to track down three terrorists believed to be hiding there.

Police and security forces have been monitoring terrorist movements in these hilly areas for the past 19 days, during which five encounters

SRINAGAR: Asking the neighboring country to with India, National Conference (NC) President, Dr Farooq Abdullah on Friday said that J&K would never become a part of Pakistan.

Talking to reporters, Dr Farooq, as per the news agency—Kashmir News Observer (KNO) said that the government cannot bring Kashmir Pandits to their homes until they feel secure and safe here in

the Valley. "We have to prepare the conditions for it, which cannot be done through speeches as the ground work needs to be done in this regard," he said, adding, "If we want to bring them back, we need to tell the neighbouring country to stop the terrorism. Enough is enough, we cannot be part of Pakistan, but we can live like friends. The fear will prevail till terrorism continues."

"I remember Atal Bihari Vajpayee's saying that friends can be changed but not neighbours. If we have good relations with each other, both the countries will progress, but the hostilities will only hamper the pace of progress, which is being witnessed today," About the closure of Jamia Masjid, he said what message are they giving to the people. "Is it indicating the peace here? How can we ask frequent closure of Jamia Masjid where the people used to pray," he said.

Saudi Govt's visa suspension won't impact Hajj pilgrims from J&K: Officials

SRINAGAR: The Saudi Arabia government's recently imposed temporary ban on the issuance of Umrah, tourist and visit visas ahead of the Hajj-2025 has sparked concerns among the aspiring

However, the officials, who spoke to the news agency-Kashmir News Observer (KNO) clarified that this move was a routine pre-Hajj measure and will not affect the upcoming Hajj pilgrimage from India, including

Jammu & Kashmir.

Executive Officer of the J&K State Hai Committee, Dr Shuiaat Ahmad Qureshi, clarified that the ban applies specifically to Umrah, tourist and visiting visas and has been enforced in coordination with multiple countries.

this decision will prevent the misuse of Umrah or visit visas by individuals, attempting to perform Hajj illegally—a problem that affected accommodations and logistics in previous years.

"Last year, those who went

on Umrah or other visas often stayed back and performed Hajj without authorisation, which led to overcrowding, particularly in Mina tents," the senior officer said. "This year, such practices will be curbed due to the ban and legitimate pilgrims will benefit with better access to facilities."

He added that this was done every year, typically a few days before Hajj, however, this time the visa suspension was imposed $nearly\,20\,\hat{days}\,in\,advance, stating$ that might have caused some confusion.

The Executive Officer of the &K State Haj Committee said that the move is expected to streamline the Hajj process and reduce issues faced by officially registered often encountered logistical challenges due to overlapping stays by non-Hajj visa holders."It helps avoid unnecessary crowding and mismanagement, especially

JK likely to require additional 1862 MU power in 2026-27

SRINAGAR: Amid surge in power demand, Jammu and Kashmir is likely to require additional 1862.53 Million Units (MUs) of power from the year 2026-27.

The concerned authorities have projected that there will be a peak electrical requirement of 22,507 MU in the year 2026-27 with 3566 Megawatts peak electricity demand.

The documents further said that some intra-state transmission



schemes are being planned to be implemented through Tariff Based Competitive Bidding (TBCB) route by Jammu and Kashmir, Damodar Valley Corporation (DVC) and Rajasthan.

In the meantime, the recent economic survey of the Jammu and Kashmir government reveals that from the fiscal 2020-21 to the year 2023-24, the power usage in the region had increased from 17,721.76 MU to 20,644.47 MU.

Recently, the government had said that Jammu and Kashmir had generated over 16,300 MUs of electricity from different hydel power projects in the year 2023-24.

As already reported by KNO, Jammu and Kashmir is likely to witness nearly 15 percent increase in peak power demand by the upcoming fiscal. An official had said that till the ongoing fiscal, Jammu and Kashmir has touched a peak power demand of nearly 3000-3100 Megawatts (MW) of power. The official documents in this regard states that the region was having actual peak power demand of 2675 MW till the year 2016-17.

Three terrorists killed in Kishtwar encounter, operation continues

KISHTWAR: Two more terrorists have been killed in the ongoing operation in the Chhatru forest area of Kishtwar district in Jammu and Kashmir taking the toll to three terrorists killed so far.

Earlier One terrorist body was recovered from the operation site by the security forces. The Exchange of fire had resumed between terrorists and security forces in the Chhatru forest area of Kishtwar district early Friday morning after three continuous days of massive search operations in the area.

According to top security officials, three dead bodies of the terrorists have been recovered along with arms and ammunition from the operation site. Security forces believe that all the killed terrorists are foreigners.



Sharper probes, better prosecution to boost convictions in NDPS cases: Chief Secretary

JAMMU: Chief Secretary, Atal Dulloo, chaired the 13th UT Level NCORD (Narcotics Coordination) meeting to review progress on tackling drug trafficking and abuse across Jammu & Kashmir.

The meeting highlighted key achievements, ongoing challenges and future strategies to curb the menace of narcotics in the region.

During the meeting, the Chief Secretary gave a set of comprehensive directions aimed at tightening the enforcement and judicial mechanisms under the NDPS (Narcotic Drugs and Psychotropic Substances)

Act. He underscored the urgent need to adopt a multi-pronged strategy combining strict law enforcement, judicial efficiency and community awareness to successfully deal with this menace.

In a significant decision, the Chief Secretary asked for constitution of District Monitoring Committees in each district of the UT. These committees, to be headed by the respective Deputy Commissioners, with SSPs and Public Prosecutors as members, will be responsible for regularly monitoring the status of NDPS cases. NIA court sends Mumbai attacks mastermind to 18-day custody

NEW DELHI: The NIA special court at Patiala House here sent Mumbai attacks mastermind Tahawwur Hussain Rana to 18-day NIA custody on Friday.

According to the details available with the news agency-Kashmir News Observer (KNO), the court also directed the NIA to conduct a medical examination of Rana every 24 hours, and allow him to meet his lawyer every alternate day.

Pertinently, the National InvestigationAgency"successfully secured the extradition" of Tahawwur Hussain Rana, a key accused in the 26/11 Mumbai terror attacks, from the United States and brought him to the national capital on

Thursday.

Rana was arrested formally immediately after his arrival at Indira Gandhi International Airport in New Delhi, following his successful extradition from



the United States.

The NIA on Friday began Rana's questioning to unravel the larger conspiracy behind the deadly terror strikes of 2008 in which 166 persons were killed and over 238 sustained injuries.

Rana was brought to the NIA headquarters early this morning and is being kept in a highly-secured cell, inside the anti-terror agency's head office at CGO complex here, being

guarded by security personnel round the clock.

The investigation is being led by NIA's Deputy Inspector General (DIG) Jaya Roy, who is also the Chief Investigating Officer.

The interrogation, sources said, is focused on getting more details on his possible connection with Pakistan-based terror group Lashkar-e-Taiba(LeT), which had

orchestrated the attacks.

NIA Interrogates Tahawwur Rana To Unravel Larger Conspiracy Behind 26/11

Agency (NIA) on Friday began questioning of Mumbai attacks mastermind Tahawwur Hussain Rana here to unravel the larger conspiracy behind the deadly terror strikes of 2008, official sources said.

Rana was brought to the NIA headquarters early Friday morning after a Delhi court granted 18-day custody to the probe agency, following his extradition from the US.

Rana is being kept in a highly-secured cell, inside the anti-terror agency's head office at CGO complex here, being guarded by security personnel round the clock, the sources said.

A 24×7 surveillance is being maintained and Rana has been provided with basic necessities like food and meals among others, they said.

The investigation is being led by NIA's Deputy Inspector General (DIG) Jaya Roy, who is also the Chief Investigating Officer, they said.

"Rana will remain in NIA custody for 18 days, during which time the agency will question him in detail in order to unravel the complete conspiracy behind the deadly 2008 attacks, in which a total of 166 persons were killed and over 238 injured," said a statement issued by the probe agency soon after the court's order.

It is learnt that the interrogation is focussed on getting more details on his possible connection with Pakistan-based terror group Lashkar-e-Taiba (LeT), which had orchestrated the attacks.

The 64-year-old Pakistani-origin Canadian businessman – a close associate of key Mumbai terror attacks conspirator David Coleman Headley alias Daood Gilani (a US citizen) – would also be questioned



on his suspected links with the officials of Pakistan spy agency Inter-Services Intelligence (ISI) and his exact role behind the attack, the sources said.

The investigators also hope to find some important leads on his travels in parts of northern and southern India, days before the carnage in the country's financial capital on November 26, 2008, they said.

Rana visited Hapur and Agra in Uttar Pradesh, Delhi, Kochi, Ahmedabad, and Mumbai with his wife Samraz Rana Akhtar between November 13 and November 21, 2008, the sources said.

They said there could have been a larger conspiracy aimed at targeting other places across the country behind his visits to these places, and the exact details would be ascertained only after his interrogation.

Incidentally, Rana's custodial interrogation comes at a time when senior Maharashtra-cadre Indian Police Service (IPS) officer Sadanand Vasant Date is at the helm of the NIA. Date, who was then posted as an Additional Commissioner

The NIA claimed in the court that it suspects terror plots akin to 26/11 Mumbai attacks were devised by Rana to target multiple Indian cities.

The court remanded Rana in 18-day NIA custody. In its order, the court also directed the NIA to conduct a medical examination of Rana every 24 hours, and allow him to meet his lawyer every alternate day.

NIA office has been beefed up. Central Reserve Police Force (CRPF) and Delhi Police personnel are guarding the outer periphery of NIA headquarters.

The NIA had secured Rana's extradition from the US following years of sustained efforts, and after the terror mastermind's last-ditch efforts to get a stay on his extradition from the US failed.

With the coordinated efforts of India's Ministry of External Affairs and Ministry of Home Affairs, along with the relevant authorities in the US, the surrender warrant for the wanted terrorist was eventually secured and the extradition was carried

The anti-terror agency had registered a case on November 11, 2009 under sections 121 A of Indian Penal Code (IPC), Section 18 of Unlawful Activities (Prevention) Act and Section 6(2) SAARC Convention (Suppression of Terrorism) Act against Headley, his childhood friend Rana and

Rana is charged with numerous offenses, including conspiracy, murder, commission of a terrorist act, and forgery in the country.

During the NIA investigation, the roles of senior functionaries of terror groups LeT and Harkat-ul Jihadi Islami (HuJI) — Hafiz Muhammad Saeed alias Tayyaji, Zaki-ur-Rehman Lakhvi,

Sajjid Majid alias Wasi, Illyas Kashmiri, and Abdur Rehman Hashim Syed alias Major Abdurrehman alias Pasha — had emerged, the officials said. They worked in active connivance with officials from the ISI, namely Major Iqbal alias Major Ali and Major Sameer Ali alias Major Samir, according to the NIA probe.

SC reserves verdict on ex-CM Yediyurappa's plea against revival of corruption case

its verdict on a plea of senior BJP leader and former Karnataka Chief Minister B S Yediyurappa against an order reviving a corruption case against him.

The Karnataka High Court, on January 5, 2021, allowed a plea of complainant A Alam Pasha, who hails from Bengaluru, and revived his complaint.

Pasha alleged corruption and criminal conspiracy against Yediyurappa and former Industries minister Murugesh R Nirani and Shivaswamy KS, former managing director of Karnataka Udyog Mitra.

The high court ruled the absence of prior sanction for prosecution-leading to the quashing of an earlier complaint—did not bar the filing of a fresh complaint once the accused had demitted office.

It, however, did not allow criminal prosecution of V P Baligar, a retired IAS officer and former Principal Secretary of the State Government, in the corruption case.

On April 4, a bench comprising Justices J B Pardiwala and Manoj Misra concluded the hearings and framed several key legal questions for its adjudication including whether after a Judicial Magistrate has ordered probe under Section 156(3) of Code of Criminal Procedure (CrPC), would a prior sanction of the appropriate Government authorities be still required under Section 17A of the Prevention of Corruption (PC) Act.

Section 156(3) of the CrPC permits a judicial magistrate to order a police investigation into a complaint and it may include order for a preliminary inquiry or registration of an FIR.

Section 17A of the PC Act says, "No police officer shall conduct any enquiry or inquiry or investigation into any offence alleged to have been committed by a public servant under this Act, where the alleged offence is relatable to any recommendation made or decision taken by such public servant in discharge of his official functions or duties, without the previous approval..."

The top court framed seven crucial legal questions, primarily focusing on the interplay between various provisions of the PC Act and the

NEW DELHI: The Supreme Court has reserved CrPC on the issue of prior sanction to prosecute a public servant and power of the judicial magistrate to entertain a private complaint and order probe and an FIR.

"What are the relevant considerations as contemplated by Section 17A of the Prevention of Corruption Act, 1988 which the appropriate authority or Government is expected to look into before the grant of approval for initiation of any enquiry, inquiry, or investigation by the police?" read the first question the bench framed.



Whether the considerations which weigh with the appropriate authority or Government while granting approval under Section 17A of the PC Act are fundamentally so different from the one that a magistrate is ordinarily expected to apply while passing an order under Section 156(3) of the CrPC, read the second issue. "In other words. whether the considerations under Section 17A of the PC Act are of such a nature that they are necessarily beyond the ambit or scope of consideration by a Magistrate while directing an investigation under Section 156(3) of the CrPC," the bench said. The top court asked if it could be said that once a magistrate has applied his mind under Section 156(3) of the CrPC, the requirement of a prior approval under Section 17A of the PC Act is meaningless, redundant and no longer necessary.

Varanasi developed under PM Modi's leadership: Yogi Adityanath

VARANASI (UP): Devotees from all over the country are flocking to see the new Kashi which has developed under the leadership of Prime Minister Narendra Modi in the last 11 years, Chief Minister Yogi Adityanath said on Friday.

His remarks came after the prime minister inaugurated and laid the foundation stone of 44 projects worth Rs 3,880 crore in his parliamentary constituency.

"Everyone has seen Kashi changing in the last 11 years. This is the same Kashi, which was known for its narrow streets and traffic jams. Kashi has been an ancient centre of education, but along with the centres of education lying in disarray, projects worth more than Rs 50,000 crore have come here in the last 11 years for health, tourism, connectivity," he said. A dityanath noted that this was the first visit of the prime minister to Varanasi after the historic victory of the BIP in the Haryana, Maharashtra and Delhi assembly elections as well as the organisation of the Maha Kumbh.

Kashi also became a witness to this divine and grand Maha Kumbh, he said.

"Every devotee coming from the country and the world was eager to see this new Kashi and the holy land of Baba Vishwanath in a new form under the leadership and guidance of the prime minister in the last 11



years. On the occasion of this 45-day event, a grand gathering was also seen in Kashi and during this time more than 3 crore devotees came here and became a part of the virtue by visiting the holy abode of Baba Vishwanath," Adityanath said. He also said that after the Namami Gange project, every devotee who took a dip in the confluence of Ganga, Yamuna and Saraswati felt overwhelmed.

"Due to the success of the Namami Gange project, the Maha Kumbh has also been successful," Adityanath said.

The UP chief minister also said that efforts of the prime minister to provide national and international recognition to the products of Kashi and Uttar Pradesh have proved fruitful.

"Kashi and its neighbouring districts have

received the maximum number of GI tags so far and Uttar Pradesh is achieving the number one position in GI tags in the country. Certificates for 21 new GI tags are also being $provided \, today \, by \, the \, prime \, minister. \, These \,$ efforts have been made to give a new identity to the products of local handicraftsmen and artisans at the national and international level," he said.

The Ayushman Bharat scheme has also proved to be a milestone in providing health facilities to the poor, he said.

Rana's extradition a big breakthrough, will reveal real plot of 26/11 attacks: Ajit Pawar

PUNE: Maharashtra Deputy Chief Minister Ajit Pawar on Friday termed Tahawwur Hussain Rana's extradition a major breakthrough and said it would help unravel the crucial details of the conspiracy behind the 26/11 Mumbai terror attacks.

The 64-year-old Canadian citizen of Pakistani origin, a key accused in the case, landed in Delhi in a special plane from Los Angeles Thursday evening. A special court subsequently remanded him in the custody of the National Investigation Agency (NIA) for 18 days.

Rana is accused of conspiring with David Coleman Headley alias Daood Gilani, and terrorist organisations Lashkar-e-Taiba (LeT) and Harkat-ul-Jihadi Islami (HUJI) along with other Pakistanbased co-conspirators, to carry out the three-day terror siege that killed 166 people.

Speaking to reporters in Pune, Pawar recalled being present in



Mumbai during the 2008 attacks along with the then chief minister Vilasrao Deshmukh and home minister R R Patil.

"After the operation, we visited all the attack sites. A probe was launched to identify the masterminds. Now that this man(Rana) has been extradited to India, it will come to light who were behind the attacks, on whose orders he acted and what their objective was," Pawar said.

Pawar was here to pay tribute to Mahatma Phule at Phule Wada on the birth anniversary of the iconic social reformer.

Asked about the discontent expressed by senior OBC (Other Backward Class) leader and his NCP colleague Chhagan Bhujbal over the slow pace of Phule Wada's expansion, Pawar said he has directed the Pune civic body to expedite the work and ensure land acquisition for the

"Rhuihal saheh won't have to go on a hunger strike. The work will be completed," he said.

Bhujbal, who has been vocal about not being nominated for the Rajya Sabha or given a ministerial berth in the state, had said on Thursday that since he holds no position in the government, he could sit on a fast to push for the expansion of the Phule memorial.

Referring to the death of a pregnant woman after she was allegedly denied admission at Deenanath Mangeshkar Hospital in Pune, Pawar said action will be taken once the third report on the matter is received by the state government.

Asked whether he had forgotten the protests he had led against rising fuel and LPG prices while in the opposition, Pawar said, "I haven't forgotten. But global fuel price fluctuations are real. After Donald Trump came to power in the US. His tariff policies have affected the global economy.' Though there has been a hike of Rs 50 (per LPG cylinder), Prime Minister Narendra Modi has told oil companies not to increase prices and bear the difference themselves, he claimed. "Since Home Minister Amit Shah is in the state, we will discuss the issue with him," he added.

A bench of Justices Abhay S Oka and Ujjal Bhuyan questioned the agency on how it had filed a writ petition under Article 32 of the Constitution meant for individuals.

Article 32 of Constitution guarantees the "Right to Constitutional



Remedies," empowering individuals to seek redressal from the Supreme Court for violations of their fundamental rights, allowing them to directly approach the court for enforcement of these rights.

Following the bench's remarks, additional solicitor general SV Raju sought its permission to withdraw the plea and said, "ED also has fundamental rights." "In a lighter vein, if ED has fundamental rights, it should think about fundamental rights of people too," the bench said. The court then allowed Raju to withdraw the plea. The Enforcement Directorate (ED) last year claimed former IAS

Govts that didn't implement Ayushman Bharat scheme in states voted out of power, Bengal's turn next: Nadda

NEW DELHI: Union Health Minister and BJP chief J P Nadda took a dig at political opponents on Thursday, saying the state governments that did not implement the Ayushman Bharat scheme were voted out of power and asserting that it is West Bengal's turn next. After signing a memorandum of understanding (MoU) on April 5 to implement the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), the Delhi government on Thursday signed another MoU with the Centre for the implementation of the Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), which was launched in October 2021 to ensure that the public health infrastructure effectively manages future pandemics and outbreaks of diseases. Addressing a gathering after the signing of the MoU, Nadda said the AB-PMJAY is the world's largest health-coverage programme under which 62 crore people are currently being benefitted. "It is a moment of pride that 36 lakh people in Delhi will be benefitted by the AB-PMJAY now," he added.

Nadda also informed that with the implementation of the AB-PMJAY in Delhi, all senior citizens aged 70 years and above, irrespective of their socio-economic status, will be covered under the Ayushman Vay Vandana Yojana.

He highlighted that 8.19 crore people have already availed treatment under the scheme and the government has spent a total amount of Rs 1.26 lakh crore for the same. Of the beneficiaries, 19 lakh were downtrodden people who could not have afforded these treatment without the Ayushman Bharat health coverage, he said. "As a result of the Ayushman Bharat scheme, out-ofpocket expenditure has declined from 62 per cent to 38 per cent today," Nadda said.

He reiterated that the AB-PMIAY is an "assurance" and not an "insurance" scheme, whereby the government assures the beneficiaries of a Rs 5-lakh health coverage and on top of that, the Delhi government has added another Rs 5 lakh, amounting to a total coverage of Rs 10 lakh.

Nadda said Delhi faced a black chapter for seven years as even though the scheme was launched in 2018, 36 lakh people, including six lakh elderly



people, remained deprived of its benefits.

"There is a need for you to ponder on how your rights are curtailed when a wrong government comes to power. And when the right government comes, you get what is rightfully yours within 50 days," he said. Three states had refused to implement the Avushman Bharat scheme, Nadda said.

"One was Odisha, where the previous government fell and the lotus (the BJP's poll symbol) bloomed. The second one was Delhi, where the government was voted out of power and the lotus bloomed. Now, only one state – West Bengal – remains. There too the lotus will bloom and the government would be ousted," the Bharatiya Janata Party chief said.

Dilapidated iron bridges in Bandipora endanger commuters

Schoolchildren, SFs navigate daily risks, locals demand concrete replacements

BANDIPORA: Several dilapidated iron bridges along key routes in north Kashmir's Bandipora district have become a growing concern for commuters, locals and officials alike.

With some of these bridges witnessing frequent VIP movement, military convoys, and regular public traffic, the crumbling infrastructure now poses a serious safety risk.

Among the most affected is the iron bridge at Naninara Sumbal, located on the vital Bandipora-Srinagar road. This bridge, which has long shown signs of wear and tear, is now in a severely deteriorated condition. Large cracks, rusted joints and shaky supports have made it increasingly dangerous for both pedestrians and vehicular traffic.

Another iron bridge at Guroora, also on the

Bandipora-Srinagar road, has been damaged multiple times in the past, yet no substantial repair work or replacement has been under-

"Every time it rains or a heavy vehicle passes, we fear the bridge might collapse. It's been

patched up too many times, but we need a permanent solution," said Abdul Hameed, a local shopkeeper near the site.

In Chattibandi-Aragam, a similar situation persists. The iron bridge on this route, being used frequently by security forces and local commuters shows extensive rusting and structural fatigue.

Residents of the area said that schoolchildren and the elderly are often forced to cross with extreme caution, fearing sudden collapse or injury.

"These are not just any village paths; they are lifelines for Bandipora, connecting major areas and facilitating administrative, military, and public movement," said Fayaz Ahmad, a daily commuter. "We don't want to wait for a tragedy to happen before authorities take notice."

Locals said that concrete bridges should replace these outdated iron structures to ensure longterm durability and safety. They said that while smaller villages across Kashmir are getting upgraded road infrastructure, Bandipora's key routes remain neglected.

Meanwhile, locals have urged both the Sonawari and Bandipora MLAs to look into the matter and ensure prompt action is taken, so that commuters no longer have to suffer due to the deteriorating condition of these crucial bridges—(KNO)

Teachers Forum Criticizes 'Bizarre' Directives from **CEO Bandipora**

Seeks Review in Light of NEP 2020

Bandipora, April 11: The Jammu & Kashmir Teachers Forum (JKTF), Bandipora unit, has raised concerns over directives issued by the Chief Education Officer (CEO) Bandipora, calling them "bizarre, impractical and misaligned" with the National Education Policy (NEP) 2020.

While the forum welcomed the CEO's efforts to improve accountability and functioning within the education department, it flagged two key directions as problematic - the "10% staff on duty or leave" rule and the proposal for a "uniform MDM menu across zones."

In a statement issued by District Spokesperson and General Secretary JKTF Bandipora, Anjum Nisar, the forum said that the directive allowing only 10% of the staff to be on duty or leave in a single day lacks contextual awareness.

statement read.

"How can such a rule schools with only two or three teachers? It either denies basic leave rights or renders multi-grade classrooms unmanageable," the

Calling the directive "illogical and unworkable," the forum urged the CEO's office to adopt a flexible, school-specific approach that empowers ZEOs and headmasters to manage attendance and leave schedules based on ground realities.

The Teachers Forum also expressed strong reservations about the proposed implementation of a uniform mid-day meal (MDM) menu across each zone, stating that it goes against the spirit of NEP 2020.

"The NEP promotes diversity, local food

cultures, and community participation in meal planning. Imposing a one-size-fits-all menu disregards cultural and dietary variations, local ingredient availability, and seasonal needs," said Anjum Nisar.

The Forum recommended that School



Management Committees, health officials, and local stakeholders be involved in creating flexible, inclusive MDM plans tailored to student needs, ensuring both nutrition and student engagement.

"We are not against reforms — we stand for meaningful reforms that are child-centric, teacher-respecting, and practically achievable. But policies must be designed in consultation with those who work on the ground." the statement concluded.

The JKTF Bandipora appealed to the CEO to review and revise the directives in consultation with educators and grassroots representatives to ensure alignment with national policy and local realities.

ACS Education reviews upcoming college admissions, NEP 2020

JAMMU: The Higher Education Department today convened a high level meeting in the Civil Secretariat, Srinagar, under the chairmanship of Shantmanu, Additional Chief Secretary, Education.

The meeting was attended by Director Colleges, Higher Education Department, Deans of Academic Affairs and Registrars from the University of Kashmir, University of Jammu, Cluster University Jammu and Cluster University Srinagar besides Principals of autonomous colleges, Government College for Women, Parade Jammu, GDC Baramulla and Islamia College of Science and Commerce, Srinagar.

The deliberations centered on critical issues pertaining to undergraduate admissions for the upcoming 2025-26 academic year and crucial progression of students to the 4th year under the transformative National Education Policy (NEP) 2020 besides other NEP related initiatives.

The meeting took several decisions aimed to smoothen the admission process for upcoming UG 2025-26 admissions. It was decided that the Universities across the Union Territory will formulate and implement statutory provisions by the end of this month, facilitating lateral entry for eligible polytechnic students into the 2nd year(3rd semester) of Four Year Undergraduate Program of Degree Colleges.

It was decided that admissions would continue to be granted through both CUET and non-CUET modes, aligning with established practices. However, timelines will be thoroughly reviewed and optimized to ensure greater student convenience and accessibility. In order to optimize the process, Director Colleges will coordinate and oversee the admission process, working in close liaison with the universities to ensure strict adherence to stipulated timelines. All the universities are mandated to

establish statutory mechanisms and guidelines as provisioned under NEP 2020 for multiple exit options at the end of the 1st and 2nd year, providing students with greater portability. Besides, the Universities shall come up with an implementation plan in terms of requirement of additional credits for award of Certificate or Diploma.



It was further decided that the Director Colleges, Higher Education Department, will undertake a reclassification of colleges based on admission grant criteria on CUET or NON -CUET, pre informing students and institutions, so that aspirants seek admissions without any ambiguity.

The ACS asked for ensuring that the admission process is completed well within the time to ensure adherence to the academic calendar. He said that the admissions should be centralized at the directorate level, instructing the Director Colleges to start the process of developing a robust centralized admission system. The meeting also took decisions regarding progression of students to 4th Year of NEP in Honours and Research Mode and finalisation of the statuary provisions by the Universities for admission to 4th year under the Honours and Honours with Research programs. The exercise is to be completed by the month end to ensure smooth transition to 4th Year for enrolled students.

It was decided that the transition to the 4th year will be implemented in a phased and calibrated manner. The students will be duly informed about the modalities of transfer from various degree colleges to facilitate their pursuit of quality research and Honors programs. It was clarified that 4th Year programs will be offered at selected institutions, necessitating the student mobility across institutions.

The ACS instructed the Universities to finalise statutory provisions without delay to facilitate the identification and offering of courses through the SWAYAM platform, thereby enhancing credit transferability and providing students with greater academic flexibility. An Action Taken Report, in this regard, will be submitted by the HEIs to the Higher Education Department by the month end, he added.

He affirmed the department's commitment towards coordinating with the National Testing Agency (NTA) at the highest level, to ensure that CUET examination is conducted with an increased number of centers within the UT with enhanced facilities.

Shantmanu reiterated that the Higher Education Department is committed towards taking all necessary steps to facilitate the smooth and effective implementation of NEP 2020 and to continuously improve the quality of higher education in Jammu and Kashmir. He appreciated the role of Universities in implementation of NEP for the undergraduate students.

The Jewish Dimension of Jerusalem in the Hellenistic-Hasmonean Period

The Second Temple period witnessed a series of efforts aimed at defining Jerusalem as the quintessential Jewish city by emphasizing its uniqueness and particularity. Ezra and Nehemiah's attempts to separate the city and its population from the surrounding regions and peoples was a religious policy which reflected Judaea's geographical and political isolation; this policy would be advocated by other authors and

Hasmonean hegemony were, in fact, reclaiming their ancestral homeland and, in fact, were obliged to eliminate all pagan worship. This led to the destruction of pagan shrines and, at times, to the death or exile of native populations. Ironically, it was precisely at this time that the institution of conversion first made its appearance in a Jewish context, as the Hasmoneans forced conversion upon the idumeans in the south and the ltureans in the north

3. The Hasmonean era witnessed an enhanced prominence of the Temple in Jewish life. The Hasmoneans rose to power as defenders of the Temple and its purity from foreign cults, and this achievement played a central role in their court propaganda, as indicated by II Maccabees and the letters prefacing that book. Brief references in I Maccabees and Josephus indicate that each and every Hasmonean ruler devoted energy and funds to improving and strengthening the Temple and its surroundings.

world was radically different from the Jerusalem of Ezra and Nehemiah. Alexander had married a Persian princess and compelled his officers and soldiers to wed Persian women. The message here was loud and clear: isolation, insulation, and estrangement were to be rejected; a meeting of cultures-symbiosis, synthesis, and even syncretism-were the order of the day. This, of course, is a far cry from the mass-divorce from non-Jewish spouses by members of the Jerusalem aristocracy that was advocated by Ezra and Nehemiah. Moreover, what had been of marginal significance before Alexander became much more central after his conquest.

The impact of Hellenism on the \sim r East in general, and on Judaea and Jerusalem in particular, was considerable. From the very beginning of this era, there are indications of Jerusalem's .. participation in the life of the wider Hellenistic world, such as its diplomatic relations with Sparta, which developed

der, Diodorus, Apollonius, Eupolemus, Antiochus, Numenius, Antiochus, Jason, Antipater, and Aeneas.

Under Hasmonean rule (141-63 B.C.E.), instances of Hellenization within Jerusalem became more commonplace. The document in I Mace. 14, recording the public appointment of Simon as leader, high priest, and strategos, is written in a style strikingly reminiscent of documents from the Hellenistic world. The structure of this declaration, the claims put forward to justify and explain this appointment, the use of purple robes and gold ornaments by the Hasmoneans, the dating of an era commencing with Simon's appointment, and, finally, recording the text of this document on bronze tablets and placing them in a prominent place in the Temple area and in the (Temple?) treasury are well-known Hellenistic practices.

Beginning with the second generation, the Hasmoneans began adopting Greek names in addition to



The emergence of apocalyptic literature in the third and second centuries is a further expression of Jewish particularism, as was the newly established centrality of the Torah in Jewish religious life, a centrality which found expression in Sabbath and festival communal-reading frameworks that crystallized during this period. This introversive focus on the Jewish body polity was given a dramatic boost in the mid-second century B.C.E., with the ascendance of the Hasmoneans and the establishment of a sovereign state boasting ambitious territorial designs.





their Hebrew ones: John Hyrcanus I (134-104 B.C.E.), Aristobulus I (104-103 B.C.E.), Alexander Jannaeus (103-76 B.C.E.), Salome Alexandra (76-67 B.C.E.), Aristobulus II (67-63 B.C.E.), Hyrcanus II (63-40 B.C.E.), and, finally, Antigonus (40-37 B.C.E.). Hellenization in the Hasmonean court is likewise reflected by the hiring of foreign mercenaries and, more poignantly, by the assumption of royalty by Aristobulus I, Alexander Jannaeus, and Aristobulus II. No less telling in this regard is the sole rule of a queen, Salome Alexandra. Hersmooth and unchallenged succession may well have been facilitated by contemporary Ptolemaic practice. Several burial monuments and graves discovered in Hasmonean Jerusalem similarly reflect a significant appropriation of Hellenistic forms.

The two principal remains of such funerary monuments, the priestly Bnei J.Iezir tomb from the Qidron Valley to the east of the city and Jason's tomb (also probably belonging to a priestly family) to the west (in today's Re}).avia neighborhood), were both built in typical Hellenistic fashion~the former with its facade in classic Doric style (columns, pilasters, and frieze), the latter with its single Doric column and pyramid-like monument. Both tombs feature kukhim (or loculi, rectangular niches cut perpendicularly into the tomb's wall for primary burials), a burial arrangement which reached Judaea from Alexandria and Palestine's southern coastal region (e.g., Marisa).

The tomb of Jason features scenes of merchant-and warships, a gazelle, as well as a series of menorah graffiti. Both of these tombs feature a variety of inscriptions, one in Hebrew in the Bnei Hezir tomb, and Greek and Aramaic ones in Jason's tomb. The tiny bronze coins minted by the Hasmoneans are a fascinating example of the cultural synthesis of Hellenistic and Jewish traditions. The very issuance of coins for economic and political purposes clearly reflects contemporary practice of both established kingdoms and newly-founded political entities seeking recognition and legitimacy.

sects down to the end of the Second Temple era. We have the testimonies of a number of Greek writers from the early Hellenistic period indicating the relative success of this policy.

Hecataeus of Abdera, for instance, describes the uniqueness of Jerusalem, its Temple, and people, as well as the success of Jewish society in preserving its ancestral traditions. Ben Sira advocates a similar posture, and the agenda of the second century Hasidim seems to have had an intensive Jewish focus.

Moreover, during these three centuries, between Ezra and Nehemiah on the one hand and the Hasmoneans on the other, a number of practices and literary works evolved which clearly expressed a particularistic social and religious thrust. This proclivity was expressed early on in a variety of ways, from banning foreign merchants on the Sabbath, emphasizing the use of Hebrew, to driving out foreign wives. The division of the Jewish population into priestly mishmarot and lay ma'amadot, each with semi-annual obligations in the Temple, also seems to have evolved at this time, as did a series of haidimic requirements, such as spending the "second tithe" in the city four times every seven years.

The emergence of apocalyptic literature in the third and second centuries is a further expression of Jewish particularism, as was the newly established centrality of the Torah in Jewish religious life, a centrality which found expression in Sabbath and festival communal-reading frameworks that crystallized during this period. This introversive focus on the Jewish body polity was given a dramatic boost in the mid-second century B.C.E., with the ascendance of the Hasmoneans and the establishment of a sovereign state boasting ambitious territorial designs.

Among the most prominent changes effected, the following may be noted:

1. The Hasmoneans radically altered the geographical concept of Eretzlsrael to include almost all of the territory west of the Jordan River and \cdot large tracts to its east; for the 400-or-so years beforehand, Jewish Judaea included only the region around Jerusalem, which \cdot was more or less contiguous with the Persian administrative region, Yehud.

2. Concomitant with the successful conquests, there crystallized an ideology that the Jews under

4. Together with the above campaigns to ban idolatry and reemphasize the Temple's prominence came a greater emphasis on matters of ritual purity within Jewish society. This new focus found expression in many of the halakhic decisions ascribed in our sources to the early Pharisees and the Qumran community. In the material culture, this emphasis is evident in the appearance of ritual baths (miqva'ot), and this tendency is further underscored by the almost exclusive use of local (as against imported) ware and by the more frequent recourse to using the ashes of a red heifer, intended for purification from corpse impurity. This rare sacrifice was reportedly offered seven times {five, according to another tradition) from the Hasmonean period onward, i.e., in the last two hundred years of the Second Temple period. Only two cases are noted for the previous millennium.

5. Jewish art underwent a radical change at this time, and was now characterized by the studious avoidance of any figural representation, either human or animal. Up to this point, such depictions were not uncommon in Jewish circles, from the cherubs over the holy ark and the lions of Solomon's throne, to the figurines found in Israelite settlements and the human and animal images on Yehud coins from Persian and Hellenistic Jerusalem. The magnificent Tobiad palace in Iraq el-Amir (between Jericho and Amman), dating from the early second century B.C.E., is adorned with majestic figures of eagles and lions carved in stone. However, commencing under the Hasmoneans and continuing for some three centuries, human and animal representations were not to be found in Judaea. Exceptions to this rule exist, but they are few and far between.

6. Finally, the emergence of Jewish sects-e.g., Pharisees, Sadducees, and Essenes (including the Qumran community as well), each with its own particular religious agenda-is a further indication of a more concerted Jewish emphasis at this time, at least within certain circles.

Understanding the Jewish component of Second Temple Jerusalem is necessary for an understanding of the city and its workings-necessary but not sufficient in and of itself. Another force at work in the wake of, and even before, Alexander's conquests of the East was Hellenistic culture, and this dimension was to shape the city profoundly.

The social and cultural message of the Hellenistic

in the third and second centuries (B.C.E. or its use of imported Rhodian wine, as attested by the discovery of hundreds of stamped amphora handles dating from the mid-third to the late second centuries B.C.E. Several books written or edited in the third century B.C.E., e.g., Ecclesiastes (Qohelet) and the Song of Songs, appear to reflect either Hellenistic genres (in the case of the latter) or the questioning of traditional Jewish values resulting, inter alia, from the impact of Hellenistic culture (in the case of the former). Contrastingly, a number of other books written at about this time express opposition to certain hellenizing tendencies, as, for example, Ben Sira and jubilees, although even these exhibit a certain measure of outside influence. The piece de resistance of Hellenization in Judaea, occurred in 175 B.C.E., when the high priest Jason con~erted Jerusalem into a Gr~ek polis replete with gymnasium and ephebeum (II Mace. 4). Whether this step represents the culmination of a 150-year process of Hellenization in Jerusalem, or whether it was the initiative of only a small coterie of Jerusalem priests with no wider cultural or social ramifications, has been debated for decades.

The answer may well lie somewhere between these two polar positions. In any event, Jason's move constituted a bold step in the city's adaptation to the wider world, a process which would be interrupted-albeit only temporarily-by the persecutions of Antiochus IV and the resultant Maccabean revolt. A further stage in the Hellenization process took place under Hasmonean rule. The motivation of the Hasmonean revolt has often been misunderstood. It has been contended that this revolt came in protest to the process and progress of Hellenization in Judaea, but this is patently not the case. The Maccabees revolted in response to the persecutions imposed by the king-a most exceptional policy for an enlightened Hellenistic king. It was an extreme measure and was undoubtedly motivated by the most unusual of circumstances, although there is little scholarly agreement as to precisely what these were.

Following their victory, the Hasmoneans themselves quickly adopted Hellenistic mores; they instituted holidays celebrating military victories (Nicanor Day on the 13'h of Adar), as did the Greeks; they signed treaties with Rome and forged close alliances with the upper strata of Jerusalem society, whose hellenized proclivities are attested by names such as Alexan-

and facilitate their speedy trial and disposal, he added. He also directed that a police station-wise review of all NDPS cases be carried out regularly to strengthen the quality of prosecution and enhance conviction rates.

The Chief Secretary also took stock of various FIRs registered years ago in different police stations that remain pending for final disposal. He asked the Deputy Commissioners and SSPs to personally monitor the progress on such cases and ensure investigations are concluded without any further delay.

The Chief Secretary raised concerns over underutilization of court time in handling NDPS cases, often due to gaps in the investigation process. He emphasized the need to identify these lacunae and hold officials accountable, particularly in instances where defective charge sheets (challans) delay or derail the judicial process. He asked the Police Department to closely examine whether procedural delays or poor-quality investigations were causing bail or acquittals, especially in serious cases involving commercial quantities of narcotics.

Recognizing the evolving nature of drug trafficking networks, Dulloo called for strengthening the intelligence-gathering mechanism to identify and apprehend key players involved in the drug trade. He advised the Police Department to utilize its intelligence network effectively to detect patterns, identify repeat offenders, and track supply chains.

In cases involving habitual or organized drug traffickers, he suggested invoking the provisions related to organized crime or Sec 346 of BNSS to effectively dismantle syndicates and create a strong deterrent in the society against drug trade.

The Chief Secretary expressed concern over the vulnerability of border districts to cross-border drug smuggling, particularly from neighbouring regions. He directed the concerned authorities to maintain heightened vigil in these areas and increase surveillance activities with several other measures to detect the involvement of locals in this illicit trade.

Dulloo also instructed that unauthorized drug deaddiction centres be identified and penalized heavily for violating norms. Additionally, he emphasized strict monitoring of chemist shops to ensure that no contraband substances are sold without valid prescription or authorization.

Highlighting the delays in trial due to pending forensic reports, Dulloo instructed the Forensic Science Laboratory to expedite the analysis and reporting of samples collected under NDPS cases. He asserted that early submission of forensic evidence plays a pivotal role in the timely conclusion of trials.

Reiterating the importance of community engagement, Dulloo called for continuous IEC (Information, Education, and Communication) campaigns to raise awareness among the masses, particularly the youth, about the harmful effects of drug abuse. He said such campaigns must reach even the remotest corners of the UT to prevent young people from falling prey to this life-destroying menace.

While speaking in the meeting, Director General of Police, Nalin Prabhat, emphasized upon adopting if 'whole if government approach' to successfully nip this evil from the society. He made out that the law enforcement agencies can not be successful without the active support of other government departments and responsible citizens.

In his remarks, Principal Secretary Home, Chandraker Bharti, made out that the quality of investigation can further be improved to further increase conviction rates. He also favours making of appeals in genuine cases and handing over of big value cases to NCB/ED for more professional investigation and better outcomes.

The DG, Prosecution and ADGP, CID along with othef senior officers including Divisional Commissioners, IGP, Kashmir/Jammu also gave their viewpoints to curb this menace in a more efficient manner. Some of the Deputy Commissioners/District SSPs also made their presentations highlighting the action taken by them to get rid off this drug abuse in their districts.

The meeting noted that enforcement agencies have registered significant cases and arrests over the

past two years with some 1,514 cases registered in 2024 and 2,260 arrests made and 274 detentions under the NDPS Act.

For the first Quarter of 2025 (Jan-Mar), it was added that 464 cases had been registered till date with 637 arrests and 76 detentions, with 31 cases involving commercial quantities the properties of drug dealers worth Rs 12 Cr stands attached by the authorities.

Regarding the destruction of illicit crops and conduct of awareness programs, the meeting was informed that in 2023-2024, poppy cultivation on 273 acres of poppy and cannabis on 1,642 acres was destroyed. In addition, over 1,903 programmes on public awareness conducted across the districts, with Kupwara/Handwara leading at 347 events.

As far as the training and fixing of accountability is concerned, it was revealed that 195 training sessions were conducted since 2022, training 4,267 officers. It was further divulged that 27 departmental inquiries were initiated in 2024 against the IOs, with 16 punishments awarded including censures and withheld increments.

About the treatment facilities, the meeting was apprised that around 20 Addiction Treatment Facilities are functional across the UT (11 in Kashmir, 9 in Jammu). It was given out that 2,332 new patients were registered, with 77,382 follow-up visits recorded for the first quarter of 2025 in these treatment centres.

Besides, the Police and Social Welfare Departments run facilities reported 1,762 fresh OPD cases and 450 IPD admissions in 2024.

DRDO Successfully Conducts Release Trials of Indigenous Long-Range Glide Bomb 'Gaurav' from Su-30 MKI

NEW DELHI: The Defence Research and Development Organisation (DRDO) has successfully conducted release trials of the indigenously developed Long-Range Glide Bomb (LRGB) 'Gaurav' from the Indian Air Force's Su-30 MKI

The trials, carried out between April 8 and 10, mark a significant milestone in enhancing India's precision strike capabilities.

According to officials, the bomb was tested in various warhead configurations and integrated across multiple stations on the Su-30 MKI platform. The weapon demonstrated its ability to strike land targets with pinpoint accuracy at a range of close to 100 kilometres.

'Gaurav' is a 1,000 kg-class glide bomb designed and developed by DRDO's Research Centre Imarat (RCI), Armament Research and



Development Establishment (ARDE), and the Integrated Test Range (ITR), Chandipur. The successful trials were observed by senior officials of DRDO and the Indian Air Force (IAF)

and the Indian Air Force (IAF).

The development of 'Gaurav'

has involved collaboration with key industry players including Adani Defence Systems & Technologies, Bharat Forge, and several Micro, Small, and Medium Enterprises (MSMEs). Certification and quality assurance

were provided by the Centre for Military Airworthiness & Certification and the Directorate General of Aeronautical Quality Assurance.

Defence Minister Rajnath Singh congratulated DRDO, the IAF, and industry partners on the successful trials. "The development of this glide bomb will greatly enhance the capabilities of our Armed Forces," he said in a statement. Chairman DRDO and Secretary, Department of Defence R&D, Dr. Samir V. Kamat also lauded the DRDO teams involved in the project, highlighting the indigenous innovation behind the strategic weapon system.

An official spokesperson said the successful completion of these trials paves the way for the induction of 'Gaurav' into the Indian Air Force, further strengthening India's deterrence and offensive capabilities in modern aerial warfare.
