# Weather Delays Historic Katra-Kashmir Train Launch by PM Modi

JAMMU: The much-anticipated inauguration of the train service from Katra-the base camp of Shri Mata Vaishno Devi Ji shrine-to Kashmir has been postponed due to an adverse weather forecast. Prime Minister Narendra Modi was scheduled to launch the service on April 19, but the event has now been deferred following predictions of heavy rainfall in Jammu and Kashmir on April 18 and 19.

Reports quoted Union Minister of State in the Prime Minister's Office (PMO), Dr. Jitendra Singh, as saying that the



decision to postpone the inauguration was taken in view of the unfavorable

weather conditions predicted during the Prime Minister's visit.

As per the original itinerary, PM Modi was to land at the Udhampur defence airport, fly by helicopter to the Chenab Rail Bridge-the highest railway bridge in the world-then travel by train to Katra. He was to inaugurate both the Chenab Bridge and India's first cable-stayed railway bridge over the Anji Khad, flag off the Vande Bharat Express between Katra and Baramulla, and address a massive rally at Katra Stadium.

Sources said the Prime Minister's visit is likely to be rescheduled after the India tour of U.S. Vice President JD Vance

and National Security Advisor Michael Waltz, which begins on April 21 and is expected to last four days. The new date for the inauguration is expected to fall in late April or early May.

#### Wagf case:Would Muslims be part of Hindu trusts? SC asks Centre

NEW DELHI: The Supreme Court on Wednesday asked the Centre whether Muslims would be allowed

to be part of Hindu religious trusts during the hearing of pleas challenging the constitutional validity of the

Waqf (Amendment) Act, 2025. A bench of Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and K V Viswanathan asked solicitor general Tushar Mehta, appearing for the Centre, on how "waqf by user" can be disallowed as many will not have requisite documents to get such waqfs registered.

"Waqf by user" refers to a practice where a property is recognised as a religious or charitable endowment

(waqf) based on its long-term, uninterrupted use for such purposes, even if there isn't a formal, written declaration of waqf by the owner.

"How will you register such waqfs by user? What documents will they have? It will lead to undoing something. Yes, there is some misuse. But there are genuine ones also. I have gone through privy council judgments also. Waqf by user is recognised. If you undo it then it will be a problem. Legislature cannot declare a judgment, order or decree as void. You can only take the basis," the bench said.

Mehta submitted there was a large section of Muslims who did not want to be governed by Waqfact. The bench then asked Mehta, "Are you saying that from now on you will allow Muslims to be part

of the Hindu endowment boards. Say it openly.' The apex court said when a public trust was declared to be a wagf 100 or 200 years ago, it couldn't suddenly be taken over by the waqf board and declared otherwise."You cannot rewrite the past,"

SRINAGAR: Former Intelligence Bureau (IB) Director A.S. Dulat has made a startling revelation, claiming that National Conference (NC) president Dr. Farooq Abdullah seriously

contemplated an alliance with the Bharatiya Janata Party (BJP) in the aftermath of the abrogation of Article 370, particularly during 2022-2023

In a recent interview, Dulat disclosed that he was informally tasked by the Modi-led central government to establish contact with Abdullah while the veteran Kashmiri leader was under house arrest in 2019. "Shortly after Article 370 was scrapped, someone from the Government of India requested me to reach out to Farooq," Dulat stated.He further revealed that Abdullah's release was tied to two unspoken conditions: refraining from criticizing the revocation of J&K's special status and avoiding any reference to Pakistan. ## SC Fixes May 14 For Hearing Pleas Against Appointment Of CEC, ECs Under 2023 Law

**NEW DELHI**: The Supreme Court on Wednesday fixed May 14 for hearing a batch of pleas challenging the appointment of the chief election commissioner (CEC) and election commissioners (EC) under the 2023 law.

Abench of Justices Surya Kant, Dipankar Datta and Ujjal Bhuyan fixed the date after advocate Prashant Bhushan urged the bench to accord urgent hearing in the matter.

Bhushan, appearing for a petitioner NGO challenging the appointment process, said the issue was covered by the Constitution bench verdict of 2023.

Justice Kant told Bhushan that the court will take up the matter on May 14 by cancelling a special bench matter on the said date.

Bhushan said though the matter is listed in the business of the day of the bench, they are urging the court to take it on top of the board.

Justice Kant said the bench will be taking several part-heard matters involving land acquisition on Wednesday.

On March 19, the top court had fixed April 16 for hearing a batch of pleas challenging the appointment of the CEC and election commissioners under the 2023 law.

He had argued that the government, by appointing the new CEC and EC under the 2023 law, was making a "mockery of democracy".

On February 17, the government appointed EC Gyanesh Kumar as the

CJI from the selection panel and deferred the hearing on a batch of pleas against the appointments.

The apex court told the petitioners that the March 2, 2023 verdict directed for the three-member panel comprising the prime minister, Leader of Opposition and the CJI to operate till Parliament enacted a law.

The apex court's verdict held that leaving the appointment of the ECs and CEC in the hands of the executive would be detrimental to the health of the country's democracy and the holding of free and fair elections.

The NGO challenged the CJI's exclusion and said the election commission should be insulated from "political" and "executive interference" for maintaining a healthy democracy.

The ADR's plea alleged the verdict was overruled by the Centre without removing its basis and the composition of the selection committee under the new law which amounted to excessive interference of the executive in the appointments and was detrimental to the independence of the poll panel.

Former IAS officers Gyanesh Kumar and Sukhbir Sandhu were recommended to be appointed as ECs in 2024 by a selection panel chaired by Prime Minister Narendra Modi under the new law.

# National Herald case: BJP rejects Cong's charge of vendetta

"license to loot", the ruling BJP on Wednesday dismissed the Congress' charge of vendetta after the ED chargesheeted Sonia Gandhi and Rahul Gandhi in the National Herald case.

Former law minister and BJP leader Ravi Shankar Prasad asked the Congress to reply to the substance of allegations against the Gandhis instead of merely offering a political reaction, noting that the opposition party found no relief from the judiciary in its pleas against the probe.

Speaking to reporters, Prasad outlined the main charge against the Gandhis that as the 76 per cent share-holder of the Young India company they "misappropriated" thousands of crores of real estate owned by the Associated Journals Limited (AJL), which owned the National Herald newspaper.He said the Congress has the right to hold 'dharnas' (to protest ED chargesheet against Sonia Gandhi and Rahul) but that right does not extend to misappropriating public properties given by the government to the National Herald. He accused the Congress of issuing threats to the probe agency and asked if the party and Gandhi's believe in the due process of law or not."We condemn the threats from the Congress. There is Modi government in place. It will allow the law to take its own course," he said.

The Young India, he said, wrote off the Rs 90 cr loan that the Congress had given to the AJL and got the ownership of the company with a paltry investment of Rs 50 lakhs.

The land was given to the AJL by the government, he said, adding that the National Herald was allegedly used by the Congress establishment

The Congress described the ED's chargesheet as vendetta politics and claimed seizing of assets in the case was a "state-sponsored crime masquerading as the rule of law".

KOLKATA: West Bengal Chief Minister Mamata Banerjee on Wednesday termed the recent communal violence in Murshidabad as "pre-planned" and accused a section of the BSF, central agencies, and the BJP of fanning tension by allegedly facilitating cross-border influx from Bangladesh.

Speaking at a meeting with Imams, Banerjee alleged that despite the volatile situation in neighbouring Bangladesh, the central government allowed illegal entry from across the border, and claimed that the BSF and certain agencies played a role in triggering unrest in Bengal.

With only 14 seats in the 147-member Odisha Legislative Assembly, Congress has adopted bold tactics to regain political relevance and visibility. The party is focusing on alleged governance failures under the BIP-led government, particularly highlighting emotive issues such as women's safety.

A central part of Congress's critique has been Chief Minister Mohan Charan Majhi's own admission that over 36,000 women and 8,400 children have gone missing. The party has seized on this to challenge the BJP's law-and-order credentials, aiming to mobilise public sentiment, especially in tribal-dominated regions like Koraput and Nabarangpur.

Meanwhile, the BJD, despite being the official opposition, has taken a notably subdued approach since its 2024 defeat. Its response has been limited to sporadic statements and symbolic actions, such as lodging complaints with the Election Commission. Congress is now stepping into this vacuum, presenting itself as a more vocal and active opposition to the BJP government.Following its poor performance in the 2024 elections, Congress dissolved the Odisha Pradesh Congress Committee(OPCC) in July 2024 to address internal factionalism and leadership challenges.

Hemant Soren elected as JMM central president, Shibu Soren made 'founding patron'

RANCHI: Jharkhand Chief Minister Hemant Soren was on Tuesday elected as the central president of the ruling JMM, while his father Shibu Soren was made the "founding patron" of the party, a JMM leader said.

Shibu Soren had been the Jharkhand Mukti Morcha's chief for the past 38 years, while his son Hemant served the party as its executive president since 2015, he said.

Senior party leader and Dumka MP Nalin Soren proposed the name of Shibu Soren as the founding patron during the IMM's 13th Central Convention and it was seconded by the Maheshpur MLA Stephen Marandi.

Thereafter, Shibu Soren proposed the name of Hemant Soren as the central president of JMM, which was passed unanimously.

"The responsibility that respected Baba Dishom Guruji (Shibu Soren) has given me,

the faith that lakhs of party colleagues have shown in me, I will work hard day and night to fulfill it. This support of all of you is my strength," Hemant Soren later posted on X. He said that he would serve the people

### Govt Bans Manufacture, Sale Of 35 Fixed-Dose Combination Drugs

**NEW DELHI:** Apex drugs regulatory body CDSCO has directed drug controllers of all states and Union territories to stop manufacture, sale and distribution of unapproved 35 fixed-dose combination drugs that include painkillers, nutrition supplements and anti-diabetics.

They have also been asked to review their approval process for such fixed dose combination drugs (FDC) and ensure strict compliance of the provisions of the Drugs and Cosmetics Act 1940 and rules.

FDC drugs are those which contain a combination of two or more active pharmaceutical ingredients (APIs) in a fixed ratio.

The regulator issued the directions after it found that certain FDC drugs have been licensed for manufacture, sale, and distribution without prior evaluation of safety and efficacy,

Upon issuance of show cause notices to the manufacturers, they have stated that these licenses were granted by the respective drug licensing authorities and have not violated any rules, it said. This has resulted in a lack of uniform enforcement of the





Nearly nine years after they were first sanctioned, two of Jammu and Kashmir's most critical infrastructure projects-the Singhpora-Vailoo Tunnel and the Sudhmahadev-Dranga Tunnelcontinue to remain entangled in a web of delays, policy shifts, and bureaucratic hurdles, dashing public hopes once again. Sanctioned in 2017 under the BharatmalaPariyojana, these tunnels were envisioned as lifelines that would establish allweather connectivity between South Kashmir and the Chenab region by bypassing the dangerous Sinthan Top Road, a mountainous route notorious for its accident-prone curves and months-long closures due to heavy snowfall.

Despite being tendered first in 2023, both projects suffered an unexpected blow when the tenders were cancelled in 2024. Initial explanations cited administrative issues, but recent revelations confirm that the Union Home Ministry refused to grant clearance to the lowest bidder, an Azerbaijani construction firm. At that time the decision met with disappointment and frustration among the people of both Kashmir and Chenab, who have long viewed these projects as transformative not just for connectivity but for regional economic upliftment.

After passing of almost one-year, political leaders, including the Member of Parliament from the Anantnag-Rajouri constituency, raised the issue with the concerned ministries and executing agencies, receiving assurances that the tenders would be reissued and the projects awarded by mid-2025. Union Minister for Road Transport and Highways, Nitin Gadkari, also addressed the matter during the recent inauguration of the Z-Morh now Sonamarg Tunnel, stating that the Singhpora-Vailoo and Sudhmahadev-Dranga tunnels would be retendered soon. In the Jammu and Kashmir Legislative Assembly, Deputy Minister Surinder Choudhary confirmed that while the projects were originally approved under the Bharatmala

The PIB cited high costs, questionable techno-feasibility, and the existence of an "adequate" alternate road as reasons for their decision, asserting that there was no direct, demonstrable benefit from the construction of the tunnels. However as per the reliable sources the news has been misquoted and only some objections have been raised and projects have not been dropped down. This rejection/objection has triggered wide-

spread disbelief and raised uncomfortable questions. Experts argue that the detailed project reports (DPRs), prepared after thorough technical and traffic feasibility studies, already addressed these concerns. Leave NH-244's DPR aside, even in the Detailed Project Report (DPR) which had been approved by the NHAI for the five tunnels currently under construction on NH-44 (Srinagar-Jammu National Highway), between Ramban and Banihal, has been prepared by ICT and Altinok in 2018-19. The DPR clearly states that NH-44 shall be planned to be upgraded from four lanes to six lanes by 2026 to accommodate the anticipated rise in traffic. However, due to the challenging geological terrain in this stretch, such an expansion is technically unfeasible. In fact, even the existing

been made in the NH-244 corridor, including the construction of a 10-kilometre greenfield road from Alstop on NH-44 and the deployment of multiple work packages to upgrade the NH-244 alignment. The Singhpora-Vailoo and Sudhmahadev-Dranga tunnels were more than just construction projects; they symbolized hope for reliable connectivity, economic integration, and a safer, more prosperous future for two historically underserved regions. Their abrupt sidelining by the PIB has left feasibility studies, and land acquisition. To claim now, almost a decade later, that these projects offer no tangible benefit undermines the very process of long-term planning and development. Despite the rejection of the Vailoo-Singhpora

Tunnel Project and the Sudhmahadev-Dranga Tunnel by the Public Investment Board (PIB) on 22 March 2025, optimism remains for their eventual approval. Historical precedents demonstrate that projects initially declined can later receive approval after addressing concerns and securing necessary revisions. For instance, the Mumbai Trans Harbour Link (MTHL) faced multiple hurdles, including environmental clearances and funding challenges. Initially proposed under a public-private partnership (PPP) model, the project struggled to attract bids. Subsequently, it was restructured as an engineering, procurement, and construction (EPC) project, with the Japan International Cooperation Agency (JICA) committing a significant loan of 8,600 crore to facilitate its completion. In Maharashtra, the Upper Tapi Dam and Shelgaon Barrage projects were rejected in 2019, only to be revised and cleared in 2021. Similarly, the Baglihar Dam project in Jammu and Kashmir encountered delays due to environmental concerns and political disputes. After addressing these issues and obtaining necessary approvals, the project was completed in two stages, contributing significantly to the region's power supply.

Financial implications are often pivotal in securing project approvals. In cases where domestic funding is insufficient, international agencies like JICA can play a crucial role. For example, JICA extended a loan of 18,750 crore for the Mumbai-Ahmedabad High-Speed Rail Project, marking one of its largest single-project commitments globally. Such collaborations can provide the necessary financial backing to overcome initial rejections and ensure project realization.

These examples underscore the potential for projects like the Vailoo-Singhpora and Sudhmahadev-Dranga tunnels to be reconsidered and approved, provided that concerns are adequately addressed and appropriate financial mechanisms are secured. Unless the Central Government and the administration of the Union Territory act swiftly to revive and revalidate these projects under the current policy framework, the window

The Count was conducted simultaneously in all the major water-bodies along with lesserknown wetlands of the valley which included Hokersar, Shallabugh, Hygam, Mirgund, Wullar Lake Badinambal, Narkara, Nigeen Lake, (6 associated wetlands, Anchar Lake, Dal Lake, and wetlands from Pampore viz., Manibugh, Kranchoo, Chatlum and Fashkhoori. It was revealed that the activity was conducted by 160 volunteers including NG0s, Bird Lovers, students from Kashmir University and SKUAST-K along with the staff of Wetlands Division and North Division. The survey culminated into recording a total of 13,43,506 number of birds belonging to 67 species in all the wetlands. Hokersar contributed 29.97 % of the total birdcount followed by Shallabugh (29.44%) and other wetlands (40.59%). On the occasion, the Chief Secretary launched two mobile apps pertaining to monitoring of CAMPA works and its nursery module for real time updation of data by the concerned to chase the targets on time.

third-party evaluations show improved survival rates. The third party evaluation (2012-2019) reported a 50% survival rate and in the next phase (2019-2022), conducted by AFC India Limited, survival rates improved significantly to 62.70%, with Kashmir at 65.40% and Jammu at 60%.

Giving the financial overview of this scheme as on March 2024, it was divulged that a total of Rs 851.65 crore were available with an approved outlay of Rs 276.27 crore for FY 2024-25. It was further added than an expenditure of Rs 153.67 was booked during this year leaving a balance of Rs 727.66 crore available with the department.

As far as the outcomes over the past 15 years are concerned, the meeting was apprised that during 2010-11 to 2024-25, a substantial amount of forest land has been treated under CAMPA initiatives, with the total area afforested reaching thousands peaking at Rs 153.67 crore in FY 2024-25 with corresponding increase in year-wise plantation efforts. These efforts are aimed at enhancing green cover, improving biodiversity, and mitigating the impact of climate change.

The Annual Plan Outlay (APO) for the fiscal year 2025-26 was presented and approved, with a total proposed outlay of Rs 193.72 crore, of which, Rs 170.47 crore have been proposed under the forest sector activities and Rs 23.25 crore under wildlife conservation.

Regarding different components of APO, the Compensatory Afforestation has an outlay of Rs 12.71 crore, Additional Compensatory Afforestation Rs 7.27 crore, NPV (Forest) Rs 117.96 crore and NPV (Protected Areas) Rs 23.25 for the ensuing year.

The Committee also reviewed and approved several key targets for the upcoming fiscal year.

Baramulla: In a significant initiative aimed at strengthening the legal and operational understanding of antiterror laws, a one-day workshop on the "Investigation and Prosecution of Cases under the Unlawful Activities (Prevention)Act(UAPA)" was conducted at District Police Lines (DPL) Baramulla by the Range Police Headquarters (RPHQ), North Kashmir Range (NKR).

The workshop was inaugurated by Deputy Inspector General of Police, North Kashmir Range, Maqsood-ul-Zaman, in the presence of Senior Superintendent of Police, Baramulla, Shri Gurinderpal Singh.

In his keynote address, DIG Zaman emphasized the critical role of UAPA as a vital legal tool in the hands of law enforcement for maintaining national security.

He underlined the challenges faced by investigating officers while dealing with UAPA cases and stressed the need for adopting remedial strategies for effective and timely prosecution.

Highlighting the broader vision, DIG Zaman reiterated the central government's goal to achieve a 90% conviction rate in UAPA cases within the next five years, as envisioned by the Hon'ble Union Home Minister. He noted that this target aligns



with nationwide efforts to modernize criminal justice mechanisms and ensure that anti-terror laws are implemented both rigorously and fairly.

The workshop focused on key themes including recent amendments to the UAPA, best practices in investigation and evidence collection, the role of intelligence inputs, and judicial interpretations of relevant case law. The sessions were

# The Future of Israel and Palestine: Navigating Uncertainty in a Changing World

alestinian society, meanwhile, is marked by deep frustration and disillusionment, particularly among younger generations who have grown up knowing only occupation, blockade, and economic hardship. Many Palestinians have lost faith in their leadership's ability to achieve statehood through negotiations, viewing both the Palestinian Authority and Hamas as ineffective, corrupt, or disconnected from the realities on the ground. The failure of past

#### create meaningful change.

A two-state solution remains the most widely endorsed framework for resolving the Israeli-Palestinian conflict, yet its feasibility appears increasingly distant. For this scenario to materialize, significant political will, domestic consensus, and international support would be required to address the core issues that have plagued past negotiations. Key questions surrounding borders, security arrangements, the status of Jerusalem, and the fate of Israeli settlements in the West Bank would need to be resolved through mutual compromise. A viable two-state solution would involve establishing an independent Palestinian state alongside Israel, with secure and recognized borders. East Jerusalem would likely need to serve as the capital of a future Palestinian state, while arrangements ensuring security for both sides would need to be implemented and enforced over the long term. However, achieving such an agreement would require overcoming deep mistrust, addressing internal political fragmentation among Palestinians, and navigating the growing influence of nationalist and religious factions within Israeli politics. Without strong

markets, and create new refugee crises, adding to the complexity of an already volatile region.

Each of these scenarios presents distinct challenges and risks, underscoring the complexity of the Israeli-Palestinian conflict and the high stakes involved in determining its future trajectory. While a two-state solution remains the most widely accepted framework for a peaceful resolution, the political realities on the ground suggest that alternative scenarios, including prolonged stalemate, one-state outcomes, or regional escalation, are increasingly plausible. The choices made by leaders, civil society, and the international community in the coming years will determine whether the region moves toward peace, perpetuates the status quo, or descends into further violence and chaos. The future remains uncertain, but the consequences of inaction could be devastating for generations to come.

Any future peace effort between Israelis and Palestinians must prioritize rebuilding trust, a task that has become increasingly difficult after decades of violence, failed negotiations, and mutual suspicion. Trust cannot be restored overnight, and it



peace processes, combined with ongoing settlement expansion and military incursions, has led to widespread cynicism about the possibility of a diplomatic solution. For many, the idea of a two-state solution feels increasingly out of reach, and alternative approaches, including calls for a single democratic state or continued resistance, have gained traction. This disillusionment has also fueled support for grassroots resistance movements, as Palestinians seek to challenge the status quo through protests, civil disobedience, and international advocacy. However, the absence of a unified national strategy has limited the effectiveness of these efforts. The division between the Palestinian Authority in the West Bank and Hamas in Gaza has created political fragmentation that weakens the overall Palestinian struggle. Without a clear vision for the future and a leadership that can rally broad support, the Palestinian national movement remains in a state of paralysis, with no clear path forward.

Despite the political deadlock, grassroots movements that

leadership capable of mobilizing public support and making difficult concessions, the prospect of a two-state solution will remain an elusive ideal.

In the absence of political breakthroughs, the status quo of occupation, settlement expansion, and periodic violence is likely to persist, leading to a prolonged stalemate with no clear path to peace. This scenario envisions continued Israeli control over Palestinian territories without any meaningful progress toward Palestinian statehood. Israeli settlement expansion in the West Bank would continue, further eroding the territorial contiguity necessary for a viable Palestinian state. The division between the Palestinian Authority in the West Bank and Hamas in Gaza would remain unresolved, perpetuating internal Palestinian disunity and weakening the Palestinian national movement. Periodic flare-ups of violence, whether sparked by clashes in Jerusalem or military confrontations in Gaza, would continue to destabilize the region and exacerbate humanitarian suffering. The longer this stalemate endures, the more entrenched the existing power dynamics become, making it increasingly difficult to reverse course. Over time, this reality risks deepening resentment and despair among Palestinians, fueling extremism, and increasing the likelihood of sporadic violence that could spiral out of control. As settlement expansion continues and the possibility of a two-state solution diminishes, the prospect of a one-state reality becomes more likely. In this scenario, Israel would maintain control over the West Bank and Gaza without granting Palestinians equal rights, leading to accusations of apartheid and growing international condemnation. The continued denial of political rights to millions of Palestinians under Israeli control would raise profound ethical and legal questions, intensifying pressure from the international community to address the inherent inequalities of such an arrangement. Alternatively, a one-state framework based on equal rights for all residents, regardless of ethnicity or religion, could emerge as a potential solution. However, this approach would fundamentally challenge the notion of Israel as a Jewish state, as granting equal political rights to Palestinians would alter the demographic balance and potentially undermine Israel's identity as a Jewish and democratic state. This scenario would face significant political opposition within Israel, where concerns about maintaining a Jewish majority and preserving national security remain paramount. The prospect of a single democratic state where Jews and Palestinians coexist as equals is appealing to some activists and intellectuals, but it remains politically untenable in the current environment. The risk of a major escalation or regional war remains a looming threat that could reshape the landscape of the Israeli-Palestinian conflict. Continued tensions between Israel and Iran-backed proxies, including Hezbollah in Lebanon and Hamas in Gaza, combined with growing frustration among Palestinians, could trigger a broader conflict that destabilizes the entire region. A large-scale confrontation could draw in multiple actors, including Iran, Syria, and other regional powers, leading to devastating humanitarian consequences and widespread destruction. In such a scenario, military escalation could spiral beyond the confines of Gaza or the West Bank, potentially involving Lebanon's southern border, Syria's Golan Heights, and Iranian influence networks across the region. The consequences of such a conflict would be catastrophic for civilians on all sides, deepening animosities and further diminishing the prospects for peace. A regional war could also exacerbate sectarian divisions, disrupt global energy requires a multifaceted approach that addresses past grievances, acknowledges the legitimacy of each side's aspirations, and promotes dialogue at both the political and societal levels. Political leaders on both sides must demonstrate a genuine commitment to dialogue and compromise, but grassroots initiatives that foster understanding and cooperation are equally essential. Civil society organizations that bring Israelis and Palestinians together to engage in meaningful dialogue can play a critical role in challenging narratives of hatred and dehumanization. About 72 petitions, including those by AIMIM leader Asaduddin Owaisi, All India Muslim Personal Law Board (AIMPLB), Jamiat Ulama-i-Hind, the Dravida Munnetra Kazhagam (DMK), Congress MPs Imran Pratapgarhi and Mohammad Jawed, have been filed challenging the validity of the Act.

The Centre, on April 8, filed a caveat in the apex court and sought a hearing before any order was passed in the matter.

Since its rollout in April 2023, HADP has achieved notable milestones such as the development and multiplication of high-quality seeds, promotion of oilseeds and cash crops, technological advancements in sericulture, formation of 300 Farmer Producer Organizations (FPOs), and the launch of the JK Soil & Land Resource Information System.

### Kathua Encounters Exposed Infiltration Route of Terrorists: Police

and Kashmir's Kathua district "exposed" the route used by terrorists to infiltrate into India from across the International Border (IB), a senior police officer said on Wednesday.

Senior Superintendent of Police, Kathua, Shobhit Saxena also said the successful recovery of huge quantities of arms and ammunition including explosives from the terrorists after the gun fights scuttled a major plan of the terror groups to carry out a major strike in Jammu and Kashmir.

Kathua district witnessed four encounters between a group of recently infiltrated terrorists and security



forces in the past one month.

Two heavily-armed terrorists were eliminated in Safiyan forest on March 27. Four police personnel were killed in the encounter which took place four days after police intercepted the infiltrating terrorists in Saniyal forest of Hiranagar sector.

"We are chasing the remaining three to four terrorists who escaped the encounters and are on the run. We are confident of tracking and neutralizing them soon," the SSP told reporters at Rajbagh police station, where all the seized material including sophisticated weapons, explosives and daily-use items was on display.

He said a tight security grid is in place in the district, from the border villages to hinterland, leading to the successful operations against the terrorists.

"The encounters exposed their traditional (infiltration) route... We will not allow them to use this route again," Saxena said.

He said the recoveries showed that they had come with ill intention and were prepared for a long stay.

He said the seizure of a huge quantity of explosive material thwarted their plan to carry out Improvised Explosive Devices (IED) blasts, while some quantity of heroin suggested that they were also consuming drugs.

He praised the cooperation of the people in the anti-terrorist operations and said the "civil population helped us a lot and are providing immediate information which helped us to make an assessment about the terrorists on the run and are accordingly planning our operations to neutralize them".

According to evidence, Saxena said terrorists had recently sneaked into this side from across the border but police "did not allow them to succeed in their nefarious designs".

On local support to terrorists, he said 30 people have been identified and booked under Public Safety Act (PSA) in the district so far.

Among the material seized from the terrorists include two AK assault rifles, one M4 carbine, grenades, and sophisticated gadgets for navigation, clothes, sleeping bags, Pakistan-make medicines, beverages and food items. (Agencies)

Wani concluded by saying the party remains strong and united and that no such developments, as suggested by the rumors, have taken place.

#### Rains lash Kashmir; MeT predicts 3-day wet spell from Friday

**SRINAGAR:** A day after the Valley recorded the hottest day of the season, fresh rainfall in Srinagar and other parts of Kashmir on Wednesday led to mercury plummeting across the region.

According to the details available with the news agency—Kashmir News Observer (KNO) the weather conditions remained mostly cloudy today across the Valley while the rainfall in the evening led to the decline in temperature.



Amidst the gusty winds, the rains lashed multiple areas of the Valley including Srinagar, especially north and central Kashmir. However, the weatherman has predicted generally dry weather tomorrow.

Director Meteorological department, Dr Mukhtar Ahmad said that the weather is expected to remain wet from April 18 as light to moderate rain and snow (higher reaches) at most places and moderate to heavy rain at isolated to scattered places during 18th & 19th April accompanied with thunder and gusty winds from April 18th evening onwards is expected in the region.

The major activity is expected on April 19 as the local MeT department here has issued yellow and orange alerts for the day.

On April 21, he predicted cloudy weather with possibility of light rain and thunder at scattered places. "From April 22 to 25, the weather conditions would remain generally dry," he added.

In between April 26 & 27, the weather would again turn cloudy in the region, he said.

olkata Knight Riders skipper Ajinkya Rahane admitted that his batters lacked "game awareness" in their defeat to Punjab Kings and reminded them that strike rotation is as important as hitting sixes in the T20 format. The 16-run defeat in a low-scoring thriller here on Tuesday night kept the Knight Riders at sixth spot on the table with as many points after seven matches.

The Kings were all out for 111 but they came back strongly to roll over KKR for 95 to celebrate a fine victory.

"See, it was not a flat wicket. It had something for the bowlers. We had to grind it out. Even though sometimes you will have to play a maiden over in T20s, that's alright or play at a strike rate of 70 or 80, that's fine," Rahane said in the post-match press conference.

"It's all about rotating the strike as a batting unit. T20, I believe, it's not only about hitting sixes. Now, we are seeing most of the batters are going for big shots and they want to look good on the field.

"But it's all about reading the situation well, having that game awareness as a batter, and then taking the game forward. That's what I thought we lacked," he added.

Rahane was gracious enough to take the blame for the defeat on his shoulders but hoped that his colleagues would up their game in the next match itself.

"I take the responsibility (for the defeat) as a captain. But individually, I'm sure all the players, especially the batters, will think about their own game and improve in the upcoming matches.

### **Ponting: That might** be the best win I've ever had as coach in IPL

unjab Kings (PBKS) head coach Ricky Ponting has been coaching in the IPL since 2014 but he called Tuesday's low-scoring thriller against Kolkata Knight Riders (KKR) "just about the best win that I've ever had" as a coach in the tournament. Ponting watched from the sidelines as PBKS defended 111, the lowest total that has been defended in IPL history, for a 16-run win. Ponting said pulling off a win like this could be a "season-defining moment".



"The heart rate still up a bit for me - it's probably up over 200," Ponting told the broadcaster soon after the game. "I don't need many of those games like that at my age of over 50 now.

"It just goes to show how funny a game it is. Only three days ago we couldn't defend 246 [245] and here we are, defending 112 [111] with 16 runs up our sleeves. We actually said to the guys at the halfway mark that really small chases like this are sometimes the hardest. The wicket wasn't easy. You can see right through the game it was holding up.

"But what about [Yuzvendra] Chahal tonight! How good a spell of bowling was that! We've actually put it on him a bit during the week. He had a fitness test before the game today with his shoulder injury that he picked up in the last game and I grabbed him at the warm-up, looked him in the eye and said, 'Mate, are you OK?' He said, 'Coach, I'm 100% alright, let me out there', and what a spell of bowling."

When asked what was the talk in the dressing room at the innings break, Ponting said: "Well, you can probably see the way we changed things up with the ball as well, with Marco [Jansen] taking the first over and [Xavier] Bartlett the second. Normally, it's been a role for Arshdeep [Singh] with the brand new ball, but the match-ups tonight suggested that Jansen and Bartlett were better suited.

"But we just said that wins like this are always the sweetest ones. If we can pull this off, then this would be as good as a win most guys have probably been involved in. I've coached a lot of games in the IPL and that might just be about the best win that I've ever had."
